Dear Judge Dufficy:

On Monday, March 30, 1992 I attempted to file the Waiver of Right to Petition for Writ of Mandate; Request for Immediate Transfer of File in the captioned case. My purpose was to expedite the transfer of the referenced action to the Los Angeles Superior Court by waiving our right to petition for a Writ of Mandate so that the Clerk would not have to wait the 20-day period required by Code of Civil Procedure §§399 and 400.

I was informed by the Clerk's office that you had directed them to receive no further pleadings in this matter. The Clerk informed me that she would transmit the referenced pleading to your court clerk. Today I received your Minute Order to the effect that no further orders are to be submitted, nor will there be further hearings regarding this matter. I also received today a letter from Ford Greene, a copy of which is enclosed, informing me that two depositions, which had been duly and timely noticed for April 2 and 3, would not take place because, in Mr. Greene's words, "no court presently has jurisdiction over the above case."


I regret that I must make one final request of Your Honor. That request is that you direct the Clerk to accept for filing the referenced pleading and instruct the Clerk to have the case files transferred immediately to the Los Angeles Superior

Court. The required fees were paid by delivery of checks in the appropriate amounts by me to the Court Clerk on Monday, March 30.


