In December 1992 and July 1993, Orders to Show Cause re Contempt were issued against the defendant in the above-entitled matter. Hearing on these Orders was stayed by Judge Wayne pending appellate review of the Order of Injunction upon which the OSC's were premised. Appellate review is now complete and the OSC's have been set for hearing on July 28, 1994.


