



23 On May 28, 1995, the Los Angeles Superior Court issued a
24 preliminary injunction in this matter, contingent upon the
25 posting by plaintiff, Church of Scientology International, of a
26 bond in the amount of \$70,000. On June 5, 1992, the Church of
27 Scientology international made a deposit with the Los Angeles
28 Superior Court of \$70,000, [Ex. A, Receipt], in lieu of posting a

1 bond or undertaking, as permitted by Code of Civil Procedure
2 Section 995.710(a)(1). The deposit was transferred to the Marin
3 Superior Court in January, 1995, [Ex. B] although the accumulated
4 interest remained in Los Angeles. This Court having issued a
5 permanent injunction, there is no longer any need for the
6 deposit.

7 Accordingly, pursuant to Code of Civil Procedure Section
8 995.360(a), plaintiff Church of Scientology International and
9 defendant Gerald Armstrong stipulate that the deposit of \$70,000
10 made by the plaintiff in this action upon the issuance of a
11 preliminary injunction may be withdrawn from the Court and
12 returned to the plaintiff, together with interest thereon. The
13 parties also agree that ^{any of the} ~~Armstrong's right to~~ ^{issues on} appeal from the
14 order of permanent injunction in this action ^{are} ~~is~~ not affected by
15 this stipulation.
