THE COURT:*

The court has read and considered the "Response to Petition, etc." filed December 23, the "Motion for Clarification of Temporary Stay Order" filed December 27, and the "Emergency Motion for Partial Reconsideration of Temporary Stay Order" filed December 28.

This court's December 22, 1988 Temporary Stay Order is hereby modified to read as follows:

It is hereby ordered that respondent's orders of November 9 and 30, 1988, in Los Angeles Superior Court case No. C 420153, entitled Church of Scientology of California v. Armstrong (and related cross-action), are, until further order

of this court, stayed in effect to the extent, and only to the extent, that they unseal that court case file as to the general public and permit review and photocopying thereof by any person other than moving party, Bent Corydon, and his counsel of record, Paul Morantz, and attorney Toby L. Plevin, subject to the protections and restrictions in the following paragraph.

Bent Corydon, Paul Morantz and Toby L. Plevin are prohibited from disseminating copies of or disclosing the content of any documents (or portions thereof) found within Los Angeles Superior Court case file C 420153 to the public or any third party, except to the extent necessary to litigate the six actions now pending between Bent Corydon and the Church of Scientology. When offering to file, lodge or otherwise disclose copies of such documents (including portions thereof) or information contained therein for any purpose in any of the six pending actions, Corydon and his counsel of record shall make a good faith request that such material be placed under The above-described rights of inspection and copying by attorneys Paul Morantz and Toby L. Plevin shall terminate immediately upon cessation of the respective attorney's status as attorney of record for Bent Corydon in the six pending actions. All inspection and copying rights of Corydon and his respective counsel shall terminate upon final disposition of the six pending actions. The prohibition against disclosure and dissemination shall continue until this court determines the related appeal.

The petition filed December 19, 1988, fails to conform to the requirements of California Rules of Court, rule 56(c)(2) and (3). Petitioner is ordered to lodge true and complete copies of the missing exhibits with this court on or before January 9, 1989.
