
On the application of appellants to extend the time in which to file appellants' Opening Brief and good cause appearing,



APPLICATION FOR EXTENSION OF TIME IN WHICH TO FILE APPELLANTS' OPENING BRIEF

TO THE HONORABLE PRESIDING JUSTICE OF THE COURT OF APPEAL,
SECOND APPELLATE DISTRICT:

Appellants Church of Scientology of California, et al. hereby apply for special permission from the Presiding Justice to file their Opening Brief 45 days after November 6, 1989, the date the Opening Brief is presently scheduled to be filed.

Eric Lieberman, the counsel who will be preparing the opening brief to file herein, is the counsel who briefed and presented the argument before the Court of Appeal originally in August 1986. At that time the court declined to decide the issues on appeal because there was a cross-claim still pending. Shortly thereafter, on December 11, 1986, the cross-claim was

settled and dismissed from the action. On February 9, 1987, plaintiffs filed a new appeal. The record for this appeal was finalized on October 6, 1989 and the opening brief herein was thereupon scheduled to be filed on November 6, 1989.

1. Due to the complexity of the issues of fact and law in the instant litigation, counsel for appellants believe that 45 additional days are required in which to fully brief the issues.

2. The Counsel responsible for the preparation of the brief is also engaged in a number of other court matters during October and November, which will make a full and adequate briefing of the issues extremely difficult. In particular, counsel for appellants was required to prepare an emergency brief to the U.S. Court of Appeals for the 11th Circuit. Further, counsel is required to file a petition for a Writ of Certiorari with the United States Supreme Court in a complex matter arising from a different division of this district.

3. This is appellants' first request for extension for an allowance of an additional 45 days to the current deadline of November 6, 1989.

4. Rule 16 of the California Rules of Court, specifies that appellant's opening brief be served and filed within 30 days after the filing of the record of the reviewing court. Rule 17 provides that "[i]f a sufficient written showing of excuse is made within such 30-day period, the Chief Justice or Presiding Justice may grant additional time to file the brief subject to such conditions as he may deem proper to impose."

5. Further, Rule 43 of the California Rules of Court

provides for the granting of applications to extend time for filing records and briefs for good cause shown.

Appellants therefore respectfully urge this Court to grant an extension of time of 45 days from November 6, 1989 to and including December 21, 1989, in which to file appellants' Opening Brief, so that appellants may thoroughly brief the relevant issues of fact and law herein.


