# Equivariant Singular Riemann-Roch Theorem

## 1 Introduction

The Rieman-Roch theorem [7], [2] has played such a key role in the study of algebraic geometry, algebraic topology or even number theory, that many attempts have been made to generalize it to the equivariant case (for example [9], [4]). Here we consider the case of the equivariant singular Riemann-Roch theorem, following the framework of P. Baum, W. Fulton and R. MacPherson.

## 2 Totaro's approximation of $E G$

The purpose of this section is to describe a construction, due to Totaro [5], of an algebro-geometric substitute for the classifying space of topological group.

For topological group $G$, the spaces $E G$ and $B G$ are infinite dimensional, it is hard to control in general. What Totaro produces for a reductive algebraic group is a directed system of $G$-bundles $E_{n} \rightarrow B_{n}$ with the following property: for any algebraic principal $G$-bundle $E \rightarrow X$, there is a map $X^{\prime} \rightarrow X$ with the fiber isomorphic to affine space $\mathbb{A}^{m}$, such that the pullback bundle $E^{\prime} \rightarrow X^{\prime}$ is pulled back from one of the bundles in the directed system by a $\operatorname{map} X^{\prime} \rightarrow B_{n}$.

For a complex linear reductive algebraic group $G$, Totaro constructs the directed system as follows:

Every object in the directed system is a pair $\left(V, V^{\prime}\right)$, such that $V$ is a representation of $G, V^{\prime}$ is a non-empty open set of $V, G$ acts freely on $V^{\prime}$, $V^{\prime} \rightarrow V^{\prime} / G$ is a principal $G$-bundle. $\left(V, V^{\prime}\right)<\left(W, W^{\prime}\right)$ if $V$ is a subspace of $W, V^{\prime} \subset W^{\prime}, \operatorname{codim}_{V}\left(V-V^{\prime}\right)<\operatorname{codim}_{W}\left(W-W^{\prime}\right)$. The morphisms are just inclusions.

For some groups, there is a convenient choice of the directed system. For example, if $G=T$ is a split torus of rank n , then $\left\{\left(V^{n},(V-\{0\})^{n}\right) \mid \operatorname{dim} V=\right.$ $l\}$ is the directed system.

## 3 Equivariant cohomology

In general [1] , we define

$$
H_{G}^{*}(X)=H^{*}\left(X \times^{G} E G\right)
$$

Using the directed system above,
LEMMA 3.1 For a complex Lie group $G$ and for $X$ a complex algebraic variety on which $G$ operates algebraically, we have

$$
H_{G}^{*}(X)=\lim _{\left(\overleftarrow{V}, V^{\prime}\right)} H^{*}\left(X \times{ }^{G} V^{\prime}\right)
$$

Proof. See [3]
For every $G$-vector bundle $E$ over $X, E \times{ }^{G} V^{\prime} \rightarrow X \times{ }^{G} V^{\prime}$ and $E \times{ }^{G} E G \rightarrow$ $X \times{ }^{G} E G$ are all $G$-vector bundles, so we can define the Chern character $c h^{G}(E) \in H_{G}^{*}(X)$ and $c h^{V}(E) \in H^{*}\left(X \times{ }^{G} V^{\prime}\right)$ by

$$
\operatorname{ch}^{G}(E)=\operatorname{ch}\left(E \times{ }^{G} E G\right)
$$

and

$$
\operatorname{ch}^{V}(E)=\operatorname{ch}\left(E \times{ }^{G} V^{\prime}\right)
$$

We know that under the map $H_{G}^{*}(X) \rightarrow H^{*}\left(X \times{ }^{G} V^{\prime}\right), c h^{G}(E)$ goes to $c h^{V}(E)$.

When $X$ is smooth, then for any $\left(V, V^{\prime}\right)$ in the directed system, $X \times{ }^{G} V^{\prime}$ is smooth. So we can define the cohomological equivariant Todd class $T d^{G}(X)$ to be the element in $H_{G}^{*}(X)$ which maps to $T d\left(X \times{ }^{G} V^{\prime}\right)$ for every $\left(V, V^{\prime}\right)$ in the directed system.

## 4 Equivariant homology

Now for a complex linear reductive algebraic group $G$, by using the constructed directed system, we can define the equivariant homology [5] for a $G$-variety $X$, suppose $\operatorname{dim}_{\mathbb{C}} X=\mathrm{n}$.

$$
H_{i}^{G}(X)=\lim _{\left(V, V^{\prime}\right)} H_{i+2 l-2 g}^{B M}\left(X \times{ }^{G} V^{\prime}\right)
$$

where $l=\operatorname{dim}_{\mathbb{C}} V, g=\operatorname{dim}_{\mathbb{C}} G$.
Remark It is possible that $H_{i}^{G}(X) \neq 0$ for negative $i$.
PROPOSITION 4.1 $H_{*}^{G}(X)$ is independent of $\left(V, V^{\prime}\right)$ if $\operatorname{codim}_{V}\left(V-V^{\prime}\right)$ big enough.
$H_{*}^{G}(X)$ is a module over $H_{G}^{*}(X)$. In other words there is a cap product: $\cap: H_{G}^{*}(X) \otimes H_{*}^{G}(X) \rightarrow H_{*}^{G}(X)$ defined in the following way:

If $\alpha \in H_{G}^{*}(X)$, then for any $\left(V, V^{\prime}\right)$, the image of $\alpha$ under the map $H_{G}^{*}(X) \rightarrow H^{*}\left(X \times{ }^{G} V^{\prime}\right)$ defines a map by cap product: $H_{*}^{B M}\left(X \times{ }^{G} V^{\prime}\right) \rightarrow$ $H_{*}^{B M}\left(X \times{ }^{G} V^{\prime}\right) \rightarrow H_{*}^{G}(X)$. Go over to the direct limit, these maps induce a map from $H_{*}^{G}(X)$ to $H_{*}^{G}(X)$. This gives us the module structure.

For a non-singular variety $X$, we can define the orientation class $[X]_{G} \in$ $H_{2 n}^{G}(X)$ as follows:

For any object $\left(V, V^{\prime}\right)$ in the directed system, $X \times^{G} V^{\prime}$ is non-singular, so we have a class $\left[X \times{ }^{G} V^{\prime}\right] \in H_{2 n+2 l-2 g}^{B M}\left(X \times{ }^{G} V^{\prime}\right),\left\{\left[X \times{ }^{G} V^{\prime}\right]\right\}$ gives the orientation class $[X]_{G}$.

## 5 Equivariant Riemann-Roch Theorem

Now we can define the equivariant Todd class $\tau^{G}$ as follows,
For any equivariant coherent $G$-sheaf $\mathcal{F}$ over $X$ ( $X$ is a complex algebraic variety), if $p: X \times V^{\prime} \rightarrow X$ is the projection, then the pullback sheaf $p^{*} \mathcal{F}$ is a sheaf over $X \times V^{\prime}$, it descents to a coherent sheaf $\mathcal{F}_{V}$ over $X \times{ }^{G} V^{\prime} . \tau\left(\mathcal{F}_{V}\right)$ is in $H_{*}^{B M}\left(X \times{ }^{G} V^{\prime}\right)$, so we get a map $K_{0}^{G}(X) \rightarrow H_{*}^{B M}\left(X \times{ }^{G} V^{\prime}\right)$. Obviously, it is compatible with the transition maps, so we get a map $K_{0}^{G}(X) \rightarrow H_{*}^{G}(X)$, that is $\tau^{G}$.

THEOREM 5.1 (Equivariant Riemann-Roch Theorem) $\tau^{G}$ is the unique natural transformation (with respect to $G$-equivariant proper maps) from $K_{0}^{G}(X)$ to $H_{*}^{G}(X)$, such that for any $G$-variety $X$, we have the following commutative diagram:

$$
\begin{array}{rllll}
K_{G}^{0}(X) & \otimes & K_{0}^{G}(X) & \xrightarrow{\otimes} & K_{0}^{G}(X) \\
& \downarrow & c h^{G} \otimes \tau^{G} & & \downarrow \tau^{G} \\
H_{G}^{*}(X) & \otimes & H_{*}^{G}(X) & \xrightarrow{\cap} & H_{*}^{G}(X)
\end{array}
$$

and if $f: X \rightarrow Y$ is a proper $G$-equivariant algebraic map, then

$$
\begin{array}{rrr}
K_{0}^{G}(X) & \xrightarrow{f_{*}} & K_{0}^{G}(Y) \\
\downarrow \tau^{G} & & \downarrow \tau^{G} \\
H_{*}^{G}(X) & \xrightarrow{f_{*}} & H_{*}^{G}(X)
\end{array}
$$

Furthermore, if $X$ is non-singular, and $\mathcal{O}_{X}$ is the structure sheaf, then

$$
\tau^{G}\left(\mathcal{O}_{X}\right)=T d^{G}(X) \cap[X]_{G}
$$

Proof. In fact, the proof is already encoded in the definition.
From the discussion, we have the following commutative diagram:

where both downarrows are induced by forgetting functors.

## 6 Equivariant Riemann-Roch theorem with value in equivariant Chow group

For linear algebraic group $G$, by using the same directed system, we can define [6]

$$
A_{i}^{G}(X)=\lim _{\rightarrow} A_{i+2 l-2 g}\left(X \times^{G} V^{\prime}\right)
$$

where $l=\operatorname{dim}_{\mathbb{C}} V, g=\operatorname{dim}_{\mathbb{C}} G$.
For the equivariant operational Chow group $A_{G}^{*}(X)$, we define it as

$$
A_{G}^{i}(X)=\lim _{\leftarrow} A^{i}\left(X \times^{G} V^{\prime}\right)
$$

This definition concises with the definition in [6].
As in the previous section, we can define the Chern character, the Todd class and get a theorem similar to Theorem 5.1, except we use $A_{G}^{i}(X) \otimes \mathbb{Q}$ and $A_{*}^{G}(X) \otimes \mathbb{Q}$ to replace $H_{G}^{*}(X)$ and $H_{*}^{G}(X)$.
