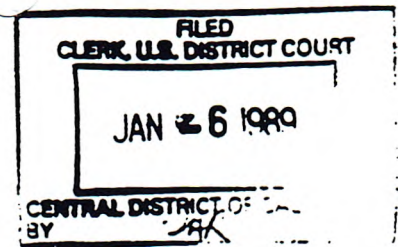

8 Pursuant to the Motion of defendants-counterclaimants  
9 filed on December 12, 1988, defendants-counterclaimants moved  
10 to compel plaintiffs-counterdefendants Vicki J. Aznaran and  
11 Richard N. Aznaran (i) to produce the tape recordings of  
12 their interviews with agents of the Internal Revenue Service  
13 held on or about May 19, 1988 and (ii) to testify in deposition  
14 concerning the interviews.

15 Defendants-counterclaimants' Motion came on regularly for a  
16 noticed hearing at 9:00 a.m. on Friday, January 6, 1989, in  
17 Courtroom "O" of the above-captioned Court, the Honorable  
18 Charles F. Eick, United States Magistrate, presiding.  
19 Defendant-counterclaimant Religious Technology Center appeared  
20 by its counsel Wyman, Bautzer, Kuchel & Silbert, by William T.  
21 Drescher and by its counsel Cooley, Manion, Moore & Jones, P.C.,  
22 by Earle C. Cooley. Defendant Church of Spiritual Technology  
23 appeared by its counsel Cooley, Manion, Moore & Jones, P.C. by  
24 Earle C. Cooley and by its counsel Bowles & Moxon by Kendrick

1 International appeared by its counsel, Boles & Moxon by  
2 Kendrick L. Moxon. No opposing papers were filed and no  
3 appearance was made on behalf of plaintiffs-counterdefendants.  
4 The Court, having reviewed the moving papers, having heard  
5 the arguments of counsel, and having been fully informed,

6 IT IS ORDERED:

7 Defendants-counterclaimants' Motion to Compel is GRANTED.  
8 The discovery sought is relevant and not privileged.  
9 Plaintiffs-counterdefendants are hereby ORDERED to produce the  
10 requested tape recordings to counsel for defendants-  
11 counterclaimants forthwith. Plaintiffs-counterdefendants shall  
12 also make themselves available for the resumption of their  
13 depositions, upon reasonable notice and shall answer questions  
14 concerning the areas set forth in Defendants-counterclaimants'  
15 moving papers.

16 As to Defendants-counterclaimants' request for an award of  
17 attorneys' fees and costs against the Aznarans and their former  
18 counsel, Cummins & White, defendants-counterclaimants shall  
19 submit a declaration as to the amount of fees and costs expended  
20 in preparation of the aforementioned Motion to Compel and shall  
21 notice a hearing to provide plaintiffs-counterdefendants and  
22 their former counsel an opportunity to challenge the  
23 reasonableness of the amount of fees and costs to be awarded to


