(1.) In 1866 I graduated in Medicine and Surgery at the University of Glasgow with Commendation.

(2.) For fourteen years I have taught Midwifery and the Diseases of Women and Children, first at the Western Medical School, and now at Anderson's College Medical School, and for the past ten years my Lectures have been recognized for Graduation by the University.

(3.) Since 1879 I have acted as Dispensary Physician for Diseases of Women at the Western Infirmary.

(4.) After serving for eight years as Obstetric Physician and Lecturer on Clinical Obstetrics at the Glasgow Maternity Hospital, I was appointed one of the Consulting Physicians in November, 1891.

(5.) I have for seven years been an Examiner in Midwifery and the Diseases of Women for the Triple Qualification of the Royal College of Physicians, Edinburgh; the Royal College of Surgeons, Edinburgh; and the Faculty of Physicians and Surgeons, Glasgow; as well as for the Fellowship of the last mentioned body.
