

***DIPLACUS BICOLOR*, CORRECT NAME IN THE GENUS *DIPLACUS*  
FOR *MIMULUS WHITNEYI* (PHRYMACEAE)**

**ABSTRACT**

***Diplacus bicolor* (A. Gray) Hrusa, comb. nov.**, is the correct name in *Diplacus* for *Mimulus whitneyi* A. Gray, 1886, a nomen novum based on *Eunamus bicolor* A. Gray, 1868.

Review of a draft version of the *Diplacus* treatment for Volume 17 of *Flora of North America North of Mexico* revealed that the listed combination *Diplacus whitneyi* (A. Gray) G.L. Nesom (*Phytoneuron* 39: 29. 2012), based on *Mimulus whitneyi* A. Gray (*Syn. Fl. N. Amer.* ed. 2, 2(1): suppl. 445. 1886), has an earlier epithet available.

In the protologue for *Mimulus whitneyi* Asa Gray cited as a synonym the legitimate *Eunamus bicolor* A. Gray, *Proc. Am. Acad.* 7: 381. 1868. The new epithet ‘*whitneyi*’ was proposed due to the existing name *Mimulus bicolor* Hartw. ex Benth. (*Pl. Hartwegianae* 328. 1849; = *Erythranthe bicolor* (Hartw. ex Benth.) G.L. Nesom & N.S. Fraga, *Phytoneuron* 39: 36. 2012). As there is no impediment to use of the epithet ‘*bicolor*’ at specific rank in *Diplacus*, the combination *Diplacus whitneyi* is superfluous (ICN Art. 52.2). The resulting absence of a legitimate name for *Eunamus bicolor* in the genus *Diplacus* is rectified with the following new combination.
