COMMENT ON THE PROPOSED ALTERATION OF THE SPELLING OF GRACILLARIA HAWORTH, 1828. Z.N.(S.) 1757

We are opposed to the proposal which would alter the original spelling of *Gracillaria* Haworth, 1828.

Paragraph 1 of the proposal by Zimmermann and Riley contends that Haworth mis-spelled the word. There is no evidence for this. Haworth consistently used Gracillaria with a double "1" six times in the text and once in the Index. The Proposers attribute the mis-spelling to incorrect latinisation of the word. Article 32a(ii) of the Code specifically states that improper latinisation is not to be considered as an inadvertent error, and the original spelling of the name is to be retained.

In paragraph 2, referring to Zeller's alteration of the spelling, the Proposers say "Zeller emended the spelling without specifically stating that he was so doing". Zeller's alteration must therefore be treated under Article 33 as an incorrect subsequent spelling, since he made no conment. By contending that Zeller "emended" the spelling, the Proposers are introducing the requirements of the Code. In paragraph 2 the Proposers reiterate the incorrect latinisation, which is unacceptable under the

Code.

Paragraph 3 of the proposals states "Considerable confusion exists in the literature because of the variant spellings of this generic and family-group name". This is an exaggeration of the position. There exist two spellings of the genus and family name, one with a single "1", one with a double "1". No confusion has arisen as to what was intended with either spelling. The original spelling has been retained by about as many workers as have used the altered version. For example, Curtis 1833, Duponchel 1835, Bainbrigge-Fletcher 1929, Kloet & Hincks 1945, Vari 1961, have used Gracillaria while Zeller 1839, Stainton 1854, Meyrick 1895, Staudinger 1901, Forbes 1923, have used Gracillaria.

We ask the Commission:

(1) to reject the proposal to alter the original spelling of Gracillaria Haworth, 1828,

(2) to place the generic name Gracillaria Haworth, 1828, type-species by subsequent designation, anastomosis Haworth, 1828, on the Official List of Generic Names in Zoology.

(3) to place the family-group name GRACILARIIDAE Stainton, 1854 (an incorrect original spelling for GRACILLARIIDAE) on the Official Index of Rejected and

Invalid Family-Group Names in Zoology.

(4) to place the family-group name GRACILLARIDAE Stainton, 1854 (type-genus Gracillaria Haworth, 1828) on the Official List of Family-Group Names in Zoology.
