The Booth Coat of Arms.

Upon the opposite page, appears a fac-simile of the coat of arms or ensign armorist of the Ancient Booth Family, borne by the family for upwards of seven hundred years- The Lion, denoting loyalty, and the Wild Boar's Head, denoting bravery, are the oldest crests known in England. They show the antiquity of the family adopting them, also its dignity, rank and near relationship to the reigning sovereign, as well as the family's reputation for undaunted courage. The shield is a modification of the Norman shield, denoting the intermingling of the noble Norman blood with the native Briton by intermarriage of races. The device as shown, is copied from that preserved in the Booth Family by Lady Mary, Countess Dowager of Stamford, only daughter of Sir George Booth, third Lord Delamere and second Earl of Harrington, in whose possession the principal documents relating to the early history of the Booth Family were in 1771. The family motto "Quod Ero Spero," literally translated means. "What I shall be I hope," liberally rendered it signifies. "What I hope to accomplish I shall accomplish," or in other words. "Hope, Perseverance, Success." This motto typifies the character that marks the race. Illustrious examples of which have developed all along the line to the present day.

In this genealogy it has been our design to follow the direct line of descent only, (except in the last five generations which are very nearly complete to date,) and no effort has been made to search for data on collateral lines. Possibly mistakes have been made in dates, for records could not be found in all instances, but of the correctness of the line from Robert Booth of Exeter, N. H. and Saco, Me., we are confident.

The Booth Genealogy.

Adam DeBoothes came over to England with William the Conquerer in 1066. His descendents were:—

William, m. Sybil Brereton.

Thomas, son and heir of William.

Robert, m. in the Barton family of Lancashire.

Thomas of Barton, Knight, m. dau. of Thomas de Workesly.

John, son and heir of Sir Thomas, was styled John of Barton and bore as his paternal arms the ancient Booth device viz. three boar's heads; m. 1st. Joan, dau. of Sir Henry Trafford, 2nd., Maude, dau. of Sir Clifton Savage; had 19 children.

Robert, m. Dulcis, dau. of Sir William Venables, had 14 children; died in 1450.

Sir William, m. Maude, dau. of Joseph Dutton; had 14 children died in 1478.

Sir George, m. Catherine; dau. of Robert Montford. The Montfords were of noble connection, being related to David King of Scotland. Sir George died, leaving three sons and two daughters.

Sir William was twice married and had 10 children; died Nov. 19, 1519, and was buried at Bowden.

Sir George m. Elizabeth Butler; had 11 children; died in 1531, aged 40.

Sir George, born in 1515, died in 1544 was twice married and left 4 children.

Sir William was but three years old when his father died m. Elizabeth, dau. of Sir John Warburton; died in Sept. 1579; had 13 children.

George, born in 1557, was the first Lord Delamere, was committed to the Tower; tried for high treason and unanimously acquitted by a court of 27 Peers. He was made Privy Counsellor, Chancellor of the Exchequer and was created Earl of

Warrington. He had 17 children, one of whom was Richard (baptized, 1578, and died in 1628) the fifth son, from whom the first Booths of America are descended.

His three sons—Robert, Richard and John landed at New Haven, Conn., in 1639.

Richard settled in Stratford, Conn.; John in Southold, Long Island, while Robert went north.

Robert Booth first appears on a petition to the General Court in 1645 as a resident of Exeter N. H. but he was made a freeman as a citizen of Saco, Me. in July 1653 and was commissioned as a magistrate and authorized to preach in the absence of a minister in that town. He was a man of note in those days and was chosen town clerk of Saco for several years. He was also coroner, selectman in 1653 and was the first representative from Saco to the General Court in Boston from 1659-70. He had a tide mill on the Saco River and died in Saco in 1672, aged 68 yrs. He was twice married his last wife surviving him and marrying Thomas Ladbrook of Portsmouth N. H.

Charles Franklin (9), son of Mary Wilder (8), a young man of excellent character, found employment when a youth in the woolen mills at Enfield, N. H., and enlisted from there in 1861. He served through the Civil War without losing a day and, returning at the close of the war, resumed his former work. He remained at Enfield, N. H. until about 1871, when he accepted a position with the Northern Railroad and was killed by the cars in the fall of 1875, dying unmarried.

Samuel Slader (8), son of Mason (7), settled in Norwich, Vt., about 1841, and engaged in the manufacture of ladies' fine shoes, later in the merchantile business; in 1850 went to California by the overland route in pursuit of gold but returned in 1851, owing to poor health in 1854 he engaged in the lumber business, which he followed until 1879, when he retired from active business life. He was a respected citizen of the town, taking an active interest in its affairs; m. Apr. 3, 1845, Mary A. St. Clair who was b. Dec. 12, 1824 and d. Apr. 5, 1903 ^{70. mo.} ₇₈₋₃₋ He died in Norwich, Vt., July 14, 1886; she died in Malden, Mass. They are both buried in the family lot at Randolph, Vt.
