"TRIMMING THE SAILS."

Our ship has recently sustained a great loss through the resignation from office of several members of its crew. Chief in importance is that of Mr. C. H. Edmonds, who has for years rendered magnificent service to the movement. As Honorary Secretary of the B.E.A., and Editor of "International Language," he has been a tremendous force, and we shall miss his help in many ways. (With him have resigned office Messrs. H. Boll, F. R. Shelton, G. T. Smith, and F. E. Wadham.

The immediate cause for these resignations will be seen in the correspondence which follows in this number. I felt it my duty to do all I could to bring the whole of the officers into agreement as quickly as possible. That I failed to do so must be attributed to the fact that when an immovable body meets with an irresistible force, one arrives at a deadlock. One cannot go forward on the same course. The only alternative is to circumvent the difficulty by adopting other methods. I at once sought the assistance of other members to enable the work of the B.E.A. to be carried on with as little inconvenience as possible. The task of doing this was rendered even more arduous by the previous resignation of Mr. H. A. Epton, the Business Manager, who is to be congratulated upon obtaining a more promising position in the commercial world, and by the temporary illness of our secretary.

It was a critical moment in the life of our Association. The seas were running high, and

the wind was blowing a gale against us. The sails had to be trimmed, or the ship would have been driven a wreck on the rocks. I appealed with success for immediate assistance. Mr. R. Robertson agreed to undertake the work of the Hon. Secretary. Mr. L. N. Newell, with the co-operation of his younger brother, Mr. F. M. Newell, as his assistant, has consented to be responsible for the editorship of "International Language." Mr. W. H. Matthews will manage the Radio section, and other gentlemen have taken on their shoulders further duties in connection with various committees. It may be necessary to reduce speed for a time, but rest assured we shall "carry on," and although the voyage may be a little prolonged, we shall steer our beloved vessel safely into port.

Mr. Edmonds and his friends have not left the movement. They are as enthusiastic as ever in wishing Esperanto God-speed, and will continue their good work, but it will be, at least for a time, in other ways. We stand at the beginning of a New Year. The world is undoubtedly awakening at long last from its apathy to our call. We have every reason to feel that our movement is nearing a great triumph. To a great extent that triumph will rest upon your personal efforts. I therefore beg that you will, each one of you, strain every nerve to give us the full benefit of your support in 1926. May the year be rich in blessings for you all. May Esperanto flourish and prosper, and may concord and harmony reign in all our undertakings.

Report on Special General Meeting held at the Offices of the Association on Friday, 20th Nov., 1925.

Twenty-two members entitled to vote were present. The Meeting elected Mr. Robert Robertson to the Chair. The Special Resolution before the meeting for consideration was as follows:—

"That in Article XIII of the Articles of Association the word 'Chairman' be inserted after the word 'Vice-Presidents,' and that subject to this alteration coming into effect, Mr. Charles Herbert Edmonds be hereby appointed to fill the office of Chairman until the next Annual Election of Officers of the Association."

Proxies were called for, and Mr. J. H. Fitton produced 60 proxies in due form, which were read and found to be in order.

The Hon. Secretary, Mr. C. H. Edmonds, read the following letters:—

(1) *From the President to the Secretary:* (Dated, 7/11/25).

"I enclose a letter from the Secretary of the Scottish Esperanto Federation which I should like you to read to the members who attend the Special General Meeting which has been called to pass the suggested alteration of rule respecting the officers of the B.E.A."

This letter arises out of an enquiry which I received asking me to explain why it was proposed to create a new position of Chairman, and to which I replied at some length, giving the reasons which were stated in the discussion which took place at the Council Meeting which accepted my proposition.

I have had considerable correspondence from different parts of the country, all showing the same tendency, namely, that the creation of a new office is undesirable, but stating that, in deference to myself, they did not intend to take formal objection to the same. Some few have definitely stated, however, that they will oppose the motion at the Annual General Meeting if the proposal is maintained.

I think it is only fair to mention these things to the meeting, although, as most of the letters have been written to me in confidence, I cannot send them on for the meeting to read."

(2) *From the Hon. Secretary of the Scottish Esperanto Federation to the President.* Dated 5/11/25

"With further reference to your letter of 8th October, replying to my enquiry *re* the significance of the proposed new appointment of a "Chairman of the Association"; the next meeting of the Council of the Scottish Esperanto Federation does not take place until January, but I have shown your reply to several members of the Federation, and from the opinions expressed by them I feel sure the Federation will not be able to accept the reasons given as sufficient to warrant this new appointment. I suggest that, under the circumstances, it would be wise to hold up this proposal for the present."

(3) *From the Hon. Secretary of the Yorkshire Esperanto Federation to the Secretary.* (Dated 17/11/25.)

"At the Quarterly Meeting of the above Federation in Huddersfield on Saturday, 14th November, 1925, I was instructed to forward to you the following resolution which was passed:—

"That the Yorkshire Esperanto Federation and B.E.A. Members who are present at this meeting, 14/11/25, strongly protest against the manner in which the Special Resolution—that in Article XIII., of the Articles of Association the word Chairman be inserted after the word Vice-Presidents, and that, subject to this alteration coming into effect, Mr. Charles Herbert Edmonds be hereby appointed to fill the office of Chairman, until the next Annual Election of Officers of the Association—is being dealt with, and that in any case there is no necessity to deal with it until the

Annual Meeting of the B.E.A., at Whitsuntide, 1926. Therefore the Yorkshire Federation, and Members of the B.E.A. who are present, beg the B.E.A. Council to postpone the consideration of the whole matter until Whitsuntide, 1926, at the Annual Meeting of the B.E.A."

(4) *Mr. Edmonds then read the following two letters from himself to the President.* Dated 10/11/25.

"Your letter of the 7th instant to the Secretary enclosing letter from Miss Agnes Macfarlane, indicated perfectly clearly to me that there is an important body of objectors who severally, and, as far as I know collectively, are determined not to allow me to assume the office of Chairman of B.E.A. Meanwhile, they and you have offered no other means or suggestion of means as to any manner in which I can retain my position in the Association, and at the same time reduce the enormous and always increasing bulk of detail work which I find it already impossible to carry on.

I made it perfectly clear to you at the outset that that is the sole reason for any change in my personal status. It is impossible for me to do a mass of clerical work and supervise all the activities of the Association at the same time. I think by now I have proved my ability not only to supervise, but also to produce a sufficiency of new and valuable ideas to justify me in claiming that in supervision and not in clerical work lies my proper sphere.

Having arrived at that conclusion I appealed to the Association, through you, to be relieved of the inevitable drudgery that has more and more during the recent months oppressed me beyond all proper measure.

I must also recall to you that at the end of the half-year, when I discovered the danger of a more than ever serious deficit in the Balance Sheet, I explained to you that had I been able to devote sufficient time to supervision that deficit would in all probability have been avoided. Further, I explained to you at the time the desirability of training some person or persons in the work upon which I have spent myself hitherto, in order that if at any time I found it necessary for any reason to give up that work the Association would not be left without adequate personnel.

But in the discussions by letter and otherwise that have taken place since the idea of a Chairman was first mooted, no single constructive idea has been opposed to that, and I am left with the feeling that the attitude of the objectors is simply one of personal antagonism. This leaves me only one course to take, and that I am taking. This is to give you notice that I resign all my offices in the Association, and my last official act will be the issue of the December number of *International Language*. You must please accept it as definite and final that this decision is irrevocable, and that I shall not be prepared at any future date to resume any activities for the B.E.A. in its present form."

(5) Dated 17/11/25.

"I duly received your letter of the 18th instant in which you ask me to withhold my resignation until after the Special General Meeting, on the 20th instant, and to stand by the decision of that meeting, and beg to inform you that I cannot see my way to depart from the decision already advised you. Please regard the last sentence of my letter to you of the 10th instant as my final word on the subject.

In the circumstances I propose to read to the Special General Meeting on the 20th instant your letter to the Secretary of the 7th instant, and the letter from Miss Agnes Macfarlane, referred to therein, together with my letter to you of the 10th instant, leaving the meeting to take what action it sees fit with regard to the Special Resolution put forward by the Council on your proposal.

Perhaps in the meantime you will be good enough to take active steps to relieve me of my responsibilities,

which I cannot continue to assume after publication of the December number of 'International Language'."

Mr. Edmonds added that he had nothing further to remark on the subject of the meeting, which he then left, with four other members, and there being no longer a quorum the proceedings closed.

A recitation was given by Mrs. Elliott from New Zealand, and songs were given by the Misses Nellie Hallam and Josie Malone, from the National Opera Company; Mr. Harrison Hill, and Mr. H. Moy Thomas.
