Point of View --- It's a Bad Idea, Now or Anytime

Last month a motion was made and passed by a relatively large group of members which would eliminate monthly meetings for CATS, save for quarterly catch-ups. One of the members stated emphatically he does not like to sit through boring meetings, and enough support was garnered to cancel all but two or three business sessions the rest of this calendar year. The same member declared that to him the most important thing is the group's informal bull sessions each month. "Business" is therefore secondary and dispensible. A reality check will show that the CATS Bylaws clearly call for monthly business meetings, among other regularly scheduled happenings. A serious deviation such as this requires that an amendment to the Bylaws be proposed, published in the newsletter, and affirmed or denied a month later. So the motion passed month has no actual standing until it follows that path. Nor should it. CATS often has significant business to transact, much of it unpredictable as to when it will occur and what it will contain. No provision was made for this in last month's motion. If business meetings currently last too long, that is the joint responsibility of the management (President) and the membership. It is not necessary to hear what everybody thinks about everything all the time before doing anything. A more practical approach would be to limit such meetings to 30 or, at most, 45 minutes. What doesn't get covered can be carried over to the next month. Conversely, if there are no significant matters on the docket,

the President always has the option

of dispensing with a business meeting altogether. For while some members may chafe at the thought of sitting through parliamentary gyrations (rare though they may be), there are many more who expect a kind of structure and substance from CATS that exceeds endless, aimless bull sessions. We have made arrangements with the library system to have the use of the conference room at New Carrollton library from noon onwards, just for the purpose of faciltating informal interchange. In fact, we have been told we can have the use of the room at 11 a.m. if we want it, or even 10 a.m., for that matter. Last calender year, with the same arrangements, nobody ever showed up before noon. Travel considerations of course entered into this, but the point remains that the bull sessions were largely unattended at the early times, even though the room was available. So now the bull-throwers want to jettison the CATS business meetings? That would be a giant step on the path to degradation --- and the eventual extermination of CATS. No longer will CATS be an organization with a purpose and a modicum of organizational stability. It will simply be an unannounced, random gathering of people without a purpose, becoming incrementally more unattractive as time goes by. It should be imperative that the hard core of CATS enthusiasts consider realistically the consequences of what is being proposed. For to follow that path would accellerate dramatically the certain demise of CATS as we know C.H.D.


