CATS' CONSTITUTION
Amended 05/04/91 (non-member n/l subscriptions)
Amendment 07/10/93 (streamlining)

ARTICLE ONE: Name of organization

This constitution creates an organization to be known as the Capital Area Timex/Sinclair Users Group (CATS.) CATS shall be a voluntary, not for profit organization.

ARTICLE TWO: Purpose

Section One: General

The purpose of CATS shall be to create and maintain a spirit of helpfulness among owners and users of the Timex/Sinclair (T/S) family of computers, and to educate the membership in the uses and applications of these computers.

Section Two: Newsletter

CATS shall publish a newsletter monthly, or otherwise as the Users Group shall direct, to record the activities of CATS, to announce events of interest to the membership, and to exchange ideas concerning T/S computer matters.

Section Three: Miscellaneous

CATS shall serve as a clearinghouse for information on the T/S family of computers. It shall act as a group to make discount purchases. CATS does not assume any obligation to intervene on behalf of any member or other person in connection with any legal proceeding.

ARTICLE THREE: Meetings

Section One: General

Meeting shall be held on the second Saturday of each month or as the Users Group may direct. Organizational business may be transacted at any meeting at which a quorum (see Article Three Section Four) is present. The meetings may be conducted informally unless Robert's Rules of Order Revised is invoked by a majority of those present.

Section Two: Annual

A meeting shall be held each year in conjunction with the June general meeting for the purpose of electing officers.

Section Three: Quorum

A quorum for the general and the annual meetings shall consist of five members IN ATTENDANCE OF WHICH AT LEAST ONE MUST BE AN ELECTED OFFICIAL OF CATS.

ARTICLE FOUR: Officers and the newsletter editor

Section One: Officers

The officers of CATS shall consist of a Chairperson, a Vice-Chairperson, a Recording Secretary, a Corresponding Secretary, and a Treasurer. All officers shall be members of CATS and shall serve without compensation.

Section Two: Newsletter editor

A newsletter editor who shall be a member of CATS, shall be appointed by the President and approved by a majority at a general meeting.

ARTICLE FIVE: Duties of officers

Section One: Chairperson

The Chairperson shall preside at all meetings described in Article Three, shall appoint and abolish temporary committees.

The Chairperson shall appoint a replacement for any officer of the Users Group.

Section Two: Vice-Chairperson

The Vice Chairperson shall preside at meetings in the absence of the Chairperson.

Section Three: Recording Secretary

The Recording Secretary shall keep a written record of all meetings described in Article Three.

Section Four: Treasurer

The Treasurer shall receive and disburse all monies belonging to CATS and shall represent CATS to the general public. No extraordinary expenditure shall be made by the Treasurer without the approval of the Users Group (see Article Eight Section One.) The Treasurer shall keep an accurate record of general organization accounts and shall report on the state of the finance of CATS at the general meetings. On the expiration of the term of office of the Treasurer all monies, accounts, records, and receipts shall be turned over to the incoming Treasurer.

Section Five: Corresponding Secretary

The Corresponding Secretary shall be responsible for receiving mail directed to CATS. The Corresponding Secretary shall be responsible either for answering the mail, if it is general in nature, or for routing to an appropriate member for a response and/or action. The corresponding secretary shall be responsible for reviewing significant transactions with the membership, either through the newsletter or at general meetings.

ARTICLE SIX: Election of officers

Section One: Term of Office

The Chairperson, Vice Chairperson, and Recording Secretary shall be pro-tem positions, and shall serve for one month. The term of office for all other officers of the Users Group shall be one year. All terms shall COMMENCE AT THE CLOSE OF THE MEETING at which they were chosen.

Section Two: Nominations

Nominations for the pro-tem positions will be generated each month. Nominations for the yearly positions shall be made at the June general meeting.

Section Three: Elections

The presiding Chairperson shall conduct the election.

ARTICLE SEVEN: Membership, dues, and newsletter subscriptions

Section One: Membership

A Membership in CATS shall last for twelve months and shall include a newsletter subscription. A membership may include an entire family, but it entitles the family to only one vote.

Section Two: Dues

Dues shall be determined by a majority vote of the membership at a general meeting.

Section Three: Non-Member newsletter subscription

A Non-Member newsletter subscription shall be available for a twelve month period. Its rate shall be determined by the Users Group.

ARTICLE EIGHT: Finances

Section One: Obligations

Authority for the payment of bills shall be made by the Users Group at general meetings.

Section Two: Authorized signatures

CATS' checks shall be signed only by the Treasurer or Corresponding Secretary.

Section Three: Audit

An audit of all CATS' financial records shall be conducted immediately following the closing of the Treasurer's term of office and shall be presented to the membership at the next general meeting. The Audit shall be conducted by two members of CATS. They shall be appointed by the Chairperson.

Section Four: Projects

Official projects shall be approved by the Users Group. Monies from all official projects of CATS shall be routed through the Treasurer. No Property of CATS shall be disposed of without a majority vote of the membership at a general meeting.

ARTICLE NINE: Standards of conduct

It is the policy of CATS that software piracy and theft of intellectual property are incompatible with its goals.

ARTICLE TEN: Amendments

This constitution may be amended by raising the issue from the floor at any general meeting. The proposal shall be printed in the newsletter and presented at the next general meeting. A two thirds (2/3) vote of the membership present shall be required to approve the proposed amendment. The final version shall be printed in the next newsletter.

Russians to Get E-Mail

From the National Science Foundation

A simple communications link with the outside world is proving to be one of the most valuable resources any scientist in the former Soviet Union (FSU) can have.

Through *e-mail*, a scientist can contact international counterparts, compare data, collaborate on publications, arrange to attend conferences, locate funding for continued research, and access hundreds of databases through the *Internet*, which is due in Moscow later this year.

E-mail is the most cost-effective, rapid, and reliable avenue to and from the FSU. All users need is a PC, a modem, an affordable *e-mail* account, and access to a telephone line---an outlay of about \$2,000 for the first year.

The most popular word processing program in the FSU is Lexicon, which can be utilized on most US-oriented PC's, though it cannot be used yet on the German QL's. Lexicon supports both English and Cyrillic characters and has a help menu in both languages for novice users.

Most obstacles to implementing *e-mail* systems in the FSU have not been technical, as most westerners might expect. Rather, computer-user-phobia is the most common problem: potential users are afraid to touch the computer, and have the misconception that all computer users are geniuses.

This all lasts about as long as it takes the potential user to send and receive the first on-line message as the direct result of pushing buttons on the keyboard in the correct, logical sequence. After having accomplished this, the users rightfully become certified experts in their own eyes!

Sarah Fisher on the Internet

Sarah Fisher gave a superb presentation on the *Internet* to July's overflow gathering of CATS enthusiasts.

Fortunately enough for everybody, all of **Sarah's** supporting pieces fell neatly into place at the appointed time. First and foremost, the telephone jack in the main meeting room was---for the fifth month in a row---unexplainably "live". One-hundred feet of RX-11 telephone cord was quickly produced, and the jack was linked to **Herb Schaff's** QL/modem in the small meeting room.

The Kodak Datashow, which was cleverly reconstructed by **Herb**, worked flawlessly as it grabbed the screen from **Herb's** QL and projected it onto a library wall. Then **Herb** and **Duane Parker** fiddled with Q Link until **Sarah** was able to dial up the College Park Campus of the University of Maryland, precisely at 2 p.m.

Sarah sketched some of the background of the *Internet*, which was born in 1969 as a Pentagon experiment to help researchers trade information. It is today a loose confederation of 1.5 million users linked by about 12,000 large and small networks. Costs of running it seem to be borne happily so far by large organizations and institutions, such as the National Science Foundation.

The growth of the Internet has not been logical or rational, but as **Sarah** says, rather chaotic. Still, it holds a fatal fascination for a certain breed of computer hacker, though others have certainly made good use of it, as was the original intent.

Large library systems are generally on the *Internet* bandwagon already. Besides providing network services of their own, libraries can act as a gateway to the *Internet*.

Sarah brought up a screen for the "Puppy Project", which is part of the Seymour System. The Seymour System is an ambitious undertaking in Maryland which, by 1997, should have all libraries in the state on a fiber-optic information network.

Several screens were explored by the group, the most popular of which was "Search the *Internet*".

Sarah produced a handout of how to dial into the UM/CP system from home. There are no security restrictions and there is no cost to connect, save a local phone call. All you need is a QL rigged up with a modem.

Sarah commented that the proposed Maryland information network may seem to be start-of-the-art to many, but she has observed at national librarians' meetings that there are almost a dozen other states (none of them large) that seem to be exponentially ahead of us.

An acid test of the acceptance of the Seymour System could conceivably be the day when **Bob Diggs** goes to the Cecil County Library, sits down at an emulation of a VT-100 terminal, and accesses the files of---or sends a message to---a ham radio enthusiast in a suburb of Moscow! All free!!

MONEY and MODEMS

The convergence of computer and communications technology offer investment prospects. Could keep you away from IBM's at their tops. There are mutual stock funds, open and closed-end types, that specialize and invest only in telecom or computer tech stocks. Even I entered into computer stocks once -- lost my shirt. So beware.

In the U.S.A we have one telephone per each two people. In the emerging and third world countries they have one per more than ten people. As telecom systems are utilities with monopoly status coupled with the growth room available in growing economies they are popular in Wall Street as growth investments.

In the U.S.A. we have giant AT&T, Motorola, Tel-Communications, Intel, Microsoft, National Semiconductor, Texas Instruments, McCaw Cellular, Qualcomm, Cellular Vision, etc., and of course all the regional Bells. AT&T is selling its services overseas to upgrade telephone services and infrastructures, in China and SE Asia. Motorola has a joint venture going with Japanese firms to explore cellular comm using satellite relays. Then there are the 'baby' Bells who recently proposed a \$125 Billion project to build the 'Info Roads' to the future if the Feds give them cable TV rights. Of course the Cable boys are committing themselves to a multi-billion dollar project to also upgrade and expand their charters to fiber.

At present highway patrolmen can scan your fingerprint, radio it to HQ'ers, which searches FBI files and sends the results to the patrolmen in a few minutes. Don't get caught speeding as they will get a bead on you in no time.

If investing turns you on get involved with 'Cyberspace' -- an electronic world thriving with a dizzying array of financial

information services. On-line you trade stocks and bonds, read an abbreviated version of the Money section of USA Today for free, download historical stock quotes or capture them in 'real time' from a radio signal. You can also find what's called 'Shareware' software programs -- where you pay for the program if you keep it -- to spot bull or bear markets or chart price trends.

About 20% of the members of the Association of Individual Investors (AII) say they used electronic brokers last year -- a 102% increase over 1991. And 50% of its members, in 1991, tapped into on-line financial services. Maybe CATS can join the AII, use its on-line info to dump their info into our bulletin board where each of us interested can tap it as desired. Then there is the Dow Jones News/Retrieval and Compuserve services for a fee which I explored a score years ago and decided it was to costly for me.

So your modem for now can give you access to much beyond your personal data bank. On top of it all you can buy into other data banks for a fee.

Of course there is the mysterious 'Internet Network' -- black market underground data banks? Or is it a free source of oodles of info if you know how to tap it? We heard from one of our members on this subject last month. Should we hear more?

Next time I want to tackle the subject of digital communication.

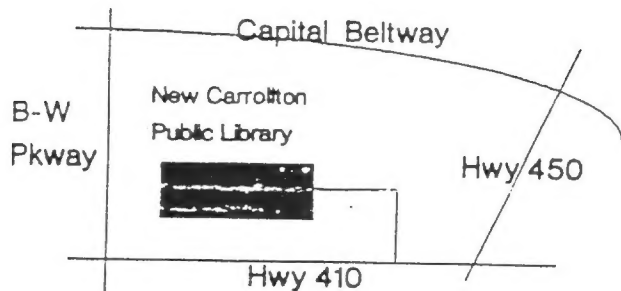
