Part of the drive was MS Dos and the rest of the disk was QDOS with Abacus, Easel and Quill files! Believe me when I say things run better on a hard drive than on two floppies. Using a virtual drive, Dos commands, files, or programs can be stored there. Then, using an auto batch file, data from the virtual drive can go back to the source automatically and prevent any loss from using the ram disc.

# DIGITAL VS ANALOG

Early as a Sea-Scout and latter as a midshipman I learnt digital -- the morse code. Dit-dah, yea-nay, 0 or 1, precursors to machine code?

In those days of the computer the IBM'ers were pondering as to whether to develop their machines along digital or analog lines. Just recently the far-ahead Japanese lunged toward high resolution TV (HRTV) development via the analog route. A U.S.A. consortium pushing digital imagery claims cheaper and better images with digital technology. As far as I can tell over these forty years the game is over -- digital communication, for whatever purpose, for audio or video, is in, is basic, is fundamental to the decision process of the human brain.

Digital means on-off, yes-no, up-down, good-bad, and so on. These fences zero-in on a target eventually and computer chips are being made to do the zeroing-in at light speed and cheaply as compared to what is going on in the analog camp. The future is digital in language. Your Sinclair unit speaks this language. You, we, have an interpreter - don't sell it short. My forty years wait has ended.

From what I have said previously the laws of economics favor digital solutions, that is chips, for all the varied uses electronic communications will lead us into.

From my life-long observations I would venture that our most complex sense, that of sight communicates to the brain in bits which can define colors, structure, forms, etc. It is thus not surprising that we can transmit video imagery by digital code and in very high resolution at that.

I would like to say I can say I know some about analog systems, but I don't. I am willing to be tutored on this. For now, as in the past I saw the analog communication as one attempting to simulate as closely as possible what it is put to define and transmit.

The new battle in communications and

computing is now what's the best medium to transmit through to interface outside of one's station and that one can afford. For now the wire is ahead, because its already in place and has been paid for. But for new or reworked installations there are two alternatives - as mentioned previously, fiber optic cable and wireless transmissions at revolutionary frequencies and bandwidths used by the latest cellular phone industry.

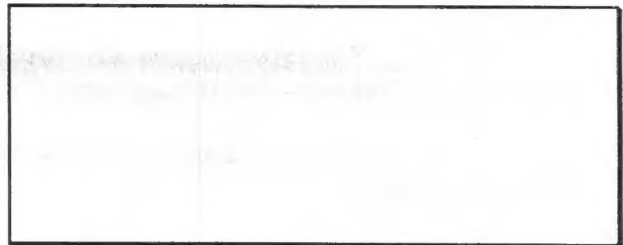

Meanwhile the big boys will be making bids, sales pitches, and proposals to capture as much market share of information consumers they can get. And making many flashy claims that could lead some to go broke in short order.

CATS has its own Marconi -- Bob Diggs, and if he understands and can relate to what I have said so far he should be able to give us insight on the prospects of wireless communication with computer systems. If you remember some years ago he gave a demonstration of interacting his QL with broadcasted transmissions. I am sorry I don't remember the details.

For those of you that keep tabs on converging technology and the players therein you should of recently noticed the AT&T merger with McCaw Cellular (wireless phone service). That merger has the Baby Bells upset and is AT&T's announcement its betting on microwave telecom in the immediate future. Its a big market is Asia, which is ready to leap-frog the wire and cable (?) route to spread communications, video, and computering.
