Computer viruses-a true story About a month ago, I finally received a W-P program that had been upgraded. I then looked at the data folders in the rest of the programs on my hard disk and found the same thing! Only one

Could the software people be mistaken about the contageousness of the virus? Could this have been caused by somthing else? I don't know; however, it has given me an increased insight on this computer problem. Now before I put a program, even commercial ones, on my disk, I check each disk with a virus killer. "If not by the date of the meeting, then we certainly will have them in members' homes in time for holiday tinkering," Tom stated.


While the initial surge of orders from the members went out the middle of November, Tom says that individuals can still take advantage of the terms of the offer. He emphasizes that this is a bare

from where I sit

Several months ago, I suggested that we start a series on how we used our computers. At the time I thought that it would be interesting to see the QL in a wide variety of settings. Who knows, it might have contained the spark that caused another person to say, "Hey, I need to do that too". Well the response has been UNDERWHELMING. I guess that it was predictable, seeing that my previous requests have met similar fates. Well, if you thought that silence would make the topic go away, you're WRONG.

Like many QL owners, I own more than one machine. In fact, I own four. Two are out of service for a variety of reasons-mainly due to the fact that I can never find the time to repair them--and the other two are in active service. I use one at home to work up some of the files that I use for the newsletter. The second is at work and really does "work". Since I got wrapped up in the Atari, my home machine has gotten less use; however, that is not to say that it is any less important now than before. You just have to use the Atari for a while to understand that statement. Oh, yes. I agree that using a mouse is really neat and that the way the desktop/ directories are portrayed makes everything clearer, but, if I just want to "plain vanilla" compute, the QL is my choice. My home rig is real garden variety QL, Trump Card, and a NEC P2200 and Avatex 1200hc modem, both of which are shared with the Atari. I use Taskmaster at home and work and, for my money, it is the best multitasking front end going. Playing off against the QL is my Atari setup, Mega4 ST, monochrome and color monitors. and 100MB hard disk. Yet I still use my QL. Why? I don't think there is a more simple or user-friendly word/document processing program

than "Quill" so, when I have to send off a quick letter to someone, I fire up the QL. The same goes for the "Abacus" spreadsheet. I've developed a program that lets me track my investments that I run every day, so I just switch over from Ouill to Abacus and I'm on my way. It is simple and many of the operations which are almost effortless on the QL require complicated "macros" in 1-2-3. I have a series of prompts using the ASKN and ASKT functions and they are a snap to set up. I've got a Lotus 1-2-3 clone on the Atari but if you've wrestled with the Lotus instruction set you would know that I could almost be through an application on a QL before the Atari program got set up. What's more, all my Atari W-P programs stink. There's no nicer word for the gyrations you have to go through to get decent output. That about covers my home usage, so what about at the office?

At work my setup includes a Sandy 512K SuperQ board (with inoperative mouse port), a NEC P5300, and an Epson HI80 plotter. As far as I'm concerned, this is my workstation of choice. I really do have a choice since just across the hall and dedicated to me, if I want, is an IBM PC/XT (upgraded to a 386), 80MB hard drive, Epson FX286 printer, and a Hewlett-Packard scanner. This equipment lies idle while I merrily bang away on my QL doing office correspondence, reports, spreadsheets for tracking month-to-month budget expenditures, and graphs for various reports. Since I am responsible for building the budget, a once a year one month marathon, and the monthly tracking of our department's expenses, I use Abacus quite often. Once a month I prepare a summary of data extracted from the company generated budget reports and at this time I really give

the QL a workout. I use Abacus to prepare the spreadsheets which. incidentially, use all 256 rows! After the spreadsheets are generated, I use some of the data to update a set of Easel graphs which I can print out in 4 colors on the HI80 plotter or use the NEC printer for black and white. Finally, I print out a cover using Digital Precision's Desktop Publisher Special Edition (v 2.0). (And you thought I had completely foresaken dtp on the QL. Shamel) To get a quick print, suitable for our internal use, I wheel the Epson in from across the hall and print it off. When finer output is needed, I use the NEC and graFixC. I spend half my day writing reports and other correspondence so Quill gets a real workout.

That's my "how I spent my summer vacation" piece on my QL usage. How do you use yours?



BBS Report by Mark Fisher, SYSOP

We've got a Kayprol It's been a long road, but it looks like we'll be able to drive the BBS through our newly acquired K-10. It will offer 300 or 1200 BAUD service (what the heck how about 9600 BAUD?), and allow up to ten Megabytes of data storage. In today's terms, that ain't much, but for us, it should hold most of the important 1000, 2068 and QL programs.

Getting it:

Tom Bent made the initial contact with the seller, based on a tip from Mike Cohen. Due to delays, the Kaypro was sold to someone else. Tom picked up an Altos as consolation prize. It was a fantastic value - 10 MEG hard drive, multiuser operating system, provisions for six simultaneous RS232 lines, at half the cost of the Kaypro. BUT. It also carried some liabilities.

- 1) While it used the same (CPM) operating system as the K-10, it couldn't use the BBS programs I'd already recieved from Phoenix Pete, as they used machine-specific overlays to handle the MODEM.
- 2) It used an 8" drive. Software would have to be piped in through the RS-232 ports.
- 3) It was LOUD. This BBS is going to be on the air 24 hours a day, and having such a machine grinding away in the back of the office was not an attractive prospect.
- 4) It wouldn't boot. Aside from Sinclair, the rest of the world stores it's operating system on magnetic media, and uses only a VERY barebones set of instructions coded in a ==4K EPROM for start up. I could get that EPROM to go, but I couldn't get the main operating system to load either from the Hard disk, or from the two 8" floppies I had. I phoned the seller, and he told me that the person that had bought the K-10 out from under us had changed his mind, and it was available for us again.

Four days ago, I drove up to Sikesville, and traded machines. Bringing it back, I confidently plugged it in... and IT wouldn't boot either! I contacted the interim buyer, who had had it working (after he discovered the difference between the FORMATCOM program which reformats the HARD DISK without warning, and FLPYFMTCOM, which formats floppies). We went over the machine, checking connections and plugging and unplugging connections... and IT BOOTED!

Current events:

Right now, I'm re-learning CPM-ese. I want to verify the reliability of the HD first. Then, I've got to review the contents of the HD. There are a lot of duplications, with some signifigant differences between identically named programs (!!). When that's straightened out, I'll pull the unneeded programs off the HD, and start into the six packed disks that Pete Fischer sent me.

As always, I appreciate the help of many others: Tom Robbins, who sent me a CPM for the QL to try out the programs on, Tom Bent, who contacted the seller, Phoenix Pete, for the BBS programs, information, and encouragement, Mannie Quintero, who was going to research the local Kaypro user's group, Stan Guttenberg, who happened to have a copy of an Altos manual (sorry Stan, wrong one), Sam Chayt (the seller) who had held our check for a MONTH while I diddled around with the Altos, John Weske, an Osborne whiz that helped me tackle the K-10, and the rest of you, for your enthusiastic support. 

Using Smartterm II for data uploads.

Problem: I had promised Vernon I'd upload the Membership list to the BBS. OK so far, except that I had only loaded CODE files into the buffer before, and the mem-list copy I got was stored in a character array file on tape.

Solution: From within Smartterm II: got to the Data menu, and clear the buffer (E). Exit to BASIC, and LOAD "DATA A\$(). As a direct command, type POKE 23627, PEEK 23641: POKE 23648, PEEK 23642. RETURN TO SMARTTERM, via Rand USR 54016. The buffer will now contain the array.

For binary files ("" CODE blah, blah): From within St II: GotData menu, and set buffer open, CONversion to NONE. Goto System Menu, and set Duplex to half. Goto Terminal mode, and type a couple of lines, to start the buffer. Return to data menu, and Transmit buffer. When you return to Terminal mode the material you are transmitting will be echoed to the screen, and also added to the end of the buffer! Popping back to the Main menu will let you stop this process when you have expanded the buffer enough for your file.

Now exit to BASIC, Load "" CODE 26710, and return to the terminal mode, as above. Before you log on the BBS, make sure the Duplex is back to Full, and that the buffer is CLOSED, and that CON is NONE.

SOME ARCHIVE UTILITIES Thomas Robbins

Archive is, arguably, the most powerful of the Psion programs. It is an extremely flexible data base system. One feature lacking is a reasonable directory system. With 720 k disk space, one can have a lot of data bases and programs on one floppy--and not all Archive files. The directory command in Archive lists all files to the screen. This can get pretty confusing and cumbersome when you want to find a single data base or program whose name you can't quite remember exactly. It would be nice to have a directory of just the "-dbf" files or just the "-pro" files. There is a relatively easy way to add this feature to Archive using the extended directory features included in Toolkit II and most of the floppy disk interfaces.

Listing one is a SuperBasic program that generates two export files. The first contains only "-pro" Archive program files and the second contains only "-dbf" Archive database files. This should be run prior to executing Archive.

Listing two is an Archive program that imports these files as two databases - one of Archive programs and the other of databases. It also contains the procedures 'DBFDIR' and 'PRGDIR'. This is activated by entering Run "Archmenu" after loading Archive.

Entering DBFDIR in Archive will list to the screen by name and number up to thirty data bases from your disk. You then select the database to be opened by entering the number from the list.

Entering PRGDIR in Archive will list to the screen all the program files. By entering the approriate number, the selected program will be merged.

If there is interest, future articles will show how to add a "Mail Merge" facility to join Quill and Archive (create your own junk mail) and how to add statistical functions and graph plotting to Archive.




