Estate Planning

Wills

Your will is the last and possibly most important legal document you may prepare and so it should be done meticulously, leaving no opening for the Register of Wills and its probate court to recind it or any portion of it.

A soberizing view of how scandalous probate proceedings can be is described by Norman Dacey in his best seller "How to Avoid Probate", chapters 1-3. Based on my views I intend to make mine simple and direct to comply with the minimum legal requirements of the state. I don't intend it to be a monument to my vanity, nor will I build me a mausoleum, defined as the final and funniest folly of the rich.

The things that must be addressed in a will, in one way or another,

- 1. The renuciation of all former wills.
- 2. The identity of your imediate blood and bond legal inheritors ie your spouse, children, and any grandchildren of a deceased child, all by full name. This is the extent of the probate authority, if you have the relations above.

- 3. Debt by exclusion, since the law and a purpose of probate is to satisfy creditors. Since this issue will be addressed by the probate process why waste words on it.
- 4. Naming your Exexcutor (Personal Representative) and successor exexcutor to probate the will. This keeps the probate court from assigning one for you, at your cost.
- 5. The distribution of your probate assets, ie Real (estate) and Personal property (everything else), to those mentioned in 2. above. You can disenherit anyone by giving them \$1, but if you do not mention them that can lead to a challenging of the will. So mention all in 2. above and give them something.
- 6. Lastly have your signature witnessed by witnesses (three recommended) and notarized it on the spot.

Before ending my digest on wills, beware, if you will to a minor any sizeable sum (>\$5,000) as you would invite the probate court (in Maryland it's the Orphans Court) to action as they feel compelled to assure that minors and their property are protected. They have the power to appoint a guardian for the minor and another for the minor's property, irrespective of any stated in a will. This situation also will require yearly accounting to be filed with the court for years and years.

It should be noted that a simple and concise will, with no complicating factors that the court can get its hands on will allow the will to be probated informally through the simpler administrative procedure involving the Register of Wills but not the court. This saves time and money. A ray of hope.

As for using your computer to prepare a will or wills, I find my QL and Quill as perfect for the task. After I get a final version of my will made I save it to disk, then keeping the master on the

screen I subsitute my wife's name for mine and change all his's to hers and I have a second will, a mirror image of my own, which I again save to disk but under her name. Thus the dexterity of the Quill wordprocessor allows one to kill two birds with one stone.

A few legal tips. Make the witnesses to your will aware that it is your last will and testament, but you do not have to read it to them. Give each page a number as page one of three, etc. and sign each page except the last where your signature appears anyway.

Do not use the self justification features of margins that are automatic with Quill. Rather keep the one letter space between words all the way to the margins even if you have to break up words at the margins, as gaps between words can invite alterations later on. Make a few certified xerox copies of your will and store them or give a copy each to your executor and successor as well as advise them where the original is stored. And store the original in a safe fireproof place or with your Register of Wills in your county.

Part 4: Code Generator

The last part of the project is the code generater. This procedure takes the output from the lexical analyser and turns the tokens into SuperBasic code.

I picked a subset of LOGO that would be very easy to directly translate to SuperBasic. Most of the Little LOGO code is a one to one translation to SuperBasic. The code generator is composed of a number of simple IF statments, so it should be fairly easy to read.

There are a few caveots: I forgot to include the :LABEL command in the syntax checker, so I will not include it here. If you try :LABEL, the syntax checker should cry foul about it.

I also found a problem with the lexical analyser. After it prints out the last token, it does not print a End Of Line marker, so the End Of File (EOF) marker is right after the last token. When inputing and checking for EOF, the last token is missed. The same problem might be found in the syntax checker.

You will need to put a print statement (to the proper channel) at the end of the lexical analyser procedure. This will correct the problem.

I don't promise that any of these programs are perfect and bug free. They are here to learn from. All of the programs will need to be reworked to be taken seriously. They are written to show that this project is possible and a way of doing it. If anybody merges these three procedures together and cleans them up a bit, I'd like to know. I hope others would be interested in seeing the program as a whole.


