T/S 2068 Serial Cable

Fellow TS 2068 users. I have found over the last few months that, some of the information needed to complete some projects is not always clear with the instructions you may receive with the project. During the last couple of months I have started two such projects, namely the conversion of the 2050 modem to a modified serial port, and the building of a Z-SIO port card for my 2068.

The building of both projects was not that hard to do, having some prior kit building experience. especially soldering. Let me say that the first thing anyone must have is the patience to keep working at it to get it right. completing each of the two projects, I ran into the same problem. I needed a serial port cable that would work with each of the two projects. The 2050 converted serial port had to have a male DB25 to female DB9 cable. The Z-SIO serial port card had to have a male DB25 to male DB25 cable (DB9 and DB25 refers to the connector types).

The instructions for each project did not give a clear pinout for either cable. They did give the signal available at each pin, but how these should be configured with the signals needed for the external modem was not given. After some

study and just plain trial and error, I was able to find the correct configuration for each cable. The information was there, but for a novice, it took a little work and some added advice from some friends to put it together right.

Listed below is the serial cable configuration that I have found will work on the Z-SIO serial port card, and the modified 2050 serial port. I hope this information is helpful.

Estate Planning

Estates

As I mentioned earlier there are many types of "estates" definitions, and each can be of correspondingly different sizes and worth for the same person, depending on how one's assets are titled and structured.

My objective is to minimize my probate estate by having a simple clean cut will which is essentially empty of assets, but meets all the legal needs to get through probate and end all outside intrusions into my privacy. Of course if I am lucky and blessed with assets that approach the Federal taxable estate limit (\$6000,000) then I would start to worry and hopefully spread assets into my spose's trust. If that gets filled up (another \$600,000) I am

sure to go to heaven and to hell with the rest of what I may leave behind.

I retired a couple of years early as my intuition suggested I would need those years to get my finacial house in order and understandable, at least to myself. Well that's how much time it has taken -- and a large measure of that time has been in determining just what my Total, Federal, Non-probate, and Probate estates are. And with knowing that, even if approximately, I could start to plan my estate in terms of what I want my will to reflect and to do, and what type and need I may have to set any trust or like estate tool, ie, Joint Tenancy, insurances or equivalents.

In the course of all this the Abacus program (spreadsheet) is ideally suited to use, easy to upgrade, expand, and a valuable summary of where I stand in assets, obligations, income, outgoes, prospective taxes, etc., as well as providing my beneficiaries with a concise overview and information of all my account numbers, locations, etc.

Abacus, with its X - Y (row, colums) structure has permitted me to list all pertinent assets and items of interest in column A and to use all other colums to identify the asset by account name, number, location, amount, income, expense and importantly by taxable estate status, such as Probate, Federal, Non-probate, or Total, and pertinent notes.

Since Abacus allows easy summing of columns, I can sum my yearly income, expenses, net, or gross, worths. This information also helps to make schematic diagrams of money bottlenecks, and flows, or some balancing needing redispositon of assets to reduce to probate expenses, inheritance taxes, and or federal estate taxes.

The combined Quill and Abacus programs are therefore indispensible in helping me as a do-it-yourself

planner for my estate. Of course I could get so-called experts to do all or most of all this for me --but my experience is that they are not likely to do much better, nor save me much time and effort, and certainly they will cost a lot and worse yet I'll lose that inalienable right to privacy.

What I have written to date is what I am and have been doing, considering that I have a spouse, children, and grandchildren to be concerned with. I expect every estate plan is likely to be different and needs to be tailored to the specific circumstances of the person involved. Be it so, I still think that if you can handle a QL you can handle the future of your estate and keep the barracudas out of your backyard.

Next edition I'll chat about Powers of Attorneys, a subject well covered by Denis Clifford in his new book "The Power of Attorney." All this amounts to the fact that you really don't have the right to die without attorney and medical consensuses. One more indication of how far our civilization (?) has progressed over the ages.

After this I'll voluteer to make a summary presentation to the club with emphasis on the Abacus matrix I have developed for my use which can be a guide for you do-it-yourselfers who wish to do your own in your estate planning.

Trump Card on the OL

Well, here we go again! Al Feng said, "Ask Butch about the TRUMP Card". Now you may not have to!

The TRUMP Card that I use is a combination 768K memory board and disk interface. As with all QL disk interfaces, it plugs into the 64-way connector which is located behind a "trap door" on the left hand side of the keyboard. Currently, there are three versions of the TRUMP Card available (Memory varies

in 256K increments). All are fully socketed; and, lesser boards can now be expanded with the addition of the appropriate chips.

The TRUMP Card has additional code which makes the "extra" 256K of RAM act as though it is a part of the "standard" 640K to which a QL is normally limited. Consequently, all of the extra memory can be used as a single RAM disk of over 800K ("Dynamic" RAM disk code is just one of the added features of the TRUMP Card).

SuperTOOLKIT coding is another major inclusion on the TRUMP Card. The SuperTOOLKIT code is in "upper" memory, and must be invoked using the 'TK2_ext'. The ROM port remains free for another EPROM. The advantages of the SuperTOOLKIT are too numerous to mention here.

While the TRUMP Card's current cost may seem high, it is bound to come down a little as DRAM prices come down. You can always purchase one of a 256K board for the time being, and add chips later.

If you get the TRUMP Card, I don't think that you will be disappointed. I've been using the TRUMP card along with dual 720K 5.25" disk drives for about a year now and I'm as pleased today as I was when I finally began to unleash the potential of the QL.

The only real limitation is the inability to address more than two drives. Tom Bent (of the CATS User Group) has suggested a possible fix for this; but, I don't have a need to access more than two drives.

Al Feng has mentioned that the 34 pin socket (for the I/O cable) lacks a "quick release" mechanism; and, he thinks the lack of a plastic shroud makes the QL look a bit unfinished. Neither bothers me; and, I'm the one using it every day!


