## Briefs...

A trailer court near Carmel River Bridge, north of the river, east of Highway 1, is in the works. See lead story this page.

In addition to the need to protect Carmel Valley mouth from further commercial development, there is an aspect of this application that concerns Scenic Highway 1 from Carmel River to San Simeon.

The county planning commission has already permitted a trailer court on Highway 1 down coast. Now comes this application. We can expect more to follow.

The more trailer courts in the vicinity of Highway 1, the more pressure will develop from court owners for widening the road and cutting down the curves.

One builds a trailer court; one sets about attracting customers, and Highway 1, in its present narrow, winding, country-road state, which constitutes part of its attractiveness, is not easy for passage of monster "mobile home" trailers, the type this proposed court is specifically planned to accommodate.

## Trailer Park Proposed At Valley Mouth

Carmel planning commissioners sat seemingly stunned yesterday afternoon when Charles F. "Bud" Giles stated that the 110-unit trailer park which he hopes to construct on 13 acres at the mouth of Carmel Valley would be "an asset to the community."

On land now zoned agricultural-nonproductive, belonging to artichoke growers Bruno and Emilio Odello, situated beside the Carmel River 400 yards from the highway, Giles proposes to construct Carmel Valley Mobile Park for retired and semi-retired persons. Each trailer will be placed on a 4,000 square foot fenced site landscaped with one tree, lawn and patio. Streets will be paved, off-street parking for two cars per space provided, utilities put underground, according to the typed information sheets Giles distributed.

The 13 acres will be screened by a redwood fence. None of the trees on the north side will be removed. Entrance will be off the Carmel Valley Road through Carmel Rancho shopping center.

At the center of the development will be a recreational area containing recreation hall, swimming pool, utility rooms, and a home for Mr. and Mrs. Giles and their four children. Giles, who is a Pacific Grove clothing merchant, and Mrs. Giles will be owner-managers.

No children or pets will be permitted in the development and only new trailers allowed. Shuffle- (Continued on Page Seventeen)

### Why Just the Carmel Citizens Committee?

John Chitwood's first act, after he relinquished his mayor's chair and took Allen Knight's police commissioner's seat at the city council table Tuesday night, was to commend the Carmel Citizens Committee.

He proposed that new Mayor Frank Putnam direct the city clerk to write a letter of congratulation to the citizens committee for disseminating information about the candidates before the election.

Newly elected councilmen Putnam and Eben Whittlesey said the citizens committee should be congratulated on their performance in general, including their Monday night's meeting on the proposed master plan, and not especially on their pre-election work. This motion carried.

We agree that the citizens committee deserves praise for public service as do two other organizations which were forgotten Tuesday night.

The citizens committee mailed to every voter a brochure containing the nine candidates' answers to a group of questions posed by the committee's executive board on what the citizens committee considers are essential issues.

The Carmel Business Association sponsored a candidate's forum in which the voters had an opportunity to hear and see the candidates, and ask their own questions.

But Chitwood neglected to ask the council to send a letter of commendation to the Carmel Business Association.

Nor did Ex-mayor Chitwood suggest that the Klenke Committee receive a letter praising their several years' struggle to "hold the Old Carmel line." They have stood up at council meetings and spoken. They got several thousand verified signatures on a petition in opposition to Chitwood's proposal of parking meters for Carmel.

Concerned over the late administration's trend away from the policies that have created and kept Carmel the special community it is, the Klenke Committee persuaded a young man, whose publicly ex- (Continued on Page Four)

**All Saints' Asks Permit Extension For New Building**

Yesterday afternoon Carmel planning commissioners in study session received plans for additional buildings for All Saints' Episcopal Church, situated in the residence district under a use permit. Addition of Grant Hall, Grant Garden and Sunday school classrooms to existing development on the church site will require an extension of the use permit.

Next week in regular session, the planning commission will set a date for a public hearing.

The church is situated along Ninth Avenue from Dolores to Lincoln Street. Additional development now planned is on property immediately south of the church fronting on Dolores Street.

Commercial district plans studied by the commission yesterday afternoon included landscaping for the parking garage at the Fenton Plaza.

S. A. Dibble showed commissioners a plan to provide additional off-street parking for three cars at the Wayfarer Inn, Mission and Fourth. He asks for permission to eliminate 25 feet of sidewalk and a landscaped area.

Charles Catalan submitted plans for a 20 unit motel on two lots on the west side of San Carlos Street between Fourth and Fifth Avenues,

with less than seven and a half percent of the site landscaped.

Robert Little explained plans for interconnecting passageways to parking lots for Carmel Sands Motel and Carmel Lodge at San Carlos and Fifth Streets. Mr. Little and Dr. Dexter Whitcomb have acquired Carmel Sands motel adjacent to their Carmel Lodge property and wish to connect parking facilities for the two developments with passageways.

(Continued from Page One) pressed opinions coincided with theirs, to run for city council, and worked hard for his election. Robert Strum polled a surprising large number of votes. He failed of election because he hasn't been long enough in the community or in public life to be personally known to enough people.

The Klenke Committee supported successful candidates Whittlesey and Whitaker.

We are a little confused by John Chitwood's new-born enthusiasm for the citizens committee. We, who have supported them from the first as stirrers up of public debate, diggers up of information, and a force that should not be ignored when they come before the council with a valid proposal or a veto of an administration project, have noticed over the past two years that Ex-mayor Chitwood has opposed with all his might almost everything the citizens committee proposed, and brushed off their opposition to administration projects whenever possible.

Is his commendation of the citizens committee, now, an act of expiation?

It isn't necessary. "I've fought with everybody in town," he said, in his last speech as mayor. "And if I've missed anyone, it's a matter of omission and not commission."

He has fought with almost everyone.

But John Chitwood has a very lovable quality. He's incapable of holding a grudge. So, few are capable of holding a grudge against him. I can recall no city councilman with whom I've disagreed more, nor liked more. That feeling is probably shared by a large part of the community. —Wilma Cook.

**15-18 Cents Tax Increase Seen In Carmel School Bonds**

Carmel trustees adjourned to a study session with a nucleus of the school bond election steering committee last night. Committee members are Mrs. Louis Gardner, Mrs. Roderick Wilson, Maynard Petersen, Malcolm Millard, and Mark Raggett.

Superintendent Stuart Mitchell told committeemen that the county counsel has advised that the school district may no longer help to finance election campaigning. Such funds must now be raised by groups of private citizens, he said.

The bond issue, to appear on the ballot in the fall of this year, will be for a figure somewhere between two and three million dollars, the

committee was told. It is estimated that it will add from 15 to 18 cents to the tax rate.

Site acquisitions will account for one million, Mitchell told the committee, and a junior high school and one elementary school, both in Carmel Valley, will call for an equal amount.

"Land is going up, so we should start preparing for future purchases of school sites now," Mitchell said. "At the moment, our most pressing need is for construction at Carmel school. We need four more classrooms there."

The committee could not agree on a chairman, and set another meeting for May 3. At that time members will consider expanding

the committee, discuss future needs of the district to be provided for in the bond issue, and select a chairman.

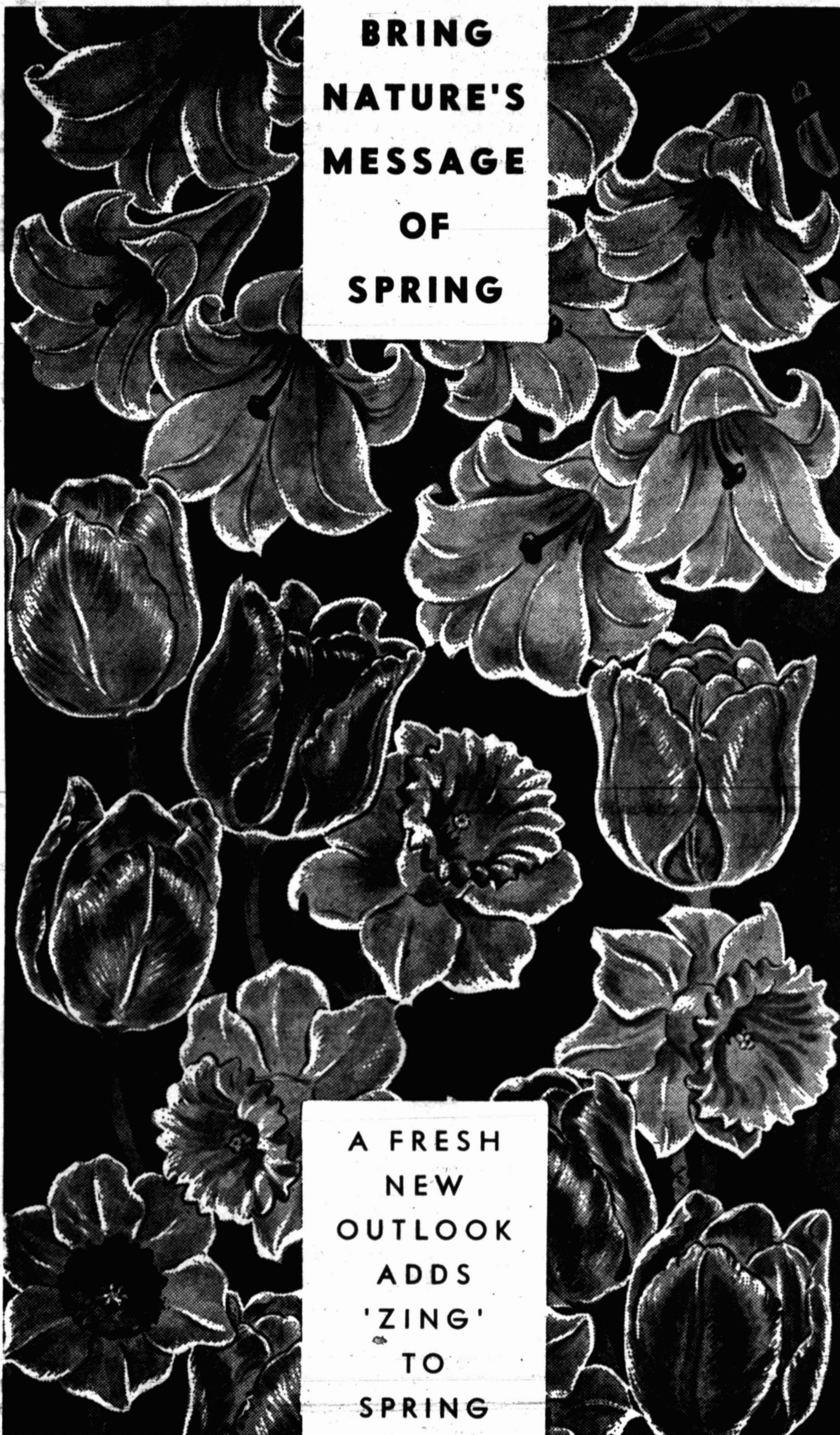

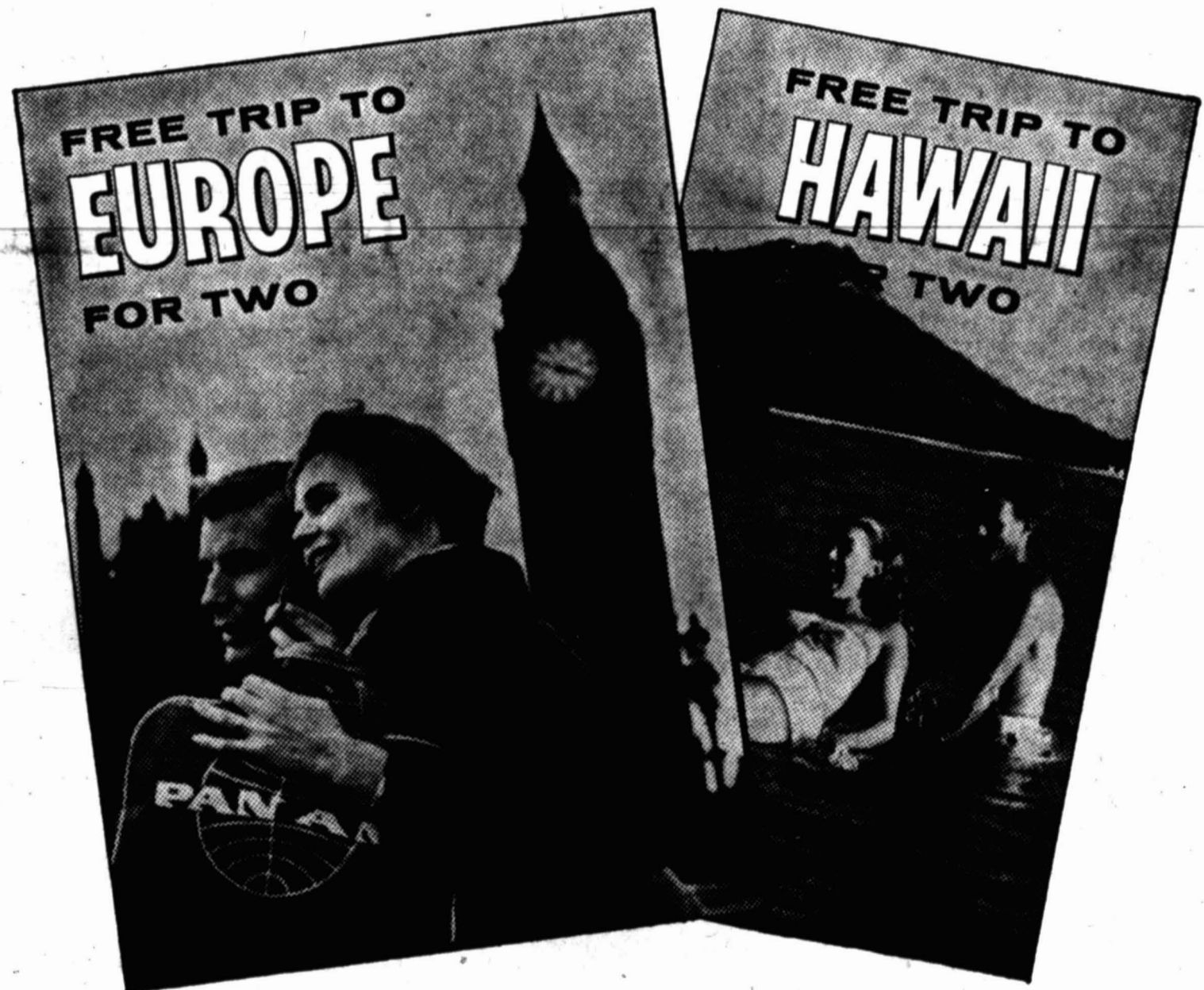

George Bernard Shaw's Pygmalion will be revived at the Golden Bough Circle Theatre next week for a limited run of one month. Rosamond Beck-Meyer Zammitt will play the London flower girl transformed into a duchess by Henry Higgins, played by Errol Allan.

When Shaw boasted some years ago that Pygmalion had been "an extremely successful play, both on stage and screen, all over Europe and North America as well as at home," he could not have foreseen that My Fair Lady would make Eliza Doolittle twice as famous as she had already become. But the popularity of the play has not been lessened by the success of its musical sister, as numerous productions throughout California have recently proven.

Written for Shaw's beloved Mrs. Patrick Campbell, Pygmalion has since starred such noted actresses as Gertrude Lawrence and Wendy Hiller. The latter made a film sensation as Eliza, opposite Leslie Howard's Higgins, in 1938.

The Circle production, last of the 1959-60 Subscription Series will open April 29 and close on the 29 of May.

**April 28 Set For Fire Inspection Of Business Premises**

A systematic fire safety inspection of the City of Carmel business establishments will be conducted on the morning of April 28, according to P. A. McCreery, president of the Carmel Insurance Agent's Association.

The inspection will be made by a group of teams composed of members of the Central Coast Insurance Underwriters Association, the Carmel Youth Center and the local Fire Department, in cooperation with Chief Robert Smith.

It is the first such program offered in the city.

"The object of the inspection is to make businessmen aware of potentially hazardous—or deficient—situations within their stores," said Mr. McCreery.

"It is voluntary, but the response

has been high in surrounding cities, which include Salinas, Hollister, Los Gatos, and Santa Cruz."

The teams will survey business premises throughout the city for such points as cleanliness and compliance with municipal fire codes; wiring, electrical equipment, and lighting; fire protection, egress, fire extinguishers; heat producing devices; air conditioning; refrigeration, and storage and handling of flammable liquids.

Red "Fix-Me" tags will be affixed to noted problem areas, and complete reports will be turned over to each proprietor.

Duplicates will form the basis for a final town inspection report, to be presented at the luncheon. City fire officials will receive the duplicates for follow-up inspection.

"In other cities at least one deficiency has been noted in about 90 percent of the stores," McCreery said.

"Firemen have reported that about 75 percent of these are cleared up before they make their follow-up," he added.

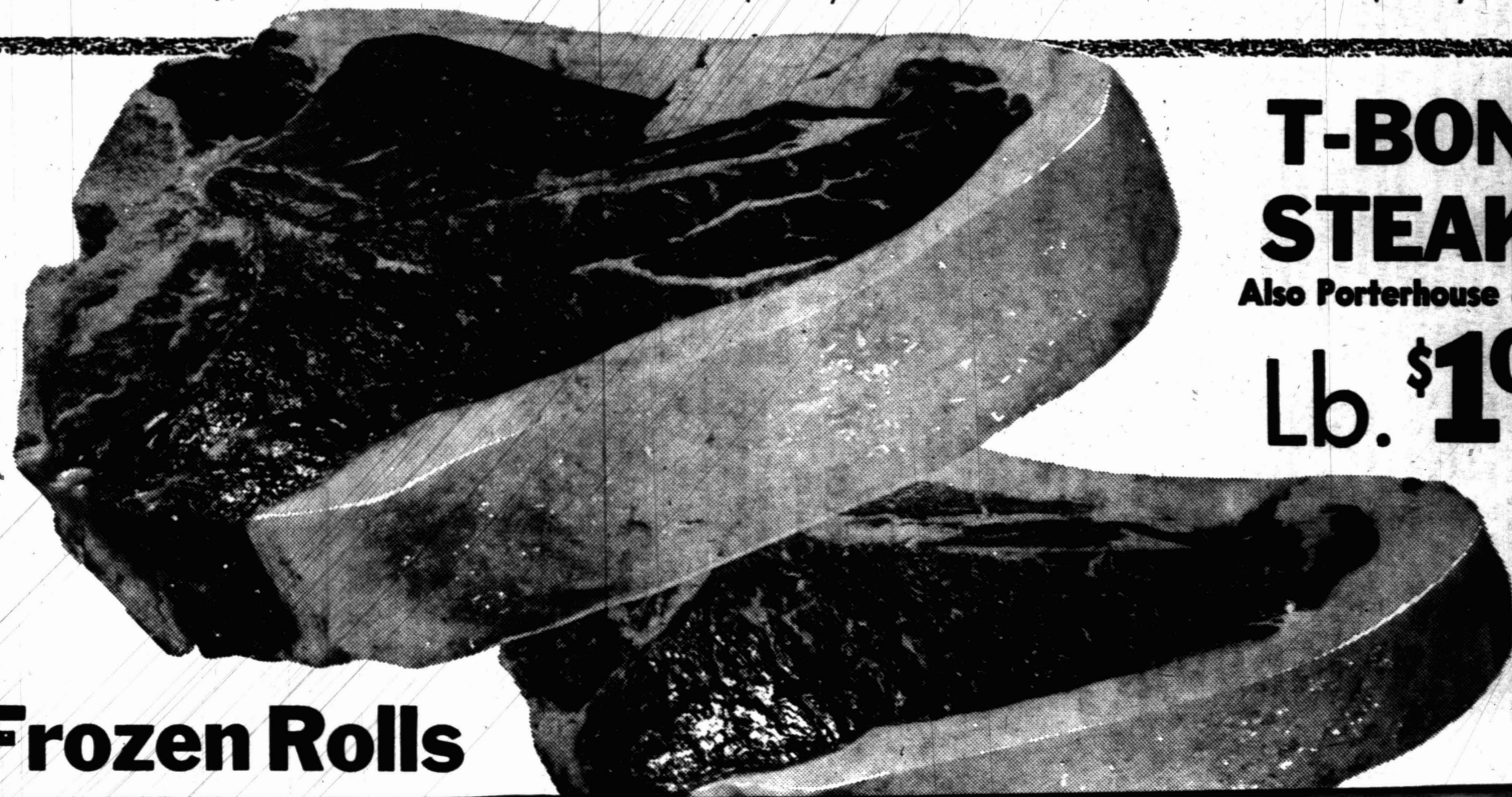

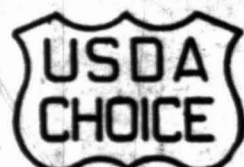

We will have a copy of each to circulate, and a copy or two at the desk, non-circulating for visitors. But if you are spending your vacations somewhere in California, borrow one or both of these to help you plan your trip. And just remember how many thousands of miles visitors come for California vacations, and cancel your tickets to far-away places. This state has everything.

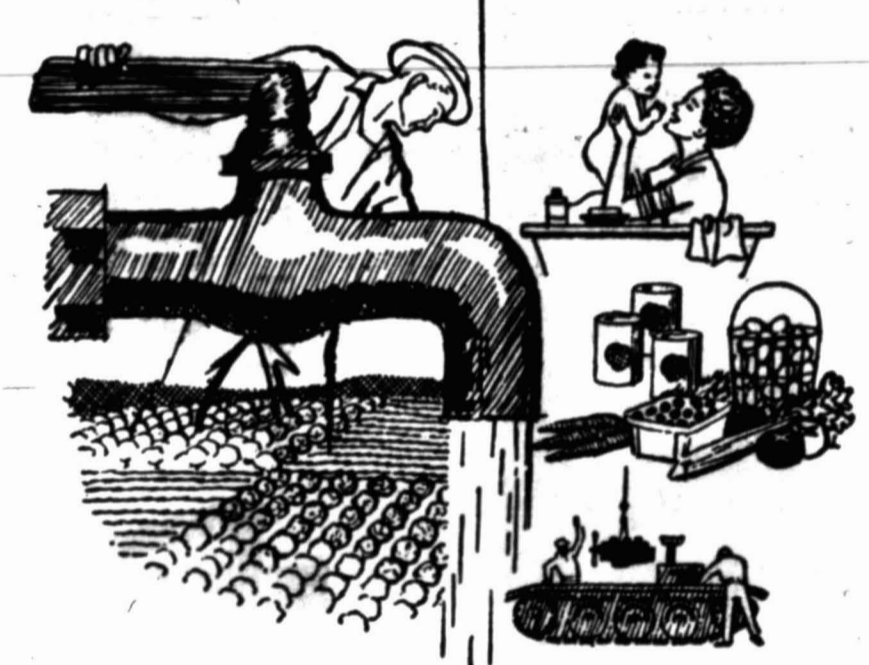

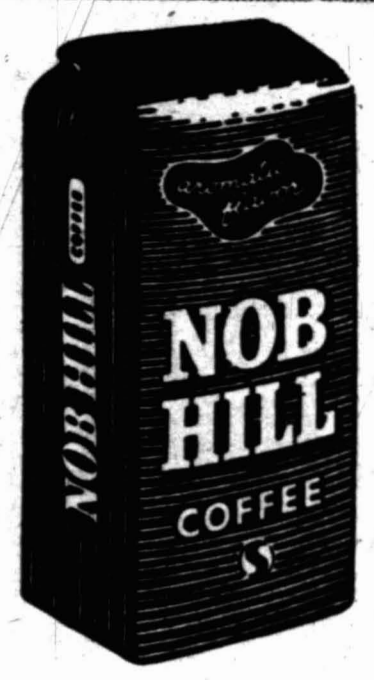

**ORDINANCE NO. 6 C.S.**

**AN ORDINANCE AMENDING CERTAIN PROVISIONS WITH RESPECT TO ELECTRIC WIRING SERVICES**

BE IT ORDAINED by the City Council of the City of Carmel-by-the-Sea as follows:

**Section 1.** That Section 1137(a) of the Municipal Code be, and the same is hereby amended to read as follows:

**"Section 1137. GENERAL PROVISIONS.** (a) All electrical wiring for light, heat and power shall be enclosed in a rigid conduit or electric metallic tubing of approved make in all buildings erected in fire zone No. 2, as the same is defined in Section 706 of the Municipal Code, with the further provision that all structures in fire zone No. 2 requiring new electric service shall have such service supplied from a service lateral of continuous, rigid conduit placed underground to the curb of the sidewalk and attached to an approved terminal box at that point. From such terminal box the remainder of the underground service to existing Pacific Gas & Electric Co. service facilities shall be run in continuous rigid conduit. This requirement shall be effective on all new buildings requiring electric service and on all existing buildings when the electric service is to be altered or rebuilt."

**Section 2. Effective Date.** This Ordinance shall become effective thirty (30) days after its final passage and adoption.

- (b) The bond of the City Treasurer shall be in the penal sum of one hundred thousand dollars (\$100,000.00)."

**AN ORDINANCE AMENDING THE MUNICIPAL CODE SO AS TO PROVIDE AN INCREASE IN THE SALARY OF THE CITY CLERK**

THE CITY COUNCIL OF THE CITY OF CARMEL-BY-THE-SEA DOES ORDAIN as follows:

**Section 1.** That Section 241, of the Municipal Code be, and the same is hereby amended to read as follows:

**"Section 241. SALARIES AND ALLOWANCES.** The salary of the City Clerk elective shall be \$600.00 per month. The salary of the City Treasurer elective shall be \$65.00 per month. Salaries and allowances of all other city employees shall be established from time to time by the City Council by resolution."

**Section 2. Statement of Urgency, and Effective Date.** The within Ordinance is hereby determined to be an urgency ordinance, a statement of its urgency being as follows:

The salary of a city clerk by State law may only be changed to become effective coincident with the commencement of a new term of a city clerk. That if this ordinance bringing about such change be not adopted prior to the municipal election in April, the proposed change would be a nullity for the ensuing four (4) years, and it is necessary for the proper continued conduct of city business to adjust the salary of the City Clerk commensurate with present economic conditions, forthwith. In the premises this ordinance shall become effective upon its final passage and adoption.

**AN ORDINANCE AMENDING THE MUNICIPAL CODE SO AS TO INCREASE THE PENALTIES FOR VIOLATION OF ITS REGULATORY PROVISIONS**

**Section 1.** That Section 30 of the Municipal Code be, and the same is hereby amended to read as follows:

**"Section 30. VIOLATIONS.** A MISDEMEANOR. Unless otherwise herein specifically provided, any person violating any of the provisions or failing to comply with any of the regulatory requirements of this Code, shall be guilty of a misdemeanor. Any person convicted of a misdemeanor under the provisions of this Code shall be punishable by a fine of not to exceed Five Hundred Dollars (\$500.00) or by imprisonment in the County Jail of Monterey County for a period of not to exceed six (6) months, or by both such fine and imprisonment; and every day during any portion of which any of the provisions of this Code shall be violated, or during which there shall be a failure, neglect or refusal to comply with any of said provisions, shall constitute a separate misdemeanor, and shall be punishable as herein provided."

ORDINANCE NO 18 C. S.

AN ORDINANCE PROVIDING FOR PROCEDURES RELATIVE TO SPECIAL POLICE-MEN

THE CITY COUNCIL OF THE CITY OF CARMEL-BY-THE-SEA DOES ORDAIN as follows:

Section 1. That Part IV of the Municipal Code be amended by the addition of a new division to be known as Division 12, which shall read as follows:

"DIVISION 12

SPECIAL POLICE OFFICERS

Section 690. SPECIAL POLICE OFFICER DEFINED. For the purpose of this division, a Special Police Officer is defined as a Police Officer doing police work pursuant to assignment by the Chief of Police or his duly authorized representative, at the request of a person, firm, corporation or a political subdivision of the State, when such police work does not consist of police service provided the public generally by the Police Department.

Section 691. PRIVATE EMPLOYMENT OF CITY POLICE OFFICERS PROHIBITED. No Police Officer while employed by the city shall henceforth accept pay from any other person, firm, corporation or political subdivision of the State for doing police work, whether or not such work is done by such Police Officer while off duty.

Section 692. PROCEDURE FOR OBTAINING SPECIAL POLICE OFFICER. Any person, firm, corporation or political subdivision of the State desiring the services of a Special Police Officer who is an employee of the city shall contract for his services with the city, and pay the city for such services in the amount as the City Council may from time to time provide by ordinance, resolution or special contract. The city may from time to time contract in writing to provide such services for any of such parties desiring such services, said contract to set out such requirements and terms relative to the matter as is deemed best by the City Council, which shall approve such written contract on behalf of the city. In all cases where the city does not enter into a formal, written contract, such party desiring such services shall request them of the Chief of Police; the Chief of Police may then assign such special policemen in answer to the request as he in his own judgment deems best, bearing in mind the police needs of the city, the personnel available and the Police Department morale. The Chief of Police shall then collect the charges for such services as are provided and shall remit the same to the City Clerk as collected. The powers given to the Chief of Police in this paragraph may be exercised by his duly authorized agent in charge of the Department if the Chief of Police be absent or be unable so to act in the matter.

Section 2. Effective Date. This Ordinance shall take effect thirty (30) days after its final passage and adoption.

## Difficult To Give Accurate Estimate Of Cost To Carmel Of Junior College Annexation Nuttall Tells School Board

Whether or not Carmel voters elect to join the Monterey Peninsula Junior College District on June 7, they will continue to pay "substantially the same amount" toward its support for the next five or six years, Drayton B. Nuttall told school trustees last night.

Nuttall, head of The State Bureau of School District Organization, said in presenting his survey report on the pros and cons of annexation that he saw no need for additional capital outlay at the college campus for that length of time.

Basing his predictions on a 20-year bond issue for an estimated purchase price of \$2,095,000 for the college plant, he said that the tax load would be offset by dropping the current tax Carmel is paying for tuition and by aid from the state general fund.

"The first year," he estimated, "the general fund will pick up to 35 cents of your tuition bill, and you will pay the balance." This balance will run from about 13 cents for the first year of the bond issue to about five cents the twentieth year.

Carmel now pays a 48-cent tuition tax for the students it sends to the college.

"For the first year you will make the same payment as you would if you had stayed out of the district. You will still wind up paying 48 cents," Nuttall said.

"If you stay outside the college district, during the next ten years you will probably pay from 47 to 54 cents, including the tuition bill."

Nuttall added that when the college reaches an average daily attendance figure of 2500 to 3000—in 1965 or 1966—the operating costs may drop.

Estimated purchase price is based on a "net investment" figure. Total investment was given as \$2,985,737. From this were deducted tuition payments made by Carmel and Pacific Grove in the amount of \$850,376, and \$40,469 for a bus stop to be retained by Monterey High School district. This places Monterey's net investment at approximately \$2,094,900.

The bond issue for this amount would begin in 1962 and run for 20 years at 4.5 per cent.

"This interest rate is a broad guess," Nuttall told trustees. "It's probably as high as it could go. And these figures do not contemplate any additional capital outlay at the college."

The junior college district will gather revenue from the following sources: state apportionments, local district taxes, federal funds (Public Law 874), and tuition receipts from out-of-district students. Nuttall estimated this revenue at \$993,060 for 1961-62, and at \$1,599,960 by 1965-66.

It is difficult to present an accurate estimate of the probable future cost to Carmel taxpayers, Nuttall said.

"This is because the cost factors may change," he told the board, "and because we don't know just what the legislature is going to do about junior college financing."

Sale of facilities by the Monterey High School district to the Monterey Peninsula Junior College district while the personnel of the two boards is identical—as it is at the moment—can be made only on

the basis of an appraisal. As soon as the majority overlapping of board membership no longer exists the sale can be negotiated between the two boards. The annexation of Carmel or Pacific Grove or both does not immediately make any changes in the junior college board. The present members will serve out their terms. Terms of two of the members will expire June 30, 1961. At that time persons from Carmel and Pacific Grove could be elected as trustees. They would take office July 1.

The terms of the three remaining members will expire in 1963. At that time three persons could be elected from Monterey, and one more from each of the districts of Carmel and Pacific Grove. Any variation in this procedure would require either resignations or some legislative action.

### Chitwood Stages Brown Act Protest In Mayor Election

John Chitwood staged a one-man walk-out protest against the Brown Act Tuesday night. As a result, Frank Putnam was elected mayor of Carmel by a three-man vote. Chitwood, waiting in the hallway, was unable to vote, but before his departure from the council chambers stated that if he were to remain, he would nominate Putnam for mayor.

The Brown Act, a state law two years old, requires that all public bodies conduct their business in public. The only exception is "personnel" matters involving firing an employee where open discussion of charges, not yet proved, might result in libel action.

Until the Brown Act ruled out executive sessions, it was the custom for new Carmel City Councils to adjourn, as soon as they had taken the oath of office, to executive session to discuss in private—more often fight it out—who is to be mayor and who is to have what commission.

Tuesday night, with Chitwood waiting in the hall, the remaining city councilmen honored another Carmel tradition, gave the first refusal of the mayor's office to the newly elected councilman who had received the greatest number of votes. Of the three new councilmen, the second high man on the vote count totem pole, Eben Whittlesey, nominated top man, Frank Putnam.

Putnam accepted; Gunnar Norberg, holdover councilman; Whittlesey and Whitaker, made it a unanimous vote of three and somebody summoned Achilles out of the hallway.

The new mayor, with compliments, dispersed the commissions. He invited Whitaker to serve as street commissioner. To Ex-mayor

Chitwood, who before his term as mayor, served six years as police commissioner, Putnam offered the guardianship of the police department, Chief of Police Clyde Klammann's round face, naturally designed for beaming, out-beamed itself. Eben Whittlesey was endowed with Health and Safety, and Gunnar Norberg, who is probably the most satisfactory fire commissioner the department has ever had, because he has so many other city projects pending that he forgets for six months at a time he is fire commissioner, accepted the fire commissionership again, with the hearty approval of Fire Chief Robert Smith.

board and croquet and horseshoe courts will be included in the recreation plans, also a one-acre putting green, TV rooms, and a kitchen for luncheons and potluck dinners. Dancing will be scheduled for guests.

Revenue to the community from state license fees of \$115 per unit would amount to \$7,590, Giles said. This would be divided into \$3,795 for the Monterey County General Fund and the Carmel Unified School District. Property tax would net the county an additional \$2,000. Estimated sales tax revenue from occupants of the park would amount to \$3,146, according to Mr. Giles' figures. Altogether county,

school district and community would supposedly gain \$12,736 in tax revenues, the financial statement proposes. In return, Mr. Giles told planning commissioners, county operating costs and Carmel school district educational costs for Carmel Valley Mobile Park would be zero.

Giles told commissioners that the proposed mobile park development would provide flood control for Lower Carmel Valley including Mission Fields. Dikes, totalling 1700 feet in length, will be built and 12,000 yards of fill provided to prevent flooding by filling in the old river channel.

Giles was introduced to the commission by his father, County Treasurer Russell A. Giles, who stated that yesterday afternoon's discussion was the first public pre-

sentation of the development which will be given to the county planning department tomorrow afternoon for consideration later by the county planning commission.

Plans were presented to the Carmel planning commission at their study session yesterday because the mobile home park, one mile east of Carmel, is within the Carmel commission's three-mile advisory limit to the county planning commission.

The property for the mobile park must be rezoned by the county from agricultural to residential-commercial use before Carmel Valley Mobile Park can be developed.

**Henry Dickinson**

Henry Dickinson, 53, son of Henry F. Dickinson of Carmel, died on April 11 in a Los Angeles hospital following a brain operation to remove a blood clot. He had received a head injury in a fall several days previously.

He was born in Evanston, Illinois, and came to Carmel as a youth when his parents established a home on Carmel Point in 1923. He studied drafting at the California Institute of Technology for two years, transferred to Reed College in Portland, Oregon, and developed an interest in philosophy. He studied in this field at Columbia University under philosopher John Dewey, and continued further postgraduate studies in philosophy at Harvard University.

After returning to California he taught at the Peninsula School in Palo Alto before discovering the creative possibilities in the craft of pottery. Working in this medium in Carmel, Henry Dickinson found no efficient small electric kilns were available for potters' use. Aroused by this fact he invented the Dickinson electric kiln. The demand for this kiln was so great that he established Dickinson Kiln Incorporated, a manufacturing firm situated in Los Angeles. His small kilns were purchased by potters all over the United States and also interested industries that desired him to invent large electric kilns for specific manufacturing processes. He expanded his business to fulfill this demand and became an authority on kilns used for many varied industrial uses in this country and abroad. At the time of his death he was considering the possibility of again expanding his plant to manufacture larger kilns to fill orders for aircraft and other defense industries supplying government contracts.

In addition to his father, Henry Dickinson is survived by two sisters, Mrs. Elizabeth Dickinson White of Los Angeles, and Edith Dickinson of Sausalito; a nephew, John White of Carmel Valley; and an aunt, Mrs. Ralph Skene of Carmel.

Funeral services were held last week in Los Angeles. Inurnment will take place in the Dickinson family plot in the Rockford, Illinois, cemetery.

He has exhibited in the Galleria

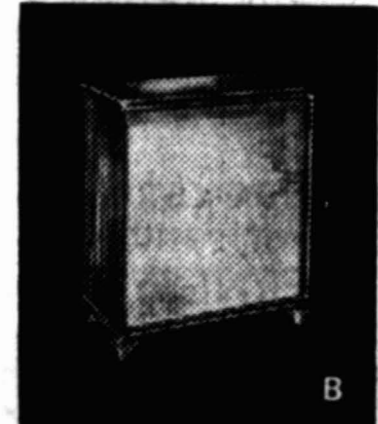

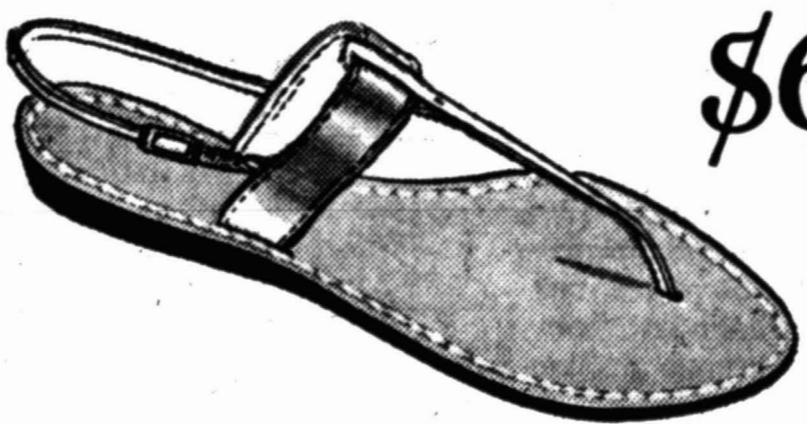
