University of Toronto.

STATUTE I.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

All previous Statutes of the University are hereby repealed.

STATUTE II.

OF THE RULES FOR PROCEEDINGS AT MEETINGS OF SENATE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

The following shall be the rules relative to the proceedings of the Senate, which rules shall be observed, unless a majority of the whole Senate shall decide for some sufficient cause that it is necessary or expedient to dispense with any portion of them.

I. The Senate shall meet annually on the (Thursday next after the tenth of May, and on the first Thursday in December), and may continue in Session by adjournment. Amended by Stat. lxxii.

II. Special Sessions may be called by the Chancellor, or in his absence, by the Vice-Chancellor. ✱

III. The summonses for the Regular Sessions and for Special Sessions, or for the adjourned meetings thereof, shall be sent through the post office to each member; summonses for the Regular Sessions and for Special Sessions shall be sent at least ten days before the day of meeting, and those for Special Sessions shall specify the business which is to be brought forward.

IV. No business shall be proceeded with unless there be a quorum present within twenty minutes after the appointed time; but the members present may declare the meeting adjourned to another day.

V. No business shall be introduced at any Special Session in addition to that specified in the summons.

VI. The Summonses shall be issued by the Registrar under the direction of the Chancellor or Vice-Chancellor.

VII. At least one day's notice must be given of every motion, except for the suspension of a rule or for adjournment.

VIII. No Statute shall be introduced without at least one day's notice, nor shall it be passed at the same meeting at which it has been first read; but it shall be read a second time, at another meeting, on a subsequent day.

IX. At the second reading of a Statute any member may require it to be read clause by clause, and the vote to be taken on each.

X. The Order of Proceedings shall be.

- (1) The Registrar to read the Minutes of the last meeting.
- (2) Letters received since the last meeting to be read.
- (3) Notices of intention to introduce Statutes or Motions to be given.
- (4) Reports of Committees to be read according to priority of appointment.
- (5) Business remaining since last meeting to be taken up.
- (6) Drafts of Statutes to be discussed.

XI. No member shall speak on any subject more than once, except the introducer of the subject under discussion, who shall be entitled to reply once. Every member, however, shall have the right to explain himself, having first obtained the leave of the Senate, and subject to the direction of the Chair.

XII. No member shall speak upon any subject which has not been committed to writing, and moved and seconded, or which he does not intend to make the subject of a motion.

XIII. No motion prefaced by a written preamble shall be received by the Senate:

XIV. Every member while speaking shall address the presiding officer, and the members shall not interrupt the proceedings by conversation.

XV. When the question has been entirely put by the presiding officer, no member shall speak upon the subject before voting.

XVI. Any member may require the yeas and nays to be entered on the minutes, but no member shall be permitted to enter the grounds of his dissent.

XVII. In all unprovided cases, resort shall be had to the rules, usages, and forms of the Legislative Council of Canada.

STATUTE III.

OF THE CORPORATE SEAL.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The Seal heretofore used shall continue to be the Seal of the University of Toronto.

II. The Seal shall be kept in such place of deposit and in such charge as the Chancellor shall from time to time direct; and it shall not be affixed to any instruments except in the presence of the Chancellor or Vice-Chancellor, who shall attest such sealing by his signature.

STATUTE IV.
OF THE VICE-CHANCELLOR.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The election of Vice-Chancellor shall be held on the (Thursday next before Christmas) in each alternate year, except in the special cases hereinafter provided for; (and the first election under this Statute shall take place on the Thursday next before Christmas, in the year 1858.)

(II. The Vice-Chancellor shall continue in office until the election of his successor.)

III. Not less than ten days before the time appointed for the election of Vice-Chancellor, the Registrar shall send by the post to each member of the Senate a notice of the time of such election.

IV. Whenever a vacancy shall occur in the office of Vice-Chancellor by death, resignation, or otherwise than by the expiration of the appointed term, the Chancellor shall, without unnecessary delay, direct the Registrar to call a meeting of the Senate, if not then in session, for the election of a Vice-Chancellor for the remainder of the term, giving not less than ten days' notice; or if the Senate be in session at the time any such vacancy occurs, then the Senate shall appoint the day for such election, allowing an interval of not less than ten days; and the Registrar shall give notice thereof to every member accordingly.

V. The Vice-Chancellor shall perform such duties as may from time to time be assigned to him by the Senate.

VI. The salary of the Vice-Chancellor shall be at the rate of (two hundred pounds) per annum.

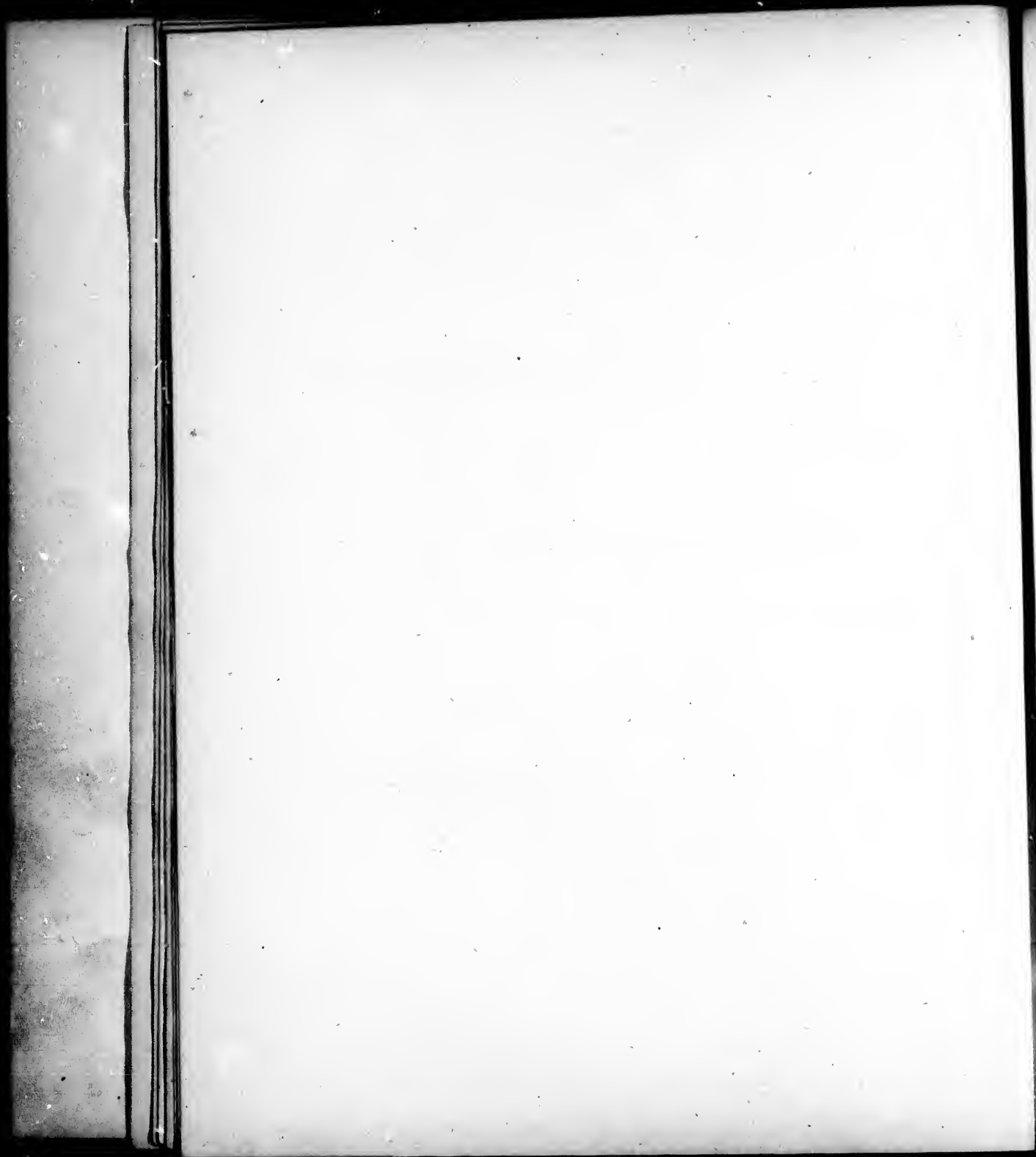

STATUTE V.
OF THE SENATE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

Whenever by death, resignation, or otherwise, the number of the members of the Senate shall be reduced below ten, exclusive of the Chancellor and Vice-Chancellor, the Chancellor, or in his absence, the Vice-Chancellor, shall direct the Registrar to call a meeting of the Senate, if not then in session, for the purpose of electing one or more persons as members of the Senate, exclusive of the Chancellor and Vice-Chancellor, giving at least ten days' notice of the meeting and of the object for which it is called; or if the Senate shall be in session when the number of the members of the Senate is so reduced below ten, then the Senate shall appoint the day for such election, giving at least ten days' notice, and the Registrar shall call the meeting accordingly.

STATUTE VI.
OF THE SUBORDINATE OFFICERS AND
SERVANTS.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The following officers shall be appointed, viz.: the Registrar, the Bedel, and the Messenger.

II. The Registrar shall be appointed by Statute, and shall be removable at pleasure by a like Statute.

III. The duties of the Registrar shall be to take charge of the records and papers of the University, and to keep the same properly arranged for convenient reference in such place as shall be appointed by the Chancellor—to keep regular entries, in a form to be approved of by the

Chancellor or Vice-Chancellor, of the names of all persons who shall be candidates for Matriculation, Degrees, or Scholarships, Prizes, and Certificates of Honor; of all Examiners who shall from time to time be appointed; and of all such particulars connected with each examination as the Chancellor or Vice-Chancellor shall direct—to conduct all necessary correspondence under the supervision of the Chancellor or Vice-Chancellor, and to keep proper records thereof—to attend all Meetings of the Senate, and keep regular Minutes of all the proceedings thereat—to prepare all Statutes, Resolutions, Reports, or other papers which the Senate may direct, and all copies which may be required of any such documents or papers—to prepare and countersign all official documents, and generally to discharge such other duties as may be assigned to him by the Senate, or, when the Senate is not in session, by the Chancellor or Vice-Chancellor.

IV. The Registrar, before entering upon the duties of his office, shall make and subscribe before the Chancellor or Vice-Chancellor a declaration to the following effect, viz:—

“I, A. B., do solemnly declare that I will, to the best of my ability, faithfully discharge the duties of Registrar of the University of Toronto, according to the Statutes of the said University, and the directions to be given to me under authority thereof, and that I will not directly or indirectly publish or make known any of the proceedings, affairs, or business, of the institution, unless under the authority of the Senate, or upon the requisition of the Visitor, or under compulsion of legal proceedings.”

V. The Bedel and the Messenger shall be appointed by the Chancellor, and shall hold their offices during his pleasure.

VI. The Bedel and Messenger shall discharge such duties as are usually discharged by persons holding such offices in similar institutions, and generally shall act under the direction of the Senate, the Chancellor, or the Vice-Chancellor.

VII. The salary of the Registrar shall be at the rate of £187 10s. per annum.

VIII. The salaries of the Bedel and Messenger shall be determined by resolution of the Senate.

STATUTE IX.
OF DEGREES IN THE FACULTY OF MEDICINE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The following shall be the requisites for admission to the Degree of Bachelor of Medicine, viz :

(1). Having matriculated in any of the Faculties of Law, Medicine, or Arts.

(2). Being of the full age of twenty-one years.

(3). Having pursued Medical studies for the period of at least four years, and having regularly attended Lectures in the following branches of Medical education for the respective periods hereinafter set forth :—

Anatomy, two courses of six months.

Practical Anatomy, two courses of six months.

Theory and Practice of Medicine, two courses of six months.

Principles and Practice of Surgery, two courses of six months.

Chemistry, two courses of six months.

Midwifery and Diseases of Women and Children, (one) *two* Stat XXXIV
course of six months. *or one course with 12 cases of labour.*

Therapeutics and Pharmacology, (one) course of six months.

Physiology, (one) course of three months.

Medical Jurisprudence, one course of three months.

(4). Having attended for at least twelve months the practice of some general Hospital, and having attended during six months Clinical Lectures on Medicine and Surgery.

(5) Having passed in this University an examination in all the subjects specified in Article 3.

(6). Producing satisfactory certificates of good conduct.

II. The following shall be the requisites for admission to the Degree of M. D., viz :

Having been admitted to the Degree of M. B., being of one year's standing from admission to the Degree of M. B., and having composed an approved Thesis upon some medical subject.

STATUTE X.

OF DEGREES IN THE FACULTY OF ARTS.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. Candidates for the Degree of B. A. may matriculate at any of the five examinations appointed for Under-graduates in the Faculty of Arts.

II. Candidates entering at the matriculation examination, or at the examination for the first year, must have completed the (14th) year of their age.

III. Candidates who have completed the (16th) year of their age may enter at the examination for the second year, and shall, in addition to the subjects appointed for that year, pass the examination in Mathematics required in the first year.





IV. Candidates who have completed the (20th) year of their age may enter at the examination for the third year, and shall, in addition to the subjects appointed for that year, pass the examination in Mathematics required in the first year (and shall not be permitted to exercise the option between the departments of "Greek and Latin," and "Modern Languages.")

V. Candidates who have completed the 25th year of their age may enter at the final examination for B.A., and shall, in addition to the subjects appointed for that year, pass the examination in Mathematics required in the first year, the examination in Logic, Ethics, and Metaphysics, required in the second year, and the examination in History required in the third year; and they shall not be permitted to exercise any of the options, which are allowed at the final examination. If candidates for Honors, they shall be arranged in the Class Lists according to their proficiency (but they shall not be permitted to compete for Scholarships).

VI. The restrictions as to age in preceding sections shall not apply to Students of other Universities, who produce satisfactory certificates from the authorities thereof.

VII. Students in any of the Colleges affiliated to the University of Toronto shall not be required to pass any other examination in the University than that appointed for the second year, and the final examination for B.A.; but they shall produce certificates from the Head of such affiliated College, that they have in the other years passed satisfactory examinations in all the subjects prescribed for those years by the Statute respecting "Subjects of Examination in the Faculty of Arts."

(VIII. Candidates for the Degree of B.A., who are not Students in any College affiliated to the University, shall, in each of the years succeeding that in which they matriculate, pass an examination in the subjects appointed for such year).

IX. Candidates for admission to the degree of M.A.; shall have been admitted to the Degree of B.A., shall be of the standing of one year from admission to the Degree of B.A., and shall have composed an approved Thesis upon some subject in one of the departments of the Faculty of Arts.

STATUTE XI.

OF DIPLOMAS IN THE DEPARTMENT OF CIVIL
ENGINEERING.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

Vid. Curriculum. The requisites for obtaining the Diploma in Civil Engineering shall be as follows:—

Having matriculated in any of the Faculties, or having passed the examination appointed for matriculation in the Department of Civil Engineering.

Being of the standing of two years from matriculation

Having passed, in each of these years, an examination in the subjects prescribed for such years in the course appointed for Students in Civil Engineering.

STATUTE XII.

OF DIPLOMAS IN THE DEPARTMENT OF
AGRICULTURE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

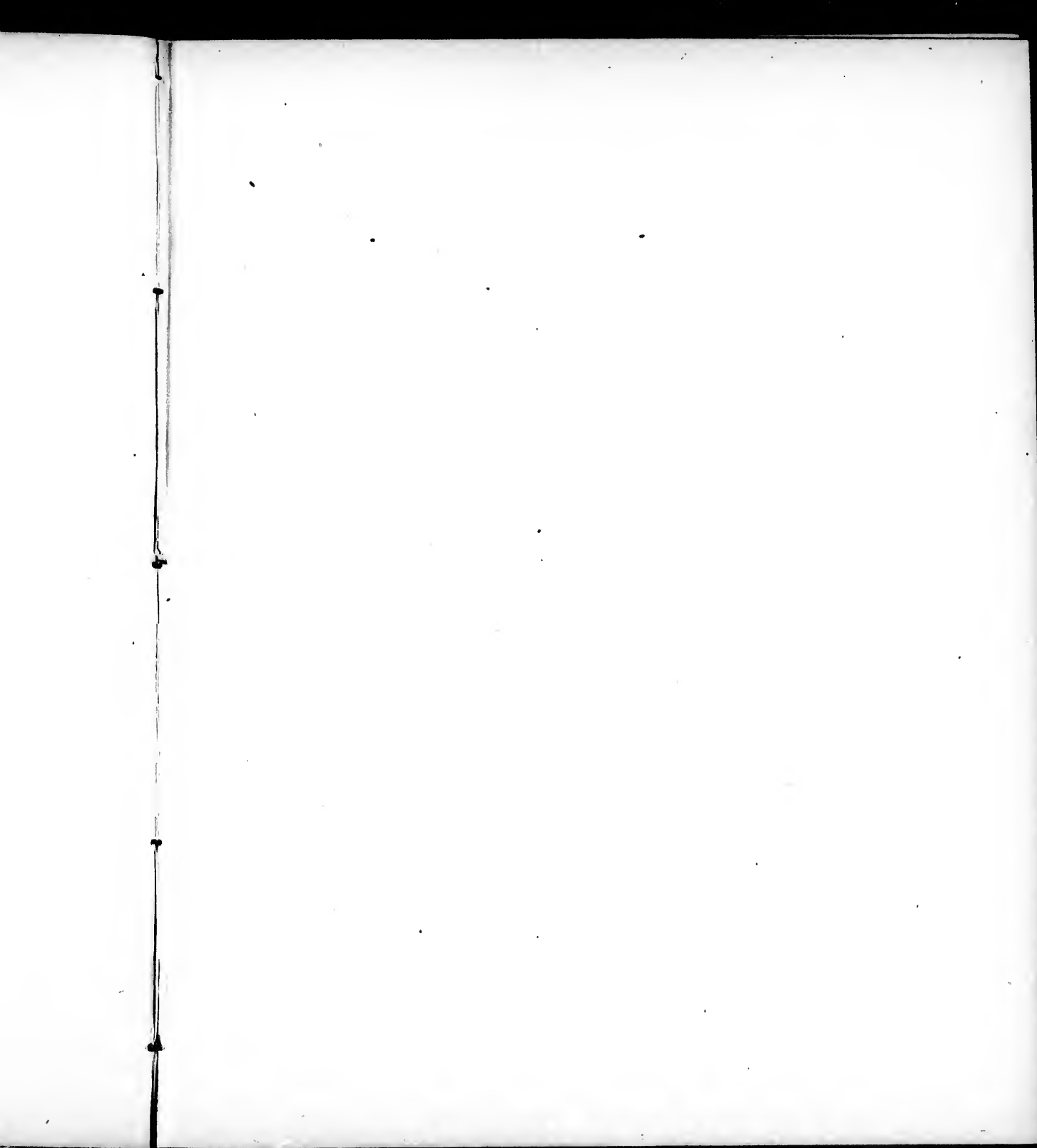
Be it enacted:

Vid. Curriculum. The requisites for obtaining the Diploma in Agriculture shall be as follows:—

Having matriculated in any of the Faculties, or having passed the examination appointed for matriculation in the Department of Agriculture.

Being of the standing of two years from matriculation.

Having passed, in each of these years, an examination in the subjects prescribed for such year in the course appointed for Students in Agriculture.





STATUTE XIII.

OF THE TIMES OF HOLDING EXAMINATIONS
AND CONFERRING DEGREES.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The examinations for Matriculation in the Faculties of Medicine and Arts, and in the Departments of Civil Engineering and Agriculture, shall be held in the latter part of the month of September. Vid. Stat. liv.

II. The Annual Examinations in the Faculty of Arts, and in the Departments of Civil Engineering and Agriculture, other than Examination for Matriculation, shall be held in the latter part of the month of May. Vid. Stat. liv.

III. The Annual Examinations in the Faculty of Medicine, other than the Examination for Matriculation, shall be held in the beginning of the month of April.

(IV. The Examinations in the Faculty of Law shall be held in the beginning of the month of February.) Repealed by Stat. liv.

V. Additional Examinations for Matriculation may be held at such other periods of the year as the Senate may by resolution appoint, but no Scholarships or Honors shall be awarded at such additional Examinations.

VI. The Convocation for admission of Matriculants, and for conferring Degrees, shall be held in the month of June.

VII. It shall be the duty of the Vice-Chancellor, on or before the tenth of January in every year, to give public notice of the days when the regular Annual Examinations for the year will commence, and when the Convocation for the conferring of Degrees will be held.

STATUTE XIV.

OF EXAMINERS AND EXAMINATIONS.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The Examiners shall be appointed annually by resolution of Senate.

(II. The remuneration of each Examiner for his services at the annual examinations shall be twenty pounds.)

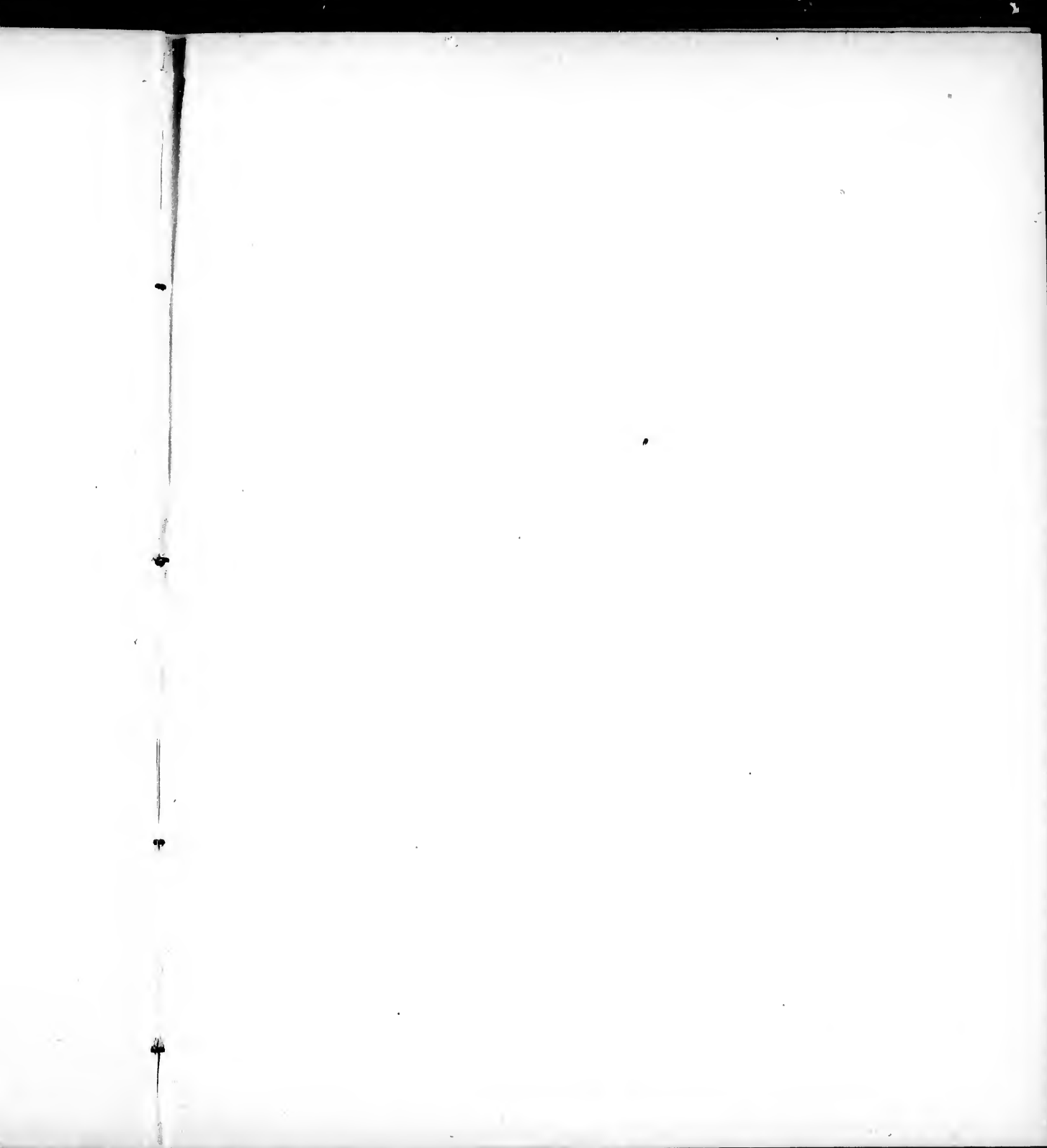
III. Every Student who proposes to present himself at any examination shall send in to the Registrar, at least three weeks before the day appointed for the commencement of the examination, a paper according to a printed form to be provided, stating the Faculty in which he is a candidate, his standing, whether he is a candidate for Honors or otherwise, and the departments or branches of departments in which he proposes to offer himself for examination.

IV. The examinations shall be conducted either wholly on paper, or partly on paper, and partly orally, at the discretion of the Examiners, with the following reservations, viz., that the same questions shall be proposed to every candidate, and that in the Department of Languages, whether ancient or modern, a part of the examination shall be *visa voce*.

V. The examinations shall be conducted under the immediate supervision of the Vice-Chancellor, by whom all the details shall be directed, and who shall present a report to the Senate, giving full information relative to all the particulars of the examinations.

VI. The Vice-Chancellor shall convene meetings of the Examiners, for the purpose of arranging and determining on all matters relative to the examinations; and he shall preside at all such meetings, or in his absence the Examiners present shall elect their own Chairman.

VII. The Vice-Chancellor, or in his absence the presiding Examiner, shall have power to call for numerical returns in all doubtful questions relative to the results of the





examinations, and any questions relative to the examinations, on which a majority of Examiners do not agree, shall be referred to the Senate.

VIII. Candidates for Honors and Scholarships shall be arranged, in each department or branch of a department, in two classes, and placed in each class according to their respective merits, and the names of those who are not entitled to a position in either class, shall be placed (below a line drawn under the lowest in standing of the second class.) Amended by
Stat. xvii.

IX. Candidates who have been examined in the subjects appointed for all Students, but not in those prescribed for candidates for Honors and Scholarships, shall be placed, in each department or branch of a department, in the third class; (and the names of those who are not entitled to a position in the third class shall be placed below a line drawn under the lowest in standing of the third class.)

X. The Registrar shall furnish each of the Examiners with printed forms, on which they shall enter the results of the examinations, and they shall return the same to the Vice-Chancellor, bearing their signatures; they shall also sign all recommendations of candidates for Degrees, Medals, Scholarships, and Prizes.

XI. No Scholarship, except one for general proficiency, shall be awarded to any candidate, who shall not be placed in the first class in the department or departments, to which the Scholarship is assigned.

XII. No candidate shall be entitled to any Medal, Scholarship, or Prize, in the Faculty of Arts, awarded for proficiency, in more than one department or branch of a department (except Scholarship for General Proficiency), who is not placed in the first class in each such department or branch of a department.

XIII. No candidate shall be entitled to any Medal in the Faculty of Medicine, unless he shall have been classed in Honors in all the departments comprised in the Examination, nor shall he be entitled to any Scholarship unless he shall have been classed in Honors in at least two-thirds of such departments.

XIV. In all cases of Medals, Scholarships, or Prizes, which are awarded for Proficiency in departments or branches of departments, which are under different Examiners, the

recommendation for such Medals, Scholarships, or Prizes shall be signed by the Examiners in all the departments or branches included in such decision ; and if, after reporting the result to the meeting, of Examiners in that Faculty, any of the original Examiners shall dissent from the decision of the meeting, then each shall report to the Senate the value assigned by him to the answers of the candidate in the subjects under his charge, assuming the whole value of the questions proposed therein to be 100, and the Senate shall make the award.

XV. No candidate shall be reported as having passed, unless all the Examiners by whom he has been examined assent to the report, or it be otherwise decided by a majority of all the Examiners in the Faculty ; but the question may by any two be referred to the Senate, in which case each Examiner shall report the value assigned by him to the answers of the candidate in the subjects under his charge, assuming the whole value of the questions proposed therein to be 100 ; and the Senate shall make the award.

XVI. The Examiners shall transmit their reports to the Vice-Chancellor, together with a copy of the examination papers and the papers sent up by the candidates.

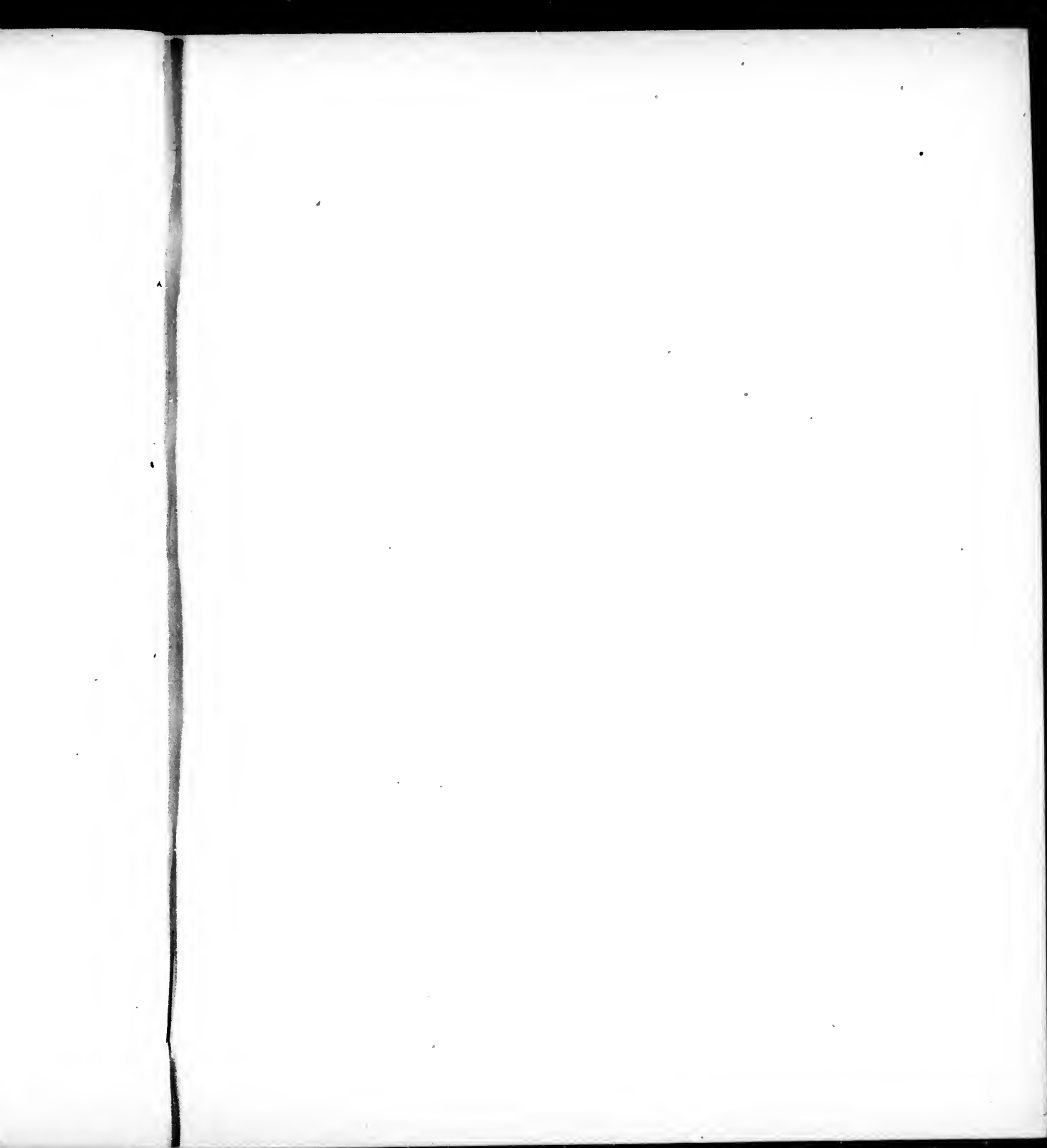

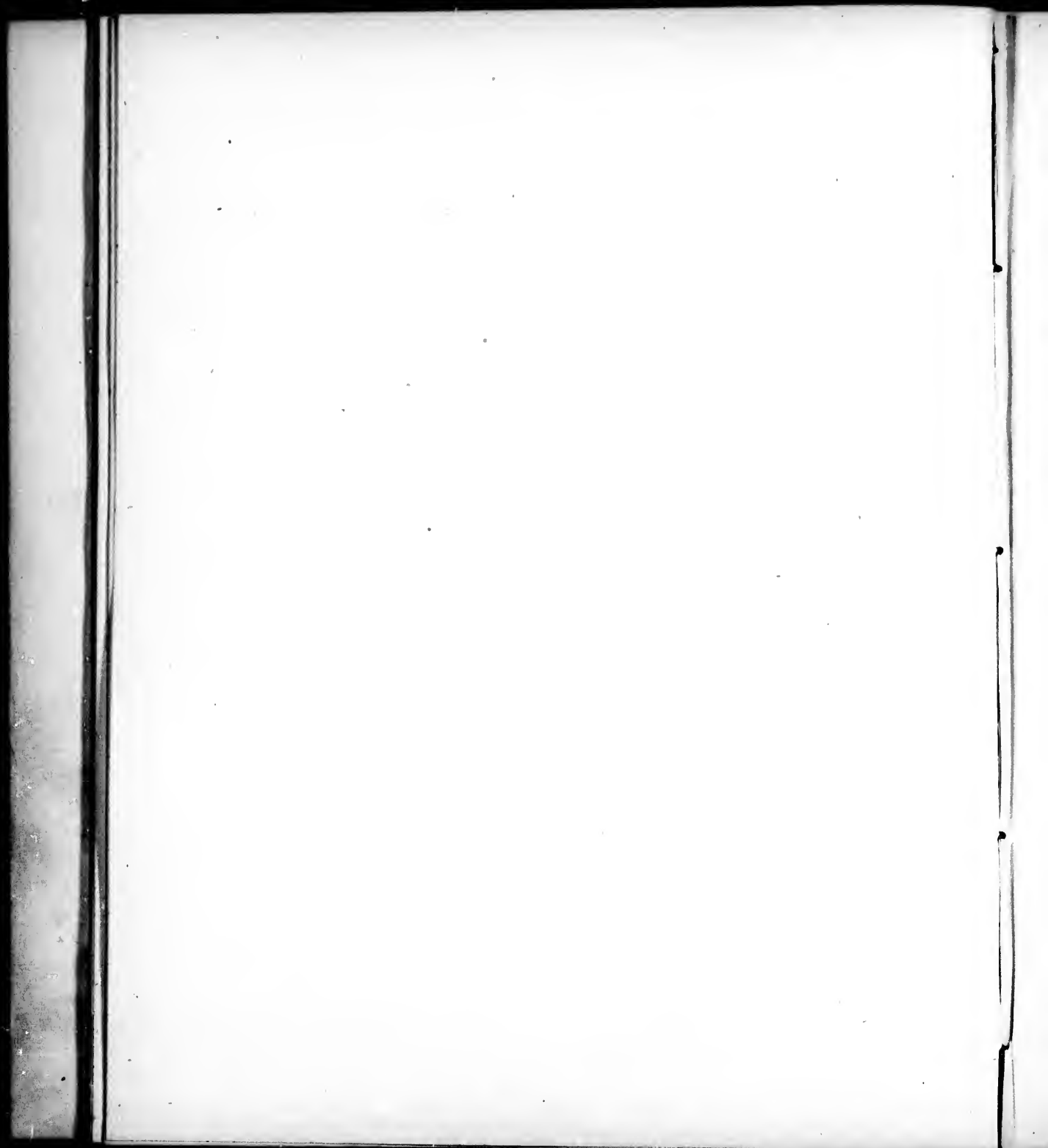

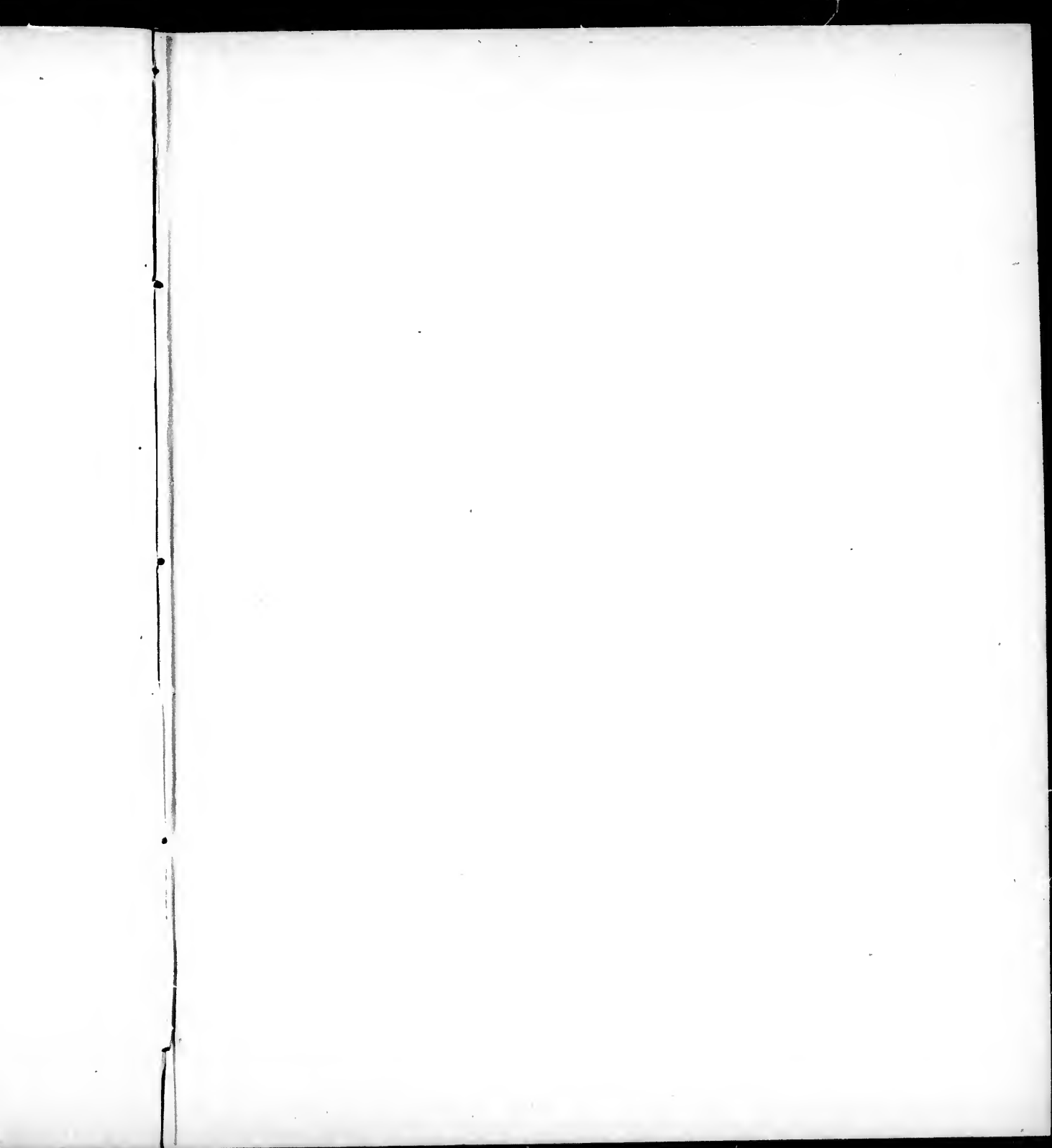

II. There shall be (ten) Scholarships in the Faculty of ^{Repealed.} Law, viz. : (four) for Matriculants, (three) for Students of one year's standing, and (three) for Students of two years' standing.

III. There shall be (ten) Scholarships in the Faculty of ^{Repealed.} Medicine, viz. : (three) for Matriculants, (three) for Students of one year's standing, (two) for Students of two years' standing, and (two) for Students of three years' standing.

IV. There shall be (thirty-seven) Scholarships in the ^{Repealed.} Faculty of Arts, viz. :

(For Matriculants—two in the Greek and Latin Classics, with History and Geography, two in Mathematics, one in Modern Languages, with History and Geography, and three for general proficiency in the subjects appointed for all Students.)

(For Students of one year's standing—two in the Greek and Latin Classics, with History, two in Mathematics, one in the Natural Sciences, one in Modern Languages, with History, one in Oriental Languages, and one for general proficiency in the subjects appointed for all Students.)

(For Students of two years' standing—two in the Greek and Latin Classics, two in Mathematics, one in the Natural Sciences, one in Modern Languages with History, one in Logic, Metaphysics, and Ethics, and one in Oriental Languages.)

(For Students of three years' standing—two in the Greek and Latin Classics, with Ethnology, two in Mathematics, one in the Natural Sciences, one in Modern Languages, with History, one in Ethics and Metaphysics, with Civil Polity and History, and one in Oriental Languages.)

(For Candidates for the Degree of Bachelor of Arts—one in the Greek and Latin Classics, one in Mathematics, one in the Natural Sciences one in Modern Languages, and one in Logic, Ethics, and Metaphysics, with Civil Polity.)

(V. There shall be two Scholarships in the department of ^{Repealed.} Civil Engineering, viz. : one for Matriculants, and one for Students of one year's standing.)

(VI. There shall be two Scholarships in the department ^{Repealed.} of Agriculture, viz. : one for Matriculants, and one for Students of one year's standing.)

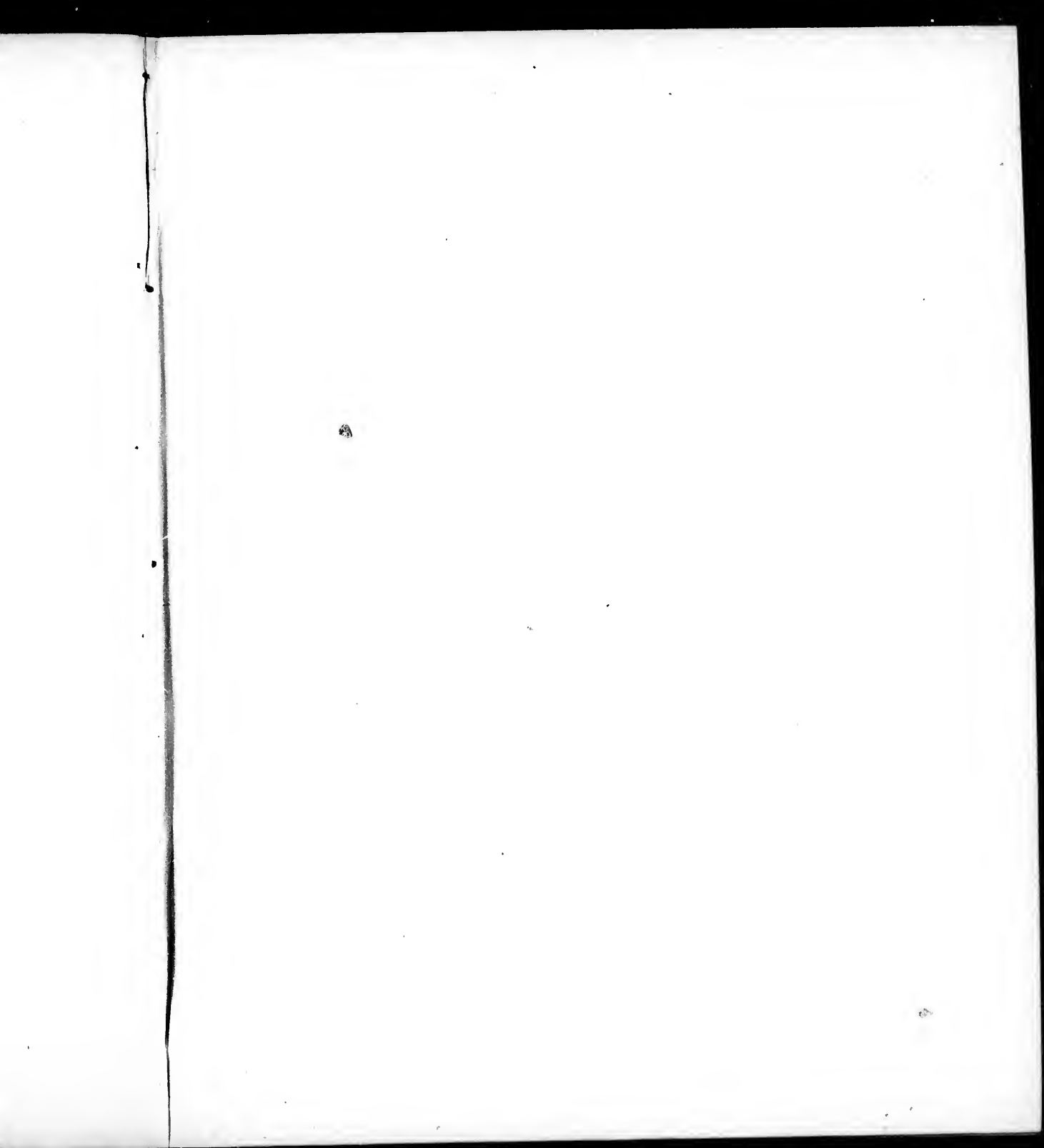

No Student shall hold two Scholarships at the same time, but if two or more Scholarships shall have been awarded him, he shall, (before the declaration of the class list, make his election which Scholarship he will hold, or if he be absent, the Vice-Chancellor shall make the election for him, and any Scholarship which is so vacated shall be awarded to the Student, if any, who would next have been entitled to it; but a Student having obtained more than one Scholarship,) shall be entitled to the sum of ten pounds for each additional Scholarship, and the Scholarship which he holds shall be called a double, triple, &c., Scholarship, as the case may be.

XI. The Senate shall have power to create additional Scholarships in any special cases, where the results of the examinations shall place two or more of the candidates so nearly equal, as to induce the Examiners to report each of them to be deserving of a Scholarship.

XII. Scholars in all the Faculties shall be required to sign a declaration that it is their intention to proceed to a Degree in the University of Toronto, (and Scholars in the Department of Civil Engineering and Agriculture shall sign a declaration that they propose to follow those branches as a profession, and to pursue the study in one of the Colleges affiliated to the University.)

STATUTE XXI.
OF MEDALS, PRIZES, AND CERTIFICATES OF
HONOR.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. Gold Medals shall be given to the Students who, at the final examination for the Degrees of LL.B. and M.B., shall have been placed first in the first class of Honors.

II. Gold Medals shall be given to the Students who, in the final examination for the degree of B.A., shall have been placed first in the first class of Honors in the following departments:

The Greek and Latin Classics.
Mathematics (pure and applied).
The Natural Sciences.
Modern Languages.
Logic, Ethics, and Metaphysics, with Civil Polity.

III. Silver Medals shall be given to all Students who, at the final examination for the Degrees of LL.B. and M.B., shall have been placed in any position in the first class below the first; and to all Students who, at the final examination for the Degree of B.A., shall have been placed in any of the above-named departments in any position in the first class below the first.

IV. A Prize in Books of the value of five pounds, shall be given to each candidate who, at the final examination for the degree of B.A., shall have been placed first in (any single branch) in the Natural Sciences.

V. A Prize in Books of the value of ten (pounds) shall be given to any Student who, at the final examination for the degree of B.A., shall have been placed first in the first class in Oriental Languages.

(VII. Three Prizes of the value of £6, £4, and £2, respectively, shall be given in each of the Faculties of Law, Medicine, and Arts, for the three best Theses by Candidates for the degrees of LL.D., M.D., and M.A.)

VIII. The Prizes to which the University Arms shall be attached shall not exceed three volumes in each case.

IX. Certificates of Honor shall be given to those Students who shall have been placed in the first class in any Department.

X. Any person who does not propose to proceed to a Degree in the University may, upon application to that effect to the Vice-Chancellor, be admitted to offer himself for examination in any one or more of the Departments appointed for the final examination for the degree of B.A., and if he shall have been placed in the first class at such examination, he shall receive a Certificate of Honor.

XI. The Certificates of Honor, and those attached to the prize books, shall be signed by the Chancellor, or in his absence by the Vice-Chancellor, and shall be counter-signed by the Registrar of the University.

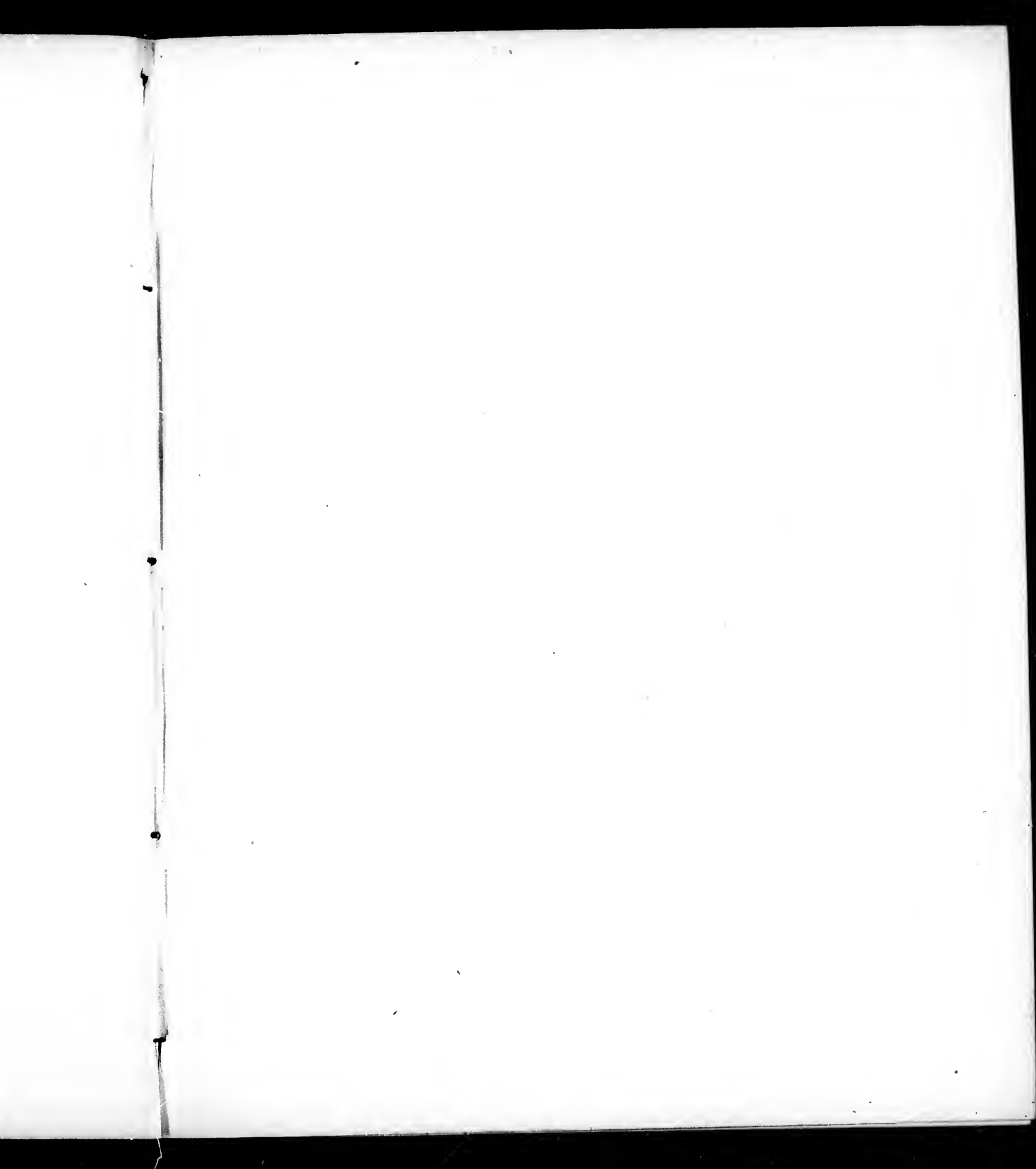
STATUTE XXII.
OF THE LIBRARY.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The Library of the University shall be under the superintendence of a Committee, to be called the Library Committee, which shall consist of seven persons, three of whom shall be a quorum, viz.: the Chancellor, the Vice-Chancellor, the President of University College, and four other persons, two of whom shall be members of the Council of University College, if members of the Senate. The appointments shall be made annually by the Senate, on the (Thursday next before Christmas;) but if a vacancy occur in the interval, it may be filled up by the Senate at any other time.

II. In the event of the President of University College being either Chancellor or Vice-Chancellor, he shall be a member of the Committee as President of University College, and the Senate shall appoint another member.

III. The Committee shall order all purchases of books, and all fittings-up for their proper arrangement; and all accounts shall be first approved of by the Committee, and the Chairman shall thereupon sign an order on the Bursar, who shall pay the same from the funds in his hands applicable to that purpose.

IV. The Committee shall make from time to time such regulations as they shall think necessary for the safe-keeping of the books, and the accommodation of persons using the Library.

V. Until such time as the new buildings are completed all Members and Officers of the Senate, all Graduates and Matriculated Students of the University, all Officers and Students of University College, all Masters of Upper Canada College, and all Officers of any affiliated Institution, shall have access to the Library. After a reading room has been provided in the new building, the Library shall be open to all persons who enter their names in a book to be kept for that purpose.

VI. Members of the Senate, and Professors of University College, shall be permitted to take books out of the Library subject to such regulations as may from time to time be made by the Library Committee; but no other person shall take books out of the Library except on the order of the Library Committee.

VII. The Librarian shall be appointed by the Senate, and they shall also provide such other assistance as may be found necessary.

VIII. The salary of the Librarian shall be at the rate of (three hundred pounds) a year. Amended by Stat lxxxI.

STATUTE XXIII.
OF THE MUSEUM.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The care of the Museum shall be entrusted to five Directors, viz.: the President of University College, and the Professors of Chemistry, Natural Philosophy, Natural History, and Mineralogy and Geology, in University College.

II. The Directors, or the majority of them, shall report from time to time to the Senate upon the condition of the Museum, the amounts which they think it desirable should be expended in the several departments, including chemical and Philosophical Apparatus, and upon the fittings-up for the proper arrangement of the collections; and they shall also recommend such Regulations as they may deem necessary for the safe keeping of the Museum.

III. The Senate may, by resolution, from time to time, authorize the expenditure of any sum upon the Museum, or upon the different departments thereof, out of any moneys already appropriated for that purpose, and the Vice-Chancellor shall have authority to sign orders upon the Bursar to such amounts, upon the certificate of the Chairman of the Directors.

IV. The Senate shall make regulations for the admission of visitors to the Museum, and for the safe-keeping of the collections.

V. The Professors of University College may remove from the Museum such specimens or apparatus as shall be necessary for the illustration of their lectures, subject to the regulations which may be made by the Senate.

VI. The Senate may appoint a Curator or Curators, with such other assistance as may be found necessary.

STATUTE XXIV.
OF THE GROUNDS.

BY THE SENATE OF THE UNIVERSITY OF TORONTO.

Be it enacted :

I. The superintendence of the University Grounds shall be entrusted to a Committee consisting of five persons, any three of whom shall be a quorum, viz : the Chancellor, the Vice-Chancellor, the President of University College, and two other persons, who shall be appointed annually by the Senate, on the (Thursday next before Christmas) ; but if a vacancy occur in the interval, it may be filled up by the Senate at any other time.

II. In the event of the President of University College being either Chancellor or Vice-Chancellor, he shall be a member of the Committee as President of University College, and the Senate shall appoint another member.

III. The Committee shall decide upon all improvements and alterations, and all expenditure which may be necessary for keeping the Grounds in order, and all accounts shall be first approved of at a meeting of the Committee, and the Chairman shall thereupon sign an order on the Bursar, who shall pay the same out of the funds in his hands, which shall have been appropriated for that purpose by the Senate.

STATUTE XXV.
OF THE OBSERVATORY.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The ordinary management of the Observatory shall be vested in the Director, subject to the authority of the Senate, or of the Committee of Management to be appointed by it.

II. The Committee of Management shall consist of five persons, any three of whom shall be a quorum, viz : the Chancellor, the Vice-Chancellor, the Chief Superintendent of Schools, and two other persons, who shall be appointed annually by the Senate on the (Thursday next before Christmas) ; but if a vacancy occur in the interval, it may be filled up by the Senate at any other time.

III. It shall be the duty of the Committee of Management to visit the Observatory from time to time and inspect its affairs, and to make at least one report during the year to the Senate relative to its conditions and prospects.

IV. The Committee of Management may authorize the Director to obtain such additional assistance as may from time to time appear to them to be necessary.

V. The Bursar shall pay all salaries, and the ordinary contingent expenses of the Observatory, on the certificate of the Director, who shall lay before the Committee at the end of each quarter a statement of all such payments authorized by him.

VI. All ordinary expenditure upon the buildings, enclosures, and approaches to the Observatory, and upon instruments, shall be approved of by the Committee, and shall be paid by the Bursar, upon the certificate of the Chairman.

VII. The fund out of which the Bursar shall pay the expenses of the Observatory, shall be the annual Parliamentary grant, and such other sum as may from time to time be placed at the disposal of the Committee out of the University Income Fund.

STATUTE XXVI.

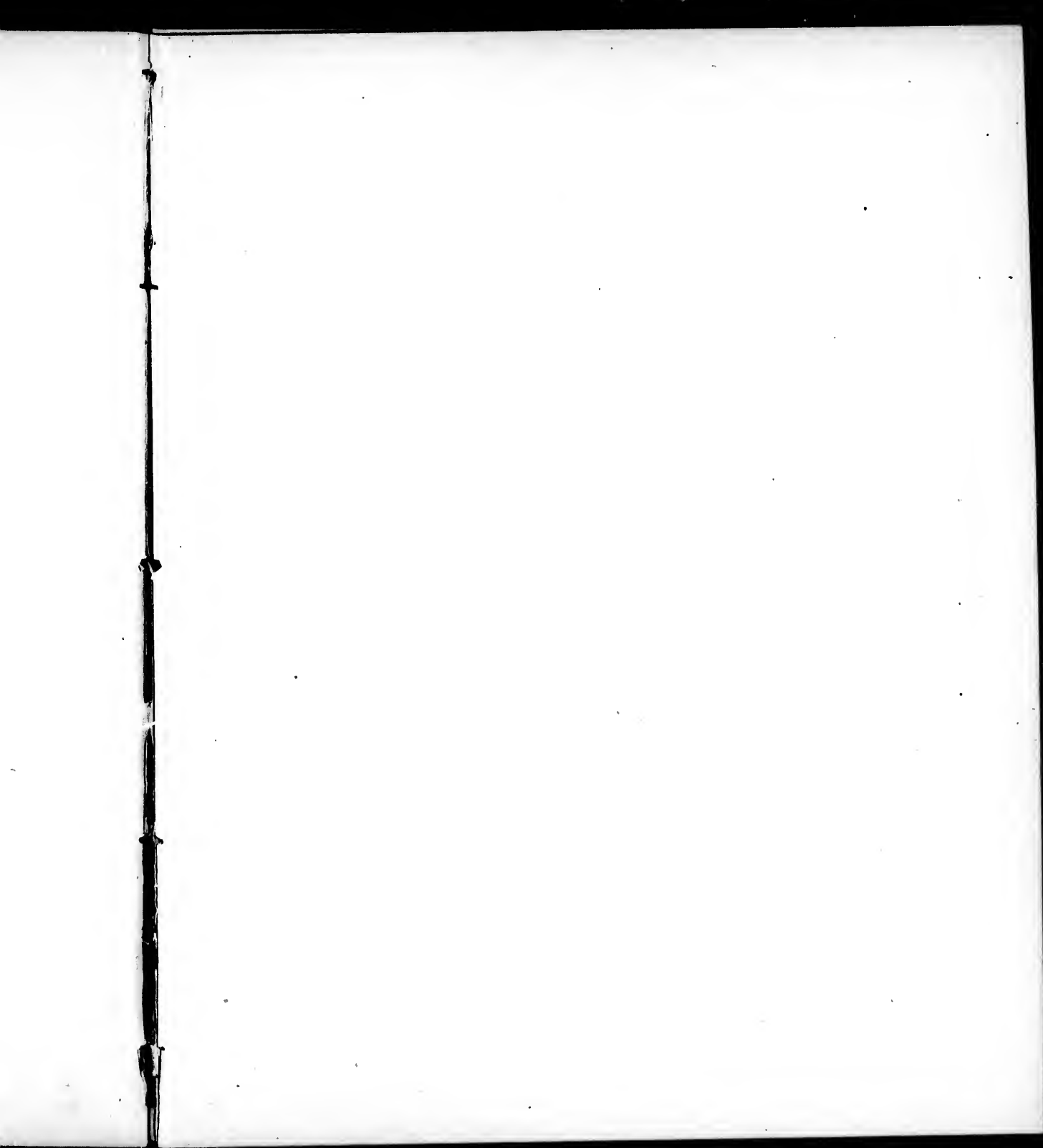
OF THE COMMITTEE OF UPPER CANADA
COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The Senate shall appoint annually, at the first meeting of the Session in (May,) a Committee for the supervision of Upper Canada College, which shall consist of (three) Members, any (two) of whom shall form a quorum.





II. It shall be the duty of the Committee to visit the College from time to time, and to offer to the Senate such recommendations as they may deem calculated to benefit the Institution.

III. The Committee shall have authority to suspend the Principal or any of the Masters; but they shall communicate without delay the facts and grounds of such suspension to the Chancellor, for the information of the Senate, who shall confirm or remove it as they see fit.

IV. The Committee shall have authority to order and superintend such alterations in the buildings as may from time to time be approved of by the Senate; they shall cause to be put in proper condition, as a play ground, so much of the land lying to the westward of the present lawn as they may deem requisite; and they shall take such other steps as may be necessary for the purpose of providing for the Pupils the means of exercise and amusement upon the grounds.

V. In all cases not provided for by this Statute, the Committee shall have authority to act in such manner as they may think desirable for the well-being of the College, and shall, in every case, communicate such action to the Chancellor for the information of the Senate.

STATUTE XXVII.

OF FEES AND AND SALARIES IN UPPER
CANADA COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The Fees payable for Tuition by Pupils attending the College shall be One Pound Five Shillings per Term, or such sum as may from time to time be fixed by resolution of the Senate.

II. The Fees payable for Board by Pupils living in the College Boarding-house shall be Ten Pounds per Term, or such sum as may from time to time be fixed by resolution of the Senate.

(III. All Fees shall be payable in advance, and no Pupil shall be entitled to admission until his fees have been paid.)

VIII. The Salary of each of the three Classical Masters and of the Mathematical Master, shall be at the rate of £334 per annum, with his share of the Fees and a residence.

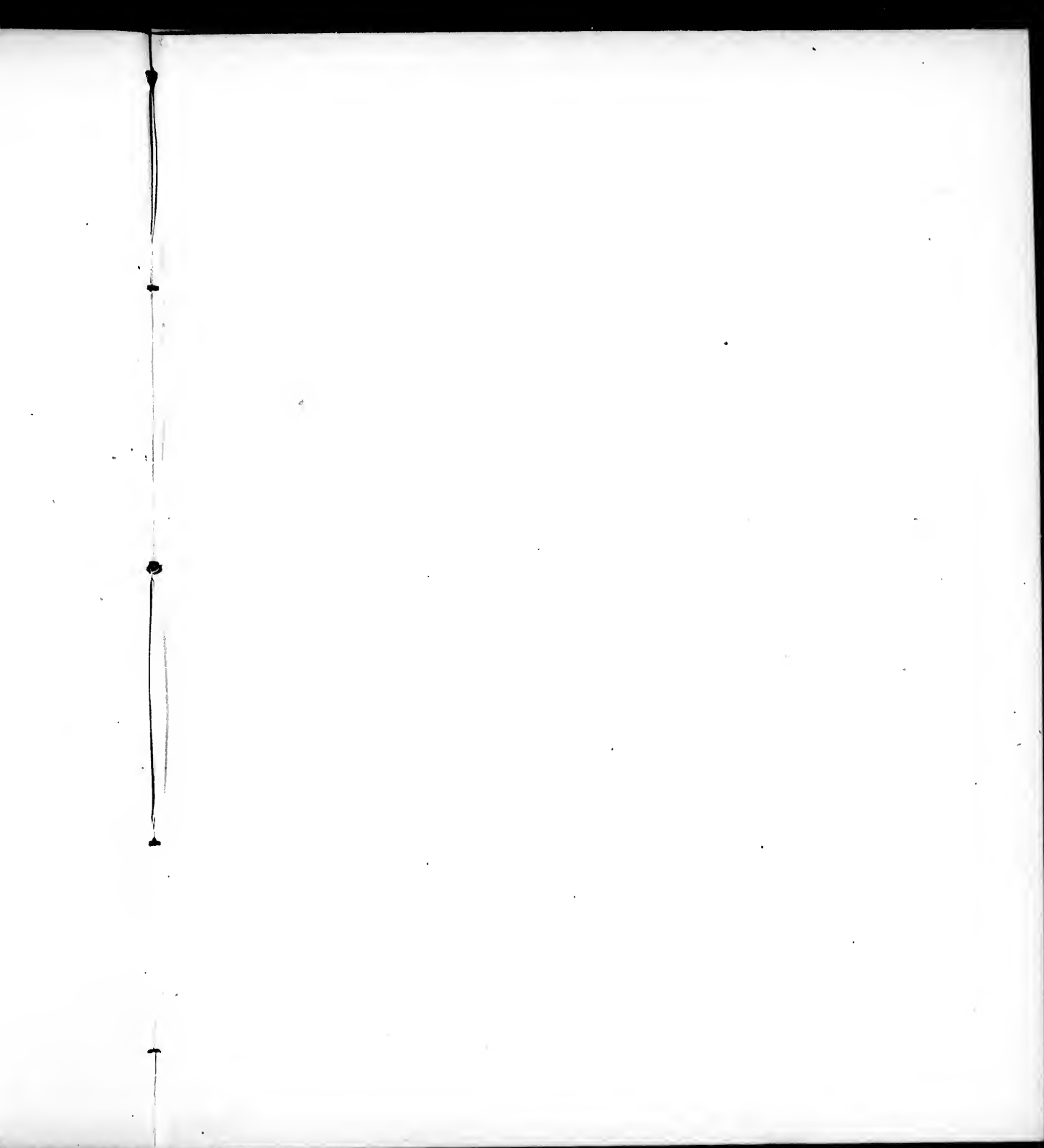

X. The Salary of the first English Master shall be at the rate of £200 per annum, with his share of the Fees and a residence.

XII. The Senate shall from time to time determine, by resolution, the Salary or rate of remuneration of any occasional Masters who may be engaged in the College, and the Salaries of the Servants employed.



STATUTE XXVIII.
OF UPPER CANADA COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The ordinary Government of the College shall be vested in the Principal, subject to the control of the Committee of the Senate.

II. If the office of Principal be vacant, or during the absence of the Principal, similar powers shall be vested in the Master next in seniority.

III. The Masters shall rank as follows, viz. :

- (1) The first Classical and the Mathematical Masters, according to date of original appointment.
- (2) The second Classical Master.
- (3) The third Classical Master.
- (4) The first English and the French Masters, according to date of appointment.
- (5) The second English Master and the Commercial Master, according to date of appointment.

IV. The general superintendence of, and maintenance of discipline within, the College Boarding-house shall be the especial duty of the Principal, subject, however, to the control of the Committee, and with such assistance from the Masters as may be required by the Principal.

V. The superintendence of the economic details of the College Boarding-house shall be entrusted, subject to the general control of the Principal, to an Officer, who may be one of the Masters, or otherwise, whose duties shall from time to time be defined by the Committee, and who shall receive such allowance as the Senate may determine upon.

VI. The Bursar shall pay the expenses of the College Boarding-house out of the Income Fund upon the order of the Principal.

VII. The Superintendent of the College Boarding-house shall keep accounts, with proper vouchers, of all the expenses of the establishment. His books shall at all times be open to the Principal and to the Committee, and at the end of each Term he shall submit his accounts to the Committee for audit.

VIII. It shall be the duty of the Principal to ascertain the place of residence of all Students in the College, and to exercise a general oversight over those not resident with their parents or guardians.

IX. The Principal is authorized to suspend or expel, as may be necessary, any of the Pupils; but he shall not exercise the power of expulsion without having previously communicated with the Masters in Council, and made a minute of the reasons for the course pursued, and he shall, within three days, forward to the Committee a copy of the minute.

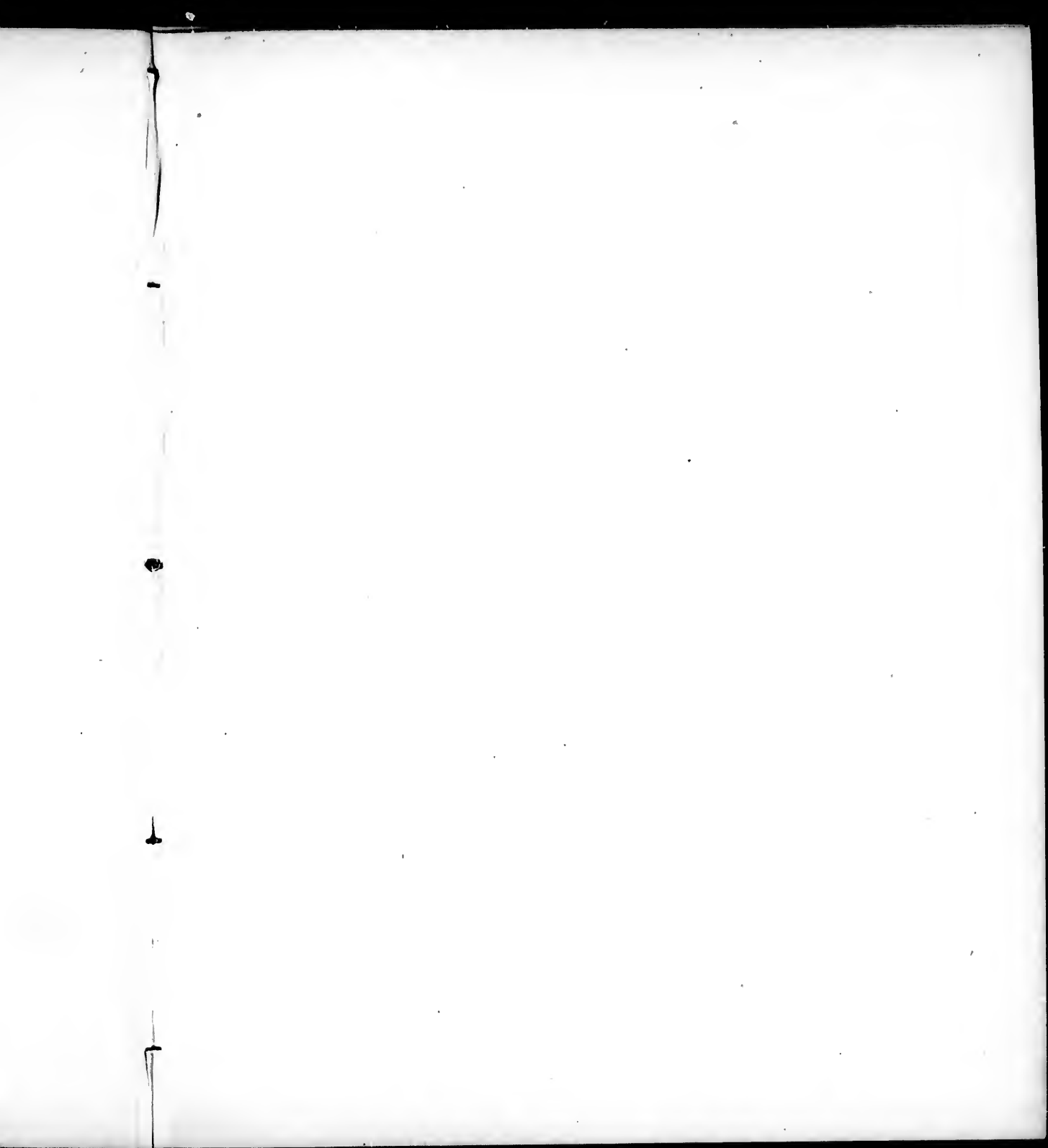

STATUTE XXX.

OF THE ENGLISH CLASSICAL MASTER IN
UPPER CANADA COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. There shall be an additional Master in Upper Canada College, to be called the English Classical Master, who shall rank with the second and third Classical Masters according to seniority of appointment in the College.

II. The English Classical Master shall receive a salary at the rate of three hundred pounds per annum, together with his share of the tuition fees; and he shall be entitled to a residence, in case of any becoming vacant, in the order of his seniority.

STATUTE XXXI.

OF EXHIBITIONS IN UPPER CANADA COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. In place of all Exhibitions heretofore established in Upper Canada College there shall be founded nine Exhibitions, three of which shall be called First Exhibitions, and shall entitle the holders to the sum of twenty pounds and tuition free; three, to be called Second Exhibitions, shall entitle the holders to the sum of ten pounds and tuition free; and three, to be called Third Exhibitions, shall entitle the holders to tuition free. II. All such Exhibitions shall be open for competition to the whole Province, and shall be awarded after a public examination to be held at the end of the summer term, and they shall be tenable for one year by pupils attending Stat. lxxxiii.

regularly at Upper Canada College; but the Exhibitioner of one year may compete for the Exhibitions of succeeding years.

III. There shall be annually awarded for proficiency in the subjects which form the annual course of the Fourth Class in Upper Canada College four Exhibitions, viz.: One First, one Second, and two Third; for proficiency in the subjects which form the annual course of the Fifth Class three Exhibitions, viz.: one First, one Second, and one Third; and for proficiency in the subjects, which form the annual course of the Sixth Class two Exhibitions, viz.: one First and one Second.

IV. It shall be the duty of the Principal of Upper Canada College to cause to be printed and distributed to each Grammar School in the Province, and to such other persons as may apply for the same, a statement of the subjects which form the annual courses for the Fourth, Fifth, and Sixth Classes, respectively, naming the text books which are used in the College; and he shall also cause the time of the annual examination to be advertized.

V. The Principal of Upper Canada College shall annually name two Examiners who shall be entitled to receive the sum of (seven pounds ten shillings each,) for their services who, with the assistance of such of the Masters in the College as they may call upon, shall conduct the Examination and report to the Principal the candidates who have shewn the greatest proficiency. *

VII. Two medals for 1/4 by one card of appl. & sch. reg. U.C. Coll. become fund.

VIII. No free help, except those holding Exhib.

Whereas, it is expedient that the Gold Medals being the highest honor in the University should be awarded only for very superior merit; By the Senate &c

II No Gold Medal shall be awarded except to such Students as at the Final Examⁿ for the degrees of B. A. & B. Sc. shall have been placed in the first class of Honors in the Faculties of Law & Medicine or first in the first class of Honors in the following Dept: of the Faculty of Arts viz: Greek, Latin, Classics, Mathematics (Pure & applied), Natural Sciences, Modern Languages, Logic, Ethics, & Metaphysics with Civil Polity.

III No Gold Medal shall be awarded except upon the special recommendation of the Exr. in the Faculty or Department to which the award is made.

STATUTE XXXVI.
OF DEGREES, &c.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

I No graduate or student in any other University shall be
Be it enacted: *admitted to the like degree or to the like standing in the*
University of Toronto except in the cases hereinafter mentioned -

II. A graduate in any of the Faculties of Law, Medicine, or Arts, in any University in Great Britain or Ireland, if such Degree be not an honorary one, may, upon making application to that effect to the Senate, and upon producing satisfactory proof that he obtained such degree in regular course, be admitted to the same degree in the University of Toronto.

III. A Student in the Faculty of Arts in any University in Her Majesty's Dominions, upon making application to that effect to the Senate, and upon producing satisfactory proof of good conduct, and of his standing in such University, may be admitted to the like standing in the Faculty of Arts in the University of Toronto.

IV. A Student in such University applying to be admitted to the standing of the third or fourth years in the University of Toronto, shall not be allowed to exercise the options permitted at the examinations for those years, unless he shall also produce proof, that in such other University he had passed satisfactory examinations in the departments which he proposes to omit.

V. A Student applying to be admitted to any lower standing in the University of Toronto than he held in such other University, shall not be permitted to compete for any Scholarship, or be classed in Honors, at any examination for Students of a lower standing than that which he held in such other University; but if the Examiners shall report that he was otherwise entitled to be classed in Honors, he shall at the next succeeding examinations be permitted to exercise the options of a Student who had been classed in Honors.

VI. No Undergraduate who shall have been admitted to any standing in the Faculty of Arts from any other University, shall be permitted to proceed in the Faculties of Law or Medicine, without passing the Examination for

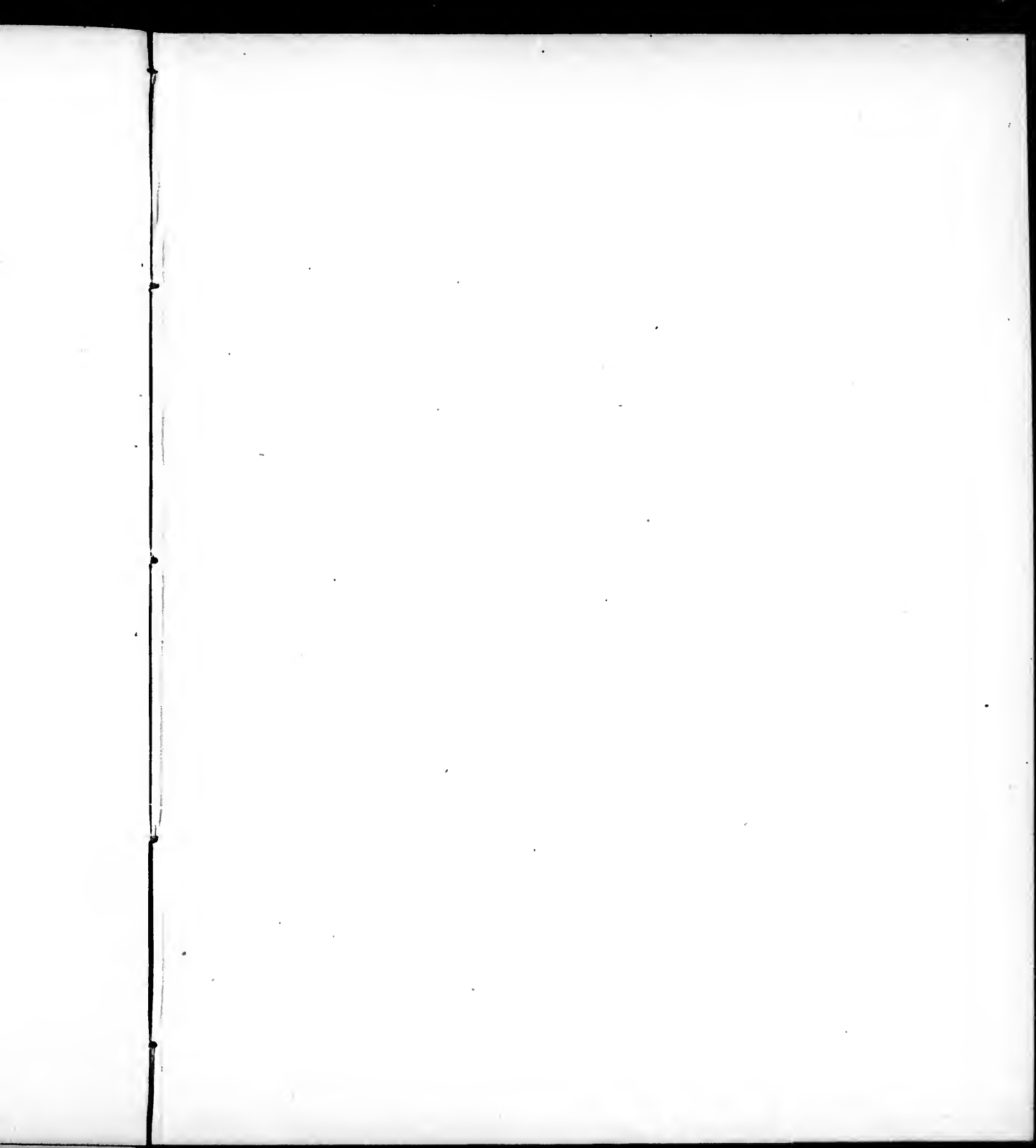
Matriculants in those Faculties, unless he shall have passed one Examination in the Faculty of Arts in the University of Toronto, but the Vice-Chancellor may appoint a special time for such Matriculation Examination, and no Honors or Scholarships shall be awarded thereat.

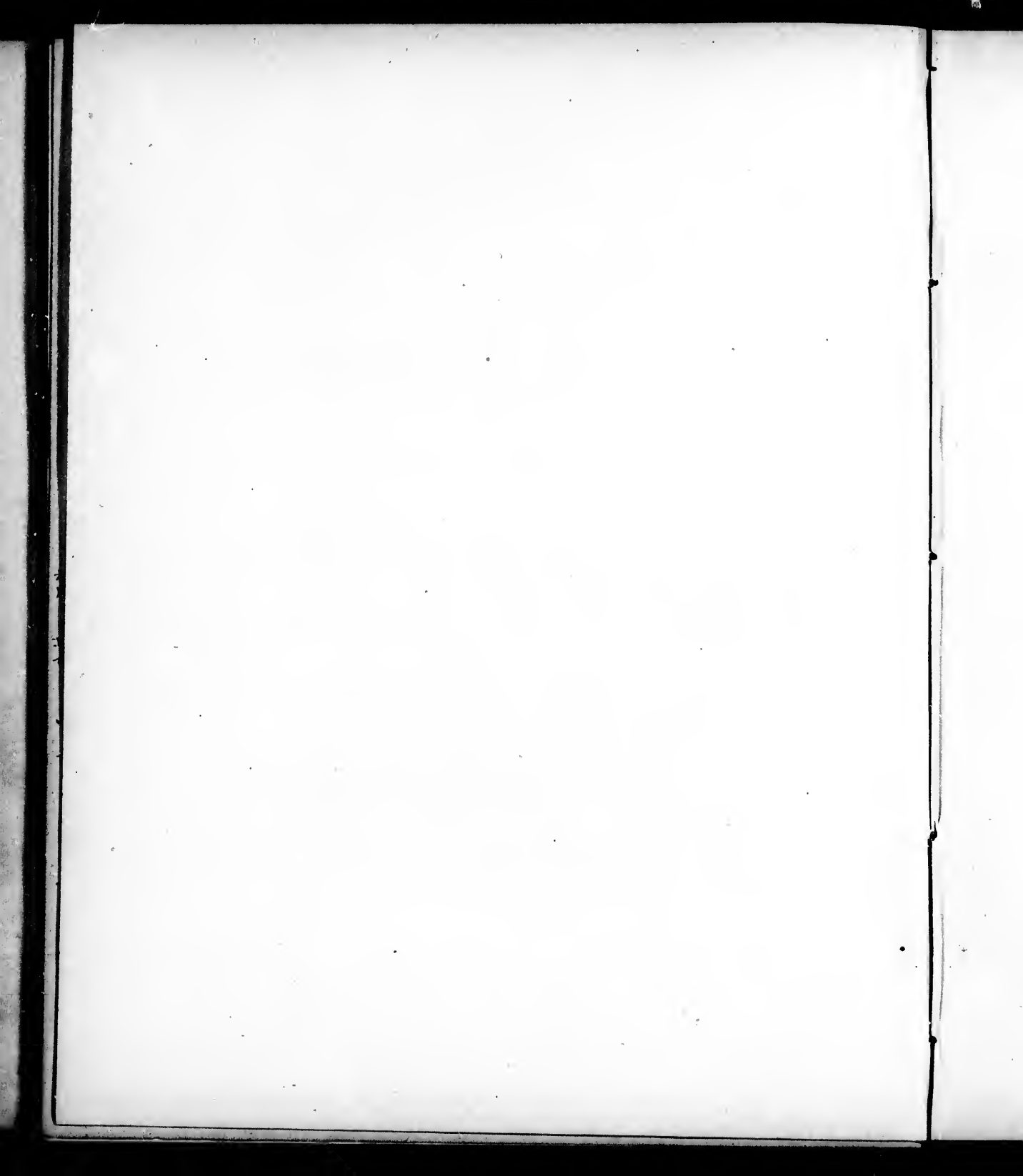
VII. A graduate in the Faculty of Arts in any University in Her Majesty's Dominions, may be permitted to proceed in the Faculties of Law or Medicine in the University of Toronto, without passing the Examination appointed for Matriculants in these Faculties.

VIII. Any person who has been admitted a Barrister by the Law Society of Upper Canada, shall be entitled to offer himself at the Examination for Students of one year's standing in the Faculty of Law without passing the Examination appointed for Matriculants in that Faculty.

IX. Any Graduate in the Faculty of Arts in the University of Toronto, of three years' standing, being also admitted a Barrister by the Law Society of Upper Canada, or any Master of Arts of seven years' standing in the University of Toronto, or any Barrister of seven years' standing from his admission by said Law Society, may be admitted to the Degree of LL.B., on passing a final Examination to be appointed for that purpose at which Examination no Honors shall be awarded.

X. All applications for admission to Degrees, or to standing, shall be sent to the Registrar, at least fourteen days before the first meeting of the regular or special session of the Senate at which the application is to be brought forward; and the Registrar in issuing the summonses for such Session shall add thereto a list of all the applicants, specifying their names, the University to which they belong, and the degree or standing which they seek to obtain in the University of Toronto.





STATUTE XXXVII.

APPROPRIATING PART OF THE GROUNDS AS A
PUBLIC PARK.

Whereas, by an Act of the Parliament of Canada, passed in the twenty-second year of Her Majesty's reign, entitled "An Act to authorize the Senate of the University of Toronto to appropriate certain lands for the purposes of a Park, and to include the same within the limits of the City of Toronto, and to extend the Police Regulations of the said City to the University lands adjacent thereto," after reciting that "whereas the Chancellor, Vice-Chancellor, and Members of the Senate of the University of Toronto, deem it expedient, with a view to the interests of the said University, to set apart a certain portion of the lands now vested in Her Majesty on behalf of the said University for the purpose of a Park. And whereas the Mayor, Aldermen, and Commonalty of the City of Toronto have offered to put in order the said Park; take charge thereof and keep the same in order, in consideration that the same may be appropriated as a Public Park to which the Public generally shall have free access. And whereas, it is for the interests, of the said University that such offer should be accepted, and that such appropriation should form part of the said City of Toronto, and that the other lands vested in Her Majesty, as aforesaid, adjacent to the City of Toronto, should be subject to the Police Regulations of the said City of Toronto, it is enacted that "The Bursar of the University of Toronto, may demise at a nominal rent for a period of nine hundred and ninety-nine years to the Mayor, Aldermen, and Commonalty of the City of Toronto, for the purposes of a Park, as well as for the use of the Professors, Students, and other Members of the University, as of the Public generally, and for no other purpose whatsoever, so much of the land vested in Her Majesty, as aforesaid, situate within, or adjacent to the limits of the said City, as said Chancellor, Vice-Chancellor, and Members of the Senate of the University may by By-law, approved of by the Governor-in-Council, set apart for such purpose, not exceeding in the whole fifty acres, in trust for the said purposes, and upon such terms and conditions as may have been heretofore, or may hereafter be agreed upon between them."

And whereas, after various conferences with the Council of the said City of Toronto, the conditions upon which the demise aforesaid shall be made, have been agreed upon as hereinafter specified.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

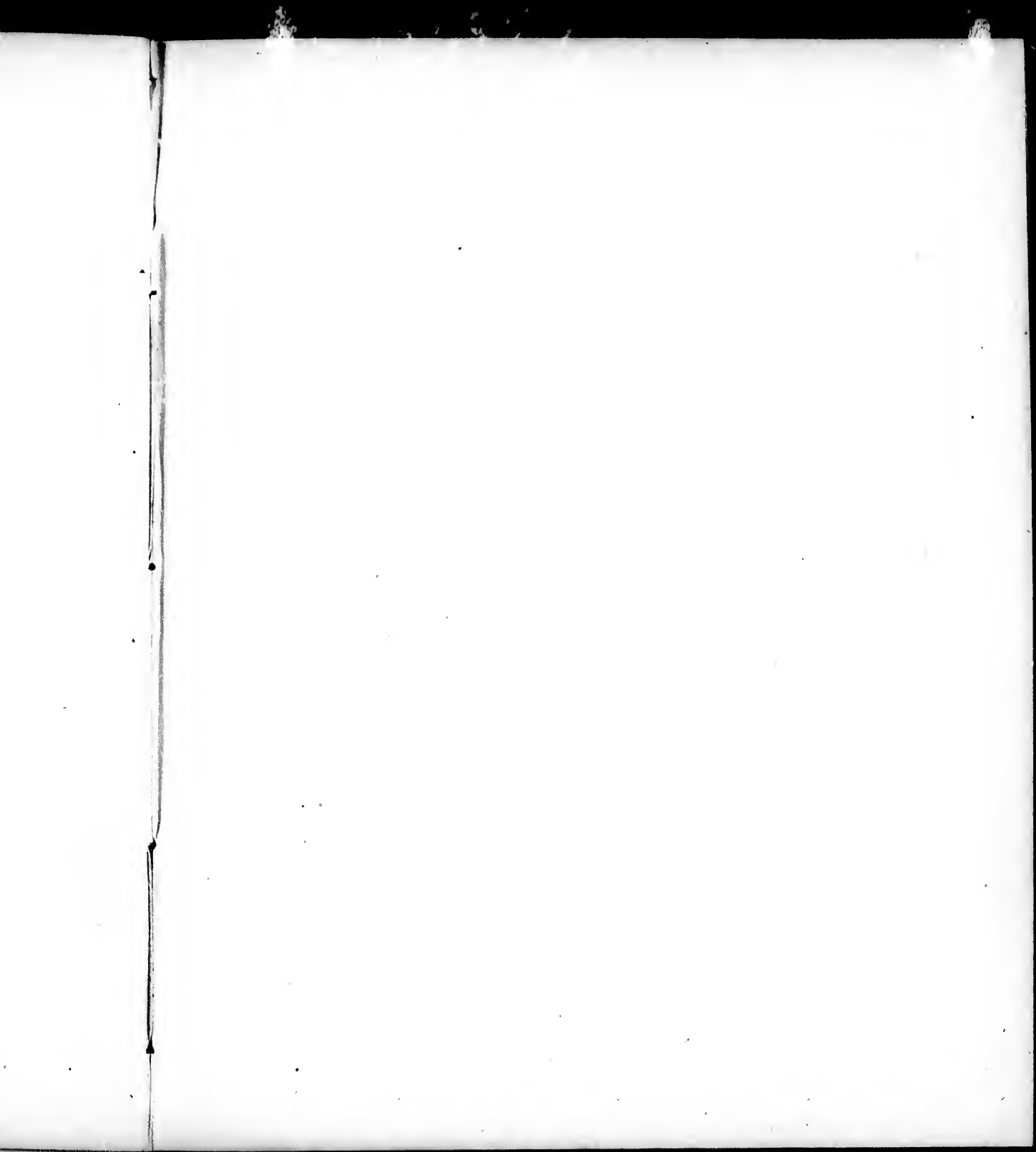
Be it enacted:

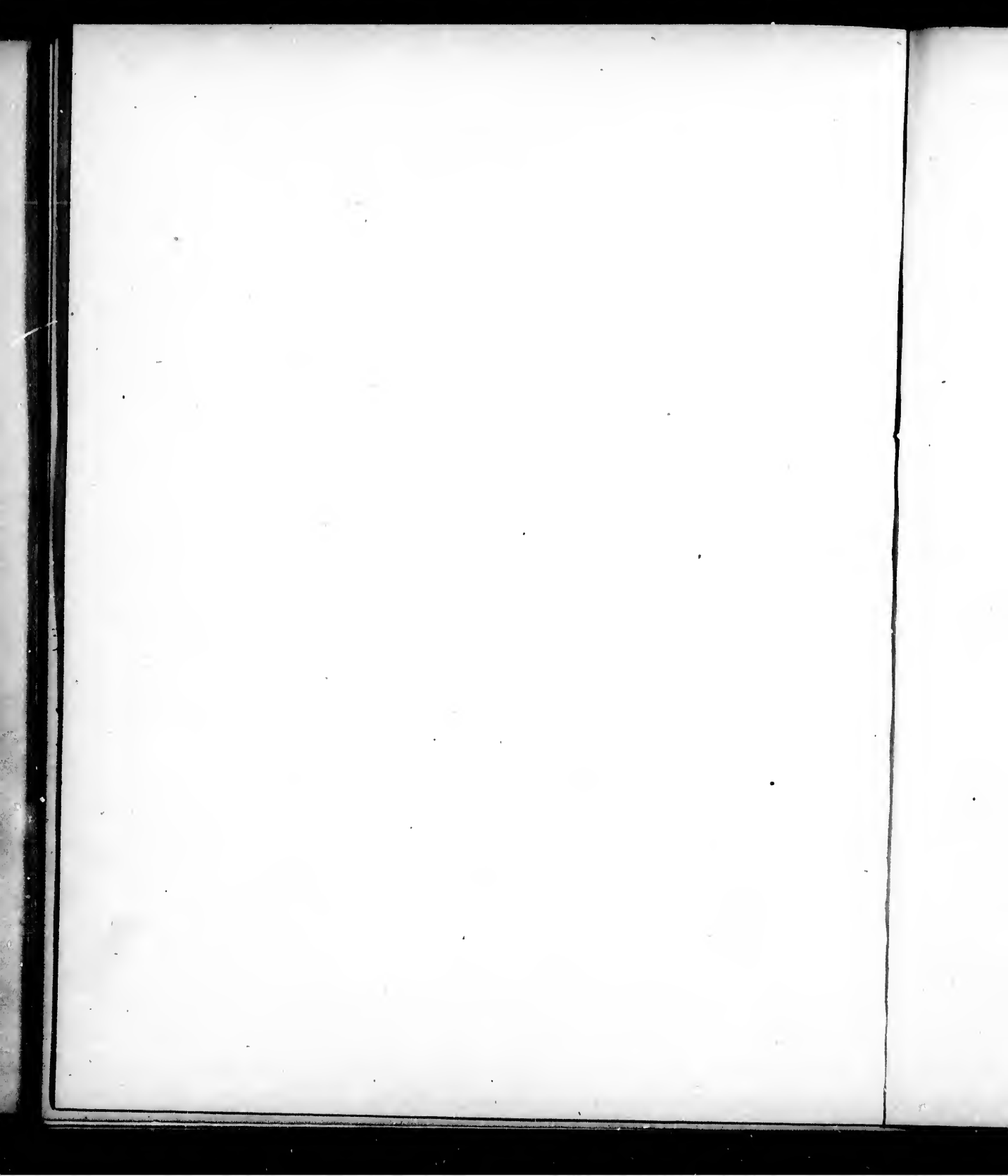
I. There shall be set apart for the purposes of a Park, as well for the Professors, Students, and other Members of the University of Toronto, and of University College, as of the Public generally, and for no other purpose whatsoever, that part of the lands aforesaid, laid out upon or described in the plan hereunto annexed, that is to say: those portions enclosed with a red line on said plan, including the Queen Street Avenue and the Yonge Street Avenue with its extension to College Street, the whole containing forty-nine acres, more or less, but subject, nevertheless, to the restrictions and conditions following:—

First. There shall be reserved in and by the base thereof the stone building with the ground immediately around it, as laid down in the said plan and marked "reserved"; such building lots used by the Senate only for Literary, Scientific, or Academical purposes, but may be sanctioned by the City Council upon application of the Senate, and if the Senate resolve at any time to sell the building, the City shall have the right of pre-emption upon condition that the same shall be used for the above purposes only, or may be used for such purposes as may be sanctioned by the Senate upon application by the City Council; and in case the said buildings should for any reason be removed or pulled down, or be sold to the City of Toronto, then the land so reserved shall be demised to the City, as part of the Park and subject to the said restrictions.

Second. Should the Senate hereafter decide upon forming a Botanic Garden within the Grounds so demised for a Park, there shall be reserved the right to occupy that portion of the land designated upon the plan "Botanic Garden," for that purpose, such garden to be made and maintained at the expense of the University, and to be open to the Public under such restrictions and conditions as the Senate may impose.

Third. No building or buildings shall be erected or placed within the Public Park or Avenues.





Fourth. Those persons to whom the University shall lease or sell building lots fronting on the Public Park or on the Avenues shall have free access through the Park and Avenues at all times.

Fifth. Free access to the Park shall be provided by the University at all times through the two gates on the East and the gate on the North as shewn upon the plan or in such other way as the Senate and City may agree upon.

Sixth. The roads and ornamental grounds within the Public Park, the lodges connected with the Park, and the approaches thereto shall be put in repair and kept in all necessary repair by the City Council. It shall also be the duty of the City Council to provide for, and carry into effect, that proper care shall be taken of the same, and that the Avenues shall be sufficiently lighted with gas, and watched by the City Police; this shall not, however, include the Botanic Garden, should the Senate establish one.

Seventh. The City Council shall construct a suitable fence around the Public Park herein mentioned, or such part of it as they may be so required to do by the Senate.

Eighth. All the roads, lodges, fences, &c., which the City Council is hereby required to construct and put in repair, shall be so constructed or repaired within one year from the date of the lease hereby authorized to be executed.

Ninth. The lease of the said grounds, authorized by this Statute shall contain full and proper covenants, both on the part of the City Council and University of Toronto, for the due performance of the stipulations herein mentioned, and shall also contain proper conditions and provisoes, that the same shall become void in case of refusal or neglect on the part of the City Council to perform the stipulations on their part, and in such case the Bursar may re-enter upon the lands demised.

II. Before any lease, however, shall be executed by the Bursar under the authority of the said Act of Parliament and of this Statute, the same shall be submitted to the Senate first, for the approval thereof to be endorsed upon the same.

STATUTE XXXVIII.

OF THE FRENCH MASTERSHIP IN UPPER
CANADA COLLEGE.

Whereas, the French Master in Upper Canada College has sent in his resignation, accompanied by a memorial praying that he may be allowed some compensation on retiring, and the said resignation has been accepted ;

And whereas, it is not expedient that the French Master should hereafter be a permanent Master, according to the provisions of the 27th and 28th Statutes of the University of Toronto.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The 9th section of the 27th Statute, and so much of the 3rd section of the 28th Statute as determine the rank of the French Master, are hereby repealed.

OF FEES IN UPPER CANADA COLLEGE.

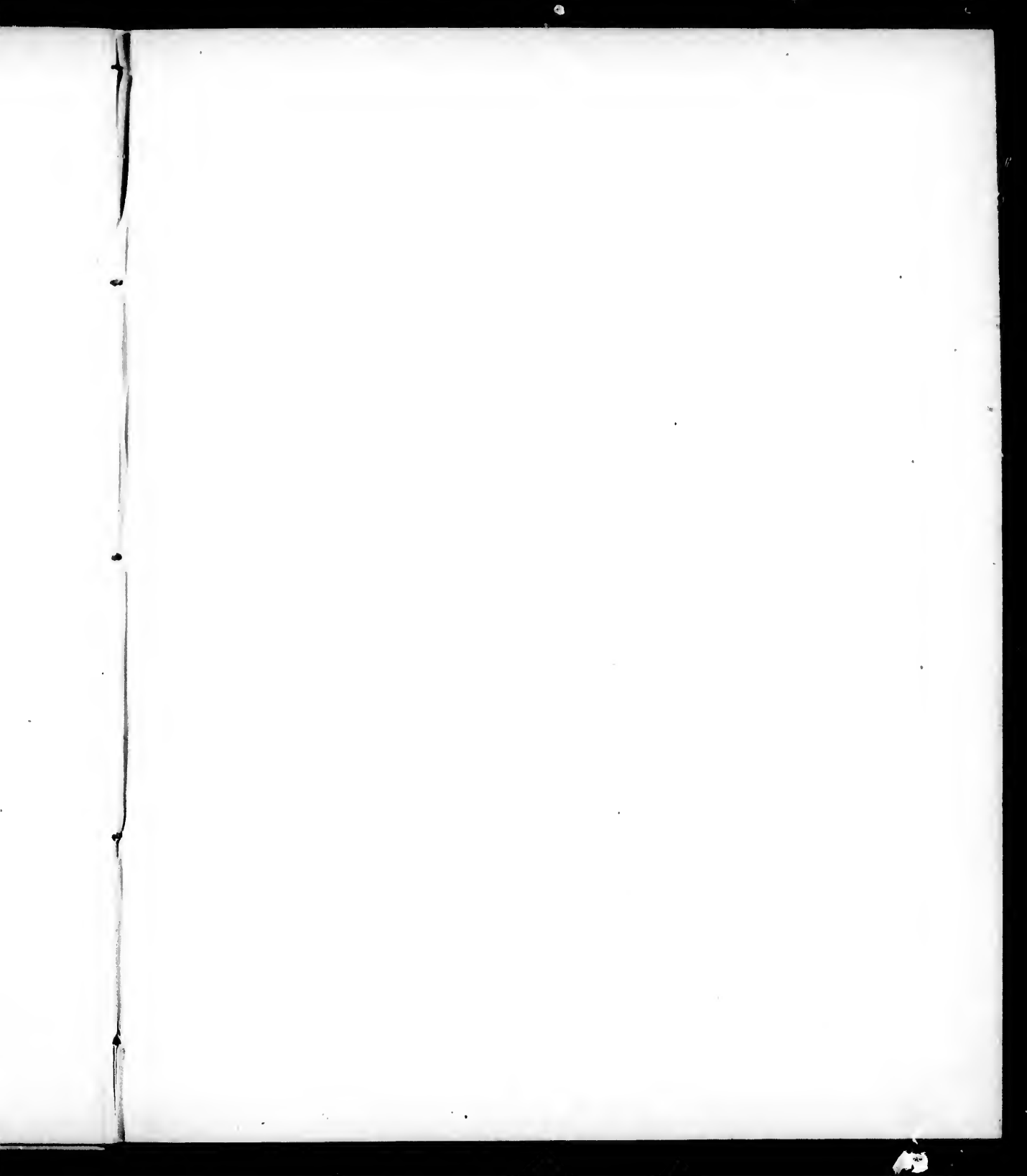

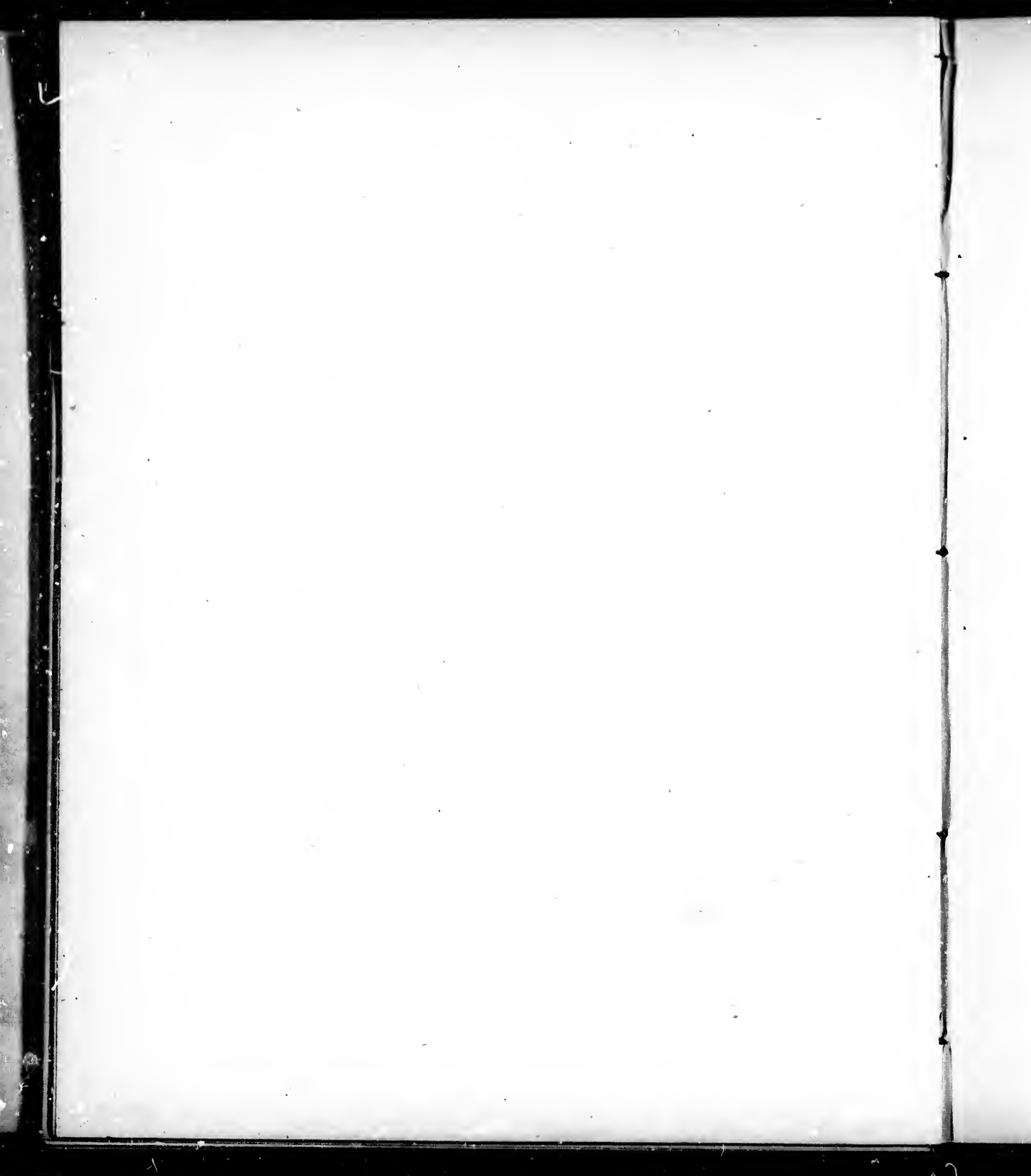
BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The Tuition Fee for one Pupil shall be at the rate of (eight) dollars per term ; if there shall be two Pupils from one family, the fee shall be at the rate of (seven) dollars each per term ; if there shall be three Pupils from one family, the fees shall be at the rate of (six) dollars each per term ; (if there shall be four Pupils from one family, the fee shall be at the rate of five dollars each per term.)

II. The Tuition Fee for Pupils in the Boarding-house shall in all cases remain at the rate of (five) dollars per term. Amended by Stat. IX.

III. The half of all the Tuition Fees collected shall not be divided amongst the Masters, as provided by the 5th section of the 27th Statute; but the sum of two-and-a-half dollars only for each Pupil shall continue to be so divided.

IV. The new scale of fees shall take effect for new Pupils from the commencement of the year 1869, and for old Pupils from the commencement of the spring term of the same year. 5/

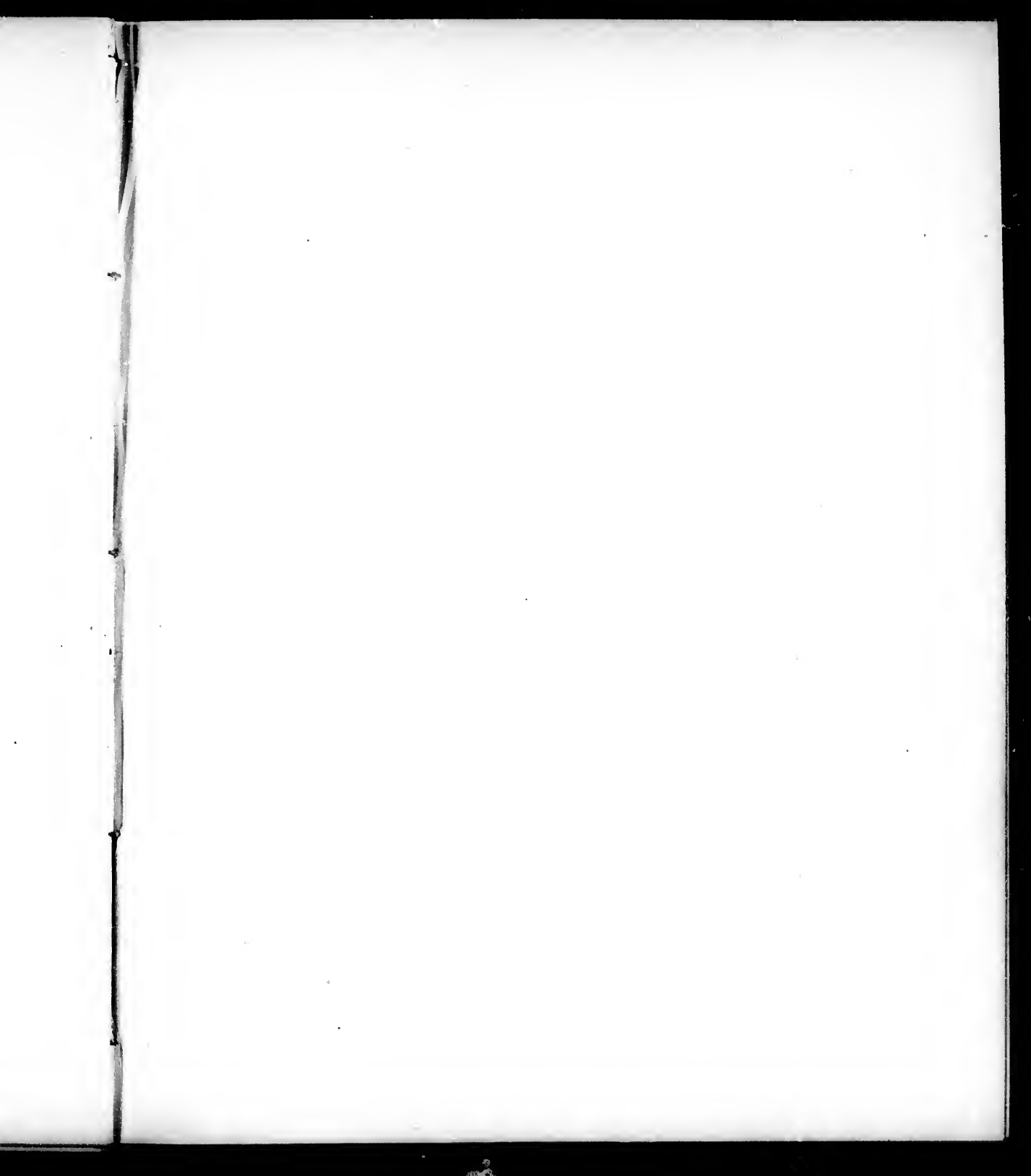

II. All Fees shall be paid to the Registrar, who shall pay the same over to the Bursar.

III. The Fee for Matriculation shall be paid before the candidate is permitted to offer himself for Examination; but if he be not admitted on such examination, he may offer himself at any subsequent examination without any further fee.

The fee for admission *ad eundem statum*, or for admission to Matriculation, upon the certificate of the head of any affiliated College, shall be paid before the Student offers himself at any examination in the University of Toronto.

The fee for a Degree shall be paid before the Degree is conferred.





STATUTE XLIII.
OF MATRICULATION.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. Statute VII., intituled "Of Matriculation," is hereby repealed.

II. Every candidate for Matriculation shall produce satisfactory certificates of age and good conduct.

III. Candidates may matriculate in any Faculty or Department, according to the regulation established by the Statute respecting Degrees or Diplomas in such Faculty or Department.

A Student having Matriculated in any Faculty, may proceed in the Departments of Civil Engineering or Agriculture; and a student having passed one other examination besides that for Matriculation in any Faculty, may proceed in any other Faculty as of one year's standing from Matriculation; but no student having already matriculated in any Faculty shall offer himself for Honour or Scholarships at the examination appointed for Matriculation in any other Faculty or Department.

IV. The Degree of LL.B. may be conferred after one examination in the cases provided for in Statute XXXVI.

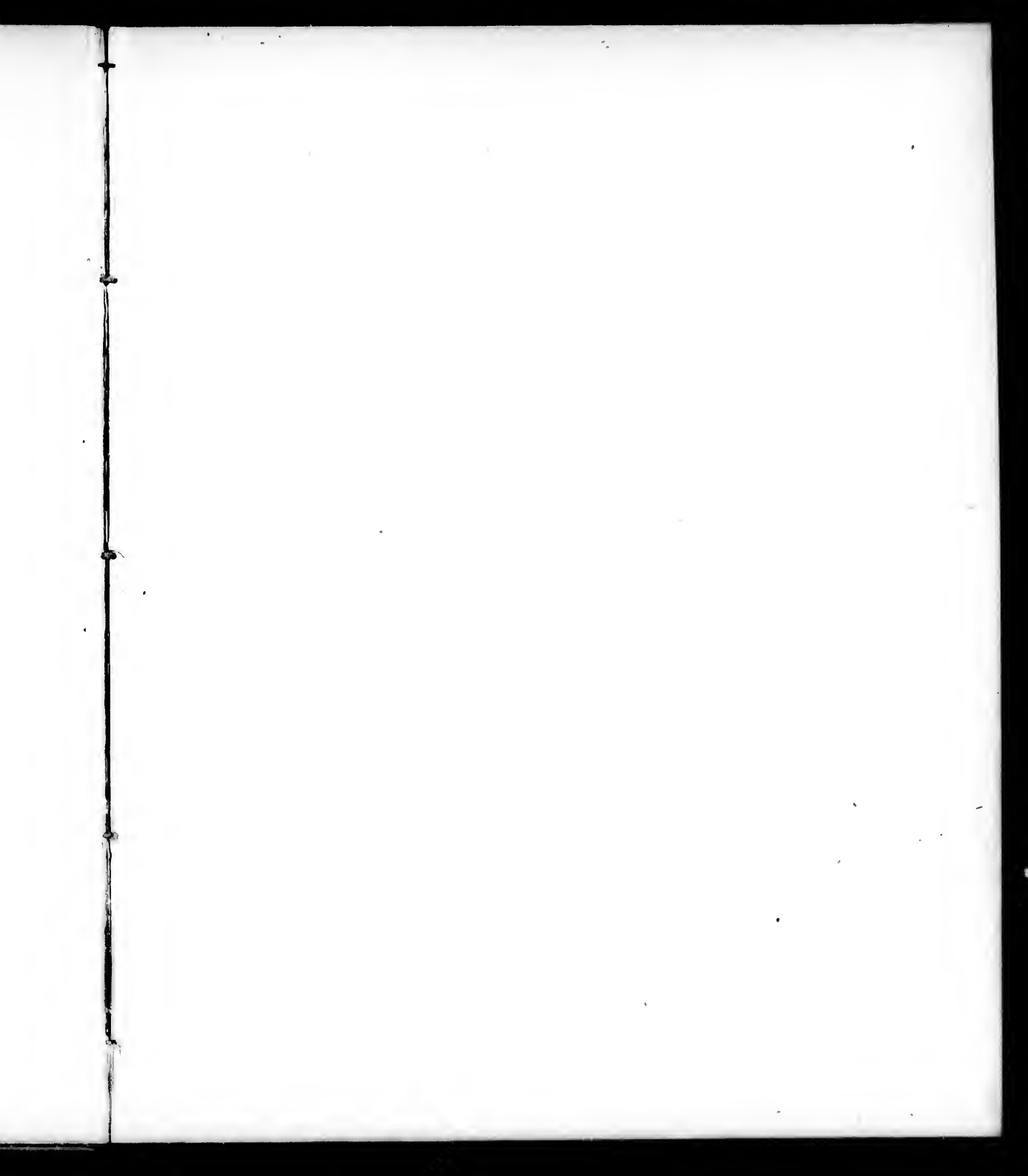

That the third and fourth clauses of the Statute XXVII., intituled "Of Fees and Salaries in Upper Canada College," be hereby repealed, and the following substituted in lieu thereof:—

III. All Fees shall be payable in advance ; and no pupil shall be entitled to admission either in the Boarding-house or College, until his fees have been paid to the Bursar, and a certificate of payment in duplicate obtained therefor ; and one of such certificates shall be presented to, and left with, the Principal.

IV. It shall be the duty of the Bursar from time to time to receive all such fees, and to grant the necessary duplicate certificates of payment.

Whereas, the Parliamentary grant, which in former years was made annually to Upper Canada College, has been withdrawn, and it is necessary to make provision for a reduction of expenditure :

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The Tuition Fees, payable by students not resident in the Boarding-house shall, after the end of the current term, be at the rate of ten dollars per term. If there shall

be two pupils from one family, the tuition fees shall be at the rate of nine dollars each per term; and if there shall be three or more pupils from one family, they shall be at the rate of eight dollars each per term. The proportion of the fees now payable to the Masters shall remain as established by Statute XXXIX., Section 3. The tuition fees for pupils in the Boarding-house shall remain as at present established.

II. The sixth section of Statute XXVII., providing for the payment of the Principal of the sum of fifteen shillings for every pupil who shall have resided during the term in the College Boarding-house is hereby repealed.

III. From and after the first of January there shall be only two Classical Masters and two Junior English Masters.

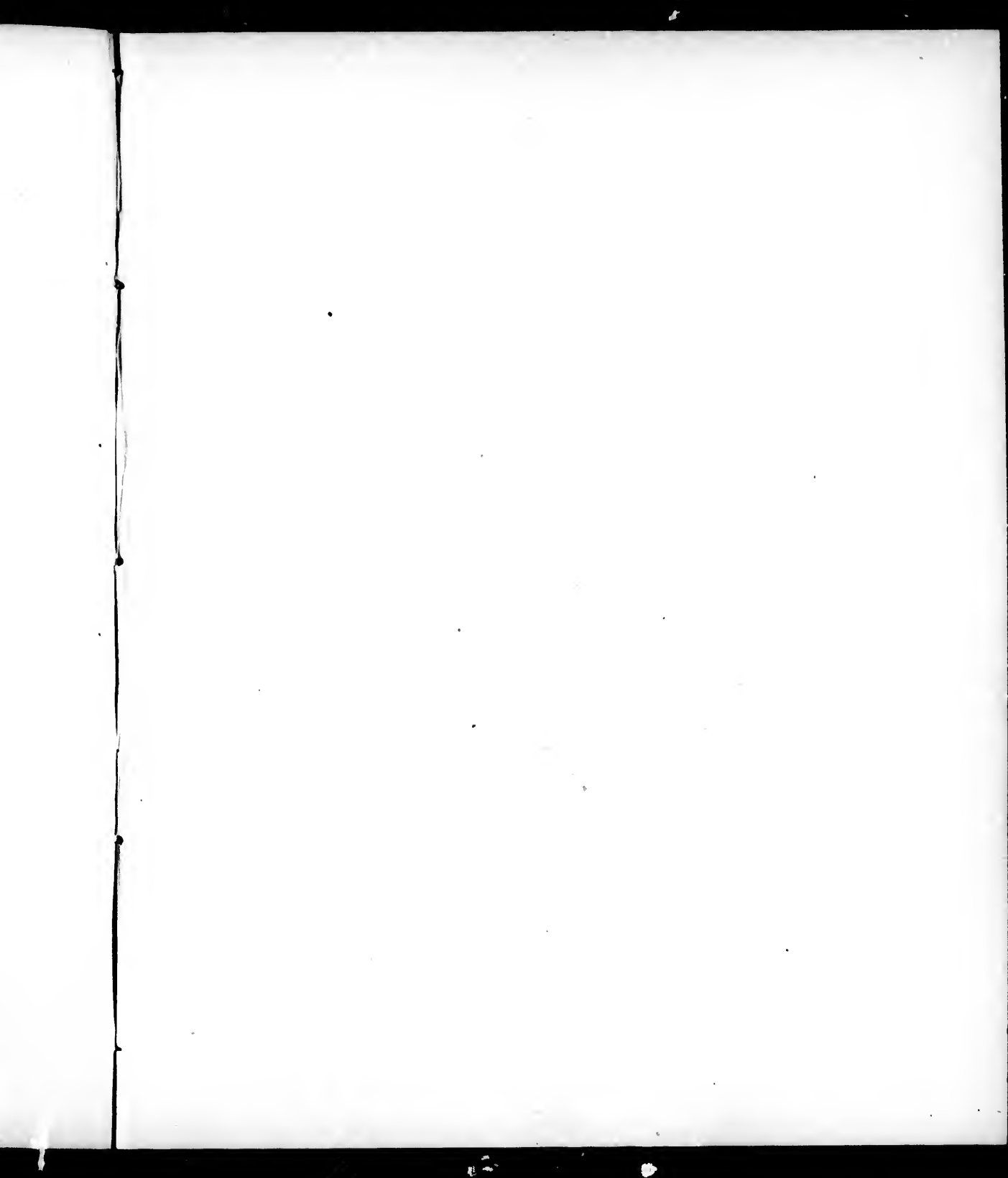
IV. A reduction of one-sixth shall be made on all the higher salaries now payable to Masters in Upper Canada College, viz.: upon the salaries of the Principal, of the Classical and Mathematical Masters, and of the English Classical Master. A reduction of one-eighth shall be made upon all the lower salaries payable to Masters in Upper Canada College, viz.: upon the salaries of the Junior English Master and of the French Master.

V. The Committee on Upper Canada College may authorize the Principal to employ an occasional Master to assist in teaching the lower forms, at a salary of four hundred dollars; but such occasional Master shall not be entitled to a share of the fees.

VI. The Senate may, by resolution, grant a gratuity to the Masters whose salaries have been reduced by the fourth section of this Statute, if in any year the income of the College will permit of it; provided, that such gratuities shall be proportional to the reduction thereby made.

STATUTE LXII.

AMENDING THE STATUTE OF "EXAMINERS AND EXAMINATIONS."

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The second section of the Statute XIV., intituled "Of Examiners and Examinations," is repealed.

II. The remuneration of the Examiners for their services shall be proportional to the number of papers which they have to report upon, according to the following scale:—

The minimum remuneration shall be twenty dollars.

If the number of papers exceeds fifty, the remuneration shall be forty dollars.

If the number of papers exceeds one hundred, the remuneration shall be sixty dollars.

If the number of papers exceeds two hundred, the remuneration shall be eighty dollars.

III. It shall be the duty of the Registrar, after every examination, to prepare a statement of the number of papers reported upon by the Examiners in each department, by adding together the number of candidates who have appeared at each of the divisions of which such Examiners have conducted the examination, which he shall submit to the Vice-Chancellor; and the Vice-Chancellor shall thereupon certify to the Bursar the amount payable to each Examiner.

IV. The Vice-Chancellor may, in addition to the sum as ascertained by the above section, certify as payable to any Examiner not resident within ten miles of Toronto, five dollars for every day that such Examiner has been necessarily absent from home in attending the Examination.

STATUTE LXIII.
OF THE PRINCE'S PRIZE.

Whereas, His Royal Highness the Prince of Wales, upon the occasion of his recent visit to Canada, was graciously pleased to present to the University of Toronto the sum of two hundred pounds for the purpose of establishing a prize in commemoration of His Royal Highness's visit :—

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. The sum of two hundred pounds, presented by His Royal Highness the Prince of Wales, shall be invested by the Bursar in such securities as the other funds of the University are authorized to be invested in; and the said sum and the interest accruing thereon, shall be kept by him as a separate fund.

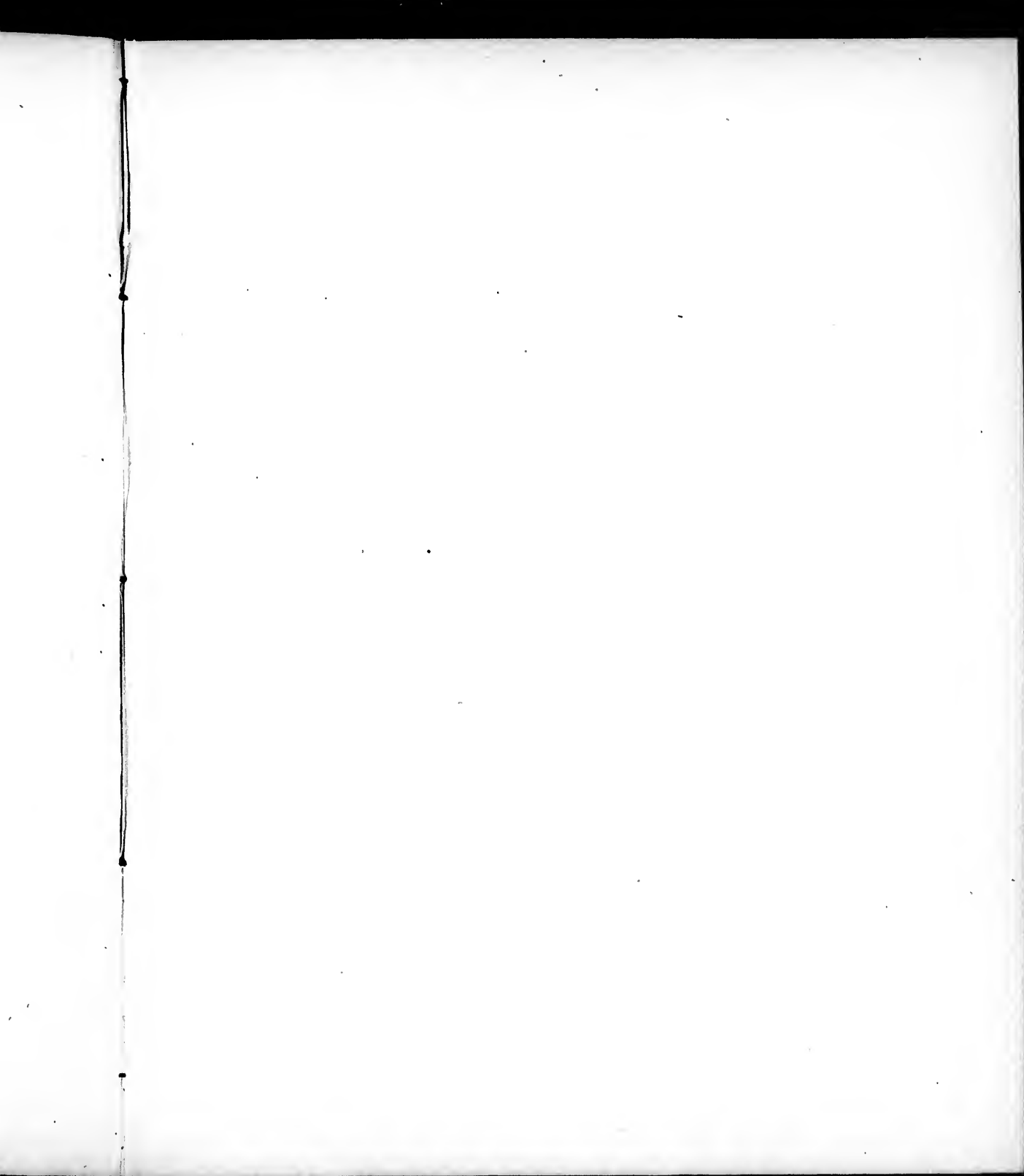
II. The sum of forty-eight dollars, or such smaller sum as may be realized as interest on the investment, shall be annually appropriated for a prize, which shall be called the "Prince's Prize," and shall consist of an Inkstand of such pattern, and bearing such device as shall be determined upon by a Committee appointed for that purpose.

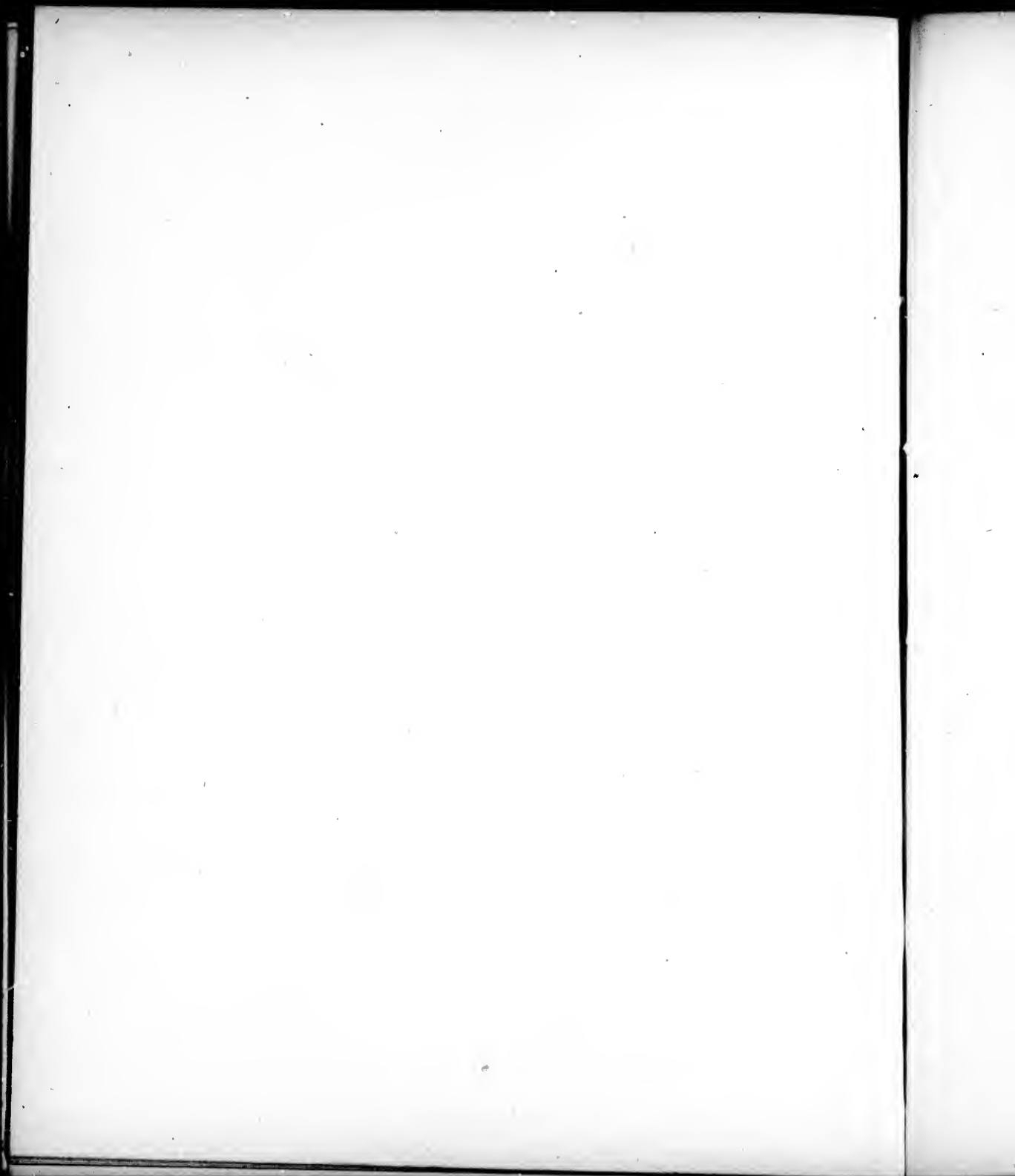
III. The Prince's Prize shall be awarded annually to the Candidate for the Degree of B. A., who having been classed in Honors in at least two departments, and in the first class in at least one department, shall have obtained the highest aggregate number of marks in all the subjects which are appointed for the Examination of Candidates for the Degree of B. A., together with the additional subjects herein prescribed.

IV. In addition to the subjects appointed for the examination of Candidates for the Degree of B. A., the Examiners in each department or branch of a department shall examine the candidates for the Prince's Prize in one paper upon such books or subjects as formed part of the course in previous years, but are not included in the final examination.

V. In determining the aggregate amount of marks, the Examiner shall estimate the comparative value of the





several departments and branches of departments, according to the following schedule, viz. :— and Curriculum of 1869.

VI. If, in any year, the Prince's Prize shall not have been awarded, the sum which would otherwise have been appropriated for the purchase of a prize shall be added to the capital of the fund; and whenever the capital shall have accumulated to twelve hundred dollars, the Bursar shall report the same to the Chancellor, to the intent that the Senate may make a further appropriation of the interest thereof, in compliance with the object of the endowment.

STATUTE LXIV.

AMENDING THE STATUTE "OF SCHOLARSHIPS." Vide Stat. lxxi.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The first sixteen sections of the Statute XX., intituled "Of Scholarships," and the second section of the Statute XLV., intituled "Of Subjects of Examination in the Faculty of Law," are repealed.

II. The number of Scholarships in the Faculty of Law shall be four, viz.: one for Matriculants, and one for Students of one, two, and three years' standing respectively.

III. The number of Scholarships in the Faculty of Medicine shall be four, viz. : one for Matriculants, and one for Students of one, two, and three years' standing respectively.

IV. The number of Scholarships in the Faculty of Arts shall be (twenty-four, six) for each of the four years of the course, viz. :—

For Matriculants, (one) in the Greek and Latin Classics; (one) in Mathematics, and one for General Proficiency in all the subjects appointed for Matriculants.

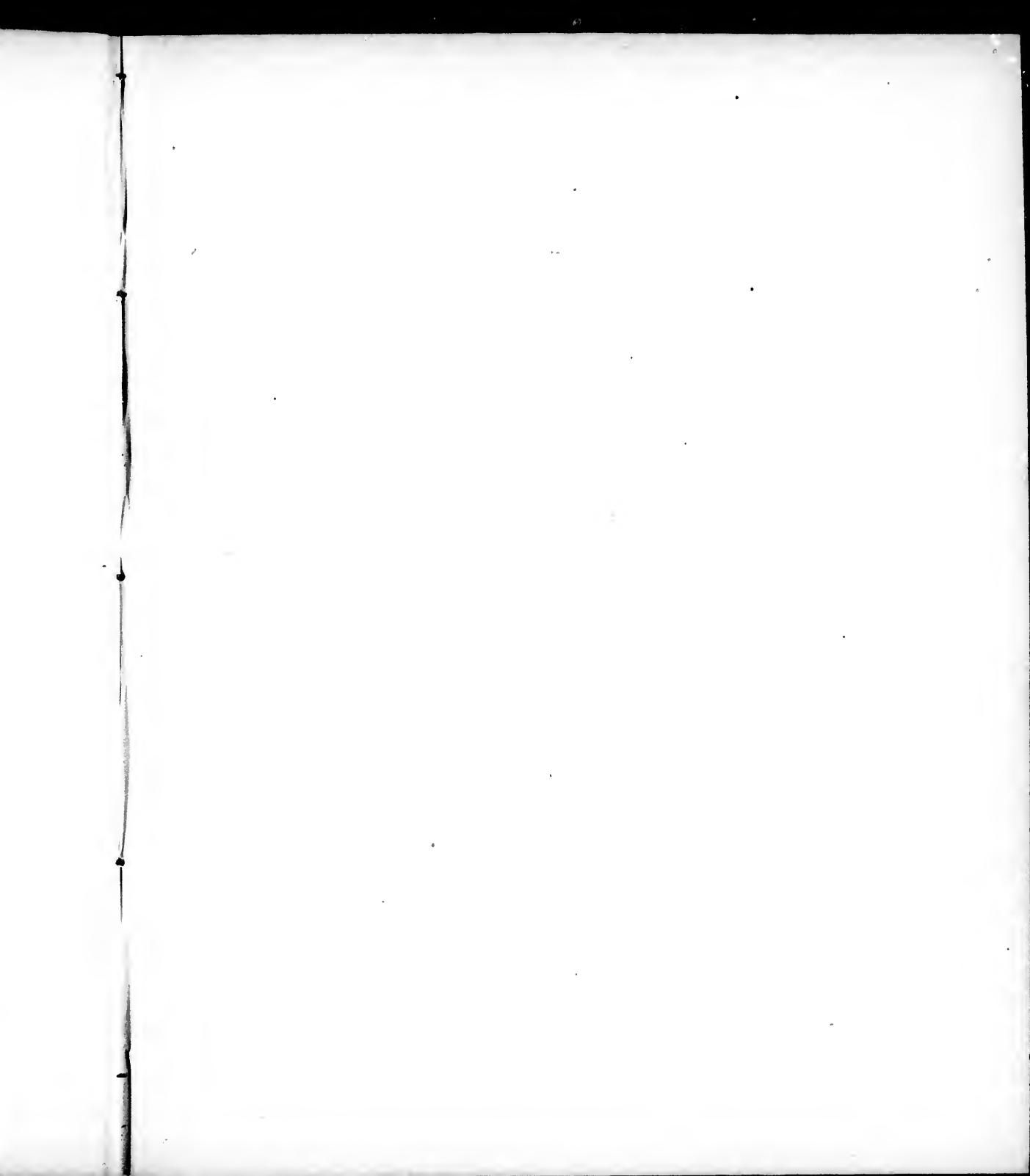
For Students of one year's standing: one in the Greek and Latin Classics; one in Mathematics, and four for General Proficiency in all the subjects appointed for Students of the first year.

For Students of two years' standing: (one) in the Greek and Latin Classics; (one) in Mathematics; one in the Natural Sciences; one in Modern Languages, with History; one in Logic, Ethics, and Metaphysics; and one for General Proficiency in all the subjects appointed for Students of the second year.

For Students of three years' standing: (one) in the Greek and Latin Classics; (one) in Mathematics; one in the Natural Sciences; one in Modern Languages, with History; one in Ethics and Metaphysics, with Civil Polity and History, and one for General Proficiency in all the subjects appointed for Students of the third year.

V. Candidates for the Scholarship in the Natural Sciences in the second year shall, in addition to the subjects appointed in that department, be re-examined in those portions of Natural History which formed the subjects of examination in the first year; and Candidates for the Scholarship in the Natural Sciences in the third year shall, in addition to the subjects appointed in that department, be re-examined in those portions of Mineralogy and Geology which formed the subjects of examination in the second year.

VI. Candidates for the Scholarship for Modern Languages in the third year shall, in addition to the subjects appointed in that department, be re-examined in those portions of English which formed the subjects of examination in the second year.





VII. In awarding the Scholarships for General Proficiency, the Examiners shall not take into account the subjects appointed for all Students only, but also the subjects appointed for Candidates for Honors; and the Scholarships shall be awarded to such Students as have obtained the highest aggregate number of marks upon the whole Examination; but, in this aggregate, the marks obtained by any Candidate in the additional subjects in the Natural Sciences and in English prescribed by the two next preceding sections shall not be included.

VIII. In awarding the Scholarships for General Proficiency, the Examiners shall estimate the comparative value of the several departments and branches of departments, according to the following schedule:—

IX. This Statute shall first come into force after the first day of January, 1862; and the Scholarships awarded at the Examinations which take place before that day shall be awarded according to the provisions of the Statute or sections of Statutes hereby repealed.

STATUTE LXV.

TO AMEND THE STATUTE RELATING TO MEDALS.

Whereas doubts have been entertained as to the interpretation of Statute XXXII., relating to Medals:

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. That the third section of the Statute XXXII. be amended by inserting the following proviso: "Provided that no Gold Medal shall be awarded in the Natural Sciences or Modern Languages, except to such students as shall have been placed in the first class of Honours in all the prescribed subjects of examination, viz: for Natural Sciences, Chemistry, Zoology, and Botany, and Mineralogy, and Geology; and for Modern Languages, English, French, German, Italian, and Spanish.

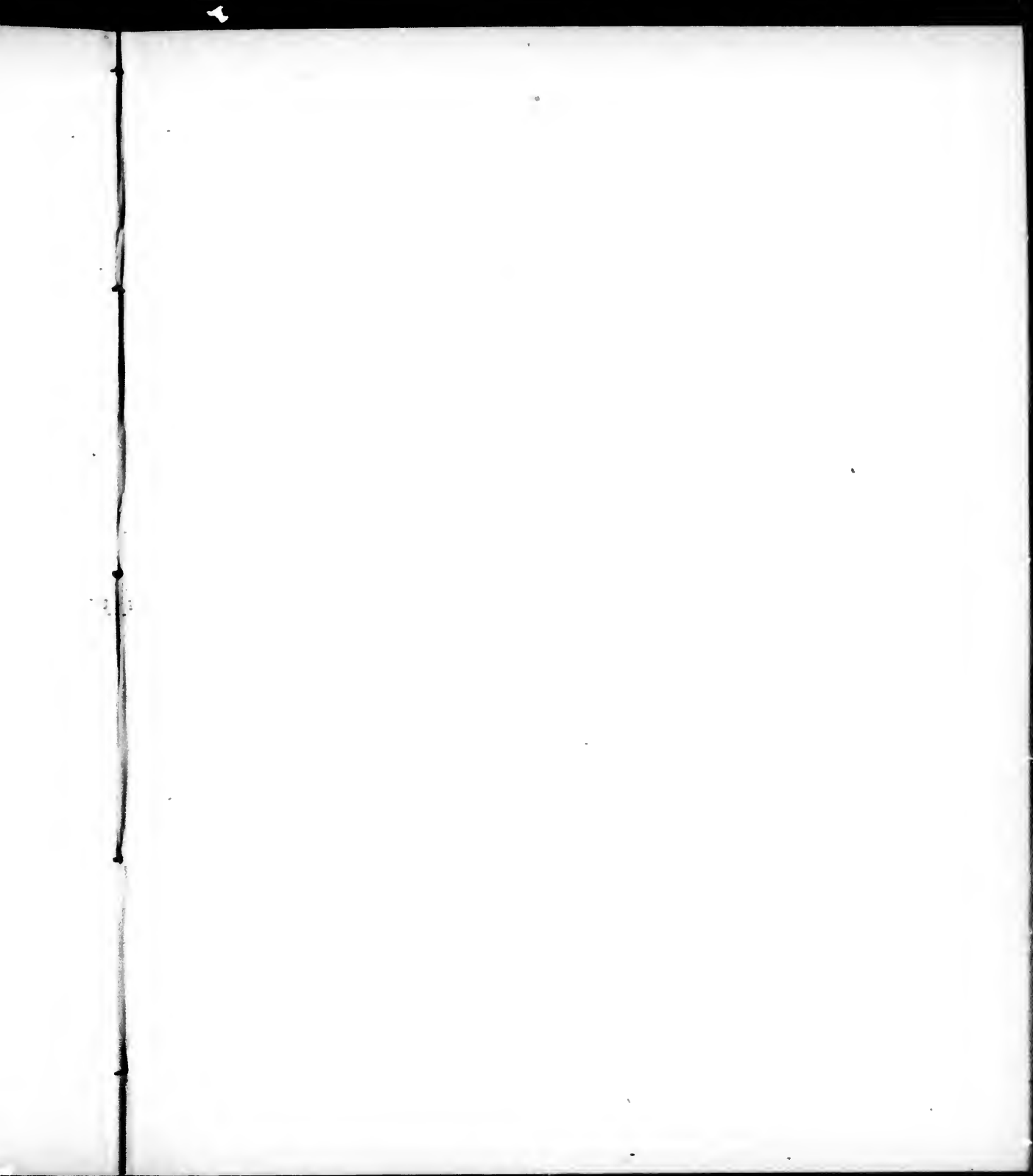

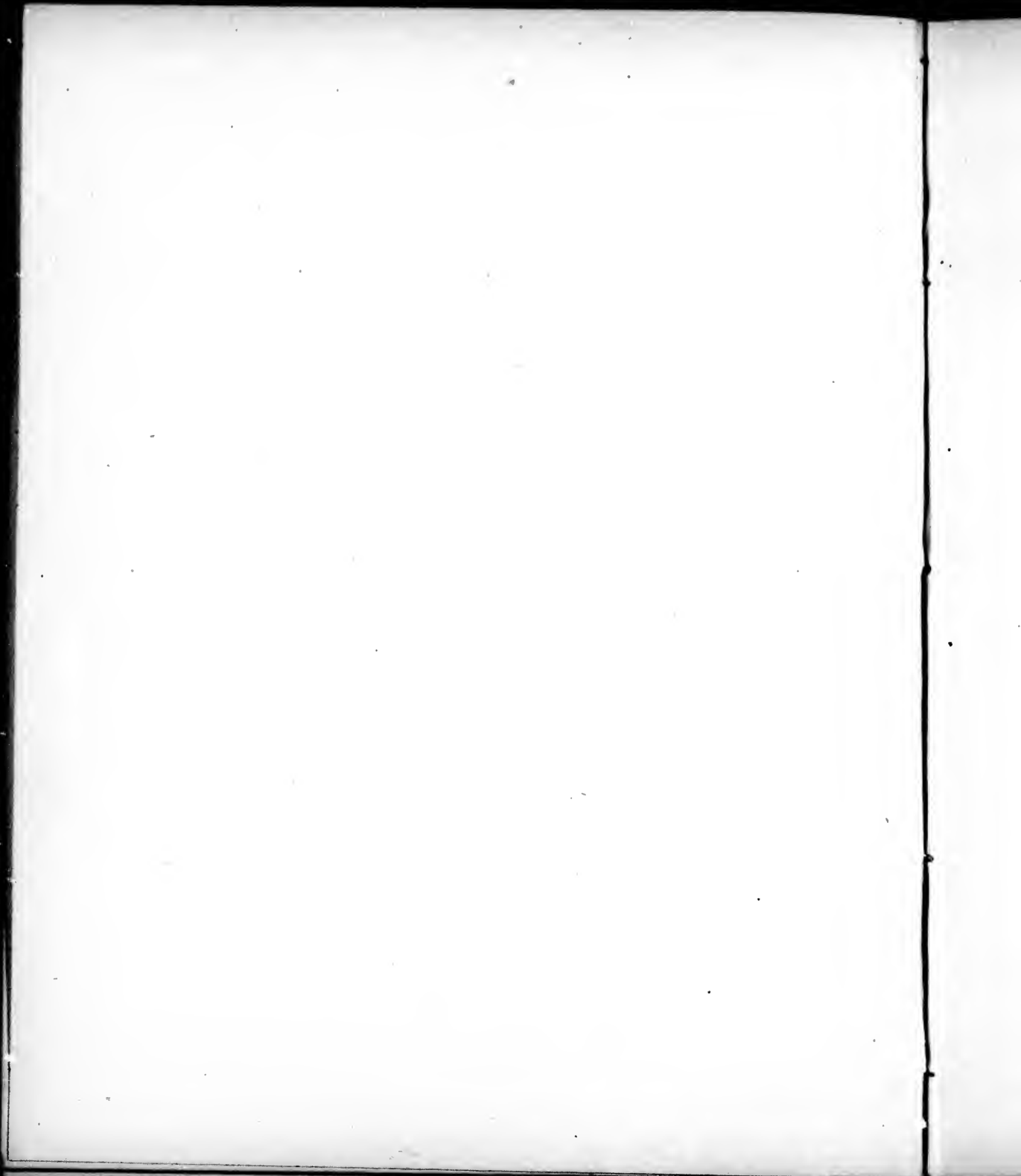
I. That from and after the passing of this Statute, Students of Medicine of two or three years' standing may submit themselves for an examination, termed Primary, in the following subjects, viz :—

1. Descriptive Anatomy.
2. Physiology.
3. Chemistry.
4. Materia Medica.

II. Students who have passed a satisfactory examination for a Scholarship in the second year shall, after passing an examination in any of the above subjects not therein included be considered as having passed the Primary Examination.

III. That Students of Medicine of four years' standing, having satisfactorily undergone the Primary Examination, and having attended the Courses prescribed by the Senate, may present themselves for examination in the following subjects for the Degree of M.B. :—





1. Surgical Anatomy.
2. Practical Chemistry.
3. Medicine.
4. Surgery.
5. Midwifery.
6. Medical Jurisprudence.

Provided, that Candidates for Medals or Honors at the Examination for Degree shall undergo an examination in all the subjects prescribed by the existing Statute.

STATUTE LXIX.

OF THE LECTURER ON CHEMISTRY AND PHYSIOLOGY IN UPPER CANADA COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

That from and after the first day of January, one thousand eight hundred and sixty-four, there shall be paid to the Lecturer on Chemistry and Physiology, in Upper Canada College, a salary at the rate of three hundred dollars per annum.

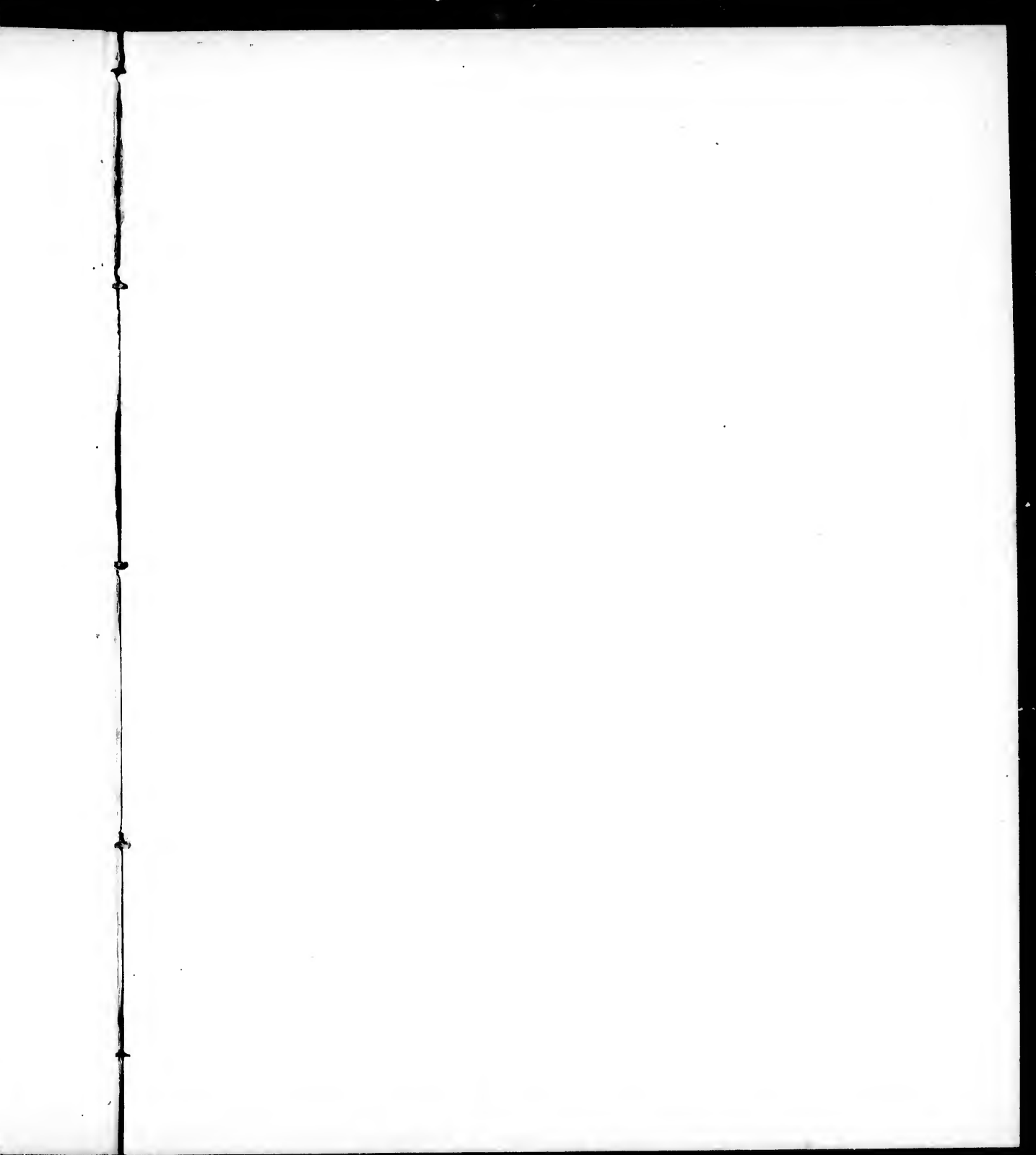

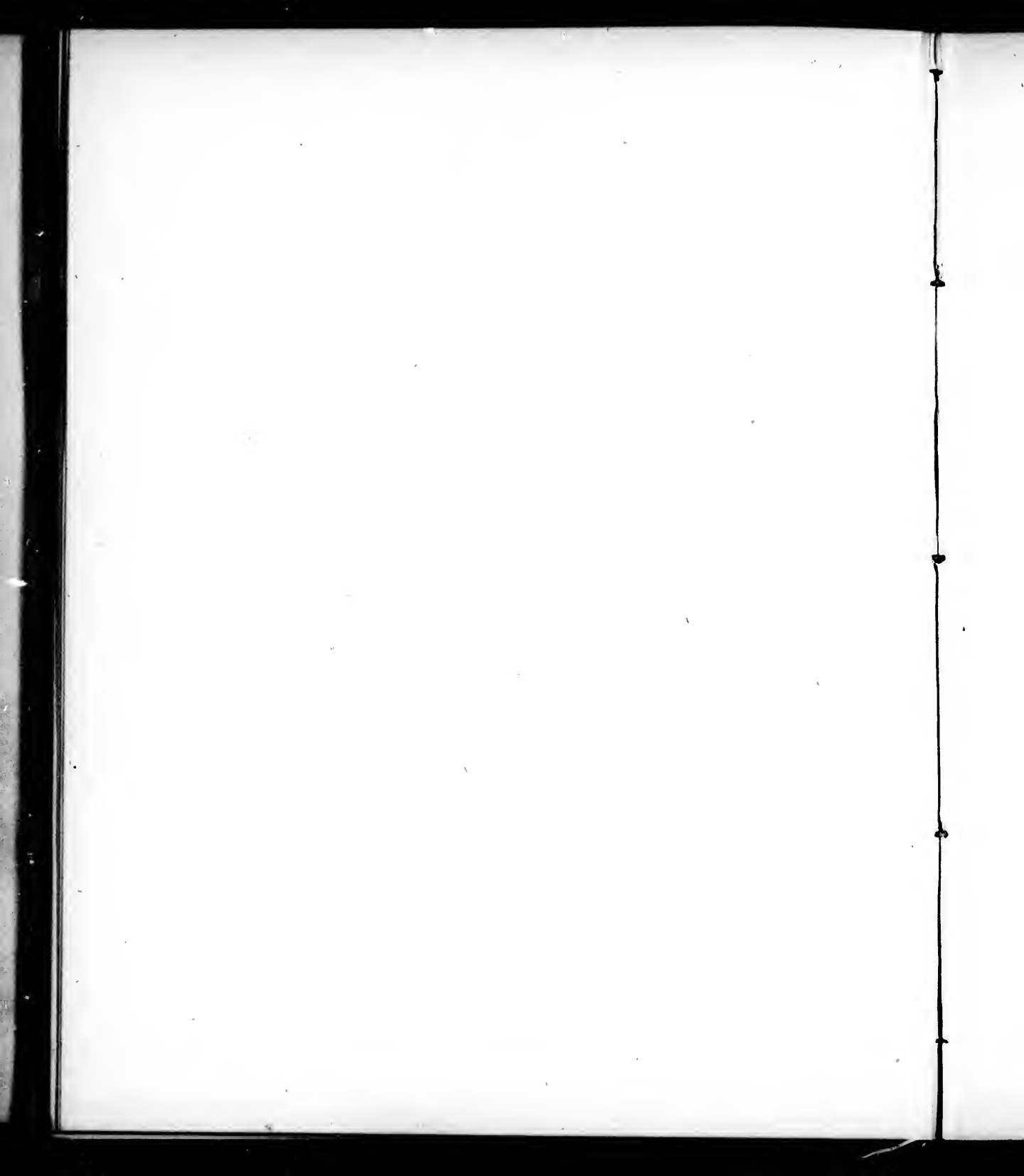

That clause I. of Statute IV. be amended by striking out the words "Thursday next before Christmas," and substituting "first Thursday after the first Tuesday in October;" and further that the first election of the Vice-Chancellor under the Statutes as now amended, do take place on the first Thursday after the first Tuesday in October in the year 1866, and that the term of office of the then Vice-Chancellor do terminate on the last mentioned day.

III. That clause I. of Statute XIV be amended by adding after "annually," the words "on the first Tuesday in October," and by adding the following: "And in all cases of vacancy occurring in the Board of Examiners by death, resignation, or otherwise, notice of the same shall be inserted in the circular calling the next ordinary meeting or a special meeting summoned for the purpose, when the vacancy shall be filled up."

IV. That clause I. of Statute XXII., clause I. of Statute XXIV., and clause II. of Statute XXV. be amended by striking out the words "Thursday next before Christmas," and substituting "First Tuesday in October."

V. That clause I. of Statute XXVI. be amended by striking out the word "May," and substituting "April."

VI. That all former Statutes determining the times of meeting of the two regular Sessions of the Senate of the Election of Examiners and Committees, in so far as they conflict with the Statutes as now amended, are hereby repealed.

STATUTE LXXIV.

AMENDING THE STATUTE RELATING TO THE
VICE-CHANCELLOR.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be is enacted :

That Section VI. of Statute IV. respecting the Vice-Chancellor be repealed.

And be it further enacted,

That the salary of the Vice-Chancellor shall be at the rate of four hundred dollars per annum.

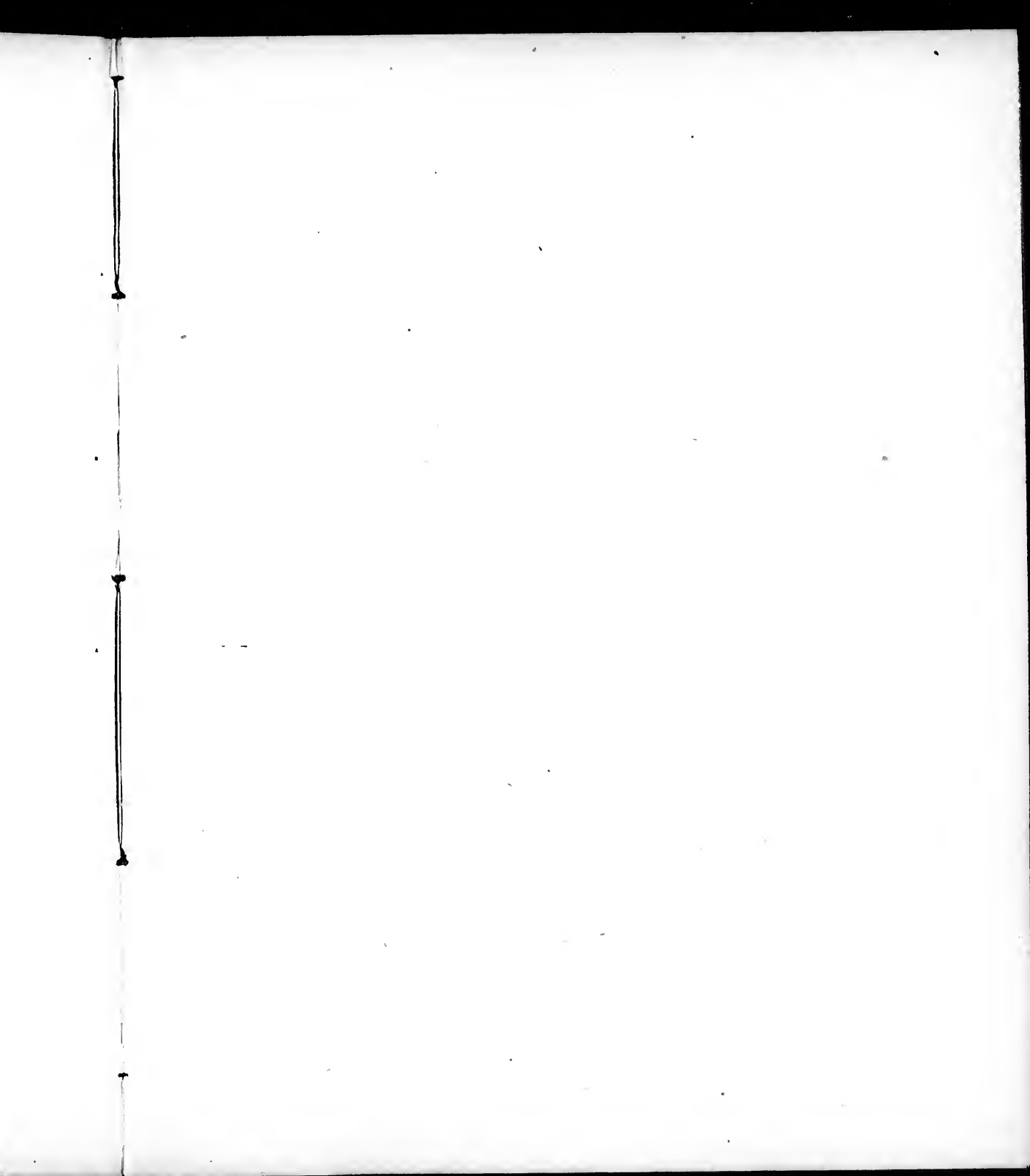

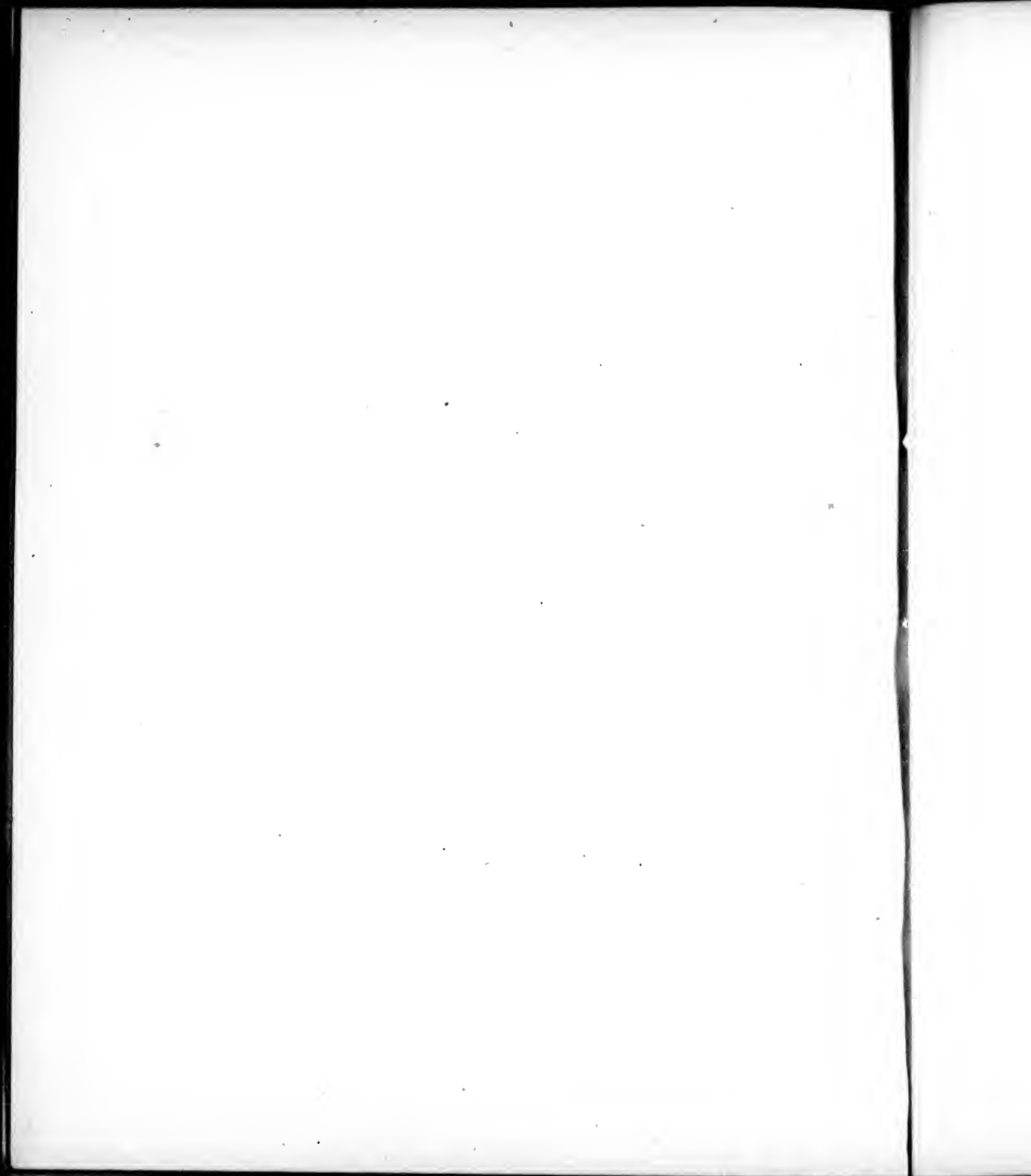

The surplus income of the Boarding House, out of which such payments may be ordered, shall be the net income of the year, to be ascertained after all expenses properly chargeable to such year shall have been defrayed.





STATUTE LXXVI.
OF THE APPOINTMENT OF A MEMBER TO THE
MEDICAL COUNCIL.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. That the election of the person to be chosen by the University of Toronto, as a member of the "The General Council of Medical Educations and Registrations of Upper Canada," pursuant to the provisions of the Medical Act for Upper Canada, shall be triennial, or once in every three years.

II. The first election shall be held at a meeting of the Senate, to be called after the confirmation of this Statute, and all subsequent Elections shall take place during the Regular Session of the Senate to be held in the month of April in each triennial period; and in case of failure to make such election at such time, the same shall take place at the first meeting of the Senate to be thereafter holden.

III. In case of any intermediate vacancy, caused by the death, resignation, or otherwise, of the member so elected by the Senate, the Senate may, by resolution, appoint another member to fill such vacancy, who shall hold office for the unexpired residue of the term for which the member so ceasing to act shall have been elected.

IV. The Registrar shall certify to the President of the Medical Council the election of the member from time to time chosen by the Senate.

STATUTE LXXVII.

FOR THE APPOINTMENT OF A COMMITTEE
CALLED THE FINANCE COMMITTEE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. That there shall be a Committee of the Senate who, in conjunction with a Committee of two of the Council of University College, appointed for a similar purpose, shall determine from time to time what portion of the expenditure of the income available under the order of the Executive Council, the twenty-first day of December last, shall be borne by the University and University College, respectively, and shall form a Joint Committee to control the items of joint expenditure. This Committee shall also supervise and manage all matters of a financial character within the control of the Senate in Council.

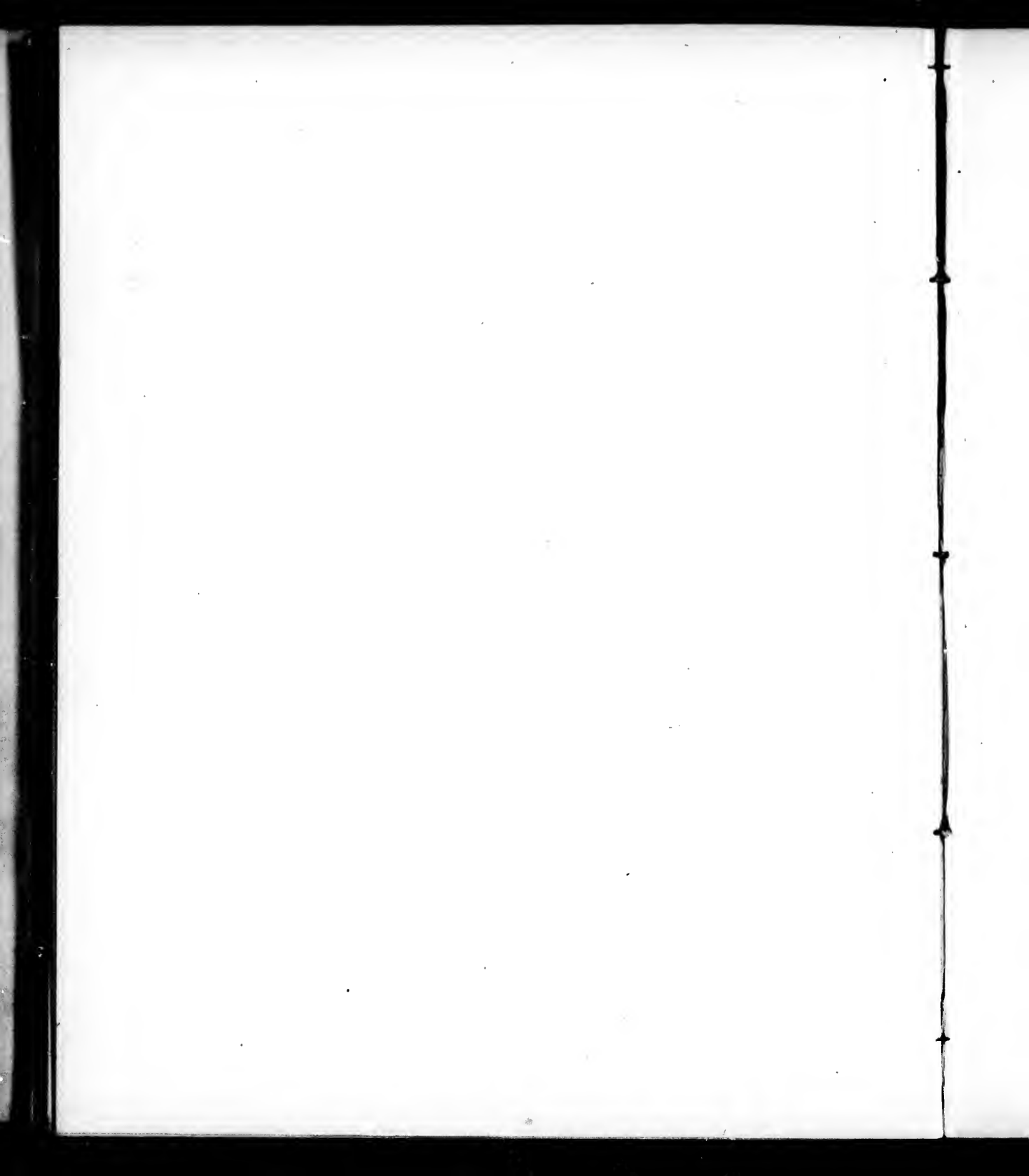
II. That the said Committee of the Senate shall consist of the Chancellor, the Vice-Chancellor, and one member of the Senate, to be annually elected on the first Thursday after the first Tuesday in October in each year, and subject to the Statutes and directions of the Senate, shall have supervision and control of that portion of the expenditure which is to be borne by the University; and such Committee shall make reports to the Senate relative to the same once in every three months at least.

III. That two shall form a quorum of the Committee of the Senate, and three a quorum of the Joint Committee, of which at least one shall be the Vice-Chancellor or elected member.

IV. Such Committee shall keep regular minutes of their proceedings, and shall from time to time report the same to the Senate.

V. That this Statute shall continue in force until 30th June, 1871.

STATUTE LXXVIII.

AMENDING THE STATUTE "OF THE FACULTY
OF ARTS" (1864).

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. That the following words shall be added to the first clause relative to the variable course for candidates for the degree of B. A., in the Statute of 1864, viz.: "of which at least two must be selected from the first four Departments, scil.: Classics, Mathematics, Modern Languages, and Natural Sciences;" so that the whole clause as amended shall be: "Those who are not Candidates for Honors may select any three Departments, of which at least two must be selected from the first four Departments, scil.: Classics, Mathematics, Modern Languages, and Natural Sciences." See Curriculum of 1909.

 STATUTE LXXIX.
RESPECTING THE BOARDING HOUSE AND THE
SALARIES OF THE MASTERS IN UPPER
CANADA COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. The Statute numbered LXXV., relating to Upper Canada College Boarding-house Fees, is hereby repealed.

II. The Bursar shall keep an account for the Boarding-house, separate from the Upper Canada College Income Appropriation.

III. The Bursar shall keep accounts open for at least four days after the conclusion of the Summer Term, for all Receipts and Expenditure on account of the Boarding-house, and on account of the Upper Canada College

Income Appropriation, and any receipts or expenditure in such accounts subsequent to June 30th shall be held to form part of the accounts of the previous financial year.

IV. The Upper Canada College Boarding-house Fees, and all other receipts applicable to it and the expenses, shall be charged against it in the following order of precedence:—

1. The ordinary expenses of maintenance, including repairs and improvements in the building.

2. The allowance to the Superintendent, by resolution of the Senate, of three dollars per term for each pupil resident in the Boarding-house.

3. Any sum which the Committee of Upper Canada College may think it advisable to reserve to meet repairs or improvements in the Boarding-house, which, in their opinion, will be required.

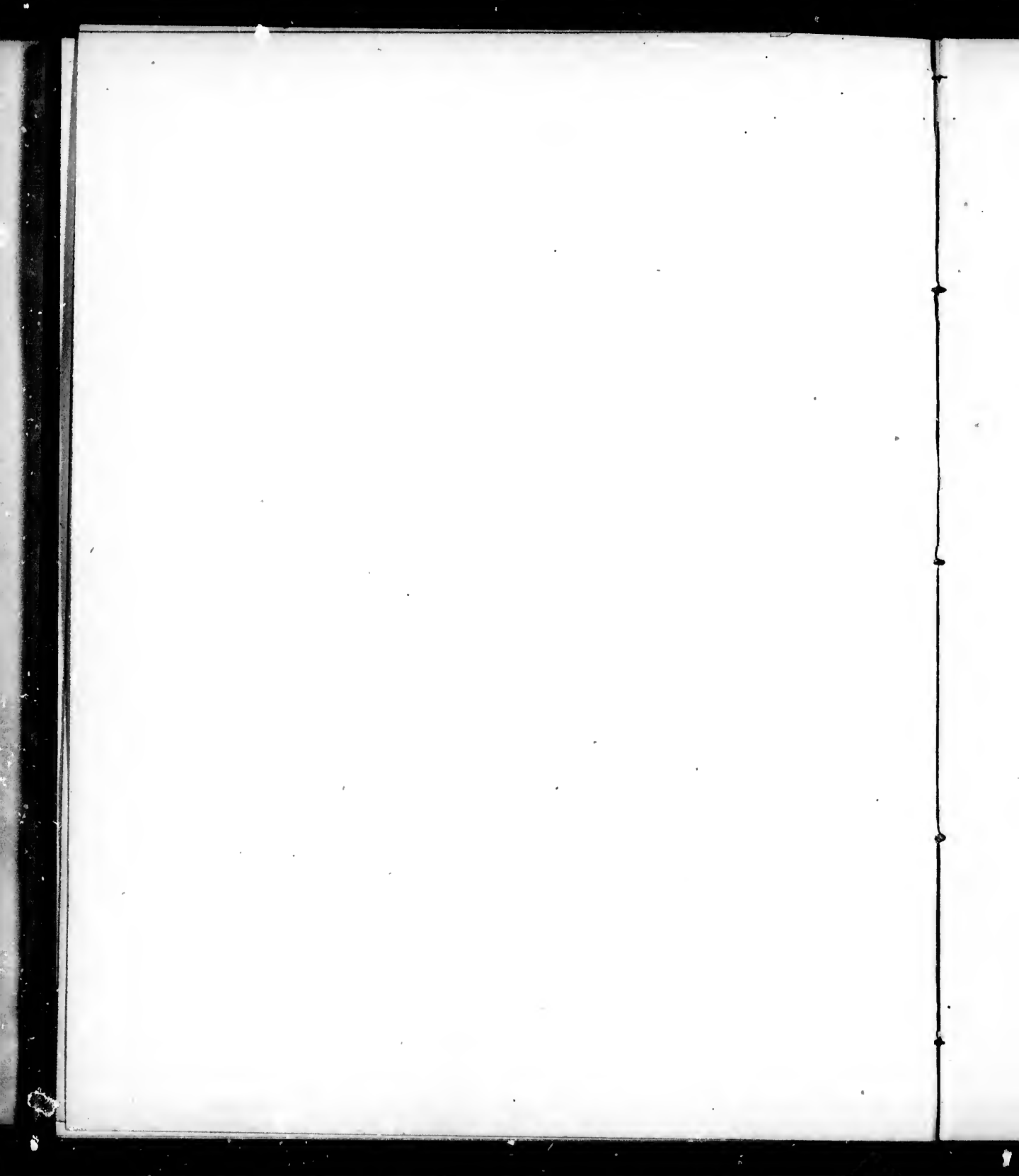
4. The payment to the credit of the Upper Canada College Income Appropriation of such a sum for each pupil resident in the Boarding-house as shall make up the five dollars per term, which is now charged to the amount per term which each would have paid had they not been resident in the Boarding-house. Provided always, that if at any time no balance of salary shall be due to any Master in Upper Canada College from the suspense account ordered to be kept by the order in Council of December 21st, 1865; and that there shall be sufficient funds at the credit of the Income Appropriation Account to pay the Masters in the College their full salaries for that year at the rates established before 1860, then no payment shall be made for that year from the Boarding-house, as above provided, or only so much as shall enable the Income Appropriation to pay the above charges.

5. The payment to the Principal of three dollars per term, for each pupil resident in the Boarding-house, as provided by the Statute ~~is~~ hereby repealed.

The above-named charges, numbered 2, 3, 4, and 5, shall only be paid or reserved (as the case may be) to the extent that there may be a balance in the year's account available to meet them, and no part of such charge remaining unpaid shall be considered a debt chargeable against the income of the following year; and any balance which may remain after these charges have been paid in full, shall be carried forward to the credit of the Boarding-house for the following year.

V. The Upper Canada College Income Appropriation shall have to its credit the appropriation from the Income fund of all miscellaneous receipts applicable to the account, the tuition fees, and the proportion of fees above made payable from the Boarding-house, and it shall be charged with expenses in the following order of precedence:—

1. All salaries of Masters, as at present established, with the ordinary expenses of maintenance, repairs, &c., as provided by the Order in Council of December 21st, 1865.

2. The repayment of any deductions from salaries, in accordance with the Order in Council of December 21st, 1866.

3. Any sum which the Committee on Upper Canada College may think it advisable to reserve to meet the expenses of necessary repairs or improvements.

4. An apportionment amongst the Masters, in proportions in which their salaries were reduced by the Statute of Fees and Salaries in Upper Canada College, passed October 5th, 1860, so far as to make their salaries for the then current year equal to what they were in 1860.

The above-named charges, numbered 2, 3, and 4, shall only be paid or reserved (as the case may be) to the extent that there may be a balance in the year's accounts available to meet them, and no part of such charge remaining unpaid shall be considered a debt chargeable against the income of the following year; and any balance which may remain after these charges shall have been paid in full, shall be carried forward to the credit of the appropriation for the following year.

VI. This Statute shall take effect from the first day of July, 1866.

STATUTE LXXIX. (a.)

AUTHORIZING THE ERECTION OF A MEMORIAL
WINDOW IN THE CONVOCATION HALL
OF THE UNIVERSITY.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

I. That a Memorial Window be erected in the Convocation Hall to perpetuate the memories of undergraduates Mewburn, McKenzie, and Tempest, who fell so gallantly when repulsing the Fenian invaders at Lime Ridge, on the second day of June, 1866.

II. That a Mural Monument or other suitable Memorial be also placed in the Convocation Hall, to commemorate the names of those Members and Students of the University or University College, who were wounded or took part in the same engagement.

III. That to defray the cost of the foregoing, subscriptions from Members and Students of the University and College be invited, and that the University do contribute therefor, if necessary, a sum not to exceed two hundred and fifty dollars.

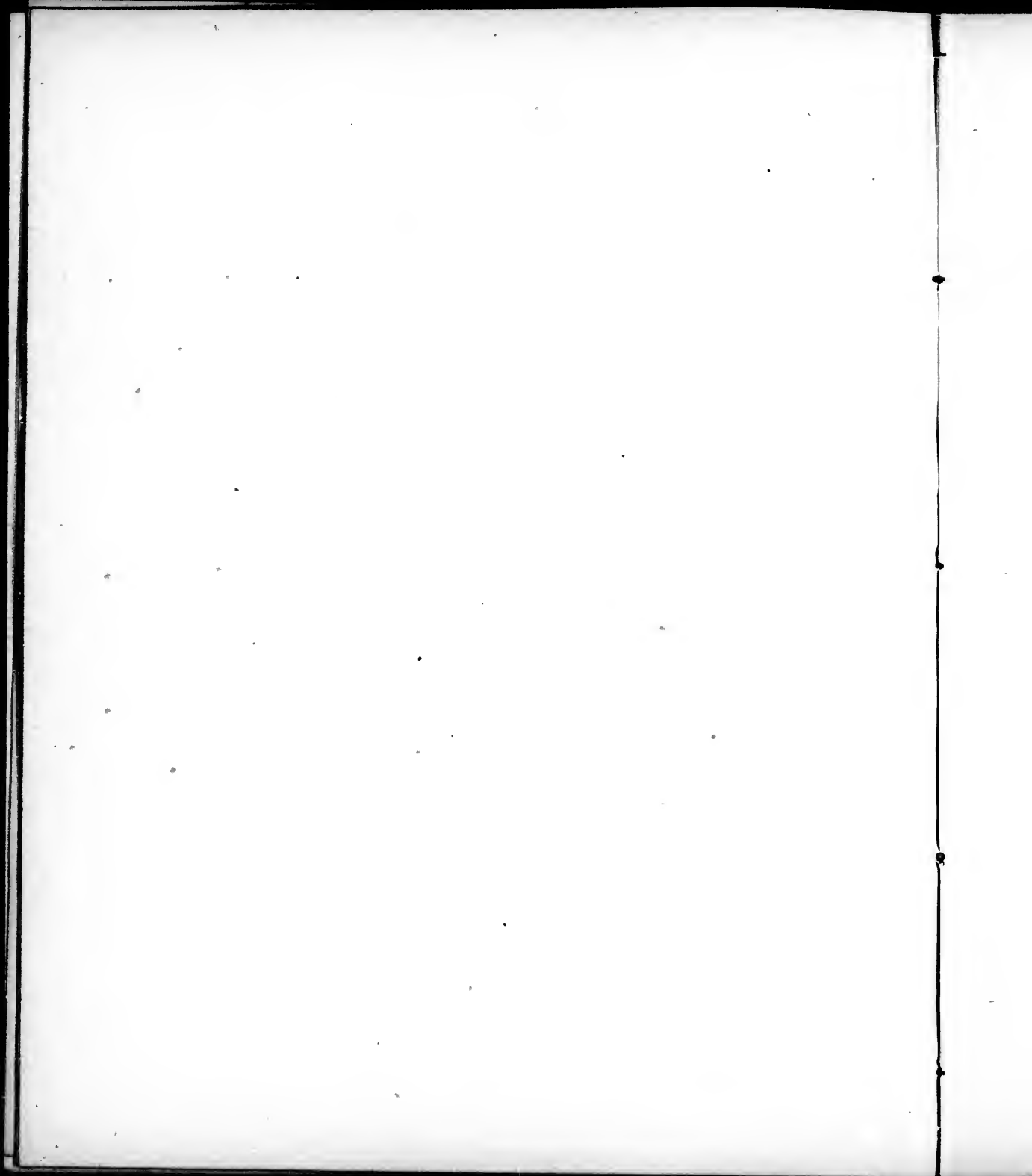

Any Candidate who, at any time during the year 1868-1869, may present a certificate from the Registrar of the General Medical Council of his having duly passed the Matriculation Examination prescribed by the Medical Act, may, in the discretion of the Senate, be admitted a Matriculant in the Faculty of Medicine, on payment of the usual fee, without further examination.

III. Botany shall be an additional subject for the Primary Examination, and also for the degree of Bachelor of Medicine, and a three months' attendance upon lectures on this subject shall be necessary.

IV. Attendance upon lectures for a period of at least three sessions of six months each, shall be one of the requisites for the degree of Bachelor of Medicine.

V. This Statute shall come into effect forthwith, and any provisions in former Statutes inconsistent with the foregoing are repealed.

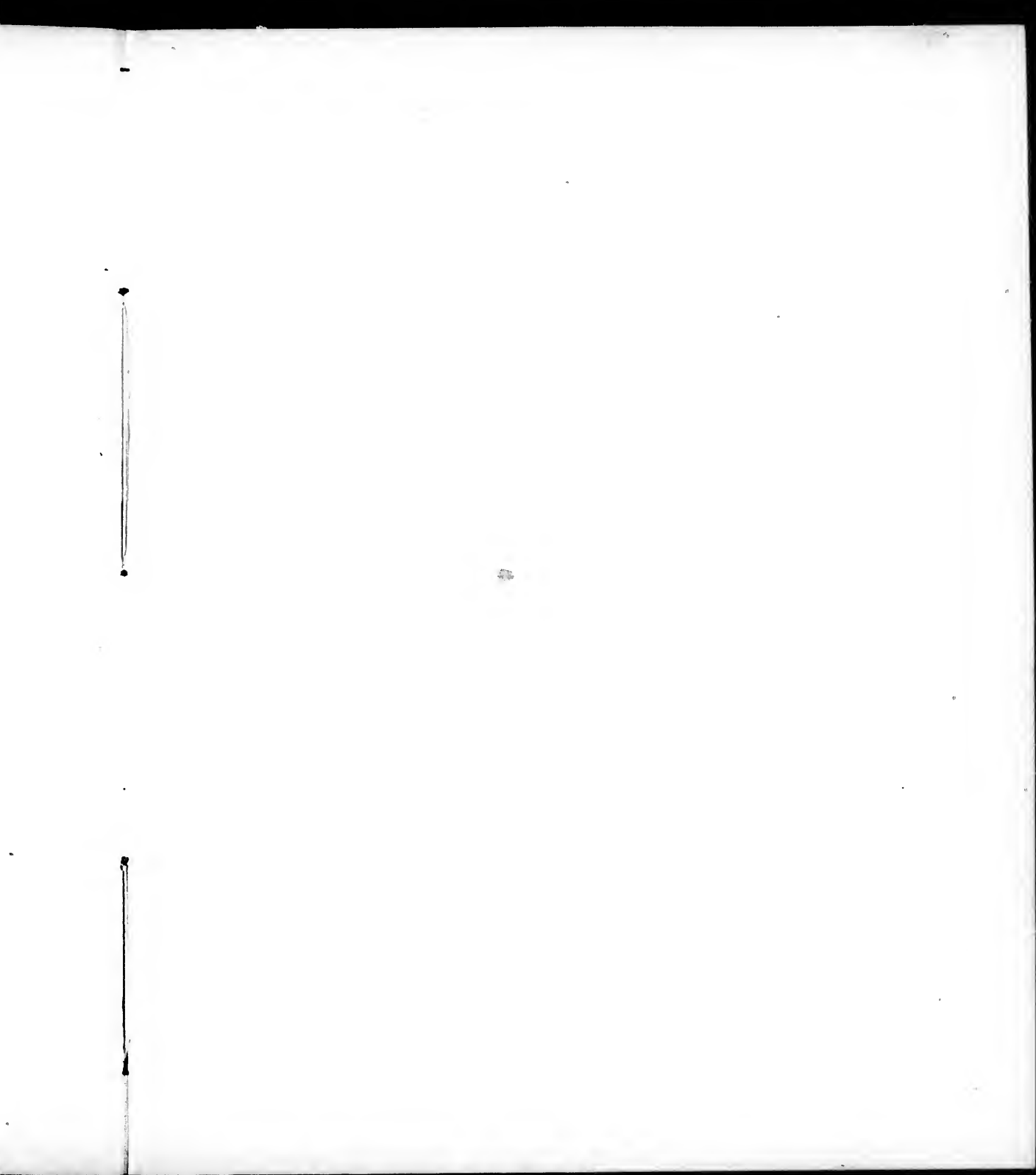
RESPECTING THE LIBRARY.

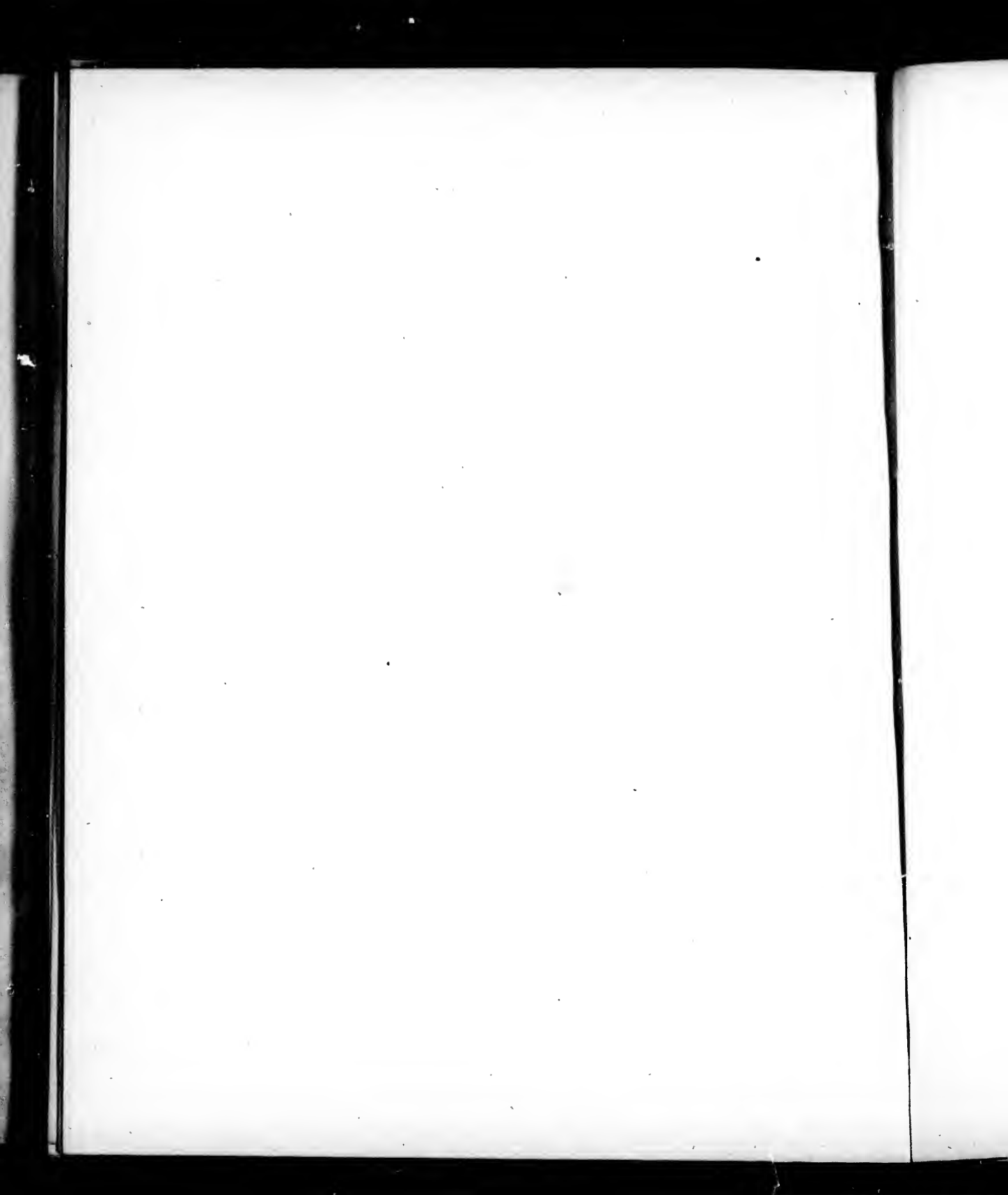
BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

I. That the salary of the Librarian shall be at the rate of \$1,000 per annum, instead of \$1,200.

II. John Edgeworth Thomson, Bachelor of Arts, is hereby appointed Librarian in the place of the Reverend Alexander Lorimer, Master of Arts, deceased.





STATUTE LXXXII.
OF STARR MEDALS.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

That, in place of the present provision, that there shall be three Starr gold Medals, the following shall be substituted, viz.: "That there shall be one Starr gold medal of the value of thirty-two dollars, and two silver of the value of six dollars, to be called respectively the first and second Starr Medal, and that all candidates for medals shall be required to take all the subjects for honours, as specified in the Statute on Medals.

STATUTE LXXXIII.

RESPECTING EXHIBITIONS IN UPPER CANADA
COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

That section 31 of the existing Statute be repealed, and the following be substituted therefor:—

All such Exhibitions shall be open for competition to the whole Province, and shall be awarded after a public Examination to be held at the end of the summer term. They shall be tenable for one year by pupils attending regularly at Upper Canada College, or at any of the Grammar Schools of the Province of Ontario; but the Exhibitors of one year may compete for the Exhibitions of succeeding years.

Competitors in the subjects forming the Annual Course of the Fourth Form shall not exceed seventeen years of age at the end of the Summer Term, June 30th.

STATUTE LXXXIV.

OF DEGREES, &c., IN THE FACULTY OF ARTS.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

That all previous Statutes relating to Degrees, Change of Faculty, Admission *ad eundem*, Fees, Examination, Scholarships, Medals, Prizes, Certificates of Honour, and Subjects of Examination in the Faculty of Arts are hereby repealed, and the following is substituted in lieu thereof, that is to say—

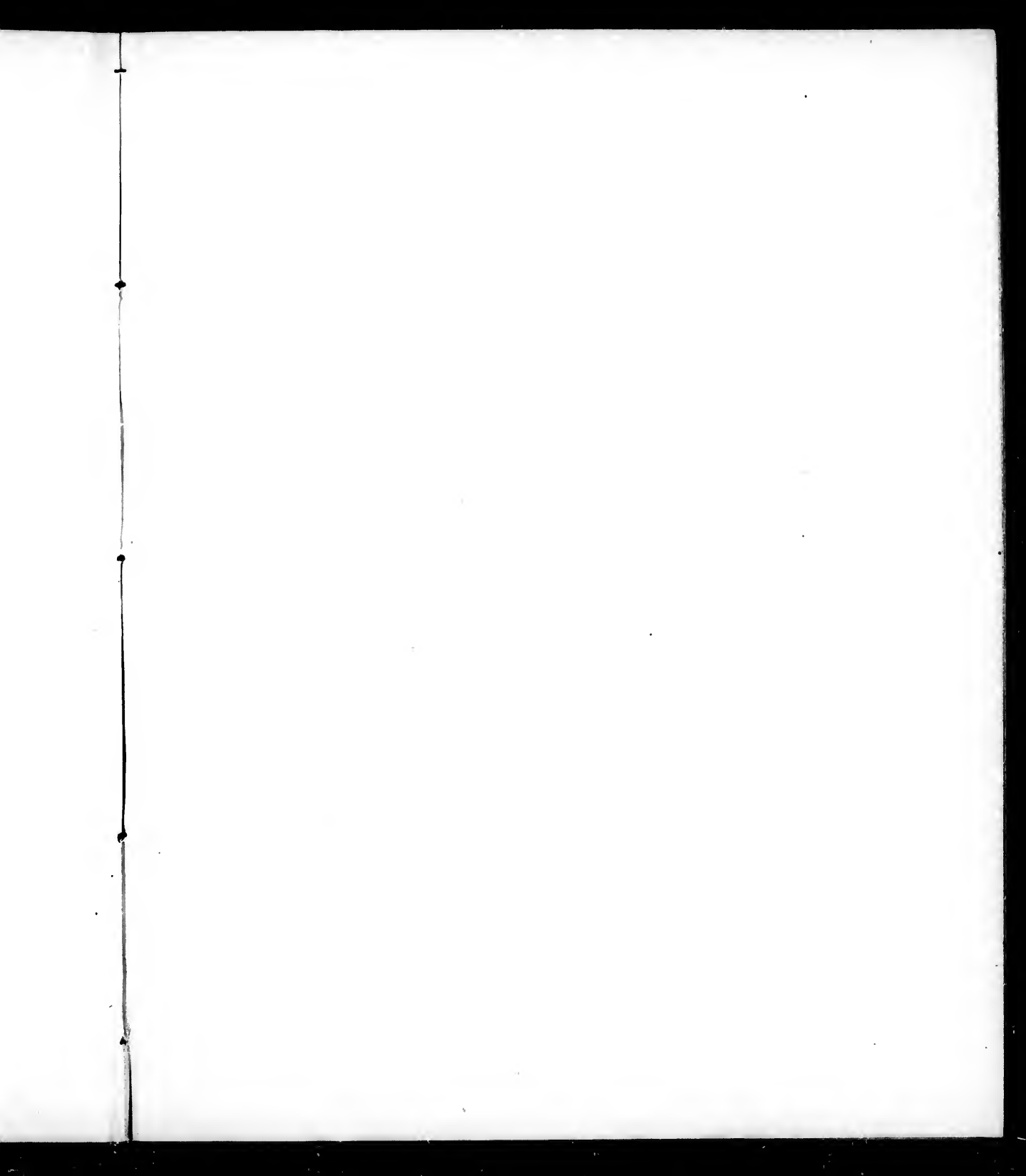
STATUTE LXXXV.

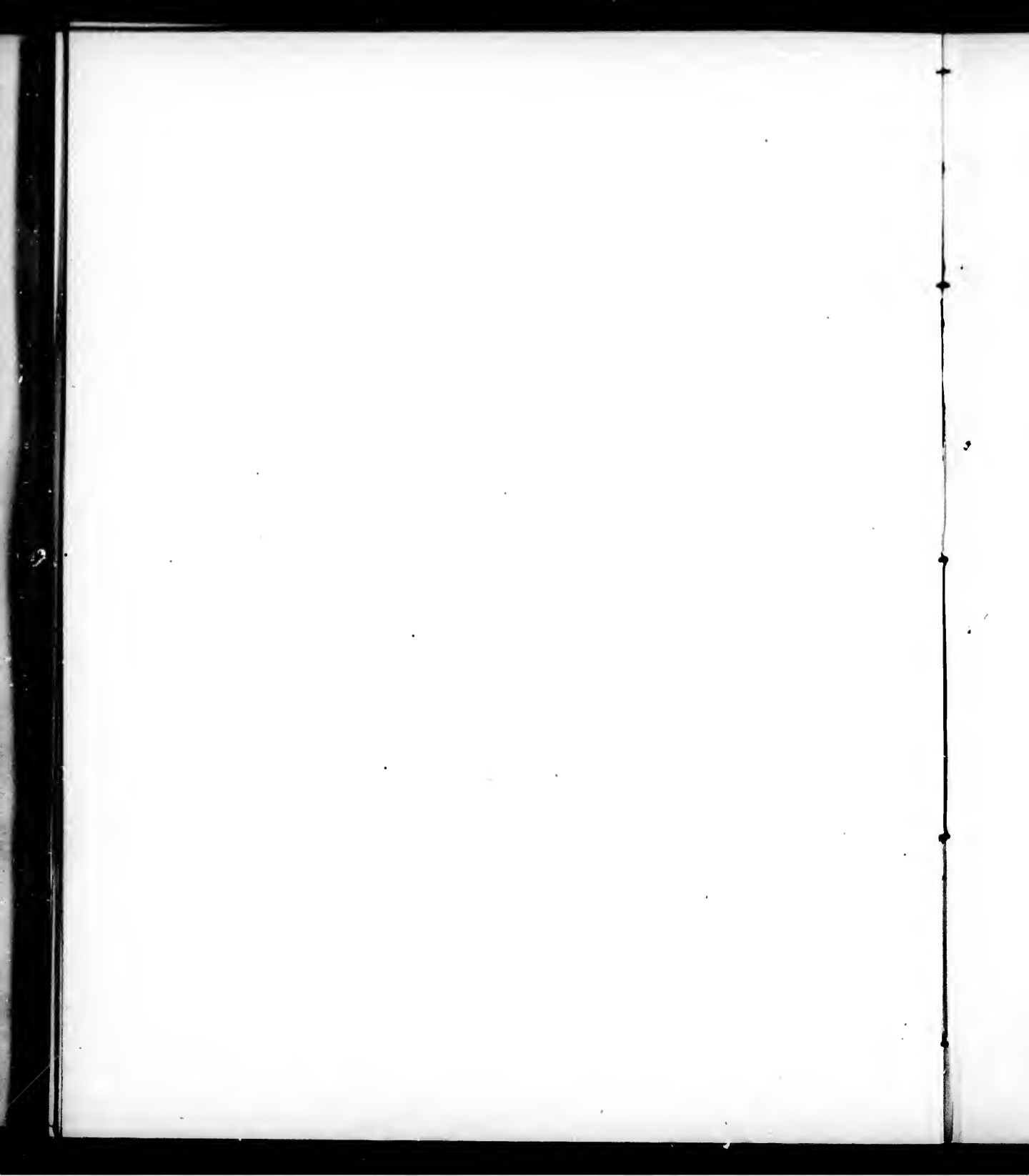
RESPECTING THE UPPER CANADA COLLEGE
BOARDING HOUSE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

That in consequence of the overcrowding of the Upper Canada College Boarding-house, and the number of applications for residence which are necessarily declined, it is expedient to authorize the enlargement of the Boarding-house, so as to contain from forty to fifty additional residing pupils; and *it is hereby enacted*, that the expenditure attending the said erection shall be charged upon and paid out of the Permanent Fund of Upper Canada College, to be redeemed by any surplus that may exist from time to time in the same fund. And that such expenditure shall not exceed for the said erection, and in respect of providing the requisite household and other furniture therefor, the sum of eight thousand dollars.





STATUTE LXXXVI.
APPOINTING A SOLICITOR.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

That Angus Morrison, Esquire, be appointed Solicitor of the University, in place of D. Ashe Sampson, Esquire, Master of Arts, deceased.

STATUTE LXXXVII.
OF THE TENURE OF OFFICE OF VICE
CHANCELLOR.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

That to remove doubts, the tenure of office of the Vice-Chancellor shall be held to commence on the first day of January next succeeding his election, and to terminate in two years after the said first day of January.

STATUTE LXXXVIII.
OF THE ERECTION OF A BOILER AND ENGINE
HOUSE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted :

That the sum of three thousand dollars be appropriated out of the General Income Fund for the erection of a Boiler and Engine House, with the appurtenances.

STATUTE LXXXVIII (a).

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

That in order to complete the erection of the Boiler and Engine House, and to defray the expenses connected with the removal and replacement of the boilers and the necessary improvements and connections, a further sum, not exceeding fifteen hundred dollars, be expended and charged against the General Income Fund.

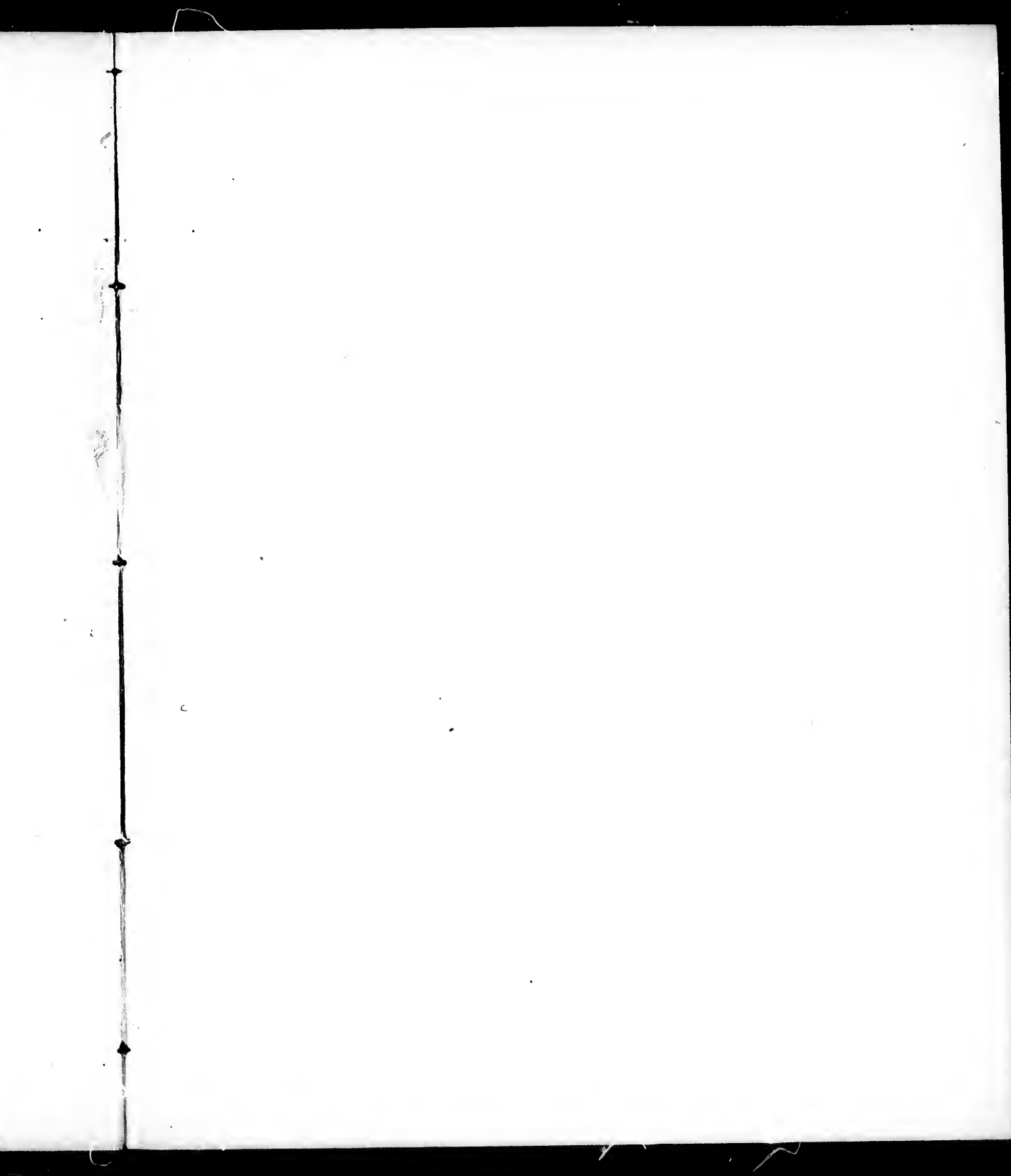

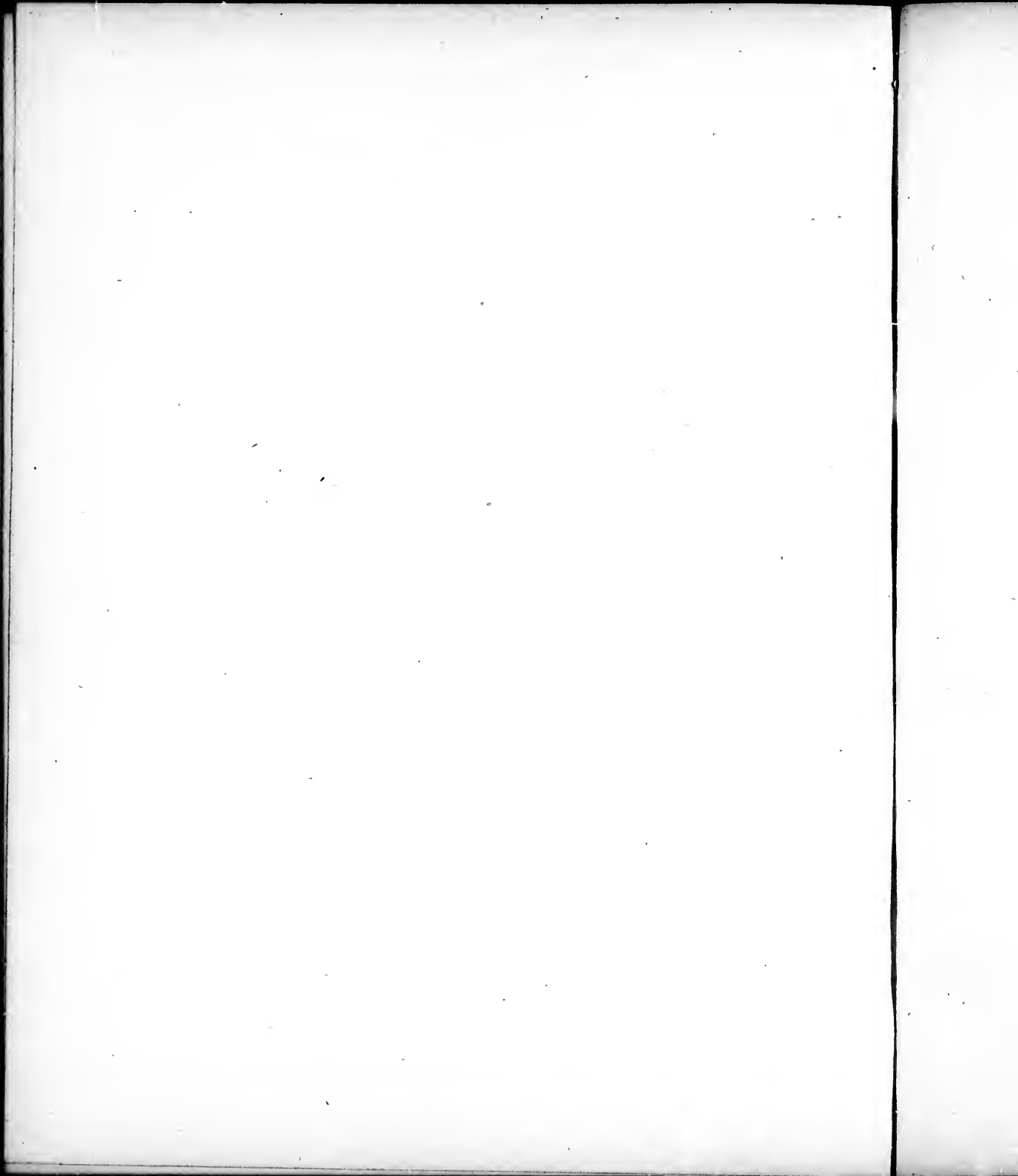
RESPECTING THE BUILDING ERECTED BY THE

BY THE SENATE OF THE UNIVERSITY OF TORONTO,

Be it enacted:

That the sum of two thousand dollars be paid to the Agricultural and Arts Association of Ontario, as the valuation agreed upon for the building erected by the Agricultural Association of Upper Canada, on the grounds formerly occupied as an Experimental Farm.





STATUTE XC.

RESPECTING AN ADDITIONAL MASTERSHIP IN
UPPER CANADA COLLEGE.

BY THE SENATE OF THE UNIVERSITY OF TORONTO.

Be it enacted:

I. That an additional Mastership be established in Upper Canada College for instruction in Mathematical and Physical Science.

II. That the Salary and Emoluments attached to said Mastership shall be the same as those now attached to the Second Classical and Mathematical Masterships, and the person appointed to such Mastership shall occupy the same position in the College as the Second Classical Master, their relative precedence being regulated by seniority in their respective appointments.

STATUTE XCI.

RESPECTING AN APPROPRIATION OF \$2,000 FOR
THE LIBRARY.

BY THE SENATE OF THE UNIVERSITY OF TORONTO.

Be it enacted:

That the sum of two thousand dollars be appropriated from the General Income Fund of the University for Library purposes; and that it be applied in finishing the internal arrangements of the Library, and for acquiring books as may be determined by the Committee on the Library, in addition to the annual allowance in the Special Departments.

APPOINTING W. G. FALCONBRIDGE, M.A.,
REGISTRAR.

BY THE SENATE OF THE UNIVERSITY OF TORONTO.

Be it enacted:

That William Glenholme Falconbridge, Master of Arts, be appointed Registrar in the room of Thomas Moss, Master of Arts, who having been appointed a member of the Senate, has resigned the office.

Statute XCIII

Respecting the Election of Chancellor and Members
of the Senate -

By the Senate of the University of Toronto.

Be it Enacted

That the votes to be given at the Election by Convocation for the office of Chancellor, and for members of the Senate respectively under the Act respecting the University of Toronto shall be delivered to the Registrar in the University Building not later than three o'clock on the afternoon of the second Thursday in May in each year, and that the Registrar may proceed to open the voting-papers, at the expiration of fifteen minutes thereafter.

Statute XCIV

Re-enacting and amending the Statute
of the Finance Committee (LXXVII)

By the Senate of the University of Toronto -

Be it enacted.

I That there shall be a Committee of the Senate, who in conjunction with a Committee of three of the Council of University College appointed for a similar purpose, shall determine from time to time what portion of the Expenditure of the Income available under order of the Executive Council shall be borne by the University and University College respectively, and shall form a joint Committee to control the items of joint expenditure - This Committee shall also supervise and manage all matters of a financial character within the control of the Senate and Council, but no extraordinary expenditure shall be incurred without the previous approval of the Senate and Council -

II That the said Committee of the Senate shall consist of the Chancellor, the Vice-Chancellor and two members of the Senate to be annually elected on the first Thursday after the first Tuesday in October in each year, and, subject to the Statutes and directions of the Senate, shall have supervision and control of that portion of the expenditure which is to be -

borne by the University, but no extraordinary ⁷⁷
^{expenditure} shall be incurred without the previous approval
of the Senate; and such Committee shall
make reports to the Senate relative to the same
once in every three months at least.

III. That two shall form a quorum of
the Committee of the Senate and three a
quorum of the joint Committee, of which at
least one shall be the Vice Chancellor
or an elected Member of the Senate.

IV. Such Committee shall keep regular
minutes of their proceedings and shall from
time to time report the same to the Senate.

V. That Thomas Moss, M.A. and John
Macdonald Esquire be elected to serve on this
Committee until the next regular election.
