CONSTITUTION OF THE SOCIETY.

I.

The Society shall be called the **DIOCESAN CHURCH SOCIETY OF NEW BRUNSWICK.**

II.

No constitution, bye law, rule or regulation of the Society, or any abrogation, repeal, change or alteration of the same, shall be of any force until it shall have been sanctioned and confirmed by the Bishop of, and administering the Diocese for the time being, by writing under his hand.

III.

The payment at any one time of a sum not less than Ten Pounds, shall constitute a Life Member; and the payment annually of any sum, however small, shall constitute the person paying the same a Member of the Society.

IV.

The Society shall have a President, who shall be the Lord Bishop of the Diocese; two or more Vice Presidents, of whom the Archdeacon shall be the first; one or more Treasurers; one or more Secretaries; two Auditors of Accounts; and an Executive Committee of twenty four Lay Members of the Society, being Life Members of the Society, or Subscribers of, at least, One Pound to the funds of the Society; who, with the exception of the President and Vice Presidents, shall be annually elected at the Anniversary Meeting.

V.

The Officers of the Society and the Clergy of the Diocese shall be *ex-officio* Members of the Committee: five to be a quorum, and three of the five Laymen.

VI.

The Society shall embrace the following objects, and none other, viz :—

1. Missionary Visits to places where there is no settled Clergyman, and aid to new and poor Missions.
2. The establishment of Divinity Scholarships at King's College, Fredericton; and assistance, where necessary, to those who may be under preparation for the Ministry, especially Sons of Clergymen.

3. Aid to Sunday and other Schools in which Church principles are taught, and the training and encouraging of Schoolmasters and Catechists.

4. The supply of Books and Tracts, in strict conformity with the principles of the Established Church.

5. Aid to the building and enlarging of Churches and Chapels.

6. Aid to the building of Parsonage Houses.

7. The creation of a fund towards the augmentation of the stipends of Clergymen who are poor; and towards the education of the Children of such Clergymen; and towards the making a provision for those who may be incapacitated by age or infirmity.

8. The creation of a fund for the Widows and Orphans of the Clergy.

VII.

The Society will employ no Clergyman on Missionary services without the Bishop's licence and appointment, and will submit its choice of Divinity Scholarships to His Lordship's approbation.

VIII.

The Society will circulate no Books which are not in the Catalogue of the Society for promoting Christian Knowledge, except such as the Bishop shall approve.

IX.

It shall be competent to any Member of the Society to limit his subscription to any one or more of the objects above recited, which he may be most anxious to promote.

X.

The Members of the Society in each Mission, or in each Parish of each Mission, at the discretion of the Missionary, shall constitute a Local Committee.

XI.

It shall be competent to each Committee to recommend any of the above recited objects to the special consideration of the General Committee, in the appropriation of the funds of the Society.

XII.

The Society shall hold its Anniversary Meeting at Fredericton and Saint John alternately; at the latter place on the Thursday after the third Tuesday in January, and at the former

place on the Thursday after the second Tuesday in February in each year.

XIII.

The Committee of each Parish or Mission shall hold an Annual Meeting, on some convenient day, previous to the Anniversary Meeting, when the recommendation to the General Committee of special objects shall be determined on.

XIV.

Each Local Committee shall be empowered to depute two Lay Members of the Society to be elected at the Annual Meeting of the Committee, to assist the Missionary in submitting the recommendations of the Committee to the consideration of the General Committee.

XV.

For this purpose the Missionaries and Lay Deputies shall meet in General Committee on the two days, or more if need be, previous to the Anniversary Meeting, to make the annual appropriation of the funds of the Society.

XVI.

The Executive Committee shall meet either at Fredericton or Saint John, on the first Wednesday in January, on the day after the Annual Meeting, on the first Wednesday in March, on the first Wednesday in June, and on the Wednesday after the first Tuesday in October.

XVII.

The Clergy are requested to preach annually two Sermons in their respective Churches, with a collection on each occasion for the General Purposes of the Society.

XVIII.

No article of the Constitution of this Society shall be rescinded, altered, or amended, except with the concurrence of two thirds of the Members present at a General Meeting: and notice of any motion shall be given at the General Meeting previous to the one at which such motion is to be made.

Prosper with Thy blessing the designs of this Society. Comfort with Thy grace those benefactors who contribute to its support. Bless the ministry of thy servants, the Clergy; the endeavours of all who are engaged in spreading the knowledge of true religion in the dominions of our Sovereign, and the labours of those Missionaries who are promoting the same in this Province. And may Thy Holy Spirit direct all our consultations to the advancement of Thy glory, and the good of Thy Church, through Jesus Christ our Lord.—Amen.

O MERCIFUL GOD, who hast made all men, and hatest nothing that Thou hast made, nor wouldest the death of a sinner, but that he should be converted and live: Have mercy upon all Jews, Turks, Infidels, and Heretics, and take from them all ignorance, hardness of heart, and contempt of Thy Word; and so fetch them home, blessed Lord, to Thy flock, that they may be saved among the remnant of the true Israelites, and be made one fold under one Shepherd, Jesus Christ our Lord, who liveth and reigneth with Thee and the Holy Spirit, one God, world without end.—Amen.

OUR Father, which art in Heaven, Hallowed be Thy name. Thy Kingdom come. Thy will be done in earth as it is in Heaven. Give us this day our daily bread. And forgive us our trespasses, as we forgive them that trespass against us. REPORT.

It has been wisely ordered, that to effect any object for the well-being of man, much exertion and self-denial are required. By no other means has any important end ever been attained. Man must labour to gain his daily bread,—the support of his material frame: and the obstacles which demand all his energy for the spiritual welfare of himself or others, are aptly represented by the “thorns also and thistles,” which the ground was ever doomed to bring forth. To afford to the ignorant and the destitute the means of salvation, as far as the human effort is concerned, comes under this universal law; and generally, in proportion to the exertions which are made, is the Divine blessing imparted. To try our faith and save us from the sin of vain-glory, this blessing may at times seem to be withheld, but even then, we are told not to “be weary in well doing, for in due season we shall reap if we faint not.”

All professed members of the Church must admit, that by the extension of her ministrations the command of the great Head of the Church can be most effectually performed. To do His blessed will, and spread abroad the glad tidings of His salvation, is the grand object for which we are associated. We cannot expect that this will be a light work, or easily accomplished. Difficulties will from time to time be presented; imperfections, to which human instrumentality is ever subject, will be made manifest; and the object we seek to gain may seem distant and unattainable. But when we look at what has already been done by this Society, and examine the Reports of the past years, we find it steadily, though slowly gaining ground, and its members shew, by their continued offerings, substantial proof of their confidence in its operations. Thus an impulse is given to increased exertion, and our labour is lightened by the hope that the arm of Omnipotence supports and directs our cause.

We are engaged in this great work at a period of diversity of opinion even among the members of the Church. But whatever the nature of these differences, or the evils to which they lead, we must all agree that, as christians—members of Christ's Holy Church—we are bound to maintain and to extend, as far as in us lies, the blessings we ourselves enjoy.

Among churchmen both in England and the United States, the feeling is said to be every day prevailing, that it is high time to lay all party feeling aside, and as the peculiar people purchased by the blood of a common Saviour, to shew forth by united works of love "the praises of Him who hath called us out of darkness into his marvellous light." The work for which this Society solicits the offerings, labours and prayers of her members may, most of all, lead to such a desirable result amongst ourselves. That great spiritual destitution exists, not only in more distant settlements, but every where around us, is notorious. "The harvest truly is plenteous, the labourers are few." Many thousands for whom our Saviour died are born, and live and die without God in the world. Let a sense of this appeal with its full force to every heart, and there will be found little time and less inclination for any thing but what may conduce to the salvation of those whose spiritual wants call upon us for relief. In doing this, the distant members of the Church will look towards us with hope; many now living as heathens will be led to our Communion, and all will see from what the Church is doing, what they will never be led to believe by any other means, that "the Lord of Hosts is with us, that the God of Jacob is our refuge."

By a perusal of the following Abstract of the Reports of the Local Committees of our Society, we shall find much cause for gratitude and encouragement in this labour of love.

ST. ANDREWS.—Rev. Dr. Alley writes, that at the annual meeting of this Local Committee on the 23rd December 1852, the following Resolutions were unanimously passed:—

1. That this Committee continues to entertain a high sense of the labours of the Diocesan Church Society in this Diocese.
2. That the improvement in the prospects of this Town will, it is hoped, be attended by a proportionate increase in the subscriptions to the Society.
3. That the thanks of this Committee are due to the Lord Bishop of the Diocese for his unwearied labours in favour of the Society and of the Church committed to his charge.
4. That the Lay Delegates from this Committee be instructed to bring under the notice of the General Committee, the importance of the Society employing a Missionary to visit and labour amongst the different Islands in this County, comprising the Parishes of Campo Bello and West Isles.

Amount reported—Contributions, £21 13 1½; 1st semi-annual Collection, £2 10 10; 2nd do. £4 15 9; Total, general purposes, £28 19 8½.

CAMPO BELLO.—Rev. Dr. Alley encloses the sum of £6 10s. from this Parish, and also the following Resolutions passed at a meeting of the Local Committee held at Campo Bello on the 10th January 1853:—

1. Resolved, as the opinion of this Committee, that the labours of the Diocesan Church Society merit the thanks of the community at large for the good it has hitherto done in advancing the interests of true religion, and that, in the opinion of this Committee, it is the bounden duty of every member of the Church to aid it in every possible manner.
2. That the Lay Delegates be instructed to call the attention of the Society to the urgent necessity for the appointment of a Clergyman to this Parish, where there is a promising congregation, and every prospect of its increase, and where the members of the Church are willing to subscribe towards the support of a Clergyman as far as their means will allow.

GREENWICH and PETERSVILLE.—Rev. J. Bartholomew writes, that at meetings recently held in both branches of this Mission, Resolutions were passed, expressive of continued attachment to the Diocesan Church Society, and of gratitude for its liberal grants to that Parish. Although during the year there has been no great increase to the numerical strength of the Church, evidence has not been wanting, on the part of some, of a desire to cultivate a more pious and prayerful disposition, and thus prove themselves not only churchmen in name, but christians in deed. The erection of the Church at the Douglas Valley, which for a time was not proceeded with for the want of funds, has by aid from distant friends been again resumed. Further assistance from the Society is solicited for this object.

Contributions from Petersville, £7 1s; Greenwich, £10 17 7: Total, £17 18 7.

WESTMORLAND.—Rev. Donald M. Bliss reports contributions to the amount of £17 9 1; Collection in St. Mark's Church, June 18, £2; Do. June 25, £1: Total, general purposes, £20 9 1.

CHATHAM.—Rev. Samuel Bacon reports, that at a meeting of this Local Committee held at St. Mary's Chapel, after prayer, on the Festival of St. Thomas, it was unanimously resolved—

1. That this Committee return their sincere thanks for the various grants of books made from time to time towards the augmentation of their Sunday School Library, which are attentively perused and duly appreciated. They trust they will not be overlooked at the next appropriation.

2. That this Committee regret exceedingly that their contributions do not amount to so much as those of the preceding year. This, however, does not arise from want of confidence in the Society, but is owing to the inclemency of the weather at the time the semi-annual collections were made.

Contributions are—For Schools, 10s; general purposes, £13 5s; 1st Collection, £2 13s; 2nd do. £3: Total, £19 8s.

HARVEY and HOPWELL.—Rev. Charles P. Bliss writes, that he has succeeded in obtaining a larger amount of contributions to the Diocesan Church Society than last year.

The Harvey Local Committee met on the 23d December, and passed a Resolution thanking the Society for its aid in support of the Mission and the grants made towards the erection of the Church; and that, as the resident members of the Church were unable to complete the work and pay the debt already incurred, further aid is earnestly solicited.

The Local Committee of Hopewell, at their meeting on the 4th January 1853, also thank the Society for the grant to the Church in that place, and request another appropriation to assist in finishing the building.

Contributions reported from Harvey, £9 16 2; Hopewell, £4 2 6: Total, general purposes, £13 18 8.

MONCTON.—Rev. W. N. Boyer reports contributions from this Mission for general purposes, £2 0 3.

KINGSCLEAR.—Rev. J. Black reports contributions as follows:—Widows and Orphans Fund, £2 10s; general purposes, £8 10 7: £11 0 7: 1st Collection, £1 5s; 2nd do. £1 8 3: Total, £13 13 10.

GRAND MANAN.—Rev. G. T. Carey encloses a subscription list amounting to £4 5s., and requests a grant of books, consisting of the Common Prayer and Tracts.

CARLETON.—The Rev. F. Coater encloses returns as follows:—Contributions, £12 13 3; 1st Collection, £2 16s; 2nd do. £2 12s: Total, general purposes, £18 1 3.

GAGETOWN.—Rev. N. A. Coater reports contributions, £9 11 3; Collections at Church, £3 5s: Total, general purposes, £12 16 3.

FREDERICTON.—At a meeting of this Committee on the 6th December, the Venerable the Archdeacon in the Chair, it was reported that the annual subscriptions exceeded those of the past year, but that there was unavoidably a deficiency in the amount of the semi-annual collections.

It was resolved,—“That whereas there continues to be an increasing demand for Bibles, Prayer Books and other works at the Depository in this place, this Committee again strongly recommend a liberal grant for the importation of books, as well for the supply of grants to the different Local Committees, as for sale at the Depository.”

Contributions are £138 13 1; 1st Collection, Christ Church, £10; 2nd do. £11 11 8; 1st Collection, St. Ann's Chapel, £3 16 10; 2nd do. £3 9 8: Total, general purposes, £167 11 3.

NEW MARYLAND.—The members of the Church in this place have been called upon this year to contribute to the utmost of their ability for local purposes, which has prevented them from adding a larger amount to the funds of the Society. Contributions are £3 8 6; 1st Collection, 17s 4d; 2nd do. 19s 2d: Total, general purposes, £5 5s.

SACKVILLE and DORCHESTER.—Rev. T. N. DeWolfe reports contributions from Sackville, £7 16 1; 1st Collection, £1 5s; 2nd do. 15s 4d; Total, £9 16 3½; and from Dorchester, £4 8s; 1st Collection, £1 3 1½; 2nd do. £1 0 4; Total, £6 12 0½; in all, £16 5, for general purposes.

SIMONDS.—Rev. J. W. Disbrow writes, that he is requested by this Local Committee to thank the Society for its liberal grants. A grant for books is recommended by the Committee, and also an addition to the appropriation of last year towards the Church at Black River. He is happy to report a small increase in the amount of contributions, which he trusts will be continued every year. They are—Subscriptions, £8 19 4½; 1st Collection, £1 0 2; 2nd do. 12s 9d; Total, general purposes, £10 12 3½.

UPHAM and ST. MARTINS.—Rev. W. H. DeVeber reports, that the contributions from his Mission will probably somewhat exceed £25. He is happy to say that the interest felt by his parishioners in the Society's welfare continues unabated. He returns thanks for the grants of books to both Churches in his Mission, and hopes that they may be the means of promoting christian knowledge among his scattered flock. He regrets that he has not been able to avail himself of the grants to the Londonderry and Quaco Churches, but has no doubt that before the close of the ensuing summer the Church at the former place will be completed, and that at St. Martins in an advanced state. He cordially unites in the prayer, which he doubts not ascends from many a heart in every part of the Province, that God will bless the members of the Church with a deeper sense of their responsibility, and the almoners of the Society's bounty with such wisdom, that they may set forth the glory of God, and set forward the salvation of men.

PRINCE WILLIAM and DUMFRIES.—Rev. J. Elwell reports an increased amount of contributions this year, viz: general purposes, £5 5s; Collections in Church, £2 11s; Total, £8 6s.

SAINT JOHN.—R. Parker, Junior, Esquire, the Secretary of this Local Committee, reports contributions as follows:—Books and Tracts, £10; Widows and Orphans Fund, £16 2 6; general purposes, £138 2 4; Collection 21st June, £12 7 9; do. 17th October, £9 5 10; Total, £185 18 5.

During the past year the Parish of St. James has been set apart from St. John, which has limited the operations of this Committee.

SAINT JAMES.—H. W. Frith, Esquire, reports the formation of a Local Committee in this Parish, and contributions as follows:—Widows and Orphans Fund, £2; Parsonage House, £2; general purposes, £22 18s; Collection in June, £5 2 6; do. in October, £4; Total, £36 0 6.

The Church Wardens were appointed Lay Delegates to the General Committee, and were requested to obtain a grant of books for the formation of a Parochial Lending Library.

ANDOVER and GRAND FALLS.—The Rev. S. J. Hanford writes, that the grants of books made to this Mission were gratefully received. He solicits another appropriation this year for the Libraries attached to the two Churches and the Station at the Grand Falls, and also for distribution in his lengthened visits farther up the River Saint John. The contributions are—Widows and Orphans Fund, £2; general purposes, £12 1 3; 1st Collection, £2; 2nd do. £1 13 3; Total, £17 14 6.

HOWARD SETTLEMENT, DUMFRIES.—Rev. Thomas Hartin thanks the Society for the grant of books made to this Mission. He writes, that there are about forty families in the Settlement who attend the Church, but so widely separated that he is obliged to hold Divine Worship at four different Stations. In addition to this, the Missionary officiates once a month in the M'Ilroy Settlement, four miles above Eel River, and occasionally on the east side of the Saint John, in the Parish of Southampton. He has also extended his visits to the more remote Settlements along the River.

The Missionary entered upon his duties in July 1851, under many discouragements, and having much opposition to contend against. A favourable change has however taken place, and there is now evidently a growing interest in favour of the Church. He has already baptized seventy five persons; among whom was a venerable old man nearly sixty years of age. At the various Stations where Divine Service is held the attendance is generally good, and the Missionary is received with much kindness and respect.

Contributions are £9 11 7½; 1st Collection, 17s; 2nd do. 11s 3d; Total, general purposes, £10 19 10½.

GLENELG, and the Settlements on the South West Branch of the Miramichi.—Rev. J. Hudson, Visiting Missionary on the Miramichi, reports, that after Prayers on the Festival of Saint John the Evangelist, the usual meeting of the Glenelg Committee was held in the Parish Church, at which a Resolution was unanimously passed, expressing the people's lively interest in the Missionary operations of the Church Society,—“wishing it good luck in the name of the Lord,”—and re-affirming its urgent and undoubted claims upon the alms and prayers of all “sober, peaceable, and truly conscientious sons of the Church of England” throughout the Diocese.

During the past year, the still unassisted writer has officiated as often as possible in all the Churches and Stations in his present field of labour, and the services were better attended than he had reason to expect; but a long time must elapse before much fruit will be gathered in, and the hope of the present spiritual husbandman is rendered still more faint by the want of a true-hearted brother Missionary. O that God would "send forth more labourers into his harvest"—men willing "to endure hardness as good soldiers of Jesus Christ!"

Offerings given cheerfully to the Society have already been forwarded, to the amount of £21 1 4; besides such contributions as will be sent to the Treasurer before the next Anniversary Meetings take place. Books have been sold and paid for to the amount of £2 18 6.

NELSON.—Rev. J. Hudson since reports the formation of a Local Committee in this, an extensive but thinly populated Parish, and that at their meeting they passed a Resolution, thanking the Society for its liberal assistance towards the building and completing their Church, and requesting a grant towards liquidating the debt due on the Church in the adjoining Parish of Blackville. The amount of subscriptions from this Committee is £5 12 8, which makes in all, from Mr. Hudson's District, £29 3 1.

The Missionary concludes his Report with an humble request that he and his people may not be forgotten by the Executive Committee in their next distribution of Books and Tracts.

SHEDIAC.—Rev. Dr. Jarvis writes, that the contributions from Shediac are £3 10s; 1st collection, £1 5s; 2nd do. £1 10 7½; Total, £6 5 7½.

ST. MARY'S.—Rev. W. Jaffrey reports contributions in his Mission, £12 0 6; 1st Collection, 10s 6d; 2nd do. 7s 6d: Total, £12 18 6. The Missionary writes, for the information of the Society, that during the past year he has had thirty three baptisms, seventeen marriages, and three burials; and in the summer months about one hundred children are in attendance at three Sunday Schools. The prospects of the Mission, he continues, are encouraging; and in nothing more than the seeming unanimity which, by God's blessing, prevails amongst his people, which leads him to say thankfully with the Psalmist, "Behold how good and pleasant a thing it is, brethren, to dwell together in unity."

PORTLAND, and District of St. Paul's Church.—Rev. Messrs. Harrison and Lee report contributions from the District of St. Paul's Church, £34 11 9; 1st Collection, £8 10 11; 2nd do. £3 10 7: Total, general purposes, £46 13 3; and from the Parish Church, £16 2 5: Total, general purposes, £62 15 8.

WESTFIELD.—Rev. C. Milner encloses contributions for Books and Tracts, £6 18 3½; general purposes, £7 10s; 1st Collection, 12s 9d; 2nd do. 10s 3d: Total, £15 11 3½. His parishioners, he writes, are anxious for an addition to their Parochial Library, and for this desirable object, which he prays may prove a great benefit, he solicits further aid.

ST. GEORGE and PENNFIELD.—Rev. J. M'Givern reports, that at the meeting of this Local Committee on the 11th January the following Resolutions were passed:—

1. That the last year's Report affords additional evidence that this Society is gradually and steadily acquiring the confidence and regard of the members of the Church in this Province, and that this Committee consider the publication of the Society's Reports one means of diffusing much information as to its objects and actual operations.

2. That in the opinion of this Committee, the liberal amount annually received from the Venerable Society in England, ought to induce all those to whom God has given the means to contribute to the support of this Society, and especially towards the opening of new Missions.

3. That this Committee, thanking the Society for the grant of books last year, solicits a further appropriation for St. George and Pennfield. Contributions are £20 13 2; 1st Collection, £3 19 8; 2nd do. £1 11 5: Total, general purposes, £20 13 2.

The Rev. J. M'Givern in transmitting the above, expresses much thankfulness for the prosperity of the good cause, and considers the additional amount of contributions an indication of interest felt by his people in behalf of the Society; more especially as the parishioners of St. George have within the last month raised the sum of £50 for an object connected with the Church in this Mission. He requests an increased grant of books for the Parish of Pennfield.

SUSSEX.—Rev. T. M'Ghee reports contributions, £8 1 0½; 1st Collection, £2 2 6; 2nd do. £1 6 10: Total, £11 10 4½.

RICHIBUCTO.—Rev. J. Neales writes, that although at first prevented by illness from soliciting contributions, he is both gratified and surprised at being able to report a larger amount than last year. Subscriptions are, £29 7 3; 1st Collection, £2 5s; 2nd do. £2: Total, £33 12 3, for general purposes. "I trust" he adds "that by God's blessing more will be done next year, as we cannot do enough for our Master's cause—our Saviour's Church."

SPRINGFIELD.—The contributions reported from this Mission are, for general purposes, £4 17 5½.

LANCASTER.—Rev. T. W. Robertson writes, that at the annual meeting of this Committee on the 26th December, Resolutions were passed, expressive of their strong attachment to the Constitution of the Diocesan Church Society, and their confidence in the ability, disinterestedness and impartiality which characterize the management of its affairs and the distribution of its funds, pledging themselves to do all in their power to advance its interests. The Committee have as yet been unable to proceed with the erection of a Chancel to the Parish Church, in aid of which a grant was made last year. They now request an additional sum of £5 towards this object. The Committee also thank the Society for the grant of books.

Mr. Robertson is happy to say that the contributions exceed those of last year, although the people of Musquash have been to the expense of painting the Parsonage. He concludes by saying that everything is going on satisfactorily in his Mission, and that he never felt more encouraged to labour on, in the hope of a happy issue, than at present. "I thank God," he says, "for the past, and take courage for the future."

CAMBRIDGE, Queen's County.—Samuel J. Scovil, Esquire, has remitted contributions from this Parish to the amount of £11 for general purposes; and the Rev. A. Wood reports the additional sum of £1 17 6, and requests a grant in aid of finishing the Church at Young's Cove, and also a large Bible and Prayer Book for use in the same.

DOUGLAS.—Rev. A. V. Stuart writes, that this Local Committee met at his lower Church on the 29th December, and after prayer, passed the following Resolutions:—

1. That in the opinion of this Committee, it is very desirable to build a small Church near the Mills, in the lower part of the Parish, for the benefit of those families residing in the Settlement of the M'Leod Hill and on the Royal Road, those places having been for a long time destitute of Church privileges.

2. That an application be made to the General Committee of the Diocesan Church Society for the sum of £25 in aid of the above object, the cost of which is estimated at about £200, £66 of which have already been subscribed.

The Committee thank the Society for the grants of books, and trust they will be remembered in the next appropriation.

In a letter enclosing the foregoing Resolutions, Mr. Stuart urges very strongly the application for aid to the proposed Church, on the ground of the spiritual destitution of those whom it is intended to accommodate. He is happy to say that the attendance at Church in his Parish is good, and he thinks no detriment has arisen from his absence in England. He hopes that the cause of true religion is gaining ground.

Contributions are, £14 17 4; Collection, £1 15s: Total, general purposes, £16 12 1.

WOODSTOCK.—Rev. S. D. Lee Street reports, that the following Resolutions were unanimously passed at the annual meeting of this Committee on the 22nd December 1852:—

1. That this Committee again respectfully call the attention of the Lord Bishop and the Society to the spiritual wants of many portions of this extensive Mission, and the necessity of a more adequate provision for the support of a Curate, there being many Settlements to which it is impossible for the Rector, with the many calls upon his time, to give that attention which their spiritual necessities demand; and it is much to be feared, that even those now rightly disposed, must soon, as a natural consequence, become so estranged from the Church, that it will prove a work of time and labour to bring them back to the fold.

2. That this Committee, thanking the Society for the grants of books to the Lending Libraries of Woodstock, Richmond and Jacksontown, solicit further aid to the same object.

Contributions reported as follows—£38 18 9½; Collection, £2 8 3½: Total, £42 7 1.

KINGSTON.—Rev. W. E. Scovil writes, that this Committee met on the 15th December, and chose the Hon. W. M'Leod and David Wetmore, Esquire, for Lay Delegates to the General Committee. A Resolution was passed to the following effect:—That from the past operations of the Diocesan Church Society, and the good service it has already done to the cause of true religion, the Committee are encouraged to hope that a still more general interest will be felt in its welfare, and its means of usefulness increased, till the legitimate wants of the Church shall be supplied, and the saving truths of the Gospel made fully known throughout our Province.

QUEENSBURY.—Rev. H. W. Tippett reports contributions, £7 9 4, and Collections, £1 5s: Total, general purposes, £8 14 4.

ST. STEPHEN.—N. Marks, Junior, Esquire, Treasurer of this Committee, encloses the amount of subscriptions, £8 15s; collected at Church, £7 9s; collected at St. James, £2 3 6; Books sold, 7s 6d: Total, general purposes, £18 15s: additional, 10s: £19 5s.

The Rev. Dr. Thomson writes, that this Committee met in August last, and that a number of the Clergy were present, including the Rev. Mr. Durell, of Calais, and that Resolutions were unanimously passed expressive of the continued confidence of the meeting in the Society, and of their duty to support it as far as they were able. Through the indefatigable exertions of Mr. N. Marke, a larger amount than usual has been obtained this year.

Dr. Thomson regrets that an attack of illness prevents his having the pleasure of attending the annual Meetings.

They have desired him to use his exertions in pressing upon the General Committee the urgent need of a new Church in the Parish of St. David, to replace the present dilapidated building, and they pledge themselves to do their utmost in rearing a House at once creditable to themselves and fit for the worship of the Most High.

The contributions from St. David are £10.

The people of St. Patrick, the Missionary regrets, are unable to contribute to the Society this year, as all their means are required for the repair of the Parish Church, in consequence of the insufficiency of its foundation.

HAMPTON.—Rev. W. W. Walker reports contributions for Widows and Orphans Fund, £4; general purposes, £16 1s; 1st Collection, £2; 2nd do. £2 12 6; sale of Books, 6s 6d: Total, £25.

Thus, the members of the Society may perceive that during the past year there is reported as follows:—For Schools, 10s; Books and Tracts, £16 18 3½; Widows and Orphans Fund, £29 9 3; Parsonage Houses, £2; General purposes, £1012 7 8: Total, £1061 5 2½. Contributions are still expected from three Local Committees.

It was said of the great increase to the funds of the Parent Society during the past jubilee year, that—though vast the amount received, and cheering the circumstances which attended that celebration,—yet “the work had been scanty weighed with the opportunity;” the offerings small compared with the wealth of English Churchmen—small compared with the extent of want which appealed for relief. May not the same be said with equal truth of us? Has enough been done compared with the ability God hath given, the high privileges we enjoy, the destitution which exists, and the strict account we shall have to render? Our country during the past year has been blessed with much prosperity. Do the fruits shewn forth of our gratitude warrant the hope that these great blessings will be continued?

By the introduction of public works, the prospect is opened of rapid and increased communication with adjoining countries. This measure, with its supposed advantages, will bring among us a great increase to the number of those whom we should stand ready to lead in the way of righteousness. Before this Society then, a work is set forth, which may well call into action the best energies, and the self-denying zeal of every member of the Church; a work worthy of the greatest self-sacrifice; a work which may be aided by the smallest gift, and furthered by the humblest prayer. A work, in which we must not fail nor be discouraged, till the most distant and the poorest in our land have received the means of grace; until the Word of God and the Book of Common Prayer are placed in every hand; until in every spiritually barren waste a House of God is built and a Clergyman settled in an adjoining Parsonage,—the example, friend and guide of his flock; until a sufficient fund is provided for the Widows and Orphans of those Pastors who have finished their course,—and all the members of the Church, as brethren drawn together in this work of love, can then look abroad upon some dark heathen land to which to return the bounty they themselves have so long received.

 addressed a letter to the Chairman, expressing their dissent to the alterations so
 reported. Notwithstanding which, the Bill passed the Council with such alter-
 ations, but was afterwards rejected by the House of Assembly, for the reasons

Read by the Secretary a Petition addressed to His Excellency the Lieutenant Governor and the two other Branches of the Legislature, praying that the said Bill may pass.

Whereupon, on motion of the Hon. Mr. Justice Street, seconded by Mr. F. A. Wiggins—Resolved unanimously, that three copies be made of the said Petition, and when signed by the President of the said Society, one be laid before His Excellency the Lieutenant Governor, that the Hon. E. B. Chandler be requested to present one to the Legislative Council, and the Hon. the Attorney General be requested to present another to the House of Assembly.

On motion of the Hon. the Attorney General—Resolved, that copies of the foregoing Resolutions, certified by the Secretary, be attached to the said Petitions.

The Hon. Read by the Secretary, from the Minutes of the Executive Committee, the appointment of a Committee in October 1852, to prepare a draft of a Bill to incorporate the Society, and their Report to the Lord Bishop.

Mr. W. Wright, from the said Committee, presented the draft of an Act of Incorporation, which he read; which having been amended by striking out certain clauses, which do not form a part of the present constitution of the Society, and agreed to by the Committee,—

On motion of Mr. W. Jack, seconded by Mr. W. Carman—Resolved unanimously, that the Report now read be adopted, and the draft of the Bill as proposed, be accepted and approved by this Meeting.

Read by the Secretary a Petition addressed to His Excellency the Lieutenant Governor and the two other Branches of the Legislature, praying that the said Bill may pass.

Whereupon, on motion of the Hon. Mr. Justice Street, seconded by Mr. F. A. Wiggins—Resolved unanimously, that three copies be made of the said Petition, and when signed by the President of the said Society, one be laid before His Excellency the Lieutenant Governor, that the Hon. E. B. Chandler be requested to present one to the Legislative Council, and the Hon. the Attorney General be requested to present another to the House of Assembly.

On motion of the Hon. the Attorney General—Resolved, that copies of the foregoing Resolutions, certified by the Secretary, be attached to the said Petitions.

The Hon. Mr. Justice Parker renews the notice given last year, of the following Resolution to be moved at the next annual meeting:—"That in future no part of the funds of the Society shall be appropriated to the building, repairing or enlarging any Church or Chapel, except some Parish Church, or some Chapel belonging thereto." And also, that he will at the same time move the following Resolution:—"That no more than two of the Judges of the Supreme Court shall be members of the Corporation at the same time; and no payment of money at any one time, or annually, shall constitute the Chief Justice, or any Judge of the Supreme Court, a Member of the Corporation, if there be at the time two Judges of the Supreme Court Members thereof."

Read an account of the St. John Book Depository Committee up to the 18th May 1852, shewing sale of books, £8 18 6½. Also an account of the Fredericton Book Depository for the quarter ending June 30th, 1852, shewing amount of sales, £1 19s 6d; and a further return for the quarter ending Sept. 30th, 1852, shewing proceeds of sales, £18 19 10½. Resolved, that the said accounts be received.

Read an account of the Rev. J. Hudson, for travelling expenses from 31st May to 29th Sept. 1852, amounting to £7 9 8. Ordered that the same be paid.

On motion of the Rev. I. W. D. Gray, D. D.—Resolved, that the Loan Committee be requested to report on or before the next meeting of this Committee, the state of the Society's investment on the property of Mr. J. H. Hartt, in St. John; and also that they be requested to require the immediate pay-

ment of all balances of interest due on the several investments of the Society, and to report upon the same at the next meeting of this Committee.

Read a statement of the expenses incurred in printing the last Annual Report, amounting to £32 10s. On motion of Mr. W. Jack—Resolved, that the payment of the same be approved.

Read an application from the Rev. S. J. Thomson for books. On motion of Mr. J. V. Thurgar—Resolved, that books to the amount of £2 be granted to Mr. Thomson.

On motion of the Rev. F. Coster—Resolved, that the following gentlemen be a Committee to prepare another application to the Legislature for the Incorporation of the Society; and that they be requested to submit a draft of the Petition and Bill to the Executive Committee at their next meeting, in order to the same being brought before the next General Meeting of the Society, viz:—the Hon. the Attorney General, Rev. F. Coster, R. F. Hazen, W. Wright, F. A. Wiggins, and J. C. Allen, Esquires.

APPENDIX.

A COMPENDIUM, or Summary Statement of the Constitution, Bye Laws, Objects, Purposes and Proceedings of the Diocesan Church Society of New Brunswick, 1853.

The Diocesan Church Society of New Brunswick held its first meeting at Fredericton, February 9, 1837. Previous to that day there had been several Meetings of the Clergy of the Province, the first of them in 1832, in which a very decided opinion had been repeatedly expressed in favour of "an active union among the Members of the Church, both lay and clerical, for the promotion of such objects as the Church, wherever it exists, must find essential to its welfare and utility." On September 8th, 1836, they again assembled at Fredericton, on the invitation of the Archdeacon, for the consideration of a plan proposed by the late respected Bishop of Nova Scotia, for the formation of "a Church Society in each of the Archdeaconries of his Diocese, to embrace all the objects of the Societies in England for the Propagation of the Gospel and for Promoting Christian Knowledge." At this Meeting the Clergy formed the Society recommended by the Bishop, having agreed upon a Constitution, which was ratified and confirmed at the first meeting of the Society.

The following is a brief description of the composition of the Society, and of the different Committees, by whose agency its work is carried on.

I. THE SOCIETY.

The Society (by Rule III. of its Constitution) is composed of persons presumed to be members of the United Church of England and Ireland, who at any one time have paid a sum of not less than ten pounds to the Society, and by reason of such payment, are constituted Life Members; and also of such as pay to it annually any sum, however small. This sum (by Resolution 1838) is declared to be due at the Annual Meeting. The Society (by Rule XII.) holds an Anniversary Meeting at Fredericton and St. John alternately,—at the latter place on the Thursday after the third Tuesday in January, and at the former place on the Thursday after the second Tuesday in February. At this meeting the election of the officers of the Society takes place. The officers elected annually (by Rule IV.) are "one or more Treasurers, one or more Secretaries, and two Auditors of Accounts." The Executive Committee is also elected at this time: and all motions are disposed of for effecting alterations in the Constitution. It is necessary (by Rule XVIII.) that notice of any motion for effecting such alteration should be given at the General Meeting previous to the one at which such motion is to be made; and no article of the Constitution can be altered, except with the concurrence of two thirds of the Members present. And (by Rule II.) every alteration in the Constitution, before it becomes of any force, must be sanctioned and confirmed by the Bishop, by writing under his hand.

Special General Meetings are called by the Bishop, as President, upon authority given to him, for that purpose, by the Society, at an Anniversary Meeting.

II. THE GENERAL COMMITTEE.

The General Committee of the Society is composed of Clergy and Lay Deputies. The Lay Deputies consist (by Rule XIV.) of two Members of the Society elected by each Local Committee, at the annual Meeting of such Committee. These Clergymen and Lay Deputies (by Rule XV.) meet in General Committee on the two days (or more if need be) immediately preceding the Anniversary Meeting. In this General Committee, all applications for aid out of the funds of the Society are considered and disposed of; and all grants of money made; all accounts passed; and in general all business transacted, in any way connected with the administration of the funds of the Society.

The powers of the Lay Deputies (by Resolution 1837) are verified by a Certificate under the hand of the Chairman or Secretary of the Committee deputing, in form following, viz:—"This is to certify that A. B. and C. D. were elected at the Annual Meeting of the ——— Committee of the Diocesan Church Society, as Deputies from that Committee, under the authority of Article XIV. of the Constitution. (Signed) E. F., Chairman or Secretary." Dated ——— 18—.

In all cases of irregularity in the form, substance or mode of execution of the certificate, a vote of the General Committee is requisite to give effect to the appointment.

III. THE LOCAL COMMITTEES.

The Local Committees consist of all Members of the Society, residing in the several Parishes throughout the Diocese. They hold respectively an annual meeting (by Rule XIII.) on some convenient day previous to the Anniversary Meeting of the Society, at which annual meeting they elect two Lay Deputies from that Committee to the General Committee; and determine what objects they will recommend to the special consideration of the General Committee, in the appropriation of the funds of the Society,—it being competent (by Rule IX.) to any Member of the Society to limit his subscription to any one or more of the Society's objects, which he may be most anxious to promote.

The Clergy (by Rule XVII.) are requested to preach annually two Sermons in their respective Churches, on behalf of the Society, and to take up a collection on each occasion for its general purposes.

IV. THE EXECUTIVE COMMITTEE.

The Executive Committee (by Rules IV. and V.) consists of the President, the Vice Presidents, the Treasurer, the Secretary, the Auditors, the Clergy of the Diocese, and twenty four Lay Members of it, being either Life Members or subscribers of at least one pound to the funds of the Society, and annually elected at the Anniversary Meeting. This Committee has a Secretary elected at the same meeting. It meets at Fredericton and St. John alternately on the following days, viz. the first Wednesday in January; the day after the Annual Meeting; the first Wednesday in March; the first Wednesday in June; and on the Wednesday after the first Tuesday in October. By this Committee all business of an executive character is transacted, except such as is specifically committed to the General Committee.

V. THE DEPOSITORY COMMITTEES.

There are two Depositories for the Books imported by the Society, for sale and distribution—one at Fredericton, the other at St. John. Each of them is managed by a Committee, elected by the Executive Committee out of its own body, usually at the meeting which occurs on the day after the Anniversary Meeting. Each has its own Chairman and Secretary. Regulations are from time to time prescribed to these Committees by the Executive Committee, in addition to those contained in the Constitution. The Books and Tracts to be supplied (by Rule VI.) are to be in strict conformity with the principles of the Established Church, and (by Rule VIII.) none are to be imported or circulated, which are not in the Catalogue of the Society for Promoting Christian Knowledge, except such as the Bishop shall approve,—such approval (by Resolution of the Executive Committee 1849) to be manifested only by his Lordship's signature. Additional regulations were ordered by the Executive Committee, March 6, 1850. (See 15th Report, page 25.)

VI. THE LOAN COMMITTEE.

The Loan Committee is also a Committee elected at the first meeting of the Executive Committee, which occurs after the Anniversary Meeting, and out of that body. It is the duty of this Committee to effect proper investments of the Society's funds; in the performance of which duty, the members of it are guided by instructions from the Executive Committee. Regulations were enacted for their guidance, June 7, 1848. (See 13th Report, page 19.)

VII. THE OFFICERS OF THE SOCIETY.

The respective Lieutenant Governors of the Province in succession, since the formation of the Society, viz. Sir Archibald Campbell, Sir John Harvey, Sir William M. G. Colebrooke, and Sir Edmund W. Head, have been severally pleased to accept the office of Patron of the Society.

The Lord Bishop of the Diocese (by Rule IV.) is declared to be the President of the Society.

The Archdeacon of the Province (by the same Rule) is declared its first Vice President, and (by Resolution 1837) there were nominated as Vice Presidents—being members of the Society—the Chief Justice, the Members of the Legislative and Executive Councils, the Speaker, the Judges of the Supreme Court; (by Resolution 1838) the Attorney and Solicitor General; (by Resolution 1841) the Master of the Rolls; and (by Resolution 1852) Frederick A. Wiggins, Esq. was elected in the room of the late Wm. Scovil, Esq. The Treasurer, the Secretary, the Secretary of the Executive Committee, and the Auditors, are, as before stated, annually elected at the Anniversary Meeting.

VIII. THE OBJECTS OF THE SOCIETY.

The objects embraced by the Society are (by Rule VI.) the following, and none other:—

1. Missionary Visits to places where there is no settled Clergyman, and aid to new and poor Missions.
2. The establishment of Divinity Scholarships at King's College, Fredericton, and assistance, when necessary, to those who may be under preparation for the Ministry, especially sons of Clergymen.
3. Aid to Sunday and other Schools in which Church principles are taught, and the training and encouraging of Schoolmasters and Catechists.
4. The supply of Books and Tracts in strict conformity with the principles of the Established Church.
5. Aid to the building and enlarging of Churches and Chapels.
6. Aid to the building of Parsonage Houses.
7. The creation of a fund towards the augmentation of the stipends of Clergymen who are poor; and towards the education of the children of such Clergymen; and towards the making a provision for those who may be incapacitated by age or infirmity,
8. The creation of a fund for the Widows and Orphans of the Clergy.

IX. THE PROCEEDINGS OF THE SOCIETY.

1. MISSIONARY VISITS.

For carrying out this most important object, the General Committee makes a large annual grant. Upwards of £700 is generally appropriated to the payment of allowances to different Clergymen serving in the Diocese, in sums of £30, £50 and £60, according to the amount of salary allowed them in other quarters. The number of such Clergymen is at present seventeen. The amount of capital funded by the Society for this object is, with interest, very nearly £400; and it is to this object that the munificent legacy of £10,000, recently bequeathed to the Society in reversion, by the late Chief Justice Chipman, is dedicated by his Will. For Missionary purposes the Society has already expended the large sum of £3,800.

2. DIVINITY SCHOLARSHIPS.

The sum funded for this object, with the interest which has accumulated upon it, is £65.

3. SCHOOLS. 4. BOOKS.

These two objects have been hitherto to a great extent united, the aid afforded by the Society to Schools being almost invariably in the shape of Books. The Books imported by the Society consist of Bibles, Testaments, Prayer Books, and the publications of the Society for Promoting Christian Knowledge, together with such other works as may be selected by the Depository Committees, and approved by the Bishop of the Diocese. A Grant of Books is made every year to each of the Local Committees of the Society, and a stock is constantly kept on hand for sale at the Society's Depositories at Fredericton and Saint John. The value of the Books already imported by the Society is very nearly £3,500.

5. CHURCHES.

Since it commenced operations, the Society, at an expense of very nearly £1,700, has by its grants aided in the erection of no less than 54 Churches in different parts of the Diocese, and in the enlargement of 5 others; making a total of 59 Churches and Chapels built or enlarged.

6. PARSONAGE HOUSES.

At an expense of upwards of £300, the Society has assisted in the erection of 11 Parsonage Houses in the Diocese.

7. AGED CLERGY FUND. 8. WIDOWS AND ORPHANS FUND.

The amount of the Society's capital funded for these two objects, till lately united, with the interest thereon, is upwards of £800, the General Committee having made a grant to the Fund every year since the formation of it in 1846. Out of the interest which has accrued, allowances have already been made to the Widows of three deceased Clergymen.

All grants by this Society (by Resolution 1841) for any purpose whatever, become void if not claimed within three years from their dates respectively.

The Bishop requests the Clergy to be so good as to preach the Sermons for the Church Society in June and October, and if possible, not to delay the second sermon to the latter part of the month, as the weather is often unfavourable to a collection.

A Resolution was passed at the last Annual Meeting of the Society—

"That His Lordship the Bishop be requested to obtain from the Clergy, and that the Clergy be requested to furnish, on or before the first day of June next, a return of the several Churches and Chapels erected or in progress of erection, within their several districts, specifying the dimensions of the same, and the amount of accommodation they respectively contain, and the date at which they were completed, or in case of those not completed, the time at which they were commenced; and that such returns be forwarded to the Reverend the Secretary."

In compliance with the above Resolution, the Bishop requests that the Clergy will furnish the Secretary with such information as it is in their power to give.

The Secretary of the Society takes this opportunity to request, that when it is equally convenient, parties wishing to remit payments to the credit of the Society, would enclose the same direct to the Treasurer. This method will be more convenient for that officer and relieve the Secretary from unnecessary responsibility. He also respectfully calls the attention of the Clergy and others to the latter clause of the Auditor's Report, (see page 31.)
