But I have spoken to Mr. Townend at the Treasury who filed in the main app. Stalling tactics have been applied by the War Office on the principle that the longer we take in coming to a decision officially the less we shall have to pay out to the Americans - who are apparently in the right. The Treasury are concealing a suitable reply to B.M.E.O.

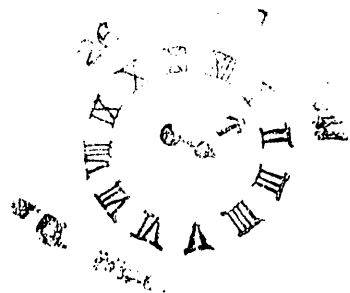
