

#### NOTES ON THE GOTTS OF NEW ENGLAND

The name of Gott is of Old English origin, meaning a water way or water course, to be recognized in our word gutter and gut, meaning a channel of restricted limits. As early as the fourteenth century Gotts appear in the English records and later as residents in Yorkshire and in Kent. A diligent search among the parish records of Old England has failed to locate the antecedents of Charles Gott and his wife Sarah, first of the name in New England. In the publications of the British Records Society the name is frequently met with and also in the numerous English county genealogies; but no mention of any Charles Gott of whom Hubbard thus speaks: "With Mr. Endicot in the year 1628 came Mr. Gotte, Mr. Brokenbury, Mr. Davenport and others who being added to Capt. Trask's preparations for a new colony that was coming over."

The Captain Trask mentioned by the New England historian was Captain William Trask and it is interesting to note this early mention of two family names well known in the Mount Desert region.

As the history of any region is contained in family records I make no apology in presenting these papers relating to the Gotts of New England who spread from Salem, Massachusetts, to Connecticut and to New York; to various parts of Maine, especially Mount Desert where many of them were among the first permanent settlers.

La Petite Plaisance of Champlain is our Gott's Island of today; a name for which the lack of euphony is more than compensated by its signifigance in the pioneer history of Mount Desert.

# THE GOTTS OF WENHAM, MASSACHUSETTS

## CHARLES GOTT, THE IMMIGRANT ANCESTOR

On June 28, 1628, the ship Abigail sailed from Weymouth, England for America. Among those on board were John Endicott, afterwards Governor of the Province of Massachusetts Bay and Charles Gott. After a passage of two and a half months the Abigail reached Salem and two years later the records show that Charles Gott, on October 19, 1630, requested admission as freeman; that on May 18, 1631, he was received as such. In 1635 he was made a deacon of the Church and all through his life he played an active part in civic affairs. His wife's first name was Sarah but I have been unable to determine her maiden name. In the Records and Files of the Quarterly Courts of Essex County (published by the Essex Institute, 1917), a John Mansfield is mentioned as a cousin of Daniel, son of Charles (2:251), but this is a clue that I have not yet been able to follow up.

There is on record a Gift Gott who subscribed her name to the covenent of the First Church of Salem, 1637 (Hist. Coll. Essex Inst. 1:39, 1859). Perhaps she was the mother of Charles Gott or his sister.

Charles and Sarah Gott were the parents of three children, (Salem Rec.) Deborah, bpt. Dec. 12, 1636; Charles, bpt. April 1639; Daniel, bpt. April 28, 1646, though Savage (Genealogical Dict. 2: 284), gives these baptisms as of Feb. 12, 1637; June, 1639, June 28, 1646.

In 1653, Charles Gott purchased land and a dwelling house in Wenham, Mass., removed thither with his family and spent the remainder of his life there. He represented the Town in the General Court from 1654 to 1666 and hisname is frequently mentioned in the records. On December 8, 1663, both he and his wife were admitted to the Wenham Church. His wife Sarah died on August 8, 1665. The Court Records give the date of Charles Gott's death as January 23, 1667. In his will, proved March 31, 1668, he mentions his sons Charles and Daniel; Charles "shall have my great Copper Kitle," and Daniel "my brass Kitle."

# CHARLES (II) SON OF CHARLES (I)

Charles, the elder son of Charles of Salem and Wenham, was made a freeman on May 27, 1663; admitted to the Wenham Church with his father and mother, December 25, 1665; married November 12, 1659, Sarah, daughter of Edward Dennis, of Boston. Sarah died August 8, 1665, and on December 25, 1665, Charles married as his second wife, Lydia, daughter of William Clark. Lydia was born October, 31, 1642 and died February 20, 1717-18.

Charles Gott saw military service as Lieutenant of a training band in 1693. Children of Charles and Sarah Dennis Gott from Wenham Records:

# DANIEL (II), CHARLES (I).

Daniel, youngest son of Charles (I), m. Jan. 2, 1665, Mary Morris (Wenham records), Nov. 2, 1665, Elizabeth Morris, (Lynn records). Daniel had four children: 1. Mary, b. Nov. 27, 1666. 2. Daniel, b. Aug. 15, 1668. 3. John, b. Sept. 17, 1672. 4. Thomas, b. July 22, d. Aug. 3, 1675. Wife Elizabeth d. Jan. 1690-1. Of Daniel (III) I find no record. Daniel (II) and wife were dismissed to the church in Lynn on April 12, 1682.

John (III) m. Elizabeth, widow of Jonathan Tarbox, of Lynn; had a dau Elizabeth who m. May 22, 1713, Joseph Skillion, of Marblehead, and a son John. b. April 17, 1700, at Malden. John (III) and family afterwards removed to Hebron, Conn.

The Lynn, Mass. records have the marraige intentions of John Gott, of Hebron, and Eleanor Tarbox, Sept. 26, 1718.

JOHN (IV), JOHN (III), DANIEL (II), CHARLES (I) was evidently the father of Daniel, John, Isaac, and Story who were all in military service in the French and Indian War from Hebron and are mentioned in records published by the Connecticut Historical Society. John (IV) and Eleanor Tarbox also had a daughter, Esther, b. 1743; m. March 25, 1762, Zebulon Strong, of Colchester.

In the U.S. Census, 1790, at Hebron were: Daniel Gott, wife and two daughters, and one son over 16; Jonathan Gott, wife, daughter, and one son under 16. From a published genealogy of the Strong family it is learned that a daughter of Zebulon and Esther Gott Strong. Rebecca Gouch. b. April 13, 1803, m. March 20, 1821, Hazael Gott, son of Hazael and ——Phelphs Gott, of Hebron.

A Hazael Gott was the father of Daniel, b. July 10, 1794, at Hebron, Conn., who became a very distinguished man. At the age of sixteen, Daniel went to Pompey, N. Y. where he was a teacher in the Academy. He lived with his uncle, Eben Barber and deciding to locate in Pompey in 1817 there took up his residence. He studied law with Daniel Wood and soon became a law partner of Samuel Baldwin. On Sept. 12, 1819, he married Ann Baldwin, widow of Stephen Sedgwick, of Pompey.

In 1846 he became a member of the National House of representatives, serving two consecutive terms. It is worthy of note that Daniel Gott, of New York, offered in Congress the first resolutions dealing with the Slavery question; that his bill to instruct the committee on the District of Columbia forbidding slave trade in the district passed, though it was afterwards reconsidered and smothered. (See Congressional Globe, 2nd. session, 30th. Congress, p. 38). The bill so alarmed the Southern members that on the night of Dec. 22, 1848, in caucus assembled, it was declared that his Northern encroachment could not be tolerated; hence the subsequent action.

In 1851, Daniel Gott was nominated by the Whigs for Justice of the Supreme Court, but he was defeated by Daniel Pratt. In 1844 he was on the electoral ticket for Henry Clay. In 1853 he removed from Pompey to Syracuse; died in Pompey, July 6, 1864.

By his marriage to Anne Baldwin Sedgwick Daniel became the stepfather to Henry J., John, and Charles B. Sedgwick. By his wife Anne he had:

#### THE GOTTS OF NEW YORK STATE

The Revolutionary War records of New York contain the names of David Gott, John Gott, and Story Gott. Jr. I am informed by Joseph W. Gott, Esq., of Goshen, N. Y., that an ancestor of his, Story Gott, who came originally from Hebron, Conn., lived at one time at Austerlitz, N. Y., thus establishing descent from Charles (I) of Salem and Wenham, Daniel (II) of Wenham and Lynn, John (III) of Lynn and Hebron, Conn. As Congressman Daniel Gott was from Hebron, both branches of the New York Gotts were related to each other and also, though the connection is very distant, to the Gotts of Mount Desert.

# JOHN (III) KNOWN AS LIEUTENANT JOHN OF WENHAM

John (III) of Charles (II) is frequently mentioned in both the Topsfield and Wenham records together with his sons John and Samuel. In May, 1699 we find him engaged with others in determining the boundary line between Wenham and Topsfield. As there was a Jonathan Gott sent with twenty other soldiers to relieve the garrison at York, Maine, by order of Commander-in-chief Bartholemy Gedney of date August 26, 1696, (Me. Hist. and Genealog. Rec., 3:109) it is likely that this was John Gott of Wenham.

John (III) married at Lynn, July 19, 1693, Rebecca, daughter of Samuel Tarbox. (Lynn Rec.) Rebecca was born August 8, 1672. John died at Wenham, January 25, 1722-3 and by will, dated January 21, 1722-3, he bequeathed to his son Benjamin two hundred pounds "in silver money and good bills of credit." His widow married, October 14, 1723, William Fairfield, of Wenham.

John Gott (IV) was a selectman of Wenham, served on various town boundary committees and his name is often coupled with that of his brother Samuel. Here is one of several entries in the Town records:

"At a Lawfull Town meeting March ye 11, 1728-9 Mr. John Gott and Mr. Samuel Gott all of Wenham concerning ye way which Leads from ye Town bridge through their Lotts to see if they will give Liberty of a convenient was for ye Neighbors to go through said Lotts." (Topsfield Rec.)

#### DR. BENJAMIN GOTT OF MARLBORO

Benjamin (IV) son of John (III) of Charles (II) of Charles (I) was a prominent citizen of Marlboro, Mass. He was a skillful doctor of medicine, noted for his kindliness. He was a man of considerable property. His first wife was Sarah, daughter of the Rev. Robert and Elizabeth Wainwright Breck. Robert was grandson of Edward Breck, the immigrant who settled at Dorchester, 1636.

Sarah Breck Gott died April 11, 1740, aged 29. On October 5, 1740, Dr. Benjamin married Lydia Ward, of Boston. Lydia died Oct. 11, 1745, aged 43 and Dr. Benjamin Gott died July 25, 1751. The Boston News Letter, Aug. 1, 1751, speaks of him as a man of great learning, pecularly faithful to his patients, moderate in his charges and charitable to the poor.

### SAMUEL GOTT OF WENHAM AND GLOUCESTER

Samuel (III) son of Charles (II) of Wenham, married in Wenham, June 26, 1697, Margaret, daughter of William and Margaret Woodward Andrews, of Ipswich. Two children were born to them at Wenham and in 1702 the family removed to Gloucester. On October 23, of that year Samuel purchased of William Cogswell, of Chebacco, for sixty pounds lawful money, eight six acre lots on Halibut Point.

Margaret Andrews Gott died on October 20, 1722 and on July 22, 1723, Samuel married Bethany, daughter of John and Margaret Gifford Cogswell. Bethany was born in 1687 at Ipswich and died on April 23, 1755. (Jameson, Cogswells in America, p. 52).

# DANIEL (IV), SAMUEL (III), CHARLES (II), CHARLES (I)

Daniel Gott, the Mount Desert pioneer was born in Gloucester, March 28, 1703. His mother was an Andrews, a descendant of Lieut. John, of Ipswich and through her Daniel was related to two other pioneer families of Mount Desert, the Norwoods and the Hadlocks. On December 22, 1726, Daniel married Rachel, daughter of Eliab and Rachel Littlefield, who removed from Wells, Maine to Manchester, Mass. Both the intentions and the date of the marriage are recorded in the Manchester records with the statement that the marriage took place at Gloucester.

#### THE GOTT FAMILIES OF MOUNT DESERT

Having traced the ancestry of Daniel Gott (IV), the patriachal pioneer of Mount Desert, attention will now be called to several generations of his descendants, together with those of Stephen Gott, his nephew, son of Daniel's brother Stephen and also those of Peter Gott, another nephew, brother of Stephen, who was the founder of the Gott Family of Swan's Island. As I have been frequently asked for information in regard to the early Richardsons of Mount Desert, perhaps this is an opportunity, since their wives were all Gotts, to give what I have been able to find about them.

Daniel Gott, Sen., Daniel Gott, Jr. his son, and Stephen Gott his nephew, were living on Somes Sound near the head when Governor Francis Bernard to whom Mount Desert Island was given by the General Court of Mass., caused surveys of the Island to be made in 1763.

Daniel Sen. afterwards moved to Bass Harbor, and later Daniel Jr. bought Little Placentia, now Gott's Island from Massachusetts. Here he lived and died. Stephen Gott later lived with his second wife, Sarah Hendley, near the head of Somes Sound on a little inlet still known as Granny Gott's Cove.

#### DANIEL GOTT (V) OF GOTT'S ISLAND

This Daniel signed the Bernard petition as Daniel Gott Jr. He married Hannah Norwood of Gloucester, a sister of Joshua and Stephen Norwood who were pioneer settlers at Mt. Desert. In 1785 Daniel built a house at Bass Harbor which he occupied that year. This house he sold to John Gott Richardson and removed to Little Placentia Island in the spring of 1786.

Daniel Gott received a deed from the Commonwealth of Massachusetts for Little Placentia and Bar Islands, now known as Gott's and Little Gott's Islands. This deed, given in consideration of eighteen pounds lawful money was signed on March 25, 1789, thus antedating the de Gregoire-Cadillac deeds by some three years; it is still in existence.

Daniel and Hannah Norwood Gott were members of the First Church of Mount Desert which was established on October 17, 1792. Hannah was one of the original members and Daniel was admitted on September 4, 1796.

#### PETER GOTT OF SWAN'S ISLAND

Peter (V) son of Stephen (IV) and Eunice Emmons Gott, was born at Gloucester Nov. 17, 1745. He was early at Mount Desert and returned to Gloucester where he married about the year 1776. Charity Carter. He then came back to Mount Desert and settled at Ship Harbor, near the present Radio Station.

In the Commissioners' report on disputed land titles, 1808, there is a reference to Peter Gott:

"Joshua Norwood saith Peter Gott took up this lott in the year 1780 and has lived on it ever since."

Hence, Peter was living at Ship Harbor on his one hundred acre lot as late as 1808. The date of his removal to Swan's Island has not been determined but it is certain that he did not settle there until after the year 1808.

Peter's wife, Charity Carter Gott d. before 1821. On Oct. 6, 1821 Peter m. Hannah Norwood Gott, widow of his cousin Daniel Gott of Gott's Island.

# THREE GOTT SISTERS WHO MARRIED THREE RICHARDSON BROTHERS

When Governor Bernard had a survey made of Mount Desert Island in 1763, Thomas and James Richardson were located near the head of Somes Sound. A few years later a brother, Stephen Richardson joined them, afterwards removing to Bass Harbor. It was at Stephen's house there that the first plantation meeting at Mount Desert was held, 1776.

The following records of Rachel, Elizabeth, and Margaret, daughters of Daniel and Rachel Littlefield Gott and wives of James, Stephen, and Thomas Richardson, have been obtained from Mrs. John Allan Somes with additions from the records of the town of Mount Desert.

About the year 1738 a Stephen Richardson and wife Jane Montgomery left Londonderry, Ireland, for Gloucester, Mass., removing soon to Londonderry, N. H. where some of their friends had preceded them. Five of their sons were at one time or another at Mount Desert, three of them locating permanently.

#### RACHEL GOTT RICHARDSON

Rachel, eldest daughter of Daniel (IV) and Rachel Littlefield Gott, married James, son of Stephen and Jane Montgomery Richardson who came to this country from Londonderry, Ireland, in 1738. James was born about 1730, and died at Mt. Desert. December 12, 1807. They were married at Gloucester, March 19, 1752 and came to Mount Desert, settling at the head of Somes Sound, 1763.

Elijah was a brother of Stephen, Thomas and James Richardson whose descendants are many in the Mount Desert region.

In a list of marriages noted in the almanac diary of Rev. Samuel Chandler, of Gloucester, (New England Historical and Genealogical Register, 56:319) appear the names of Elijah Richardson of Windham, N. H. and Jemima Gott of Gloucester, m. Nov. 8, 1764.

#### A FIFTH RICHARDSON BROTHER AT MOUNT DESERT

For a short time there was at Mount Desert a Hugh Richardson, brother of James, Thomas, Stephen, and Elijah. Hugh seems to have remained long enough at Gloucester to have married on Sept. 28, 1766, Elizabeth Clark. They had two daughters, Hannah, and Lucy Maderson b. May 7, 1768, who in 1786 married her cousin George, son of James and Rachel Gott Richardson; died March 10, 1809. In some Mount Desert records Lucy is referred to as Lucy Pindexter, a name for which I am unable to account. George and Lucy had several children and many descendants.

The Mount Desert records mention the marriage of a Hugh Richardson and Mary Scott, April 1, 1812; presumably a son of Hugh and Elizabeth Clark.

#### STEPHEN AND PATIENCE GOTT GOTT

Stephen (V), son of Stephen and Eunice Emmons Gott, was born in Gloucester, Mass. September 18, 1731. He married at Gloucester, January 9, 1755, his cousin Patience, daughter of Daniel and Rachel Littlefield Gott, born at Gloucester, August 18, 1737.

In the Mount Desert Register published in 1909, the maiden name of Patience Gott is given as Richardson. This is an error as shown by the Gloucester records; to be explained by the fact that since four Richardsons married four Gott girls the compiler of the records coupled the name of Richardson once or twice too oiten.

Stephen Gott and his family were living on Somes Sound as early as 1763, for his name appears in the surveyors' notes of that date.

At the close of the war Stephen and his 2nd wife returned to Mount Desert where she was known as "Granny Gott'."

Stephen and Sarah lived between Broad Cove and the Narrows on the western side of Somes Sound, so Mr. William S. Holmes tells me, near the shore of a small inlet still known as Granny Gott's Cove. Mr. Holmes also states that there was once an old cemetery on the Southwest Harbor road on the top of the hill north of Beech Hill cross road, and that he thinks Stephen and Sarah Hendley Gott were buried there.

Patience Gott married a second time for the Mount Desert records have the publishment, October 12, 1776, of Andrew Tarr and Patience Gott, "formerly the wife of Stephen Gott," and that a certificate of said publishment was received on October 28, 1776.

When Bartholemy and Marie Therese de Cadillac de Gregoire came to live on Mount Desert Island, Langley served as a sort of confidential agent and business manager for Mme. de Gregoire; made two trips on foot to Quebec across country on important missions for that lady; signed many papers as a witness, including many of the Cadillac de Gregoire deeds.

Philip and Esther dwelt happily together for many years on their island farm and although they had no children of their own they gave a good home to a boy and a girl whom they adopted. Later, when Lucinda Gott Stanley, sister of Esther, died a few days after her son William Blunt Stanley was born, Esther, on her return from the funeral at Little Cranberry Isle brought her tiny nephew back with her to Langley's Island, where he grew to maturity. To the Moore boys, sons of his first wife, Philip was a second father, and descendants of Joseph, Samuel and Welch Moore owe to him a large debt of gratitude for the paternal interest which he took in his step-sons.

When Philip Langley died, sometime in the early thirties, his widow, Esther Gott, unable to dwell alone on the island, sent for her brother Nathaniel and her younger sister Jane. Nathaniel and his wife, Hulda Hadlock, lived in a house which Nathaniel built, while Jane stayed with Esther in the farm house. Nathan-

iel's stay was not a long one and when he departed Esther and Jane looked about for some on who could run the farm for them.

#### JAMES GRENAN AND JANE GOTT

It was about the year 1835 that James Grenan, a native of Ireland, found his way from Halifax to Southwest Harbor where he obtained employment with Henry Clark, of Clark's point. One day Henry suggested to James that as Esther was on the lookout for a good steady man to run her farm for her, he better apply for the job, slyly adding that Jane Gott was a fine woman who would make any man a good wife, and that the fellow who got her would probably inherit Langley's Island sometime.

Grenan was not slow to act, and borrowing a skiff he rowed the short distance which separated him from the Langley farm, presented himself at the door, stated his errand and was hired on the spot. Esther and Jane need not leave the island now, for the farm would be in good hands. That sunny, jovial, capable James Grenan did not put all of his time on farming is shown by an entry in the Mount Desert Town Records to the effect that on July 5, 1837, James "Grinnin" was published to Jane Gott; that on the 21st of the same month "a certificate of said Publishment was returned" to the Town Clerk.

It was a grand wedding and the folks came from all over the region; from Gott's Island and Beach Hill. Bass Harbor and the Cranberry Isles, Gotts and Gotts-in-law arrived by the boat load, while the innumerable sisters of the bride made quite a good sized party by themselves. Though the groom, veritable character that he was, had no relatives in these parts, his droll humor, dry Irish wit and cheery good nature had won to him a host of friends, all of whom were among those present; and, thus, surrounded by this merry company, Jim Grinnin', as everybody called him,—the reason is apparent—and Jane Gott were made man and wife.

James had no children by Jane, but a son by a former marriage had been left in Halifax after the death of James' first wife. In 1839 this son, Richard by name, was brought to Langley's Island by James who made a trip to Nova Scotia for the purpose of bringing the boy, who was then about ten years old back with him. Richard was not a strong lad and his father worked hard and industriously to acquire a competence for him; but the boy died suddenly at the age of eighteen years.

Jane Gott Grenan died in 1857 and James inherited her share of the island. Early in the year of 1863 James purchased of William Blunt Stanley, Esther Gott Langley's foster son, his share of the island which Esther had deeded to William some years previous. Thus was Henry Clark's prophecy fulfilled, for Grenan now owned the whole of Langley's Island.

James Grenan married a second time and had three children; one who died in infancy, a daughter Cora, who married, January 12, 1882, William H. Bracy of Mount Desert, and a daughter Nettie M., who married, March 13, 1884, Otis L. Mills of North Haven who later removed to Southwest Harbor.

On the first coast chart of Mount Desert Island, published in 1875, Grenan's appears as Greening's, a form which still obtains, though for historical reasons, it must be conceded that Langley's Island would be a more appropriate name.

Not only was Philip Langley allied by marriage to two early pioneer families but he himself was a land owner at Southwest Harbor before 1783. This property

was later made over to his step daughter-in-law, Nancy Rich Moore, who, after her husband, Joseph Moore, was drowned, married Joseph Lancaster and with him and her children removed, in 1806, to Sutton's Island, the first settlers there.

The deed for Somes Island, as it was then called, given to Langley in 1788, in payment for the work which he did for Marie Therese Cadillac de Gregoire, was, with the possible exception of the Mayo deed for land at the Narrows, the first Cadillac de Gregoire deed executed on Mount Desert Island, and it antedates Daniel Gott's deed of Little Placentia from the Commonwealth of Massachusetts by a year or more. Langley settled at Southwest Harbor almost fifty years before James Grenan appeared on the scene, and for near half a century until death took him, he was a highly respected, well beloved citizen, whose fondness for children was proverbial.

It is to be regretted that the name of Langley is not now on the map of Mount Desert.

#### OTHER GOTT RECORDS

There was an Eliab Gott who, with his family, lived on Outer Long Island. He was a useful and industrious citizen, but there is nothing in the Mount Desert records to show his connection with the Gott families of Mount Desert. Eliab Gott m. Aug. 22, 1814, Sarah Ladd. Sarah was the dau. of Jacob and Hannah Lurvey, b. June 22, 1786, at Newbury, Mass., bpt. at Mt. Desert, Aug. 30, 1789. She m. 1st. Dec. 30, 1802, Moses Ladd, "a sojourner," and settled in Newbury, Vt. Moses served in War of 1812 and d. in camp at Platsburg, N. Y. His widow with her children returned to her father at Mt. Desert where she soon m. Eliab Gott. Children of Eliab and Sarah:

- 1. Martha, b. April 30, 1816; m. William Burns, April 10, 1832. Res. Eden.
- 2. Mary, b. April 30, 1816; m. Ezekiel Moore, son of Samuel and Sarah Peach Moore. Res. Cranberry Isles.

By the death of Sarah Lurvey Gott, May 20, 1816, not only were her twin daughters, Mary and Martha, left motherless but her five children by her first husband, Moses Ladd, became orphans.

Thomas and Mary Hadlock Manchester who lived on Great Cranberry Isle, took Irene and Hiram Ladd and their half sister, Mary Gott, the latter's birth being recorded in the Cranberry Isles Towns Records under Thomas Manchester's record. Irene Ladd is sometimes referred to as Urilla or Lorilla which was not her name. Miss Carroll tells me that when the Manchesters took Sarah Lurvey's children that Aunt Mary Manchester gave Irene the pet name of "Rilla" and that it is a mistake to speak of her as Lorilla or Urilla which are but derivations of a nickname.

Eliab m. 3rd., July 16, 1830, Tryphosa Ober, widow of John Ober who was one of the nineteen men lost off the schooner Minerva, Capt. Samuel Hadlock, Jr., master. The vessel was lost with all on board while on a sealing voyage to the Artic, March, 1829.
