

Leamington (Oct. 1908)Atlantic City 1

Sat. Oct. 17: Slept very well, having been very tired last night. Wrote to Prof. Edmon, about the M.S. of my "Jales out of School"; to Secy Brown, about the 2 M.S. I had left with publisher, in New York, on Wed. y; to Rev Mr. Kern of Parkesburg, about Latta's account; and to Pres. Roosevelt, offering to go to East Africa with him. Opened my box of framed diplomas, down in the cellar; & found half of the glasses of them broken. In afternoon, went to Mr. Kurtyhalz, of 6360 McCallum St., by 4. P.M., for an afternoon tea, and a 20 minute talk on "Missions in the Sudan". Miss Brown & her mother, and Miss Hurlow, whom I used to know at Dr. Morter's. Rev. Mr. Bennett, and about 30 ladies. A satisfactory talk. Returned. After supper, helped Elizabeth with her lessons in Latin.

Sunday
Oct. 18

A warm pleasant day; did not need to wear an overcoat. In morning, at Westside, a layman, a Mr. Gheson, of J. M. Co. A. work, in Japan, spoke in the pulpit. In afternoon, son William wanted me to take a class in Sab. Sch.; but I declined. Late in afternoon, took a walk toward Wisahickon creek. In evening, at Westside; Mr. Lee preached.

On the 19th, in the late afternoon, went to Atlantic City via Market St., and lodged at Craig Hall, by the Post office, corner of Pennsylvania & Pacific Ave. Attended Squad, in evening. Met many friends.

On the 20th, attended morning, afternoon, and evening, or Synod; and, at noon, meeting of Pky of New Brunswick. Rev. Dr. Holloway asked after daughter Mary; also, Rev. Dr. Landerburg; & Rev. J. W. Martin, of Hackettstown.

On the 21st. I presented the Prefertial Report of Corisco Pky, at request of its Committee, Rev. Dr. Mason, and, was appointed to attend the unveiling of the tablet, at Freshhold, for the late Rev. Dr. Chandler.

Thursday, 22nd. Up by 6. A.M.; a slight breakfast, with a Mr. Morgan, and, with him, off by 7.30. In Phil^a, at once to Dr. Warden, 17th & Spruce. Then, to 1515; the house still in confusion. Bessie & all out; but her cousin, Miss Berg~~er~~, with whom I left \$2.00, owned by daughter Mary, to Bessie; Back to Cheltenham; & found a number of letters awaiting me. May not well at all, wrote some letters. My eyes tired for sleep. The day cold. Retired early.

Friday, 23rd. A dull, damp day, with occasional rain. Writing on the "Memorial". A letter from Mrs. Robinson, of Freshhold, that she has visitors, and it not convenient for me to go there next week.

Store 116, North 3rd St. He had gone home. Went to his home at 217 Washington St., Haddonfield. Only himself & Mrs. M.C. & little Annetta at home. A pleasant evening chat.

On 20th: At the magnificent new Presb. ch.. The Pastor, Mr. Allen, away, exchanging with Rev. Mr. Bischoff of Audubon. Met many pleasant people I had formerly known of the church: Miss Long, Miss White, Mr. Henry & family. Was introduced to a Miss Bredt, daughter of Mrs. Bredt, who has written evangelistic hymns. In afternoon, at the splendid Sab. Sch. Talked, at request of the Supt. Mr. Perkins, for a few minutes, told story of Ekaterine & the snake. At church in the evening, sat in the pulpit, and assisted in services.

On the 26th, Breakfasted early. To Phil^{ly}; in the subway to Broad St.; to 11th & Fairmont, & got my books; to 1515, & Bessie told me about the bungalow. To Dr. Ward's; to the florist 17th above Chestnut. To Broad St. & Chilton, had 1 1/2 hours, to look over letters; make entries; gather things, and went to Trenton. Took lunch at a small restaurant near the Station; to the shoe-black; out to Miss Gummere's, by 3 P.M. Rainy afternoon. Remained until 6.30. At the Station, caught the 6.44 P.M. train to Germantown. A letter from Rev. Dr. Lowe;

Wed. 28th } up memoranda and answering letters.

The weather was variable. In evening, a game of lagomachy was interrupted by a call from a Mr. Perry, connected with the Silver Bay (Lake George) Summer Conference.

On the 28th, A rainy dark day, writing on the "Memorial," went into the city to Dr. Warder. My throat sore with a cold; do not know where I ~~got~~ took it.

Thursday, 29th: A rainy day. At "Memorial," and writing letters. In afternoon, went up Chelton Ave, to get my repaired shoes, and to look for a picture-store, to have ~~the~~ broken glasses of my framed diplomas repaired. Put some of the diplomas on the walls of my room. Lagomachy, Heavy rain at night.

Friday, 30th A cold day. Went into the city, in company with May, went to Dr. Warder's, To 1515, and saw Bessie; she phoned to Wananamakis for me, about the cardigan I ordered some 2 weeks ago. Returned, & went to Herm^{antown} Ave, to look for some one to put new glass on 2 of my framed diplomas. After lunch, took the 2 frames there. Wrote 3 letters. Prep and my remarks for Freehold.

On 31st, various jobs. In afternoon, about 3.30, to Freehold. Rev. Dr. Everitt on the train from Jamesburg. At Freehold, met by Mr. Cowart, & sent to Belmont Hotel. At supper time, was introduced to Dr. Hall, & sat at table with him & Mrs H. Mr. Cowart had come, and had told me arrangements for Sunday. And soon, Rev. A. W. Remington came, & told me the same. Bands of music, & Republican parade for the election. Called at Mr. Cowart's, to see Mrs Chandler, & her niece Miss Moore.

On Nov. 1st, clear, cool day. Went early to Sab. Sch. The Dept. Mrs. Barkala wanted me to speak, but, I declined. At church service, Tablet to Memorial of Rev. Dr. Chandler; address of Presentation & Reception by Mr. Cowart & Mr. McDevitt, my 15 minute Address, & Everitt's 10 minute paper. Pleasant welcome. Late in afternoon, went to say goodbye to Mrs. Chandler, Miss Perrine, Col. Wright. Loaded on new Robinson. Supper at Mr. Remington's. Spoke on Africa, for $\frac{1}{2}$ ^{hour} in church, at night.

On Nov. 2nd. By 9. A.M., went to Mr. Remington's, to go & play golf; but, air

was too cold. Went & made a long call on Mrs Laid; very affecting. Went to Elder Cowart's office; & he paid my expenses. Left for Trenton. Lunch at restaurant near the Station. To Hotel "Sterling", & left my suit-case; & shoe-black. Out to Mrs. Eumans, by 3. P. M. Walked with her to the Park. Returned to hotel; dressed; back to Mrs. Eumans, on the way, stopping at W. Hamill's; Hugo sick. Met Mr. Baldwin. Supper with the 3 sisters; and returned to hotel.

On the 3^d. Paid bill; breakfast; to Station to leave my suit-case. By trolley, and waited for Lawrenceville trolley; met Mrs. Furman & Mr. Berrian, Voted. Came back by trolley, & caught 11.05 A. M. train to N. Phil. At Germantown. Letters. Went up street, to get my repaired diploma frames. Parked, & left, to catch 3.20. P. M. train to Baltimore. Met by Mrs Baldwin. On trolley to her home. Her surprise at my having voted for Bryan. Elizabeth Baldwin's birthday-cake, & her young friend from Syria, daughter of a missionary.

On Nov. 4th. At supper, last evening, was a Prof. Willoughby; went to church

of Rev. Dr. Galtier, with Mrs Baldwin. Spoke for 1 hour, with the 55 stereopticon plates of Africa. Post Mrs Wiley & her son. At lunch, with Mrs Baldwin, Mrs Wiley, & Mr. W.; Rev. & Mrs Kinsolving; Rev. Dr. & Mrs Galtier; Mrs J. H. M. Knox & son; Rev. McIlvaine; Rev. Hurtle(?). & others.

The 5th. Very cold morning. At 11. A.M., Dr. Cox came in his buggy, & drove me the 5 miles to his home in Arlington, Park Heights, & Roper Station. E. Mrs Cox, & little Katherine & Newman. Mrs Porter, Rev. Neal, called. In evening, at the church fair; Mrs. Wiley; Miss Horne; Miss Haskell & her mother; Dr. ...; & Elder ...; & Mr. Ashburner; Mr. Miller; Hamilton
On 6th. In afternoon, on trolley, with Mrs Cox & the children, to her relatives, in county, Mrs Nourse, & took afternoon tea. At night, at church fair again. Very pleasant time.
On 7th. Into city, with Mrs Cox, shopping; and at 12.45, on electric car to Annapolis. Met by Barnett McComb. To Mrs Bowling's boarding house. Walk with McComb over Naval Academy grounds. To football game with Villa Nova. Good seat on middle seats. Afterward, walked to Library; Work shop; Y. M. C. A., and other buildings. Lacked at Gen. Breckinridge's

His daughter, Mrs. Hines, & daughter Miss Margaret. Called on Chaplain Clark; he not in.

On 8th. Rose late. Breakfast 9. At 10.30, the formation of the cadet march to Chapel. Splendid building; miserable acoustics. Chaplain Clark. McCoub at dinner; his mate Molton, & Mrs. Hy. (formerly Miss Brearly of Trenton). Rented. Called at 2.30, Prince George St. Lieut. Kerfoot, on mission Lida Gorman. Rented, supper at East. Brickmidge, at 6. P. M. At 7. P. M., at Y. M. C. A. Crowded, about 200. Commemorative Home. Led by Middy, Percy Wright, I spoke for an hour. Applause. A Middy, Rodgers, of Springfield, Ohio, & Fagan of Germantown. McCoub's room-mate. Officer Kerfoot.

Monday, 9th Paid bill at Mrs. Bowling's. Her horrible belief in the divine origin of Negro Slavery, and the blessings she claimed as flowing from it for that Race!! Left Annapolis, about 10.30 A.M. In Baltimore, after 2 or 3 mistakes as to the route on the street-car, found my way out to Arlington. Rented in afternoon. In evening, at Men's Meeting at the church. Addressed by George Smith, who said he had met me at a Grand Assembly; & by 2 others

gentlemen (Hall & McGill(?)), the latter said he had been member of church of the late Rev. Dr. Henry of Princeton ch. W. Phil^a.
A very damp, chilly evening.

Sunday 10th

My eyes very tired. Rested all morning. Mrs Cox's sad story of the victrola lady. In the afternoon, went, with Dr & Mrs Cox, into the city, to Mrs Watson's, and waited there until Dr. Co. came at 5 P.M., & took me to Dr. Kelly's, the distinguished surgeon, who had invited me to afternoon tea. Dr & Mrs K, & 5 of their children, their governess, & a lady visitor. His wonderful study & its surroundings. Kelly was very cordial, & we talked Africa &c, rapidly. Left, at 6 P.M. for Mrs Watson's. Dr. Co. returned home. Mrs C. & I went, with Mr & Mrs Watson to their apartment dinner, & returned to their home. Mrs Moore, Mrs C. & I went to Babcock Memorial Ch., to missionary address by Rev. Dr. Janvier. Met Rev. W. Neal there, with a Miss Kilgore. On the way home, Mr. & Mrs Zimmerman. Wed. 11 Slight rain. Rode with Dr. Cox, in his buggy, to Johns-Hopkins Hospital, to see an operation. His patient not willing to be operated. Dr. C.'s English fox-terrier followed us the whole way, 5 miles each way. Rested, in afternoon. Addressed Prayer meeting, at night. Rainy.

Baltimore (Nov. 1908) Germantown

Thursday, 12th. Weather clear & cold. By 9. A. M., said good bye, & Dr. box drove me into the city, to R.R. Station, for train to Phil^a, at 10. A. M. Reached N. Phil^a; & took street-car for Germantown. Rev. & Mrs. Malone had arrived 10 days ago, for the winter: the cellar crowded with their baggage; busy all afternoon, at letters, Mr. awaited me, and in looking over clothing in my trunks, for this cold weather.

Friday, 13th. Cold and clear. Went into the city to 1555, & saw son Charles. To Dr. Warden's, for treatment of my throat. To Wanamaker's, & paid my bill for Octob^r, including the cost of the suit of son William & hat of Elizabeth. In afternoon, writing letters, & hunting for my lost watch-chain. In evening made out, with May, the specifications in my Application for membership in the Penna Society of Sons of the Revolution. Went to bed late, and eyes tired.

Sat. 14th. My eyes hurt me, so I did not do much writing. Completed the Applications; wrote a few letters. Snow began to fall in afternoon, & it turned to rain & sleet. Went to a notary's office, to have the Application sworn, but the public-building was closed. In evening, practised with my flute & the piano, with Elizabeth. Then, told her how we held Christmas in the Equator in Africa, with the natives.

Sunday 15th. Ground covered with snow, to several inches.
At Westside church, with Mr. Malone.
Also, in evening, to Westside.

Monday 16th. At breakfast, came a letter from Miss Gummere,
inviting me to luncheon, West to Germantown. Went
to notary public, to have sworn my Application
for membership in Sons of Revolution. Noun train
to Trenton; Mr. Barnes of Westside on the train.
In Trenton, stopped at Hedges bank, & executed
daughter Mary's acct. To Miss Gummere, for
lunch. Sat on veranda; & walked ^{with her} down town, to
Mr. Harold's. Met Miss Roberson there.
Returned ^{with} Mrs. G. to her home. And, left, on
6.44 for Germanstown. Retired early.

Tuesday 17th. My watch-chain, for wh. I had searched every
bundle & package in every part of ~~the~~ my room,
& thought it lost or stolen, was found, by Mrs
Narciss, in my box of visiting-cards. But, I
do not believe that I had put it there. Went
into the city to Dr. Warden; to Warranthen; &
returned. Wrote letters. In afternoon, Rev. &
Mrs Lee called on Mr. & Mrs Malone & me.
Mrs Malone superintended, very finely, an excellent
supper. The parlor so cold, that I could not
sit there, & had to go to my room & sit by my
little kerosene stove.

Wed 18th. A raw chilly day, but not freezing. A letter from
Rev. J. R. Wight, about Starks. Wrote several

letters. And spent several hours in arranging my trunks, sending the summer one to the cellar, & bringing up the winter one. And opened the box of medicines I brought from Africa 2 years ago. Rev. & Mrs. Malone and Mrs. W. L. Nassau went out visiting in W. Phil^a. I went to Westside Prayer-meeting, in evening.

Thursday 19th Clear. Blue sky & white fleecy clouds; not cold. Went, with Mr. Malone, to visit League Island. Thought Mr. Lieut. Conder Harlow was still there, but he had been sent elsewhere: officers polite. Exercise grounds. Was shown through the "Indiana". Saw machines drilling and marching. At the Rush Library, seeking for old Nassau records. Lunched at a small but good restaurant on Sanson near 13th. Returned very tired. A Mr. Duncan, member of Westside Ch., called, in the evening.

Friday 20th. A spring-like day. Went to Wanamaker's, to have my new coat lengthened in the sleeves. Then to 1515: son Charles just leaving, to visit in the Adirondick. Returned, & wrote letters; & copied Nassau Family Genealogy. In evening, went, with Rev. & Mrs. Malone, to Univ. of Pa. Madolin & Glee Clubs Entertainment, at Germantown, Pa. C. & S.

Saturday 21st Frost last night. Clear and cold. Went into the city, to Dr. Ward's. To Wanamaker's, to try & find a letter-rack for May. Wrote letters. The evening cold; I cling to my little stove.

Sunday 22. A rare foggy day. At Whiteide church, both morning and evening.

Monday 23. After breakfast, on cars, to city, to Dr. Ward's; waited a while; as he did not appear, left. Bought some Florida persimmons, to take to Mrs. Greenman. Went to Witherspoon Building, to minister meeting, left, at 12. noon, to Board A, train to N. Phil^a. Ticket thence to Trenton, then, went, at once, & cashed the Annapolis check, & deposited \$150., from Board of Relief. To shoe-black. To restaurant. Saw Chief Justice Greenman there. On trolley, saw a man, whom I felt sure was Rev. S. M. Patterson. To Mrs. Greenman's; Walked, with her, to the Park, Returned, & sat in her home until 6.15. Left, and took train 6.44. to ~~Germanstown~~ ^{N. Phil^a}; and thence, by trolley to Germanstown. Got cakes for supper, at the ice-cream house. Tired with the day's travel.

Tuesday 24. Made no entry. Very foggy day. Went to be very much depressed about my position here.

Wed. 25. Warmer, but foggy. Went into city to Dr. Ward's. Thence, to Rush Library, and searched for Nassau records, for almost 2 hours; but could not find what I wanted. Then, to 1515 Wallace, for lunch. Katherine, and little Charles not well. Went to 1816 Grand ^{W.B.} Nassau Ave, to inquire whether any late cousin ^N

had left any records there; no one answered the bell; & I came away. At Germanstown, found a letter from Rev. Mr. Reigwin, of Florida, saying the Starks Presb. ch. was occupied for the winter. At Westside Prayer Meetings very dense fog.

Thursday 26. Another foggy day. To Westside Church; & Mr. Lee had me in the pulpit with beer. A late, but most abundant dinner; an enormous 23 lb turkey, & a large four-thigh-cured ham. In evening, kokonole, with young William, & a lagomachy with beer, & Mrs. Malone & son & William & his wife. Weather quite temperate, indeed, so warm, that I lay outside of my bed before I got under the covers.

Friday 27. Made no entry.

Sat. 28. Cold clear day. Went into the city to Dr. Warden. To Wananake's, and bought a dozen nut-picks. At Chelton St. again. Mrs. W. L. Mason very busy preparing an afternoon lunch, in honor of Mrs. Malone, and she notified Mr. Mason, Mr. Malone & me, that she wished us to be out of the house, from 4 P.M. to 6 P.M., as there were to be some 40 ladies invited, for her, I went on errand to Germanstown St. to buy nuts & candy. At 3 P.M., left the house, and went to the new wonderful Walnut st single-arch bridge; talked with the police man

there; climbed the hill; walked over the bridge, went to an adjacent football practice, came back by S. P. M. Went to Cheltenham Av Station, & sat there for an hour. Came to 424, as saw a carriage still there; went back to station, meeting also Mr. Madell, and Mr. Malone, and, finally came home; there were there still Mrs David ["Vellie"] Lee, & Miss Jones, & other Latta relatives. Had supper; retired early, being fatigued with my walking.

Subbath. 29.

Bright, cool day, went to the W. Coulter St African church, of Rev. Mr. Armstrong. He was away, & Rev. Dr. Wm. Endenan, ^(colored) preached in his place. Some of the audience so white, but they should have been ranked as white people. Did not feel well, & rested all afternoon. Went to Westside, in evening.

Monday. 30.

After breakfast, to Dr. Ward's; thence, to the Witherspoon Building, to ministers meeting; heard a sermon by Rev. Dr. J. Spachak Jones; met Rev. Messrs, Kruse, Turnbull Lee, Eccles, Newkirk, Landenburgh, Lottcher, W. P. Lee, Ragan, & others. With Mr. Malone, went to the Cafe Rutanent on Sanson & 13'. Then, went to Historical Library, and examined books on family history of "Todd" & "Hawill"; went down Arch, to try & find something on Mrs. L. Kearny; failed. Depressed at night.

(Dec. 1908)

Tue day! Spring-like morning, went up Chelton, to a barber-shop, was tired from yesterday, and fell asleep before dinner. After dinner, with Mr. Malone, into the city to Witherpoon building to see Rev. Dr. Fullerton, Moderator of Gen'l Assembly; ~~He~~ recognized me, having once heard me make a missionary Address (probably at St. Louis, in 1900). ~~Went~~ We made an appointment, for to-morrow, at 10. A.M. Went to City Hall, to Records of deeds, and looked up deed of property of my great-grandfather, ^{Nassau} then, to a stationery store, on Market St., to buy, for Mrs. W. L. Nassau, a letter-file. Market St. very crowded, especially at 13th St. Supper late. Went to West side, to an Entertainment of Music & Recitations. The evening cold & sleep, with moon half.

Wed 2^d. Went into the city, on Steamcars, with Mr. Malone, to 10. A.M. appointment at Witherpoon Building, for Rev. Dr. Fullerton, while waiting for him, we went into the Presb. Historical Library. Dr. Fullerton was otherwise engaged, & he made appointment for 2. P. M. Rev. Dr. Roberts gave us tickets to Academy of Music, for to night, at meeting of the Council of Churches of America. Mr. Malone went home. I went to Phil. High Socy, for lunch, to Childs, 12th & Market; Returned at 2. P. M.

To Witherspoon Building, to Dr. Fullerton, He was very attentive, & recommended for me a church in Mississippi. Returned to Chelten Av. West to see Mrs W. L. Nassau, with Mrs Malone, Mrs N. sick in bed, gave her the Letter-rack I had bought for her on Tuesday. At night, with Mr. & Mrs Malone, went to Academy of Music; my seat was in a balcony box, there in the Family Circle. Many Address of from 10 minutes to 20 & 25. The handsome arrangement of the choir of 1000 singers, in form of a cross. A great decouration by representatives of 18,000,000 Protestant Churches. Returned, on 10.51 train from Broad St.

Thursday 3.

Went into the city to Dr. Warder, To City Hall, & copied old deed of great-grand father Nassau's purchase of a house on Callowhill St.:- To the "North American" building, to see the price of Boyd, about entrance into the ^{at 4th Street} Market House. To the florists, & ordered roses for Trenton. To Wallace St, & lunched there, & came back to Chelten Av.:- In evening, to Westside Temple Meeting; & after the close of their business, told them some African Tales of Aesop. Returned home late.

Friday 4.

Went to Trenton; To the Trust Company bank, & examined my accounts to date, went to Princeton on trolley. Lunched at a restaurant. To Mrs Gosman's.

Thence to Prof. Libbey's. To R.R. station & Princeton Junction; train a half-hour late. Caught the Germantown train at N. Phil.; in Princeton, there had been weighed snow & hail & rain. At Chilton Av., landed at Hamilton; at home before 9. P. M.

Sat. 5th

After breakfast, went into city, by steam-car, to St. Warden's: Thence, to Historical Library, 1300 Locust. Thence, to Wawamakers, & paid the month's bill. Returned for lunch. Got Kaname, for my little stove. Wrote 4 letters. Cold day. Snow fell in the evening.

Sabbath 6th

A clear & cold. Went to Westside Church, on returning, I observed ~~two~~, before my right eye, were flashes of light and dark. So, I sat part of the afternoon with ~~my~~ eye bandaged. Miss Walker, who gave me the wild-violets to plant, 18 months ago, ("The Lady of the Violets") was at lunch & supper, to sing in Son William's choir, in the evening & did not go to church, at night, sat with my bandaged eye, & with Mrs Malone, & the 2 grandchildren played at remembering Scriptive names. Went to bed early.

Monday 7th

Rainy morning. The affection of my eyes continues. About 11.47. A.M., went to N. Phil. Station and thence to Trenton. To restaurant; to bank, & left a letter for cousin Hugh, in hands of Mr. Guerinore; to banker. Thence, to 908, West State St

M. for the 6.44 train to N. Phil., & thence to Chelton Av. Got a lunch at Hawvillors, and back to 4.24; & retired early.

Tuesday 8. Rose late. Clear cold day. My S. A. R., Application papers arrived, signed by Judge Beaver. Went into the city to Dr. Shoemaker, for my eyes (first went to Dr. Warden, and thence, on the way, stopped at the office of son Charles). To Warranburg, & bought a nice blank-note-book. Lunch at Childs, market above 12°; and back to German town. In evening, a game of logomachy was begun, but was interrupted in attention to other members of the household. My right eye still weak.

Wed. 9. Into the city, to Dr. Shoemaker; to Historical Society; to Childs Restaurant; to Lowly's drug-store; and back to Chelton Av. late. A cold windy day. In evening, with aid of Mrs. W. L. Vassar, completed the Application for entrance into the S. A. R.



Tuesday 15, Various jobs. At 12.33. P.M. on P.R.R. to N. Phila., & by 1.12 to Trenton, at 1.42. Lunch at the restaurant near the R.R. Station. An Old Fellows parade. To Miss Gummere by 2.45 P.M. Miss Robeson was there: she soon left, & the 2 other Miss Gummere went in a cab visiting and riding. During the afternoon, Mrs Stockton called. Miss Gummere and I walked to the park. I left at 6.55. But, there was no street car for 20 minutes. Took the 6.44 express: & took the 7.10, which made good connection at N. Phila. with the 8.02 for Germantown. Had brought with me the guitar I had given Miss Gummere 2 years ago. Lunch at Hamilton. Feeling more than usually well; my eyes better.

Wed. 16. May returned me part of the Wanamaker bill. Went by steamer into city to Dr. Shoemaker, & he snipped off the little polyp on my right upper eyelid. Monday 21: Bright & clear when the fog lifted. Into the city by rail; to the florist on 17th & engaged flowers: to Dr. Warden; back to the florist & got the flowers: - To witherpoon building by 11. A.M. Rev. Dr. Covertman asked me to open the Minutes Meeting with prayer. Address by Rev. Dr. Eccles. I was made corresponding member, & I spoke on Dr. Eccles Address. Rev. Dr. Fairbank, of the Address Committee, asked me to address on Jan'y 11th, but I will be in Eastern at that time. Rev. Dr. Laird of Frankford, & Rev. Dr. Burchfield of the North Park, ch., wish me for address. Rev. Dr. Gibbons told me of his performing the marriage ceremony for Mrs. Garrutt. Rev. Dr. Brown & others cordial. Hasted away by trolley, & caught the 1.12. P.M. train from N. Phil^a to Trenton. Friday 15. A letter from Barker Hannell, containing
deal about daughter's cranberry-bag, which
annoyed me, considering Mr. J. Foster's
statement ~~my~~ signature would ^{be} only a matter
of "courtesy" and not of right. In afternoon,
went to Westside Church, and for half-hour,
told the children of Mrs. Clark's class,
some of my African Animal Stories; a success.
The day had been with higher temperatures, but
by night, there was freezing again.

Hermantown (Jan'y 1909) Trenton, N.J.

Saturday 16th. After breakfast, early by steam car to Broad St. and Wanamaker's to get my gold-pen; but it was impossible to have it repaired. Thence, to 1515, and told Bessie about my visit to Easton. Out again to Chilton, & dressed for Trenton; to N. Phil? to 1.12 P.M. train. At Trenton; at restaurant: - to the bank, but it was closed for Sat'y. Went to 231, to see Barker Hamill about daughter's deed for the Cedar-bury log. ~~He~~ He was not in. Saw Mrs Hamill & Matilda, but not cousin Hugh. Walked with the deed down street to seek a Notary Public. Found Justice of the Peace Solan; & he had one sign it. Caught a street car to 231, & left the deed then for Barker. Went on out W. State at a long way, & was overtaken by a car, to 908. Was an hour late. Spent the afternoon & tea with Miss Greenware. And, after supper, left immediately. Caught street car at 7.50 P.M.; at the Station by 8.15; train at 8.27 for N. Phil: by 9. P.M. Then Hermantown train at 9.09 P.M. At Chilton Station made arrangements for my Battle Creek ticket for Monday morning. At the house, William kindly waiting for me, near 10. P.M. Putting things away, & reading letters. To bed by 11. P.M. A very cold day. While in Trenton, a heavy snow-storm had come up.

Germanstown

(Jan'y 1909) Battle Creek, 39

Sunday 17, very cold last night, but moderated this morning, & melting. By chuds time, a slight rain falling. But, when we came from chud, a cold wind was up, & the snow was freezing. I did not go out at night.

Monday 18. Rose early. After breakfast, left at 7.46, & just caught the train with son William. On the train at Broad St, started at 8.25. For 3 hours, a splendid showing of the frozen snow & ice on trees, bushes, fences & grass. Did not know there would be a driving-car after leaving Harrisburg; so, bought sandwich & other things. Became sleepy, through the rivers, valleys, & the mountains. At Buffalo by 7.45, the incomplete Station. Left on 8.25 train. Train very warm. The Michigan family that alighted at Jackson; the father's ignorance.

Tuesday 19

By 4.40 A.M. at Battle Creek; I the only one to take a cab. Received at the Sanitarium. Supposed to see my name on the program, as a Vice-Pres. & for 2 speeches to-day. Went to bed, but did not sleep much. At breakfast by 8. A. M., Mrs. Dow Koontz & Bfr. Thoburn. After breakfast, Dr. Tenney ^{came} to me, to show me the way to a bath, Electro, & massage. Then sat in my room; rested; & prepared response to Address of Welcome.

Wednesday 20

A good sleep last night. Wrote letter to cousin ^{my} Sweeney, of Detroit. In the parlor, an

 meetings with other missionaries of Africa: Mrs. Chubb,
 Mrs. Dye, Mrs. Woodside; of China, Mr. Courtney &
 Wilson, & Dr. Hartwell, & Miss Smith, of Persia
 Mrs. Miller, of India, Bp. Thoburn, & Kenyon,
 Friends of Siam, & others.

Thursday 21. Meetings all day. Dr. Kellogg arranged the afternoon
 Exercise, so as to give me $3/4$, from 6.45 to 7.30
 to tell my Animal Stories in the Parlor. It was
 filled; I told 4 stories, & the audience was
 delighted. Farewell Service, from 7.30 to 9.30.
 Mrs. Hedrickson, a German, of the Kongs announced
 & interested the audience.

Friday 22. Up early. Hasty breakfast. Met Miss Benson.
 At 8. A.M. with Dr. Darkouth, to the College
 Lecture room, to meet 30 young students, & spoke
 to them on a "Call for Foreign Service". Came
 back, & gathered my things for the journey. Went to
 Dr. Darkouth's office, to say good bye, & sign the
 Letters of Resolutions. Went with Mrs. Darkouth
 to their house, & took a slight lunch: & she had
 the Sanitarium put up a lunch box for my
 journey. Left in cab, at 12.30. P.M., for the

12.49 train on Mich. Central. A rainy day. On the train, shortly after starting, a costly financial experience. Dismal view out in the rain. Enjoyed the lunch box. At Buffalo, by 10.30. And, immediately ticketed on P.T.R. for Phil^o. Cars warm, but I became very tired. A mother & her 2 little children. Delayed by a slight accident to the car, near Reno. train 1 1/2 hours behind time.

Sat'y 23^d. By daylight, running cautiously through a fog. No stop between Harrisburg & Phil^o. Last an hour near W. Phil^o, by the congestion of trains. At Broad St Station, a long wait for a German by train. At Schellen by 12. P.M. Tried a Lungy. Telling of my journey. Back, rainy after noon. Putting things away; reading letters that had accumulated while I was away.

Sunday, 24th. Temperature very much moderated. At Westside church, in morning. Read in the afternoon. Did not go out in evening.

Monday, 25th } Left about 12.30. P.M. for Trenton; there by
Tuesday, 26th } 1.45. P.M. At Rahambr.; at Hotel "Sterling"; at
banker's shop. At 3. P.M. found the bank's doors closed. Was disappointed. Delayed, waiting for a street car. Was late on reaching 908. W. State. Miss Gummere was disappointed at my lateness.

Trenton, N.J. (Jan'y 1909)

We started for a walk by the bank, but the path was too muddy. Returned to the "Sterling", & got supper at Hildebolt's restaurant.

On the 26th, Breakfast at the hotel cafe; went to bank; inquiries with Mr. Chacabertⁱⁿ about the legality of my right in the ^{of Mary} Esenbury bag, & the legal meaning of the word "curtesy", not the usual word "courtesy". Found Mr. Barker, Havill had not received the deed I had signed Sat'y a week ago! Hasted to 231 W. State St., & found Mr. Howard Hunter, to whom I had handed the deed, had not given it to Barker Havill; it had been lying in one of Cousin Hugh Havill's drawers. Came back, & delivered it to Mr. Barker H. Got \$50., on acct. Went to St. Church, to Pringle just in time to answer to my name on roll call.

Discussion about admitting as a candidate, a very recent convert from Romanism. At noon, went to 231 for lunch. Returned to Pringle, discussion about validity of ordination of a certain young man candidate. Left at 3.30 P.M.; went to Miss Gumm's. Sat with her on the veranda in the cool clear air & high sunshin. For supper, went with her to the "Sterling"; then to 231. Mr. Bedford, & Mr. Ridgway also there. Escorted Miss G. to her home, & returned to the "Sterling".

Greenmount. (Jan'y 1709)

Wed. 27. Breakfast at 8. A.M. at the "Sterling"; and, on the train for Phil^a at 9.05. A.M. At Cheltenham in due time. Letters awaiting me. In evening, left at 6.45., on trolley, & was at the North Park. ch. corner of Broad & Allegheny, 1/2 hour in advance to make a 15 minute address. Back again by 10.30. P.M. A good bunch had been saved for me by Mrs. Nassau. Had been accompanied, at the meeting, by the 6 other speakers, all over-seeing their time.

Thursday 28. A very cold day. Did not go out all day, except to buy Kerosene for my little stove, and to mail some packages & letters. Before supper, practiced on my guitar. Before supper, a Mr. Carlisle was present. Spent the evening in my room, near the stove.

Friday 29. A dark, chilly morning. Snow began about noon. Writing letters. In afternoon, went by trolley, & at 1515 gave Bessie a copy of the photograph of Nassau-Nassau's Cost of Amos. On to the Witherspoon Building, and, in the office of Rev. Dr. Roberts, looked up some names in the roll of Lutheran Park. ch., of 2 of our Seminary classmates. Then to room of B. of Education, & consulted with Mr. Wilson, about health of Rev. Dr. R. M. Patterson; also consulted with Rev. Dr. Hunter. Rainy weather. Back to Cheltenham. After supper, to Westside, African Stereoscopic Views.

Saturday 30th. A very cold day. Went to drug-store, to buy envelopes. Walking slippery. Preparing items for addresses soon to be made. In the afternoon, looking through my trunks for outlines of some missionary addresses. Very much disappointed as no one told me the hour for William's Organ Recital was afternoon and not evening; felt very much hurt. But son William eased it somewhat when he came home. Mr. Malone not very well. Wind high, & cold deeper.

Sunday 31st. Bright cold day. At Westside in morning. In afternoon, made address at N. Broad; & success. In evening at Westside, a sermon on the Church of the Waldenses by Rev. V. Alberto Costabel, former Pastor of the earthquake destroyed city of Messina.

Monday 1st. Very cold weather, but I had to go out just after breakfast, for Kerosene. Writing letters; and after lunch went out to post them. Also went to a tailor's, to inquire about lining of my over-coat to be repaired; & came back to the house to get the over-coat. In evening, a small game of logomachy. Unusually cold weather.

Tuesday 2nd. Weather still cold, and clear. Went into the city to the Baptist Pub. House, to inquire about the addresses of 2 men, many and

Wednesday 3rd. I had taken calomel last night, and was

 Snow falling all day. Did not feel able
 to go out to Prayer-meeting in the evening.

Thursday 4th. Slept poorly last night: feared I was about

Friday 5: Somewhat better, but still heavy in my head, continuing with quinine. A package from Stark Florida, from Mr. Hull. Did nothing all day, but read, wrote a letter or two, and rested. The weather much warmer.

Saturday 6: Rain last night; snow all gone. Bright sun. Went into city to Dr. Warden; he encouraged me, but my joints are very stiff & heavy. Wrote a few letters; but did very little all day. Rested, and took medicine.

Sabbath 7: A variable day as to weather. My joints felt so stiff, and my head uncomfortable; so I do not go to church, nor out of the house the whole day. I could not fulfill my appointment for Camden for Mr. Malone. At supper were 2 ladies, of distant Latin connection. In afternoon, weather colder, & some snow.

Monday 8: Bright clear day, with a keen melting the snow of last night. Went to tailor to get my thick coat, that should have been finished last Friday. Into the city by railway, to Dr. Warden; felt better. To Wanamaker, & chose a vest, but left it to be altered. To 1515 Wallace, & gave Bessie the little set of rhymes I made about my foot, toe (carmen de meis pedibus) when I was 12 years of age; also, for Charles, the \$25. pocket musical card Uncle Samuel ^{Hamill} gave me as a

wedding-present in 1881. Returning, on the trolley at Wayne Junction, a lady came in the car, a few seats from me, & saluted me, but I can not remember who she was. Called at the tailor's, to get the coat I exchanged in the morning. A letter from Batanga; from Mrs. Adams, & Kikiie, Balaka & Mr. Powell.

Tuesday 9th. Feel almost well. Weather moderated. Wrote long letter to Batanga. An invitation to go to Atlantic City on Thursday, for the day. Took my fall & spring over-coat to the tailor, to have the lining repaired. Practised some on my guitar, which I have not done, for a long time.

Wednesday 10th. An exceedingly variable day, with varieties of weather, rain & shine, warm & cold. Went to Dr. Warden's; then to Warrant Keis, & got my new vest, & came back by trolley. Somehow, I forgot my umbrella. In afternoon, went to Dr. Warden's & Warrant's to look for the umbrella, but could not find it. Bought a new one. In evening, at Westside prayer-meeting, engaged to speak next Tuesday night to Mrs. Ribb's class of young ladies.

Thursday 11th

Sat'y 13th
Sunday 14th } Left for Atlantic City, & arrived there at 11. A.M. In the omnibus for the "Seaside Home", was Mrs. Styker, wife of Dr. Styker of W. Phil^{la}, and Aunt

of Mrs Hugh Hamill. At the "Seaside", were met by Mrs Hamill & Miss L... Gummere. In the afternoon, with Miss G., Mr. & Mrs H. & Matilde, & Mrs Steyer, at the Pier, for the Italian Varella Band music. Mrs Steyer left, & returned to Phil^a. ^{In the evening,} ~~at the~~ talk Mr. H. & the 3 ladies some of my African Animal Folk-lore Tales. A delightful day!

On Friday, Presented Miss G. with a St. Valentine's original Poem. Took her out on the Boardwalk in a chair. Chace days, in strong cold wind. In afternoon, at the music, Mr. & Mrs Hamill; Miss G. & myself; and Matilde and Mr. Huey. Sat with Miss G. in the evening in the parlor, until she needed to go to her room to pack her trunk.

On Sat'y, With Mrs Gummere, left on the 10. A. M. train for N. Phil^a; changed cars for Trenton; obtained a cab for Miss G. to go to her home; and, in less than 1/2 hour, I passed on to New York. To the "Continental", corner of Broadway & 20th. Went out to a restaurant; returned, and dressed in my best clothes; on the subway, went to call on daughter, at the "Bryer Mawr" Restaurant House, corner 121st St & Amsterdam Ave.

Davis; Dr. Styker, a Mr. Hoar, a Mr. Duryea; And, at the table, was called on to pay grace. Sat by Mrs. Henry Green of Trenton, Speckers, Col. Saturday 20th } Cold windy day. Left at 9.37. A.M.; at N. Phil?
 Sunday 21st } 9.45; left N. Phil? at 10.02. Many people
 Monday 22nd } going to Atlantic City. At Trenton, 10.32.
 Left my suit-case at Parcel-room. Felt uncomfortable in my bowels from operation of medicine of yesterday. To the bank; saw Backus, Hamill & Miss Lukens, & got \$25. Went on to Mrs. Guzman's by 11.30. With her, rode back into the city to Mr. Hamill's; no one at home. Excorted her back to 908; & I rode again into city to Hildebrandt's restaurant, for dinner. Went over to the "Starling"; & returned to 908; & with Mrs. G. walked into the Park, & sat under the rest-house sheltered from the wind. Returned with her to 908; & left in time for 5.23. P.M. train to Bristol. Met by Rev. Dr. Burns, & taken to his home. Mrs. Burns, We all, by invitation went to tea at Mrs. Chichton's (pronounced Cuyler). Her brother W. C. After tea, some dozen ladies & gentlemen came in, by previous invitation, & I told them some of my African Animal Tales. Dr. & Mrs. King, Mrs. Ardey, her daughter & daughter-in-law, & Mrs. Ardey her son, Mrs. Fredick^(Fredrick?) of Manassas, Va., & others. They were very much interested; & Dr. Burns

had to insist that it was time to leave. It was well; for I was very tired. Slept very soundly.

On the 21st up by 7. A.M. & dined for 7.30. A.M. breakfast. Was glad I was not to speak in the morning, for I was still tired. Sat in the church pew. A son, young Mr. Burns, had come on from Brooklyn. After church, was taken to dinner by Mrs. Landreth, whose maiden name was Phillips, & whose sister had been a pupil of sister Belle at Lawrenceville. Mrs & Capt. L. their 3 sons, a daughter, & daughter-in-law, & 2 grandchildren. They kept me very busy talking Africa; & I told my elephant story. took trolley to Chelten. Found letters. Wrote letter to Dream Day, 3156 Fifth Ave, Union House, sending a box of gifts to native friends at Batanga, W. Africa, through Mr. Adams. Took the box to Germanstown Ave. to express-office, & mailed the letter. Back to 424, met May & William and their Elizabeth going down into the city for the afternoon Fairy S. P. Reception. Made up my bundle of soiled clothing for laundry, & other jobs. Went to tailor's to pay bill for repairing coat; the bill was exorbitant, \$4.50. Wrote a few letters; & wrote up this diary. At 4 P.M., with Mrs Malone went to 1300 Locust at the Historical Rooms, to a Reception of Sons of the Revolution; met my cousin Genl Davis, Dr. Jordan, Mr. Weaver, Rev. Dr. McCurdy; Mr. Cadwalader, Mrs Woods, & other ladies. I escorted Elizabeth Nassau. Came back to a late supper.

Tuesday, 23rd. A rainy day; drizzling in the morning, and becoming heavier later in the day. With aid of Mr. Maree, brought 2 of my trunks from the cellar, and packed into them all the articles of mine in my room. Cousin C. W. Nassau, wrote asking a loan of two dollars. I sent it, but, I could spare it with difficulty. Busy all day with the packing. Late in afternoon, went out to engage a cab, for tomorrow morning to Wayne Station of the Reading Railroad.

Wednesday 24th. Rain ceased early this morning, but a very heavy fog. Rose at 6.30. A.M., & completed everything ready for breakfast at 7.30. At 8.15, was anxious about the non-arrival of my promised cab. Went to the Station, & found the driver just arrived. He came to the house, I got in with my two suit-cases, & late, started. Horse was slow & sick. Fare 50 cts, only 5 minutes to spare. Rain began again. A foggy ride. On a through car. At on the train. At Wyckwocung, on time, 2.35 P.M. Mr. Cook was not there; but soon arrived. His horse lame. The new state-made road to Crompton, met Mr. Kennedy on the way. At Mr. Cook's, 3 of his daughters, Miss Alice, Francis, & Anna. The change in the public school arrangements, the state bringing the children in a large wagon to the one large school at Crompton. Weather turned very cold at night.

Thursday 25th. Wind very strong last night. Arranging, in the morning, my topics of address for the seven or 8 lectures to Mr. Cook arranged for me here, & at 2 adjacent places, within the next 10 days. Dozed some in the afternoon. Miss Elliott came, in the late afternoon; & with Miss Cook, we drove to the Crompton church. Very cold weather. The 2 younger daughters, Francis & Anna were

Miss Kennedy (the young pastor's) was one of those waiting on the tables. After supper, sat in the ante-room & talked with some ladies & gentlemen, & played "tag" with 2 little girls & a boy. Then I went up into the church-room, and restit & went over my thoughts for the evening. At 7.30. meeting began. Mr. Cook's mistake in announcing that I had African curios to exhibit, & that I would tell them African Folk Lore Tales. I had to check his sleeve, & had him rectify the statement; for, I spoke on "Mission Schools". I cold ride home.

Friday 26th. At night, a boating wind. Very cold in the morning. Immediately after breakfast, with Mr. Cook & Anne, & Miss Kennedy, & her young cousin, rode to Wyalusing. Ruffed exceedingly with cold in my arms & hands. Tickets to Towards. The travelling ticket agent. At Towards, felt very tired. Rested in the court house. Drove at hotel. met Dr. Rockwell of Marquette. After dinner, called at home of Rev. Dr. Stewart. Then, to the Open House, where a county School Spelling Contest was to be held. But, so many were

Maryall, Pa. (Feb'y 1909)

The applicants ~~at~~ time passed while they were being tested & eliminated, ~~at~~ we had to leave for the train of 4. P.M. before the contest began. Back by train to Wycharing, & with the horse & carriage to Maryall. Went to bed by 9. P.M. The cold had abated.

Saturday 27th. The weather moderated last night, & my room's air was not ~~so~~ as cold as other days, in dressing. Later in the day, there was a drizzling rain. In the evening, after supper, went with Mr. Cook to call on the Elliott family, and also on the Kennedy family. A cold wind at night.

Sabbath 28th. Snow fell at night: but, during the day, it melted under the sun. At 9, A.M., rode with Mr. Cook the 5 or 6 miles to the Herrick church, & preached. The church is small, & only 31 people present. Was introduced to them all. Had met most of them 2 years ago; I remembered having met Miss Eiskine. The ride there was in face of the wind all the way; but, I was well covered with rugs & gloves & fur to cap, & hot stone at my feet. Returned for dinner. At 3. P.M., went with the family to Exmpton church, & preached to some 90 people: & returned home: no evening service. Retired early; the wind had again become cold.

Merryall, Pa. (March 1909) Stevensville

Monday 1: A bright morning; but the sky soon became threatening. I felt exhausted from the Saurien and riding of yesterday, and stayed in doors all day; read & dozed. In the morning, Miss Cook rode to Wyalusing, to meet a Miss Smith, a Mt. Holyoke classmate, coming as a visitor. Perfected plans with Mr. Cook about details for my address, tomorrow at Stevensville, & Rushville for Rev. Mr. Wilkes; & for the return to Lime Hill on Wednesday.

Tuesday 2: } The morning was threatening either snow or
Wednesday 3: } rain. But, by 10 A.M., the sun shone warmly. Rev. Mr. Wilkes, of Stevensville, came in his buggy for the 6 mile ride to his home. Dinner with him; Mrs. Wilkes, & the 4 children, William, Harriet, Robert, & the baby. Mrs. W. is brother of the lady from Bath, N.Y., whom I met at Camptown, 2 years ago. After dinner, rode 4 miles to Rushville, to the pretty little church with its memorial window to a former pastor, Rev. Mr. Thomas, whose grave stone was in the yard, given by his daughter, the wealthy Mrs. Welles of France. A good service of 45 minutes, to a small but interested audience of 25 people. Then, returned to Stevensville; & at 7.30, in the church, an address of 1 hour, to about 50 people. The weather had been comfortable. Beautiful moonlight.

Campton (March 1909) Merrill

After a comfortable night in Mr. Wilkes' house, he drove me, on Wed. A.M., to Campton, by 11. o'clk, where, by appointment, I was met by Mr Cook, Mrs Cook, & Miss Smith, & he drove me to Leve Hill, for dinner, at Mr Fish; where, in afternoon, the Ladies' meeting was held; & for an hour, I talked on Africa. Had been very cold on the long 6 miles ride to Mr Fish; & was tired with constant talking.

On invitation of Mr. Howard, at whose home, I had been for the Ladies' meeting 2 years ago, we drove to his house for supper. His wife & sister-in-law, Mrs Howard, were away in Florida. I was very tired; my teeth plate had made my upper gums sore, & I was anxious to get to the quiet of Mr Cook's; so, we declined the invitation to stay all night. Was very carefully wrapped in the carriage; but, suffered very much by being having no place where to rely to a cell of Nature. Was much relieved on arrival at Mr Cook's, to bed by 10.30. o'clk.

Thursday 4th. Slept very well. On awaking, saw the ground covered with snow, & a severe storm in progress. At breakfast, a young son of Mr. Howard. The children

went to school in the Kennedy carriage. I stayed in the house all day, reading much of the time, as the storm continued all day with snow and wind, so that the appointment for the evening service at Compton church had to be called off.

Friday 5th. Cold weather continued. In morning, Miss Elizabeth Elliott came in a small carriage, and crowded in the 2 ladies, Miss Cook & Miss Smith, and took them to a Ladies meeting at Wyalusing. In afternoon, Mr. Cook took me to Compton School, & Prof. Woolson had me make an address to the pupils. Then, Mr. Cook took me to the home of a young man Smith, whose limbs had been paralyzed; & I talked with him about Africa. He had read a number of books of African travelers. Then, about 5 P. M., Mr. Cook took me to Mrs. Jones home, where I stayed for supper, & he went back to Merryall to his supper, & to bring his family, for my evening African & Animal stories. They came about 7.30. Went to the side rooms of the church, & I talked some half dozen stories, for half hour. Came back late; & the family all in a merry humor. The night very cold.

Saturday 6th: This morning, the coldest since I came here. Weather very clear & cold. Miss Cook took my photograph after breakfast, with her Kodak.

Preparing to depart. Rev. Mr. Wilkes came at dinner; also Miss Elizabeth Elliott. After dinner, at Miss Elliott's request, I told the "Princess Corilla". Then, good-bye; and Mr. Wilkes drove me to Wyalusing, to home of Rev. H. C. Sitches; with whom I went to the C. E. Rally at his church, & addressed for 20 minutes. Was very well received. Met Miss Adams & her sister Miss Thomas. Did not attend the evening Service. Found ~~Mr.~~ Mr. & Mrs. Sitches knew Mr. & Mrs. Reading (family of Africa). Fine moonlight night.

Sunday 7th. Had a very fine sleep last night. Ate only a slight breakfast, having a dull head. Putty little Cornelia Sitches. Preached in the morning. Member of the Lewis family. Miss Smith, formerly a school-mate of daughter at Blainstown. Remained to Sat. Sch. Headache; ate very little dinner. Slight snow in morning; but cold bright afternoon. Rested by myself during afternoon. In evening, at church, a union Service; the Melts. Pastor, Rev. Mr. Barker, present; also a large audience. Spoke for 1 hour. After meeting, a Mrs. Harris, who had been a Miss Lantz (?) at Monroeton, & knew daughter, came to introduce herself. A very interested audience. At Mr. Sitches's, delightful acquaintance,

as he had been a Theol. Society classmate of nephew Walter Lounie. Told him & Mrs S. about African Ants, White & "Driver". Retired late.

Monday 8th, Rose early. Breakfast by 7. A. M. Hack came at 7.30. Mr. Smithe & little Connelley, rode with me to the station. A Mrs Horton & her daughter, of W. Phil^a. Chatted on the way. Waiting more than an hour for change of cars at Wilkubane. My gums sore, from my plate of artificial tooth; could not eat anything hard. At Phil^a, at Wayne Junction, took street car, & went with my 2 suit-cases, directly to 1515 Wallace; left them there, & at once returned to Chelton Ave, to give order for my trunk for to-morrow. At 4.24, found letters; stayed to supper. Mrs W. L. Nassau was not at home. In evening, left 4.24, finally, for my new quarters at Wallace. Welcomed there by son Charles & his wife, in his very comfortable home.

Tuesday 9th. A rainy day. Stayed in doors all morning, making memoranda, gathering up odds & ends, & waiting for my trunk to come. They came before noon. In afternoon, went to the Witherspoon Building, to look up the addresses of some former members of the Princeton Theol. Society class of 1859. Then, to Wanamaker, & paid my bill for Feb'y 09

and bought socks, and made a purchase at the Broad St Station drug store. Enjoyed my sitting at son Charles table. The day was misty & dripping rain. An accident at the building, across the street, a man fell from the scaffolding, & hurt his back.

On the 13th, went to Trenton, and directly to West State St, to Miss Gummow, and stayed to lunch. And then, on trolley, to Princeton. On way to 175, was met by a gentleman, who said he was Mr. Dalton? missing to the Philippines, who stopped me to say he wanted the honor of my acquaintance. Welcomed by the Gummow niece.

On the 14th. To church, with Miss Belle, Rev. Mr. Beach with a very good sermon. Mr. Mr. Howel, Miss Howel, & Mrs. Jean? Howell. Mrs. Beach to lunch at the Gummow table. In afternoon, Miss Lettie - I went to see cousin Sam Wood, who was sick. Matilda Wood's growing deafness. Again to church in evening. Met Miss Buffield, a nice young niece from New York, and Miss Wilbur.

On the 15th, good by; the niece went first to their libraries. By 9.30. A.M., I was at the study of Mr Beach in the church. And by 10.15, at the Little home. Prof. & Mrs. Tibbey were going out. Read in the library for a while; and, by 11.20, was at the trolley. And by 12. noon, in Trenton. To the Photo. black; to Carrie Haglis. Met Mrs. & Mrs. Cook. Stayed to lunch. 2 Elders, Messrs Keiner & Hallman, called to see me; & I was shown deeds of the church property signed by my grand-father Robert Havill.

On Sabbath, a bright & not very cold day. Preached in morning; the ch. organization my father supplied in 1832-'33. Very attentive audience, & many came to see afterward to salute me. In afternoon, walked in the cemetery, & saw the graves of 5 generations of my Godd ancestors. With Mr. Wagner, rode to Eagleville, & there, on the Germantown pike through Fairview, to the old Harrison church. Views all around the county for 20 miles distant. Thursday 25. Weather variable, with rain & some snow. Wrote letters in morning. In afternoon, made first draft of account of my visit at the Providence church. Felt tired & sleepy, & rested, when the daylight weakened by the clouds.

Smith at dinner. In afternoon, went to the
shop to get my camp-chair; very poorly repaired.
At supper, another Miss Berg present. Felt
sleepy, & retired early.

Thurs. 10th. Another rainy day. Went out to a hardware
store, to buy brass-tacks to complete the unsatisfactory
repair of my camp-chair. Also, went to Chelton
Ave, with some more of our belongings, to place
them in the reserve trunk. Fogonachy in evening.

Friday 11th. Weather cleared off. Afternoon warm. At lunch, Mrs Emily Green from Wayne was present, & Mrs Margaret Fox. And later, Mrs Berg left, to go to Wayne. And later, 2 teachers from the school, where the 2 little girls attend, made a call. I went into the city to get a blank-book at Wanamans, & to get my felt hat, which was to be cleaned. Bright star-light night.
