About three months ago we had a family with three kids that used the showers and were very appreciative to have the opportunity to shower since they hadn't showered in four day's. However, about 90% of the people who use the showers are the same prostitutes and dope fiends that are harassing, robbing and threatening our patrons and staff. In my observation the crime rate has gone up since the shower's have been here and as I am writing this the same 13 RV's have not moved since we did the walk through on April 4th.

In brainstorming for solutions, we discussed foot beats in the park to address drinking in public and narcotics. Park Rangers, LAPD, HOPE, and Security Services are going to form a task force for after hours. We also brought up possible problems with mobile showers.

#### Summary

- Problem RV's on Valley side of park

- · Foot beats in park to address drinking in public and narcotics





- Activate towing of vehicles left on private property (pending Th 3/7)
- Install No Trespassing Signs and Fencing (pending Th 3/7 & F 3/8)

CD1 and Sgt Arellano at LAPD Northeast have discussed this schedule shared by new property owners/ development group. Sgt Arellano is evaluating resources to help and will know more later this morning.

CD1 needs LAPD support to clear the encampments and vehicle dwellers at site that may not voluntarily leave upon receiving notices from property owner today.





For the past three weeks - we've had a group of rowdy homeless People take up camp on the east bank / underneath

the DWP utility tower.

As you can see in photographs taken tonight- the camp now stretches from Gatewood (east) to Meadowvale (west) in Elysian Valley- 1/4 of a mile of tents with people and dogs living along the top of the wall of the flood control district's service road - levy.


On the West Bank of the river we have a bike path and residents and homes. On your side you have people camping in your right of way. But it's industrial, not open to the public and has Metrolink.

Please follow protocol - for homeless people living in the channel- move them out. I understand 48 hours after giving notice you can move them out. Please relocate them to a safe place to camp. They urinate and deficate in the river. They bathe in the river and recently the MRCA has even opened up a water station at Oros. My neighbors say they've seen a naked woman bathing there. She's sick- 30 yr old - head shaven -swore at me for 5 min- when I told her it was not safe to sleep in the river during the storm.



Thank you for sharing this information as we have some families that will benefit from this community resource. I am also reaching out to you for your support regarding the bridge that faces Loreto's lower yard near Cypress Avenue. In the last couple of weeks, we have had an increase of homeless encampments under the bridge visible on our yard. In addition, shopping carts with personal belongings from transient are blocking access to families who use the bridge to get to school on a daily basis. These photos were all taken this week and not more than a 5 block radius from my home.




I am grateful for all that you have accomplished so far, but there is much more to be done.

I will report to DOT 2 RVs on Artesian facing Ave 33 for investigation of not moving 72 hrs.


