

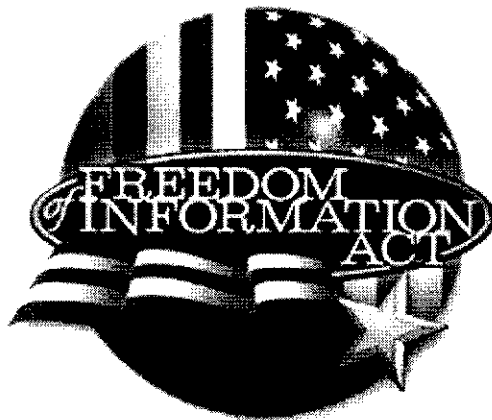

A confidential source, who has furnished reliable information in the past, advised on April 15, 1965, that Harry Wachtel and Bayard Rustin were in contact on that date. Wachtel inquired if Rustin would be able to make the appointment at 1:00 p.m., on April 16, 1965, at his (Wachtel's) office. Rustin said he would be able to appear as planned. X(u)

The source advised on April 15, 1965, that Bayard Rustin, Executive Director of the Southern Christian Leadership Conference (SCLC), was in contact with Harry Wachtel on that date. According to the source, they discussed a "proposed conference with Government officials." In that regard, Rustin said he and Harry Wachtel were concerned. He said the conference would be planned on a tentative basis only, so that they could get out of it if things looked badly. Furthermore, Rustin said, they should insure that King was not placed in a position where he could be criticized for leaving a conference of Government officials without getting anything. X(u)

Young J. King was concerned about getting out of this thing. (the Alabama boycott). Blackwell (Ralph Blackwell), Young said, felt that no pressure had been applied to the boycott, but that it was about ready to commence. X(u)

Young commented that if the conference (proposed
conference with Government officials) was put off until
September in May, they could let things take their natural
course, and then return to Alabama on Monday (April 19,
1965), thus focusing attention on the problem and bringing
about greater understanding of the boycott". Rustin replied
that he hoped that was the case, but thought King wanted
to get rid of "this thing" (the boycott) at any cost. X (u)

Young and Rustin concluded their contact on a
note that they would discuss these matters when they met
on Friday, April 16, 1965. X (u)

On April 16, 1965, the source said Andy (Andrew
Young) and Rustin were in contact on that date. Young said
the meeting which he was supposed to have attended on
April 15, 1965, in Washington, did not materialize because
he missed his plane. He said another meeting was scheduled
for 1:00 p.m., on April 19, 1965, in Washington. Young said
he would meet with Collins (Le Roy Collins, Director of the
Community Relations Service) and other Department of Commerce
officials. The meeting, Young said, would be devoted to
matters relating to the Alabama boycott and other matters
relating to the SCLC. X (u)

Rustin, at Young's request, agreed to accompany
him to Washington to attend the meeting. [REDACTED]

The first source mentioned heretofore, advised on

contact on that date. Wachtel informed Rustin that he
was going to a sort of "Black Bar Association Talk," and
asked him to check on any possible advance he did not

about the meeting with Leroy Collins and others).

In "The Evening Evening Post", issue of July 11-12, 1957, page 10, Bayard Rustin is the subject of a feature article captioned, "The Lone Wolf of Civil Rights". In it, Rustin is said to have come to New York in 1950, as an organizer for the Young Communist League (YCL), and as such, he had the job of recruiting students for the YCL. Furthermore, the article reports that Rustin, who first came to New York, Rustin gave some of his earnings to the YCL. He reportedly left the "Party" in 1941, the article states.

Reference is made to a recent purchase of a copy of "The Evening Post" in 1957.

The "Daily Worker", February 11, 1957, page 1 column 2, reported that Bayard Rustin, Executive Secretary, NAACP, was an observer at the 1957 National Convention of the Communist Party, United States of America (CP, USA), held in New York City, on January 9-12, 1957.

The "Daily Worker" was an Open Source Communist publication until it ceased publication on January 13, 1958.

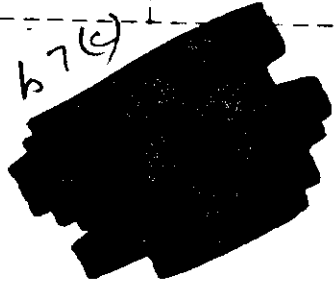

He stated this rally is only in the planning stage at this time and the speakers have not yet been determined. This memorandum recommends a letter to all offices advising of our policy relative to the receipt of information concerning threats against Martin Luther King, Jr.

b7(c)

As you are aware, the Bureau has received a number of complaints concerning threats against King. The volume of these complaints has been steadily increasing as King's activities in the controversial civil rights field are increasing and attracting publicity. Whenever we receive such complaints, we have been advising the Atlanta, Georgia, Police Department which covers King's permanent residence. We have also advised the local authorities where the threat is to be carried out when we know of such locale. We have not been advising King.

Because our above-stated policy relative to threats against King is not generally known throughout the field, it has been necessary many times to prepare teletypes, airtels, and occasionally make telephone calls in order to implement Bureau instructions promptly. A letter to all offices advising of our policy and action to take will result in a definite savings in communications costs as well as time and effort of personnel. It will also prompt more timely action.

This Division does not believe that we should in any way change our policy. It is to be noted that we are not in any way responsible for guarding King, and if we lower the bars to the point where we are advising him or his associates, the next thing that will be required of us is that

we follow-up and provide physical protection. The Bureau should never be put into this humiliating position. It is to be further noted that by memorandum from R. J. Baumgardner to W.C. Sullivan 10-22-64 concerning threats against King we stated our intention to follow the policy of not advising King and the Director approved. We definitely believe that this policy should remain unchanged.

In addition, some of the threats against King are of a nature indicating a possible violation of the Distortion Statutes. These must be handled according to Bureau instructions relating to emotion matter. The field should be reminded of this.



A source who has provided reliable information in the past on April 16, 1965, advised that considerable resentment has arisen among businessmen in Boston concerning the information that Dr. Martin Luther King would lead a march on Boston, Friday, April 23, 1965, against conditions of racial imbalance in this city. This resentment has arisen to a point that it is felt that such a parade is not being conducted in good faith.

The source said that it was felt that in Boston many responsible people who had wished to help and had pledged contributions and money are now withdrawing their pledges because of the scheduled march.

One of the strong movers behind King is Malcolm Peabody, brother of former Governor of Massachusetts, Endicott Peabody. Source also advised that he had learned that Roy Wilkins head of the NAACP and James Farmer, Head of Congress of Racial Equality, had expressed dissatisfaction in that Martin Luther King would be taking funds collected in Boston out of the city.

According to source Wilkins and Farmer felt that their organizations had started the activity against racial imbalance in the Boston schools, and believed that any money collected should be retained in Massachusetts to help out the Negro situation and should not be given to King for use of the Southern Christian Leaders Conference.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

[REDACTED], advised that on March 24, 1965, a Mrs. Phyllis Ryan who identified herself as a representative of the Massachusetts Unit of the Southern Christian Leadership Conference (SCLC) [REDACTED] had signed a contract hiring the Boston Arena for the evening of April 23, 1965. Mrs. Ryan furnished a \$200 deposit on the rental of the arena. She stated the arena is to be utilized for a rally at which Dr. Martin Luther King would be the principal speaker. No admission is to be charged and the general public is invited to attend. b7(D)

On April 13, 1965, the news service of WHDH-TV Boston, Massachusetts at 11:00 p.m. showed a short interview of the Reverend Virgil A. Wood, President of the Massachusetts Southern Christian Leadership Conference in which Reverend Wood announced that Martin Luther King, Jr. would lead a march on April 23, 1965 from the Carter Playground, Roxbury to the Boston Common for the purpose of protesting racial imbalance and slum housing in the Roxbury area of Boston, Massachusetts. Reverend Wood stated that the march would start at 9:30 a.m. and on reaching Boston Common a freedom rally would be held.

Speakers in the Boston Common will include Dr. Ralph Abernathy who will discuss the civil rights in the South and Mrs. Ruth Babson of Roxbury, Massachusetts who will discuss the civil rights situation locally.

The article states that the Reverend John Harmon, Treasurer of the local branch of SCLC, announced that this group hopes to present Dr. King with a gift of \$100,000 when Dr. King arrives in Boston. SCLC has currently raised \$19,796 towards this sum.

[REDACTED] Massachusetts State Police, Boston, Massachusetts, advised that the Office of the Governor of Massachusetts has been unable to determine the plans of Martin Luther King in regard to his coming visit to Boston on April 23, 1965. Inquiries made by the Governor's Office of the local branch of the SCLC indicate that that group is not aware itself when King will arrive beyond the fact that he will be in Boston on April 23, 1965. b7(c)

[REDACTED] Boston Police Department, Boston, Massachusetts, advised that Reverend Virgil Wood and Mrs. Phyllis Ryan, both of SCLC and himself were in conference on this date concerning the plans for the expected arrival of Dr. Martin Luther King, Jr. in Boston. Dr. King will arrive at East Boston Airport on the morning of April 22, 1965, between 8:30 and 9:30 a.m. He will be escorted to the Sheraton Plaza Hotel, Boston, Massachusetts, where he will spend Thursday night.

Dr. Ralph Abernathy and several other persons will have already taken up residence at the Sheraton Plaza Hotel on the afternoon of April 21, 1965 and the Boston Police Department will institute security measures at that hotel at 6:00 p.m. on the afternoon of April 21, 1965.

From the Sheraton Plaza Hotel Dr. King will travel to local SCLC Headquarters, 288 Blue Hill Avenue, Roxbury, Massachusetts where he will hold a press conference at 12:30 p.m.

On the morning of April 23, 1965, Dr. King will breakfast at the Midtown Motor Lodge, 220 Huntington Avenue, Boston, Massachusetts, at 9:30 a.m. At 10:30 a.m. the formation of the line of march will take place at Carter Playground, Columbus Avenue, Roxbury, Massachusetts. Dr. King will lead the march which will proceed down Columbus Avenue turning left on Massachusetts Avenue and right on Huntington Avenue. The march will continue from Huntington Avenue up Boylston Street turning left on Washington Street and again left on School Street, continuing up Beacon Street to Charles Street where the parade will enter Boston Common and proceed to the Parkman Bandstand. The rally will commence at 1:00 p.m.

Barrels will be placed in strategic spots on Boston Common and people will be asked to drop donations of money in these barrels. At the conclusion of the rally Dr. King will leave for Logan International Airport from where he expects to depart between 3:00 to 4:00 p.m. on April 23, 1965.

 advised that the only problem that the SCLC Committee foresees is the probable appearance of the so-called "Polish Freedom Fighter" Jozef Mlot-Mzor. b7(c)

The Committee have asked the Boston Police to prevent Mlot-Mzor from disrupting the rally.

A source which furnished reliable information in the past on April 14, 1965, furnished substantially the same information concerning the SCLC plans for a march on freedom rally on April 23, 1965.

In addition this source advised that on April 19, 20, and 21, 1965, the SCLC plans to have a truck travel through Roxbury accompanied by numerous young girls who will canvass the Roxbury section door to door seeking donations for Dr. Martin Luther King. As received these donations will be deposited in the barrel on the truck.

It noted that the Reverend Martin Luther King was given a deafening ovation by the 1800 present when he walked into the theatre. U

A confidential source advised on April 6, 1965, that Stanley Levison contacted Clarence Jones on that date. He said that he saw Martin at the benefit on Sunday night, that Martin called him over and sought his opinion on the boycott (economic boycott advocated by Martin Luther King against the State of Alabama). Levison stated that he told King it is not a sound policy, that King should back away from the boycott proposal, and that only new industry going into Alabama should be threatened with a boycott. He said King seemed to agree. Levison added that Bayard (Rustin) had told Roy Wilkins, head of the National Association for the Advancement of Colored People) that the idea came from the Student Non-Violent Coordinating Committee and some Southern Christian Leadership Conference (SCLC) people who pushed it on Martin. Jones confirmed this statement. X (u)

Levison remarked that he told King that he is being attacked because they are afraid of his power, that King is a powerful man, and will have to expect this. He asked if Jones was responsible for King naming Ralph (Abernathy) his successor in case something should happen to him. Jones said he was not responsible, that it was Ralph who suggested it, adding that Ralph extracts every bit of blood he can. Levison indicated he was happy that this was not mentioned at a large public gathering. (u)

The source further advised that Jones and Levison discussed the program adopted by the SCLC with Jones remarking that in the future they should have some selectivity as to priority of issues that should be resolved and acted upon during the next period such as April to September. He said he told King they could not drift into the summer without a program. Levison commented that the program adopted in Baltimore (at the SCLC conference) was an enlargement of a program put together by Hosea Williams at the end of 1964. He said this idea of 500 students coming down to 70 counties and working there was upgraded to 5000. (u)

Levison opined that, in the main, it is a good program which should be given thought, but that he has reservations about working in 70 counties. He said that the pattern has been, in the past, that when something happens you concentrate everything in one area, that it is neither safe nor good organization to spread out so far. He added that this should be discussed, that the direction is sound, that each of the counties has a political importance, but that it is a question of how to do it right. Jones remarked that he told King that the main emphasis has to be to achieve legislative recognition and protection of the right to vote and the boycott should be secondary. (u)

This is to advise of Bureau policy and procedures to follow when receiving information relative to threats against the life of Martin Luther King, Jr. In all instances, the Atlanta Office should be expeditiously advised so that the information can in turn be given to the Atlanta, Georgia, Police Department which covers King's permanent residence. This applies even though the threat indicates some action will be carried out in an area other than Atlanta. In addition, if the locale where the threat is to be carried out is known, the field office covering the locale should be expeditiously advised so that the information can be promptly furnished to local authorities.

The Bureau should be expeditiously advised of all threats and the information included in a letterhead memorandum suitable for dissemination. If the initial communication (such as a teletype or radiogram) does not include a letterhead memorandum, it should close with a statement that a letterhead memorandum follows. The initial communication should also advise as to what action the submitting office has taken and what, if any, further action it intends to take as well as action which is being requested of any other receiving offices.

Relative to advice to the Secret Service, you should be guided by the instructions contained in SAC Letter 65-10 (G), 3/9/65, "Agreement Between the Federal Bureau of Investigation and the Secret Service concerning Presidential Protection." Note particularly the applicability of Appendix B to the Agreement concerning the types of individuals to be referred to the Secret Service. Many of the individuals who make threats against King will fall into category number five of Appendix B.

I, Karl Prussion, a former counterespionage for the Federal Bureau of Investigation from 1947 to 1960, do hereby swear under oath and under penalty of perjury, that from the years 1954 through 1958 I attended five county committee meetings of the Communist Party of Santa Clara County, California. (A county committee meeting of the Communist Party consists of one delegate representing each Communist cell in a county.) The meetings were held during the aforementioned period in the following locations:

The residence of Robert Lindsey, Communist, in San Jose, California, 1954; the residence of Mary Field, Communist section organizer, Palo Alto, California, 1955; the residence of Isobel and Edwin Cernoy, both Communists, Menlo Park, California, 1956; the residence of Constance Adles, Communist, Palo Alto, California, 1957; the residence of Karl Prussion, counterespionage for the F. B. I., Los Altos, California, 1958; the residence of Myra White, Communist, Mountain View, California, 1959.

I hereby further solemnly state that at each and every meeting as set forth above, one Ed Beck, Communist, who is presently secretary of the National Association for the Advancement of Colored People of San Mateo County, California, and a member of the Congress on Racial Equality (CORE), presented the directive from the district office of the Communist Party in San Francisco to the effect that:

"All Communists working within the framework of the NAACP are instructed to work for a change of the passive attitude of the NAACP toward a more militant, demonstrative, class struggle policy to be expressed by sit-ins, demonstrations, marches and protests, for the purpose of transforming the NAACP into an organization for the achievement of Communist objectives."

I further swear and attest that at each and every one of the aforementioned meetings, one Reverend Martin Luther King was always set forth as the individual to whom Communists should look and rally around in the Communist struggle on the many racial issues.

I hereby also state that Martin Luther King has either been a member of, or wittingly has accepted support from, over 60 Communist fronts, fronts, and/or organizations, which give aid to or espouse Communist cause.

Dear Mr. Watson:

My letter to you dated April 2, 1965, furnished information concerning a proposed boycott of Alabama products which had been announced by Martin Luther King, Jr. The following additional information which was furnished by confidential sources of this Bureau who have supplied reliable information in the past may be of interest to the President.

Two frequent advisors of King, Stanley Levison and Clarence Jones, recently conferred concerning the Alabama boycott. Levison indicated that he had met with King on April 4, 1965, at which time King sought Levison's opinion concerning the boycott. Levison stated that he told King it was not a sound policy; that King should back away from the boycott proposal; and that only new industries going into Alabama should be threatened with a boycott. Levison told Jones that King seemed to agree with Levison's advice. (u)

Levison and Jones also discussed a new program recently adopted by King's organization, the Southern Christian Leadership Conference, to engage in voter registration activities in a number of southern states during the Summer of 1965. Levison told Jones that he, Levison, had also counseled King concerning this matter. Levison told King to avoid drifting into the summer without a program and while King's program appears to be a good one Levison has reservations about working in seventy counties. Levison does not believe it to be either safe or good from an organizational standpoint to spread out too much. (u)

[REDACTED] advised that five people were planning to kill MARTIN LUTHER KING, JR., at Birmingham, within the next day or two, and that a reward of \$15,000 was being offered to the assassin. [REDACTED] stated that he, himself, was asked to be one of the assassins, that he was from Washington, D. C., and was "employed" by the Federal Narcotics Bureau.

[REDACTED] Washington, D. C., was interviewed at the Sheraton Hotel on [REDACTED], 1965, [REDACTED]. He advised that while awaiting an appointment with Attorney [REDACTED] in [REDACTED] office on the [REDACTED] Birmingham, Alabama, at approximately 8:00 A.M., [REDACTED], 1965, he overheard four men in the corridor outside [REDACTED] office discussing MARTIN LUTHER KING, JR., and he heard one of the men say that KING should be killed, as he is grooming himself for the presidency and that he is an agitator and should be put out of the way. He stated that the four persons gave him the impression that they were attorneys in Birmingham. He heard one person offer \$4,000 toward a fund for an assassin. He heard another offer \$6,000 and a third person stated he would make up the difference for \$15,000 for an assassin.

He stated that when in Washington, he is used by the Narcotics Bureau of the U. S. Department of the Treasury to investigate narcotic violations in the Washington area. He stated that he is paid in cash by the Government for his work. He also said that he has a brother in Birmingham [REDACTED]

A confidential source, who has furnished reliable information in the past, furnished information on March 28, 1965, concerning a conference held that day among the Reverend Martin Luther King, Jr. (President of the Southern Christian Leadership Conference) (SCLC), Walter Fauntroy (Washington Representative of the SCLC), Bayard Rustin and Harry Wachtel. *X (u)*

The conference was mainly concerned with King's attendance on the nationally televised program "Meet the Press" scheduled for that evening. *X (u)*

King stated that he expected to be questioned concerning his relationship with the Student Non-Violent Coordinating Committee (SNCC), specifically as to whether a rift is developing between SNCC and the SCLC and the extent to which Communism and irresponsible elements dominate the SNCC movement. King stated he is not aware of any left-wing or Communist infiltration in the SNCC. *X (u)*

King advised that discussions had been held concerning the need for additional action in Alabama, and after a discussion it was agreed that he would announce plans for an embargo on Alabama products when he appeared on television that evening. X (u)

In "The Saturday Evening Post", issue of July 11-18, 1961, page 76, Bayard Rustin is the subject of a feature article captioned: "The Lone Wolf of Civil Rights". In it, Rustin is said to have come to New York in 1935, as an organizer for the Young Communist League (YCL), and as such, he had the job of recruiting students for the "Party". Furthermore, the article reports that during his first years in New York, Rustin gave most of his earnings to the "Party". He reportedly left the "Party" in 1941, the article stated.

The YCL has been designated pursuant to Executive Order 10450.

The "Daily Worker", February 11, 1957, page 1 column 2, reported that Bayard Rustin, Executive Secretary, War Resisters League, was an observer at the 15th National Convention of the Communist Party, United States of America (CP, USA), held in New York City, on February 9-12, 1957.

The "Daily Worker" was an East Coast Communist publication until it ceased publication on January 13, 1958.

The "Guide to Subversive Organizations and Publications," revised and published as of January 2, 1957, to the first edition published on May 14, 1951, by the Committee on Un-American Activities, U. S. House of Representatives, Washington, D. C., contains the following information concerning "The National Lawyers Guild:"

1. Cited as a Communist front.
(Special Committee on Un-American Activities, House Report 1311 of the CIO Political Action Committee, March 28, 1944, p. 149).
2. Cited as a Communist front which "is the foremost legal bulwark of the Communist Party, its front organization, and allied groups" and which "since its inception has been devoted to the legal defense of the Communist Party and analysis of members thereof, including Communist agents." (Committee on Un-American Activities, House Report 3123 on the National Lawyers Guild, September 21, 1950, originally released September 1950).
3. "To defend the cases of Communist lawbreakers, fronts and fronts devised making special appeals in behalf of civil liberties and reaching out far beyond the confines of the Communist Party itself. Among these organizations are the National Lawyers' Guild. When the Communist Party itself is under attack these offer a bulwark of protection."

THE REV. MARTIN LUTHER KING, JR.

Born in Atlanta, Georgia on January 15, 1929, Rev. King, Jr. was named Michael Luther King, Jr. In 1935 his father, the Rev. Michael Luther King, Sr., changed his first name and that of his son to the one by which he is now known.

Rev. King, Sr., a highly respected Negro Baptist minister, was pastor of the Ebenezer Baptist Church of Atlanta, Georgia. He had married Alberta Williams, the daughter of a minister. She was a well educated, refined girl of a fine religious family.

Rev. King, Sr. had a very large congregation in Atlanta, and was influential in the Atlanta community. He enjoyed a good income, was respected by white and colored alike, and, while always seeking to better the living conditions and opportunities of the Negro community, he always abided by the law and never became involved in agitation movements; nor would he allow himself to be swayed by "carpet-baggers."

King, Jr. was raised in a home where he had every comfort and security. He had the advantage of a devoutly religious family and seemed destined to follow in his father's footsteps, until he met up with other influences in college. In 1944 Martin Luther King, Jr. entered Morehouse College in Atlanta, Georgia, where he remained until he obtained his A. B. Degree in 1948. While there, he came under the influence of the President of the College, Benjamin E. Mays. Mays had already been affiliated with communist fronts.

He had supported Harry Bridges, had favored commissioning communists in the armed forces. While King was at Morehouse College, Mays became so interested in the communists that he lent his name on April 21, 1947 as a Negro leader in defense of the Communist Party. In the book, "Thirteen for Christ," a chapter on King was written by John Howard Griffin, author of "Black Like Me," in which we read (Pages 33-34 of "Thirteen for Christ"), "A strongly athletic, physically robust, life loving youth, he evi-

denced no obvious vocation for the ministry, but his concern for racial and economic justice was already substantial. Under the stimulus of such thinkers as Dr. Benjamin Mays and Dr. Samuel Williams it became far more profound." Dr. Mays by 1962 had piled up thirty-five affiliations with communist fronts and an important connection with the National Council of Churches.

In 1948 Martin Luther King, Jr. entered Crozier Theological Seminary, Chester, Pa., and in 1951 received his Bachelor's Degree in Divinity and the Pearl Plafkner Award for Scholarship. While there he admittedly was influenced by Dr. Mordecai Johnson, President of Howard University, who preached there. Dr. Johnson was a great admirer of Mahatma Gandhi; and King, Jr. absorbed Dr. Johnson's eulogies of Gandhi. Dr. Johnson had already been active in many communist fronts and was an ardent believer in permitting communists to be officers in the armed forces.

King, Jr. then continued on in college at Boston University, as a Louis Crozier Fellow, obtaining his Ph. D. in 1955. He was also a special student at the University of Pennsylvania and Harvard University. Then as now, there was a shortage of qualified ordained ministers in the United States, and this is especially true in the South. In order to help overcome this shortage, several Bible Schools and Seminaries have made available three-year courses in order to get more ministers, evangelists and preachers into the field. In spite of the need of the people for ministers, King stayed in school for twenty-one years, ten of those years in colleges.

On June 17, 1953, Martin Luther King, Jr. married Miss Coretta Scott, a beautiful and talented young lady from Marion, Alabama. They had met and dated when she was a student at the New England Conservatory of Music. In 1954 King was offered the pastorate of two Baptist churches in the East and teaching posts in

three colleges. He chose the pastorate of the Dexter Avenue Baptist Church in Montgomery, Alabama. King and his wife have four children, one of them a son carrying on the now traditional name of Martin Luther King III.

After becoming established in his church, King founded the Montgomery Improvement Association and led a successful bus boycott. In 1956 TIME Magazine selected Martin Luther King, Jr. as one of the "outstanding personalities of 1956." On April 24, 1957 King accepted the 1957 Social Justice Award from the National Religion and Labor Foundation. This is the organization which published the blasphemous drawing of Jesus Christ as a "Criminal Wanted for Sedition." The National Religion and Labor Foundation had been exposed and cited as a communist front in 1944, thirteen years before King accepted their award, by the Special Committee on Un-American Activities of the 78th Congress.

That same year, on September 2, 1957, Martin Luther King, Jr. was a featured speaker for the Highlander Folk School, Monteagle, Tenn., on the occasion of their 25th Anniversary Celebration. The Commission on Education of the State of Georgia cited the Highlander Folk School (after a full investigation) as being a "Communist Training School."

In March of 1957 King started the "Southern Christian Leadership Conference" with himself as President, the Rev. F. L. Shuttlesworth as Secretary, and the Rev. Ralph Abernathy as Treasurer. All three have piled up an unenviable record of affiliation with pro-communist organizations and communist fronts. In the Congressional Record, October 21, 1963, Page A-6552, the Hon. J. D. Waggoner listed the communist-fronters in the NAACP, after which he stated, "I would like to add to that list 'Reverend' Fred Lee Shuttlesworth, convicted bootlegger and head of the communist front Southern Conference Educational Fund."

After 1957 Martin Luther King, Jr. became a national celebrity, getting tremendous publicity, often by arranging to get himself arrested and for a short time failing to post bond. The liberal press built him up into the hero of the oppressed colored masses in America. The following quotation from a communist document indicates his importance in the Struggle for Negro Rights.

From the House Committee on Un-American Activities, Appendix to Hearings dated June 10, 1960, Part IV, Pages 2338-2349, we quote the following copy of an official Communist Party document entitled "Draft Resolution October 25,

1959 by Pettis Perry. "... To rally the masses against imperialism we need also slogans that correctly express the nature of today's struggle for Negro rights. "... The right of Negroes to be the administrators of Civil Rights laws, interpreters of their provisions and enforcers and judges of violations, must be recognized. One of the movements that developed and shook the world in the field of Negro liberation... is the Martin Luther King Improvement Association. This movement inspired Negroes of other cities to conduct similar struggles. So powerful was this movement, that the young Martin Luther King emerged five years ago from an obscure clergyman to prominence as an international figure. King, Abernathy, Shuttlesworth and other prominent ministers in the South are the most authorized spokesmen for this movement."

Martin Luther King, Jr. selected as his secretary at the Southern Leadership Conference Bayard Rustin, who worked in this capacity from March, 1957 until 1960. Rustin had already been convicted of and served a jail sentence for sex perversion and had also served more than two years in a federal prison rather than serve in the armed forces of our country. Rustin (who had been active in the Young Communist League) while working as King's secretary, attended the 1957 Convention of the Communist Party USA as an "observer." Other observers noted that Rustin was influencing King and that Rustin was in "good standing" with the highest echelons of the Communist Party.

In 1960, when Bayard Rustin moved on to bigger things, the communist influence in the Southern Christian Leadership Conference continued through King's hiring of a man who called himself Jack H. O'Dell, but was also known as Hunter Pitts O'Dell. King made O'Dell Educational Director for Georgia, Alabama and Mississippi. O'Dell had been expelled from the National Maritime Union for communist activities. He was the Southern District Organizer for the Communist Party USA and operated out of Party Headquarters in New Orleans. He took the Fifth Amendment regarding his Communist Party membership and activities in Hearings before the House Committee on Un-American Activities and the Senate Internal Security Subcommittee. O'Dell, who became a close adviser and planner for Martin Luther King, Jr., was a member of the National Committee of the Communist Party USA. (These facts were revealed by the St. Louis GLOBE DEMOCRAT, October 26, 1962.)

The same newspaper on January 12, 1964

quoted Gus Hall, Gen. Secretary of the Communist Party USA, as saying at a meeting, "The United States is now moving strongly in the direction of communism. . . The Communist Party will run the United States eventually." In response to a question, Hall stated the Communist Party leaders in the United States "consult with and advise top Negro leaders in their Civil Rights campaigns. . . "Members of the Communist Party are very active in all the Negro organizations engaged in the Civil Rights struggle." Joseph Alsop, liberal columnist, warned in the N. Y. HERALD TRIBUNE, "The subject of real head-shaking is the Rev. Martin Luther King, Jr. His influence is very great. Yet he has accepted and is almost certainly still accepting communist collaboration and even communist advice."

Martin Luther King, Jr. became a "joiner" in order to gather new supporters from any possible source. He became a member of NAACP and CORE. He was Editor at Large for the CHRISTIAN CENTURY, a far-left publication exposed by the Church League of America in 1959. He became a member of the National Advisory Council of the Fellowship of Reconciliation of Nyack, N. Y. This is the group Bayard Rustin was working for when he was jailed for his sex deviations. Rustin was "Race Relations Director" for the organization.

Martin Luther King, Jr. was a featured speaker for the War Resisters League of New York City which organization employed Bayard Rustin as National Secretary. Rustin had the honor of first introducing King to Kwame Nkrumah, communist dictator of Ghana. For several years King had been a member of the National Committee of the American Committee on Africa which sponsored a U. S. tour for communist Holden Roberto who admits that his communist followers, operating from the Congo, have raided villages in Angola and are responsible for the accompanying rapes, tortures, murders and mutilations. In fact, he says these things are necessary to accomplish his purpose.

Martin Luther King, Jr. was an admirer of the now cited Southern Conference Educational Fund of which identified communist Carl Braden was Field Secretary. When Braden was convicted of contempt of Congress King initiated a petition to Pres. Kennedy asking for clemency for him and solicited signers for the petition. In 1963 Rev. Shuttlesworth, King's close associate and secretary of his Southern Christian Leadership Conference, became president of the Southern Conference Educational Fund, active in twelve states, based in New Orleans. Shuttlesworth, the moonshiner and pro-communist, had become Pastor

of the Revelant Baptist Church at 1556 John Street, Cincinnati, Ohio.

Martin Luther King, Jr. became a member of the National Committee for a Sane Nuclear Policy and signed numerous petitions for them, calling for suspension of nuclear weapons testing. On May 14, 1961 King signed a petition to President Kennedy denouncing the House Committee on Un-American Activities and the Senate Internal Security Sub-committee. Earlier that year (January) he had signed petitions to Congress to abolish the H. C. U. A. One of these petitions appeared as an advertisement in the communist propaganda newspaper, THE NATIONAL GUARDIAN, on January 16, 1961.

King's close relationship to the communist front, the Southern Conference Educational Fund, was brought to light when their offices were raided by the New Orleans police and their files seized. Hearings held and reports issued by the Louisiana Joint Legislative Committee on Un-American Activities showed the tie-in of Martin Luther King, Jr. and this communist front. In Report #4, issued November 19, 1963, Page 100, there is a photograph of King with three officers of S. C. E. F., all of whom are identified communists. On Page 101, Exhibit #44 is a check payable to Martin Luther King, Jr. personally and deposited by him in his S. C. L. C. Fund. Many other letters appear in these reports which show the close working agreement in the operation of King's S. C. L. C. and the New Orleans headquarters of the communist-front, S. C. E. F.

The communist paper, THE WORKER, on October 21, 1961 reported, "Rev. King Urges UN Admit People's China. . . The Rev. Martin Luther King favors admission of People's China to the UN, he said last week. Addressing a Freedom Forum in Schenectady, N. Y., the Rev. King declared he could not understand why the U. S. objects to the admission of numerically the largest nation in the world without whose agreement there can be no peace."

On December 14, 1962, Rev. King, Jr. visited and had a conference with communist Ben Bella in a Harlem (New York City) hotel. In May, 1963, the highly respected INTELLIGENCE DIGEST AND WEEKLY REVIEW of England stated, "Two American Negro agitators were recently arrested in Birmingham, Alabama. Their names are Rev. Martin Luther King, Jr. and Rev. Ralph D. Abernathy. These two men are expert professional riot-makers. They have been in contact with advisors in direct links with the Soviet Secret Service and extremist

African groups operating from Europe."

Martin Luther King's rabble-rousing (peaceful type, that is) in Birmingham in 1963 was supported loudly by the American communists and sympathizers. Negro author, James Baldwin, spoke in San Francisco in support of King. Addressing a large group at the Masonic Auditorium, he stated, "If I find myself castrated on the streets of Birmingham, which is not improbable, and the FBI moves in, which is extremely improbable, it could turn out that the person investigating the crime is the same person who committed it." (THE WORKER, 5/14/63) A rally was held under the auspices of the "Emergency Committee to Support Birmingham" (239 West 125 St., N. Y. C.) to support King and his efforts in Birmingham. The principal speaker was Rev. Fred Shuttlesworth. Among the other speakers were James Farmer of CORE and the late Malcolm X. (THE WORKER, 5/14/63)

When the Birmingham, Alabama, disorders occurred as a result of King's (non-violent) efforts, the communist WORKER stated, "Gus Hall, head of the Communist Party USA, branded the effort of Governor George Wallace of Alabama to pin violence and disorder on the communists as a crude diversion and typical trickery of the ultra-right to cover their vile deeds by anti-communism. 'His threat to call in the HCUA only demonstrates his collaboration with the Dixiecrat hoodlums.'" (5/14/63)

Speakers at rallies in support of King and his activities included Dr. Herbert Aptheker (member of the National Committee of the Communist Party USA), Mrs. Alva Buxenbaum (National Chairman of the communist Progressive Youth Organization), Elizabeth Gurley Flynn (late Secretary of the Communist Party USA). Dr. Ralph Bunche, Undersecretary of the UN, who has a long history of affiliation with communist fronts, sent a telegram to King "lauding" the Negroes of Birmingham and congratulating Rev. King, Jr., Rev. Shuttlesworth and Rev. Abernathy.

These Birmingham activities catapulted King into the big-time and were but rehearsals for the bigger events to come in Selma and the March for "Voter Registration." These events and the accompanying violence (caused by non-violent King) are prominent in the news of the day.

When the Northern Christian Leadership Conference, an affiliate of the Southern Christian Leadership Conference, disbanded, Rev. C. W. Billingslea (Pres.) sent King a telegram in which he urged him to "reenter the pulpit and teach more of Christ and less of Gandhi." No finer advice can

be given to this "young pacifist parson" than to go back to his pulpit, and abide by the teachings of Jesus Christ. When J. Edgar Hoover called him a "notorious liar" he was speaking the truth, a practice suggested for the Rev. Dr. King upon his return to the pulpit. Rev. King's honesty in financial matters did not stand up in an investigation conducted by tax auditors in Alabama in 1961, which disclosed that King had "failed to report" almost fifty percent of his income for the year 1956. He was forced to pay the additional taxes due and narrowly escaped jail as a tax-dodger.

Karl Prussion, who was a counter-spy for the FBI for thirteen years, made a sworn statement September 28, 1963, from which we quote in part, "I hereby also state that Martin Luther King has either been a member of, or wittingly has accepted support from, over sixty communist fronts, individuals and/or organizations which give aid to or espouse communist causes." One Louisiana authority who reviewed the material seized at the headquarters of the Southern Conference Educational Fund, Inc. in New Orleans, La., came to the considered opinion that Martin Luther King, Jr. is under the discipline of the Communist Party.

Why must honest sincere Negroes allow such a man to lead them into violence and law breaking? King himself admitted that the Voter Registration Drive, even if one hundred percent successful, will not solve the Negroes' problems. What it will do, however, is provide more people to be manipulated by him and his co-plotters, which is what he really wants. King wants power for himself, not rights for the Negro.

A review of appropriate Knoxville files fails to reflect any information indicating KING'S presence at the Highlander Folk School, Monteagle, Tenn., other than the occasion of the 25th Anniversary celebration at Highlander on the Labor Day weekend of 1957. File contains the photograph circulated by the Georgia Commission on Education, Atlanta, reportedly made of KING at Highlander Folk School (HFS) on this occasion. It is noted that file contains an article in the New York Times dated 7/7/57 reporting that HFS would hold its 25th Anniversary on the Labor Day weekend of 1957. It is reported that an interracial group of consultants and speakers have been invited to participate, among those being Rev. MARTIN LUTHER KING, Jr., Dr. ALONZO MONRON, president of Hampton Institute, and AUBREY WILLIAMS, Montgomery Farm Magazine, and former director National Youth Administration, Rev. C. K. STEELE, RALPH HELSTEIN, president of the United Packing House Workers, and C. CONRAD BROWNE of Koinonia Farms, described as an interracial religious settlement near Americus, Ga.

of the Commission stated that KING was one of those present and he described a photograph of KING. This photograph apparently was the one that was later circulated by the Georgia Commission on Education.

Pamphlet distributed by Highlander Folk School, Monteagle, Tenn., entitled "Highlander Clippings" contains excerpts from newspaper articles reporting the visit of Mrs. ELEANOR ROOSEVELT at Highlander on 6/17/58 and also items concerning the 25th Anniversary of the school. One item in this pamphlet contains an excerpt of an address by KING. This item is headed "The Look to the Future" by MARTIN LUTHER KING, Jr., Montgomery, Ala.," (an address delivered at the 25th Anniversary of HFS, Monteagle, Tenn., Labor Day 9/2/57) (transcribed from a tape recording). Mr. Chairman, Mr. Horton, Distinguished Guests, Ladies and Gentlemen: It is a great privilege and a distinct honor for me to have the opportunity of being a part of the 25th Anniversary observance of the Highlander Folk School. I have long admired the noble purpose and creative work of this institution. For twenty-five years you have stood with dauntless courage and fearless determination. You have given the South some of its most responsible leaders in this great period of transition, and so I am happy to congratulate you today for all of your great work, and hope for you many more years of creative and meaningful work...."

Chattanooga News-Free Press, Chattanooga, Tenn., in issue 9/29/59 contained a news item reporting that HFS, whose main educational building had been padlocked as a "public nuisance" was trying to organize a "protest" by "friends" to the Tennessee Governor. It was reported that earlier in the month Highlander was found to have been selling beer to minors and adults without a license. It was reported the Rev. S. S. SEAY, Negro Executive Secretary of the Montgomery Improvement Association, Montgomery, Ala., had condemned the padlocking. It was noted in the article that KING was president of this association. The news item stated that in a publicity release from the MIA it was stated "the NAACP and its official family, MYLES HORTON and Highlander Folk School, MARTIN LUTHER KING,

Jr., and all who subscribe to principles of life advocated by these organizations and persons will not go unmolested by the opposition".

Reference is made to Memphis letter to Director dated 4/2/59 entitled "HIGHLANDER FOLK SCHOOL, IS - C", wherein it was transmitted a letterhead memo containing information obtained on a confidential basis [REDACTED]

The memo reflects information from records turned over to the Investigating Committee of the Tennessee State Legislature, which was inquiring into activities of HFS at Monteagle during the 1959 session of the Legislature. The information obtained came from a list of contributors maintained by the HFS on index cards. On this list appeared the name under Mobile "Rev. M. L. KING, Jr., Montgomery Improvement Assoc., 530 C. So. Union, Montgomery, Ala". It was reported these cards were broken down into sections of guarantors, funds, college service funds, unions and foundations. The card bearing KING'S name was reported to be under the section "guarantors". The source indicated that the word "guarantors" indicates the name was under a special section of names apparently made up of people who had guaranteed to contribute a certain amount periodically; however, this was not fully explained.

An article appearing in the Chattanooga Daily Times, Chattanooga, Tenn., in issue 2/23/61 datelined Atlanta, reported that the Southern Christian Leadership Conference and Highlander Folk School had joined forces to train Negro leaders for the Civil Rights struggle. It was reported that KING was head of the SCLC and a conference spokesman was reported to have said eleven Negroes had completed a week's training at Highlander and another class was expected.

The article continued that some observers had said the affiliation of Dr. KING'S organization with Highlander raised serious questions of prestige for KING'S group. JAMES R. WOOD, Administrative Assistant to Dr. KING, said the SCLC is

aware of the problem but he asserted "we find no reason not to cooperate with any organization that is interested in the development of full citizenship for Americans which cannot be proved to have conducted itself in a manner which is not American or patriotic". It is noted that the article contained no information that KING was engaged in any capacity at the school.

Knoxville letter to Director 8/13/63 entitled "HIGHLANDER RESEARCH AND EDUCATION CENTER, INFORMATION CONCERNING (IS)" reported that on 8/12/63, [REDACTED] b7(D) [REDACTED] made available names of instructors, directors and sponsors of the Highlander Research and Education Center (successor to Highlander Folk School). Among a list of approximately 25 names given as sponsors appeared the name of Rev. MARTIN LUTHER KING, Jr.

Knoxville files also contain a photostatic copy of a letterhead of the Highlander Education and Research Center dated May, 1964, reflects among approximately 90 Highlander sponsors listed on the letterhead the name Rev. MARTIN LUTHER KING, Jr. A review of the file reflects that the names Highlander Education and Research Center and Highlander Research and Education Center are used interchangeably. A pamphlet of HREC indicates that among approximately 90 sponsors in the fall of 1963 KING is also listed.

The file review fails to reflect the identity of any established reliable source who might be contacted in connection with the matter of KING'S presence at the school.

For your future guidance, information such as contained in re airtel necessitates being included in a LHM so that it may be promptly disseminated by the Bureau. The information not only deals with King's personal plans but also with other such important matters in the civil rights field as King's meeting with his staff in Selma, Alabama, and his meetings with other groups throughout the country.

Dear Mr. Katzenbach:

We are, I am sure, what you would undoubtedly term average American citizens, and we are convinced that you people back in Washington, D.C. do not realize or do not care about just what this means.

For instance, you have been quoted as stating that you do not think that there are communists or communistically inclined people involved in the too many uprisings, demonstrations, and flaunting of the laws of the land throughout the entire United States, with practically no objections from Washington.

We can assure you that we have very different reports from many different reliable sources and are deeply concerned, especially for the future of our children and their children.

We know the facts about Hungary and Korea and as yet the very uncertainty in Viet Nam, none of which reflect the true spirit of staunch and true Americanism.

We also know the facts about Alger Hiss, the red herring, the Bay of Pigs et al. We also know that Mr. J. Edgar Hoover has publicly stated that there are communists working in all the recent and present fiascoes. Just what is wrong with a Senator like Church of Idaho who writes in Look magazine that there no longer is any communism in our Public schools when within the past year I received from Mr. Hoover literature stating that Communism made great headway in our schools in the past year? And he did NOT say that it had lessened one bit recently.

What about Austin, who has been foremost in almost all demonstrations? He was scheduled to speak here at our Montana State College a few years ago and the American Legion protested strongly albeit unsuccessfully to the then President R.R. Renne because of Austin's immorality and communism.

What about the Kauter brothers having been indoctrinated for four years in Russia itself?

And what about Martin Luther King? We have a picture of him taking part in communistic training school in Monteagle, Tennessee occupying positions both as speaker and member of the school attendants.

To say nothing of taking away states' rights in too many matters to renumerate.

We also know what happened along the roads in the recent Selma march, despite your controlled press. What was done to even try to prevent such depraved acts along a public highway? NOTHING.

If you do not reply to this letter, we will assume that either you have not read it or that you are not concerned about the American people and what they feel and think.

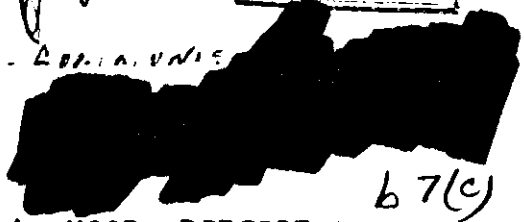



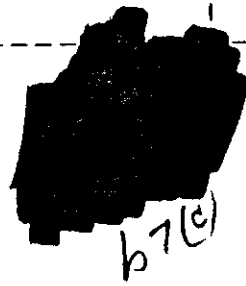

The above picture was made by an employee of the State of Georgia, at the Highlander Folk School in Monteagle, Tennessee during the Labor Day week-end of 1957. The photographer was sent to the Highlander Folk School by the Georgia Commission on Education. The Highlander Folk School was abolished by an act of the Legislature of the State of Tennessee at a later date because it was charged with being a subversive organization.

Those numbered in the picture are:

1. Martin Luther King, Jr., of the Montgomery boycott and the Birmingham riots. Karl Prussion, a counterspy for the FBI for twenty-two years, charges that Martin Luther King belongs to sixty Communist-front organizations — more than any Communist in the United States. He is promoted and encouraged by the Kennedys.
2. Abner W. Berry of the Central Committee of the Communist Party.
3. Aubrey Williams, President of the Southern Conference Education Fund, Inc., The Transmission Belt in the South for the Communist Party.
4. Myles Horton, Director of Highlander Folk School for Communist Training, Monteagle, Tennessee.

These "Four Horsemen" of racial agitation have brought tension, disturbance, strife and violence in their advancement of the Communist doctrine of "racial nationalism."

AFFIDAVIT

I, Karl Prussion, a former counterespionage for the Federal Bureau of Investigation from 1947 to 1960, do hereby swear under oath and under penalty of perjury that from the years 1954 through 1958 I attended five county committee meetings of the Communist Party of Santa Clara County, California. (A county committee meeting of the Communist Party consists of one delegate representing each Communist cell in a county.) The meetings were held during the aforementioned period in the following locations:

The residence of Robert Landsay, Communist, in San Jose, California, 1954, the residence of Mary Field, Communist section organizer, Palo Alto, California, 1955, the residence of Isobel and Edwin Cerny, both Communists, Menlo Park, California, 1946, the residence of Gertrude Adler, Communist, Palo Alto, California, 1957, the residence of Karl Prussion, counterespionage for the F.B.I., Los Altos, California, 1958, the residence of Myra White, Communist, Mountain View, California, 1959.

I hereby further solemnly state that at each and every meeting as set forth above, one Ed Beck, Communist, who is presently secretary of the National Association for the Advancement of Colored People (CORE), presented the directive from the district office of the Communist Party in San Francisco to the effect that:

"All Communists working within the framework of the NAACP are instructed to work for a change of the passive attitude of the NAACP toward a more militant, demonstrative, class struggle policy to be expressed by sit-ins, demonstrations, marches and protests, for the purpose of transforming the NAACP into an organization for the achievement of Communist objectives."

I further swear and attest that at each and every one of the aforementioned meetings, one Reverend Martin Luther King was always set forth as the individual to whom Communists should look and rally around in the Communist struggle on the many racial issues.

I hereby also state that Martin Luther King has either been a member of, or willingly has accepted support from, over 60 Communist fronts, individuals, and/or organizations, which give aid to or espouse Communist causes.

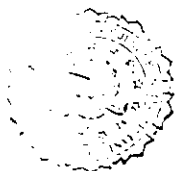

According to the article, "Broadway Answers Selma", was a benefit staged on the evening of April 4, 1965, at the Majestic Theater which brought together the stars of virtually every Broadway show and some of the great stars of past shows to give a ringing lesson in integration and to raise about \$150,000 for the cause of freedom. It was pointed out that tickets for the benefit which was staged by Hillard Elkins, sold for \$1,000 to \$5 and according to the article the proceeds were said to be the highest for a single benefit performance in the history of the theater. u

Among the beneficiaries of the performance were the family of the Reverend James J. Reeb (the minister who was recently killed in Alabama while there in the cause of civil rights), the Voter Education Program of the Southern Christian Leadership Conference (of which Martin Luther King, Jr., is President), the Congress of Racial Equality (CORE) and the E. and M. A characterization of the "School for Democracy" is set forth in the appendix pages.

The "Daily Worker" was an East Coast Communist newspaper which ceased publication on January 13, 1958.

The "Daily Worker", September 6, 1949, page two, column four, reported that Leonid Hambro, pianist, appeared at the Paul Robeson Concert at Peekskill, New York.

The late city edition, "The New York Times", December 23, 1963, reported that Paul Robeson left the United States on July 10, 1958, after an eight year legal fight on a Supreme Court ruling to obtain a passport.

According to the article, Robeson once said he loved "the Soviet people more than any other nation because of their suffering and sacrifice for us, the Negro people, the progressive people, the people of the future in this world". It added that most of the questions directed at Robeson on his arrival in New York City, on December 22, 1963, were answered by his wife, who told reporters that her husband still thinks Communism is "terrific".





"As a result of the investigations into alleged subversive activities of teachers of the New York City public schools by the Rapp-Coudert Committee of the New York State Legislature in or about 1940, a number of teachers resigned, or were suspended or dismissed by the Board of Education from their teaching posts in New York schools and colleges.

"At the annual spring conference of the Teachers Union of New York City in 1940, at which approximately 51 teachers who had been dismissed or who had resigned as a result of the investigation were present, the idea of a so-called School for Democracy was put forth and found general acceptance.***

"*** Of the organizers and original faculty of the School for Democracy, about one third have been identified in the record as members of the Communist Party, and several of those so identified have been established as functionaries of the Party's educational apparatus***."

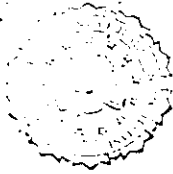

Dear Mr. Hoover,

I would, first of all, like to complement you and the Federal Bureau of Investigation for its fine work. I realize that there are groups, ⁱⁿ particular the communists, that are constantly trying to destroy the F. B. I., our local police force and the House Un-American Activities Committee.

The latest attack on you by Martin Luther King, I believe, was just another attempt at destroying the F. B. I.

Today myself and a [REDACTED] met our Congressman Jonathan B. Bingham. [REDACTED] asked Mr. Bingham his opinion of Martin Luther King. Mr. Bingham had only praise for this man. [REDACTED] mentioned that King had belonged to or had been supported by 60 communist front organizations and backed this up with an affidavit signed by a Karl Prussion. According to this affidavit Karl Prussion was a counterspy for the F. B. I from 1947 to 1960. Mr. Bingham brushed the paper away as nonsense. b7(c)

I would like to know, for myself, if you know of this affidavit or of Karl Prussion. While I believe that King is working for the communist cause, either knowingly or unknowingly, I still hesitate accepting such an affidavit without checking on its authenticity.

We suggested that Mr. Bingham check with you but this was ignored.

I find it difficult to convince many people of the communist infiltration into the civil rights movement, but I would have imagined a Congressman would be better informed. I realize that a politician must follow party line to a point but his supporting Martin Luther King is really stretching the point. I greatly fear for our country.

Enclosed is a copy of the Russian affidavit. Also I am enclosing a Declaration of Conscience distributed by the Catholic Worker, Committee for Nonviolent Action etc. While I am Catholic, I do not believe this group is a truly Catholic organization.

AFFIDAVIT

I, Karl Prussion, a former counterespionage for the Federal Bureau of Investigation from 1947 to 1960, do hereby swear under oath and under penalty of perjury, that from the years 1954 through 1958 I attended five county committee meetings of the Communist Party of Santa Clara County, California. (A county committee meeting of the Communist Party consists of one delegate representing each Communist cell in a county.) The meetings were held during the aforementioned period in the following locations:

The residence of Robert Lindsay, Communist, in San Jose, California, 1954; the residence of Mary Field, Communist section organizer, Palo Alto, California, 1955; the residence of Isobel and Edwin Cerney, both Communists, Menlo Park, California, 1956; the residence of Gertrude Adler, Communist, Palo Alto, California, 1957; the residence of Karl Prussion, counterespionage for the F.B.I., Los Altos, California, 1958; the residence of Myra White, Communist, Mountain View, California, 1959.

I hereby further solemnly state that at each and every meeting as set forth above, one Ed Beck, Communist, who is presently secretary of the National Association for the Advancement of Colored People of San Mateo County, California, and a member of the Congress on Racial Equality (CORE), presented the directive from the district office of the Communist Party in San Francisco to the effect that:

"All Communists working within the framework of the NAACP are instructed to work for a change of the passive attitude of the NAACP toward a more militant, demonstrative, class struggle policy to be expressed by sit-ins, demonstrations, marches and protests, for the purpose of transforming the NAACP into an organization for the achievement of Communist objectives."

I further swear and attest that at each and every one of the aforementioned meetings, one Reverend Martin Luther King was always set forth as the individual to whom Communists should look and rally around in the Communist struggle on the many racial issues.

I hereby also state that Martin Luther King has either been a member of, or wittingly has accepted support from, over 60 Communist fronts, individuals, and/or organizations, which give aid to or espouse Communist causes.

Declaration Of Conscience AGAINST THE WAR IN VIETNAM

Because the use of the military resources of the United States in Vietnam and elsewhere suppresses the aspirations of the people for political independence and economic freedom;

Because inhuman torture and senseless killing are being carried out by forces armed, uniformed, trained and financed by the United States;

Because we believe that all peoples of the earth, including both Americans and non-Americans, have an inalienable right to life, liberty, and the peaceful pursuit of happiness in their own way; and

Because we think that positive steps must be taken to put an end to the threat of nuclear catastrophe and death by chemical or biological warfare, whether these result from accident or escalation --

We hereby declare our conscientious refusal to cooperate with the United States government in the prosecution of the war in Vietnam.

We encourage those who can conscientiously do so to refuse to serve in the armed forces and to ask for discharge if they are already in.

Those of us who are subject to the draft ourselves declare our own intention to refuse to serve.

We urge others to refuse and refuse ourselves to take part in the manufacture or transportation of military equipment, or to work in the fields of military research and weapons development.

We shall encourage the development of other nonviolent acts, including acts which involve civil disobedience, in order to stop the flow of American soldiers and munitions to Vietnam.

NOTE: *Signing or distributing this Declaration of Conscience might be construed as a violation of the Universal Military Training and Service Act, which prohibits advising persons facing the draft to refuse service. Penalties of up to 5 years imprisonment, and/or a fine of \$5,000 are provided. While prosecutions under this provision of the law almost never occur, persons signing or distributing this declaration should face the possibility of serious consequences.*
