On the night of September 6, 1965, a confidential source, who has furnished reliable information in the past, advised that Martin Luther King (President of the Southern Christian Leadership Conference (SCLC)) was in conference with Stanley Levison on that date. Their contact, according to the source, was in regard to an article which is scheduled to appear in "The New York Times" magazine in the future. The article, which will be attributed to King, will deal with the civil rights movement in general and the Los Angeles riot in particular. Levison, the source advised, wanted King's comments regarding the draft of the article he had prepared at King's request. King said he thought it was good, but said he desired to change a couple of points, specifically: the statement at the end of the article which inferred that the only way to solve the problem (Negro) was to have a march of 100,000 people; the statement that none of the major cities have good mayors should read that, "only a few major cities have good mayors, Allen being one of them" (Mayor Allen of Atlanta, Georgia); and the statement that the riots cast light on the imperfections of the civil rights movement. King said the last enumerated statement was too strong and would expose him to the criticism of other civil rights leaders. They agreed to modify the statement by saying that the riots exposed the imperfections of the civil rights movement as well as those factions in the "social-economic" life of the community. U

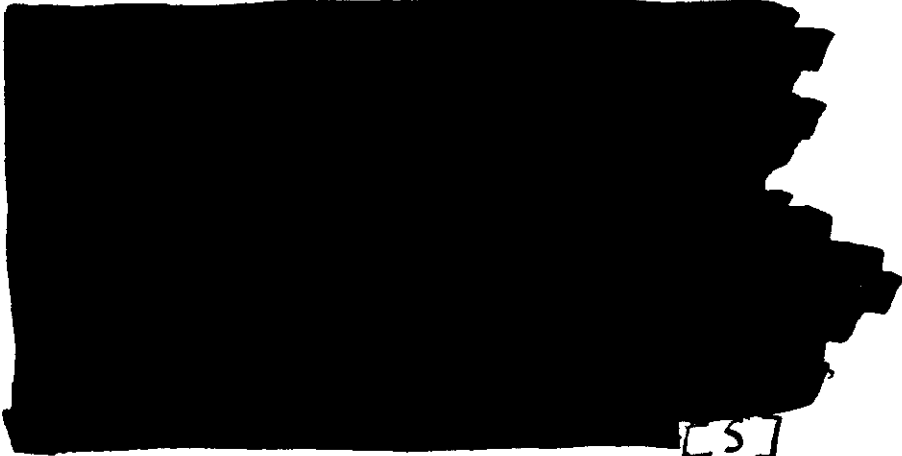

Another matter considered by King and Levison was a report that the headquarters of the SCLC had been burglarized. Levison said he had not been able to verify the story, thereby prompting King to volunteer that during the SCLC Convention (in Birmingham, Alabama, August 9-13, 1965) the safe was burglarized. According to King, checks amounting to \$6,000, which had been contributed to the SCLC, checks in the amount of \$10,000, which were to pay their bills, and a \$190,000 check representing funds of the SCLC which were being transferred to another SCLC account, were taken. Levison suggested to King that he "scotch" the rumor that one quarter of a million dollars was stolen because it could adversely affect donations.

Statement by Dr. Martin Luther King, Jr. on arrival in Los Angeles  
August 17, 1965

I have come to Los Angeles at the invitation of a number of concerned individuals and major organizations that have been, like myself, deeply involved in the struggle for civil rights and human dignity.

Let me say first of all that I profoundly deplore the events that have occurred in Los Angeles in these last few tragic days. I believe and have said on many occasions that violence is not the answer to social conflict whether it is engaged in by white people in Alabama or by Negroes in Los Angeles. Violence is all the more regrettable in this period in light of the tremendous non-violent sacrifices that both Negro and white people together have endured to bring justice to all men.

But it is equally clear, as President Johnson pointed out yesterday, that it is the job of all Americans "to right the wrongs from which such violence and disorder spring." The criminal responses which led to the tragic outbreaks of violence in Los Angeles are environmental and not racial. The economic deprivation, social isolation, inadequate housing, and general despair of thousands of Negroes teeming in Northern and Western ghettos are the ready seeds which give birth to tragic expressions of violence. By acts of commission and omission none of us in this great country has done enough to remove injustice. I therefore humbly suggest that all of us accept our share of responsibility for these past days of anguish.

I should like to state in quite more specific terms why I make this journey in the interest of reconciliation and future cooperation between the races.

First, I have come to minister to the thousands of innocent Negro people who have done no wrong or who have thought in any way to use violence, yet whose community has been disrupted by rioting, the destruction of institutions they daily need, and many of whom have lost their work. This has been for them, not merely the hardship springing from the disruption of their physical community; it has been a spiritual disaster deepening their despair and hopelessness.

Secondly, I have come to minister to the small degree that I can - to those who have been involved in the rioting. Our Christian effort must be to redeem them and to leave no stone unturned, despite their guilt, to help them find a useful place in building a good society in which they can share as equals. In this connection I shall, as a first step, seek to visit with them in prison and to urge officials to find ways for them to help reconstruct the damage they have done.

Thirdly, I would like to confer with the many segments of the white community that have been the staunch allies of the Negro people in our struggle. Surely if millions of Negroes across this country are dismayed, deeply hurt, and bewildered by these past few days, it stands to reason that our white friends are also. The strength of the Negro - white alliance for justice will be maintained only if we are in constant dialogue, understanding past mistakes, evolving new programs, and providing ways and means to avert any such recurrence of violence.

Fourthly, I would like to work with the local leadership of Los Angeles in proposing programs for the eradication of those problems relating to housing, schools, jobs, and police behavior that were directly or indirectly related to the disorder.

Fifthly, if the local leadership feels that it will be helpful, I am prepared to sit with them in discussions with public officials on the role and responsibility of governments and to evaluate with them a program that will eliminate such future occurrences in Los Angeles or in any other city of our nation.

On August 31, 1965, a confidential source, who has furnished reliable information in the past, advised that Stanley Levison conferred with Bill Stein on that date. The conference afforded Levison an opportunity to apprise Stein that he recently talked with Martin Luther King, (President of the Southern Christian Leadership Conference (SCLC) ), during which time King said the SCLC had decided to employ him (Stein). According to Levison, Stein will receive \$9,000 annually, plus expenses, and will be the highest paid employee on the staff of the SCLC.

The source said Levison told Stein that his principal function will be raising funds for the SCLC, and that he will do this by contacting churches. In this regard, Levison said he desired to accompany Stein down there (Atlanta, Georgia), to discuss a few things about the Negro churches he will contact in carrying out his duties; however, Levison cautioned that he might not be able to go since King had already delegated so many responsibilities to him that he did not know whether he would have the time.

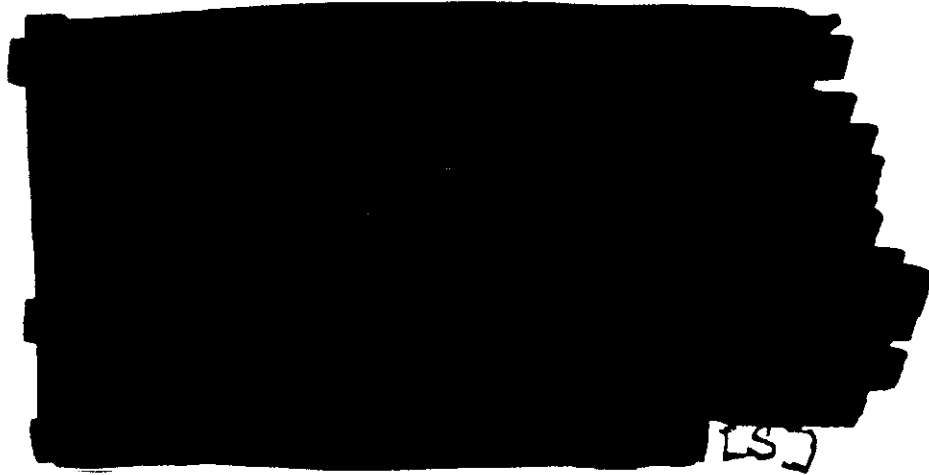

The "Guide to Subversive Organizations and Publications," revised and published as of December 1, 1961, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following concerning the National Lawyers Guild: [U]

"National Lawyers Guild

- "1. Cited as a Communist front.  
(Special Committee on Un-American Activities, House Report 1311 on the CIO Political Action Committee, March 29, 1944, p. 149.) [U]
- "2. Cited as a Communist front which 'is the foremost legal bulwark of the Communist Party its front organizations, and controlled unions' and which 'since its inception has never failed to rally to the legal defense of the Communist Party and individual members thereof, including known espionage agents.'  
(Committee on Un-American Activities, House Report 3123 on the National Lawyers Guild, September 21, 1950, originally related September 17, 1950.) [U]
- "3. 'To defend the cases of Communist lawbreakers, fronts have been devised making special appeals in behalf of civil liberties and reaching out far beyond the confines of the Communist Party itself. Among these organizations are the \* \* \* National Lawyers Guild. When the Communist Party itself is under fire these offer a bulwark of protection.'
