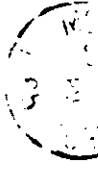

On August 13, 1953, STAUGHTON LYND during an interview with Special Agents of the Federal Bureau of Investigation stated he had joined the American Youth for Democracy in the Fall of 1946 on the campus of Harvard University and had disaffiliated himself from the American Youth for Democracy in June, 1947.

The American Youth for Democracy has been designated pursuant to Executive Order 10450.

A source advised on November 3, 1964, that STAUGHTON LYND, Professor of History, Yale University, New Haven, Connecticut, and Director of the Mississippi Freedom Schools, spoke at a Socialist Workers Party meeting held October 30,

1964, at New York, New York, as a member of the panel discussing the topic, "The Ghetto and Political Action."

The Socialist Workers Party has been designated pursuant to Executive Order 10450.

On February 12, 1965, a second source advised that at a rally protesting United States policy in Viet Nam held February 11, 1965, at Yale University, New Haven, Connecticut, STAUGHTON LYND stated he had signed a "Declaration of Conscience on The War in Viet Nam", declaring his refusal to serve in the Armed Forces if drafted.

On April 15, 1965, a third source advised that at a rally protesting United States intervention in Viet Nam, held April 14, 1965, at Yale University, New Haven, Connecticut, LYND read a letter which he had sent to the Internal Revenue Service explaining that he was refusing to pay income tax beyond his withholding tax, as a protest to the United States policy in Viet Nam.

I read with great interest your statement in part regarding the present problems faced by the nation in enforcement of the law, and the part Martin L. King has been involved in, or has contributed thereto.

It is with a great deal of pleasure to me, and so many others to have someone as yourself stand up and state the facts as they are.

You might be interested to know that recently Kingsaid and treasure made a public statement, that the more violence and bloodshed the more money they would have to come in, and even though they collected a million dollars in 1964 they would want & need more in 1965 it would seem to me that by this statement even though King was preaching nonviolence, at the same time hoping for more bloodshed.

As you said he stated he would obey only those laws he felt just, and in effect when he made that statement he was advising his fellow man to do like wise.

For your information this was read in U.S. News & World Report, and I hope that you will not mind me sending the Editors and Mr. J. Edgar Hoover a copy of this letter, for they have also shown great courage in stating the facts regarding this man who as Mr. Truman said is nothing more than a great trouble maker.

Thank all of you, may your courage never fail, and efforts never falter as you speak and print the truth.

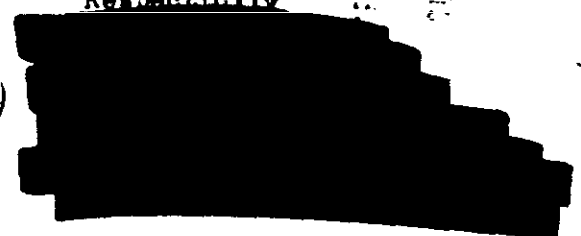

In addition to the information set forth in relet, the following derived from a review of the Who's Who, 1964 - 1965, edition, maintained at New York Public Library, 42nd Street and Fifth Avenue, NYC. The information as reported in the book is as follows:

FRANK THEODORE WILSON was born on January 1, 1900, in Maxton, North Carolina; was educated at Lincoln University, where he received an AB Degree in 1921, an STB Degree in 1924; received an MA Degree from Columbia University in 1932; and in 1952, received a DD Degree from Lincoln University.

On 6/28/64, WILSON married ANNA LUCREITIA DORSEY. Since his college days, he has had employments as National Student Secretary, National Council of the YMCA, 1924 through 1936; was Dean and Professor at Lincoln University from 1936 to 1949; was Dean of the School of Religion, Howard University, Washington, D. C., 1949 through 1957; and since 1957 has been Secretary for the Education Commission on Ecumenical Mission on Relations, United Presbyterian Church in USA.

In addition to these employments WILSON is a member, Board of Christian Education, Chairman, Social Education and Action Commission of the United Presbyterian Church. He has been a guest lecturer at Yale Divinity School, specifically in 1950 and 1954.

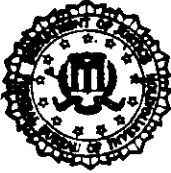

available to a Special Agent of the Federal Bureau of Investigation for review a copy of the September 15, 1963, issue of the Washington Observer Newsletter, number 3, as well as a cover letter to the newsletter signed by Lee Roberts. The letter indicated Roberts is the publisher and gave Post Office Box 9061, Washington, D. C., as the newsletter's mailing address. The letter was a solicitation for subscription.

The newsletter contained an article on Page two, which is quoted as follows:

"The Reverend Dr. Martin Luther King, on the night of August 3, gave the federal government in Washington a taste of BLACKMAIL BY PUBLIC DISTURBANCE. Threatening in terms of 200,000 "non-violent marchers," he let loose upon us a new slogan with his ultimatum: Home Rule or Invasion!

"The Reds here do not talk in terms of non-violence. The OBSERVER can and hereby does inform its readers that elaborate plans and training have been accomplished among Washington's revolutionary cadres in preparation for knocking out communications and all utilities, including the storm and sanitary sewers. This devastation will be wrought by pumping gasoline into the vast network of subways, tunnels, trenches, conduits, and communication passages under the city.

"Events will prove that he is concerned about the wrong revolution. This is the first battle of the Red Revolution and under his leadership we are about to lose it."

On October 1, 1965, a confidential source, who has furnished reliable information in the past, advised that Stanley Levison and Martin Luther King, Jr., were in contact on that date. It was during this contact that King told Levison that he recently fell backwards in his chair and cut his arm on a glass, thus necessitating a cancellation of his appointments for the next five days or so. (S)

Levison and King also discussed matters relating to the Southern Christian Leadership Conference (SCLC) office at 312W125th Street, New York. In that regard, Levison suggested that King close the office since it was accomplishing nothing constructively. King said to close the office might subject "them" (the SCLC) to criticism. Levison concurred with King's reasoning. (S)

It is noted that the SCLC office at 312 West 125th Street, Harlem, New York, New York, is run by Ruth Bailey. The other office in New York City is at 200 West 57th St., NYC., and managed by Adele Kanter. (u)

In continuing their contact, Levison said he had received word that Carey McWilliams (Editor of "The Nation"), is going to carry an editorial "supporting our position as we asked him". (u)

With regard to the above, the same source furnished information on September 13, 1965, that King and his advisors had decided to ask various newspapers to write editorials supporting King's position on Vietnam and the admission of Red China to the United Nations. As a consequence of his position that Red China should be admitted to the United Nations, King has been criticized by Senator Thomas Dodd, Democrat of Connecticut, as well as others. (u)

Before concluding their contact, King said "they" have a potentially embarrassing situation in that Ralph (Ralph Abernathy, SCLC official) got Andy (Andrew Young, Executive Director of the SCLC) to write 50 contributors about buying a car for him (Ralph); however, only one of the contributors responded. Even though only one contributor responded, the car was bought at a price of \$3000, King said and in order to avoid criticism of the SCLC, the money would have to be raised. Levison said he would contribute half and that Harry Wachtel would be approached about raising the other half. (u)

"Emergency Civil Liberties Committee

"1. 'The Emergency Civil Liberties Committee is an organization with headquarters in New York, whose avowed purpose is to abolish the House Committee on Un-American Activities and discredit the FBI. * * * The committee finds that the Emergency Civil Liberties Committee, established in 1951, although representing itself as a non-Communist group, actually operates as a front for the Communist Party. It has repeatedly assisted, by means of funds and legal aid, Communists involved in Smith Act violations and similar legal proceedings. One of its chief activities has been and still is the dissemination of voluminous Communist propaganda material.'

'FRANK WILKINSON was called as a witness when he appeared in Atlanta as a representative of the Emergency Civil Liberties Committee to propagandize against the Committee on Un-American Activities and to protest its hearings. In 1956 WILKINSON was identified as a Communist Party member by a former FBI undercover agent within the party. Summoned at that time to answer the allegation, his reply to all questions was, "I am answering no questions of this committee." This also became his stock reply to questions when he appeared during the Atlanta hearings. * * * WILKINSON has since been convicted of contempt of Congress and sentenced to one year in jail.'

Mr. DeLoach:

While I was in the office of Chuck Stone, Administrative Assistant to Congressman Adam Clayton Powell (D. -N. Y.) this morning, Stone received a telephone call from a Negro newspaperman in New York whom he referred to as Al. At the outset of the conversation Stone asked "Al" if he is now "passing." Stone was complimenting him (Al) for his item regarding Senator Dodd's recent blast at "Martin" (Luther King). Apparently this Negro newsman had written an article critical of Dodd for his recent comments about King.

Stone also suggested that "Al" get a copy of the current American Legion magazine to see the article in there by Congressman Powell on the topic of "Should the U.S. Recognize Communist Cuba." Powell takes the affirmative stand in this issue and accompanying article by Congressman Armistead Selden, Jr., (D. -Ala.) takes the negative position. Stone commented that Powell probably will be "blasted" for injecting himself into foreign policy matters.

Later in the conversation Stone mentioned Walker (apparently Reverend Wyatt Walker, Assistant Pastor of the Abyssinian Baptist Church of which Powell is Pastor). The two discussed what apparently has been a recent rift between Walker and Powell and has led Powell to tell the church board that he has been pastor for 35 years and since some of them apparently do not like how he has been running things, he will resign. Stone also mentioned that he (Walker) has been pushed out of the SCLC (Southern Christian Leadership Conference), a fact not widely known.

A confidential source, who has furnished reliable information in the past, advised on September 29, 1965, that on that date, Martin Luther King was in contact with Clarence Jones. According to the source, Jones advised King of a meeting he, Jones, had with Harry (Wachtel) at which they went over the Gandhi Society Board, the Executive Committee, the whole question of allocation of money for the Southern Christian Leadership Conference (SCLC) and the Gandhi Society. Jones continued that all problems were discussed candidly and frankly, that they both agreed on all names that should be on the Executive Committee as well as those on the Board.

Jones said he discussed the problem of the Gandhi Society not being turned into a "Frankenstein" as far as the SCLC is concerned. He said he told Harry that they must be very careful that, when high contributors give to the Society and intend the money to go to the SCLC, they insure the SCLC benefits. He added that otherwise they will find money being siphoned off to a tax-exempt organization that would otherwise go to the SCLC.

Jones further commented that Harry was in very good form, that they discussed his relationship with King and with Jones as well as the advisory committee and some of the problems which Harry felt existed. He said Harry is ready to go along at every level.

King related that he had spoken with Harry a day or two before and Jones informed King that Harry had summarized the conference held with King concerning King speaking in Philadelphia (on October 15, 1965 on the occasion of the 50th Anniversary of the Women's International League of Peace and Freedom).

King mentioned that he had heard that Harry Belafonte "had gone in the hole" for about \$10,000 and Jones commented that Belafonte had told him the same thing, that it was on the occasion of the Selma benefit. He said Belafonte would like to have some reimbursement made to Belafonte Enterprises. Jones indicated that the expense occurred from the misrouting of equipment which Belafonte shipped down.

(It is noted that Harry Belafonte provided entertainment on the occasion of the march led by King from Montgomery to Selma, Alabama, in the Spring of 1965).

According to the source, it was agreed that King would write Belafonte a thank - you letter. Jones mentioned that perhaps a check for \$1,000.00 could be sent to Belafonte, that Belafonte mentioned a reimbursement of \$2,500.00, but did not press the issue. King felt they could pull out the expense money for Belafonte if they had to.

King advised that the SCLC is in a period where things have gone down a great deal as far as fund raising is concerned. Jones brought up the September fund-raising letter and felt there will be a good response to it.

Jones inquired as to how the Philadelphia appearance had been resolved in so far as King's position on Vietnam is concerned. King related that he had decided to appear at the last minute, make an excuse for leaving and leave immediately after the speech. King said there would be no press conferences.

Jones mentioned that Wyatt Tee Walker, the former Executive Director of the SCLC made a statement from the pulpit of Congressman Adam Clayton Powell's church on Sunday, (September 26, 1965) about the peace settlement with Powell, that King is his number one leader and Powell's number one leader, but that in New York Powell is number one. King stated that he did not know about this, but knew Powell was ready to give in because a lot of members had gotten on Adam and circulated a petition. King added that Powell is smart enough to nip something like that in the bud.

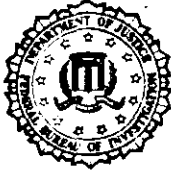

On September 20, 1965, a source, who has furnished reliable information in the past, advised that the Southern Christian Leadership Conference has reserved the dates of October 6, 7, and 8, 1965, at the Firestone Boy Scout Reservation, Carbon Canyon, Orange County, California, for a "training conference". Source did not know how many were expected to attend this training conference but the camp has facilities to accommodate up to 200 persons overnight.

The camp was reserved for the conference by the Reverend Thomas Kilgore, Jr. of the Western Christian Leadership Conference, 2400 South Western Avenue, Los Angeles. The Reverend A. A. Peters, Minister of the Victory Baptist Church, 4502 Mc Kinley Avenue, Los Angeles, who also represents the Western Christian Leadership Conference, indicated that there is a possibility that Martin Luther King, Jr. would be here for all or part of the training conference and if so would personally conduct some of the training sessions.

Source did not know the specific purpose of the training conference or the nature of the training that would be afforded those in attendance.

Dear Mr. Hoover

Regrettably, space and my meager energies forbid me from congratulating you on your long tenure in office. (Although you would be too modest to publicize it and/or security forbids it), I don't doubt that recruits from London's Scotland Yard and the Paris Surete' have visited your department at times to "pick up pointers" and, of course, their superiors must have consulted you many times, either individually, or via Interpol. It suffices that I agree 100% with the recent SATEVEPOST about you and the FBI.

It is amazing that a city like Rochester with a great density of doctors and IBM engineers could harbor hate groups. (IBM is completely integrated, the Mayo Clinic, save for staff doctors is, too.)

Four years ago, someone read my "old liberal" letters to the Rochester (Minn.) Post-Bulletin and embarrassed me by taking out a subscription to the Communist Guardian. I killed the subscription on your kind advice.

Last December I had a letter published in the Post-Bulletin defending Dr. Martin Luther King against charges that he was a Communist sympathizer or even favored Communist report.

Yesterday, the enclosed postcard came from Rochester. As an attorney who must have abstracted, if not almost memorized the laws of the fifty states in line of duty, I am certain that you can determine whether these postcards are unlawful.

I feel that the photograph bears faint resemblance to Dr. King, I have seen no pictures of him without his black suit and I doubt if he would appear anywhere in short-sleeved shirt and, of all things, unpressed grey trousers!

As an ordained minister, Dr. King cannot appear to take vengeance reserved only to God by suing for libel, slander and defamation of character, but I am certain your men in Boston can check out American Opinion and the post office can determine if it is legal to commit mail-order libel.

Your differences in the past with Dr. King have been quite legitimate, but no individual or group receives better justice than at the Department of Justice itself.

Re Atlanta and LHM 9/25/65, copies to Philadelphia, which reported on a 9/27/65 contact between an employee of subject's office and one Martha Hall. It was indicated that subject and his wife, Coretta, would be in Philadelphia, Pennsylvania, 10/15/65. Atlanta noted that it had no further information pertaining to subject's presence in Philadelphia.

For the information of Atlanta and Philadelphia, New York teletype 9/25/65, captioned "Circ" reported on a conference had 9/2-65 between subject and some of his advisors. They discussed the fact that King was scheduled to make a speech in Philadelphia 10/15/65 at the 5th Anniversary of the World's International League for Peace and Freedom. In their discussion, there appears to be a strong likelihood that King will not make an appearance because one of the individuals who is to be on the platform is Staughton Lynd and although he is a friend of King's, it was agreed that he was not the kind of person for King to be seen with. Under consideration was the idea of having someone such as Mrs. King read King's speech for him at this affair.

In view of the foregoing, referenced LHM is not being disseminated by the Bureau. Recipient offices should be alert to additional information indicating the presence of King at the affair in question, and if positive information is received, it should be incorporated in an LHM utilizing, if appropriate, information contained in the referenced LHM as well as in the New York teletype of 9/25/65.

For the additional information of Atlanta and Philadelphia, Lynd is a Security Index subject, New Haven origin, and New Haven is under instruction to furnish New York Office appropriate characterizing information concerning Lynd.

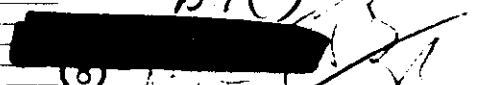

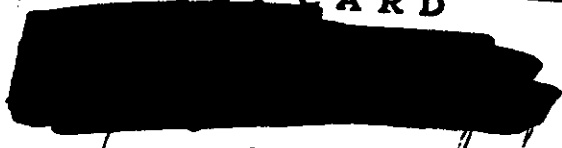

A confidential source of this Bureau, who has supplied reliable information in the past, has furnished the following information which the source described as reliable:

On September 22, 1965, Louis Lomax stated in Los Angeles, California, that he and Martin Luther King, Jr., plan to depart the United States for Vietnam on September 23, 1965. It is noted that on the evening of September 23, 1965, Lomax addressed a group of approximately 500 persons at the San Bernardino, California, County Fair and made no mention of any forthcoming travel plans.

Lomax is a well-known writer and television personality who has been active in civil rights matters. He is presently a resident of the Los Angeles, California, area.

Los Angeles radiogram 9/23/65 reported information from [redacted] described as reliable. On 9/22/65, Louis Lomax stated that he and Martin Luther King, Jr., intend to depart the United States for Vietnam 9/28/65. Lomax, Negro, is a controversial writer and television personality who has been active in civil rights matters and is presently based in the Los Angeles, California, area.

b7(D)

We had the Los Angeles Office, [redacted], cover a personal appearance of Lomax last night (9/23/65) at the San Bernadino, California, County Fair. Lomax addressed approximately 500 people but made no mention of any personal forthcoming travel plans.

We also checked with our Atlanta Office which has advised that its sources close to King have furnished no information whatsoever indicating that King contemplates travel to Vietnam.

You will recall that when King conferred with his advisors 9/13/65 he indicated that he was going to try to gracefully retreat from his "meddling" in the Vietnam situation because of all the adverse publicity King was getting. Notwithstanding the reported indication that King was going to try to back off on the Vietnam matter and the fact that the Lomax claim is not verified by any other source, we believe that the information about a possible trip by King and Lomax should be disseminated. We are following this matter very closely and we will keep you apprised of further developments.

Senator Young, (D) Ohio, spoke concerning a news article reporting that Senator Dodd, (D) Connecticut, denounced Dr. Martin Luther King, Jr., charging that he has taken advantage of his pulpit to meddle in U. S. foreign policy. Mr. Young stated "He also accused Reverend King of being 'alined with the forces of appeasement of communism.'" Mr. Young went on to state "I take violent exception to the accusation that

Reverend King has said or done anything that alines him even remotely 'with the forces of appeasement.' - - - It is dead wrong for any self-appointed vigilante to infer that Rev. 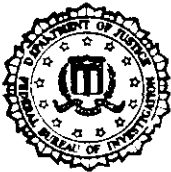

MARTIN LUTHER KING, JR.
SECURITY MATTER - C

On September 22, 1965, the Reverend Martin Luther King, Jr. was present at the annual Michaelmas Convocation of St. Peter's College, Jersey City, New Jersey. At this gathering he was awarded the Honorary Degree of Doctor of Laws and Letters by St. Peter's College and he also gave an address.

In his address Dr. King stressed the brotherhood of man and the equality of all people. He stated that while recent civil rights legislation has been enacted there is a need both in the South and in the North for massive programs to be initiated which will insure equality for all. Dr. King also stressed the need for nonviolence in the civil rights movement.

Prior to the convocation several individuals appeared outside the auditorium and distributed literature critical of Martin Luther King and some of those who have associated with him in the civil rights movement.

Newspaper reports reflect that college authorities stated numerous phone calls and letters had been received objecting to Dr. King's appearance at the college.

At the start of the convocation, while Martin Luther King, Jr. was on the stage, a telephone call was received at the college saying a bomb was on the premises. College officials told Dr. King of the call, and he asked that the call be disregarded since it is a usual thing which happens when he appears in various places. No search was made of the premises and no evacuation was made of the audience. The program was continued without incident.

At Senator Thurmond's request, I went to his office at 4:00 p. m. 9/14/65 for an appointment. I was advised by his assistants, Harry Dent and Fred Buzhardt, that the Senator had called over from the Floor to indicate he must attend a Republican Party policy meeting which former Vice President Nixon would supervise. The assistants indicated that they would appreciate talking to me and that the Senator and I could get together at another time.

Dent showed me two newspaper articles representing releases which Senator Thurmond had put out over the weekend criticizing Martin Luther King for injecting himself into matters of foreign policy at the United Nations. These releases also criticized Ambassador Goldberg for giving King an audience.

b7(c) Dent told me that it was a matter of common knowledge on the Hill that [Redacted] He stated it was also widely understood that King was controlled by communists in this country. Dent stated he had been present when one powerful leader of the Senate a few days ago told a group of newspaper men, off the record, of these facts.

Dent asked me if there was a concerted effort on the part of the FBI to discredit King. I told Dent that such matters were beyond our jurisdiction. He then replied that he felt someone, particularly a Senator, should expose King. I told him this of course was the prerogative of any of the Senators, however, they should do their homework well. Dent mentioned that he felt that King had gone too far in attempting to inject himself into matters of foreign policy. He stated he felt there would be a wide reaction on the part of the American public.

Dent asked if I could give him any advice as to what course of action Senator Thurmond should follow in the future regarding statements concerning King and civil rights leaders in general. I told him that the Senator, being a southerner, would no doubt be considered subject to bias and suspicion in any statements he might make, however, this was all the more reason why the Senator should be very careful about doing his homework.
