On March 11, 1966, a letter was circulated carrying the letterhead "martin luther king paris committee for civil rights", which is quoted below:

"Dear Friends:

"On March 28, at 9:30 p.m., the Reverend Martin Luther King, Mr. Harry Belafonte and his group, and M. Hugues Aufray will appear at the Palais des Sports for the benefit of the Southern Christian Leadership Conference in America. We also hope to have either Odetta or Mahalia Jackson. M. Jacques Monod will introduce the Reverend Doctor Martin Luther King and M. Yves Montand will introduce Mr. Belafonte.

"We are an 'ad hoc' committee gathered together specifically to plan 'La Nuit des Droits Civiques'. We believe that civil rights are of concern to Americans everywhere; that visible support for civil rights by Americans abroad is one of the best ways of helping democracy at home; that the Southern Christian Leadership Conference has proved itself to be one of the responsible voices in this area and that the evening will be a great one! Dr. King, Mr. Belafonte and M. Aufray are donating their services; we are volunteering ours; M. George Cravenne, the French expert in public relations who has been responsible for such successful events as 'Black and White', is giving of his talents and time to make this also a memorable occasion in Paris. We also ask your support.

"The Palais des Sports seats 5000 persons. We anticipate no difficulty in filling the popular price seats. The 'dress circle' seats, however, will be sold for 100 francs and 85 francs. There are approximately 800 of these seats. It is here that we would like your help. We want to fill

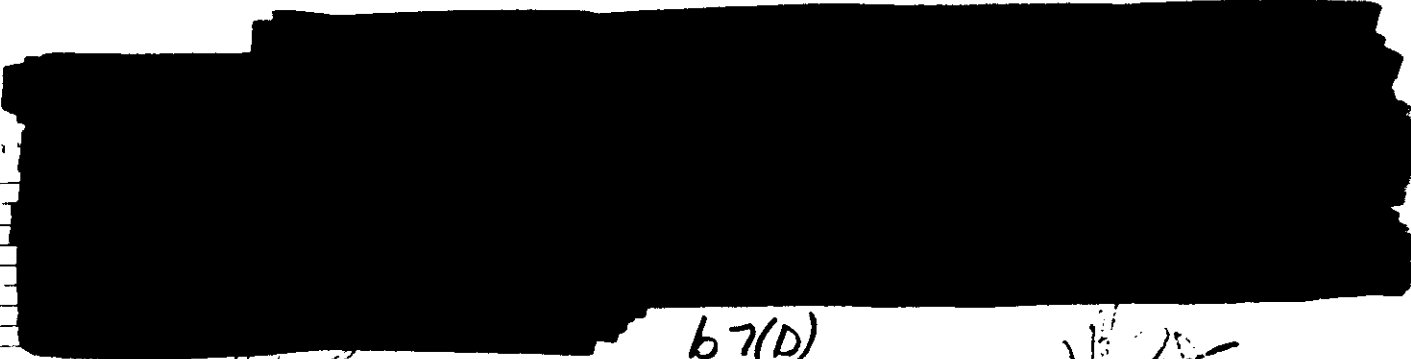

ReBuairtel dated 3/28/66, regarding information contained in Atlanta airtel 3/24/66, that HARRY WACHTEL said a housing situation developing on Long Island.

In an effort to resolve what WACHTEL had in mind, the NYO came up with an article which appeared in the March 30, 1966 issue of the Long Island "Newsday", a Long Island daily.

A review of the article captioned, "Meeting Is Set On Bias Charge", reflected that representatives of Federal, State and County agencies will meet on Saturday, April 2, 1966, with Village and North Hempstead Town officials to seek solutions to charges of alleged housing discrimination lodged by civic and civil rights organizations in Manhasset.

Furthermore, the article reports that the meeting was sparked by charges that 85 families, most of them Negroes, who now live in the 110 family Towers Apartments at 2 Spruce St., in the Village of Thomaston, would be displaced by the prospective

On March 22, 1966, a confidential source, who has furnished reliable information in the past, furnished information which disclosed that Stanley Levison was in contact with Daniel Luskind on that date. According to the information which the source was able to gather, the source was of the opinion that Luskind is a New York City stock broker. Furthermore, the source was of the opinion that the contact between Levison and Luskind concerned investments on behalf of Martin Luther King (President of the Southern Christian Leadership Conference).

In regard to the investments, Levison told Luskind that he desired to buy \$5000 worth of stock called Utilities and Industries. Luskind said it was selling for \$21.50 per share. Levison placed an order for 235 shares of the stock.

Furthermore, Levison instructed Luskind to purchase \$5000 worth of stock in the Intraamerican Life Insurance Company (a new insurance company organized by Clarence Jones). Luskind said this stock was selling for \$10.50 per share and was selling over the counter.

On March 18, 1966, a confidential source, who has furnished reliable information in the past, learned that Clarence Jones, on that date, was in contact with a Bernie Fishman (phonetic). According to the source, Jones desired to meet with Fishman to obtain Fishman's assistance in handling an investment for Martin Luther King. Jones told Fishman that he, Jones, has the authority to invest some \$10,000 for King and that it is a question of whether King wants to put it all in Intramerican (the Intramerican Life Corporation, of which Jones is President), or just \$5,000. Jones continued that King is "pretty much committed to \$5,000 in Intramerican", but wants to put the other \$5,000 in stocks which Jones believes will do as good as Jones thinks Intramerican will do. Jones stated he could not make this judgment and would like Fishman's assistance. u

The source also advised on March 18, 1966, that Bernie (Fishman) agreed to meet with Jones on that date at 425 Park Avenue, New York City. u

The source also ascertained that Jones had requested that Stanley Levison meet him at 425 Park Avenue on the afternoon of March 18, 1966, and that Levison agreed. u

[REDACTED] advised the Chicago Office of the Federal Bureau of Investigation that information available to him reflected that Dr. Martin Luther King, Jr., President, Southern Christian Leadership Conference (SCLC) had arrived in Chicago during the late afternoon hours of March 15, 1966. King had departed Chicago on March 16, 1966, for Atlanta, Georgia, to the best of [REDACTED] knowledge. [REDACTED] had no specific information concerning activities of King while in Chicago during the period March 15-16, 1966, other than participation in staff meetings with his SCLC workers here in Chicago. b7(D)

The "Chicago Sun-Times", a daily Chicago newspaper, edition of March 17, 1966, contained an article relating to Dr. King. The article reflected that King had advised Chicago's Mayor Daley that he would be unable to accept an invitation from Daley to attend a meeting of religious leaders in Chicago's City Hall on Friday, March 18, 1966. The article reflected that King, in a telegram to Mayor Daley, had stated that previous commitments of long standing in the South would prevent his being present at this meeting. The article noted in this connection that King had been one of twenty-four individuals, principally prominent local clergymen, invited by Mayor Daley to meet with him on March 18, 1966, to discuss programs for improving housing, education and job opportunities for Negroes in Chicago.

At 10:35 p.m. on March 19, 1966, the Boston Office of the Federal Bureau of Investigation received a phone call from an anonymous male who advised that he had attended a meeting in the Roxbury section of Boston, Massachusetts earlier in the evening, which he would not elaborate on. He went to the men's room when the meeting was concluded and overheard a conversation between several individuals in an adjoining room. These individuals were discussing a plan to start a disturbance in front of a grocery or candy store across the street from a synagogue in Brookline, Massachusetts where Martin Luther King, Jr. was to speak on March 20, 1966. The disturbance would start as King arrived at the synagogue and while the attention of the police was distracted, some individuals located in a yellow school house next to the synagogue would attempt to shoot King.

The caller appeared to be sober and rational but refused to identify himself or give further details. He broke off the phone call when an effort was made to question him further.

[REDACTED] Brookline, Massachusetts Police Department was immediately advised of the above. [REDACTED] stated that King was scheduled to speak at the auditorium of Temple Killhaleth Israel, 370 Harvard Street, Brookline, Massachusetts at about 8:00 p.m. on Sunday evening, March 20, 1966. He would arrive in Boston at Logan International Airport at about 7:00 p.m. and would be escorted from the airport by Massachusetts State Police, Boston, Massachusetts Police Department and the Brookline Police in turn. b7(c)

[REDACTED] of the Boston, Massachusetts Police Department and [REDACTED] of the Massachusetts State Police were advised on March 19, 1966 of the call concerning the planned attempt to shoot Martin Luther King, Jr.

On March 21, 1966, [REDACTED] Brookline, Massachusetts Police Department advised that the set up described by the telephone caller did exist as described, namely the candy store across from the auditorium and the yellow school house adjacent to it. The school house was found to have a door open which necessitated a search of the school without finding anything suspicious. It could not be determined if the door was left open through carelessness or deliberately. The candy store and the general area were covered by the Brookline Police, but nothing suspicious was noted. b7(c)

Martin Luther King arrived at about 8:00 p.m., March 20, 1966 and left at 9:30 p.m. to take the 10:30 p.m. plane from Logan International Airport, Boston, Massachusetts back to New York. The entire visit was without any incident and although the Brookline Police foresaw the possibility of the auditorium being picketed, this did not materialize.

"The Dallas Morning News" for March 18, 1966, stated King spoke before an overflow crowd in the 2,700-seat McFarlin Auditorium, at the invitation of the academic committee of SMU's Student Senate.

In his book "This Time The World," copyrighted in 1961, George Lincoln Rockwell identified himself as Commander, American Nazi Party of the World Union of Free Enterprise National Socialists (ANP - WUFENS), Arlington, Virginia.

The April 4, 1963 issue of "The Richmond News Leader," a Richmond, Virginia, daily newspaper, reported that George Lincoln Rockwell had, on the previous day, again applied for the American Nazi Party to be chartered in the State of Virginia, but this request was turned down by the Virginia State Corporation Commission. This action was taken pursuant to an act of the 1962 Virginia Assembly which prohibits use of "Nazi" or "National Socialism" in a Virginia charter. This article further pointed out that Rockwell's Party is presently chartered in the State of Virginia as the George Lincoln Rockwell Party.

On August 4, 1964, a source advised that the ANP - WUFENS was organized by George Lincoln Rockwell at his residence in Arlington, Virginia, on February 26, 1959, as an international "National Socialist" movement based on the German Nazi Party headed by Adolf Hitler. He added that Rockwell is the dominant force and personality in this party; that he is espousing a "line" of hatred against the Jews and Negroes; and that he is seeking, through speeches, distribution of literature and picketing, to establish a cohesive and dominant political party in the United States and in foreign countries.

According to the "Stormtrooper's Manual," an official publication of the ANP, the phases of ANP struggle for power are fourfold, namely, first "to make ourselves known to the masses;" second, "the dissemination of our program and truth about the Party;" third, "organizing the people who have been converted to our propaganda;" and fourth, "the attainment of power through the votes of the newly-won masses."

On September 16, 1965, the source advised that George Lincoln Rockwell believes he has completed the first three phases in his struggle for power and is now into the fourth stage, to wit, the "attainment of power through the votes of the newly-won masses." The source stated Rockwell believes this because of his success in gaining a place on the ticket in the November, 1965, gubernatorial election in the State of Virginia.

DALLAS UNIT

On January 24, 1966, a source furnished the following information:

The Dallas Unit of the American Nazi Party (ANP) is a local chapter of the ANP which has its national headquarters in Arlington, Virginia. Robert Alan Surrey, a Dallas printing salesman, is Southwestern Regional Coordinator, and Jerald Thomas Walraven is in charge of the Storm Trooper group of the Dallas Unit, both having been appointed by George Lincoln Rockwell, National Commander of the ANP.

As of January, 1966, the Dallas Unit consisted of an estimated 20 to 25 persons, of which nine were in the Storm Trooper group. The mailing address of the Dallas Unit is P. O. Box 2980, Dallas, and its headquarters are located at 3016 Fairmount Street, Dallas, Texas.

Social groups and the Storm Trooper group making up the Dallas Unit hold regular meetings. The Dallas Unit also holds karate classes, law classes, and classes designed to teach Storm Troopers public speaking. The Storm Trooper group frequently holds demonstrations of an anti-Negro or anti-Jewish nature.

The "Detroit Free Press", a Detroit, Michigan daily metropolitan newspaper, in its edition of March 16, 1966, contained an article captioned, "King Sees Calm Detroit Summer". This article went on to state as follows:

"The Rev. Dr. Martin Luther King is sure Detroit has racial problems to correct but he doesn't foresee racial trouble for the city this summer.

"Dr King said 'Our organization (the Southern Christian Leadership Conference, Atlanta) isn't going to be here.'

"He said he hasn't discussed Detroit civil rights problems with Detroit leaders in recent months.

"Our recent experience has been in Chicago, and that is where we will be this summer,' Dr. King said.

"We're going to be in all areas, and we will have demonstrations."

"The Nobel Prize winner said he is going to wage war on all fronts of segregation in Chicago, including housing, education, and unemployment.

"We're going to organize units of power into unions to end slums.'

"From our experience in Chicago we hope to develop guidelines for other cities.

"There is always a possibility that we could come to other cities and Detroit after that. Certainly Detroit has problems to correct."

"Dr. King was in town to speak at two services of the Detroit Council of Churches Lenten series, at Central Methodist Church, Woodward and Adams.

"Ill with the flu, he kept a standing-room crowd at the first service waiting a half hour. Then the crowd had to exit from the back door, to let in those waiting for the second service.

"In his sermon, Dr. King expanded on his pledge to help desegregate Chicago's ghettos and better the status of the Negro.

"He said 100,000 Negroes out of a million in Chicago are 'chronically unemployed.' And 'white high school graduates could earn more money than Negro college graduates,' he added.

"No community in the country can boast clean hands in brotherhood," he said.

"The situation in the North is becoming more serious in many ways than the South, for there is increasing segregation in housing which results in segregation in the schools."

"In Chicago, he said, '97.7 percent of the Negro people find themselves in a ghetto, and 41 percent of the Negroes in Chicago are in deteriorating housing.'

In his book "This Time The World," copyrighted in 1961, George Lincoln Rockwell identified himself as Commander, American Nazi Party of the World Union of Free Enterprise National Socialists (ANP - WUFENS), Arlington, Virginia.

The April 4, 1963 issue of "The Richmond News Leader," a Richmond, Virginia, daily newspaper, reported that George Lincoln Rockwell had, on the previous day, again applied for the American Nazi Party to be chartered in the State of Virginia, but this request was turned down by the Virginia State Corporation Commission. This action was taken pursuant to an act of the 1962 Virginia Assembly which prohibits use of "Nazi" or "National Socialism" in a Virginia charter. This article further pointed out that Rockwell's Party is presently chartered in the State of Virginia as the George Lincoln Rockwell Party.

On August 4, 1964, a source advised that the ANP - WUFENS was organized by George Lincoln Rockwell at his residence in Arlington, Virginia, on February 26, 1959, as an international "National Socialist" movement based on the German Nazi Party headed by Adolf Hitler. He added that Rockwell is the dominant force and personality in this party; that he is espousing a "line" of hatred against the Jews and Negroes; and that he is seeking, through speeches, distribution of literature and picketing, to establish a cohesive and dominant political party in the United States and in foreign countries.

According to the "Stormtrooper's Manual," an official publication of the ANP, the phases of ANP struggle for power are fourfold, namely, first "to make ourselves known to the masses;" second, "the dissemination of our program and truth about the Party;" third, "organizing the people who have been converted to our propaganda;" and fourth, "the attainment of power through the votes of the newly-won masses."

On September 16, 1965, the source advised that George Lincoln Rockwell believes he has completed the first three phases in his struggle for power and is now into the fourth stage, to wit, the "attainment of power through the votes of the newly-won masses." The source stated Rockwell believes this because of his success in gaining a place on the ticket in the November, 1965, gubernatorial election in the State of Virginia.

On January 24, 1966, a source furnished the following information:

The Dallas Unit of the American Nazi Party (ANP) is a local chapter of the ANP which has its national headquarters in Arlington, Virginia. Robert Alan Surrey, a Dallas printing salesman, is Southwestern Regional Coordinator, and Jerald Thomas Walraven is in charge of the Storm Trooper group of the Dallas Unit, both having been appointed by George Lincoln Rockwell, National Commander of the ANP.

As of January, 1966, the Dallas Unit consisted of an estimated 20 to 25 persons, of which nine were in the Storm Trooper group. The mailing address of the Dallas Unit is P. O. Box 2980, Dallas, and its headquarters are located at 3016 Fairmount Street, Dallas, Texas.

Social groups and the Storm Trooper group making up the Dallas Unit hold regular meetings. The Dallas Unit also holds karate classes, law classes, and classes designed to teach Storm Troopers public speaking. The Storm Trooper group frequently holds demonstrations of an anti-Negro or anti-Jewish nature.

[REDACTED] advised the Chicago Office of the Federal Bureau of Investigation (FBI) on March 8, 1966, that Dr. Martin Luther King, Jr., President of the Southern Christian Leadership Conference (SCLC), had arrived in Chicago at approximately 4:00 p.m. on this date, via Northwestern Air Lines from Atlanta. [REDACTED] had no information concerning specific meetings or engagements on King's part while in Chicago in the next few days, other than a reception on the evening of March 8, 1966 to advertise the March 12, 1966 Freedom Festival, the festival under the joint sponsorship of the SCLC and the Coordinating Council of Community Organizations (CCCO). [REDACTED] anticipates that most of King's activity for the next few days would be directed toward preparations for the Freedom Festival itself.

During the afternoon of March 12, 1966, [REDACTED] Office of the Deputy Superintendent, Chicago Police Department, advised that a telephone call had been received by a representative of the Catholic Interracial Council in Chicago, from an anonymous male individual, and during the course of the conversation, the caller had stated that Martin Luther King, Jr. would be shot down this evening at the Chicago International Amphitheatre.

[REDACTED] advised that this is the location where the Freedom Festival is to be held and that the Chicago Police Department is affording additional security to King as a result of this threat.

b7(c) [REDACTED] Office of the Deputy Superintendent, Chicago Police Department, advised the Chicago Office of the FBI on March 13, 1966 that those attending the Freedom Festival the previous evening at the International Amphitheater in Chicago had dispersed peacefully subsequent to its conclusion, and that there had been no incidents of any kind during the affair. [REDACTED] advised that no effort had been made to shoot or otherwise physically harm King during the course of this affair.

In connection with the Freedom Festival held on March 12, 1966 in Chicago, the Chicago "Sunday Sun-Times", a Chicago newspaper, contained an article concerning the festival and stated that in his prepared comment to the 12,000 or so persons who were in attendance, King had advised that his anti-slum campaign in Chicago would be enforced by public demonstrations if necessary.

King was quoted in this article as stating, "When it is appropriate, we will encourage sit-ins, stand-ins, rent strikes, boycotts, picket lines, marches, civil disobedience, and any form of protest and demonstrations that are non-violently conceived and executed."

The article continued that Dr. King's speech was the top attraction at the festival, which had presented noted entertainers including Harry Belafonte, Dick Gregory, Mahalia Jackson, Sydney Poitier and others.

King's comments painted a dark picture of the poverty and deprivation of the Negro race, according to the article.

He described the living conditions of the Negro immigrant from the South in the slums of Chicago and other large northern and western cities, stating that Chicago has the largest concentration of Negroes in an urban ghetto of any major city in the United States. The Negro is confined here by a conspiratorial noose pulled tight by the racist attitudes and actions of selfish profiteering real estate interests and white residents with restrictive covenants and agreements abetted by the prejudicial practices of mortgage - money lending institutions.

An article in the Chicago "Sunday American," a Chicago newspaper, also contained an article concerning the March 12, 1966, Freedom Festival at the International Amphitheatre, describing the audience of some 13,000 as a complete sellout with streets outside the Amphitheatre lined with crowds of individuals, unable to get in, estimated at an additional 10,000. This article reflected that a sum in excess of \$100,000.00 had been realized through the proceeds of this festival, the sum to be used to help finance King's anti-slum campaign in Chicago.

[REDACTED], advised that Dr. King had departed Chicago on March 13, 1966, shortly before noon, en route to New York City, New York. According to [REDACTED] King anticipated return to Chicago on or about March 16, 1966.

In regard to the assumption by King and the SCLC of the "trusteeship" of the so-called slum building on Chicago's west side, an article in the March 10, 1966, edition of the Chicago "Sun-Times" reflects that the landlord of this building, John B. Bender, age 81, was granted a 30-day stay in proceedings directed at placing this building in receivership. The attorney for Bender advised that he was completely destitute and unable to correct the many building violations which existed in the building. An attorney for Dr. King, present at the Circuit Court proceedings, stated that neither the SCLC nor Dr. King has collected any rents so far from the tenants of this building since the assumption of the so-called "trusteeship." It was stated that King has spent \$1,500.00 of his own funds

fixing up this building to make it more liveable, and pending further court action, did not plan to collect these rents in the foreseeable future.

In connection with the anticipated presence in Chicago of Dr. King during the week of March 14 - 18, 1966, the March 14, 1966 edition of the Chicago "American" contained an article reflecting that Chicago's mayor, Richard J. Daley, had invited 29 leading clergymen in the city to meet with him on March 18, 1966 for a discussion of civil rights and poverty problems in the city. Also invited by Daley to attend this meeting was Dr. King. The article noted that if Dr. King were to accept this invitation, it would be the first meeting between King and Chicago's mayor.

[REDACTED] advised on March 14, 1966, that the captioned individual assisted in the dedication ceremony marking the opening of the Kennedy-Clark Homes of the Mt. Olive Baptist Church, on Sunday, March 13, 1966. b7(D)

Dr. KING was the speaker at a banquet commemorating the above mentioned housing project, held at the Travelers Insurance Company, Hartford, Connecticut, and attended by 600 persons, on the evening of March 13, 1966. In his remarks, the speaker stated "The Negro in 1966 is freer, but he is not free. The Negro in 1966 has more dignity, but he is not yet equal."

Dr. KING also denounced what he termed "the myth of accelerated progress." He outlined the statistical evidence of the alleged oppression of the Negroes of "Chicago's Ghetto", and called that city "a prototype of cities all over the country." He was critical of educational conditions in Chicago, and described Los Angeles as a strong indicator of the problems of the Negro in the North. He claimed to have warned of conditions in Los Angeles prior to the Watts riots of 1965, and claimed to have been told by Mayor SAMUEL YORTY of Los Angeles that no problems existed. Dr. KING predicted "darker nights than Watts" if the economic plight of the Negro is not dealt with all over the Country.

HOSEA WILLIAMS, an associate of Dr. KING in the Southern Christian Leadership Conference (SCLC), told of gains in voter registration in the current Alabama campaign, which he is directing. He stated, "There is a new day in Alabama and we ain't going to let nobody turn us around. We're not out to crucify GEORGE WALLACE, but we are out to convert him."

A number of speakers, including Governor JOHN N. DEMPSEY, hailed Dr. KING and praised the project which the banquet commemorated.

[REDACTED] advised on March 14, 1966, that MARTIN LUTHER KING addressed a "Freedom Rally" which was held at the Klein Memorial Auditorium, Bridgeport, Connecticut, on March 13, 1966. b7(D)

During the course of his comments, KING said that "modern man is cursed with a poverty of spirit. Despite the technological advances that have been made, men have not yet learned to live with each other as brothers."

"Man is plagued with three evils: The evil of racial injustice, the evil of poverty, and the evil of war. Although progress has been made, the Negro is not yet free. This constitutes a national problem. Legislation on paper is not enough to free the Negro. Civil rights must be translated from thin paper to thick action."

"Poverty is like an octopus whose tentacles spread throughout the world. Two-thirds of the world's people are hungry."

Citing the Biblical parable, Dr. KING said that "the rich man did not go to hell because he was rich, but because he passed by the poor man every day and failed to see him, and whenever the rich man does not see the poor man, he is doomed."

Dr. KING stated, "The day is past when wars can be fought without affecting more than the nations immediately involved."

DR. MARTIN LUTHER KING, JR.

"Man must put an end to war or it will put an end to him", said KING quoting the late President JOHN F. KENNEDY. KING is against United States intervention in Vietnam purely on moral grounds. He advocates recognizing Red China and the strengthening of the United Nations.

KING pointed out that "If annihilation is to be avoided, it must be made clear that democracy is the best form of Government."

KING described totalitarianism as being unrealistic and opposed to the human spirit.

Approximately 1200 persons were present at this Rally.
