On April 7, 1966, [REDACTED] advised the Chicago Office of the Federal Bureau of Investigation as follows:

Doctor Martin Luther King, Jr., President, Southern Christian Leadership Conference (SCLC) arrived in Chicago during the evening of April 6, 1966. On April 7, 1966, King spent the morning at the offices of the Chicago Urban League, and in the afternoon King was to appear before a gathering of students and faculty at the University of Illinois, Circle Campus, Chicago, Illinois.

In the evening of April 7, 1966, King was to appear at a church located on Chicago's south side, the purpose of or details regarding this meeting were not known.

Re: Martin Luther King, Jr.

The "Chicago Daily News" on April 6, 1966, contained an article stating that on April 5, 1966, an order was handed down in Circuit Court, Chicago, Illinois, enjoining Martin Luther King and the SCLC from interfering with the operation of an apartment building at 1321 South Homan, Chicago, Illinois, or collecting rents from the tenants at this building. Further, an accounting was ordered for rents which had been collected and repair expenditures made by King since he took over this building.

This article reported that a SCLC official at Atlanta, Georgia, had advised that the court order would be contested and that this was only the first step to build up a body of legal precedent to guarantee tenants' rights.

On April 8, 1966, [REDACTED] b7(D) advised that King was to attend a SCLC workshop at Woodstock, Illinois, during the afternoon of April 8, 1966, and at 8:40 p.m. King was scheduled to depart Chicago, Illinois, for Atlanta, Georgia.

On April 10, 1966, a program "Sunday with Martin Luther King" was aired on radio station WAAF-AM from 10:00 a.m. to 10:15 a.m.

In monitoring this program, it was noted that it consisted of the sermon by King pointing out that just as Christianity had overcome evil, Negroes would overcome the evil standing between them and freedom.

Listeners were requested to contribute to the SCLC at 123 West Madison Street, Chicago, Illinois, and were invited to tune in each Sunday morning at 10:00 a.m. to hear Martin Luther King.

The "Daily News" on April 5, 1966, contained an article identifying Lavernon Cornelius, 7354 South Michigan, Chicago, Illinois, as one of the sponsors of a "Negro Vigilante Unit" in Chicago known as "The Deacons of Defense and Justice" (DDJ). Cornelius was reported in this article as saying that deacons are primed to fight a war if necessary to protect Negro rights.

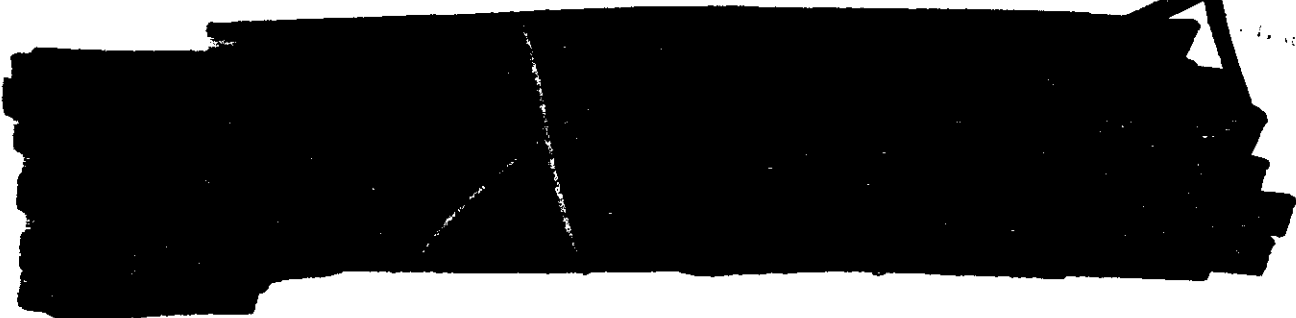

The 4/11/66 issue of 'The Miami News,' local newspaper, reflected MARTIN LUTHER KING, JR. arrived Miami this date accompanied by SCIC staff, including HARRY BOYIE, Rev. ANDREW YOUNG and ROSEA WILLIAMS, each a leader in civil rights campaigns in other cities. KING will stay at the Hampton House Hotel, 4200 NW 27th Ave., Miami.

On 4/12-13, 66 SCIC Board of Directors will hold semi-annual meeting in Miami; first time session has been held outside of Atlanta. On 4/13/66, at 8 PM, KING will address mass meeting at Mt. Zion Baptist Church, 301 NW 9th St., Miami, more than 100 expected to fill church. KING's topic will be the hostility and alienation in the Negro community, according to BOYIE.

KING also assisting in establishing local SCIC Chapter. He will leave Miami 4/14/66.

However, Sheriff's Office received information 4/7/66, that on that date a call was made to Hampton House as follows: "You had better not let MARTIN LUTHER 'COON' stay in your house." According to [REDACTED] the SCLC is aware of this call.

On 4/11/66 [REDACTED] b7(D)
[REDACTED] advised that it was his understanding that a Board meeting was also held this date at the Hampton House Motel and Villas. He had no data concerning this meeting. It is noted that the Villas are located in the interior section of this motel and activity cannot be observed from outside the motel.

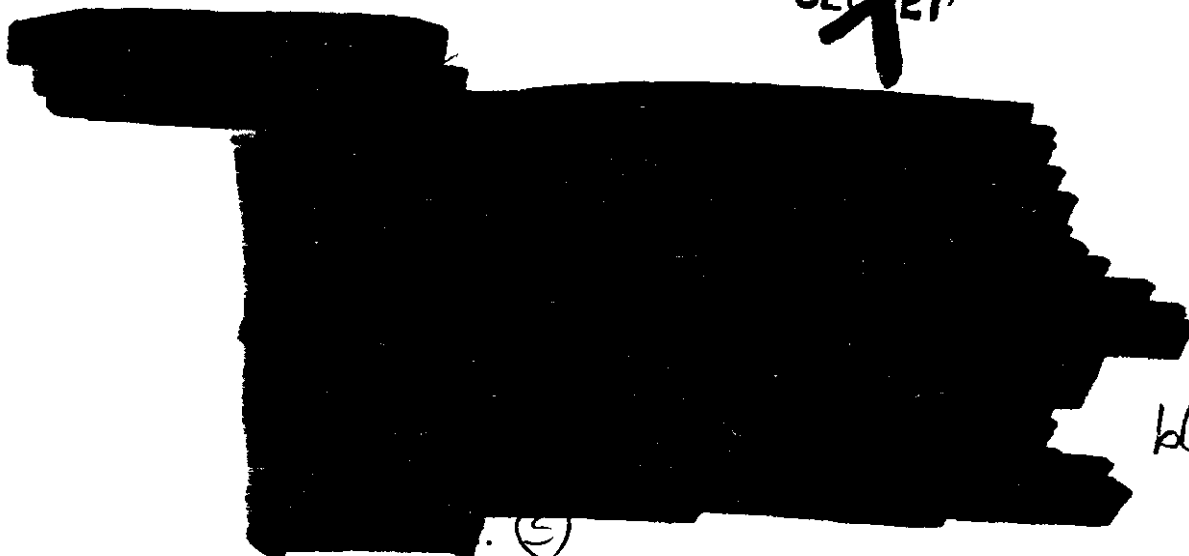

On April 6, 1966, a confidential source, who has furnished reliable information in the past, advised that on that date, Clarence Jones was in contact with Gloria (Canter, Secretary to Harry Belafonte). According to the source, Jones told Gloria that he did not go to the meeting (of the Research U Committee of the SCLC held that day).

Gloria related that they had received information from Stockholm (where a fund-raising affair was held for the SCLC on March 31, 1966) and that for a starter, \$200,000 had been sent to Dr. Martin Luther King. She said there is a possibility of another \$200,000.00. The source stated that Jones and Canter then discussed tax problems and that Jones said he was not going to get involved in it. He added that Harry's (Belafonte's) lawyer should advise "them" (the SCLC). U

On March 31, 1966, a confidential source, who has furnished reliable information in the past, advised that Stanley Levison and Adele Kanter, Director of the SCLC Office in New York City, were in contact on that date. Among the topics considered, according to the source, was the following:

Kanter said Junius (Junius Griffin), Public Relations Director of the SCLC) has resigned as Public Relations Director

Levison said that he knew that Junius was dissatisfied with his position because he told him so when he (Levison) was in Chicago recently. Levison said Junius was not a public relations specialist by any means, although he had tried to cast the Department (Public Relations Department) in his own image. Levison said he was curious over an article which appeared in "The New York Times" recently portraying the SCLC as having no program in Chicago. Levison said although the article concerning the Chicago situation had originated in the office of Junius, it had actually been approved by Andrew (Andrew Young, Executive Director of the SCLC); therefore, Junius was not to be blamed entirely.

Another confidential source, who has furnished reliable information in the past, learned on March 31, 1966, that Clarence Jones, intends to go to Miami, Florida on Eastern Airlines Flight Number 29, leaving New York City, on April 11, 1966, at 6:00 p.m. According to the source,

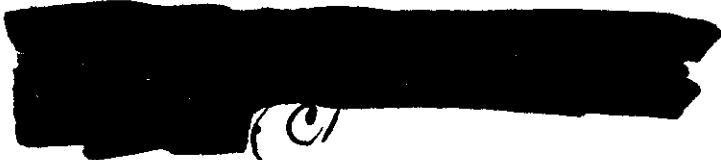

On March 23, 1966, [REDACTED]

[REDACTED] advised the Chicago Office of the Federal Bureau of Investigation (FBI) that Dr. Martin Luther King, Jr. President, Southern Christian Leadership Conference (SCLC) had arrived in Chicago from Atlanta, Georgia, shortly before noon on this date. [REDACTED] advised that his Unit had no schedule of activities for King other than that a meeting was scheduled for this evening, March 23, 1966, at the Warren Avenue Congregational Church, 3101 West Warren Boulevard, Chicago, where the East Garfield Park Community Organization (EGPCO) would hold an open hearing on slums in the area, with King in attendance. b7(D)

The "Chicago Daily News", a Chicago daily newspaper, issue of March 24, 1966, contained an article concerning the March 23, 1966, meeting of the EGPCO. King had presided at this meeting, this neighborhood organization in the East Garfield Park area of Chicago consisting of some 30 neighborhood and block groups. Several hundred persons had attended the meeting, including two white representatives of management firms in the area who handled a total of some 100 buildings, all allegedly slums. Complaints from residents of these buildings were heard, and representatives of the EGPCO gave these building management representatives ten days in which to improve conditions and make necessary repairs on certain selected buildings or the EGPCO would initiate court proceedings to force these repairs. In the event repairs were made, then another set of buildings would be specified, with another ten day deadline given to make repairs. The threat of picketing the real estate offices involved was also suggested in the event the indicated repairs were not made.

In remarks made at the conclusion of this meeting, King promised massive demonstrations in Chicago in his drive against slums, calling upon Negroes to organize in the event peaceful demonstrations are called for.

King was quoted in this article as having stated "We have a power that nobody in Chicago can stop. All you have to do is organize. By the thousands, we will get together. The people in City Hall will see a thing that no man can number and say 'where are they coming from?'"

The "Chicago Sun Times", a daily Chicago newspaper, edition of March 25, 1966, contained an article concerning the March 24, 1966, meeting between Chicago's Mayor Richard J. Daley and some 35 to 40 local religious and civil rights leaders. Also present at this meeting of March 24, 1966, was Dr. King.

The meeting, lasting some four hours, was called for the purpose of a mutual discussion of the question of how best to rid Chicago of slums and related matters. Local City Department heads briefed those present on the City's programs to improve living conditions and job opportunities of all Chicagoans. This article reflected that during the proceedings, a 20 minute dialogue took place between King and Daley, directed at the specific questions of ridding the City of slums and preventing a Watts type situation from arising in Chicago. Both King and Daley, during later press conferences, described their discussion, and the meeting in general, as very friendly and amicable.

The article continued that subsequent to this conference, King had appeared before the Headline Club, Chicago Chapter of a National professional journalism Society, where King stated that his Chicago campaign against slums and Negro unemployment would be ready to move into high gear by late May, 1966. King estimated, however, that it would be another 18 months before his program here will be operating at full strength. King described the EGPCO as typical of the community organizations he is trying to build here and which will form the basis of his campaign. He is trying to organize such groups in all sections of the City to unify Negro forces here, stating that in such unity there is the necessary strength for achieving the desiring results.

King had stated that the campaign in Chicago is the largest and most ambitious the SCLC has ever undertaken, and that the problems which he is trying to resolve are not being underestimated.

King described his movement here as "...a non violent social revolution, which seeks to dramatize its issues...We are not perfect, we will make mistakes, we are not omniscient or omnipotent...and we need a great deal of support."

According to the source, Levison told Jones that he had met with Harry Wachtel and Mrs. Wachtel and that Mrs. Wachtel is no longer thinking about running the Foundation. Levison stated that he talked Wachtel into getting an Executive Director.

The source further advised that Levison indicated he was working at getting someone to work for the Foundation and that he intended to meet with Wachtel again to continue the organization of the Foundation. Jones stated that he also would attend the meeting with Levison and Wachtel.
