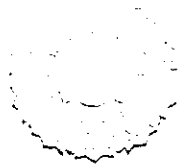

Conference; Al Raby of the Coordinating Committee of Community  
Organizations [REDACTED]

[REDACTED] indicated that it was anticipated that a crowd of some 5,000  
persons would have attended.

[REDACTED] call off the rally was made as a  
result of the recent rioting on Chicago's west side, and no  
date has been set for rescheduling of this rally, and it  
is not anticipated that such a rally will be held in the near  
future.

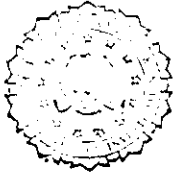

Reference is made to Chicago memorandum dated July 15, 1966, under this caption.

[REDACTED] b7(D)  
[REDACTED] advised the Chicago Federal Bureau of Investigation Office during the evening of July 16, 1966, that on this date no representatives of the CFM - SCLC had appeared at Gage Park, Chicago. He stated, however, that a mixed group of approximately 150, both Negro and white, had appeared at Marquette Park, Chicago, during the hours of one to six p.m. Marquette Park is located Southwest of the Gage Park area, in the general vicinity of 67th Street and Kedzie Avenue (3200 West), Chicago. Brown advised that the Police Department on the scene had felt certain that this group was representative of the CFM - SCLC, although no prominent or well-known civil rights figures were observed to be present. This group utilized all park facilities, departed peacefully and there were no incidents or arrest during the afternoon.

[REDACTED] advised that information [REDACTED] reflected that this group plans to visit churches in the Gage Park area on Sunday, July 17, 1966, with a prayer vigil and possible march scheduled for that afternoon, the march understood to be led by MARTIN LUTHER KING, JR., President, SCLC.

[REDACTED] advised the Chicago Federal Bureau of Investigation Office on the evening of July 17, 1966, that a prayer vigil was held Sunday afternoon in the Gage Park area by approximately 150 representatives of the CFM - SCLC. He advised that no arrest had occurred in connection with this matter, that there had been no march in the area and that Dr. King had not been present in connection with the prayer vigil.

The pertinent portions of the above information were furnished on July 16, and 17, 1966, to representatives of Region I, 113th INTC Group, Evanston, Illinois, and to Secret Service, Chicago. A copy of this memorandum is being provided to the office of the United States Attorney, Chicago, Illinois.

In connection with the prayer vigil held July 17, 1966, in the Gage Park neighborhood on Chicago's South side, an article appeared in the July 18, 1966, edition of the "Chicago Sun Times," a daily Chicago newspaper. The article noted that some 200 white and Negro civil rights demonstrators were jeered and taunted Sunday by 50 white teenagers at a South side prayer vigil. The prayer vigil was held at 55th and Kedzie, Chicago, location of the St. Gall Roman Catholic Church. The demonstrators were described as part of the action program, developed by the Chicago Freedom Movement, following the July 10, 1966, Freedom Rally at Chicago's Soldier Field, with Chicago's Gage Park area having been chosen as an initial target for testing of alleged racial barriers in Chicago.

The marchers sang and prayed while white youths greeted them with shouts of "go talk to the police captain who got shot in the back," and "why don't you go down to 12th Street where you can do some good," these remarks in reference to the rioting which took place on Chicago's West side during the past week.

After the prayer vigil at St. Gall, the group returned to the area of 55th and Rockwell Street (2600 West) where they dispersed without further incident. This vigil had been preceded, according to this article, by an action program on Saturday in Marquette Park, where approximately 120 persons, mostly Negro, picniced during the hours of 11 a.m. to 5 p.m. At this park, used only by whites before that date, the article noted that some whites had joined the picnickers in sport's activities, this according to Reverend Jesse Jackson, associated here with the Southern Christian Leadership Conference.

Reference is made to Chicago memorandum of July 14, 1966,  
captioned as above.

A confidential source who has furnished reliable information  
in the past advised the Chicago Office of the Federal Bureau of  
Investigation (FBI) on July 14, 1966, that between the hours of  
4 p.m. and 5 p.m. on this date about 100 persons, both Negro and  
White, held a meeting at the New Friendship Baptist Church located  
at 844 West 71st Street in Chicago, Illinois. This meeting was  
led by Reverend James Bevel and Jesse Jackson who are associated  
with the Southern Christian Leadership Conference, (SCLC). This  
meeting consisted of a discussion on ways and means of integrating  
the general area of Gage Park, in Chicago, Illinois.

This source further advised that at 5 p.m. on this  
date the group departed the New Friendship Baptist Church and proceed-  
ed to the Mark Realty Company located at 3018 West 63rd Street,  
in Chicago, Illinois. While at this realty company the group regis-  
tered a complaint by this realty company's past refusal to serve  
Negroes, and thereafter left peacefully and proceeded to Marquette  
Park located at 67th Street and South Kedzie Avenue. While in  
Marquette Park the group proceeded to play ball, the purpose of which  
was to protest integration conditions in this area.

This source advised the group then proceeded to the Soltes Realty Company, located at 3534 South Kedzie, Chicago, Illinois, which office closed. Leaders of this group then announced that a meeting would be held this evening at the New Friendship Baptist Church to discuss further plans concerning the integration of the Gage Park area and further activities of this group. b7(D)

On July 14, 1966 [REDACTED]

[REDACTED] advised the Chicago Division of the FBI that the above demonstration at all locations was peaceful and that there were no incidents or arrests.

On July 14, 1966, a second source, who has furnished reliable information in the past, advised that this group held a meeting as planned in the New Friendship Baptist Church at approximately 7:30 p.m. of this date. This meeting was led by Dr. Martin Luther King, Jr., President, of the SCLC. King talked in general on the integration problems in Chicago, Illinois, and stated at this meeting that Chicago must be an open city to Negroes and that this open city must be obtained through non-violence. Approximately 1000 persons were present at this meeting at which meeting it was announced that this group would shop in the general Gage Park neighborhood on July 16, 1966, and would hold a picnic on July 16, 1966, in the general location of the Gage Park neighborhood. It was also announced at this meeting that on July 17, 1966, representatives of the Chicago Freedom Movement would visit churches in the Gage Park neighborhood and would thereafter hold a prayer vigil in Gage Park. b7(D)

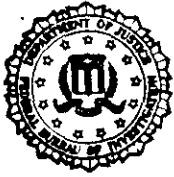

On July 12, 1966, a confidential source, who has furnished reliable information in the past, learned that on that date, Martin Luther King, Jr. and Stanley Levison discussed the Freedom Movement rally held in Soldier Field, Chicago, Illinois on July 10, 1966. King stated that the rally was attended by 60,000 people although the police estimate was 30,000. Both King and Levison felt the the rally went well.

King said that he wanted to discuss with Levison the starting of the "Action Program", noting that, as usual, they are confronted by financial problems. He added that he is convinced that there is money to be obtained in Chicago, that it is just a matter of organizing. He felt that most of the churches there would support them as well as social clubs. He said that they firmly believe there is \$50,000 to be obtained in Chicago if they organize to get it. King remarked that there is a lot of money in the white community 3 which they have not "tapped" and that these people would give if you could get to them.

King told Levison that he was thinking about getting Bill Stein (an SCLC fund-raiser in New York) to spend a month to six weeks in Chicago organizing a fund-drive (among the churches). He said that if situations arise 5 where Stein needed a front-man they could provide a Negro for it. Levison inquired if King could get a Negro preacher

to work with Stein adding that Stein could do the job and would, he believes, be happy to go to Chicago for this purpose. S

Levison commented that it is necessary to raise the money in Chicago because they (the SCLC) cannot make an appeal somewhere else for Chicago. He said the attitude would be that they (the SCLC) could raise it in Chicago, that there are churches there. Levison continued that he would discuss it with Stein, that he does not see why it cannot be done. Levison noted, however, that it meant rearranging the plans he had. He said he wanted Stein to work on a dialogue for foundations (Levison's hope to raise funds from foundations) and that they already had drawn up a prospectus. He added that he would have to take this over himself and handle the foundations. S

King inquired if Levison could work on this and get it to Chicago by Monday (July 18, 1966). Levison said it could not be done that way because, in dealing with foundations, it is necessary to make appointments with the directors at their convenience. He said he had wanted Stein to meet with them. Levison stated that he believes that foundations are now the places to go and that he cannot think of any other source today that should be more interested in the balanced approach King has. He said he is anxious to make as many of these approaches as possible. S

At 8:15 PM, July 12, 1966, [REDACTED] b7(c)  
[REDACTED] Chicago Police Department,  
advised the Chicago Federal Bureau of Investigation office  
that a disturbance was then in progress in the vicinity of  
Roosevelt Road and Throop Street, Chicago, generally in an  
area of approximately 1200 south between Racine Avenue,  
1200 west, and Ashland Avenue, 1600 west, on the near south-  
west side. This disturbance had erupted on the occasion of  
the closing by officers from the Chicago Police Department's  
12th District of an illegally opened fire hydrant at the inter-  
section of Throop and Roosevelt, where neighborhood youths  
were utilizing the hydrant due to the extremely hot weather.  
The youths objected to this closing by the police squad car  
involved, became unruly and when the police officers attempted  
to arrest several youths involved, a neighborhood crowd began  
to gather, commenced harrassing and stoning the police officers,  
who then called for assistance. With the arrival of police  
reinforcements, seven Negro youths, all minors, were taken  
into custody by the Police Department and removed to the 12th  
District station.

As a result of these arrests the crowd in the neighborhood had continued to grow in size, became disorderly, with some present beginning to smash store windows and loot stores, this in the vicinity of Roosevelt and Throop, and subsequently at a shopping center at 1300 West Racine Avenue, in this immediate area.

[REDACTED] Chicago Police Department, advised at 8:35 PM that the disturbance in this area was continuing with numerous reports being received by the 12th District of looting, window breakage and individual acts of vandalism in the general area of Throop Street and Roosevelt Road. The crowds were becoming increasingly unruly and had begun widespread stoning of police and other vehicles in the area, particularly those with white occupants. As a result of this stoning, several injuries had been reported. Reports were now rampant in the area of the disturbance that molotov cocktails would be utilized by the crowd, then generally milling about the disturbance area for several blocks in various directions. Police reinforcements were being called into the area with Plan 6 having been put into effect, calling for the maximum usage of available police manpower in an emergency situation. b7(c)

A confidential source, who has not been contacted a sufficient number of times to determine his reliability but who is knowledgeable regarding the general west side area of the disturbance, advised at approximately 10:00 PM July 12, 1966, that he had visited the area of the disturbance then in progress. He advised that he had learned that one of the reasons for the gathering of the large crowds here, and the general unrest, was because of rumors circulating the general area that a number of the Negro youths originally arrested during the water hydrant incident had been beaten by Chicago police officers of the 12th District. The source advised that he had no knowledge as to the veracity of these rumors, however, attempts were being made by representatives of the community groups in the area to get those arrested released so the rumors could be effectively squelched. These attempts were unsuccessful to the source's knowledge at this point.

[REDACTED] advised at 10:30 PM that at this point the Chicago Police Department had approximately 80 units in the disturbance area, attempting to cope with the sporadic outbursts of looting, window breaking and occasional use of molotov cocktails, all prevalent in this area. The Police Department had on hand at this point in excess of 300 police officers attempting to control this situation. b7(c)

At 11:00 PM [REDACTED] advised that representatives of the Southern Christian Leadership Conference (SCLC) were in the general area of the disturbance attempting to calm the crowd and restore order. He advised that Dr. Martin Luther King, Jr., Reverend James Bevel and others associated with the SCLC had been at a neighborhood church meeting near the area where the disturbance had arisen and on learning of the disorder had advised police authorities in the area that they would exercise every effort to assist in the dispersing of the crowd and calming the neighborhood. b7(c)

[REDACTED] advised that the situation at this point, however, was such that commanding police officials on the scene were considering a request for use of heavy equipment, shotguns and tear gas to be utilized in controlling the disorder. [REDACTED] advised that the disturbances continued to appear to be aimless in direction, with most participants being teenagers, with sporadic outbursts of vandalism, damage to property, stoning of cars, and crowds of several hundreds milling about the general area. He advised that several youths had been arrested in possession of molotov cocktails with one police squad car having been struck by two of these inflammatory devices. The resultant flames had been extinguished by the officers occupying the squad car before any extensive damage had resulted. The individuals responsible for this particular act had not been apprehended.

At 1:30 AM, July 13, 1966, [REDACTED] Police Department [REDACTED] in the area embracing the disturbance, advised that the entire area was now considerably quieter with police officers using sweeping tactics in an attempt to clear the streets. Large numbers of people continued to remain in the area but the vandalism, looting and window breaking had been halted and the situation was considered to be under control by the Police Department. General traffic in the area continued to be diverted and the Police Department continued to employ some 50 mobile units in the area. b7(c)

At 3:30 AM [REDACTED] advised the area was now calm, the streets were clear and the Police Department had released emergency forces called to control the disturbance. Officers from the 12th District continued to afford the area extra coverage to avoid a renewal of disorder and were answering more than the normal number of burglar alarms, this primarily the result of broken windows in stores in the general area. b7(c)

As of 8:00 AM, July 13, 1966, [REDACTED] advised that the disturbance area continued to be quiet with no additional vandalism, incidents or disorders having occurred during the early morning hours. Broken windows in the area have been boarded up, however, there is no comprehensive damage estimate available at this time and the number of possible injuries to civilians and persons passing through the area was not completely known. Preliminary reports [REDACTED] have indicated, however, according to [REDACTED] that much less looting took place than had been believed. [REDACTED] advised that during the early morning hours of this date a Chicago police officer had been wounded in the left wrist apparently by a gunshot, from an unknown assailant while patrolling along Roosevelt Road in the disturbance area. The officer had been treated in a nearby hospital and was not in serious condition. [REDACTED] was unaware of any other serious injuries to Police Department personnel as a result of the disturbance. b7(c)

[REDACTED] continued that the disturbance area will continue to receive special attention from the Chicago Police Department in order to preclude any further violence. He advised, however, that with the tension obviously running so high in the disturbance area, together with the continued extremely hot weather, he feels further trouble must be considered a definite possibility.

[REDACTED] Chicago Police Department, attached to the Corporation Counsel's Office, Chicago, advised on July 13, 1966, that the best available Police Department records concerning arrests for the previous evening reflected the following individuals had been taken into custody: b7(c)

[redacted] advised that these individuals, all young Negro males, address not available, had been released at approximately midnight in an attempt on the part of the Police Department to calm the situation.

[redacted] no address, had been arrested on a charge of possession of molotov cocktails, and [redacted] had been arrested as a suspected looter.

[redacted] advised that additional individuals who had been arrested during the course of the evening's disturbance on disorderly charges were as follows:

These individuals had all been released at approximately 4:00 AM from the 12th District police station when no City officials or police authorities had appeared to sign complaints against them by that time.

Additionally arrested early during the evening of July 12, 1966, was [redacted] Chicago, on charges of obstructing a police officer and disorderly conduct. [redacted] was suspected of being one of the initiators of this incident through his appeal to individuals in the vicinity of Roosevelt Road and Throop Street, Chicago, concerning the police treatment of young Negroes involved in the water hydrant incident.

It might be noted in this connection that the "Chicago Tribune," a daily Chicago newspaper, in an article concerning this disturbance quoted the two police officers involved in the turning off of the water hydrant at 1233 South Throop Street during the evening of July 12, 1966, to the effect that [redacted] had immediately stepped

up to the water hydrant and reopened it. When they had attempted to place him under arrest he had turned to the gathering crowd and shouted, "You're not going to let these policemen arrest me? Why don't you do something about it?"

[REDACTED] advised the Chicago Office of the Federal Bureau of Investigation on June 9, 1966, that Dr. Martin Luther King, Jr., President, Southern Christian Leadership Conference (SCLC) arrived in Chicago, at O'Hare International Airport, at approximately 10:12 PM on this date, via Delta Airlines Flight 762, from Memphis, Tennessee. [REDACTED] advised that King arrived from Memphis, participating there in the Voter's Registration March in progress from Memphis to Jackson, Mississippi, returning to Chicago in this instance for an anticipated 2-3 day stay to coordinate local SCLC activities. King was met at O'Hare Airport by Albert Raby, Head of the Coordinating Council on Community Organizations (CCCO), which organization is affiliated here with the SCLC. At present there was no information available to O'Malley concerning King's activities during this stay in Chicago.

On June 10, 1966 [REDACTED] b7(D)  
[REDACTED] advised the Chicago Federal Bureau of Investigation (FBI) Office, concerning King's activities here, that on the evening of this

date King was to appear at a SCLC Rally being held at the Warren Avenue Congregational Church, 3101 West Warren Avenue, which rally was for the purpose of raising funds to send an as yet undetermined number of bus loads of demonstrators from Chicago to Mississippi, to support the Voter's Registration March in progress there. On June 11, 1966, King is to participate in a SCLC Workshop to be held at Chicago's Sheraton Hotel, revolving around the participation of Chicago Negro youth and street gangs in the SCLC freedom movement here. Space has been reserved at the Sheraton Hotel for this workshop by the Unitarian-Universalist Church, Midwest Region Office, 5711 South Woodlawn Avenue, Chicago. [REDACTED] continued that during the day of June 11, 1966, King is to appear at a luncheon sponsored by the Midwest Regional United Automobile Workers Union, where WALTER REUTHER, UAW President, is also to be a speaker. [REDACTED] concluded that although no specific departure time for King from Chicago has been established, the Chicago Police Department is assuming that King will depart Chicago, most probably for Memphis, Tennessee, during the evening hours of June 11, 1966. b7(D)

Concerning the above activities of King, a confidential source, who has furnished reliable information in the past, advised on June 11, 1966, that King did not appear as scheduled at the June 10, 1966, fund raising rally at the Warren Avenue Congregational Church. The source advised that King is in Chicago at the present time, however, it was determined that during the evening hours of June 10, 1966, he was detained at another appointment, place or nature unknown, and was unable to appear at this affair.

On June 13, 1966, [REDACTED] b7(D)  
[REDACTED], advised that information only recently available to his Unit reflects that during the morning hours of June 11, 1966, King and a number of his SCLC aides, together with CCCO representatives met at the Corpus Christi Church, 4926 South Parkway, Chicago. At this meeting the decision had been made to postpone the June 26, 1966, mass rally planned for Chicago by King and the SCLC, the rally now scheduled to take place July 10, 1966. No additional changes were made in the plans for this rally as to content and organization, however, it was felt that because of the pressure built up during the past week of events in Mississippi, surrounding the shooting there of James Meredith, such a postponement was necessary.

Concerning the June 11, 1966, appearance of King at the UAW luncheon, LaSalle Hotel, Chicago, an article in the June 12, 1966, edition of the "Chicago Tribune" a daily Chicago newspaper, contained in summary the following information:

King and Reuther were the principle speakers at the Region 4, UAW affair, both commenting on the similarity between the labor and civil rights movements in this country. Reuther called upon his union to help build "the great society" by raising human rights above property rights. King stated that the civil rights and labor movements are inextricably bound together, and that the forces which are anti-labor are in almost all cases also anti-negro. He praised the UAW for "embodying principles of civil rights", noting that many of the foremost civil rights weapons, such as the sit-in, the picket line, and the demonstrations are being used in the civil rights movement because of the past successes unions have had with these tactics. King announced further that the proposed civil rights freedom rally, which was to have been held at Soldier's Field, followed by a march on Chicago's City Hall, on June 26, 1966, has been postponed to July 10, 1966. He commented in this connection that the march presently being held in Mississippi takes precedence over all other events in the civil rights movement.

Further concerning the postponement of the June 26, 1966, rally and march in Chicago an article in the June 12, 1966, edition of the "Chicago Sun Times" specifically related to this matter. King was quoted as having stated as follows: "The cowardly attempt on the life of James Meredith has created a national emergency, which has focused our immediate energies on Mississippi. This in no way diminishes our effort to end the slums in Chicago ....which is an extension of Mississippi. In Mississippi, Negro civil rights workers are physically lynched or mis-treated. In Chicago, Negroes are spiritually murdered and mis-treated." King added that it has always been basic to the civil rights movement to meet an act of violence with an immediate massive display of non-violent direct action.

In connection with the June 11, 1966, SCLC Workshop at the Sheraton Hotel in Chicago, the June 12, 1966, edition of the "Chicago Sun Times" contained an article entitled "Gang Leaders Asked to Join King's Movement Here". The article in summary set forth the following:

On Saturday, June 11, 1966, King called upon approximately 50 leaders of Chicago street gangs to "organize together" with the civil rights group, the SCLC, to fight poverty, slums, "and the power structure that makes them possible". The gang leaders had gathered together for a "first annual gangs convention". A picture of an unjust society was painted for these gang leaders, who were asked to join together to fight those evils non-violently. Chief among the evils detailed for them were those of slums, poverty, and police brutality.

Among some of the gangs represented were the "Vice Lords" from Chicago's West side; the "Disciples" from the Woodlawn area of the South side; the "Disciples" from the Englewood area on the South side; the "Del Vikings" from the South side and the "Peacemakers" from Chicago's North side. This meeting was coordinated by the Reverend A. R. Sampson, described as one of Dr. King's chief Chicago lieutenants, who is in charge of SCLC's attempt to involve gang members in civil rights activities.

The article noted that SCLC efforts to get the "Blackstone Rangers" have come under fire from social workers and the Chicago Police Department, who contend that gang members are being "incited to violence" instead of being taught non-violence. Various speakers urged gang members to realize that they are not each others enemy. The real foe was "the system", which was said to include Chicago's Mayor Daley, the Chicago Police Department, local school administrators, slum landlords, businessmen and the like. It was pointed out that when a case of police brutality or a fatal slum fire takes place "the man on top is as responsible - he is as guilty, as much a criminal - as one of us who puts a blade on someone." Sampson proposed the establishment of a Community of Police Service (COPS) to "pressure the system" for a change in the attitude and approach of the Police Department to the gangs.

The article quoted King as stating to those present "if we are to deal with our problems, we have to get power and power in Chicago is being so well organized that we can get the most powerful political organization in the country to say 'yes' when it wants to say 'no'". King also was noted as having invited all gang members to participate in the July 10, 1966, mass rally and subsequent march on Chicago's City Hall. He stated that the marchers at this time will place a number of demands before Chicago's Mayor Daley for improvements in the city's approach to those minority groups, calling for a "massive Marshall Plan" for Chicago's poor,

During the course of the work on the Urban Training Center, a local cooperative project of ministerial groups, volunteered its services to the gangs, offering to attach workers to each gang to help them in drawing up particular areas, buildings and police incidents.

On June 12, 1966, [REDACTED] advised that information available to his Unit reflected that Dr. King had departed Chicago at approximately 3:15 PM on this date for Atlanta, Georgia, although [REDACTED] considered it possible that King might in fact have Memphis, Tennessee as his ultimate destination, in view of his stated intention of periodically taking part in the Memphis to Jackson Voter's Registration March. b7(D)

[REDACTED] advised that there had been no incidents or disorders in connection with Dr. King's presence in Chicago during the period June 9 - 12, 1966.

On June 10, 1966, a confidential source, who has furnished reliable information in the past, ascertained that Harry Wachtel made arrangements with Stanley Levison to attend an SCLC meeting in Atlanta, Georgia, on June 13, 1966. Wachtel told Levison that he had heard from Dora (Mc Donald, Secretary to Martin Luther King, head of the SCLC) that King would be coming back from Mississippi very late (on Sunday, June 12) and that "they" want the meeting to be held beginning on Monday morning. Levison stated he preferred to leave Sunday night, June 12, and they agreed he would take the 6:25 p.m. Delta Airlines flight to Atlanta. Wachtel said he would leave on Monday morning.

This source also ascertained on June 10, 1965, that, on that date, Clarence Jones and Stanley Levison discussed the SCLC meeting to be held in Atlanta on June 13. Levison stated that the meeting was going to be concerned with finances and would be based on a memo he sent King several weeks ago in which it was stated that only about half the income that was anticipated will come in. He added that they would be using the entire year's budget in the first six months and will have an impossible crisis. Levison said he pointed out that while "they" keep talking about a reserve, it is not a reserve, because \$100,000, which amounts to one month's budget, cannot be called a reserve since it does not permit the solving of any problems.

Levison said that they must discuss what kind of fund-raising programs are now necessary and that he was going to propose that King has to resume "the old rallies in the cities."

Jones brought up the matter of "church rallies" and said that George Lawrence (New York representative of the SCLC) has become active again. He said that there was to be a big leaflet distribution dealing with James Meredith and Mississippi on Sunday, June 12, to all the churches and that it was being done by Lawrence and other ministers. Jones and Levison agreed that the only time Lawrence is heard from is when something newsworthy occurs and he can get his name in the press. They agreed to use him, however, if Lawrence could in any way be a force with the churches. Levison said that Lawrence usually is mostly talk.

The discussion changed to the matter of the march to Jackson, Mississippi, with Levison stating that he had been told that "they" planned 16 days for the march which would get to Jackson on the 22nd or 23rd of June, where there would be a large rally similar to the one held in Montgomery, Alabama. Levison said he has considered joining the march the last couple of days and Jones indicated he would like to do the same. They agreed that something should be done about getting delegations to join the march. 3

Levison stated the biggest attention will be given to what takes place in Jackson and that he is fearful that the march will dwindle to a handful if it continues for too long. He said this could not be allowed to happen and agreed with Jones that the emphasis should be on getting people to join. He added that a maximum number of people could be gotten only for the day in Jackson because of a lack of facilities to take care of a large number on a day or two of marching. 7

Levison told Jones that the SCLC was requesting that people be sent, noting that Dora (Mc Donald, Secretary to Martin Luther King) advised him that the United Steel Workers inquired if people and money were needed. He noted also that the United Automobile Workers Union had offered help. 2

Jones felt that a person such as Hellstein (Phonetic) (Ralph Hellstein, of the Packinghouse Workers Union) should be given some responsibility. Levison agreed that a Hellstein could lead a delegation of important trade unionists, that a Hellstein could do such things as put up the money to charter a plane from Chicago. 5

They decided to get together on Sunday, June 12, to discuss these matters. S

Upon arriving in Jackson, as now planned, there will be a big rally similar to the one in Montgomery, Alabama, which was held following the Selma to Montgomery march last year. 4

As for people who desire to go down to march, Levison instructed Robison (Phonetic) to tell them to go to the Centenary Methodist Church, Mississippi Boulevard, Memphis, Tennessee, and from there they would be provided transportation to the point of march. 2

As for his own plans, Levison said he would join the march prior to its completion. In addition to himself, Levison said Paul O'Dwyer (former New York City politician and brother of one time Mayor O'Dwyer of New York) would also go down to join the march. 5



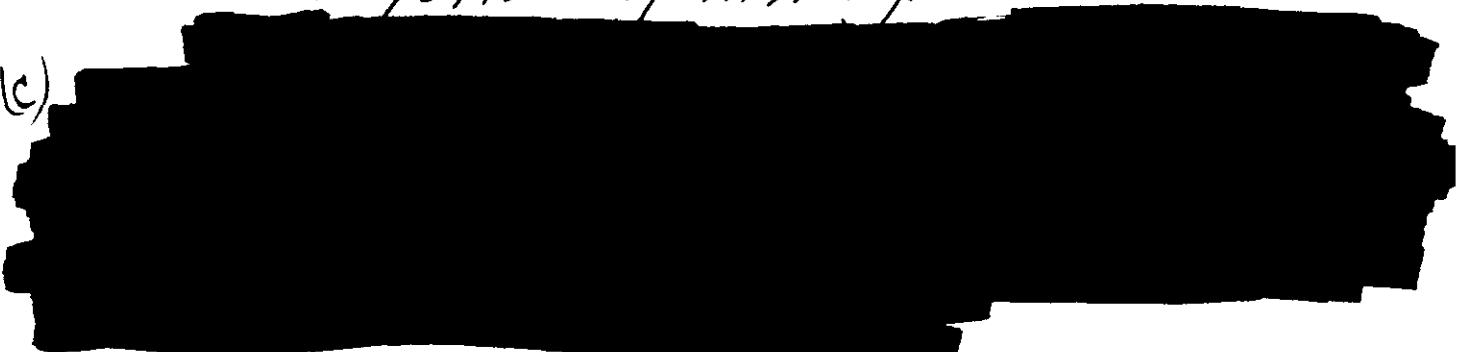

Reference is made to Chicago memorandum of May 27, 1966, captioned, "Planned Civil Rights March From Soldiers Field to City Hall, Chicago, Illinois, To Be Led By Martin Luther King, Jr., June 26, 1966, Racial Matter."

The "Chicago Daily News," a daily Chicago newspaper, edition of June 8, 1966, contained a headlined article entitled, "King Plans Sweeping 'Open City' Demands." This article pertained to demands which would be made by Dr. Martin Luther King, Jr., President, Southern Christian Leadership Conference (SCLC), during the course of the civil rights rally and march to be held in Chicago on June 26, 1966, to be led by Dr. King.

In summary, this article contained the following information:

A draft outline of the proposals to be made by King ranged from school desegregation in Chicago, to a call for a city income tax, to a demand for better rapid transit service. A document entitled, "Chicago Freedom Movement Demands

"For Creating an Open City," was distributed on Tuesday, June 7, 1966, at a meeting of civil rights workers in Chicago who are organizing the June 26th rally. According to this newspaper article, this document draws together for the first time all of the civil rights and welfare demands Dr. King has been saying he will make as a result of the Chicago Freedom Movement which the SCLC initiated in Chicago in the fall of 1965.

The newspaper article pointed out that if the demands made by King are met this would virtually upend the city's concept of how and to whom it provides public services and facilities. The demands are broken into five broad categories, at the city, state, and federal level, inclusive of jobs and income, housing, education, public welfare, and health.

At the local level, according to this article, the draft outline of King's demands would request that the Chicago authorities do the following:

1. Integrate all school faculties and high school student populations by the fall of 1966, to be followed by the integration of the entire school system by September, 1967.
2. Expand Rapid Transit facilities to the areas of O'Hare Airport and Chicago's northwest side to provide access for Negroes to jobs and housing in that area.
3. Be given permission by the state to levy a personal income tax.

On the federal level, King's demands include that for a guaranteed annual wage, a \$2.00 per hour minimum wage, open occupancy laws, more aid to education, and expanded health services.

The article continued that King desired the state to finance a network of homes for children with severe learning problems and to require the teaching of the history of Negroes in America as part of regular history courses.

In the area of jobs and income, King desired that city authorities do the following:

1. Conduct a public racial headcount in all its agencies and give "special attention" to promoting qualified Negroes to higher paying positions.
2. State publicly the racial headcount in "all agencies from which the city purchases anything" and from their contractors, and demand fair employment practices in all companies providing goods and services to the city.
3. Remove city funds from banks that refuse to grant mortgage loans to Negroes.

In housing, King would request the following of local authorities:

1. Disperse Negroes throughout the city and "sponsor" ten "new towns," each with a population of 100,000 and a 30 percent Negro residency.
2. Protect tenants who refuse to pay rents when "certain basic services are not provided."
3. Allocate police, fire, garbage collection, schools, and other services according to density of population.
4. Build 10,000 low rent public housing units a year, scattered throughout the city, and adopt New York City's program of making emergency repairs in slum buildings and using rents from landlords to pay for them.

In the field of education, King would demand the following actions:

1. Immediate publication of achievement scores of all schools.
2. Doubling the school budget.

3. Have Negro representatives on the Board of Education in proportion to the school population. (Now slightly more than 50 percent).

The article continued concerning this document, that King is requesting various welfare agencies to put an end to their night investigations, to substitute affidavits for the meanstest and allow welfare recipients to be represented by welfare unions.

Also being called for is an expansion of pre-natal and child health services and hospital out-patient facilities.

This article concluded, quoting this document, that the rally on June 26, 1966, and subsequent march on city hall, is designed to "convince people that mere concessions are not enough. You do not dole out freedom on a teaspoon."

ReAirtel and letterhead memorandum dated 6/10/66, indicating that the office of the Southern Christian Leadership Conference had been contacted by a representative of the National Emergency Committee of Persons Concerned About Vietnam, and that the contact was sanctioned by Mr. Lynd Madison of St. Louis.

Bufiles contain no identifiable information relative to the above committee or Lynd Madison. Also, the Bureau has received no information relative to the document being prepared by professors at Berkeley, California, which will be forwarded to President Johnson by the above committee.

The San Francisco office should immediately advise the Bureau of all information in its possession relative to the activities of the professors at Berkeley in the preparation of the above paper relative to Vietnam, and specifically, the identity of organizations and individuals behind it.

The St. Louis office should immediately furnish identifying information to the Bureau and the Atlanta and San Francisco offices relative to Lynd Madison. This check should be limited to identifying data and check of office files.

The Atlanta office should remain alert for any additional contacts by representatives of the above committee, and furnish the Bureau all pertinent information relative to such contacts, and whether King definitely decides to support the activities of the committee.

All pertinent information should be promptly submitted to the Bureau in a form suitable for dissemination.

The June 1, 1966, Four Star Final edition of the 'Chicago Daily Sun-Times,' a Chicago, Illinois, daily newspaper, carried a photograph on page eight which was captioned, "King, Monk Seal Bombing End." The photograph was that of Dr. Martin Luther King, Jr., and Buddhist monk Thich Nhat Hahn of Viet Nam, who, the caption continued, held a joint press conference at the Sheraton-Chicago Hotel where "both men called for an end to bombing in Viet Nam and for internationally supervised free elections. This caption described Hahn as the leader of the Buddhist Youth for Social Service in Viet Nam, whose visit in the United States is sponsored by the International Committee of Conscience on Viet Nam of the Fellowship of Reconciliation. King was described as a convener of this latter group.

The "Chicago Tribune," another Chicago daily newspaper, reported its coverage of this press conference in an article captioned, "King Equates Rights Fight with Monks," which appeared on page three, of the June 1, 1966, Three Star Final edition of this publication. In addition to the comparison referred to in the title, this article reported that Martin Luther King, Jr., had expressed sympathy for the five Buddhists who had recently burned themselves in protest against the Nguyen Cao Ky government in South Viet Nam. This article reported that Thich Nhat Hahn, a Buddhist monk touring the country under the sponsorship of the American Friends Service Committee, appeared with King at this press

conference. It was reported that Hahn, who said he was under a death sentence in Viet Nam for speaking out against the Ky government, was touring the United States to promote peace in Viet Nam. According to the article, Hahn had maintained that the Vietnamese people cannot get along with the Ky government and wanted an independent country free from outside influence. Hahn said that the Vietnamese are opposed to communist "just as much as we are opposed to other countries dictating what form of government we should have." It was also reported that the monk had asserted "that the Vietnamese people, who he said are eighty per cent Buddhists, have given up all hope of elections as long as Ky is in power. He said that most Vietnamese feel that the United States is strongly backing Ky to hold off the elections."

Continuing, the article said that King, who had been conferring with the Buddhist monk during the day, suggested an immediate cessation of bombing as a prelude to peace talks. He emphasized; however, that he did not think the U. S. was doing enough to establish peace negotiations. Neither Thich Nhat Hahn nor Viet Nam were mentioned in the remainder of this article regarding the press conference.

The Red Star edition of the "Chicago Daily News," another Chicago daily newspaper, on June 1, 1966, contained an article on page 14 which was captioned, "Ky Critic Fears Execution on Return, Buddhist Monk Speaks Here for Peace." This article reads as follows:

"Thich Nhat Hanh may face execution by the Nguyen Cao Ky government or assassination by the Viet Cong when he returns to South Viet Nam from Chicago this month.

"The reason, the Buddhist monk says, is that he is critical of both sides in the war while on his U.S. tour to plead for peace in Viet Nam.

"The law of Premier Ky says that any Vietnamese who speaks aloud for peace may be executed in the Saigon market place," he said in a prepared statement.

"Thich Nhat Hanh (pronounced tick-not-hahn) said the people of Viet Nam want a prime minister who is 'able to represent the real aspirations of the people.'

"On the other hand, he said in a press conference here, 'We Buddhists are very aware of the Communists...we want a non-Communist Viet Nam.'

"The conflict, he emphasized, is more of a psychological struggle than a military one.

"'We can win the war only if we win the people,' he said.

"Thich Nhat Hanh is director of the School for Social Studies at Van Hanh University in Saigon and director of Youth for Social Service, a Buddhist-directed 'peace corps' program.

"He conferred here with the Rev. Dr. Martin Luther King, Negro civil rights leader and Nobel Peace Prize Winner.

"In a joint statement at the conclusion of their meeting in the Sheraton-Chicago Hotel, they referred to the self-immolation of Buddhists in Viet Nam.

"'We believe that the Buddhists who have sacrificed themselves like the martyrs of the civil rights movement, do not aim at the injury of the oppressors but only at changing their policies,' the statement said.

"'The enemies of those struggling for freedom and democracy are not men. They are discrimination, dictatorship, greed, hatred and violence, which lie within the hear of man. These are the real enemies of man--not man himself.'

"Thich Nhat Hanh's 30-day visit to the United States in May and June is being sponsored by the International Committee of Conscience on Viet Nam of the Fellowship of Reconciliation, a world-wide organization of clergy and laymen working for peace in Viet Nam.

"Dr. King was one of the convenors of the committee in the United States. Thich Nhat is the only member of the committee in South Viet Nam.

"His name hitherto was not revealed by the committee because speaking out for peace in South Viet Nam is considered treason.

"Thich Nhat Hanh, in a letter last year to Dr. King, said the self immolation of Vietnamese Buddhists is not suicide nor 'even a protest.'

"He said the self-immolations were aimed 'only at alarming, at moving the hearts of the oppressors and at calling the attention of the world to the suffering endured by the Vietnamese.

"'In the Buddhist belief,' he added, 'life is not confined to a period of 60 or 80 or 100 years; life is eternal. To express will be burning oneself, therefore, is not to commit an act of destruction but to perform an act of construction that is to suffer and die for the sake of one's people.'

"His appearance here was sponsored by the Greater Chicago Emergency Committee of Clergy Concerned About Viet Nam and the American Friends Service Committee."

This article reported that an ecumenical service of peace was to be held on Memorial Day, May 30, 1966, at the Rockefeller Chapel, University of Chicago campus, under the sponsorship of the Greater Chicago Emergency Committee of the Clergy Concerned about Viet Nam. The article reported that the Greater Chicago Emergency Committee is one of about one-hundred regional groups associated with the National Emergency Committee of Clergy Concerned About Viet Nam. This group, according to an April statement of its steering committee, "desires to be of assistance especially to religiously concerned Americans in developing responsible attitudes and actions regarding the conflict in Southeast Asia. We shared the anguish of all who lament the death and destruction caused by a war which lacks the marks of justice and is self-defeating."

This article continued that the Greater Chicago Emergency Committee in accord with a policy of the national group was appealing to President Johnson and Congress to "reinstate cessation of bombing in North Viet Nam, press for a negotiated peace, including discussions with representatives of the National Liberation Front," and "resist all pressures for an escalation of the war."

The article then reported that one of the participants in this service would be a senior Buddhist monk from South Viet Nam, Thich Nhat Hanh, who would read a Buddhist prayer. Thich Nhat Hanh was said to be presently on a tour of the United States and in addition to his appearance at Rockefeller Chapel would also discuss the situation in Viet Nam at a public meeting Tuesday, May 31, 1966, at 8:15 p.m. in Breasted Hall.

The list of the participants in this service contained the names of many prominent Chicago church and church association leaders.

[REDACTED] advised on June 2, 1966, that the appearance of Thich Nhat Hanh which was scheduled at Breasted Hall, Tuesday, May 31, 1966, had been moved to Mandel Hall, also on the University of Chicago campus, so that a larger attendance could be accommodated. [REDACTED] advised he had received no information regarding details of this reported discussion type meeting other than having been informed that it was an orderly affair.

Thich Nhat Hanh and Professor Robert S. Browne were guests on the Jerry Williams Radio Show, Station WBBM, Chicago, during the evening of Monday, May 30, 1966. This program, which includes a telephone question period, is heard nightly from 8:00 p.m. until 11:00 p.m., Tom Clark substituted for Jerry Williams as the moderator of this show on this date.

Clark announced the topic for discussion on this program would be the "current crisis in Viet Nam." He introduced his first guest as Thich Nhat Hanh, a leading Buddhist monk in South Viet Nam, who is also director of the School for Social Studies at Saigon and a leading Vietnamese author and editor. According to Clark, Hanh had come to Chicago to participate in an ecumenical service at Rockefeller Chapel and also speak at Breasted Hall on May 31, 1966. The other guest, who was described as an associate of

Thich Nhat Hanh, was introduced as Robert Browne, a professor at Farleigh-Dickinson University, Rutherford, New Jersey, who was formerly employed with the United States AID Mission, Economic Offices, in South Viet Nam.

At the outset of this program the moderator asked Hanh whether he was in the United States as an official representative of the Buddhists. Hanh replied, "I am not. I received a letter from Cornell University to come to lecture on the renaissance of Buddhism and I take the opportunity to bring to the American public the message of the Vietnamese peasants who suffer too much from the war and want the war to be stopped at once."

When the moderator asked whether Hanh was taking a chance by coming to the United States and speaking as he did, Hanh replied that he would have trouble when he returned to Viet Nam because Ky would not permit individuals such as himself to speak out the truth about Viet Nam. Hanh stated that individuals and groups in Viet Nam who called for peace or who called for negotiations had been, and he assumed would continue to be, suppressed by the Ky government.

Clark also asked Hanh how he felt about U. S. involvement, the U. S. forces in Viet Nam, and whether he felt that this was the answer or would Hanh rather that the U. S. forces were not there at all. Hanh advised that the Vietnamese people recognize that the United States had good intentions in Viet Nam. He stated, however, that he did not think that the way the war was being conducted over there was right. When asked to be more specific he enumerated that the United States neglected the psychological aspects of the struggle in Viet Nam, the Vietnamese have no right of self-determination to the point where the Vietnamese army is regarded only as an extension of the United States Army, the country is so full of U. S. soldiers that the Viet Cong has been able to convince the peasants that the country is

occupied by the U. S., hence, they have increased enlistment on the side of the Viet Cong and he also believes the U. S. military men did not understand the Viet Nam culture, hence, they make mistakes every day.

Hanh also stated that the Vietnamese aspire to attain peace and reconstruction; the Vietnamese people are tired of war, so much so that the young people no longer smile. He stated further that even people in the National Liberation Front are tired and want the war to stop. Hanh stated he believed that if the United States stopped all positive attacks and bombings and remained in a position of self defense, this would be a step which would prove to the Vietnamese people that the United States is now going to secure peace for Viet Nam. Hanh was of the opinion that if the United States took this action it would have the support of South Viet Nam and would reduce the Viet Cong to a minimum.

In reply to a question as to whether the Buddhists should govern Viet Nam, Hanh said he does not think there will be a Buddhist government in that country, nor would he desire such a government. He stated that their only desire is for a government which will support nationalism, independence, and self-determination.

The opinions and statements of Professor Robert Browne during this program in substance agreed with those expressed by Hanh. Browne did comment that Hanh was not a political monk and at one point explained that Hanh did not support immediate and sudden withdrawal of U. S. troops but did feel that the continued presence of those troops and escalation of the war would only make matters worse; therefore, Hanh's recommendation is that the United States make a positive statement that it will withdraw its troops and take some positive steps in this direction.

Clark then asked Hanh if Hanh felt the first step in Viet Nam should be a cessation of the bombing. Hanh replied that this should be the first step, to be followed by promises of withdrawal, and then actual gradual withdrawal of U. S. troops. Hanh later reiterated that continued bombing is not useful and that if the United States government wants to show it has a strong desire for peace it should stop bombing, shooting, and adopt a position of self-defense.

Much of the discussion on this program was concerned with the recent acts of self-immolation by the South Viet Nam Buddhists and with the historical background of the Buddhists in Viet Nam. Hanh and Browne left this program at approximately 9:30 p.m.
