# A Limited Power Justice's General

By Marquis Childs

HOW NARROWLY wholesale tragedy was averted in Mississippi can never be known with precision. Between the violent bigotry of the whites and the long pent-up frustration of the Negroes the lines between sullen order and outright slaughter was paper thin.

The man who would have borne the blame for disaster, Attorney General Nicholas Katzenbach, kept an anxious watch over the weekend until the big rally at Jackson, the state capital, was ended. Critics, and not alone on the left of the civil rights movement, increasingly complained that in Mississippi Katzenbach failed to use the tools provided in the Federal Voting Rights Act of 1965 to register Negro voters.

The Attorney General confronts in Mississippi a sovereign power in Senator James Eastland. That power extends far beyond his fiefdom of Sunflower County to the Senate of the United States and his chairmanship of the Judiciary Committee with obstruction if not outright veto over the appointments of Federal judges and other aspects of the judicial and law enforcement machinery.

Katzenbach can, therefore, reply that in the face of such a sovereign power he has no choice but to proceed with all deliberate caution lest open warfare with Eastland be the result. The question is how far his writ runs.

WHEN Solicitor General Thurgood Marshall went before the Supreme Court, acting on the instructions of the Attorney General, to confess that a listening device had been put in the hotel suite of Fred B. Black Jr., convicted of income tax evasion, he opened the door a crack into a dark malodorous room. In this extraordinary confession Marshall said that the device was planted without authority from the Attorney General. Meanwhile, Richard Harwood, in a series of articles in *The Washington Post*, has revealed more than anyone else that the cloud over a case far more important than that of Black is still impenetrable.

If Black can get his conviction reversed because of the illicit wire tap, then Robert G. (Bobby) Baker, charged with theft and evasion, stands a chance of getting off on the same ground. Baker's attorneys allege "massive wiretapping" was the basis for the indictment. The Department of Justice has now entered a denial, stating that all the evidence was "legally obtained." But it will not be until the Solicitor General replies to the Supreme Court's request for a fuller explanation that the status of wiretapping will be clarified. If the

Baker case goes to trial, it is hardly necessary to add, his clever attorneys will make sure that the highest levels of government are involved in the disclosures.

Under the obscure laws restricting both wiretapping of electronic communications and eavesdropping through planted bugs an area of byzantine intrigue has seen every shred of privacy stripped away. Associates of one of the most prominent civil rights leaders are convinced that his hotel room in Washington was bugged by the FBI on the evening of the great march on the Lincoln Memorial in August, 1963.

NO ONE involved will admit to this. Newsmen, however, were told that they could hear the tapes and FBI agents have talked about what they revealed. Officials at the Justice Department say merely that their impression was that the tapes came from the regional office of the civil rights leader with the listening device planted by local authorities. There is good reason to believe, however, that the disclosures were intended to intimidate the individual involved.

Katzenbach has declined to talk about wiretapping or bugging pending a hearing in August on the Baker case. Spokesmen at the Justice Department will say only that neither electronic eavesdropping, which is less restricted legally, nor wiretapping of telephones has gone on for the past year. The era of wholesale tapping began in 1961 in Las Vegas, Nevada, when a series of taps were placed on the phones in big-time gamblers' offices and hotel rooms. Baker was at least indirectly involved.

Here again where authority lies is the plaguing issue for the Attorney General. The late Robert H. Jackson, after he had left the Attorney General's office and gone to the Supreme Court, once said that no Attorney General in his memory had exercised control over J. Edgar Hoover, the director of the FBI.

If Katzenbach has put an end to eavesdropping and wiretapping, except in cases involving national security, that should be put on the public record. A lot more light is needed in that dark, malodorous room.

The Chicago Office, by airtel dated June 23, 1966, has furnished information received from the Chicago Police Department relative to predictions made by a Reverend Clifford M. Royse, Director of the Chicago Psychic Center, Chicago, Illinois. Royse has made several predictions including "a warning of the greatest care for the leader, Martin Luther King assassination." Also included among fifty predictions for 1966, which were allegedly made in October, 1965, is the statement "a warning of a stroke for FBI Chief J. Edgar Hoover, leaving his job open to a younger, thinner, taller man, possibly from the Midwest."

In making his prediction concerning King, Royse also described the individual which he pictures as the person who will kill King. A Chicago Police Department artist prepared a sketch of this individual based upon the description furnished by Royse. Royse states that his predictions are based on extra sensory perception and psychic mediumship.

The files of the Bureau and the Chicago Office contain no information relative to Royse. Chicago is withholding any dissemination of the above information pending an evaluation by the Bureau.

RECOMMENDATION:

It is recommended that no dissemination be made of the above information since to do so may be placing us in the position of supporting the predictions of this unknown psychic medium. Attached for approval is an airtel to the Chicago Office advising that no local dissemination should be made.

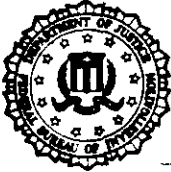

On July 1, 1966, a confidential source, who has furnished reliable information in the past, ascertained that Martin Luther King, Jr., had contacted Stanley Levison on that date. According to the source, they discussed King's desire to write an article in a national magazine restating his philosophy of non-violence. Levison told King that such magazines are not interested in a restatement but are looking for something different. King stated that he wanted to clarify many misconceptions that have developed concerning his philosophy, to explain why a mood of violence has come into being as regards the Negro freedom movement, and then move into the question of "defensive violence". King stated there is no military solution to the Negro problem.

Levison maintained that a magazine of smaller circulation might accept such an article. He contended that civil rights as an issue does not have the centrality it did previously and that, therefore, magazines are not interested because they feel their readers are not that much interested. Levison suggested that a restatement of King's philosophy of non-violence could be properly done in a book and that it was time for another book by King. King said he would work on the book in September, 1966.

King and Levison also discussed the possibility of getting out another fund-appeal mailing. It was Levison's opinion that such an appeal should be held off until September, 1966, since appeals had been made in April and May, 1966.

Levison noted that the Summer of 1966 promised to be sparse from a standpoint of income unless some special efforts could be generated. He insisted that the financial situation has to be watched very carefully and that they must become very selective about projects. Levison blamed the current financial squeeze on a combination of the war in Vietnam and the impression the anti-poverty program has created. He explained that a large number of the liberal elements have moved to another issue (the Vietnam war) while a large number of the elements in the Negro community have moved over to "a kind of social welfare approach" (the anti-poverty program).

King agreed that there is a serious problem but felt there are sources of income that have not been tapped. Levison commented on the inroads that have been made on this fund-raising efforts by the anti-poverty program. He asserted that ministers have become an arm of this program with the result that not only is money lost but dedicated men are removed from the mass action ranks.

Levison posed the question of the proper method to be pursued under the existing conditions. He stated that to proceed on the old basis could be fatal. He noted as examples the Congress of Racial Equality (CORE) and the Student Nonviolent Coordinating Committee (SNCC). He said that as they die they will become noisier and more militant in their expression. He said that "we" (the SCLC) should avoid finding less and less interest by repeating old slogans and the call for action of another period. Levison felt that it is vitally important to hold a "retreat" to examine this question and King agreed. They decided, tentatively, to hold this "retreat" in Chicago the week before the convention of the SCLC scheduled for the first week in August (in Atlanta, Georgia).

King and Levison also agreed to explore the possibility of Federal grants as a source of funds as well as grants from foundations.

[REDACTED] furnished the following information:

During 1965 a number of predictions concerning current events for 1966, were made by the Reverend Clifford M. Royse, Jr., Director of the Chicago Psychic Center, 32 North State, Chicago, Illinois.

One of the predictions made by the Reverend Royse was "A warning of the greatest care for the leader, Martin Luther King assassination."

[REDACTED] contacted Reverend Royse during June, 1966, regarding the basis for his prediction concerning King at which time Reverend Royse stated that his predictions are based on extra sensory perception and psychic mediumship. In addition Reverend Royse feels that this assassination attempt will most likely be in Chicago, Illinois, while the "flowers are still in bloom."

Reverend Royse states that he can picture the assailant as a "colored" male in his forties. Reverend Royse described the individual he pictures as the assailant to a Chicago Police Department artist who prepared a sketch which Reverend Royse advised was an excellent likeness of the picture he has in his mind.

[REDACTED] advised he was furnishing the above for information and he was not attempting to evaluate the ability of Reverend Royse.

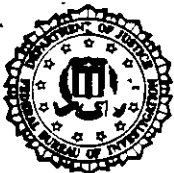

In considering the means whereby many people would get to Mississippi, Levison said they would take the regularly scheduled train which leaves New York's Pennsylvania Station on Friday, at 7:00 p.m., and arrives in Jackson, Mississippi at 4:00 p.m. Saturday. By arriving at that time the people will be able to participate in the rally which will be held in Jackson on Sunday, June 26, 1966. In addition to the people who get the train in New York, there will also be people who board the train at various stops on its way to Jackson.

Later, during June 21, 1966, according to the same source, Levison and Kanter were in contact to discuss the New York Committee for Meredith March. In that regard, Kanter said the New York Coordinator is Bayard Rustin, and that his address is 217 West 125th Street, New York City, the address of the A. Philip Randolph Institute.

Levison mentioned that there would also be a plane leaving New York City on Friday night for Mississippi (presumably for Jackson).

[REDACTED] recently attended a testimonial dinner held in Midlothian, Illinois, in honor of the head of the Thornton Township Branch of the National Association for the Advancement of Colored People (NAACP). This Township covers a portion of the far south suburbs of Chicago and the affair was attended by the Mayors, other civic and police officials of most of the suburbs in this area. The individual being honored on this occasion was Reverend C. William Billingslea, who was a featured speaker during the evening. Billingslea announced that on the afternoon of July 31, 1966, Dr. Martin Luther King, Jr., would appear as the featured guest and speaker at the annual NAACP rally to be held on that date at the football field of Thornton Fractional High School, Harvey, Illinois. The present plans call for a large group to assemble in or near Chicago Heights, Illinois, some six or seven miles distant, and march to Harvey to hear King speak. The march would be down Halsted Street, generally connecting these two communities, also known in this area as U.S. Highway 1. b7(D)

A confidential source with whom insufficient contact has been had to determine reliability advised on June 25, 1966, that Dick Gregory, James Meredith, and Ernest Thomas split with Dr. Martin Luther King over leadership of the march. Gregory, Meredith, and Thomas wanted to take the march back to Canton, Mississippi, to set up the tents as a point of defiance. King was continuing the march to Jackson.

Source advised that Charlie Sims, Deacons of Defense and Justice (DDJ), Bogalusa, Louisiana, and eight to ten DDJ members were present with Thomas in Mississippi. Source also believed two groups from Chicago were present, names and number unknown.

Mr. DOAR then asked, "Do you know about the Holiday Inn incident?" He was advised that an incident at the Holiday Inn had been called to the attention of the Jackson Office. He then related that he was at the Holiday Inn North around 6:00 PM and he had been swimming in the motel swimming pool. He said STOKELY CARMICHAEL and WILLIE KICKS, SNCC workers,

were also using the pool facilities. He said after his swim he began to make arrangements to check out of the motel. He understood a young boy was standing alongside the pool fully dressed, when he was thrown in the pool. Mr. DOAR did not say who threw the young boy into the pool. Mr. DOAR stated that he had already dressed and had gone to dinner when he received a telephone call from [REDACTED]

[REDACTED] who asked Mr. DOAR if he would return to the Holiday Inn since there appeared to be "a little trouble."

Mr. DOAR returned to the Holiday Inn and conversed with FLOYD MC KISSICK, National Director, CORE, and he observed police officers there. He understood that the manager had observed a crowd gathering and became upset and called the police department. MC KISSICK reportedly told Mr. DOAR that the manager had "a legitimate beef," concerning the incident. Mr. DOAR said evidently the crowd had dispersed when he arrived and there appeared to be no cause for concern.

He returned to the motel around 11:00 PM to spend the night and he noted a police car on duty and believed it was probably at the request of the manager.

Mr. DOAR then indicated he was calling from Indianola, Mississippi, and was en route to Memphis, Tennessee.

No leads are being set forth to the above named offices but this background information is being furnished for their information due to the fact individuals set forth in this LHM were active in the march to Jackson and have returned to their respective state headquarters.

Walter Fauntroy, Co-Chairman, Meredith March Headquarters, Jackson, and Special Representative of Dr. Martin Luther King, departed Jackson on June 27, 1966, en route to Atlanta, Georgia.

[REDACTED] stated that Stokely Carmichael, Chairman, Student Non-Violent Coordinating Committee (SNCC), was believed to have left Jackson on June 27, 1966, en route to SNCC Headquarters, Atlanta, Georgia.

[REDACTED] stated that the above individuals participated in the James H. Meredith March to Jackson, Mississippi. He stated each of the individuals marched from Tougaloo to Jackson on Sunday, June 26, 1966, to participate in the gigantic rally held at the state capitol.

[REDACTED] stated that the SCLC, SNCC, and CORE organizations have maintained residence at the Holiday Inn North, U. S. Highway 51, Jackson, but the individuals associated with the organizations checked out of the hotel on June 27, 1966.

[REDACTED] Tougaloo College, Tougaloo, Mississippi, advised on June 27, 1966, that James H. Meredith had left Tougaloo College campus on June 27, 1966, and he had received information that Meredith would reside at the home of a close friend in Jackson to rest and recuperate.

[REDACTED] advised on June 27, 1966, that on June 27, 1966, Meredith, after consultation with his physician in New York City, changed his itinerary and would return to New York City via Delta Airlines on June 28, 1966.

[REDACTED] said Meredith had originally planned to spend one week in Jackson.

A source who is in a position to furnish reliable information advised on June 27, 1966, that around 6:30 PM on June 27, 1966, there were approximately 30 Negroes observed gathering around the swimming pool of the Holiday Inn North located on U. S. Highway 51, Jackson. In addition there were approximately 30 Negroes observed at the rear section of the motel. There were several car loads of Negroes that were observed driving on the grounds of the motel at this time. The source stated that the SCLC, SNCC, and CORE organizations had several of their leaders as guests of the motel but the majority of the individuals had checked out and reportedly had left Jackson with many of their followers.

Around 6:45 to 7:00 PM a fist fight was had by two Negro youths on the motel grounds and four others attempted to break up the fight. The fight eventually stopped but not until a large crowd had gathered at the rear of the motel. The source advised that he had been told by a Negro male, not further identified, that the

first fight had actually broken out between the two groups of CORE and SNCC workers over money. The source said that by 7:45 PM the majority of the Negroes had departed the motel grounds.

The source stated that the manager of the motel had discussed this matter with Floyd McKissick, National Director of CORE, who was present and McKissick appeared to act as a mediator between the SNCC and CORE workers.

The source stated that Hosea Williams, SCLC, and advisor to Dr. Martin Luther King, had checked out of the motel on the afternoon of June 27, 1966, but was unable to make flight connections to Atlanta. Williams returned to the motel for the evening to await confirmation of his reservations for his flight to Atlanta. The source stated that there were no members of the SCLC involved in the dispute on the evening of June 27, 1966, and understood that SCLC representatives had conducted themselves in an orderly manner while guests of the motel.

Pastor of the Pratt Memorial Church and Co-Chairman of the Meredith March Headquarters, conducted a meeting. The meeting was held to handle any unfinished business concerning the Meredith March. There were approximately 100 persons in attendance and the majority of these individuals participated in the march to Jackson on Sunday, June 26, 1966. The source stated the majority of the individuals attended the meeting in an attempt to obtain money to finance their return to their respective residences. The source said there were several of these individuals from out of the state. The source said that during a heated discussion of finances, two Negro males became involved in an argument and a fight ensued. One of the Negro males, not further identified, pulled a gun but before any shots were fired, he was restrained by by-standers. Hosea Williams instructed those present not to notify the police nor to discuss this action with anyone. Williams stated this type of action certainly gives the civil rights movement "a bad name." He added if the news media became aware of this incident they would again continue the "cry of disunification." One Negro female, Barbara Rose from Natchez, Mississippi, who is very active in civil rights activities, was near the two individuals when the fight broke out and according to Williams, "began to scream and went into shock." She was treated by those present.

At the meeting Hosea Williams was questioned whether the SCLC would open an office for headquarters of SCLC in Mississippi. Williams stated that Dr. Martin Luther King and the Board had given this matter serious consideration and up until approximately two weeks ago, arrangements were being made to have a SCLC Headquarters in Mississippi. Williams stated that Dr. King and the Board had generally agreed that an office in Mississippi would be "a handicap to our big budget."

Referenced airtel advised that when discussing his pending travel itinerary on 5-19-66 Reverend KING stated that it was necessary for him to appear 6-26-66 in CV, Ohio, in order to speak for Reverend (FNU) HOOVER.

CV sources and news media have furnished no information indicating that Reverend KING expects to be in CV on 6-26-66.

The Reverend HOOVER referred to above is probably Reverend O. M. HOOVER, Pastor of the Olivet Institutional Baptist Church in CV. Reverend HOOVER accompanied Reverend KING to Norway in 1964 for the Nobel Peace Prize ceremony and news releases at the time described Reverend HOOVER as a long time personal friend of Reverend KING. News articles also noted that Reverend HOOVER's daughter, CAROL, was employed as a secretary to Reverend KING. Reverend HOOVER has not taken a significant part in civil rights activities in CV.

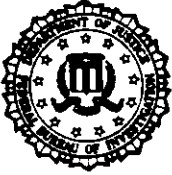

Dr. Martin Luther King, Jr., President, SCLC, had been present at this meeting at which, after much discussion, the decision had been arrived at to postpone the SCLC sponsored mass rally and march on Chicago's City Hall scheduled for June 20, 1966. This rally and subsequent march was postponed until July 10, 1966, because of the pressure of developments in Mississippi where James Meredith had only recently been shot in the course of a voters registration march from Memphis, Tennessee, to Jackson, Mississippi.

It was stated at this meeting that SCLC emphasis will be placed on this unforeseen development in the South for the immediate future, and other aspects of SCLC activities will

On June 15, 1966, a confidential source, who has furnished reliable information in the past, advised that Stanley Levison and Martin Luther King, President of the Southern Christian Leadership Conference (SCLC), were in contact on that date. Their contact was in reference to the need of funds for the Mississippi march.

King made reference to a conference of the SCLC which was held in Atlanta, Georgia, on June 14, 1966, and which Levison attended, where it was decided that various civil rights organizations engaged in the march will send out their own appeals for funds.

King urged Levison to expeditiously handle the SCLC fund appeal because "they" (the marchers) were in desperate need of money in Mississippi. Levison said he would run a fund appeal letter in the name of the "March Fund" in "The New York Times".

King said the march was going favorably, and that more voter registrations were being obtained than expected.

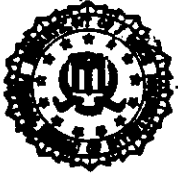

On June 20, 1966, [REDACTED]

[REDACTED] advised that a freedom day rally was held at Cobo Hall on June 19, 1966, with the Reverend Martin Luther King, Jr., and UAW President Walter P. Reuther as the principal speakers.

According to [REDACTED] Reverend King, during his speech at this rally, urged continued non-violence by civil rights workers to combat growing demands for Negroes to use force against force in the civil rights struggle.

According to [REDACTED] the purpose of the rally was to raise funds for voter registration drives in Mississippi and the deep south. Reportedly 15,000 persons were in attendance at the rally. The rally was sponsored by the UAW, AFL-CIO, the Trade Union Leadership Council (TULC) and various other civic and church organizations in the Detroit area.

According to [REDACTED] the rally was held during the approximate period from 3:30 p.m., to 6:00 p.m., and there were no incidents in connection with this rally.

In connection with the above captioned freedom day rally, an anonymous telephone call was received by the Detroit Office of the Federal Bureau of Investigation (FBI) on June 17, 1966. The anonymous telephone call was made by an unknown male who advised that he is an employee of the Cadillac Motor Company, Division of General Motors, Plant #1, Clark and Michigan Avenue, Detroit. He advised that elements of the Ku Klux Klan who are employees of Cadillac Plant #1 intend to assassinate Martin Luther King, Jr., on June 19, 1966, when he appears at the freedom day rally sponsored by local union, civic and church organizations at Detroit.

On May 10, 1966, a confidential source, who has furnished reliable information in the past, advised that MARTIN LUTHER KING, JR., had been invited to give the baccalaureate address at the graduation exercises at Bryn Mawr College, Bryn Mawr, Pa., on May 29, 1966.

This same source subsequently advised that KING planned to arrive in Philadelphia on May 29, 1966, at approximately 5:00 p.m. via chartered plane from New York. He was to be met at the airport and driven in a chartered limousine to Bryn Mawr College where he would give the baccalaureate address. KING planned on returning to New York that same evening.

On page three of the May 30, 1966, issue of "The Philadelphia Inquirer," a daily newspaper in Philadelphia, Pa., appeared an article entitled, "KING Suggests Route to Peace at Bryn Mawr." This article further reflects that MARTIN LUTHER KING, JR., in a baccalaureate address at Bryn Mawr College, Bryn Mawr, Pa., on Sunday, May 29, 1966, placed heavy accent on world affairs. He stated that Red China must be admitted to the United Nations. Such a move must precede a negotiated settlement of the Vietnam conflict because the Chinese Communists would be able to speak for the Viet Cong. He claims his visit to India last year convinced him the United States would serve humanity better by putting food in the mouths of needy nations rather than military bases on their soil.

KING asserted the American Negro is freer today than at any time in his history. To expand to that freedom non-violence is the most important thing for the Negro today. The Negro can get much by not resorting to violence. He encouraged the graduates to direct their energies to assisting the poor. The graduates are sorely

needed in the outside world to help those such as he saw going hungry in India.

On June 10, 1966, this same confidential source advised that KING was approximately 40 minutes late arriving at Bryn Mawr College and the baccalaureate services were delayed until his arrival. KING left the campus shortly after his address.

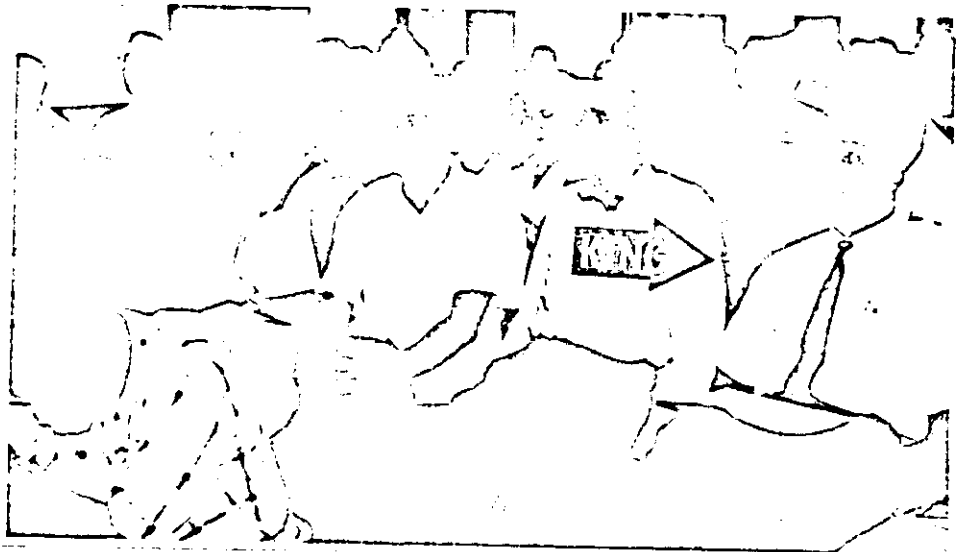

On June 12, 1966, a confidential source, who has furnished reliable information in the past, disclosed that a conference between Martin Luther King, President of the Southern Christian Leadership Conference (SCLC), Stanley Levison, Bayard Rustin and Walter Fauntroy (SCLC Director in Washington, D.C.), took place on that date. The conference, according to the information from the source, was in regard to the protest march in Mississippi.

King announced that it had been decided to extend the time for completion of the march until June 26, 1966. Furthermore, he said he expected to have approximately two thousand participants in the long march and twenty to twenty-five thousand people converging on Jackson for the climax.

King requested Bayard Rustin and Walter Fauntroy go to Mississippi to aid in the march. Rustin expressed reluctance to go for fear that Stokely Carmichael of the Student Nonviolent Coordinating Committee (SNCC) and McKissick (Floyd McKissick, National Director of the Congress of Racial Equality (CORE), and "other left wingers would take advantage" of him and that "it might degenerate into a black nationalist thing".

King agreed that Stokley would give them trouble all along and he expressed opinion that it was good that Stokley did not have a large following. King said Stokley complained that the SCLC was getting all the publicity and that Stokley was bitter because he feels the press has painted him as a black nationalist and a racist.

The conference then shifted to demands made on the Federal Government by the civil rights leaders. In that regard, King opined that "they" (civil rights organizations) would not be able to get the billions of dollars they wanted on a freedom budget largely because of Vietnam.

Levison, in commenting on Stokley and McKissick, said the best way to bury their doctrine was for people like Rustin and white people to go down there (to the march in Mississippi). Rustin said he was undecided about going, but said he would recontact King on Monday (June 13, 1966).

King said he would like to bring into the march some people from Chicago, but said he was reluctant to do so, since the SCLC was so low on funds.

Levison, at King's request, agreed to raise funds for the purpose of aiding the march. He requested King's permission to run an advertisement in "The New York Times" to raise funds for the march. King granted permission, cautioning, however, that it be done for "Meredith Mississippi March Fund", not under name of SCLC.

Bayard Rustin

In "The Saturday Evening Post", issue of July 11-18, 1964, page 76, Bayard Rustin is the subject of a feature article captioned: "The Lone Wolf of Civil Rights". In it, Rustin is said to have come to New York in 1938, as an organizer for the Young Communist League (YCL), and as such, he had the job of recruiting students for the "Party". Furthermore, the article reports that during his first years in New York, Rustin gave most of his earnings to the "Party". He reportedly left the "Party" in 1941, the article states. u

The YCL has been designated pursuant to Executive Order 10450.

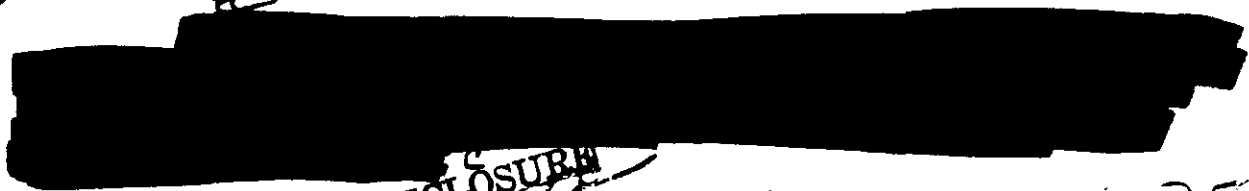

[REDACTED] advised the Chicago Office of the Federal Bureau of Investigation (FBI) on June 7, 1966, that information available to his Unit reflected that Dr. Martin Luther King, Jr., President, Southern Christian Leadership Conference (SCLC), had arrived in Chicago during the morning hours of this date.

[REDACTED] advised that this information was to the effect that King had engaged in brief conferences with representatives of the local SCLC leadership, then had departed almost immediately from Chicago for Memphis, Tennessee, where he was to meet with James Meredith, hospitalized in Memphis as a result of having been shot near Hernando, Mississippi, during the course of an intended march from Memphis to Jackson. b7(D)

[REDACTED] continued that Frank Ditto, Head of the Oakland Committee for Community Improvement, a local Chicago civil rights group, had departed Chicago for Memphis, as a result of the Meredith shooting, however, [REDACTED] had no information concerning the plans for further action on the part of either King or Ditto upon their arrival in Memphis. b7(D)

On June 8, 1966, Matthew Ahmann, National Director, National Catholic Conference For Interracial Justice, (NCC) Chicago, advised that he has been in contact with various NCC offices throughout the United States and the NCC has not yet determined what course of action it will take concerning the Mississippi march.

Ahmann advised the NCC is prepared to devote the same effort to Mississippi as was given to Selma, Alabama when they recruited thousands of priests, nuns, and lay workers throughout the United States to participate in the Alabama march.

Ahmann advised that the desires of the various civil rights organizations will be considered as well as the possible desirability of clergy participating to preclude violence. He anticipated a decision being made within the next few days.

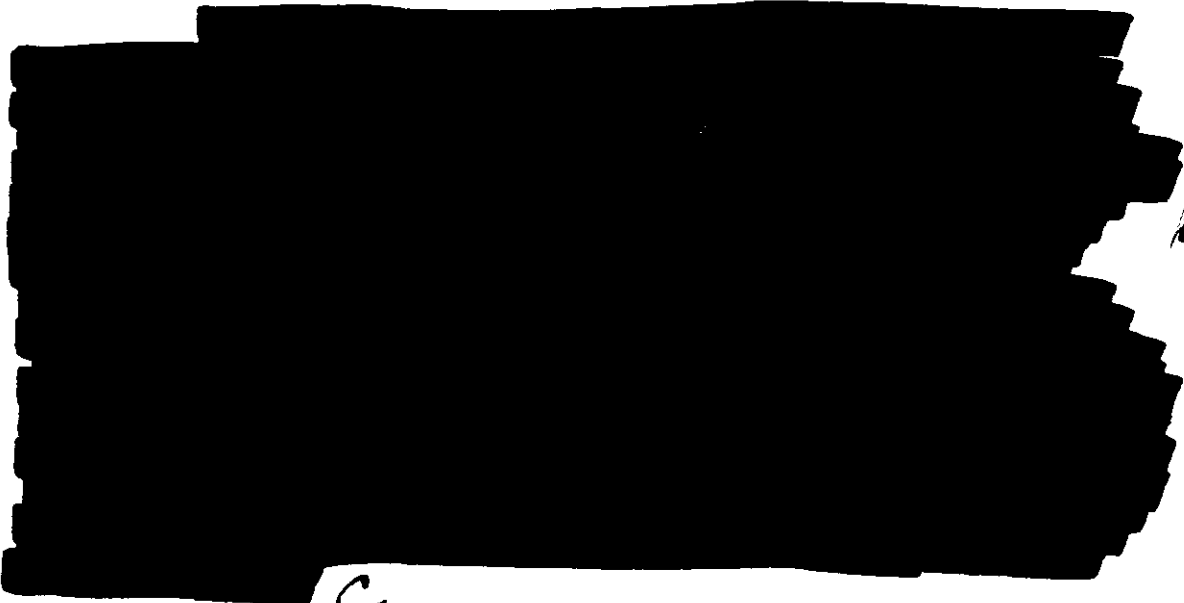

In connection with the above, a local Chicago Newspaper, the "Chicago Daily News", edition of June 7, 1966, contained an article reflecting that the Union To End Slums, described as an affiliate of the SCLC, has called for a rally in Chicago on June 10, 1966, to raise funds to send bus loads of marchers to Mississippi as a result of the Meredith incident. This meeting was to be held at the Chicago SCLC Headquarters, 3101 West Warren Avenue.

A representative of this group was quoted as having stated it is hoped that buses can be chartered "to send hundreds of civil rights volunteers" to join a march there to be lead by Dr. King.

This article continued that other civil rights organizations had begun mobilizing scores of volunteers, clergymen, students, teachers, and housewives from Illinois and surrounding states to join the march. The article reflected that although a few local leaders within the civil rights movement were urging a mass march on the Mississippi State Capitol at Jackson to rival last year's Selma, Alabama march, most have adopted a wait-and-see attitude.

Information received 6/13/66 that professors at Berkeley, California, were preparing a white paper protesting U. S. action in Vietnam. One Mattison, St. Louis, Missouri, had a representative of "National Emergency Committee of Persons Concerned About Vietnam" contact Martin Luther King's headquarters at Atlanta to solicit his signature to a letter urging President Johnson study paper. Whether King will sign letter still not known.

We have no information concerning above committee. San Francisco was requested 6/13/66 to identify committee and St. Louis was requested to identify Mattison.

Above information furnished Internal Security and Civil Rights Divisions of Department, State Department and military intelligence agencies. When identifying data regarding committee received from San Francisco, complete information will be furnished White House, Attorney General and Deputy Attorney General.

Anonymous male called Detroit 3-17-66 to advise that elements of KKK, employees Cadillac Plant No. 1, Detroit, plan to kill Martin Luther King during his scheduled appearance at Cobo Hall, Detroit, 6-19-66. Alleged that [redacted] Klan, a member of Cadillac Plant, is possibly involved.
