A CONFIDENTIAL SOURCE, WHO HAS FURNISHED RELIABLE INFORMATION IN THE PAST, ADVISED ON OCTOBER SEVENTEEN, SIXTYSIX, THAT CLARENCE JONES, ATTORNEY FOR MARTIN LUTHER KING, JR. TOLD PAUL O-DWYER (NEW YORK CITY ATTORNEY AND BROTHER OF FORMER MAYOR WILLIAM O-DWYER), THAT HE HAD BEEN GIVEN AN ASSIGNMENT BY MARTIN LUTHER KING, JR., TO ATTEMPT TO REACH JIMMY HOFFA (HEAD OF THE TEAMSTERS UNION) TO ARRANGE A MEETING BETWEEN HOFFA AND KING. JONES SAID HE DID NOT WANT ANY PUBLICITY ATTACHED TO THIS, THAT KING IS VERY SENSITIVE ABOUT ANY KNOWLEDGE OF THE MEETING BECOMING KNOWN UNTIL HE HAS HAD A CHANCE TO HAVE THE MEETING, AND THAT WAS WHY HE CONTACTED O-DWYER. O-DWYER PROMISED TO HELP. JONES STATED THAT KING WOULD GO TO WHERE HOFFA IS AND THAT HE, JONES, WOULD ALSO BE PRESENT AT THE MEETING.

ON OCTOBER NINETEEN, SIXTYSIX, THE SAME SOURCE LEARNED THAT ON THAT DATE O-DWYER TOLD JONES THAT HOFFA WANTED TO KNOW THE PURPOSE OF THE MEETING. JONES- COMMENTS INCLUDED THE FOLLOWING:

KING HAS FELT FOR SOME TIME THAT MOST OF THE SUPPORT OF THE CIVIL RIGHTS MOVEMENT HAS COME FROM THE SAME UNIONS SUCH AS DISTRICT SIXTY FIVE OF THE RETAIL, WHOLESALE AND DEPARTMENT STORE UNION, THE PACKINGHOUSE WORKERS UNION, AND CERTAIN LOCALS OF THE UNITED AUTO WORKERS UNION. KING SAID THAT HIS CONVERSATIONS WITH PERSONS AROUND THE TEAMSTERS UNION SEEM TO INDICATE THAT THE UNION MIGHT BE MORE WILLING TO SUPPORT CIVIL RIGHTS THAN PEOPLE BELIEVE. KING IS PARTICULARLY IMPRESSED WITH THE FACT THAT THE TEAMSTERS UNION HAS ABOUT FOUR HUNDRED FIFTY THOUSAND NEGRO MEMBERS AND WANTS TO HAVE A FRANK DISCUSSION WITH HOFFA ON GREATER INVOLVEMENT.

THERE HAVE BEEN CONFLICTING OPINIONS WITHIN THE SOUTHERN CHRISTIAN LEADERSHIP CONFERENCE AS TO WHETHER KING SHOULD GO TO THE TEAMSTERS. SOME SAY HOFFA WILL USE IT AND THAT THEY SHOULD NOT IDENTIFY WITH THIS UNION. THERE ARE OTHERS WHO SAY HOFFA HAS HAD HIS LEGAL DIFFICULTIES BUT IS STILL PRESIDENT OF THE UNION.

A confidential source, who has furnished reliable information in the past, advised on October 15, 1966, that Clarence Jones had recently introduced Douglas Pugh (of the Ford Foundation) to Martin Luther King, President of the SCLC. King noted that he was scheduled to meet with Bundy (McGeorge Bundy, Director of the Ford Foundation) on Tuesday (October 18, 1966), after which he wants to work out a proposal which would be helpful to the Foundation.

On October 17, 1966, [REDACTED]

[REDACTED] advised that Martin Luther King was expected at that hotel on the evening of October 17, 1966. According to [REDACTED] King and Bernard Lee (personal secretary of King), would stay for one night.

A confidential source, who has furnished reliable information in the past, furnished information on October 18, 1966, indicating that Stanley Levison and Martin Luther King were in contact on that date. King related that he had had a meeting with McGeorge Bundy of the Ford Foundation earlier in the morning in the office of Harry Wachtel. King said the meeting went very well and in fact, the Foundation plans to send some personnel to Atlanta to work out the proposal concerning voter registration in the South.

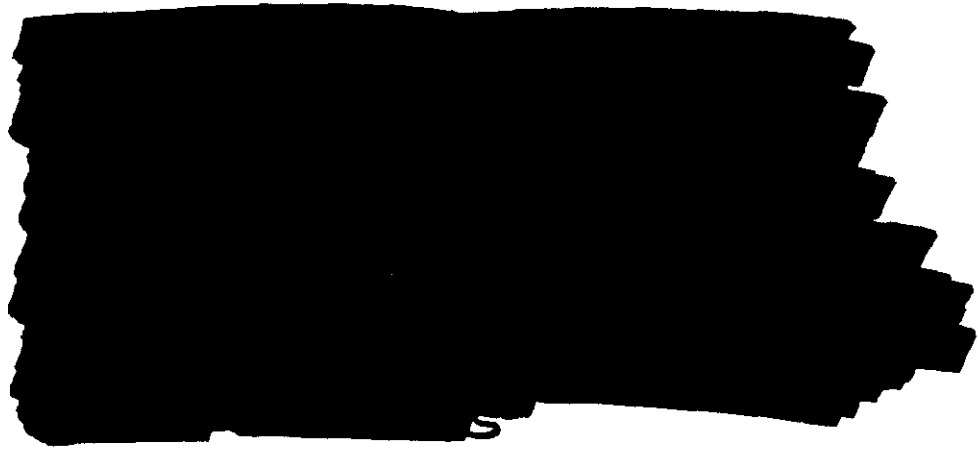

King said Bundy would present the proposal on voter registration to his Board (Ford Foundation Board) in December, 1966. Bundy, according to King, is convinced that the Foundation will make a large grant to the SCLC.

King then reminded Levison of the meeting scheduled for 2:30 PM that date in his suite at the New York Hilton Hotel. King said Dr. Kenneth Clark (psychology professor at City College, New York, New York), Clarence Jones, Andy Young (Executive Director of the SCLC) would be there to meet with him. Levison said he would be there without fail. King told him to come to room 3121.

On October 18, 1966, at 2:07 PM, Special Agents of the Federal Bureau of Investigation (FBI) observed Stanley Levison enter the New York Hilton Hotel elevator bank which services the 31st floor. He was observed getting off the elevator at 2:12 PM, from which he walked to the telephone booth in the lobby where he made several telephone calls. As he was getting ready to get on the elevator at 2:29 PM, Levison met Martin Luther King and Andy Young, who were also waiting for the elevator. They got on the elevator at 2:31 PM. At 2:36 PM, Dr. Kenneth Clark was observed taking the same elevator. He was followed by Clarence Jones at 2:36 PM. u

NATIONAL LAWYERS GUILD

The "Guide to Subversive Organizations and Publications", revised and published as of December 1, 1961, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following concerning the National Lawyers Guild:

"National Lawyers Guild

- "1. Cited as a Communist front.
(Special Committee on Un-American Activities, House Report 1311 on the CIO Political Action Committee, March 29, 1944, p. 149).
- "2. Cited as a Communist front which 'is the foremost legal bulwark of the Communist Party, its front organizations, and controlled unions' and which 'since its inception has never failed to rally to the legal defense of the Communist Party and individual members thereof, including known espionage agents.'
(Committee on Un-American Activities, House Report 3123 on the National Lawyers Guild, September 21, 1950, originally related September 17, 1950.)
- "3. 'To defend the cases of Communist lawbreakers, fronts have been devised making special appeals in behalf of civil liberties and reaching out far beyond the confines of the Communist Party itself. Among these organizations are the * * * National Lawyers Guild. When the Communist Party itself is under fire these offer a bulwark of protection.'
(Internal Security Subcommittee of the Senate Judiciary Committee, Handbook for Americans, S. Doc. 117, April 23, 1956, p. 91.)"

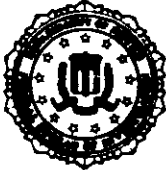

Reference is made to a previous communication captioned as above, dated September 29, 1966. u

The October 1, 1966, issue of "The Philadelphia Independent", a Philadelphia Negro-oriented weekly tabloid, carried an article entitled "Big Rights Rally Here October 9th". This article reflects that Dr. MARTIN LUTHER KING and JAMES MEREDITH would be two of the speakers at a giant civil rights rally held at the Arena, 46th and Market Streets, Philadelphia, October 9th. This rally was being sponsored by the Interfaith-Interracial Council of the Clergy and was described by a leader of the group as the biggest, most fruitful rally ever held for the benefit of civil rights in Philadelphia. u

This article further reflects that the proceeds from the rally will go toward a "MEREDITH Mississippi March". The Interfaith-Interracial Council of the Clergy was founded by the Reverend Dr. WILLIAM L. BENTLEY, pastor of the Emmanuel Institutional Baptist Church, following the riots in North Philadelphia two years ago. This organization is comprised of clergy representing all races and religions in Philadelphia. u

A review of the current telephone directory for Philadelphia reflects that Reverend WILLIAM L. BENTLEY resides at 303 Pelham Road, Philadelphia, and is pastor of the Emmanuel Institutional Baptist Church, 1730 North 22nd Street, Philadelphia, Pa. u

Reverend J. HENRY PATTEN, Secretary of the Civil Committee of the Baptist Ministers Conference in Philadelphia, had been in contact with the Civil Rights Congress in Philadelphia. u

The Baptist Ministers Conference had become interested in those cases involving discrimination against Negroes and as Secretary, PATTEN frequently represented the Conference in connection with these cases. Frequently, the Civil Rights Congress was interested in these cases, too, and requested the Baptist Ministers Conference to work with it. u

The Civil Rights Congress (CRC) has been designated by the Attorney General of the United States pursuant to Executive Order 10450. u

In late 1951, Reverend PATTEN cooperated closely with JOHN HOLTON, Secretary of the CRC in Philadelphia, in connection with the case of Reverend STANLEY HATCH, a Baptist minister from Wildwood, N. J., who was arrested on a complaint from a female parishioner and charged with rape. The CRC agreed to support HATCH's case. u

While arrangements were being made to employ a different attorney, JOHN HOLTON, Reverend HATCH, and Reverend WILLIAM L. BENTLEY, pastor of the Emmanuel Baptist Church, traveled to New York City to confer with WILLIAM L. PATTERSON, National Director of the CRC. The purpose of this visit was to receive PATTERSON's approval for the CRC to assume financial responsibility for the HATCH case. As a result of this meeting, PATTERSON officially agreed that the CRC would wholeheartedly support the HATCH case. u

advised that MARTIN LUTHER KING, JR., accompanied by Reverend RALPH ABERNATHY, Vice-President, Southern Christian Leadership Conference, and BERNARD LEE, aide, were scheduled to arrive in Philadelphia on Sunday afternoon, October 9, 1966. The tentative schedule included a press conference to be held shortly after their arrival in Philadelphia. That same evening KING, ABERNATHY, and LEE would be joined by JAMES MEREDITH and participate in a civil rights rally at the Arena, 46th and Market Streets, Philadelphia, Pa. On Monday morning, KING was scheduled to attend a private meeting with THATCHER LONGSTRETH, President, Philadelphia Chamber of Commerce, and five other industrialists. He was also scheduled to attend a luncheon of the Chamber of Commerce to honor Reverend WILLIAM L. BENTLEY. After lunch he was scheduled to participate in a dedication of several homes in the 1800 block of Lambert Street, which were u

renovated by the Interfaith-Interracial Council of the Clergy. After this dedication, he was to join a special program at the Emmanuel Institutional Baptist Church, 22nd and Columbia Avenue, of which Reverend BENTLEY is the pastor. u

On page 6 of the October 9, 1966, issue of "The Philadelphia Inquirer", a local Philadelphia newspaper, appeared an article entitled "MEREDITH Challenges Negroes to 'Shape Up'; KING Decries Violence". According to this article, JAMES MEREDITH, a lonesome traveler of the civil rights movement, and Reverend MARTIN LUTHER KING attended a rally on Sunday night, October 9, 1966, sponsored by the Interfaith-Interracial Council of the Clergy. At this rally MEREDITH stated the American Negro has a lot of "shaping up" to do before he can expect to live better. He told the Negro males to start acting like a man around the house, he admonished Negroes of both sexes to stay out of bars and look for work, and he urged the colored communities to strive for good schools instead of squabbling over integrated education. u

Following MEREDITH's speech, KING advised the 1500 people present that this black power thing has taught the Negro one thing, that is, that there are going to be some serious fights among the Negroes to determine where the Negro is going. According to KING, there is no separate black path to power and there is no separate white path to power. Power does not lie in Molotov cocktails, bricks, stones, or guns. If every Negro in the United States turns to violence, KING stated he would stand as a lone voice, saying that was not the way. He indicated he was sick and tired of violence. He also stated that the Negro needs the white man to free him from his fears and the white man needs the Negro to free him from his guilt. The destinies of the white and Negro are intertwined whether the people like it or not. u

On page 6 of the October 11, 1966, issue of "The Philadelphia Inquirer" appeared an article entitled "Dr. KING Warns of Trend Toward 'Black Cities'". Speaking before a luncheon meeting of the Greater Chamber of Commerce at the u

Benjamin Franklin Hotel and attended by more than 300 community businessmen, KING stressed the need for an early solution to settle the differences between the white and Negro populations of the country, which differences will create numerous social problems in every major city. u

This meeting was arranged to honor Reverend WILLIAM L. BENTLEY, pastor of the Emmanuel Institutional Baptist Church and President of the Interfaith-Interracial Council of the Clergy, on the celebration of his 25th year as pastor. He was presented with a citation by THATCHER LONGSTRETH, President, Chamber of Commerce. KING told the audience there is a trend in the nation toward a dangerous development in the major cities which threatens to turn them into Negro cities ringed by white suburbs. This situation can only invite disaster. According to KING, there are two Americas in existence today. One is a white America, which is beautiful and prosperous, while the other is the America of the Negroes, which is ugly, brooding, defeated, and disappointed. Combined efforts must be taken to create one America for both whites and Negroes. The Negro is still at the bottom of the economic ladder and the situation has gotten worse in the last 25 years. This problem will become more serious with the advancement of automation. KING cited the causes of the Negroes poor economic position to be underemployment and underearnings. He noted the average annual salary of white workers in the country is \$6,874, while the Negro workers is \$3,662. u

On page 9 of the October 11, 1966, issue of "The Evening Bulletin", a local Philadelphia newspaper, appeared an article entitled "Dr. KING Opens 2d Home Renovated by Clergy Council". This article reflects that KING participated in the opening of a former slum house in the 1800 block of North Lambert Street, which was bought and remodeled by the Interfaith-Interracial Council of the Clergy. According to this article, this home was purchased by the organization, was remodeled, and will be sold to one of the poor Negro families in the neighborhood. As a nonprofit corporation, the organization can keep the cost of its houses down without cutting corners or quality, and it was indicated that these homes renovated by the Council can save the buyer thousands of dollars. u

On page 4 of the October 11, 1966, issue of the "Daily News", a local Philadelphia newspaper, appeared an article entitled "KING Skips Visit to Girard, Calls Demonstrations Vital". This article reflects that MARTIN LUTHER KING had completed a two-day visit in Philadelphia without visiting either Girard College with its renewed picketing for integration or the Kensington neighborhood of Philadelphia, which was marked by disturbances last week after a Negro family had moved in. KING indicated he did not go to Girard College because he was not asked but the situation must be dramatized by demonstrations because it is a matter that needs constant public attention. KING made no comment on the Kensington situation but on the subject of housing did state that people fear Negroes moving into their neighborhoods because they still believe in the erroneous stereotype Negro and that property values will depreciate. u

KING stated that he thinks reports of a white backlash are exaggerated and suggested the people wait to see the results of a coming election. u

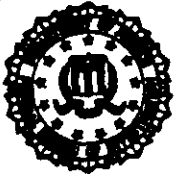

[redacted] advised that on 10/15/66 Stanley Levison and Bayard Rustin were in contact. Both have subversive backgrounds and are principal advisers to Martin Luther King, Jr., President, Southern Christian Leadership Conference. They discussed a current article appearing in the "New York Times" concerning King's stand in the civil rights movement. Rustin argued that King cannot continually put himself in the middle of the movement. Rustin asserted that King should take a firmer stand closer to that repudiating the "black power" groups.

Levison told Rustin he is trying to arrange a trip for King and his wife to Africa and Latin America to place emphasis on King being interested in the poor, both white and black.

On the same date Levison was also in contact with Andrew Young, Executive Director, Southern Christian Leadership Conference, at which time they discussed the "New York Times" article concerning King. They agreed that a letter should be directed to the newspaper setting forth what King's position is in the civil rights movement. They discussed what the contents of the letter should be. Young stated he felt the Administration was trying to divide "us." He added that King is not ready to say this publicly.

Levison later the same day contacted Martin Luther King, Jr. When discussing the newspaper article King stated "that just shows you how you can get into a bind." Levison suggested that King should send a letter to the "New York Times" and clearly state his position. King advised he did not want to be lumped in as taking the same role as Roy Wilkins of the National Association for the Advancement of Colored People and Whitney Young of the Urban League, opposing Black Power.

The following information has been supplied by a confidential source of this Bureau who has furnished reliable information in the past. u

On October 15, 1966, Stanley Levison, an adviser of Martin Luther King, Jr., President, Southern Christian Leadership Conference, was in contact with Bayard Rustin, another of King's advisers. The two discussed what position King should assume in the civil rights movement. Rustin argued that King cannot continually put himself in the middle because this is the wrong position according to a large segment of the white liberals and the Negro middle class. Levison did not agree entirely stating that it might be that way with some white liberals.

Levison explained that King's position is not too different from others. There is only a margin of difference. At the moment, King does not want to ignore or isolate those who have an erroneous slogan. Rustin was of the opinion that King should take a firm stand repudiating the "black power" groups.

Levison mentioned he had talked about arranging a trip for King and his wife to Africa and Latin America to place emphasis on King's being interested in the poor, both white and black. Upon his return, King would then be the spokesman for both white and black poor people.

On the same date, Levison was also in contact with Andrew Young, Executive Director, Southern Christian Leadership Conference. Levison acquainted Young with the "New York Times"

story captioned "Doctor King Endorses Racial Statement, Backs Negro Repudiation of Black Power Concept." Levison suggested that King write a letter to the "Times" clearly defining his stand in the civil rights movement.

Young explained, he feels King, in his statement, should say that while he realized the role of the Urban League and the National Association for the Advancement of Colored People, he never thought their role was synonymous with his. Also, he understands the frustration of the black people and their disillusionment with the Administration and that he is not ready to give up. Young indicated that he believes the Administration is trying to divide "us." He added that King is not ready to say this publicly.

Levison indicated he would get something to the "New York Times" by Monday.

Later the same day, Levison was also in contact with Martin Luther King, Jr. When discussing the newspaper article, King stated "that just shows you how you can get into a bind." Levison stated he was convinced that Rustin did this. He also believes Rustin wants to box King in. Levison suggested King send a letter to the "New York Times." King advised that the only time he makes tactical errors is when he deals with Rustin. King added that he thought a letter to the newspaper stating his position was the only way out. He stated that he did not want to be lumped in as taking the same role as Roy Wilkins of the National Association for the Advancement of Colored People and Whitney Young of the Urban League.

Stanley Levison is a long-time communist whose membership in the Communist Party, USA, has been established as of July, 1963.

During the early 1940's, Bayard Rustin was a member of the Young Communist League, an organization which has been designated subversive pursuant to Executive Order 10450.

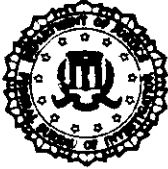

His appearance is to be sponsored by a representative of student organization of the university. It was the opinion of [REDACTED] that Martin Luther King would not make a scheduled appearance stating that he had been similarly invited before, but not only did not make an appearance, but did not return the money sent to him to cover his expenses. He gave as a reason for not making an appearance at that time the fact that he was more urgently needed elsewhere. b(2) b7(D)

[REDACTED] advised that he also had heard of a possible scheduled appearance of Martin Luther King, Jr. to the campus, but the details as of this date were unavailable. b7(D)

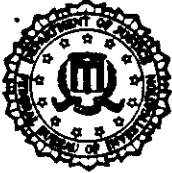

A confidential source, who has furnished reliable information in the past, furnished information on October 15, 1966, which disclosed that Stanley Levison and Bayard Rustin (organizer of the March on Washington, 1963), were in contact on that date. Their contact was in regard to the question of black power and a statement which appeared in "The New York Times" on October 14, 1955, concerning this issue. The following is in substance what Levison and Rustin said:

Levison said that when he asked Martin Luther King (President of the Southern Christian Leadership Conference) (SCLC) the reason for his positive reply to the question "Do you endorse the statement issued by other civil rights leaders", he replied, "I thought we agreed that this is what I would say". Levison added he then reminded King of what he had told him earlier saying he should say he found nothing in it that he did not agree with, but his own statement to the press was his feeling on the matter. Levison explained that the statement was different from the endorsement.

Levison commented that "The New York Times" article by Gene Roberts was placed in the paper intentionally for they apparently wanted him (King) to take that position.

Rustin said King had to make up his mind publicly and state whether he endorses the statement or not. Levison explained with regard to King's position that it could be that there was only a certain margin of difference between King and the others, and King differs only in the fact that he did not want to ignore or isolate those who have an erroneous slogan at the present time.

Rustin mentioned that he had talked to Floyd McKissick, Director of the Congress of Racial Equality (CORE), that morning and his position was that he just did not know why they continue telling "white folks" what their purposes are and they have been telling the whites for too long what they believe.

Rustin made the observation that King would be in a jam when hundreds of Negroes in the country would be endorsing and signing a statement of this nature if his name was not on it. He said in his opinion that it was a very serious mistake for King. Levison explained that it was his feeling that King would not sign the statement no matter how many were going to sign it. Rustin commented that one cannot continuously put himself in the middle this way and that was what King had done again. Rustin said that was bad with a large segment of white liberals and it was also bad with the Negro middle class. Levison said he was not convinced of that but added that it may be bad with some white liberals.

Levison suggested that Rustin should write to King about this situation. Levison mentioned that he had talked about arranging a trip for King and his wife to Africa and Latin America and place emphasis on the theme of King's interest in the poor of both white and black, in order that when he returned he could be the spokesman for both white and black poor.

The same source also advised on October 15, 1966, that Levison was in contact with Andrew Young (Executive Director, SCLC), on that date. Levison acquainted Young with the story in "The New York Times" that "Doctor King Endorses Racial Statement, Eacks Negro Repudiation of Black Power

October 14, 1966". Levison suggested that King had to write a letter to "The Times" in which he could clearly define where he stood. Young made the suggestion that they needed to say that the press came out and defined the context of the statement in the press and gave a misleading effect to it and the press should not continue to do this. Levison said that Rustin felt that King could not stay in the middle; it could do him tremendous harm. Levison said he told Rustin that King wanted to be in the middle. Levison also suggested that they could also say that King was endorsing the four principles in that statement.

With regard to the statement to which reference is made, on October 14, 1966, "The New York Times" on page 27, carried an article which was captioned "7 Negro Leaders Issue a Statement of Principles Repudiating 'Black Power' Concepts". Although King was not one of the signers of the declaration, the statement quoted Dr. John Morsell, Assistant National Director of the National Association for the Advancement of Colored People (NAACP), as having said that the absence of King's name was not a rejection by King of the statement.

The four principles in the statement to which Levison referred are:

"We are committed to the attainment of racial justice by democratic process".

"We repudiate any strategies of violence, reprisal or vigilantism and we condemn both rioting and the demagoguery that feeds it".

"We are committed to integration, by which we mean an end to every barrier which segregation and other forms of discrimination have raised against the enjoyment by Negro Americans of their human constitutional rights".

"As we are committed to the goal of integration into every aspect of the national life, we are equally committed to the common responsibility of all Americans, both white and black, for bringing integration to pass".

Young explained that he felt that King in his statement should say that while he realized the role of the Urban League and the NAACP, he never thought his role to be synonymous with theirs, and that while he understood the frustrations of the black people and their disillusionment with the administration, he was not ready to give up. Levison agreed with Young. Young indicated that he believed that the administration was trying to divide "us", but that King was not ready to say so. Levison indicated that he would like to get something in "The Times" by Monday.

"The New York Times", Monday, October 17, 1966, on page 42, carried an article captioned "Dr. King Clarifies His Stand". In it King is reported to have endorsed the four principles contained in the October 14, 1966 statement of the seven Negro leaders. He said, however, that he did not endorse the manifesto because he feared it might be interpreted by the press and public as an attempt to "excommunicate" from the civil rights movement such black power-oriented organizations as the Student Non-Violent Coordinating Committee (SNCC) and Congress of Racial Equality (CORE). *u*

On October 15, 1966, the same source advised that Stanley Levison and Martin Luther King were in contact on that date. Levison mentioned the article in "The Times" about King's endorsement of the statement and King replied, "That just shows you how you can get into a bind". Levison said he was convinced that Rustin did that; and he thought that Rustin wanted to box King in. Levison suggested that the way to handle the matter was to send a letter to "The Times" acknowledging the endorsement of the statement, but adding that

the endorsement was of the four principles that King had always accepted; however, the press had chosen to read this act as a rejection of the black power concepts and the organizations and this he could not accept and must clarify what his position was, rejecting black power as a slogan and any injury it might cause, but not rejecting the need for participation and power of Negroes.

King said he thought that that would be the only way out, and he added that what bothered him was that ^{when} he made tactical errors, it was usually when he was trying to deal with Rustin. Levison commented that King would have to rethink the business of treating Rustin as an adviser. King indicated that it made him look as if he did not have any integrity especially after he told Floyd McKissick of CORE that he did not sign the petition. King said he must be in a position where he would not be lumped in with Roy Wilkins of the NAACP and Whitney Young of the Urban League.

A confidential source, who has furnished reliable information in the past, advised on October 15, 1966, that on that date, Clarence Jones made the following observations: u

Martin Luther King not only refused to sign the statement (the statement condemning Black Power by civil rights leaders), but Bayard Rustin was the one who played the role. What happened was that the American Federation of Labor and the Congress of Industrial Organizations (AFL-CIO) working through Rustin, and the Administration working through Whitney Young (Head of the Urban League), tried to come up with this kind of statement. Rustin was prepared to present it to King, but King would not sign it. u

King said he did not agree with Stokely Carmichael on everything but Carmichael does articulate what many of the young people feel. King asked Rustin how he, King, could have their respect and continue to have a dialogue with them if he signed some statement "by some Mickey Mouse Negroes". u

Floyd McKissick had contacted King and said he was grateful that King did not sign the statement. u

King does not want to be cut off from the young people. King has been working with (youth) gangs in Chicago and he knows these gangs reflect the way Carmichael feels. King knows he can go into a room with these gangs and carry on a discussion with them. u

The source also advised on October 15, 1966, that Clarence Jones introduced Douglas Pugh to Martin Luther King. Jones described Pugh as the person who has a substantive role in the planning of the (Ford) foundation concerning poverty and civil rights. Jones said he felt it was important for King to talk with Pugh. u

Pugh told King that he had spoken to Jones about McGeorge Bundy (Head of the Ford Foundation), who is ready to move in the civil rights field. King noted that he was scheduled to meet with Bundy on Tuesday (October 18, 1966), after which he wants to work out a proposal which will be helpful to the (Ford) foundation. Pugh suggested that in King's meeting with Bundy the conversation should be broad and imaginative and that King should talk in terms of big money. u Pugh noted the White House Conference (on civil rights) had suggested a ten year program which has to be financed.

King suggested that he meet with Pugh after his discussion with Bundy. Pugh stated that King could reach him at the Ford Foundation which he recently joined after having worked with Haryou-Act and the anti-poverty program. u

On October 15, 1966, Stanley Levison, an adviser of Martin Luther King, Jr., President, Southern Christian Leadership Conference, was in contact with Bayard Rustin, another of King's advisers. The two discussed what position King should assume in the civil rights movement. Rustin argued that King cannot continually put himself in the middle because this is the wrong position according to a large segment of the white liberals and the Negro middle class. Levison did not agree entirely stating that it might be that way with some white liberals.

Levison explained that King's position is not too different from others. There is only a margin of difference. At the moment, King does not want to ignore or isolate those who have an erroneous slogan. Rustin was of the opinion that King should take a firm stand repudiating the "black power" groups.

Levison mentioned he had talked about arranging a trip for King and his wife to Africa and Latin America to place emphasis on King's being interested in the poor, both white and black. Upon his return, King would then be the spokesman for both white and black poor people.

On the same date, Levison was also in contact with Andrew Young, Executive Director, Southern Christian Leadership Conference. Levison acquainted Young with the "New York Times"

He stated that he did not want to be lumped in as taking the same role as Roy Wilkins of the National Association for the Advancement of Colored People and Whitney Young of the Urban League.

Stanley Levison is a long-time communist whose membership in the Communist Party, USA, has been established as of July, 1963.

During the early 1940's, Bayard Rustin was a member of the Young Communist League, an organization which has been designated subversive pursuant to Executive Order 10450.

A confidential source, who has furnished reliable information in the past, ascertained on October 11, 1966, that a person whom the source believed to be Douglas Pugh, Assistant Executive Director of Haryou-Act, contacted Clarence Jones regarding the advisability of Pugh attending the meeting of Martin Luther King and his advisors to be held in Atlanta, Georgia, on October 13,14, 1966. Pugh explained that his interest in attending the meeting is because he believes the foundation (the Ford Foundation) is interested in finding out what role it can play now (in the civil rights movement). He added that it might be meaningful for him to sit in on the discussions since they have this entry (to the Ford Foundation) through himself.

Another confidential source, who has furnished reliable information in the past, advised on October 11, 1966, that on that date, Jones told Stanley Levison that Douglas Pugh had informed him that (McGeorge) Bundy and the Ford Foundation are quite interested in Martin Luther King and the SCLC. According to Jones, Pugh said one of the policy discussions of the foundation is concerned with the programs they might finance in the civil rights movement and that Pugh was directed to see if he could sit in on the discussions that King and his advisors would be having.

Levison stated that he had spoken with an individual from the Ford Foundation for several hours and was told the same thing, that they are very interested. Levison said he was told that Bundy wants to give something to the SCLC because he wants to keep his relationship with Bobby Kennedy (Senator Robert Kennedy of New York), hoping that when Kennedy "gets in" he (Bundy) will be called back at a high level. D

Levison said he talked to King about what kind of proposals to make (to the Ford Foundation) and that he, Levison, raised the matter of voter registration in the South on the basis that there is much work to be done and Foundations used to support this. He said King felt this was top priority for them. D

Levison felt that Pugh should be invited when they discuss voter registration and its significance in the South. He said Jones should tell King this and that they should schedule this discussion for a specific day and invite Pugh to be there for it. D

According to the first confidential source mentioned, on October 10, 1966, Clarence Jones made plans to fly to Atlanta at 6:05 PM, October 12, 1966, by Eastern Airlines Flight 103, leaving Kennedy International Airport, New York, New York, and arriving Atlanta at 7:05 PM. u

The same source advised on October 11, 1966, that Stanley Levison stated he was taking the same flight and arranged to meet Jones at the airport. Levison further stated that reservations have been made for them to stay at the University Plaza Motel, 635 Fair Street, Atlanta, Georgia. D

The first source mentioned indicated on October 10, 1966, that (Harry) Wachtel would be taking Eastern Airlines flight 103 to Atlanta, Georgia, on October 12, 1966. u



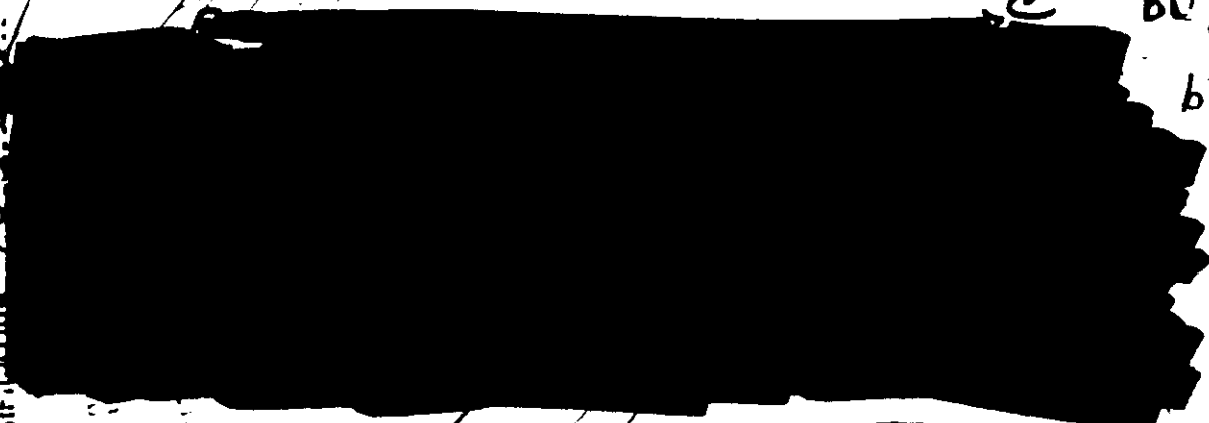

Due to the interest of the President in the activities of Stokely Carmichael and his organization, the Student Nonviolent Coordinating Committee, as well as the prominent position of Martin Luther King, Jr., President, Southern Christian Leadership Conference, in the civil rights movement, we have prepared a summary setting forth the current activities of these individuals and their organizations.



On 9/29/66, confidential source [redacted] advised that King and Stanley Levison, a long-time secret communist and a principal advisor to King, were in contact that day. King expressed extreme dissatisfaction with the election of Lester Maddox as the Democratic nominee for the Governor of Georgia which indicates a sickness developing in the Nation and he wants a two or three day conference to decide what to do about this. King informed Levison that Whitney Young, Executive Director, Urban League, is upset about the Nation as a whole and something must be done to shock white America. Young is thinking about resigning and King commented he was thinking about doing the same. Levison observed that resigning would not be shocking enough to white America.

On 10/1/66, confidential source [redacted] advised that Levison and Clarence Jones, reportedly in the mid-50's was a leader of the Labor Youth League, an organization designated pursuant to Executive Order 10450, were in conference on that date. Levison stated that King is depressed about current events and that upon Levison's suggestion, King is planning a three-day conference with the "Research Committee" of the Southern Christian Leadership Conference in New York or Chicago the week of 10/10/66.

Jones was highly critical of Stokely Carmichael, commenting that there is too much toleration of him and that Lester Maddox would never have been nominated in Georgia if "that idiot Stokely" had not started a riot in Atlanta. u

Levison stated that the Southern Christian Leadership Conference is low on funds with no immediate money forthcoming; therefore, there is a need to get busy with benefits and freedom rallies.

It should be noted that the information concerning the President's conference with King wherein the President "discreetly" requested King to obtain commitments from all civil rights groups to abstain from violence and demonstrations until after the November elections is not being disseminated to the Attorney General. The remainder of the information furnished the White House is set forth in a separate communication to the Attorney General which is attached.

RECOMMENDATION:

That the attached communications be forwarded by routing slips to the Honorable Marvin Watson, Special Assistant to the President, and to the Attorney General.

On October 10, 1966, a source who has furnished reliable information in the past stated that Dr. Martin Luther King, President, Southern Christian Leadership Conference (SCLC), Atlanta, Georgia, will be in Norfolk, Virginia, on Sunday, October 30, 1966, in connection with the installation of the Reverend Milton A. Reid as minister of the New Calvary Baptist Church, 800 Virginia Beach Boulevard, Norfolk, Virginia.

The source further advised that Reid is Regional Director, SCLC, and has been closely associated with King in civil rights demonstrations at Petersburg and Danville, Virginia, organized and directed by SCLC.

The source stated that King is scheduled to speak from the pulpit of the New Calvary Baptist Church at the 11:00 a.m. and 3:00 p.m. services on October 30, 1966, and overflow crowds from all of Tidewater, Virginia, are expected.

The source stated that no outdoor rallies or demonstrations are planned in connection with King's appearance and believes that his coming to Norfolk is due to the close friendship between King and Reid.

 was advised as to the above information and stated that he will make the necessary arrangements to assure that Dr. King's appearance in Norfolk is afforded appropriate coverage.

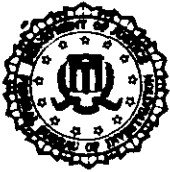

The following information has been supplied by confidential sources of this Bureau who have furnished reliable information in the past.



King on September 29, 1966, was in contact with one of his principal advisers, Stanley Levison, a long-time communist whose membership in the Communist Party, USA, has been established as of July, 1963. Levison told King that Dr. Kenneth Clark, Professor, City College of New York, New York City, and associated with Harlem Youth Opportunities Unlimited, a New York City arm of the Federal poverty program, wants to talk to King in the near future about a meeting he had with Stokely Carmichael. King indicated he would get in touch with Clark.

King mentioned he got "sick" last night when Lester Maddox was chosen as the Democratic nominee for Governor of Georgia, and he mentioned that he can see this sickness developing in the whole Nation. King commented he can see a tragic development taking place and that "black


power" is at its most powerless point right now. King stated he wants to have a two-or three-day meeting to decide what to do about it. King made the observation that the Southern Christian Leadership Conference staff is in a state of confusion.

King said Whitney Young, Executive Director of the Urban League, called him and said that he was upset about the Nation as a whole and with the white America which sends them to war against poverty and does not give them the instruments. According to King, Young believes something must be done to shock white America and that Young was so depressed he was thinking about resigning. King commented that he was thinking about doing the same thing. Levison made the observation that resigning would not be shocking enough to white America.

Levison said the odds concerning the Police Review Board in New York are very much against its being approved. He said the key vote will be the Jewish vote and he suggested King talk with rabbis about the Review Board and the "backlash."

Levison said that "they" are going to get Senators Jacob K. Javits and/or Robert F. Kennedy to talk with the rabbis to strengthen their stand on the Review Board.

King said he would be in New York on Wednesday, October 5, 1966, but merely to change planes to go to Rhode Island, and that he has to be back in Atlanta on Thursday.

Levison advised that King has been very depressed lately over current events, and King told him that he has been talking and making speeches but he really does not know

what he is saying. Levison suggested a conference with King, and King is contemplating a three-day conference with the "Research Committee" of the Southern Christian Leadership Conference the week of October 10, 1966, in New York or Chicago. Jones agreed as to the need for such a conference and commented that there is no person in the civil rights movement who has ideologically "taken on" Stokely Carmichael. Jones stated that Carmichael is reaping political havoc and must be "isolated like a black Trotskyite." Carmichael is absolutely insane and there is too much toleration of him according to Jones. Levison and Jones agreed that the nomination of Lester Maddox in Georgia would not have happened if "that idiot Stokely" had not started a riot in Atlanta. They both agreed that "Stokely must be politically isolated."

Levison informed Jones that when he was in Chicago he met Gould Maynard, who is employed by Radio Free Europe, and that when Levison told Maynard "I always had the feeling that Radio Free Europe is a fake," Maynard replied "Off the record, I agree with you." Maynard then went on to illustrate to Levison how they do not tell the truth on Radio Free Europe.

In commenting on Southern Christian Leadership Conference funds, Levison advised that this organization is running short of money and "we should get busy with benefits and freedom rallies." Levison further advised that he told King that Southern Christian Leadership Conference could not expect any funds from mail solicitations until next February. Jones and Levison then discussed the fact that Dr. Kenneth Clark is getting funds from the Ford Foundation and that Southern Christian Leadership Conference should also endeavor to get funds from this source.

Dr. King and the Firemen

DR. MARTIN Luther King Jr.'s entry into the Atlanta firemen's strike is ill-considered, damaging and unworthy.

This strike has been a taxing one and, in its earlier stage, a perilous one for the whole city. It is a problem in which the issues are not simple. Dr. King vastly oversimplifies them and does an injustice to Mayor Ivan Allen and others in the city government when he attempts to reduce the whole thing to a matter of simple unfairness to the strikers.

The city has been underpaying its firemen, and many others in city service, for a long time. It should have responded better, some time ago, to their needs. Since the strike began, it has moved for a substantial increase in pay, with more committed as soon as funds are available. The city has completely accepted the findings of a mediator. And the mayor himself has taken a leading role in seeking stronger financing of city government so that city employes may be properly provided for in the future.

These are the basic facts about the firemen's pay and the financing of it.

There are other facts of paramount importance in this strike, and it appears that Dr. King has ignored them. The first of these is that Atlanta firemen, like those elsewhere, take an oath not to strike. The reasons are obvious: The public safety is at stake.

The second paramount fact is that Atlanta firemen had a recognized union, part of the International Association of Fire Fighters, AFL-CIO, which was the proper bargaining agent. But the firemen who went on strike had abandoned it for a maverick union that has no recognition, one that apparently was formed under the mischievous influence of the Teamsters Union (not a part of the AFL-CIO).

The union that went on strike has no credentials for collective bargaining for the firemen. The strike has been condemned by the AFL-CIO's top leadership, and the international president of the AFL-CIO firemen's union now has protested Dr. King's support of the local maverick union.

Meanwhile, real progress has been made toward better reimbursing firemen and toward manning all stations with men who will not in the future endanger lives and property in violation of their oaths.

Dr. King has entered into this unhappy business with, apparently, no real understanding of all this. Mayor Allen said, after conferring with him, that no concessions had been made but he thought Dr. King had emerged with "better understanding of the facts."

We certainly hope that is true. It was an ill-considered intrusion and it should proceed no further.

SCLC Renews Vow To Aid Firemen

By TOM GREENE

Representatives of striking Atlanta firemen plan to meet later this week with members of Dr. Martin Luther King's Southern Christian Leadership Conference to discuss what support the rights group can lend the firemen.

Former fire Capt. James L. Martin, leader of the Atlanta Firefighters Union Independent which went on strike last Sept. 3 after failure to reach an agreement on wages and hours with the city, said the meeting tentatively was arranged Monday night after Rev. Andrew Young, a top aide to Dr. King, spoke to the firemen.

Rev. Young assured the firemen, who were fired by the city Sept. 5 after refusal to return to work, that SCLC stood behind them "and would support us in our endeavor in any way they could," Capt. Martin said.

DR. KING last week wired Capt. Martin his support of the striking firemen and told him "you may count on me for any help which my schedule permits."

Capt. Martin said he does not know if Dr. King will be at the meeting this week, nor what specifically will be discussed.

He said Rev. Young offered to set up the later meeting "to discuss the situation to see if there is any area in which they could assist us specifically."

One way in which SCLC may be asked to help, he said, is to assist the firemen in getting enough names on a petition to put the strike question before the people of Atlanta in the form of a referendum.

THE FIREMEN are circulating petitions to call for the referendum and Capt. Martin said they had about 24,000 signatures as of Monday night, "the minimum amount" they wanted to get. He said they will continue to circulate the petition in an attempt to get several thousand more names before the petition is presented to the city clerk, hopefully in about a week or 10 days.

The city fired some 470 of the striking firemen after they refused to return to work last month. Some of the strikers did go back on the job, and the city has hired some others. As of Monday, some 440 firemen were on duty (as opposed to an original 726) and all but one station manned due to the fact that some firemen are working a 100-hour week. Station No. 2 on Lakewood Avenue is the only unmanned station, officials said.

City officials said the city had about 70 Negro firemen on duty before the strike, and most of them participated in the walk-out and subsequently were fired.

On October 1, 1966, a confidential source, who has furnished reliable information in the past, advised that Clarence Jones and Stanley Levison were in contact on that date. Their conversation concerned the following:

Jones remarked that he was going to Chicago, Illinois, later during the day (October 1, 1966). He said he also learned that the benefit show which had been scheduled for the SCLC had been postponed due to the illness of Sammy Davis. Levison remarked he was glad it had been postponed since very little effort had been expended to make the show a success.

Levison mentioned that Martin Luther King was in Atlanta and was very upset and depressed over events in the country. Levison remarked that King had been talking and making speeches and did not know what he was saying, and as a result of King's depression, Levison said he suggested to King that he hold a three day conference with the Research Committee in New York or Chicago during the week of the tenth of this month. King had agreed. This meeting, Levison said, would be followed by SCLC staff meetings.

Jones remarked that talks were needed very much; that he personally had some arguments with some close friends of his; that while he felt very strongly that white racism was fundamentally the problem in terms of coalition with white forces in America, there was no person in the civil rights movement who ideologically was taking issue with Stokely Carmichael. and you have to fight for the supremacy of your theory; that if your theory is being attacked, you have to isolate those people who are trying to destroy it. Levison and Jones concurred that what happened in Georgia (the nomination of Lester Maddox to be the Democratic candidate for Governor) was incredible and did not have to happen if "that idiot Stokely" did not start a riot in Atlanta. They agreed that Carmichael must be politically isolated. If he is not, Jones said, he (Jones) could foresee no way of bringing about a successful alliance. Levison opined that Carmichael, by leading a small group into battle at the wrong time, did more damage to the civil rights movement than one who was a paid agent could do.

Levison disclosed to Jones that he went to Chicago, Illinois, earlier in the week and observed the SCLC active in trying to organize hospital workers and other service industries. In this regard, Levison said, the IUD (Phonetic) furnished them with ten full time organizers to organize these services.

Jones inquired of Levison who is running the SCLC at this time. Levison said Hosea (Hosea Williams) is in charge of "Southern direct action"; James Bevel, is director of "Northern direct action"; Dorothy Cotton is in charge of citizenship training, and Fred Bennett is in charge of public relations.

According to Levison, while he was in Chicago, he met Gould Maynard (Phonetic). Maynard, Levison said, is working for Radio Free Europe and when he (Levison) remarked "I always had the feeling that Radio Free Europe is a Fake", Maynard replied, 'off the record, I agree with you' and then illustrated how they don't tell the truth on Radio Free Europe.

Andrew Young (Executive Director of the SCLC) Levison said, is now running the SCLC and in his own style while Hosea (Hosea Williams) and James Bevel are doing pretty much what they want to do.

Levison said King had told him that a desperate need exists for a director in Chicago and that George Wiley is a possibility (Wiley was formerly with the Congress of Racial Equality) for the task. Furthermore, King cited financial problems as another burden of the SCLC, and suggested "we" get busy with benefits and freedom rallies.

Jones told of Kenneth Clark's desire to see King when he returns to New York. Levison said he (Clark) had been working on two grants: one for the establishment of a place, under the guise of a fellowship, where civil rights leaders can go for rest, reflection and meetings. According to the source, Levison did not describe the other grant. Jones mentioned that Clark is getting funds from the Ford Foundation. He also mentioned that Doug Pruitt (phonetic) went to the Ford Foundation and is scheduled to become the special assistant to McGeorge Bundy (Director of the Ford Foundation). Pruitt, Jones added, wants to get in touch with most civil rights leaders to get their ideas on how the Ford Foundation can be most effective. Levison said Pruitt had mentioned to him that the Foundation has an interest in dealing with poverty in the ghetto. And as a consequence Levison remarked, the SCLC should develop some outlines and try for a response from the Foundation.

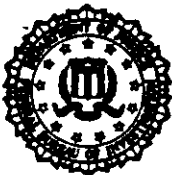

On September 29, 1966, articles in Chicago's press
media reflected the arrival of Dr. King, identified as President,

reported additionally that King was to meet on September 29,

[REDACTED] advised the Chicago FBI Office at 10:15 A.M., September 30, 1966, that a CFM March was to have taken place this morning from the intersection of Millard and Douglas Boulevard, to a slum tenement building located at 1024 South Independence Boulevard, Chicago. According to [REDACTED] the march was to have commenced at 9:30 A.M. on this date and was to have been led by Dr. King.

As of 10:30 A.M., September 30, 1966, [REDACTED]

[REDACTED] advised that as of this time only nine persons had gathered at Millard and Douglas Boulevard and Dr. King had not yet made an appearance. He advised that his information was that these individuals were awaiting the arrival of Dr. King before proceeding. [REDACTED] no problems from such a demonstration in the event it takes place.

At 12:30 P.M., September 30, 1966, [REDACTED]

[REDACTED] advised the Chicago FBI Office that no CFM March or demonstration had taken place during the morning hours of this date. [REDACTED] advised that Dr. King had appeared at the apartment building located at 1024 South Independence Boulevard and had discussed with the Negro residents their housing problems. No incidents, disturbances or arrests had resulted.

[REDACTED] advised that King was to appear in the early afternoon hours of this date as a speaker before the convention of the Radio-Television News Directors Association, then was to visit the Englewood area on Chicago's south side during the afternoon or evening hours of this date, this the area where an urban renewal program is an issue.

[REDACTED] advised that on September 29, 1966, King had met with Mr. Louis Hill, Local Urban Renewal Commissioner, in an attempt to have Hill delay renewal plans for the central Englewood area until a civil rights suit protesting this renewal program can be decided in the courts. b7(p)

At a subsequent press conference, King had stated that he had had no success in these efforts, that he had been advised the Urban Renewal Program would be continued, adding that the CFM may be forced to organize a Negro boycott of the shopping area around 63rd and Halsted as a result. King had called this project a "Negro Removal" Program in an additional effort to continue housing segregation in the greater Chicago area.

At this press conference, King had been questioned concerning the election of segregationist Lester Maddox as the Democratic nominee for Governor of Georgia, and he described this election as indicative of a basic sickness in the State of Georgia. When questioned concerning a report of a rising white backlash to the civil rights movement, King stated that he preferred to call it a backward step on part of the white community, feeling that there could be no question that the fears and hatred of the white community at this time are very large. He had stated "I am afraid of what lies ahead of us, we could end up with a full scale race war in this country -- it is very frightening."

An article appeared in the "Chicago's Sun-Times" dated October 1, 1966, concerning the address of King made on September 30, 1966, before the Radio-Television News Directors Association meeting held in Chicago. King had stated that any suppression of news is bad and described the right to be informed as part of the sacred heritage of our nation.

King had described civil rights as our most urgent domestic problem and stated that it was absolutely essential that the news media give full coverage to civil rights matters.

He said he was convinced that there would have been many more disturbances and disorders during the course of the recent open-housing marches in Chicago if television cameras had not been on the scene. He stated that nothing could be more tragic than a failure to cover something that the whole nation should see, because it is part of a struggle taking place in our land. King concluded that the civil rights movement, however, just now has descended into a valley and some days of depression are ahead. As long as there are "two Americas, one for the whites and one for the blacks, the fight must and will go on." He termed violence both impractical and immoral, and said he is more convinced than ever non-violent demonstrations are the most potent weapon available for the Negro.

Rev. J. HENRY PATTEN, Secretary of the Civil Committee of the Baptist Ministers Conference in Philadelphia, had been in contact with the Civil Rights Congress in Philadelphia.

The Baptist Ministers Conference had become interested in those cases involving discrimination against Negroes and as Secretary PATTEN frequently represented the Conference in connection with these cases. Frequently, the Civil Rights Congress was interested in these cases, too, and requested the Baptist Ministers Conference to work with it.

The Civil Rights Congress (CRC) has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

In late 1951, Rev. PATTEN cooperated closely with JOHN HOLTON, Secretary of the CRC in Philadelphia, in connection with the case of Rev. STANLEY HATCH, a Baptist minister from Wildwood, N.J., who was arrested on a complaint from a female parishioner and charged with rape. The CRC agreed to support HATCH's case.

While arrangements were being made to employ a different attorney, JOHN HOLTON, Rev. HATCH, and Rev. WILLIAM L. BENTLEY, pastor of the Emmanuel Baptist Church, traveled to New York City to confer with WILLIAM L. PATTERSON, National Director of the CRC. The purpose of

this visit was to receive PATTERSON's approval for the CRC to assume financial responsibility for the HATCH case. As a result of this meeting, PATTERSON officially agreed that the CRC would wholeheartedly support the HATCH case.

On page 3 of the September 27, 1966, issue of "The Evening Bulletin," a Philadelphia newspaper, Philadelphia, Pa., appeared an article entitled, "'Black Power' Confusion Cuts Gifts KING Says." This article reflects that the Reverend Dr. MARTIN LUTHER KING stated on Monday, September 26, 1966, that confusion over the meaning of "Black Power" has been a factor in the decrease in contributions to the civil rights movement; however, at the "Freedom Show" held, his organization was presented a check for \$10,000, which was presented to the Reverend RALPH D. ABERNATHY, Vice President and Treasurer of the SCLC. The \$10,000 was part of the proceeds from the "Freedom Show" sponsored by GEORGIE WOODS, local disc jockey, at which more than 9,000 were in attendance. In accepting the check, Mr. ABERNATHY told the audience that "We're going back down South and continue our fight for freedom and equality, and we'll take nothing else." PA

Earlier at a press conference at the Emmanuel Institutional Baptist Church, 22nd Street and Columbia Avenue, Dr. KING scoffed at reports that concern over the "Black Power" term was responsible for defeat of the 1966 Civil Rights Bill. According to KING, Congress was not prepared to act in the first place. JAMES MEREDITH, who was seated beside KING for

the press conference, agreed with him on this evaluation. KING further stated the defeat of the Civil Rights Bill, primarily because of its open housing provisions, means the death of justice and democracy in America. As long as there is such a thing as closed housing markets in the cities the inner cities will constantly face problems.

When asked if he plans to come into Philadelphia to push the open housing as he has done in Chicago, Dr. KING replied he had no present plans to come to Philadelphia, but his organization will be in Chicago for several months. KING also refused to make comment concerning STOKELY CARMICHAEL, head of the Student Nonviolent Coordinating Committee (SNCC), but he did say he would not accept black separateness or violence, both of which are advocated by CARMICHAEL.

[REDACTED] further advised that immediately after the "Freedom Show" JAMES MEREDITH drove to New York City while KING and his party returned to the Sheraton Hotel. ABERNATHY departed Philadelphia early on Tuesday morning while KING and LEE departed Philadelphia by air for Washington, D.C., at about 1 p.m. b7(D)

On page 2 of the September 24, 1966, issue of "The Philadelphia Inquirer," a Philadelphia newspaper, appeared an article indicating that Dr. MARTIN LUTHER KING and JAMES MEREDITH would head the list of speakers at a giant civil rights rally in the Arena, 46th and Market Streets, Philadelphia, on October 9, 1966. This rally, which will begin at 7 p.m., is being sponsored by the Interfaith - Interracial Council of the Clergy, and was described by a leader of this group as the biggest, most fruitful rally ever held for the benefit of civil rights in Philadelphia. The proceeds from the rally will go toward the Meredith Mississippi March.

This article further reflects that the Interfaith - Interracial Council of the Clergy was founded following the North Philadelphia riots two years ago by the Rev. WILLIAM L. BENTLEY, pastor of the Emmanuel Institutional Baptist Church.

The following information has been supplied by confidential sources of this Bureau who have furnished reliable information in the past.

On September 29, 1966, Hosea Williams, Director, Voter Registration, Southern Christian Leadership Conference, stated that President Johnson had "discreetly" requested Martin Luther King, Jr., President, Southern Christian Leadership Conference, to obtain commitments from all civil rights groups to abstain from violence and demonstrations until after the November, 1966, elections. Williams stated the President assured King that he would continue to press for civil rights reforms through legislation.

King on September 29, 1966, was in contact with one of his principal advisors, Stanley Levison, a long-time communist whose membership in the Communist Party, USA, has been established as of July, 1963. Levison told King that Dr. Kenneth Clark, Professor, City College of New York, New York City, and associated with Harlem Youth Opportunities Unlimited, a New York City arm of the Federal poverty program, wants to talk to King in the near future about a meeting he had with Stokely Carmichael. King indicated he would get in touch with Clark.

King mentioned he got "sick" last night when Lester Maddox was chosen as the Democratic nominee for Governor of Georgia, and he mentioned that he can see this sickness developing in the whole Nation. King commented he can see a tragic development taking place and that black power is at its most powerless point right now. King stated he wants to have a two- or three-day meeting to decide what to do about it. King made the observation that the Southern Christian Leadership Conference staff is in a state of confusion. S

King said Whitney Young, Executive Director of the Urban League, called him and said that he was upset about the Nation as a whole and with the white America which sends them to war against poverty and does not give them the instruments. According to King, Young believes something must be done to shock white America and that Young was so depressed he was thinking about resigning. King commented that he was thinking about doing the same thing. Levison made the observation that resigning would not be shocking enough to white America. S

Levison said the odds concerning the Police Review Board in New York are very much against its being approved. He said the key vote will be the Jewish vote and he suggested King talk with rabbis about the Review Board and the "backlash." S

Levison said that "they" are going to get Senators Jacob K. Javits and/or Robert F. Kennedy to talk with the rabbis to strengthen their stand on the Review Board. S

King said he would be in New York on Wednesday, October 5, 1966, but merely to change planes to go to Rhode Island, and that he has to be back in Atlanta on Thursday. S

Levison advised that King has been very depressed lately over current events, and King told him that he has been talking and making speeches but he really does not know what he is saying. Levison suggested a conference with King, and King is contemplating a three-day conference with the "Research Committee" of the Southern Christian Leadership Conference the week of October 10, 1966, in New York or Chicago. Jones agreed as to the need for such a conference and commented that there is no person in the civil rights movement who has ideologically "taken on" Stokely Carmichael. Jones stated that Carmichael is reaping political havoc and must be "isolated like a black Trotskyite." Carmichael is absolutely insane and there is too much toleration of him according to Jones. Levison and Jones agreed that the nomination of Lester Maddox in Georgia would not have happened if "that idiot Stokely" had not started a riot in Atlanta. They both agreed that "Stokely must be politically isolated!"

Levison informed Jones that when he was in Chicago he met Gould Maynard, who is employed by Radio Free Europe, and that when Levison told Maynard "I always had the feeling that Radio Free Europe is a fake," Maynard replied "Off the record, I agree with you." Maynard then went on to illustrate to Levison how they do not tell the truth on Radio Free Europe.

In commenting on Southern Christian Leadership Conference funds, Levison advised that this organization is running short of money and "we should get busy with benefits and freedom rallies." Levison further advised that he told King that Southern Christian Leadership Conference could not expect any funds from mail solicitations until next February. Jones and Levison then discussed the fact that Dr. Kenneth Clark is getting funds from the Ford Foundation and that Southern Christian Leadership Conference should also endeavor to get funds from this source.

The information concerning the President's conference with King wherein the President "discreetly" requested King to obtain commitments from all civil rights groups to abstain from violence and demonstrations until after the November elections is not being disseminated to the Attorney General.

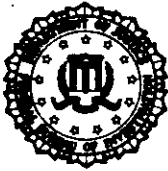

The following information supplements that contained in memorandum dated September 15, 1966, at Dallas, Texas:

A news item in "The Dallas Morning News" for September 26, 1966, disclosed that Dr. Martin Luther King had spoken before the international convention of Christian Churches (Disciples of Christ) at Dallas Memorial Auditorium on the night of September 25, 1966, after holding a press conference at Love Field, Dallas, upon his arrival in Dallas on the afternoon of the same day.

A confidential source, who has furnished reliable information in the past, advised on September 26, 1966, that members of the Dallas Unit, American Nazi Party (ANP) (See appendix), picketed briefly in front of Dallas Memorial Auditorium on the night of September 25, 1966. Source identified them as Jerald T. Walraven, officer in charge of the Dallas Unit ANP; Alvis Neil Gray; Johnny Hillhouse; and Don Mock, the latter not known to be a member of the ANP as yet, but active to a limited extent in ANP affairs in recent weeks. Source stated all were taken by police to police headquarters and released. There was no violence, no other groups demonstrating, and no arrests were made. MEMPHIS

THE GEORGE LINCOLN ROCKWELL PARTY

In his book "This Time The World," copyrighted in 1961, George Lincoln Rockwell identified himself as Commander, American Nazi Party of the World Union of Free Enterprise National Socialists (ANP - WUFENS), Arlington, Virginia.

The April 4, 1963, issue of "The Richmond News Leader," a Richmond, Virginia, daily newspaper, reported that George Lincoln Rockwell had, on the previous day, again applied for the American Nazi Party to be chartered in the State of Virginia, but this request was turned down by the Virginia State Corporation Commission. This action was taken pursuant to an act of the 1962 Virginia Assembly which prohibits use of "Nazi" or "National Socialism" in a Virginia charter. This article further pointed out that Rockwell's Party is presently chartered in the State of Virginia as the George Lincoln Rockwell Party.

On August 4, 1964, a source advised that the ANP - WUFENS was organized by George Lincoln Rockwell as his residence in Arlington, Virginia, on February 26, 1959, as an international "National Socialist" movement based on the German Nazi Party headed by Adolf Hitler. He added that Rockwell is the dominant force and personality in this party; that he is espousing a "line" of hatred against the Jews and Negroes; and that he is seeking, through speeches, distribution of literature and picketing, to establish a cohesive and dominant political party in the United States and in foreign countries.

According to the "Stormtrooper's Manual," an official publication of the ANP, the phases of ANP struggle for power are fourfold, namely, first "to make ourselves known to the masses;" second, "the dissemination of our program and truth about the Party;" third, "organizing the people who have been converted to our propaganda;" and fourth, "the attainment of power through the votes of the newly-won masses."

On September 16, 1965, the source advised that George Lincoln Rockwell believes he has completed the first three phases in his struggle for power and is now into the fourth stage, to wit, the "attainment of power through the votes of the newly-won masses." The source stated Rockwell believes this because of his success in gaining a place on the ticket in the November, 1965, gubernatorial election in the State of Virginia.

DALLAS UNIT

On July 28, 1966, a source furnished the following information:

The Dallas Unit of the American Nazi Party (ANP) is a local chapter of the ANP, which has its national headquarters in Arlington, Virginia. Robert Alan Surrey, a Dallas printing salesman, is Southwestern Regional Coordinator, and Jerald Thomas Walraven is the "Lieutenant" in charge of the Dallas Unit, ANP.

As of July, 1966, the Dallas Unit consisted of an estimated 20 persons, of which about five persons were storm troopers. The Dallas Unit had no headquarters as of that time, but was using the mailing addresses P. O. Box 22071 and P. O. Box 3980, Dallas, Texas.

Activity consisted of meetings, held on a fairly regular monthly basis, of a social group and weekly meetings, held every Thursday night, of the storm trooper group. Demonstration activity was at a minimum because, according to statements made by Jerald Thomas Walraven, the Dallas ANP was so ill-prepared for such activity, being made up of such a small group of storm troopers, and the sloppy attitude of those storm troopers in the Dallas Unit.

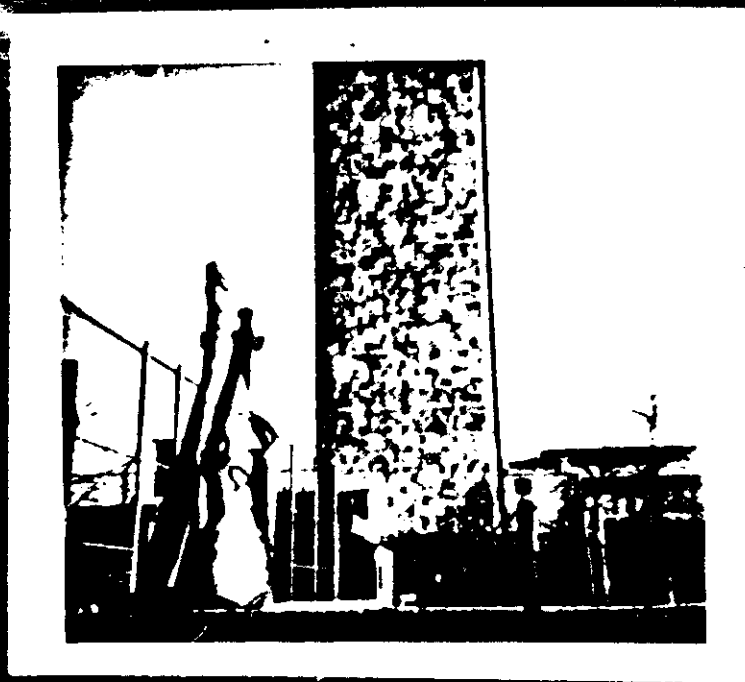

"Young, 34, is the executive director of the Southern Christian Leadership Conference and King's No. 1 aide. Young has been with the SCLC for six years and has been involved in the civil rights demonstrations in Chicago this summer. A Baptist minister, Young is married and has two children.
