

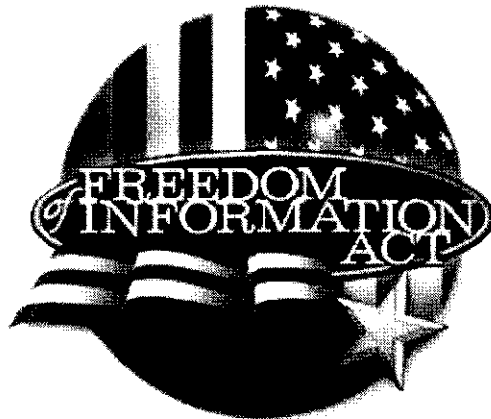

in the past, on March 11, 1967, advised that the Women for Peace, Chicago Area, on that date from 11:00 AM to 1:00 PM held a peace vigil and leaflet distribution on the east side of State Street, between Madison and Washington Streets in downtown Chicago, Illinois. Twentyfour people participated in the demonstration, the announced purpose of which was to protest United States intervention in Viet Nam and to urge people to work for peace.

The people carried placards during the demonstration which contained such statements as "Bring the Boys Home," "Stop the War in Viet Nam," "Stop the Bombing," "Not My Son, Not Your Son, Not Their Son."

The participants distributed a leaflet which contained a picture on the front page of a Vietnamese woman crying, and under the picture was the question "Isn't it time you spoke out to stop the war in Viet Nam?"

The leaflet also announced that peace, labor, religious, civil rights and student organizations in the Chicago area on March 25, 1967, plan to jointly hold a Parade and Rally for Peace in Viet Nam. Arrangements for this Rally and Parade are being made by the Chicago Committee for a Sane Nuclear Policy and the Chicago Peace Council under the name "March 25th Peace Committee." This parade will begin at Wacker Drive and State Street in downtown Chicago at noon March 25, 1967, and will proceed

The peace vigil and leaflet distribution on March 11, 1967, concluded peacefully and there were no incidents or arrests.

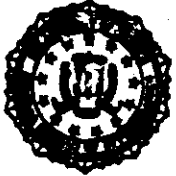

On March 6, 1967, a confidential source, who has furnished reliable information in the past, advised that information had come to his attention which disclosed that on that date, Stanley Levison was in contact with a man whose name was unknown to the source. Levison took the opportunity to apprise the man about a meeting of the Research Committee, SCLC, which he attended that date. The meeting, according to Levison, was held in the law office of Harry Wachtel, 598 Madison Avenue, New York, New York, and was attended by the following people: Wachtel, Levison, Martin Luther King, Bayard Rustin, James Bevel, Doctor Lawrence Reddick and Robert Green, a professor from Michigan State, and others whom Levison did not identify.

According to the information received by the source, one of the items considered by the participants in the conference was, whether Martin Luther King should participate in the "march" scheduled for this Spring in New York to protest United States involvement in Vietnam. Everyone was opposed to King's becoming involved except James Bevel. It was King's feeling that he would be considered a coward unless he became involved. However, King decided to think about the matter for a couple of days before making a final decision.

An Associated Press dispatch dated January 28, 1967, appearing in the "Ithaca Journal", a daily newspaper published in Ithaca, New York, indicated Reverend James L. Bevel had been selected as the National Director of the Spring Mobilization Committee in order to emphasize the recruitment of Negroes and civil rights workers. This committee was organized to coordinate demonstrations against the war in Vietnam, scheduled for April 15, 1967, in New York City. u

On March 6, 1967, the first source reported above, furnished information that Stanley Levison and William Stein, a fund raiser for the SCLC, were in contact on that date. It was during their contact that Levison made mention of the fact that he would be going to Atlanta, Georgia, on March 8, 1967, to attend a meeting of the SCLC, which is being held to re-organize the SCLC.

On March 7, 1967, the same source advised that Levison and Adele Kantor, the Director of the SCLC Office in New York City, New York, had reason to be in contact on that date. During their contact Levison apprised Kantor of the meeting of the SCLC to be held in Atlanta, Georgia, on March 9 - 10, 1967, the purpose of which will be to discuss a profound reorganization of the SCLC. Those who will attend will be the members of the Executive Committee and the Executive Staff.

In assuring Kantor that her status with the SCLC will not change, Levison mentioned that King had come to a realization that a re-organization must be made. King, according to Levison, has watched one project after another run into a stone wall, like Hosea Williams in Chicago and others. King has come to a conclusion that his people should not make decisions on their own.

The source said he had learned that Levison will stay at Paschal's Motor Hotel while in Atlanta, Georgia.

On March 7, 1967, according to the same source, Martin Luther King and Stanley Levison were in contact. Among the items of business discussed by them was King's attendance at a fund raising dinner in New York several days ago. The dinner was attended by about twenty people, and the SCLC derived approximately \$17,000 and pledges for another \$35,000.00 to be paid over a period of three years. One of those who pledged \$15,000.00 of the \$35,000.00 was Mr. Englehard, the owner of Englehard Industries.

King was cautioned by Levison against getting involved with Englehard, since he owns extensive holdings in South Africa and Rhodesia, therefore, he could be using the SCLC to get the curse off his back. Levison will do some checking on his own before giving King approval to deal with Englehard.

The affair which King attended was held in the home of a Mr. Burden, who is reportedly the son of the principal stockholder in the Columbia Broadcasting System. After hearing that, Levison was of the opinion that Burden should be contacted periodically in order to keep up the contact. It was King's belief that the Executive Director of the SCLC should make such contact; however, according to King, he is trying to fill the post in view of the fact that Andrew Young is always out of town on business.

Another matter considered was the candidacy of James Meredith for the vacant Congressional seat of Adam Clayton Powell. Levison was of the opinion that Meredith is as opportunistic as Powell. Both concurred that Powell will beat Meredith awfully bad.

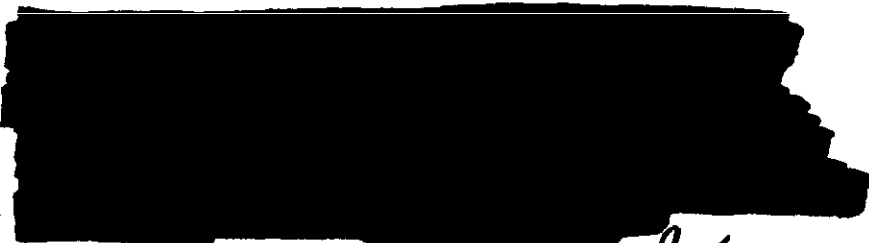



Dr. King Sees 'Ugly Racial Overtones' in Powell Ouster

By Lorraine Staats
Times Staff Writer

Following his scheduled lecture in Ban Johnson Field House yesterday morning, Dr. Martin Luther King Jr. turned his attention to answering questions submitted in writing from the audience.

Most frequently asked, and candidly answered by the Civil Rights leader, was the request for his view on the unseating of Cong. Adam Clayton Powell.

Dr. King termed the action as "unreasonable of Congress to take this step," remarking in preface that "people respond so emotionally to the question of Adam Clayton Powell that it is difficult to discuss it rationally."

Misdeeds Not Condoned

However, he assured his audience that the Negro people do not condone misdeeds of Powell and that he felt no one was defending such misdeeds, but

"the great injustice done Powell is an injustice to the Negro people as a whole—because it is unconstitutional to unseat a man who meets constitutional requirements — as Powell did."

"Beyond the constitutionality, I see in it a danger of tragic and ugly racial overtones," he continued, "when Negroes protest the unseating, it is a congressional hypocrisy protest. Much more dangerous men in America today are engaging in evil acts and condoning murder and nothing is being done about it."

In answer to another question, he said the recent murder of Wharlest Jackson in Natchez, Miss., pointed up the need to change the legal system and get some new legislation to deal with such crimes, and to a query on his feelings about a statement attributed to Stokely Carmichael that the war in Vietnam is "McNamara's Negro urban removal," he indicated his disagreement with the war was on another front — that of humanitarianism and religion and his complete refusal to kill anyone.

Referring to the busing of school students, Dr. King approved the action on the grounds that "in order to have multi-racial classes and schools, which are necessary in a multi-racial society, then we must have the inconvenience of busing."

Hard to Deal With

He described a "white moderate" as the white person who seems to be sympathetic to integration, but who is never quite ready to commit himself wholeheartedly, believing more in tranquillity than in equality; always wanting to wait a little longer, and, he stressed, "more difficult to deal with than the outright hostile segregationist."

A final question came from a member of the audience interested in knowing what an "average white layman" can do actively to work for civil rights, and to this Dr. King responded by mentioning first the advantage of joining and working with a Civil Rights organization, "for you can do much more collectively, and organizationally

than as an individual; financial support, "from compassionate hands," and "individual witness of your own personal commitment."

He urged work in the community to solve housing problems and declared "every act of brotherhood by a white person toward a Negro is valuable."

Dignity and decorum marked the speaker's visit to Marietta, his first college lecture since he addressed the University of Pittsburgh on Nov. 2, which was his originally scheduled date to appear here.

Guest at Luncheon

He talked briefly with those who flocked to the platform after the question and answer session, and was then a guest at lunch in Lafayette Motor Hotel, with members of the college administration, the student body president, John Hexter, and ministers of the churches participating in the United Campus Fellowship program.

Before his departure for a New York engagement today, Dr. King, who had explained a slight hoarseness during his address as due to a cold, and his aide, the Rev. Mr. Lee, also suffering from a sore throat, were examined by the college physician, Dr. Joseph LaBarre.

From New York, Dr. King planned to go to Atlanta to preach to the 4,000 member congregation of the Baptist Church he serves as co-pastor with his father. For despite his heavy schedule as Civil Rights leader, the minister makes every attempt to return to his church three Sundays of each month, he told his luncheon companions.

Conversation during the meal also touched on various friends and acquaintances some of the group held in common with the speaker, and on higher education for both white and Negro youths.

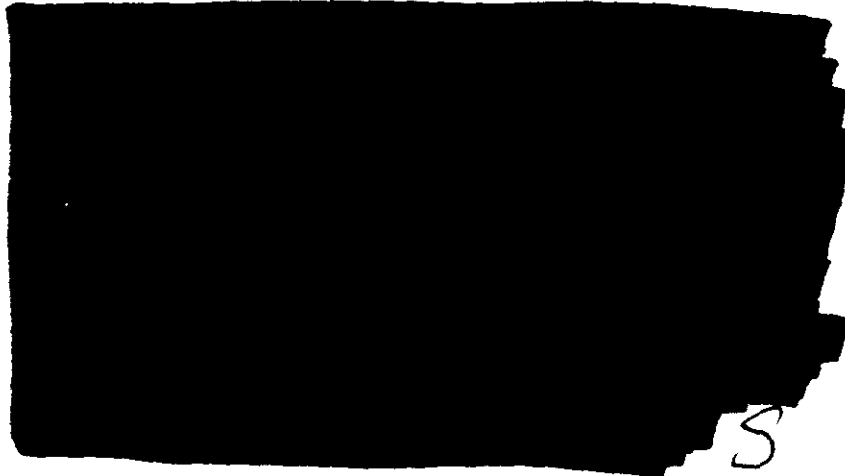



Reference is made to Los Angeles, California, memorandum, dated February 23, 1967.



On February 25, 1967, a symposium sponsored by "The Nation" magazine was held at the Beverly Hilton Hotel, Beverly Hills, California. It was announced that "The Nation" is merging with "Frontier" magazine.

JAMES STORROW, publisher of "The Nation" magazine, introduced Senator GEORGE MC GOVERN (D-South Dakota). MC GOVERN claimed that the United States obsession with communism pulled us into the Vietnamese war. He pointed out that the United States has refused to allow even trade of non-strategic materials with Red China much less allow students to travel to mainland China. He claimed that we have been opposed to Red China being admitted to the United Nations but we have not opposed recognition of CHIANG KAI-SHEK's Government.

Senator MARK HATFIELD (R-Oregon) also spoke in opposition to the war in Vietnam but spent most of his time talking about hunger throughout the world. He claimed the 70 per cent of the developing nations of the world suffer from malnutrition and that the United States could do more good by helping to develop new sources of nutrition. HATFIELD brought out the fact that when he was governor, he was the only one of all the governors attending the July, 1966, National Governors' Conference at Century City in Los Angeles who opposed the resolution to support the administrations position on the war in Vietnam.

ROBERT VAUGHN, TV personality, introduced MARTIN LUTHER KING, JR. KING stated that we are fighting an illegal war in Vietnam; and in addition to the other immoral aspects of

any war, in Vietnam we are napalming helpless and innocent Vietnamese children. KING criticized the reasoning for our being in Vietnam to "stop communism." KING was critical of the high cost in the war in Vietnam and claimed that it costs \$332,000 for each Viet Cong killed by American military men. KING stated "we have got to work for peace; but it is not enough to be for peace, we have got to get out and demonstrate and protest until it rocks the very foundations of this nation."

Senator EUGENE MC CARTHY (D-Minnesota) spoke briefly and stated that it was hard to justify war in Vietnam especially the napalm bombing of the children. He claimed that our objectives and purposes are not clear and are difficult to defend.

SEYMOUR MELMAN, Columbia University Professor, claimed that he was quoting from one of the military services newspaper (name unknown) stating that the United States intends to carry on more Vietnam wars. He pointed out that Lockheed Aircraft Corporation is building a transport capable of carrying 600 men. He stated that at that rate it would only take 20 pilots and 20 planes to carry 12,000 men. He claimed that it was obvious that the United States would have no use for such aircraft if it did not have the intention of becoming involved in the Vietnam-type wars. MELMAN criticized the 1968 budget for the expenditures for military appropriations.

MELMAN claimed that there will be a crisis in the value of the United States dollar in 1967. He was critical of the drain of gold in the United States Treasury and deficit spending. MELMAN felt that the best way to alleviate this situation was to stop the war in Vietnam and to cut down on the armed forces. MELMAN stated that in future elections we should give primary consideration on how we vote on the candidates who are in favor in giving up the Vietnam war, and are backing a conversion from a military to a peace economy.

Senator ERNEST GRUENING (D-Alaska) stated that he was one of the first people in Congress to oppose President JOHNSON's Foreign Policies. He called our presences in Vietnam unconstitutional.

CECIL BROWN, NBC News Commentator, spoke on the main topic of the inability of the news media to bring the truth about the Vietnam war to the United States public. He claimed there is no real analysis of the news, and that the news media has failed the public in this type of coverage.

MALCOLM BROWNE, Pulitzer Prize winner and Vietnam news correspondent, stated that he had married a Vietnamese girl while he was in Vietnam. BROWNE was critical of the United States participation in the war in Vietnam.

It was announced that a master tape recording of the days proceedings was being made, copies of which would be sent to every major college in the United States. Also that a special issue of "The Nation" magazine would be published with the major points made by the speakers of the day.

GIFFORD PHILLIPS stated that he was pleased with the merger of his magazine "Frontier" with the publication "The Nation" and was happy to be the assistant publisher of "The Nation."

A solicitation for contributions were made from those present. Everyone present received a copy of the 100th Anniversary issue of "The Nation" and were also given a copy of the quarterly publication "New University Thought", issue which was devoted to "Decisions for America - Priorities and Consequences."

An article entitled "4 Senators Call for U. S. Withdrawal from Vietnam War" appeared in the February 26, 1967, edition of the "Los Angeles Times" on page one. A xerox copy of this article is as follows:

4 Senators Call for U.S. Withdrawal From Vietnam War

BY RICHARD BERGHOLZ

Times Political Writer

Critics of U.S. policy in Vietnam assailed President Johnson at a day-long conference Saturday at the Beverly Hilton and, to varying degrees, called for disengagement from the war.

The session, sponsored by the liberal magazine, *The Nation*, concerned itself primarily with the problems of "redirecting American power." But the Vietnam war—and what to do about it—dominated the talks.

Featured speakers were Sens. Eugene McCarthy (D-Minn.), Mark Hatfield (R-Ore.), George McGovern (D-S.D.) and Ernest Gruening (D-Alaska), together with the Rev. Martin Luther King Jr., Pulitzer Prize-winning newsman Malcolm Browne and Columbia University's Prof. Seymour Melman.

Intervention Called Illegal

Sen. Gruening charged that U.S. intervention in South Vietnam is "illegal, unconstitutional and immoral—and no good can come from it." He said the United States should stop air attacks, negotiate directly with the Viet Cong and agree to withdraw American troops when a peace treaty is signed.

Equally outspoken in his criticism of U.S. war policy in Vietnam was Dr. King.

The Negro Nobel laureate claimed that "American planes are bombing the territory of another country, and we are committing atrocities equal to any perpetrated by the Viet Cong."

"All of this reveals that we are in an untenable position morally and politically.

"We are left standing before the world glutted by our barbarity.

"We are engaged in a war that seeks to turn the clock of history back and perpetuate colonialism.

Sees Shift in U.S. Role

"The greatest irony and tragedy of it all is that our nation, which initiated so much of the revolutionary spirit of the modern world, now is cast in the mold of being an arch anti-revolutionary."

A result of the Vietnam war is the lessening attention in this country to urgent domestic needs, Dr. King said.

"The security we profess to seek in foreign adventures we will lose in our decaying cities," he said.

What concerns him most, he added, is that a "frightful" war is being waged in the name of peace.

"When I see our country today intervening in what is basically a civil war, destroying hundreds of thousands of Vietnamese children with napalm, leaving broken bodies in countless fields and sending home half-men, mutilated, mentally and physically; when I see the recalcitrant unwillingness of our government to create the atmosphere for a negotiated settlement of this awful conflict by halting bombings in the north and agreeing to talk with the Viet Cong—and all of this in the name of pursuing the goal of peace—I tremble for our world."

Talks of Red China

McGovern concerned himself primarily with U.S. relations with Red China and called for efforts to relax tensions between the two nations.

The South Dakota senator called for a cultural exchange with Red China, relaxation of State Department restrictions on U.S. citizens' travel in Red China, an invitation to the Communists to join in disarmament and nuclear nonproliferation talks at Geneva and a policy decision by the United States to "abide by the judgment of the United Nations as to a possible solution to the Formosan problem."

Sen. McCarthy said, "We do not have (in the Vietnam war) the support of what is generally accepted as a decent opinion of mankind.

"Our objectives and purposes are not clear, not precise," he said. And napalm and bombing attacks on civilians "are much more difficult to defend than they were when we bombed civilians in retaliation" or in seeking out military targets in World War II, and used napalm as "a sophisticated weapon against an enemy using sophisticated weapons."

Browne, a veteran Vietnam war correspondent, charged that "America is a nation of ignoramuses with respect to Asia," that U.S. policy has been misguided and wrong.

"When America as a nation seeks to do battle with some of the wildest politico-military foxes history has yet brought forward, it goes out hopelessly unarmed from an intel-

lectual and psychological point of view," he said.

"Short of World War III we are not, under present circumstances, likely to achieve much by war in Asia," Browne said, adding that "in those circumstances, a complete American withdrawal from the Western Pacific might, in the long run, be the least of various evils."

Priorities Needed

Sen. Hatfield concentrated more on what he termed the need to re-determine the order of national priorities.

"Most important and basic of our national goals is liberty—for ourselves and for other people," he said. "We have narrowly defined this threat to liberty in terms of Communist aggression, and have failed to recognize that poverty and hunger can enslave a man as completely as the tyranny of Communism."

Hatfield called for greater U.S. effort to solve problems of hunger and housing and education. He also repeated his demand that the draft be replaced by a form of voluntary military service, bolstered by increased financial incentives.

Melman, too, called for a redirection of American efforts to fulfill domestic needs.

James Storrow Jr., publisher of *The Nation*, said the conference was deliberately set up to include essentially one main point of view on the Vietnam war. No defenders of President Johnson's policies or advocates of war escalation were invited, he said.

A confidential source, who has furnished reliable information in the past, advised on February 27, 1967, that he had learned that Martin Luther King, the President of the Southern Christian Leadership Conference (SCLC) and Stanley Levison were in contact on that date. Their principal purpose in conferring was to talk about a speech King had made in Beverly Hills, California on Saturday, February 25, 1967, during which time he urged the withdrawal of American troops from Vietnam.

Levison, in apprising King that his speech received front page coverage in Sunday's issue of "The New York Times", felt that no longer could it be said by the American people that King did not have the right to speak on Vietnam. In fact, according to Levison, King's appearance on a panel with four United States Senators, was the proper place for him to express his anti-war sentiments. Furthermore, he felt that King's voice was much more influential when in the company of such prominent people as the four Senators.

The article which Levison had in mind, appeared in the Sunday, February 26, 1967, issue of "The New York Times", page one, and was captioned "Dr. King Advocates Quitting Vietnam." In elaborating, the article reported that Dr. Martin Luther King joined four United States Senators in a conference in Beverly Hills, California, on Saturday, February 25, 1967. The conference, according to the article, was entitled "National

Priority No. 1; Redirecting American Power", was conducted by "The Nation" Magazine, with headquarters in New York. An audience of over 1,500 persons attended the all-day meeting at the Beverly Hilton Hotel. U

Dr. King, the article reported, in the main speech of the day, contended that the United States' failure to submit its case against the North Vietnamese to the United Nations Security Council had "undermined the purpose of the U.N., caused its effectiveness to atrophy, and placed our nation in the position of being morally and politically isolated." U

The United States' activities in Vietnam, King said, amounted to "supporting a new form of colonialism covered up by certain niceties of complexity." U

In continuing his contention that the United States should get out of Vietnam, the paper reported King as having said: "The promises of the Great Society have been shot down on the battlefield of Vietnam." U

"The pursuit of this widened war has narrowed domestic welfare programs, making the poor, white and Negro, bear the heaviest burdens both at the front and at home. The recently revealed \$10-billion mis-estimate of the war budget alone is more than five times the amount committed to the anti-poverty programs. The security we profess to see in foreign adventures we will lose in our decaying cities." U

King observed that "we" are willing to make the Negro 100 per cent of a citizen in warfare, but reduce him to 50 per cent of a citizen on American soil. U

In concluding his remarks, King is reported to have commented that "we" are presently moving down a dead-end road that could lead to national disaster. "It", King said, "is time for all people of conscience to call upon America to return to her true home of brotherhood and peaceful pursuits. Those of us who love peace must organize as effectively as the war hawks." u

The Country, according to King, still has a choice: "nonviolent coexistence or violent co-annihilation." u

The paper article identified the four Senators who took part in the conference as Eugene J. Mc Carthy of Minnesota, George Mc Govern of South Dakota, Ernest Gruening of Alaska and Mark O. Hatfield of Oregon. u

In continuing their conference, Levison and King then discussed King's newest book which Levison is helping write. In regard to the chapter dealing with what Levison described as ~~broaching~~ the question of admitting Red China to the United Nations, Levison agreed on a statement which King made to the effect that people should not be called Communists because they advocate the admission of Red China. He told King that he should also comment that spending more money on war than on social uplifting was causing the United States to approach spiritual death. E

On February 18, ¹⁹1967, a confidential source, who has furnished reliable information in the past, advised that he had learned that Martin Luther King, President of the Southern Christian Leadership Conference (SCLC), Stanley Levison, a New York City Attorney and real estate man, ^{N.Y.} Andrew Young, Executive Director of the SCLC and Cleveland Robinson, Secretary-Treasurer of District 65, Retail, Wholesale and Department Store Union, AFL-CIO, were in conference on that date concerning the role of Martin Luther King and the peace movement.

King is desirous of taking a firm stand against the war in Vietnam and of becoming a leader in the peace movement, which is currently attracting the support of students and "white liberals". He is, however, apprehensive of losing a forthcoming Ford Foundation grant if the SCLC becomes involved with a radical group. James Bevel, ^{ILL.} Chicago SCLC leader, who is now leading a peace committee, has been pressing King for support in this matter, but King intends to stall him until March 6, 1967, when King will attend a research committee meeting, concerning this problem, in New York City. SOUTHERN CHRISTIAN LEADERSHIP CONFERENCE

Young and Robinson favor overt action in this matter viewing as a moral problem requiring leadership of the masses. Robinson wants King to contact ministers and lead a grass roots peace movement. Young favors influencing Walter Reuther of the AFL-CIO to join the peace movement. After Reuther joins the movement, Young advocates that King approach President Lyndon B. Johnson and advise President Johnson that King will no longer be associated

with the administration and that he is going to fight against military service and for the peace movement. The coalition of labor and civil rights, in Young's opinion, would force an administration capitulation.

Levison is skeptical of overt action in this area. He feels the most effective stand for King is as the leader of the civil rights movement. King, from this position, could attract support from the peace movement and exercise his influence through such individuals as Senators Jacob Javits, Robert Kennedy and William Fulbright. Levison also advocates persuading Walter Reuther to join the peace movement through his brother, Victor Reuther.

This subject will be discussed more fully at the March 6, 1967 research committee meeting.

On February 20, 1967, this source advised that King, Levison, Joan Daves, a publisher's representative in New York City who handles the books which King writes, and Hermine Popper, who is editing King's new book, were in conference.

Popper is of the opinion that the chapters in the book written by King and the chapters written by Levison are excellent, however, they are obviously written by two different people with two different points of view. She finds an inconsistency in the handling of such subjects as White America, middle class Negroes, white liberals and Negroes' abilities in the economic sphere. She feels that these inconsistencies destroy the book's unity.

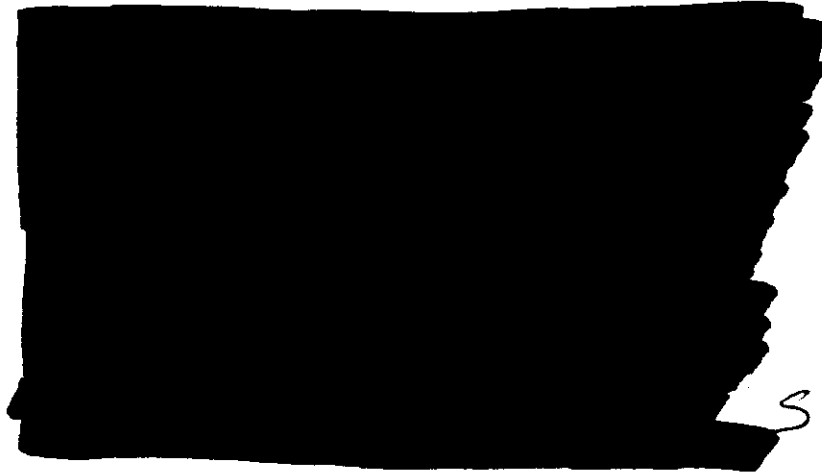
King and Levison disagree with her and feel that any differences are inconsequential and that no serious inconsistencies exist. Levison maintains that he knows exactly what King is thinking and adapts his thinking to King. Levison feels that any inconsistencies are due to poor formulation and not to a difference of thought or approach. Both Levison and King will reread their first drafts and submit minor corrections, but no major changes are anticipated.

On February 24, 1967, the same source advised that he had learned that King would arrive in New York, New York, at 12:10 p.m. on that date. According to the source, King's plans called for him to meet with Hermine Popper at the International Hotel, Kennedy International Airport, at 12:30 p.m., and with Stanley Levison and Joan Daves at 2:30 p.m.

On February 24, 1967, at 12:25 p.m., a Special Agent of the Federal Bureau of Investigation (FBI) observed Martin Luther King and Bernard Lee, the administrative assistant to King, enter the International Hotel, Kennedy International Airport. King was overheard greeting a white female as Hermine. After exchanging greetings, these three people entered the hotel elevator and went upstairs.

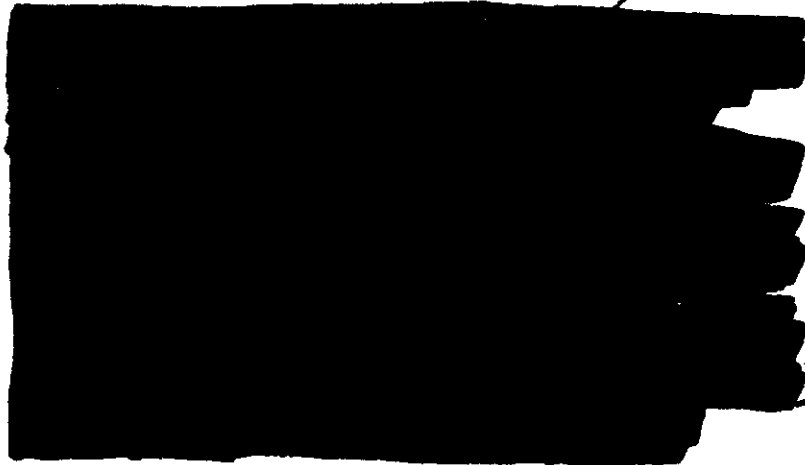

The Eighth Report on Un-American Activities in California dated 1955, published by the California State Senate Fact-Finding Committee on Un-American Activities, Page 383, reflects that Mrs. Ruth Drader testified before the Committee concerning "Frontier" magazine. A portion of her testimony is set forth below:

"Mrs. Drader testified that soon after she had joined several communist front organizations and had become active in them under the name of Jane Dawson, she received two unsolicited communications directed to Jane Dawson from Frontier Magazine, 223 South Beverly Drive, Beverly Hills, California. This publication, well financed and issued in a slick format, modestly refers to itself as the State's only liberal publication. Members of its staff are seen at Communist front meetings from time to time, as was shown by the testimony of Mrs. Drader, and its representatives frequently appear as speakers before various organizations, ranging through the political spectrum from deep red to pale pink."

"The 10th Report on Un-American Activities in California dated 1959, published by the California State Senate Fact-Finding Committee on Un-American Activities, pages 186, 187, states as follows:

"...There is little need for the Communist Party to finance propoganda publications when a magazine like 'The Nation' or one published

Friends of Gifford Phillips stated that Phillips had been in Russia at the time Elizabeth Gurley Flynn, National Functionary, Communist Party, USA, died. Phillips conducted an interview with her some time prior to her death and planned on publishing this interview some time in the future.

Source did not know Phil Kerby to be a member of the Communist Party (CP) but he considers Kerby's writings and speeches to closely follow the communist line.

On January 2, 1964, source advised that Phil Kerby was listed as a current active member of the Executive Board of the Citizens Committee to Preserve American Freedoms (CCPAF) (See Appendix).

DISCUSSION UNLIMITED, INC.

Records of the Division of Corporations, California State Department of Investments, Los Angeles, California, indicate that Discussion Unlimited filed its Articles of Incorporation as a nonprofit corporation, with the Secretary of State, Sacramento, California, on or about June 4, 1963, noting its principal site of office as Los Angeles County, California. The aims and purposes of the organization, as listed in the Articles of Incorporation, are "...to promote full and open discussion on our society and problems".

A source advised on May 8, 1963, that Discussion Unlimited, Inc. actually was originated in Los Angeles, California, in May, 1962, and was composed largely of a number of present and former Communist Party members who assist in staging panel forums and in promoting such events. Original coordinator of the group was BERNARD LUSHER, who in 1961, was educational director of the Southern California District Communist Party.

This source was recontacted on April 9, 1965, and indicated that the basic concept of Discussion Unlimited, Inc. has not changed. It continues to present "left ideas" to at least partially non-committed audiences. It proposes to develop special activities around various issues on an irregular basis. It is not a membership organization, and does not hold regular meetings as such, but rather is strictly a forum-type organization.

On May 10, 1966, another source reported that Discussion Unlimited, Inc. continues to operate as a forum-type organization.

A source advised on January 25, 1966, that the Citizens Committee to Preserve American Freedoms, (CCPAF) 555 North Western Avenue, Los Angeles, California, had recently changed its name to Southern Californians for Abolition of the House Un-American Activities Committee.

The same source advised on June 9, 1966, that subsequent to the adoption of the new name in January, 1966, the officers began to refer to it by the name Southern Californians to Abolish the House Un-American Activities Committee. This is now the official name and the new letterhead of the organization carries the name as "Southern Californians to Abolish HUAC".

The "Guide to Subversive Organizations", revised, December 1, 1961, pp. 43-44, describes the CCPAF as follows:

"The Citizens Committee to Preserve American Freedoms * * * specializes in propaganda aimed at abolishing the Committee on Un-American Activities and discrediting the Federal Bureau of Investigation. Created in Los Angeles in 1952, the front organization is run by FRANK WILKINSON, an identified Communist who recently resumed the full-time, paid post of executive secretary after approximately a year's leave of absence to assist in a similar campaign by another front in New York City, the Emergency Civil Liberties Committee.

"When the Committee on Un-American Activities held hearings in Los Angeles, September 2-5, 1958, to inquire into the nature of the Party's recent reorganization in California, the Citizens Committee to Preserve American Freedoms sponsored a series of public meetings to protest the hearings and the very existence of the Committee. Communists subpoenaed as witness were guests of honor.

"At this time, leaders of the Party's Southern California District were mobilizing Communists in the area for participation in an intensified campaign to abolish this committee of Congress. How the Citizens Committee to Preserve American Freedoms served the Party in this effort was revealed by (Communist Party) District Chairman DOROTHY HEALEY in a report to the Party's Southern California District Council on September 21, 1958. Mrs. HEALEY declared that the Party preferred public protest meetings to be held by the Citizens Committee to Preserve American Freedoms rather than under party auspices because Communists could attend without danger of being exposed as members of the Party. She also noted that Communists scheduled as congressional committee witnesses could not appear beforehand at open Communist rallies without creating the impression that the Party was conspiring with witnesses to withhold information from the committee".

Memorandum D. J. Brennan, Jr., to W. C. Sullivan, 2/23/67, captioned as above, reported Martin Luther King's scheduled participation in a U. S. Department of Agriculture Graduate School seminar and recommended we disseminate to Agriculture a copy of the paper, "Communism and the Negro Movement - A Current Analysis," which emphasizes the communist influence on King and sets forth facts concerning his immoral nature. Mr. Tolson noted, "I question this. Just who is the head of this School," and the Director noted, "Who? H." Regarding a second recommendation that name checks be conducted on six additional writers and lecturers scheduled to participate in the seminar and the results be furnished to Agriculture, Mr. Tolson noted, "Let us see them," and the Director noted, "Let me know. H."

The U. S. Department of Agriculture Graduate School has operated since 1921 as a self-supporting, nonprofit, educational institution. It does not receive any appropriated Government funds. It is governed by a General Administration Board consisting of top Government officials within and outside the Department of Agriculture, all appointed by the Secretary of Agriculture. The School, which registers about 17,000 students annually, is headed and administered by John B. Holden, who is appointed by the Board. Holden, born 9/18/10 in Ohio, is a 1932 graduate of Ohio University and later received a Doctorate in Philosophy from Ohio State University in 1955. He has held teaching positions in the fields of history, speech, and adult education in the Ohio school system and at Michigan State University. From 1956 to 1958, he served as a specialist in adult education with the U. S. Office of Education and since 1958, has served as Director of the Department of Agriculture Graduate School. It is noted that Bufiles contain nothing of a derogatory nature concerning Holden or other officers of the School.

The purpose of the Graduate School is to provide educational opportunities for Federal employees to assist Federal agencies in meeting educational and training needs. Its faculty consists largely of Federal employees who teach after hours. In isolated instances in the past, the Bureau has, with the Director's approval, sent Bureau personnel to the Graduate School during evening hours to attend specialized courses in such fields as Federal purchasing procedures, statistics and speed reading.

The seminar "Critical Issues and Decisions," (brochure attached) which begins 3/28/67 and in which King is scheduled to participate, comes under the School's Special Program Department. The announced purpose of the seminar is to provide opportunity for Federal executives, GS-14 and above, to stimulate more critical evaluation of Government problems and to develop better techniques and broader knowledge with which to cope with them. King and also six additional individuals, on whom file checks are currently being conducted on an expedite basis, are characterized in the seminar announcement as writers and scholars who will provide personal tutelage at the seminar.

OBSERVATIONS:

The Department of Agriculture Graduate School reportedly enjoys a good reputation within Government. Our files contain nothing of a derogatory nature concerning it. Although it does not operate with appropriated Government funds, it is sponsored and controlled by the Department of Agriculture. We should therefore furnish any pertinent information to Agriculture concerning the seminar participants in response to Agriculture's name check request. Since the information concerning King is sensitive, it should be disseminated at the highest level.

RECOMMENDATION:

(1) That the Liaison Section be authorized to disseminate a copy of the paper "Communism and the Negro Movement - A Current Analysis," (copy attached) containing information concerning King to the Secretary of Agriculture. (ORVILLE FREEMAN)

On 2/20/67, [redacted], Department of Agriculture, [redacted] made available to Liaison Agent the attached brochure which announces a seminar for Federal executives on the subject "Critical Issues and Decisions" offered by the U. S. Department of Agriculture Graduate School. The brochure identifies Martin Luther King, Jr., as one of seven writers and scholars who will provide personal tutelage to the seminar participants. King, who will address himself to the subject "Man, Society and the Federal Government," is further characterized in the brochure as President of the Southern Christian Leadership Conference, a leader in the civil rights movement, and the recipient of the Nobel Peace Prize in 1964 and "Time" magazine's Man of the Year Award in 1965. [redacted] requested FBI name checks on the seven writers and scholars named in the brochure. [redacted] expressed concern that one or more of these individuals might have leftist backgrounds and that the affiliation of these persons, and particularly Martin Luther King, Jr., with the Graduate School could be embarrassing to Agriculture. [redacted] pointed out that to the best of his knowledge, persons utilized by the Graduate School are not cleared through official Department of Agriculture channels.

On February 15, 1967, a confidential source, who has furnished reliable information in the past, advised that he had learned that Martin Luther King, President of the Southern Christian Leadership Conference (SCLC), and Stanley Levison, a New York City attorney and real estate man, were in contact on that date. Their contact, the source said, was in regard to King's new book.

First of all, Levison told King that he had practically finished the chapter entitled "Where Do We Go From Here?" and would soon make it available for King's recommendations and comments. He also promised to furnish the first two chapters of the book to King.

King mentioned that he had received Hermina Popper's revisions on the chapter entitled "The White Dilemma" and was very pleased with her contributions so far.

King solicited Levison's advice on other material which he should incorporate in the new book. Levison recommended that King use some of the statements made by the late Prime Minister Gandhi of India, and some of the decisions rendered by the United States Supreme Court during 1954.

Levison, in digressing to another matter which concerned King and his organization, the SCLC, said \$20,000.00 came in last Friday, February 10, 1967, and \$6,000.00 on February 15, 1967. It was Levison's opinion that contributions would increase in the future.

A confidential source, who has furnished reliable information in the past, furnished information on February 8, 1967, indicating that Stanley Levison and Dora Mc Donald, the secretary to Martin Luther King, President of the Southern Christian Leadership Conference (SCLC) were in contact on that date. Their contact, according to what the source was able to ascertain, concerned the following:

Mc Donald wanted to tell Levison that Martin Luther King was scheduled to return to the United States from Jamaica on Monday, February 13, 1967; and according to Mc Donald, King will be in Miami, Florida where he can be located through the office of Henry Arrington, a Miami attorney. Mc Donald related that King desired Levison to furnish this information to Hermine Popper since she is editing King's new book. Mc Donald gave Arrington's address as 111 North West 5th Street, Miami.

Mc Donald then told Levison that King wanted Levison to contact Bayard Rustin to see if he would write his speech which he, King, is scheduled to give in Los Angeles, California, on February 25, 1967, before an affair being sponsored by "The Nation". King, according to Mc Donald, wants to make a strong statement on Viet Nam. Levison did not think Rustin should be entrusted with the task since, in Levison's opinion, Rustin is very weak on the subject of Viet Nam. Instead of Rustin writing the speech for King, Levison felt that Tom Offenberger, of the Public Relations Department of the SCLC should write the speech.

As a guide in preparing the speech, Levison told Mc Donald to have Offenberger use the transcript of the Ribicoff Committee hearing of December 15, 1966, during which King testified on urban affairs. It was during his testimony that King had some strong remarks concerning the involvement of the United States in the Viet Nam war.

On February 8, 1967, according to the aforementioned source, Clarence Jones and Stanley Levison were in contact concerning Martin Luther King's trip to California later during the month. Jones wanted to advise that King could pick up approximately \$10,000.00 for the SCLC if he would be willing to go to a little extra trouble. In explaining, Jones said he recently talked with Al Cannon of California, who mentioned that many people are expecting King in California, including former Governor Brown. These people, according to Jones, desire King to dine with Governor and Mrs. Brown and then make a brief speech after dinner. It was Jones' belief that many of those who attend the dinner would be very wealthy individuals. It was Levison's feeling that King would not be able to make the dinner but could possibly make it for cocktails about 9:00 PM. Anyway, Levison told Jones to relay the information to Dora Mc Donald, who in turn could find out from King if he can make it.

A confidential source, who has furnished reliable information in the past, advised on February 13, 1967, that information had come to his attention which disclosed that Stanley Levison and Joan Daves, a publishers representative in New York City who handles books which Martin Luther King writes, were in contact concerning King's newest book. The following is in substance what transpired during their contact on February 13, 1967:

Levison mentioned that he was reviewing the "White Dilemma" part of manuscript which he received from Martin Luther King and that he, Levison, was revising certain parts of it. After being told that Daves was astonished since she also had a version of the "White Dilemma" which she received from King and Hermine Popper. Daves was very disappointed in King's contributions so far and said, what she had received so far, did not seem to be very constructive.

Levison commented, the source said, that he had conferred with King about the book and had expressed his dis

appointment in King's manner of dealing with the "White Dilemma" chapter, but was quite pleased with the "Black Power" chapter. His main criticism with the "White Dilemma", Levison remarked, was that King had no original ideas and that consequently had just taken old ideas and re-stated them. King, Levison commented, quotes people because it lends a scholarly style to the book.

It was Levison's opinion that King had not been taking the time to do a lot of deep thinking, but had been doing a lot of editing of material that he had and had not asked himself what was new.

In considering the work as a whole, Levison felt that the chapter dealing with "Black Power" was the best contribution so far. In commenting on his own contributions, Levison mentioned that he had revised the chapter dealing with the question "Where do we go from here".

It was Daves opinion that she could get a publisher for King's work especially in view of the chapter dealing with "Black Power". She felt that since "Black Power" is still so fresh in the minds of the American people, there would be plenty of readers for this type of contribution. She mentioned having contacted "Look", the magazine publisher, but had not been given any encouragement, so therefore, would contact "Life" to see if they would be interested in publishing King's book. Levison instructed Daves to contact King at his hotel in Miami, the Dupont Plaza Hotel or at the law office of Henry Arrington, 111 North West 5th Street, Miami, Florida, and get his permission before making any deal with "Life". King, according to Levison, will remain in Miami until February 18, 1967, when he will return to Atlanta, Georgia.
