



A confidential source, who has furnished reliable information in the past, advised on April 4, 1968, that on that night, following the assassination of Martin Luther King, Jr., President of the Southern Christian Leadership Conference (SCLC) Stanley Levison and Harry Wachtel and Stanley Levison and Harry Belafonte held several discussions on what they should It was initially agreed by Levison and Wachtel that they should go to Memphis that night so they could be of assistance there. Wachtel told Levison that he had been called by Bayard Rustin who in turn, had been called by Jim Tawson (SCLC representative in Memphis, Tennessee) and said they were trying to get all kinds of civil rights leaders down there (Memphis) to keep things from breaking wide open.

During their discussions, Levison told Wachtel that he felt they should go to Memphis because he thought there would be a whole series of perplexing questions which the (SCLC) staff would be faced with and that he and Wachtel could make a contribution. Levison said he meant (questions such as) should they go on with "this march" (the Memphis march scheduled for April 8, 1968) and should they go on with "the Washington (the Poor People's Campaign in Washington, D.C.,

Wachtel secured plane reservations for six persons to fly to Memphis the night of April 4, 1968. Wachtel felt that he and his wife, Stanley Levison, Clarence Jones, Harry Belafonte and possibly Bayard Rustin would make the trip.

Levison preferred not to have Rustin present at any meeting they might have (in Memphis) because he believed the rest of the (SCLC) staff would feel hostile.


Thereafter, Levison and Wachtel began to doubt the wisdom of going to Memphis that night since they could not hold any important discussions or make any important decisions. Wachtel noted that the most important thing they would try to do is not to have violence in King's name. He indicated that Andrew Young, Executive Vice President of the SCLC, has taken that approach. Levison stated this is not the kind of approach he would have taken, that he did not mean to tell them not to be calm or to urge them into violence, but that he feels the point they should be making is, what kind of system is it that produces such a thing (King's death) when he starts to fight for the lowly, like the garbage men. Levison said that in other words he thought "we've got to be angry". Levison added that Andrew Young was probably thinking that there are a great many Negroes who are going to get hysterical and go out and get themselves shot down.

Levison subsequently told Harry Belafonte that he had talked with Jesse Jackson, an SCLC official, who told him not to come to Memphis. Levison and Belafonte agreed to fly to Atlanta at 11:30 AM on Friday, April 5, 1968. Levison told Belafonte to make the reservations for the two of them and to let Harry Wachtel and the others worry about themselves.

On April 5, 1968, the same source learned that Andrew Young contacted Stanley Levison on that date. They discussed King's successor and agreed that Ralph (Abernathy, an SCLC official) was the only logical choice. Young stated that they were going to call a press conference on the morning of April 5, 1968, "To sort of straighten things out" and to announce the establishment of the Martin Luther King Fund to perpetuate his memory. Young noted that Senator Robert Kennedy had put his plane at their disposal.




Young and Levison agreed to meet at the (King) house in Atlanta around 1:30 PM.

A characterization of the National Lawyers Guild is attached hereto.







With respect to the Gandhi Society for Human Rights, it is to be noted that this organization is an adjunct of the Southern Christian Leadership Conference (SCLC), of which Martin Luther King, Jr. is the president, and serves to raise funds for the SCLC.

In "The Saturday Evening Post", issue of July 11-18, 1964, page 76, Bayard Rustin is the subject of a feature article captioned: "The Lone Wolf of Civil Rights." In it, Rustin is said to have come to New York in 1938, as an organizer for the Young Communist League (YCL), and as such, he had the job of recruiting students for the "Party". Furthermore, the article reports that during his first years in New York, Rustin gave most of his earnings to the "Party." He reportedly left the "Party" in 1941, the article states.

The YCL has been designated pursuant to Executive Order 10450.

The "Daily Worker", February 11, 1957, page 1, column 2, reported that Bayard Rustin, Executive Secretary, War Resisters League, was an observer at the 16th National Convention of the Communist Party, United States of America, (CP, USA), held in New York City, on February 9-11, 1957.





The "Daily Worker" was an East Coast Communist publication until it ceased publication on January 13, 1958.



Another confidential source, who has furnished reliable information in the past, advised on February 19, 20, 1964, that Bayard Rustin contacted Benjamin J. Davis on those dates and sought his advice as to how he could escape from a speaking engagement to which he was committed. On the latter contact, Davis told Rustin that he was working on his request and had contacted friends who had contacts with the group to which Rustin was to speak.

A confidential source, who has furnished reliable information in the past, advised on January 21, 1964, that as of that date, Benjamin J. Davis was National Secretary of the CP, USA.

"The New York Times", August 24, 1964, page 27, column 4, reports that Benjamin J. Davis, National Secretary, CP, USA, died in New York City on the night of August 22, 1964.

Clarence Jones is the General Counsel to the Gandhi Society for Human Rights, 15 East 40th Street, New York, New York.

The "Guide to Subversive Organizations and Publications," revised and published as of December 1, 1961, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following concerning the National Lawyers Guild:

WASHINGTON SPRING PROJECT

The following information has been supplied by confidential sources of this Bureau who have furnished reliable information in the past.

Martin Luther King, Jr., President, Southern Christian Leadership Conference, has advised that he will bring 3,000 of his followers to Washington, D. C., in April, 1968, to conduct a massive civil disobedience campaign in an effort to pressure Congress into passing legislation favorable to the Negro. King calls this the "Washington Spring Project" or the "Poor People's Campaign."

On March 28, 1968, King led a march in Memphis. Tennessee, in support of the striking sanitation workers of that city. Shortly after the march started, a riot ensued and King fled down a side street and left the area.

On March 29, 1968, King was in conference with his principal advisor, Stanley Levison, concerning the Memphis riot. King stated he was depressed by the riot and was considering calling off the "Washington Spring Project." Levison advised King to continue his plans concerning the Washington march. Levison emphasized that King can state that the Washington march will differ from the Memphis march since King will have organized the Washington march and can stress the importance of nonviolence. 

that Reverend MARTIN LUTHER KING was coming to the State of North Carolina on April 4, 1968. This source advised that Reverend KING would arrive at the Greensboro-High Point Airport at 9 A.M. He would then proceed to Thomasville, North Carolina and have a joint meeting with his followers from the Thomasville and High Point area.

After leaving Thomasville, he is to proceed to Greensboro, North Carolina, for a meeting with a group there. From Greensboro, he will proceed to Durham, North Carolina and then to the Raleigh area. From Raleigh, he will go to Rocky Mount, then to Elizabeth City. From Elizabeth City he is to go to Edenton, Windsor and Williamston, North Carolina.

At the present time he has on his schedule a visit to New Bern, however, some of the leaders in New Bern are at odds and this meeting may be canceled. From New Bern he is supposed to go to Lumberton and confer with a group of Indians. From Lumberton he will proceed to Wilmington, North Carolina and make a speech at the Williston High School in Wilmington.

If the New Bern meeting is canceled by Reverend KING or the leadership there, KING will schedule a visit to Charlotte, North Carolina, on this same date.

The March 26, 1968, edition of "The Charlotte Observer", a daily Charlotte, North Carolina, newspaper, contained a story which stated that MARTIN LUTHER KING and organized labor will support Dr. REGINALD A. HAWKINS, a Negro dentist from Charlotte, North Carolina, in his quest for the governorship of North Carolina. The story further relates HAWKINS and GOLDEN FRINKS, regional representative of the SCLC, announced Monday, March 25, 1968, that KING would make a one day tour of this state on April 4, 1968. He is scheduled to land in Charlotte around 9 A.M. and then visit Durham, Greensboro, Rocky Mount and possibly New Bern before ending the trip with a dinner speech in Wilmington. FRINKS further stated the newspaper article that if time permits, KING will visit Greenville, a slum area in Charlotte, before leaving for a ministers' conference.

KING is then scheduled to have lunch in one of Durham's poverty areas and then, FRINKS said, hold a "mock trial of the power structure" as poor people bring in grievances on welfare and housing.

KING is also scheduled to participate in a "Voter Registration march" at the election office in Rocky Mount and then go to Wilmington for a speech at the Williston High School auditorium.





During the latter part of November 1967 Reverend KING discussed with STANLEY LEVISON the advisability of him accepting an invitation to address the 100th Anniversary Celebration of the birth of W.E.B. DuBois to be held in Carnegie Hall, New York City, in February 1968. LEVISON indicated he would look into this matter further before advising Reverend KING.


The "Worker", an East Coast Communist newspaper, on page three, of its March 3, 1968, edition reported that tribute was paid to Dr. W.E.B. DuBois on the evening of February 23, 1968, at Carnegie Hall. The article explained this event was organized by Freedomways in celebration of the 100th anniversary of the birth of DuBois whom it described as a "scholar, writer, teacher, organizer, and Communist". According to the article, Reverend KING delivered the address on this occasion. During his address, he stated "It is time to cease muting the fact that Dr. DuBois was a genius and chose to be a Communist. Our irrational obsessive anti-communism has led us into too many quagmires----".






Special Agents of the FBI on April 25, 1967, observed Reverend KING accompanied by STANLEY LEVISON at 4:43 p. m. in the immediate vicinity of SCLC headquarters. Reverend KING and LEVISON entered an automobile parked nearby which Reverend KING immediately drove away.

At 5:50 p.m., April 25, 1967, Special Agents of the FBI observed Reverend KING accompanied by STANLEY LEVISON on the main concourse of the Atlanta Airport. LEVISON proceeded to Eastern Airlines Flight #114 which he boarded. This flight departed at 6:15 p.m. en route New York City.





Re Viet Nam War and Peace Issue

Reverend KING and ANDREW J. YOUNG on February 18, 1967, conferred with STANLEY LEVISON and CLEVELAND ROLLINSON, Treasurer, District 65, Retail, Wholesale, and Department Store Union, AFL-CIO, as to Reverend KING's role in the Peace Movement. Reverend KING pointed out he was desirous of assuming a firm stand against the war in Viet Nam and becoming a leader in the Peace Movement. He noted, however, that the Peace Movement was attracting support from students and "white liberals". a consequence, Reverend KING expressed apprehension as to SCLC losing an anticipated grant from the Ford Foundation should it become involved with a "radical group".

Reverend KING also mentioned that JAMES BEVEL had been seeking his support but he intended delaying any commitment to BEVEL until he discussed the matter during an SCLC Research Committed meeting scheduled to be held in New York City March 6, 1967

YOUNG and ROBINSON expressed a desire for Reverend KING on a moral basis to assume leadership of the masses. ROBINSON felt Reverend KING should contact ministers and lead a grass roots peace movement. YOUNG believed Reverend KING should influence WALTER REUTHER of the AFL-CIO to joir the Peace Move-



ment. Thereafter he said Reverend KING should inform President LYNDON B. JOHNSON he would no longer be associated with the administration and would fight for the Peace Movement and against military service. According to YOUNG, such a coalition of labor and civil rights groups would force a capitulation of the present administration.

LEVISON advised he felt the most effective position for Reverend KING would be to continue as a leader in the Civil Rights Movement. In this position, LEVISON said he could draw support from the Peace Movement and exercise his influence through United States Senators JACOB JAVITS, ROBERT KENNEDY, and WILLIAM FULLBRIGHT. LEVISON suggested WALTER REUTHER could be persuaded to join the Peace Movement through his brother VICTOR REUTHER.

The Sunday February 26, 1967, issue of "The New York Times" on page one published an article entitled, "Dr. King Advocates Quitting Vietham". This article revealed that Reverend KING, United States Senators EUGENE J. MC CARTHY (Minnesota), GEORGE MC GOVERN (South Dakota), and ERNEST GRUENING (Alaska) participated in a conference entitled "National Priorty No. 1; Redirecting American Power". on February 25, 1967, at Beverly Hills, California, conducted by "The Nation" magazine.

According to this article, Reverend KING delivered the main speech of the day and contended that the United States failure to submit its case against the North Vietnamese to the United Nations Security Council had "undermined the purpose of the UN, caused its effectiveness to atrophy, and placed our nation in the position of being morally and politically isolated". The United States activities in Viet Nam, Reverend KING said, amounted to "supporting a new form of colonialism covered up by certain niceties of complexities".







Reverend KING further contended that the United States should get out of Viet Nam and said "the promises of the Great Society have been shot down on the battle field of Viet Nam. The pursuit of this widened war has narrowed domestic welfare programs, making the poor, white and Negroes, bear the heaviest burdens both at the front and at home. The recently revealed \$10-billion mis-estimate of the war budget alone is more than five times the amount committed to the anti-poverty programs. The security we profess to see in foreign adventures we will lose in our decaying cities."

Reverend KING observed that the United States is willing to make the Negro a 100 percent citizen in warfare but reduces him to 50 percent of a citizen on American soil.

In concluding his remarks, Reverend KING was reported to have commented that the United States is currently moving down a dead-end road that could lead to national disaster. He maid, "It is time for all people of conscience to call upon America to return to her true home of brotherhood and peaceful pursuits. Those of us who love peace must organize as effectively as the war hawks." He declared the United States still has a choice "nonviolent coexistence or violent co-annihilation".

With reference to the same conference, the "Atlanta Journal" on page three of its final edition February 25, 1967, published an article datelined Los Angeles February 25, 1967, entitled "King Declares United States Actions Like Hitler". This article pointed out Reverend KING compared the United States involvement in Viet Nam to HITLER's rise to power in Germany and quoted him as follows:

"There is grave irony in the fact HITLER could come forth, following the nakedly aggressiveness, expansionist theories he revealed in 'Mein Kampf' and do it all in the name of peace."


On February 27, 1967, STANLEY LEVISON told Reverend KING that "The New York Times" publicity on February 26, 1967, concerning his speech in Los Angeles the preceding day established his right to speak on Viet Nam. Also LEVISON told him that this conference with the United States Senators was the proper place for him to express his anti-war sentiments.

On March 27, 1967, Reverend KING and STANLEY LEVISON discussed the probability that Reverend KING's current position regarding the Viet Nam war would adversely affect financial contributions to SCLC. They agreed to discuss this matter further on April 4, 1967, at a meeting to be held in New York City which would also be attended by HARRY WACHTEL and several officials of SCLC.

The "Atlanta Constitution", daily Atlanta newspaper, on April 5, 1967, published an article on page one entitled "King Calls United States Leader in Violence". The article, reflecting the byline of AUSTIN SCOTT, revealed that on April 4, 1967, Reverend KING addressed a meeting of clergy and laymen concerned about Viet Nam held at Riverside Church, New York City. During his speech, Reverend KING referred to the United States Government as the "...greatest purveyor of violence in the world today." He called upon all ministers of draft age to give up their ministerial exempt status and seek status of conscientious objectors. He further recommended conscientious objection status "...to all who find the American course in Viet Nam dishonorable and unjust."

Reverend KING, the article reflected, stated he had planned to increase the tempoof his fight against the Viet Nam War because this war was draining the domestic progress needed to fight poverty.





On April 11, 1967, STANLEY LEVISON furnished DORA E. MC DONALD a statement he had prepared for Reverend KING to incorporate into a speech he was scheduled to deliver in Lus Angeles on April 12, 1967. In this statement, LEVISON set forth several points which he desired Reverend KING utilize in his speech. These were as follows:

- Atlanta and has traveled thousands of miles each month which has taken him into Negro communities throughout the nation; that his direct personal experience with Negroes in all walks of life has convinced him that the majority oppose the war in Viet Nam; and their opposition is based on two reasons. They are against the war itself and feel it has caused significant and alarming diminishing concern to civil rights progress.
- 2) His recent opposition to the war is attributed to many requests from Negroes that he articulate their concern and frustration. They feel that divit rights is well on its way to becoming a neglected and forgotten issue long before it is even partially solved.
- 3) It was not true that he advected the fesion of civil rights and the peace movement; he and SOLO have expressed their views on the war and drawn attention to its damaging effects on civil rights programs, but do not desire a merger or fusion of movements; that the war is hampering the civil rights program could not be ignored as a factor. The basis elements in common between the peace movement and the civil rights movement are human elements.
- 4) He did not believe the nation could be a menal leader of justice, equality, and demotion if it becomes trapped in the role of a self-appointed world policeman; and that he would reiterate his determination to express his opposition to this wrong without dminishing in any way his civil rights role.







On April 12, 1967, the "Los Angeles Herald Ronniner", a major metropolitan Los Angeles newspaper, reported that on April 12, 1967, Reverend KING held a news conference in conference room number seven, Filtmore Hotel, Los Angeles, regarding his views of the Vist Kam War. Reverend KING stated he favored a dessation of borbing, unilateral withdrawet of troops and an end to American participation in this "diffest war".

During the aforementioned news conference, Reverenge KIN : stated in part as follows:


"I have lived and worked in ghettes throughout the nation and I travel ten of thousands of niles each month which takes me into dozens of Northern and Southern Negro communities. My direct personal experience with Negroes in all walks of life convinces me that there is deep and widespread discondantment with the war in Viet Nam; first because they are against war itself, and secondly, because they are against war itself, and secondly, because they feel it has caused a significant and alarming diminishing of concern and attention to civil rights progress. I have hald these views myself for a long time but I have spoken more frequently in the recent period because Negroes in so many circles have explicitly urged me to articulate their concern and frustration. They feel civil rights is well on its way to becoming a neglected and forguitten issue long before it is even partially solved.

"Recently a myth about my views on Viet Name has confused the clear issue. The myth credits me with advocating the fusion of the civil rights and peace movements and I am criticized for authoring such a serious tactical mistake. I hold no such view. The basic element in common between the peace movement and the civil rights movement are human elements.

"I am a clergyman as well as a civil rights leader and the moral roots of our war policy are not unimpostant to me. I do not believe our nation can be a moral leader of justice, equality, and democracy if it is trapped in the role of a self-appointed world policeman."






On May 12, 1967, Reverend KIVC solution into STATILY LEVISON his opinion of an invitation which Reverend KIVE had received to meet in Paris, France, with a representative of the North Vietnamese. He told LEVISON he had decided not to accept this invitation and LEVISON stated he agreed to this decision.

LEVISON suggested that since the North Vietnamese were desirous of an honest appraisal of the peace sentiment in the United States Reverend KIN2 should suggest responsible individuals in the Peace Movement prepare such an appraisal and offer it to the North Vietnamese through a representative of the United Nations.

Reverend KING said he believed it would be best if he continued to amass Negro support against United States action in Viet Nam. He said if opposition to the United States policies in Viet Nam develop to the point at favoied a constation of United States bombing he would go to Hench to meet with Ho Chi Minh to urge commencement of negatiations.




On October 11, 1967, Reverend KING discussed with STANLEY LEVISON some speeches which LEVISON had prepared for him. LEVISON told Reverend KING he had completed a manuscript for him dealing with the Viet Nam issue and pointed out this manuscript contained some different approaches than previously.




During the latter part of September 1967 Reverend KING discussed with ANDREW J. YOUNG, STANLEY LEVISON, and HARRY WACHTEL the desirability of him accepting an invitation he had received to go to Moscow with several other Mobel prize winners in order to meet with Ambassadors from North Viet Nam and the National Liberation Front.

The "Atlanta Journal and the Atlanta Constitution", weekly Atlanta newspaper, on page 2A of its Movember 5, 1967, edition published an article bylined BILL WYNN, entitled "Soviets Invite King For Vietnam Talks". This article reflected that on November 4, 1967, Reverend King said he had received an invitation to go to Russia to participate in talks aimed at ending the Viet Nam war. He explained he was one of three Nobel prize winners invited and was willing to accept the invitation if the other two individuals did so. Reverend KING, the article continued, stated there were no definite plans for the trip but declared "negotiations must be started now to bring an end to the war that is destroying the soul of this nation."

According to the article, the invitation referred to by Reverend KING had originated with the Norwegian Government and was forwarded through the Soviet Union.

In it, RUSTIN is said to have come to New York in 1938, as an organizer for the Young Communist League (YCL), and as such, he had the job of recruiting students for the "Party." Furthermore, the article reports that during his first years in New York, RUSTIN gave most of his earnings to the "Party." He reportedly left the "Party" in 1941, the article states.

A source advised that on October 26-27, 1963, a conference of members of the Communist Party, USA (CPUSA), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt for the most peaceful transition to socialism. The delegates were told that it would be reasonable to assume that the young socialists attracted into this new organization would eventually

A second source has advised that the founding convention for the new youth organization was held from June 19-21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time the name W.E.B. DuBois Clubs of America (DCA) was adopted. Approximately 500 delegates from throughout the United States attended this convention.

The second source advised in September, 1966, that MIKE ZAGARELL, CPUSA Youth Director, stated that in Negro communities the Party still supported the plan to build "left" socialist centers and to solidify the Party base through the DCA. This source also advised in September, 1966, that DANIEL RUBIN, CPUSA National Organizational Secretary, stated the Party believes the DCA should have a working-class outlook and be a mass organization favorable to socialism, socialist countries and Marxism, and in April, 1967, advised that GUS HALL, CPUSA General Secretary, indicated the DCA primary emphasis should be on developing mass resistance to the draft.

A third source advised in September, 1967, that JARVIS TYNER was elected chairman of the DCA on September 10, 1967, at the Third National Convention of the DCA held in New York, New York, from September 8-10, 1967.

A fourth source advised during August, 1967, that JARVIS TYNER is a member of the National Committee of the CPUSA.

A fifth source advised on September 21, 1967, that the headquarters of the DCA is located at 34 West 17th Street, New York, New York.

W.E.B. DU BOIS CLUES OF CHICAGO (DCC)



On May 3, 1965, a source advised that on June 30, 1964, a group of young people who attended the founding convention of the W.E.B. DuBois Clubs of America (DCA) met in Chicago and adopted a statement of purpose and constitution forming the DCC as an affiliate of the national DCA.

A second source advised on May 1, 1967, that DCA chartered clubs in the Chicago area are the West hide DCC and the North Side DCC, neither of which currently maintain a headquarters. There is no central headquarters for the DCC and there are no unchartered clubs in this area.

The second source advised that the majority of DCC members are also members of the CP.

During the past year DCC activity has been almost nonexistent.



FREEDOMWAYS ASSOCIATES, INC.

The records of the New York State Secretary of State Albany, New York, show that the Certificate of Incorporation of Freedomways Associates, Inc., was filed on March 2, 1961.

On May 24, 1961, a source advised that a report was given on "Freedomways" at a meeting of the National Board, Communist Party, U.S.A. (CPUSA), held on May 24, 1961. It was stated that the central purpose of "Freedomways" is to develop a theory and positive criticism of currents in the Negro movement, as well as to raise the level of understanding and discussion taking place in Negro life today and to project a socialist and pro-Soviet orientation.

On May 25, 1961, a second source advised that "Freedomways" was set up for the CPUSA by James Jackson.

The Second Quarter, 1966, issue of "Freedomways," self-described as "A Quarterly Review of the Negro Freedom Movement" published by Freedomways Associates, Incorporated, 799 Broadway, New York City, lists the following as its editorial staff:

John Henrik Clarke, Associate Editor Esther Jackson, Managing Editor J. H. O'Dell, Associate Managing Editor John L. Devine, Art Editor

A third source made available information on July 1, 1964, indicating that John Henrik Clarke attended the first and founding meeting of the American Institute for Marxist Studies (AIMS) which was held on December 19, 1963, and continued on January 10, 1964.

This source also made available information on August 14, 1964, indicating that Clarke is an "Associate" of AIMS.

On March 16, 1966, a fourth source advised that James Jackson, accompanied by his wife, Esther Jackson, was scheduled to depart on March 25, 1966, from the United States en route to Moscow to attend the 23rd Congress of the CP of the Soviet Union. This source described James Jackson as a member of the National Committee, CPUSA.

This source advised in July, 1962, that as of that period, O'Dell was considered by the CPUSA, as being a member of its National Committee.

On January 30, 1961, Sylvia M. Brenner Devine, 415 South 50th Street, Philadelphia, Pennsylvania, advised that her former husband, Jack Devine, mentioned on December 17, 1960, that he was still in the CP and that the CP is his whole life.

On July 24, 1963, a fifth source described John Devine as a CP member.

GANDHI SOCIETY FOR HUMAN RIGHTS

The Gandhi Society for Human Rights was formed for the purpose of developing a philosophy and technique of non-violent civil rights protests. It is a non-action organization and makes no attempt to influence legislation nor participate in demonstrations. The Society furnishes legal assistance in certain civil rights cases. The organization was incorporated June 14, 1962.

SOUTHERN CONFERENCE EDUCATIONAL FUND, INC.

"The Southern Patriot," a monthly publication, shows that it is published by the Southern Conference Educational Fund, Inc. (SCEF).

"The Southern Patriot" was cited as an "organ" of the Southern Conference for Human Welfare (SCHW) by the Committee on Un-American Activities, House Report 592, June 12, 1947.

The SCHW was cited as a communist front by the Committee on Un-American Activities, House Report 592, June 12, 1947.

An amendment to the charter of the SCHW dated April 26, 1946, changed the name of that organization to the SCEF, and listed its purpose as being to improve the educational and cultural standards of the Southern people in accordance with the highest American democratic institutions, traditions, and ideals.

The SCEF is self-described as having deep roots in the South where it began as the educational wing of the SCHW, organized in 1938 to work for economic and political reform. When the SCHW disbanded in the late 1940's, SCEF continued as an independent organization, rallying support for integration and democracy and helping to stimulate and nurture new movements of the early 1960's. The SCEF maintained headquarters in Louisiana for twenty years, but in 1966 moved its headquarters to Louisville, Kentucky.

A source advised on March 2, 1961, that CLAUDE LIGHTFOOT, a Communist Party Functionary, stated at a meeting of the Communist Party in Baltimore, Maryland, on February 25, 1961, that the Communist Party is not connected with any progressive movement but indirectly they do have some influence in the SCEF.

A second source, who is familiar with some phases of Communist Party activity in the New Orleans area, advised on June 8, 1966, that during the time that the SCHW was in existence members of the Communist Party were members of and worked actively in the SCHW; however, since the formation of the SCEF, Communist Party members have not been encouraged to work in the SCEF. The source stated that the SCEF is a progressive, liberal organization, which he considers a Communist Party front organization because it has gone along with the Communist Party on certain issues, particularly on the racial issue.

CARL BRADEN and ANNE BRADEN, Director and Associate Director respectively of the SCEF, were identified by ALBERTA AHEARN, 2311 Payne, Louisville, Kentucky, a self-admitted former member of the Communist Party, on December 13, 1954, in her testimony in Jefferson County, Kentucky, Court in the prosecution of CARL BRADEN under a state sedition statute as members of the Communist Party in Louisville, Kentucky, From January, 1951, to December, 1954.

A third source advised on May 28, 1965, that GEORGE MEYERS, a Communist Party functionary, expressed great admiration for CARL and ANNE BRADEN and the SCEF, with which they are affiliated, and expressed the view that the SCEF is the best organization in the South as far as doing effective work is concerned and that they have a better idea of what they are doing, where they are heading, and influence other organizations for the better.

The second source also advised on June 8, 1966, that many people who are officials and supporters of the SCEF, while liberal in their views, are by no means Communists.

On March 26, 1968, a confidential source, who has furnished reliable information in the past, advised that Dora McDonald, Secretary to Martin Luther King, Jr., head of the Southern Christian Leadership Conference (SCLC), requested Stanley Levison to prepare a letter for colleges pointing out that King is not a candidate for the presidency and that there is no campaign material available. She said she wanted this letter, because due to the "Time" Magazine, College Presidential Poll in April, letters have been received from many colleges asking for campaign material and King's appearance at these colleges

The source learned that later on March 26, 1968, Stanley Levison discussed with Martin Luther King, Jr., the request from Dora McDonald to prepare a letter stating King is not a presidential candidate. Levison suggested that King's position, on this college poll, should be to state that he, King, does not want to be included as a candidate because his candidates are those who are strongly opposed to the (Vietnam) war or those in favor of ending the war and those who support the principles of the President's Commission on Civil Disorders. Levison continued that as King sees it, there are only two candidates who reflect these points of view, namely, Senators Robert Kennedy and Eugene McCarthy, and King would prefer not to be a third candidate and split the anti-war candidates.

King agreed with this suggestion. He noted that he already determined that he would say he is not a candidate and is not interested in becoming one. He felt a better way to handle the requests would be to send some material such as some of his speeches.

Levison commented that if King were to be a candidate in the college poll he, Levison, could envision King polling a number of votes, along with Kennedy and McCarthy, which would result in President Johnson emerging the winner in the collegiate poll. Levison pointed out that, in taking the position he suggested, King would be "blessing both McCarthy and Kennedy", and not making a choice yet between them.

King stated this is the position he has followed thus far, that both are good, competent men, committed to the principles they are concerned about. He added, however, that they should be realistic enough to see that, if there is any possibility of stopping President Johnson, it will be Kennedy.

Levison agreed, stating that many liberals are being sentimental and not very wise because Kennedy will have a tough job in stopping President Johnson. He said it cannot be done "with a Galahad, like McCarthy". He added that he keeps pointing out that McCarthy was less progressive than Kennedy in the past. Levison agreed with King that McCarthy has not been as strong on civil rights as has Kennedy.

Levison and King agreed that President Johnson has his greatest strength among the working class and among Negroes, that McCarthy has no strength among these groups, but that Kennedy does. They agreed also that Kennedy will split the Negro vote with Levison adding that Kennedy also will split the working class vote.



King expressed the opinion that at some point along the campaign trail Kennedy and McCarthy will have to get together. Levison then criticized McCarthy's stubborness on this point, stating that he would have expected McCarthy to say he will finish up, do a tremendous job in Wisconsin, then withdraw.

The American Mau Mau was organized in Harlem,
New York City, by CHARLES MORRIS, also known as Charles
Kenyatta, and Charles 37X, in the Fall of 1966. A source
advised that the following are the aims and objectives of the Mau Mau, as stated on a form distributed to new members:

"The Mau Mau Society is a group of Afro-American militants and semi-militants who, under the direction and was leadership of Charles Kenyatta, Chairman and Founder, have come together to further, or help further, the cause of Black Liberation on a world-wide as well as national scale. The Mau Mau Society is not a true organization in the true sense of the term organization but, rather, as stated, a society, a Black Society. The Mau Mau membership may come from many and any walk of life. They are bound together by one common thought, BLACK LIBERATION AND BLACK FREEDOM, NOW! This is the common thought, dream and goal. Membership in the Mau Mau body is unrestricted save that the applicant be Black, Afro-American in particular or any Black Person in general. Age, sex, previous or present affiliation or membership in any other group or organization, religion, etc., of an applicant for membership shall have no bearing upon acceptance or rejection of that application. He welcomes brothers and sisters of any and all beliefs and persuasions, requiring only that such sister or brother be in tune in some way with the Black Revolution and be BLACK."(u)

CHARLES MORRIS was a member of the Nation of Islam (NOI) Mosque #7, New York City, as of August 8, 1962, according to a second confidential source. He was expelled April 6, 1964, according to a third source. CHARLES MORRIS held a position of leadership and responsibility in the Muslim Mosque Incorporated (MMI) and was a close friend of MALCOLM X LITTLE, slain founder and leader of the MMI, according to a fourth confidential source. 



A sanitation workers strike has been going on in Memphis for some time. Martin Luther King, Jr., today led a march composed of 5,000 to 6,000 people through the streets of Mamphis. King was in an automobile preceding the marchers. As the march developed, acts of violence and vandalism broke out including the breaking of windows in stores and some looting.

This clearly demonstrates that acts of so-called nonviolence advocated by King cannot be controlled. The same thing could happen in his planned massive civil disobedience for Washington in April.

Martin Luther King, Jr., President of the Southern Christian Leadership Conference, injected himself into the sanitation workers' strike in Memphis, Tennessee, and the result of King's famous espousal of nonviolence was vandalism, looting, and riot.

Previously, King involved himself in this strike, called for a general strike, and called for a mass march. Today he led the mass march in an automobile at the head of the line. Negroes began shouting "black power" and trouble began. King, apparently unable or unwilling to control the marchers, absented himself from the scene; window breaking and looting broke out.

Police officers were forced to use gas to break up the march and to control the crowd. It was necessary to activate the National Guard. Martin Luther King claims his much-heralded march on Washington, scheduled for April 22, 1968, will also be "nonviolent." He says he has persuaded militant black nationalists to abandon violent extremism in Washington, D. C., during the march. Memphis may only be the prelude to civil strife in our Nation's Capitol.



A confidential source, who has furnished reliable

information in the past, learned on March 28, 1968, that, late on that date, Stanley Levison and Martin Luther King, Jr. discussed the violence that occurred in Memphis, Tennessee mon March 28, 1968, following King's leadership of a protest march through downtown Memphis. King indicated that he has become so depressed over the developments in Memphis that he has considered calling off the Washington March (his self-described Poor People's Campaign, scheduled to begin in Washington, D.C. on April '22, 1968)

Levison told King that his depression was aggravated exhausted as a result of his recent strenuous program. He counseled King not to be on the defensive over the events in Memphis but, on the contrary, should take the position that the majority of people in the Memphis March did not join in the rioting that took place, proving the effectiveness of King's leadership and his policy of non-violence. Levison emphasized that the Washington March will be different in that King will have organized this march and his forces can stress the importance of non-violence. Levison suggested that Saturday morning (March 30, 1968) would be a better time to meet in Atlanta to discuss the Memphis incident rather than meeting on Friday night (March 29, 1968) because it will give King time to rest.





King agreed in every respect with Levison's evaluation.

The source also ascertained that, prior to conferring with King, Levison spoke with the Reverend Ralph Abernathy, an aide of Dr. King's, who advised Levison that King has cancelled a scheduled appearance in Washington, D.C. on March 29, 1968. Abernathy also noted that King is scheduled to be in Virginia on Saturday (March 30, 1968) but will probably cancel that appearance. Abernathy continued that it was a mistake for the King forces not to have a staff in Memphis to train people in non-violence. He said it also was a mistake on the part of the King forces not to have been more aware of the local situation.

A source who has furnished reliable information in the past advised on March 20, 1968, that the Reverend Martin Luther King, Jr., President, Southern Christian Leadership Conference (SCLC), would participate in a motorcade from Norfolk, Virginia, to Richmond, Virginia, on March 30, 1968. According to the tentative plans, Reverend King will arrive at Norfolk via airplane at approximately 9:00 a.m. March 30, 1968, and travel to Suffolk, Virginia, arriving there about 11:30 a.m.; proceed to Ivor, Southampton County, Virginia, 1:00 p.m.; arrive Waverly, Sussex County, Virginia, 2:00 p.m.; arrive Petersburg, Virginia, 3:00 p.m.; arrive Hopewell, Virginia, 4:00 p.m.; will hold a mass meeting at Sixth Mount Zion Church, Richmond, 7:00 p.m.; then depart for Atlanta, Georgia, via plane. This source said Reverend King planned no speeches except at Richmond.

"The Ledger-Star," a daily Norfolk newspaper of general circulation, dated March 25, 1968, reported a news release from Richmond in which it was pointed out that Richmond may be the marshaling point and possibly the starting point of Doctor Martin Luther King's "poor peoples march on Washington." This announcement, according to the newspaper, was made by officials of the SCLC. This news report said that Reverend King, SCLC head, is scheduled to make a seven-stop speaking tour in Virginia on Saturday (March 30, 1968) with a final engagement scheduled for Richmond. It was also pointed out that it was believed he may announce his selection of Richmond as the central southern staging area for his march scheduled for April 22, 1968.

The newspaper pointed out that during Reverend King's Virginia tour he is scheduled to visit Norfolk, Suffolk, Ivor, Waverly, Petersburg, and Hopewell before appearing in Richmond.



A confidential source, who has furnished reliable information in the past, learned on March 23, 1968, that on that date William Rutherford, (Executive Director, Southern Christian Leadership Conference) (SCLC) was in contact with Stanley Levison. Levison told Rutherford that the question of finances is of concern to him and Rutherford agreed that they do not have the income to match their needs. He explained that as regards regular operations they have no problem but that their traveling bills are now double and that, in addition they have extraordinary needs which are getting worse.

Levison commented that the fund-appeal letters cannot bring in enough money to take care of these kind of extraordinary expenses and that there is no other apparatus to raise the money. He said they must take a hard look at what kind of money is going to be involved, adding that it would be insane to bring 3000 people to Washington, D.C. (for Martin Luther King's Poor People's Campaign) only to find that they (the SCLC) cannot provide for them.

According to Rutherford this is what "they" are saying, "to hell with that", get the people first because something always happens (in the way of finding accommodations).

Levison stated that he intended to be present at an executive meeting on March 25, 1968, to fight this attitude.

Rutherford related that Martin Luther King is concerned that recruiting (for the Poor People's Campaign) is slow and that a new approach has been decided upon. He said that Hosea (Williams), Bernard (Lafayette), Jim Bevel, and Andy (Young), (all SCLC officials) are among the best recruiters and it is felt they should get out and recruit. Rutherford continued that there is a "wing" coming down from the Boston, Providence, New York area which would be handled by Andy (Young), a "wing" from the midwest encompassing Milwaukee, Detroit, Chicago and Cleveland to be handled by Jim Bevel, a "wing" from the South to be handled by Hosea (Williams) and that Bernard Lafayette would be in Washington, D.C. to coordinate the operation. Rutherford added that recruiting has been going well in the New York City area and in Philadelphia.

Levison said he would rather have one thousand good "troops" that can be housed together and mobilized effectively so they could be moved from place to place rather than have three thousand scattered all over Washington.


Rutherford stated that they are going to set up a camp and Levison remarked that, if it is a camp he saw projected for one thousand (people), it will cost \$31,000, a figure that does not include labor, food and bedding. Levison asked where this money is to come from, noting that it is one thing to proceed on faith but to launch something this important is another. He said this campaign will receive a great deal of publicity, leaving no margin for error, and that all the publicity could be on the campaign floundering if they proceed on faith alone.

They discussed the possibility of getting the finances from labor unions with Levison stating there is no precedent for it.

He said no labor union has ever donated more than \$10,000 except on one occasion. Levison said the only union he could see, which might give the money needed, is the United Automobile Workers (UAW) and that King would have to do this personally. Rutherford commented that he raised the question whether King could appeal to (Walter) Reuther (head of the UAW) and that "they felt iffy about it".

On February 12, 1968, the "Washington Evening Star", a daily Washington, D.C., newspaper, reported that the Very Reverend Francis B. Sayre, Dean of the Episcopal Cathedral, Washington, D.C., had invited Dr. Martin Luther King, Jr., to speak from the Cathedral pulpit concerning the poor people's march planned by King and the Southern Christian Leadership Conference, of which King is President. The newspaper quoted Dean Sayre as saying that King "is the best hope we have" and called him "the apostle of non-violence."

On March 20, 1968, the "Washington Post and Times Herald", a daily Washington, D.C., newspaper, reported that King had announced he had accepted an invitation to preach at the eleven a.m. service in the Washington Cathedral on Sunday, March 31, 1968.

advised March 14, 1968, that Dr. Martin Luther King, Jr. was scheduled to address the convention of the California Democratic Council at the Anaheim Convention Center, Anaheim, California, at noon on Saturday, March 16, 1968.

advised on March 16, 1968, that Dr. King appeared at a press conference at the Disneyland Hotel, Anaheim, California, that date. He stated that he never endorsed any presidential candidate, but spoke highly of Senator Eugene Mc Carthy, Minnesota, and indicated that he might endorse him as a presidential candidate in the 1968 election, claiming that he is passive, non-violent but militant against poverty and the Vietnam War.

stated that Dr. King also appeared as the main speaker at the luncheon of the California Democratic Council which was held at the Anaheim Convention Center on the same date. Dr. King stated that if the Government would do something about Negro poverty in the winter time there would be less likelihood of summer violence. He also indicated that there would be a march on Washington, D. C., in April 1968 and the participants will conduct a "stay-in" at Governmental offices until the end of the congressional session to protest Negro poverty. He stated that it was ridiculous to spend money to kill Vietnamese in Vietnam and not help underpriveleged Negroes.

stated that King left Anaheim at 2:30 p.m. for an unknown appointment in Los Angeles.

A source, who has furnished reliable information in the past, advised on March 17, 1968, that Dr. King spoke at an Elk's Club somewhere in Los Angeles on the afternoon of March 16, 1968. There he received donations for the Washington Spring Project in the amount of \$6,000, in cash and an undisclosed amount in checks.

The "Los Angeles Times", a daily newspaper published in Los Angeles, California, in its issue of March 17, 1968, carried an article which quoted Dr. King while he was in Anaheim, California, on March 16, 1968. He stated, "The problem is the Government has many programs but nothing has been done." He stated that the spring demonstrations which he will begin in Washington, D. C., on April 22, 1968, are to appeal to the conscience of Congress to escalate the war on poverty and racism and de-escalate the war in Vietnam.

advised on March 18, 1968, that Dr. King was staying at the Hyatt House Hotel, 5547 West Century Boulevard, Los Angeles, and would be leaving Los Angeles for New Orleans and Memphis about noon on March 18, 1968, via National Airlines.

The "Los Angeles Times", previously mentioned in its issue of March 18, 1968, indicated that Dr. King had spoken at the Second Baptist Church in Los Angeles On Sunday, March 17, 1968. He stated that it was time for someone in Washington to admit that a mistake has been made in Vietnam and that this nation is involved in a "senseless, reckless, immoral and unwinnable war." He also indicated white racism is "still a glaring reality in our country" and that Congress, dominated by the rural South "stands as a stubborn force in the way of social progress."



Reference is made to our memorandum dated March 14, 1968, and captioned as above.

Martin Luther King, Jr., President, Southern Christian Leadership Conference (SCLC), has publicly announced he will conduct a massive civil disobedience campaign in the Nation's Capital during April, 1968, in an effort to pressure Congress into passing legislation favorable to the Negro.


In pursuit of this project, the SCLC has opened an office in Washington, D.C., from which to organize and direct the Washington Spring Project (WSP).





stated they expect the "non-poor" to join the demonstration on Sundays and also to visit various Congressmen on behalf of the MSP. They do not expect the "non-poor" to actually march with the demonstrators unless the poor are subjected to harsh treatment at which time they expect them to join the poor and subject themselves to the same treatment.







Alternate Housing: To develop alternate housing arrangements in the Washington Metropolitan area (e.g. private homes, churches, gymnasiums, hotel facilities, etc.) in case the participants are unable to live in the "New City" which is the name WSP officials have given to the camp-in site to be constructed for the Project.

Transportation: To develop resources (e.g. buses, cabs, private cars, etc.) for transporting participants without expense to various campaign activities in the Washington Metropolitan area.

Building Structures and Layout: To design and find resources for the construction of temporary shelters (e.g. tents, prefabricated housing, shanties, etc.) and to arrange them in a manner which enhances social interaction and other functions of the "New City."

Social Services: To provide specialized care that is not within the framework of campaign workers. To set up model social services facilities and make referrals to pertinent local chapters in home communities of the "New City" families.

Entertainment: To organize programs of entertainment for participants in the campaign.

Food: To make arrangements and be responsible for the feeding of participants of the campaign including the collection of food, its preparation and distribution to participants.

Freedom Schools: To plan and implement a model educational program for pre-school and school children, including high school participants in the campaign and to locate the resources, material and instruction necessary to operate the schools.

Medical and Sanitation: To work for the development of a model health care program for participants in the campaign, to carry out a regular program of health inspections of "New City" facilities, and develop the water supply and sanitary facilities of the "New City."





Procurement Committee: To make arrangements and be responsible for the acquisition of all supplies and necessities pertinent to the needs of all other committees and the general needs of "New City."

- 6. An area in the vicinity of 10,000 New Hampshire Avenue, White Oak, Maryland.
- 7. An area in the vicinity of 900 Rhode Island Avenue, N.E.
- 8. An area in the vicinity of Brentwood Road and T Street, N.D.





This committee has defined its' responsibilities as follows:

- 1. Site selection: Locate suitable open areas, determine size, location and ownership.
- 2. Develop Plan: Provide (in terms of materials available) plans for the use of the site.
- 3. Supervision: Check final construction of site for safety.

Their schedule calls for the selection of the site and planning for materials between March 10 and 31, 1968; obtaining material from March 30 until completed; making definite plans between March 30 and April 20, 1968; and construction and supervision from April 13 until completed.

This committee plans to meet again on March 19, 1968.

During the course of their conversation, the above mentioned person told LEVISON of negotiations or discussions having been carried on in Western Europe and with some people in the US, notably a MARK RASKIN (ph) and a DICK BARNETT (ph) in Washington at the Institute of Policy Studies.

The NYO indices have no identifiable information on a DICK BARNETT but the MARK RASKIN mentioned is undoubtedly the subject of NY File 161-249, Bureau file 161-429. In addition, "The Worker" of 10/24/67, Page 1, Column 5, noted that a MARK RASKIN of the Institute of Policy Studies spoke at the Pentagon during the rally against the Vietnam war sponsored by the National Mobilization Committee to End the War in Vietnam. In addition, "The Worker", of 10/8/67, Page 2, Columns 3 and 4 lists signers of a pledge denouncing US agression in Vietnam and pledging to raise funds to organize draft resistance unions and to aid resistance to the war. MARCUS RASKIN, former White House Aide is listed as one of the signers. (U)

A confidential source, who has furnished reliable information in the past, learned on January 22, 1968, that on that date, Stanley Levison had been contacted by a person from London who was unknown to the source. This individual told Levison that he was calling at the suggestion of Andrew Young, Executive Assistant to Martin Luther King, President of the Southern Christian Leadership Conference (SCLC). He said he had come to the United States from England on behalf of a canon of St. Paul's Cathedral, whom the source understood to be named Collins, to request Martin Luther King and Dr. Benjamin Spock to come to England at the end of February, 1968, to attend a meeting of several days aimed at beginning a campaign against the war in Vietnam. According to the source, this individual furnished the following information about this meeting: [

For several months there have been discussions in Western Europe as well as with some people in the United States, notably with several at the Institute of Policy Studies, Washington, D.C. They have been seeking a way of setting up an International Ad Hoc organization which will launch a mass media campaign, in newspapers and by buying spot television time (8

against the Vietnam war. Some people are suggesting this organization be called Act for Peace. It is felt that several million dollars could be raised to do this and, although it would be difficult to raise this kind of money in the United States, a number of private individuals and some of the churches of Europe are willing to put up the money.

The sponsors are likely to be people such as Archbishop Ramsey of the Church of England, Pierre Mendes-France, and a Cardinal from Bologna.

They would like Martin Luther King to agree to be a sponsor and for him and Dr. Spock to come to England for the meeting at the end of February, 1968, at which it is hoped the plans will be made and the campaign launched. In the meantime, he will be traveling between England and the United States getting the thing organized.

The individual from London said he had just come from Washington where he talked at length with Senator (Eugene) Mc Carthy who suggested it would be useful if he attended the February meeting. The idea at that time will be to hold private conversation with a group of people, one of whom was a legislative assistant in the Congress, one to be himself, Mr. Mendes-France's secretary, with a sort of organizing group in the British churches, and decide how the campaign will be launched.

He has talked with Andrew Young a number of times about King attending the meeting and being a sponsor. It appears that Dr. Spock will be agreeable although there is no confirmation on Spock's part as yet.

The source further advised that this individual told Levison that he wanted to let Levison know the details. He said Andrew Young had asked him to explain to Levison what was happening so that when a decision is made on King's attendance it can be discussed with Levison.

England

Levison asked about the length of the meetings and was told there probably would be several days of discussion and, if a decision is made to launch the campaign, a public meeting will be held about February 27, 1968. Levison was also told that if Dr. Spock should come they will have a public meeting about the indictments anyway (the indictment of Dr. Spock and others for violation of the Selective Service Act).


Levison felt that idea was good but suggested that King's problem might be his plans for his civil disobedience campaign in the United States in April, 1968.

The man from London commented that they were hoping that the mass media campaign would articulate with and be useful to King's April campaign.

Levison also inquired about the people who have committed themselves to the idea of an Ad Hoc Organization. He was told that as far as the Church of England is concerned, even though there may be some difficulty about the Archbishop, they have the backing of two very powerful Bishops, Woolich and Southick as well as Bishop Reeves of South Africa and Bishop Roberts. If they can move properly in the next ten days then, this individual believes, Ramsey will agree. As far as Mendes-France is concerned there is no problem. The cardinal from Bologna has not agreed as yet and neither has the Archbishop of Vienna. In addition several Nobel people are not certain. He told Levison that it is a question of deciding how high a level of sponsorship above, for example, Nobel Peace Prize winners, they want to get.





The following information has been supplied by confidential sources of this Bureau who have furnished reliable information in the past.

Martin Luther King, Jr., President, Southern Christian Leadership Conference, has ennounced publicly he will conduct a massive civil disobedience campaign in the Nation's Capital in April, 1968, in an effort to pressure Congress into passing legislation favorable to the Negro. King calls this campaign the "Washington Spring Project" or the "Poor People's Campaign."

On March 19 and 20, 1968, King and key members of his staff toured the State of Mississippi attempting to generate interest and support for this project.

In Jackson, Mississippi, on March 20, 1963, before an audience of approximately 400 persons, Hosea Williams, an eide to King, advised that the Southern Christian Leadership Conference had just completed a strategy macking. The data of the "Washington Spring Project" set as April 22, 1968, at Washington, D. C., has been canceled. According to Williams, King and his top leaders of the Southern Christian Leadership Conference will go to Washington, D. C., either April 23 or 24, 1968, where they intend to contact Congressional leaders, the Secretary of Labor, and the Secretary of Commerce. At this time, King will present his "Economic Bill of Rights" to the Congressional leaders and Government officials in an effort to receive assumences that legislation will be passed favorable to the Negro.


On April 27 or 23, 1966, the people recruited for this campaign in Mississippi will arrive in Jackson for a wass meeting. They will march through the downtown section of Jackson en route to Birmingham, Alabama. At Birmingham, they will meet another group which will have completed a mass meeting and march through Birmingham. This same procedure will be adhered to in the following cities: Atlanta, Georgia; Columbia, South Carolina: Lurham, North Carolina; and Richmond, Virginia. This group will then continue to a staging area located at Alexandria, Virginia. At the same time, groups will follow the same arrangement describing from Boston. Massachusetts: Datroit, Michigan; Chicago, Milinois; and Philosolphia, Penncylvania. This latter contingent will meet at a staging area near Bultimore, Amyland. The Southern Christian Leadership Conference expects to have a total of 3,000 paople in .. these groups who will then march on Vashington end stay for at least two weeks. This original group, after two weeks, will be replaced by a second group and this will continue until enough pressure has been applied on Congress and favorable legislation is passed. A "Gity of Hope" or a "Shanty Town" will be built in Washington to house and feed these demonstrators. According to Williams, the Scuthern Christian Leadership Conference will stay in Vashington by continuing to send vevos of people until the Democratic Convention which begins in August, 1968.

King also spoke at this meeting and expressed the same sentiments as Williams. King also stated that professional groups, professional people, and industrialists throughout the country are being contacted for denations to support this project.

After this meeting, as in the other Seven meetings where King spoke, a collection was requested for funds to support this campaign. To a select group later, King expressed disappointment at the lack of enthusiass and small denations has

had received in the past two days in illesissippi. It was determined that a total of \$1,000 was collected from these eight rallies and there appeared to be few volunteers available to go to Washington.







Stated that Dr. King arrived in Batesville shortly before 1 p.m. and departed Batesville shortly after 1:20 p.m. He stated that Dr. King spoke to a group of approximately 400 individuals assembled at the Mount Zion Church.

stated that Dr. King's speech centered around the forthcoming march in Washington, D.C. King encouraged individuals to participate in this matter; and the group, according to Myles, was very receptive to King.

The March 20, 1968, edition of "The Clarion-Ledger", page 7, a Jackson daily newspaper, contained an article that stated that one white man contributed a \$100 bill during Martin Luther King's appearances at the Mount Zion Baptist Church, Batesville, Mississippi.

Martin Luther King, Ralph Abernathy, and Hosea Williams arrived at Valley Queen Baptist Church, Marks, Mississippi, at 1:45 p.m. March 19, 1968. All three spoke at that Church without incident, and they departed Marks at 2:10 p.m.

The above individuals arrived at Clarksdale, Mississippi, 3:15 p.m. at the Chapel Hill Baptist Church, 303 Carolina, and all three spoke to 500 to 600 people until 4:30 p.m. at which time they departed en route to Greenwood.

They asked for a show of hands regarding those who would participate in the Washington Spring Project (WSP) from Clarksdale area and two persons raised their hands.

On March 19, 1968, Martin Luther King arrived at 5:30 p.m. at Greenwood, Mississippi Airport, Greenwood, Mississippi, in a twin engine Cessna 411 Charter Aircraft bearing Identification Number N3223Q.

that King spoke to a group of approximately 475 individuals at the Jennings Temple Church, Avenue G and Ash Streets, Greenwood, Mississippi. King advised his appearance in Greenwood, Mississippi, was to recruit poor people to go to Washington, D.C. King stated that their purpose was to recruit 3,000 to 6,000 unemployed to go to Washington and stay as long as possible, with new waves of people to come in every week. King advised that after an appropriate number of people were present they were going to make a massive march to "plague" Congress.

During the speech, King requested a show of hands as to the number of individuals who would be available to go to Washington, D.C. during April, 1967.

At approximately 7:00 p.m. King and six other individuals were observed departing Greenwood, Mississippi Airport in the above aircraft on route to Grenada, Mississippi.

party arrived via aircraft at the Grenada, Mississippi Airport at 7:30 p.m. March 19, 1968. King thereafter held a meeting of approximately 30 minutes at the Bellflower Baptist Church, Pearl Street, Grenada, before a group of approximately 175 - 200 individuals. King thereafter departed the Grenada Airport at 8:45 p.m. via the Cessna 411 Aircraft, registration number N3223Q, en route to Laurel, Mississippi, to hold a similar meeting. King was in the company of Hosea Williams, Reverend Ralph Abernathy, Leon Wilbert Hall, Dorothy Cotton, and an MISS unknown young Negro male.

advised that License Number 22-3381 is registered to the Bellflower Missionary Church, Grenada, Mississippi.

that when King appeared before the crowd of approximately 200 individuals, he asked for support of his poor peoples march in Washington, D.C. citing necessity for this march as a request for jobs and other benefits. When King requested individuals to stand up to show their support for his project and the identity of those who would participate, approximately 30 individuals responded.

Source stated that the crowd responding to King's meeting was small in comparison to those in the past that King and his associates had drawn, nor did King receive an overwhelming support for his 'proposed project.

advised that King departed Grenada Airport, Grenada, Mississippi, at 8:45 p.m. in above described plane en route to Laurel, Mississippi.

that Martin Luther King arrived at St. Paul's Methodist Church, 517 Jefferson Street, Laurel, Mississippi, at approximately 10:00 p.m. on March 19, 1968, and delivered a 10 to 15 minute inspiring talk concerning the Washington Spring Project. King pointed out that the grandparents and parents of those present worked for nothing and as a result the present generation of Negroes have little or nothing. King warned that the grandchildren of those present will also have nothing if the Negro fails to act today and demand his God given and constitutional rights. He strongly encouraged the local Negro to rise up and join the Washington Spring Project. King explained that the purpose of the Washington Spring Project was to emphasize to the world that the American Negro, though he is an American citizen, he is not receiving the constitutional rights which are supposedly guaranteed to all American citizens but in reality are given only to American white citizens.

Source advised that the Church was crowded with approximately 300 persons and some 100 to 150 left before King's arrival as he was approximately three hours late arriving in Laurel. A collection was taken for King at the Church, the amount received unknown.

Young, and other leaders of SCLC will go to Washington either April 23 or 24, 1968, where they intend to contact Congressional leaders, the Secretary of Labor, the Secretary



of Commerce, and expect to receive assurances of legislation to improve the plight of the Negro. They will present "SCLC's Economic Bill of Rights to Congressional leaders and Government officials".

On April 27 or 28, 1968, the "Beachhead Troops", people from all over Mississippi, will arrive in Jackson for a major mass meeting. They will then march through downtown Jackson and board buses provided by SCLC and will leave en route to Birmingham, Alabama. At Birmingham they will meet a group who had just completed a mass meeting and march through Birmingham and will proceed on to Atlanta, Georgia; Columbia, South Carolina; Durham, North Carolina; Richmond, Virginia; and will meet at a staging point at Alexandria, Virginia. At the same time groups will have departed from Boston, Detroit, Chicago, and Philadelphia, to staging points around Baltimore, Maryland. They expect to have a total of 3,000 people in this group who will stay in Washington for at least two weeks. Then they will be replaced by a second group and this will continue until enough pressure has been applied that Congress takes appropriate action. They will build a "City of Hope, a shantytown", in Washington, D.C., to house and feed all participants. They will stay in Washington by continuing to send waves of people until the Democratic Convention.

Abernathy and King spoke briefly and echoed same sentiments as Williams. King said professional groups, professional people, and industrialists throughout the country are being contacted for donations for this project. He did not comment on how much has been received.

This source stated that there appeared to be few volunteers available to go to Washington, D.C. Source stated that King appeared irritated over the lack of enthusiasm of his crowd at the Masonic Temple for his Washington Spring Project.

advised that King expressed esseppointment over the lack of enthusiasm and turnout for his speech at the Masonic Lodge on this date.

At 4:16 p.m., March 20, 1968, King, Abernathy, Williams, and Dorothy Cotton departed from Thompson Airport, Jackson, Mississippi, via privately owned plane as described previously, en route to Birmingham, Alabama.
