

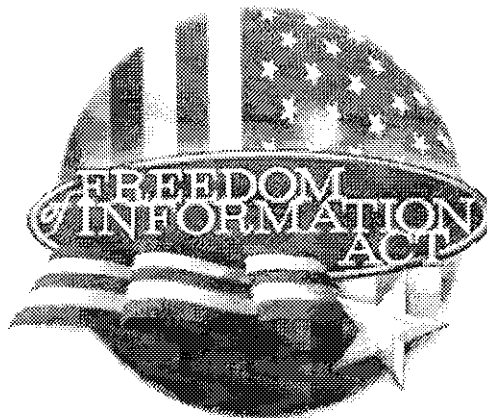

SAC Roney of New York called this morning and advised that information had just been received from Atlanta that King would arrive in New York today to fulfill a speaking engagement this evening in Madison Square Garden. He advised that King has reservations for himself and an associate in rooms 3027 and 3029 of the Americana Hotel in New York. *u*

New York has made preliminary inquiry concerning the possibility of a microphone installation in the rooms occupied by King tonight

On many occasions in the past, when King has been in New York, he has held strategy conferences with advisors such as Stanley David Levison, Clarence Jones, Harry Wachtel or Bayard Rustin, certain of which have security backgrounds. In view of the possibility that such a conference may occur at the Americana and on New York's assurance that an installation can be made with full security, New York was authorized to go ahead with the survey and the installation if it can be done securely. Immediate action was necessary in the interest of time. *u*

This installation will only be in effect one evening and an appropriate communication will be directed tomorrow to the Attorney General.

This Bureau's investigation of the communist influence in racial matters has developed considerable information indicating the influence upon Martin Luther King, Jr., head of the Southern Christian Leadership Conference, by individuals with subversive backgrounds such as [Stanley David Levison, Clarence Jones, Bayard Rustin] and others. From time to time, King meets with these individuals and coverage of these meetings by this Bureau results in the obtaining of evidence of the influences upon King as well as information concerning the tactics and plans of King and his organization in the civil rights movement. *SU*

On May 12, 1965, information was obtained indicating a meeting of King and his advisors was to take place in New York City on that date. Because of the importance of the meeting and the urgency of the situation, a microphone surveillance was effected May 12, 1965, on King in Suite 1690, Sheraton Atlantic Hotel, 34th Street and Broadway Avenue, New York City. This surveillance involved trespass and was discontinued on May 13, 1965.

NOTE:

This memorandum is classified "~~Secret~~" since it concerns a microphone surveillance, unauthorized disclosure of which could result in serious damage to the Bureau's security coverage to the detriment of national security.

Memorandum from J.S. Sizoo to Mr. Sullivan 5/13/65 reported the telephonic request of the New York Office 5/12/65 for authority to make installation of the microphone surveillance and in view of the urgency of the situation and on New York's assurance of full security, they were instructed to make the installation.

CIRM Communist Infiltration in Racial Matters

SAC [Roney] of New York called yesterday and advised that Martin Luther King was due to arrive in New York that evening and had reservations at the Sheraton Atlantic Hotel, 34th and Broadway, New York City. He has been assigned Suite 1690 and New York advised that Suite 1690 is available for the use of the New York Office for monitoring purposes. If the Bureau will approve a microphone installation, New York desires to install a [redacted] and which can then be monitored in Suite 1690.

In the past King has had conferences with [Stanley Levison, Harry Wachtel] and other advisors while he was in New York and New York advised that a conference with King, [Levison and Clarence Jones] is scheduled for late afternoon, probably in this hotel room. New York desired to make this microphone installation immediately. [Roney] requested authority so they could proceed with the necessary arrangements.

ACTION:

On New York's assurance that full security was available, and since time was of the essence, I told New York to go ahead with the installation as planned. In accordance to New York's request, New York was also authorized to pay up to \$40 a day for Suite 1690 if necessary for monitoring purposes.

Reurairtel 4/15/65 which advised that Martin Luther King, Jr., was planning to move his residence during the week of 4/12/65 to a recently purchased home located at 234 Sunset Avenue, N.W., Atlanta, Georgia, and that he was planning to have two telephone numbers at his new residence. It was stated that it was apparent that present source at King's residence, [redacted], would be discontinued as a result of the move. Bureau authority was requested to conduct a survey on the new residence so that appropriate recommendations might follow concerning technical coverage there. You assured full security for this survey.

Bureau authority is granted for the survey, full security is assured. Take no action relative to installation, limiting your action only to survey. Expedite so that any break in coverage may be minimized. Promptly advise Bureau of time and date of discontinuance at old residence.

Keep Bureau promptly advised of all pertinent developments.

NOTE: [redacted] is a technical surveillance on the residence of King, 563 Johnson Avenue, N.E., Atlanta, Georgia. It was authorized 10/15/63 and installed 11/8/63. It is noted that when we received the then Attorney General's authority for installation of this coverage, it was to be on King's residence or at any future address to which he may move. This source has, of course, been a most prolific one for extremely valuable intelligence relating to King and communist influence on him. After receipt of the results of survey and Atlanta's recommendations, a memorandum will be prepared along with any necessary correspondence with the Attorney General.

It subsequently developed that King himself did not stay in the Americana Hotel at night although he and the others had registered in the two rooms in question.

Informal memorandum 11/27/64 (attached) set forth a summary of data pertaining to highly sensitive coverage afforded Martin Luther King, Jr., during 1964. The summary set out the various incidents covered and noted the number of reels of tape available, the approximate listening time and the extent to which transcripts are presently available.

Mr. Tolson noted "I think all should be transcribed" and the Director so instructed.

Pursuant to your instructions to get the maximum amount of material available transcribed, we propose doing the following. In connection with items number 2, 3, 4 and 5 in the attached memorandum, it is noted that we already have field-prepared transcripts to the extent of 31 pages, 59 pages, 20 pages and 23 pages or a total of 133 pages. It is believed that these transcripts which were prepared by Agents on the scene are sufficient to back up the tapes. These were represented by the field as being complete transcripts, pursuant to Bureau instructions.

In connection with item number 1, the Willard Hotel, Washington, D. C., incident, we have no transcripts but only an 8-page memorandum. We propose having transcripts prepared covering the 15 reels and approximate 17 hours listening time. In connection with item number 6, the Los Angeles, California, 7/8-9/64 incident, we have only 3 pages of transcript and inasmuch as there are 5 reels with approximately 7 1/2 hours listening time we propose having a more complete transcript prepared.

If approved, we will immediately direct the Washington Field Office to commence preparing the transcripts for items 1 and 6, it being noted that Washington Field Office has available sound-trained Agents who participated in the original monitoring, are very familiar with voices, etcetera, and are in the best position to handle this matter which will be a very time-consuming process because of such various factors as outside interference, numerous individuals talking at once, the drunken condition of many of the individuals at times, their manner of speech and other similar factors. The Laboratory will furnish the necessary equipment to assist in this project.

RECOMMENDATION:

Upon approval, this memorandum should be returned to the Domestic Intelligence Division for issuance of necessary instructions to get the preparation of the transcripts underway.

I see no necessity, however, in this work being done at the present time inasmuch as the controversy has quieted down considerably and we are not in need of transcriptions right now. In view of the transcription already accomplished, and because of the above-mentioned reasons, I would recommend that we hold off doing this tremendous amount of work until there is an actual need.

I think it should be done now while it is fresh in the minds of the specially trained agents.

Set forth below, in chronological order, is a summary of data pertaining to highly sensitive coverage afforded Martin Luther King, Jr., during 1964.

1. Washington, D. C., January 5-7, 1964. 15 reels of tape available amounting to approximately 17 hours listening time. Of the 15 reels, four reels amounting to approximately three hours, are of conversation in a room occupied by some females. The activity in this room is practically negative and the conversation of relative unimportance. Deducting these four reels we would have a total of 11 reels and approximately 14 hours listening time. No transcription, as such, available. We have an eight-page memorandum prepared by WFO which is in a "story fashion" relating the activities and including, in exact quotes excerpts of pertinent conversations.

2. Honolulu, Hawaii, February 18-20, 1964. We have nine reels with a total of approximately eight and one half hours listening time. To back this up we have 31 pages of transcript prepared by the field.

3. Los Angeles, California, February 20-21, 23-24, 1964. We have 21 reels with an approximate listening time of 22 and one half hours. We have 59 pages of transcript prepared by the field.

4. Detroit, Michigan, March 19-20, 1964. All tapes are maintained by the Detroit Field Office. Number of reels and listening time unknown. We have 20 pages of transcript prepared by the field. *No relevant activity.*

5. Sacramento, California, April 23-24, 1964. We have five reels with approximate listening time of five hours. We also have 23 pages of transcript prepared by the field.

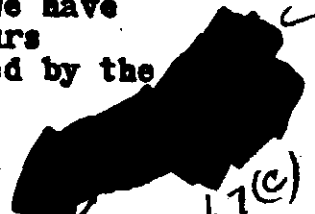

During a recent conversation between Martin Luther King, Jr., and his Executive Assistant, Andrew Young, King indicated that a \$100,000 benefit on behalf of King is to be held in Boston, Massachusetts. King said that the Governor of Massachusetts had declared 4/23/65 as Martin Luther King Day in that state, King further stated that he, along with other civil rights leaders, plan to go to Boston in the Spring of 1965 to "scare the power structure" in that area. King did not elaborate on what methods they would use in "scaring the power structure"; nor did he indicate that this visit would coincide with the testimonial planned for him by the Governor.

Pursuant to your request of SAC Handley, Boston, for discreetly-obtained available information concerning a planned "Day" for King, ASAC Whittaker, Boston, today (3/2/65) telephoned the following information to the Bureau. Arrangements for a "Day" for King have already been firmed up. It is to be 4/23/65. An award is to be made to King, the nature of which has not yet been determined. Neither the place for the testimonial yet been determined. There is no information that the invitation to King has been definitely extended as yet. SAC Handley has met [REDACTED] who is cordial and friendly to the Bureau and Handley believes that [REDACTED] could be safely contacted on a highly confidential basis and briefed concerning King. With the end result that the affair for King will be watered down.

OBSERVATIONS:

Because of the known communist influence on King [REDACTED], it is believed that it would be [REDACTED] in the interest of the Bureau to have SAC Handley [REDACTED] brief him concerning King. Although arrangements have progressed so far for the King Day that the affair will likely come off, our briefing [REDACTED] will likely induce him to minimize the affair and especially the award for King.

SAC [Roney] called on 1/28/65 asking for authority to place microphone coverage on the rooms King and a traveling companion will occupy in the Americana Hotel in New York on 1/29 and 1/30/65. He advised King had been assigned Rooms 3223 and 3225, and that the New York Office has available for coverage purposes Rooms 3323 and 3325, which are one floor above those occupied by King. [These rooms were obtained without advice to the hotel of the office's interest in King.]

New York stated that in view of King's continued contacts with persons affiliated with communist interests [and his general activities] it was considered desirable that microphone coverage be placed on King while in New York. He is scheduled to arrive in New York early 1/29 and leave late 1/30/65. New York also requested authority to pay up to \$40 a day for the rooms necessary for monitoring purposes.

ACTION:

I authorized New York to go ahead with the microphone coverage since it will only be on for a short time and in view of the potential for developing intelligence information of interest to us. New York also was authorized to make the necessary expenditures for rental of monitoring space.

New York called today and advised that King, [Bernard Lee, and Andrew Young] registered at the Park Sheraton Hotel and were assigned Room 2541 and 2543. SAC [Roney] advised that the New York Office had for monitoring purposes the availability of Rooms 2439 and 2441.

In view of the nature of the discussion which King was scheduled to have in New York with [Clarence Jones and Harry Wachtel], it was felt the results of the discussion would contain considerable intelligence information. New York said that through other information which they have developed, it appears the meeting will actually be held in [Wachtel's] office, but New York still strongly recommended use of microphone coverage in the rooms occupied by King's party as the results of the meeting in [Wachtel's] office would later be discussed in the hotel rooms.

In view of King's continued contact with [Clarence Jones, who is King's conduit for contact with communist [Stanley Levison] and in view of other activities of King,] it is considered highly desirable that New York place microphone coverage on these rooms if this can be done with full security. [REDACTED] reported on the evening of November 9, 1964, Bayard Rustin was in contact with Andrew Young, Executive Director of the Southern Christian Leadership Conference, which is headed by Martin Luther King, Jr. Rustin told Young that he, Rustin, was leaving for London, England, November 11, 1964, for the purpose of clarifying confusion surrounding King's trip to Europe in December, 1964. (King is to receive the Nobel Peace Prize in Oslo, Norway, December 10, 1964.) The confusion arises in that the Archbishop of Canterbury desires to receive King but has been opposed by certain elements inasmuch as King is a Baptist. Rustin is to also determine, while in London, whether King can have a meeting with the British Prime Minister, Harold Wilson.

Rustin has already been in contact with Peggy Duff, a resident of London, England, who is Executive Director of the Campaign for Nuclear Disarmament. Rustin told her that King will be in London on December 6 and 7, 1964, and Rustin wanted to know if Prime Minister Wilson would be prepared to receive King then. She indicated that she would check into this. Rustin said that it should not appear as though this was King's idea, stating that it was preferred that Wilson announce that he is inviting King to visit him.

The Director has instructed there are to be no technical surveillances in cases which would thereby be tainted for prosecution.

[Redacted] is a technical installation on the residence of Martin Luther King, Jr., at 563 Johnson Avenue Northeast, Atlanta, Georgia. King is a national figure prominent in the racial movement. He has been involved with and is taking advice from well-known communist figures. This source provides information regarding his contact with these individuals as well as information as to what they advise him to do. A considerable amount of the information we have received from this source has been furnished to the White House, the Attorney General, and other Government agencies. This source has provided a great amount of information concerning racial disorders in the South, racial riots in Northern cities as well as racial activities at both major political party conventions.

[Redacted] (which has been furnished to the White House) *[Redacted]*

The type of information received through this source is not available through any other source.

There is no prosecutive action pending concerning King and on the basis of the information we have, prosecutive action appears to be unlikely in the foreseeable future. It would appear logical to continue this installation because of the large contribution that it has made to our intelligence in the racial movement.

I received a telephone call Friday, 8/21/64, from SAC Bachman concerning technical coverage on King in Atlantic City. You had previously instructed that he explore the possibilities of putting technical and microphone coverage on him there.

Bachman advised that he had made a preliminary security check and that suitable reliable contacts were available at the hotel which would make possible a microphone installation, though it might be necessary to take the hotel manager into confidence to the extent of identifying King as the individual in whom they were interested. Bachman advised that as to the technical installation, a preliminary check revealed this could be done. He noted that a suite of 3 rooms had been set aside at the Claridge for the use of King and others traveling with him.

ACTION:

I told Bachman to go ahead with the microphone installation if this could be done with the understanding that no one other than the manager would have knowledge of our interest in King, and that neither the manager nor anyone else would have knowledge of the nature of the coverage. I further pointed out that it would be necessary that Newark be in a position to assure full security from a technical point of view.

I also authorized Bachman to go ahead on the telephone installation provided this could be done with full security. It should be noted in this connection we already have authority from the Attorney General to cover any residence which King may use with a technical telephone installation.

King, his wife and children intend to stay in [REDACTED] apartment most of remainder of August, 1964. Bufiles and those of NYO negative re [REDACTED] New York has advised that installation of tesur is feasible and full security is assured. In October, 1963, we received the Attorney General's authority to place a tesur on King at his Atlanta, Georgia, residence or at any future address to which he may move. We previously extended such coverage to temporary residences of King and it is believed most desirable to do so in this instance in view of his association with communists and the very vital matters he is presently concerning himself with, such as the forthcoming Democratic National Convention; the Mississippi situation; the matter of racial disorders.

SAC Ponder of Atlanta called at approximately 9:30 a.m. this morning and advised that through technical coverage of King's residence it was learned that a telephone call was received by Mrs. Coretta King from an individual who identified himself as Nelson Smith of the American Broadcasting Company (ABC). Smith said that ABC had a representative who had infiltrated "one of the groups" (not further identified) and that this group had plans to kill King today.

SAC Ponder was instructed to advise SAC Moore in Jackson of the receipt of this information so that he and Agents there would be alerted to this threat to King. SAC Moore subsequently advised that King was still in Jackson and had meetings scheduled there until noon when he would go to Tougaloo College on the outskirts of Jackson for a luncheon. At 2:00 p.m. he is to return to Jackson for meetings with Congress of Racial Equality (CORE) and Council of Federated Organizations (COFO) officials. At 5:30 p.m. he is to go by caravan from Jackson to Vicksburg, Mississippi, where he is to attend a mass meeting tonight and will stay overnight in Vicksburg. King's schedule calls for his going to Meridian for most of the day and event tomorrow and departure Saturday morning for Atlanta.

Moore said that extensive plans are already in effect by city police, sheriffs, and State Highway Patrol officers to provide escorts and protection for King. He said that he was mindful of the instructions which he had received from the Bureau on 7/21 concerning King's safety and that he would use all available manpower as necessary to supplement local law enforcement officers.

Mr. DeLoach was advised of the above and will check [REDACTED] to determine if there is in fact an ABC representative named Smith in the Atlanta area. If so, additional action as may be possible without endangering our source of information will be undertaken in an effort to determine the reliability of the information which Smith has passed on to Mrs. King.

This matter will be followed closely.

Memorandum from Mr. Baumgardner to Mr. Sullivan
7/2/64 recommended, and the Director approved, that a

This memorandum recommends that we authorize an extension of the current technical surveillance (tesur) on Martin Luther King, Jr., to cover his activities in Los Angeles, California, commencing 7/8/64 and authorize installation of a microphone surveillance (misur) at the same time and place.

King plans to be in Los Angeles commencing 7/8/64

It is noted that the Republican National Convention is scheduled to start in San Francisco, California, 7/13/64.

ASAC Onsgard, Los Angeles, telephonically advised 7/1/64 that Los Angeles can effect a tesur with full security by running lines from the office's technical plant to the Hyatt House Hotel and in the event King registers there, it will be a simple matter to activate such a tesur. Los Angeles is presently checking out the feasibility of a misur at this Hotel to further our coverage and is to advise the Bureau of the results of its check.

OBSERVATIONS:

It would be most desirable to effect as much technical-type coverage as can be safely done to cover King's activities on the West Coast. He undoubtedly will attempt to inject himself into the Convention proceedings as he had previously indicated possible demonstrations or picketing of the Convention. During his stay in Los Angeles just prior to the Convention he is very likely to reveal much of his plans and such information would undoubtedly be available through a tesur. King has also injected himself into the current Mississippi situation and the tesur would be a source in that regard. The tesur would likely furnish intelligence

It is noted that in October, 1963, we received the Attorney General's authority to place a tap on King at his Atlanta, Georgia, residence or at any future address to which he may move. We believe we should extend such coverage to his temporary (Hotel) residence in Los Angeles. It is likewise felt that a microwire should be installed, if it can be done with full security, to gain further evidence of the activities of this moral degenerate.

RECOMMENDATIONS:

(1) If you approve, we will telephonically advise Los Angeles to go ahead with the tap provided it can be done with full security.

(2) With your approval we will also authorize a microwire at such time as Los Angeles advises that it can be effected with full security.

With respect to HARRY WACHTEL, it is to be noted that he is a successful, apparently wealthy attorney in the law firm of WACHTEL and MICHAELSON, with law offices on the fifth floor of 575 Madison Avenue, New York City. The law firm moved recently to this location from 711 Fifth Avenue.

SAC Lynum, San Francisco, called today to advise that Martin Luther King plans to go to Sacramento, California, on 4-23-64 and will stay at the Senator Hotel there. Through a contact at the hotel we have learned that he has reserved a suite of 3 double-sized rooms (2 bedrooms separated by a parlor). SAC Lynum requested permission to conduct a survey tomorrow morning to determine the feasibility of establishing coverage of King's activities at the hotel. He said this could be done with full security.

San Francisco was authorized to make the survey tomorrow morning but, before any installation is made, the Bureau should be advised of the results of the survey and whether coverage would be possible under completely secure conditions.

RECOMMENDATION:

If the results of the survey show it is feasible and can be done with a guarantee of absolute security, that approval be granted for San Francisco to install the necessary technical coverage.

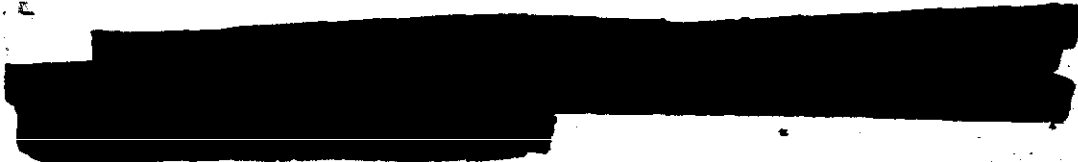

My memorandum to you 1/22/64 recommended, and the Director approved, that [redacted] of the San Francisco Office report to the Bureau 2/2/64 for a one-day conference preparatory to effecting coverage of the activities of Martin Luther King, Jr., and his associates in Honolulu 2/12-25/64.

An all-day conference was held as scheduled with [redacted] and officials and Supervisors of the Domestic Intelligence Division, including representatives from the Laboratory and Washington Field Office. [redacted] was thoroughly briefed on all aspects of this matter, with emphasis being given to the fact that security is paramount and that the need for discrediting King is based upon the communist influences on him. Thorough discussion was had concerning all the matters relating to the operation contemplated, including such facets as technical, personnel and equipment needs, transportation and timing of movements and the like.

Plan of Operation

[redacted] is to be in complete charge of this operation and, for security reasons, will principally utilize San Francisco Office personnel augmented by having some Honolulu personnel assist in matters where security will not be lessened by the fact that the Honolulu Agents are probably known in many places on the island. (A separate communication is being directed to the personal attention of SAC Price, Honolulu, advising him of Bureau plans and that [redacted] will be in charge of this operation.) [redacted] and one sound-trained Agent from San Francisco will go to Honolulu about 2/12/64 for purposes of making necessary surveys and effecting coverage. Such minute advance planning is deemed necessary for reasons of security and to insure optimum results. It will include, per suggestion of the Laboratory, a "dry run" if at all possible. On about 2/16/64, two or three additional Agents from San Francisco will go to Honolulu, one of whom will be a sound-trained Agent and the other possibly an expert in photography. We are also insuring that these Agents have an adaptability to monitoring techniques so as to insure best possible coverage.

The Laboratory has already undertaken the assembly of sufficient equipment to provide for flexibility in operation and will arrange for shipment directly to Honolulu.

For reasons of security and because of the distances involved and the fact that we may not know until the last moment exactly where the installations will be made, [redacted] was given authority, provided full security was always assured, for necessary surveys and installations in connection with this operation. He was instructed that the Bureau must be promptly apprised of all pertinent developments in this matter and that under no circumstances must any action be taken that could in any way alert King or other unauthorized individuals of our interest in King; neither could anything be done which could bring embarrassment to the Bureau.

This memorandum recommends that Security Supervisor [redacted] of the San Francisco Office be ordered to report to the Bureau 2/3/64 for a one-day conference preparatory to effecting coverage of the activities of Martin Luther King, Jr., and his associates in Honolulu 2/18-25/64.

Our investigation of the communist influence in racial matters clearly reveals King to be one of the most prominent and important leader of the Negro people today. Investigation to date has proven his being under strong communist influence and [redacted]

Because of the communist influence on him, he needs to be, for the security of the Nation, completely discredited. [redacted]

For some time King has been planning on a trip to Honolulu, where he is scheduled to speak about 2/18/64. His itinerary tentatively calls for departure from Los Angeles, California, for Honolulu 2/18/64 and return to the mainland 2/25/64. He will be accompanied by his Executive Assistant Wyatt Walker. [redacted]

The Attorney General spoke to me with reference to our memorandum of October 18, 1963, recommending a technical surveillance on the office of the Southern Christian Leadership Conference at Atlanta, Georgia. It is noted that last week the Attorney General authorized similar coverage on the residence of Martin Luther King, Jr., President of the Southern Christian Leadership Conference. (u)

The Attorney General is apparently still vacillating in his position as to technical coverage on Martin Luther King and his organization, it being recalled that he had initially suggested such coverage and then changed his mind and felt it might be inadvisable. (u)

The Attorney General said that he is still uncertain in his own mind about this coverage. I reminded him of our previous conversation, wherein he was assured that all possible would be done to insure the security of this operation. (u)

The Attorney General advised that he was approving the October 18, 1963, memorandum but asked that this coverage and that on King's residence be evaluated at the end of 30 days in light of the results secured so that the continuance of these surveillances could be determined at that time. This will be done. (u)

The original of our October 18, 1963, memorandum was handed to me by the Attorney General. It is attached hereto. (u)

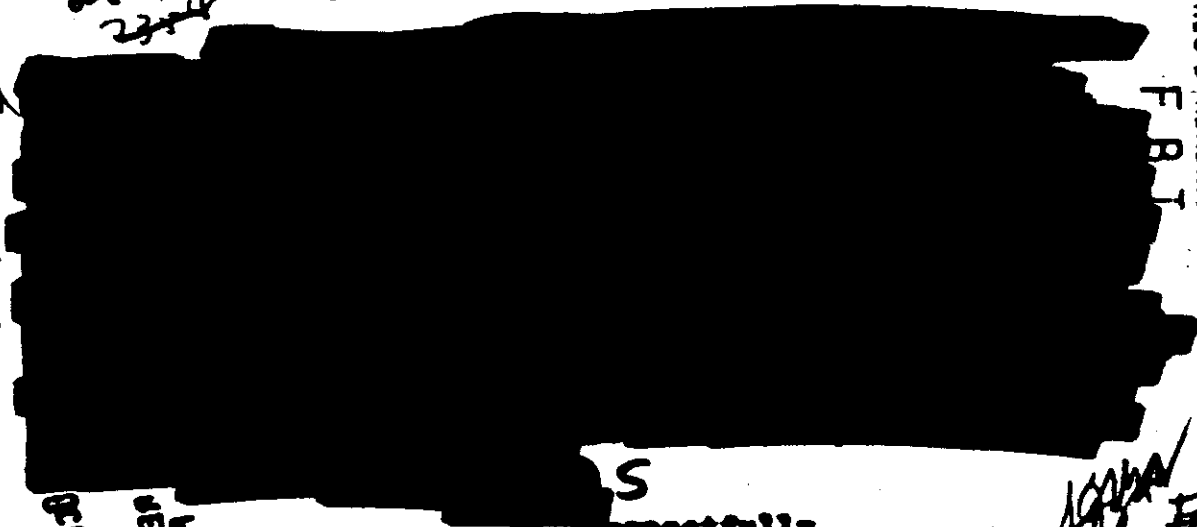

You will recall that on 7/13/63 the Attorney General advised Assistant Director Evans that in view of the possible communist influence in the racial situation he desired consideration be given to placing technical surveillances on Martin Luther King, Jr., leader of the Southern Christian Leadership Conference (SCLC), and Clarence B. Jones, a New York City attorney who is closely associated with King and involved in the racial movement. The Attorney General at that time indicated he was not concerned with the repercussions if it should ever become known that such surveillances had been put into effect and that he thought it advisable to have complete coverage. Although, when such a request was made of the Attorney General 7/22/63 he rejected coverage on King, he has subsequently authorized technical coverage on the New York office of the SCLC as well as the Atlanta residence of King.

A survey has now been conducted on the headquarters of the SCLC at Atlanta, Georgia, and this survey indicates it is feasible to install a technical surveillance on this place with full security.

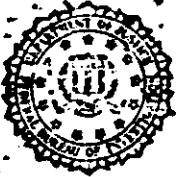

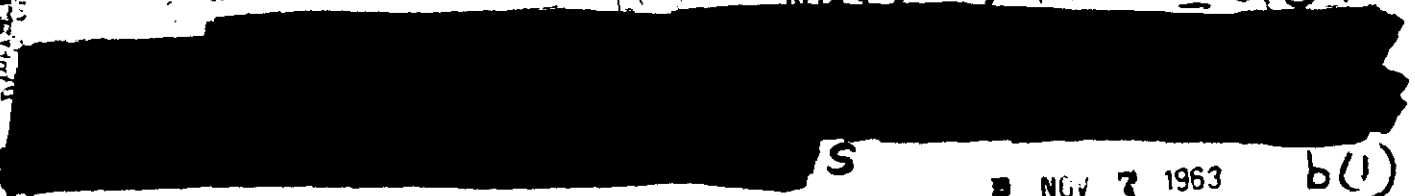

Surveys have been made on the residence of Martin Luther King, Jr., in Atlanta, Georgia, and the headquarters of the Southern Christian Leadership Conference (SCLC) in New York City. These surveys indicate it is feasible to install technical surveillances on these places with full security. (u)

You will recall that on 7/18/63 the Attorney General advised Assistant Director Evans that in view of the possible communist influence in the racial situation, he desired that consideration be given to placing a technical surveillance on Martin Luther King, Jr., leader of the SCLC, and Clarence B. Jones, a New York City attorney who is closely associated with King and involved in the racial movement. The Attorney General at that time indicated he was not concerned with the repercussions if it should ever become known that such surveillances had been put into effect and that he thought it advisable to have complete coverage. However, when such a request was made of the Attorney General on 7/22/63, he rejected coverage on King. (u)

King resides at 563 Johnson Avenue, N.E., Atlanta, Georgia and is president of the Southern Christian Leadership Conference, 330 Auburn Avenue, Atlanta. The New York office of the SCLC is located at 312 West 125th Street, New York City. (u)

The Attorney General orally informed me today that he had been considering the request he made on July 16, 1963, for a technical surveillance on Martin Luther King at his home and office and was now of the opinion that this would be ill advised.

At the time the Attorney General initially asked for such a surveillance, he was told there was considerable doubt that the productivity of the surveillance would be worth the risk because King travels most of the time and that there might be serious repercussions should it ever become known the Government had instituted this coverage. These were the very thoughts that the Attorney General expressed today in withdrawing his request.

With reference to the other technical surveillance requested at the same time, namely, the one on Clarence Benjamin Jones, the Attorney General felt this was in a different category and we should go forward with this coverage. It is noted that this was previously approved in writing by the Attorney General.

The memorandum we sent to the Attorney General on July 23, 1963, requesting authority for the King surveillance has been retrieved and is attached.

ACTION TO BE TAKEN:

We will take no further action to effect technical coverage on Martin Luther King, either at his home or at his office at the Southern Christian Leadership Conference, in the absence of a further request from the Attorney General.

This is a recommendation requesting the Attorney General's authority for the installation of a technical surveillance covering the home telephone of Martin Luther King, Jr., as well as the telephone covering the Southern Christian Leadership Conference, of which King is the President.

You will recall that on 7/16/63 the Attorney General advised Assistant Director Evans that in view of the possible communist influence in the racial situation, he desired that consideration be given to placing a technical surveillance on Martin Luther King, Jr., leader of the Southern Christian Leadership Conference, and Clarence Benjamin Jones, a New York City attorney, who is closely associated with King. The Attorney General indicated he was not concerned with the repercussions if it should ever become known that such surveillances had been put into effect and that he thought it advisable to have as complete coverage as possible.



Pursuant to the Attorney General's request that consideration be given to placing a technical surveillance on King, our Atlanta Office was requested to conduct a survey to ascertain if such coverage is feasible and could be conducted with full security. Atlanta teletype 7/20/63 discloses that technical coverage on King is feasible and can be conducted with full security.

At present there are 58 investigative-type technical surveillances in operation and 6 being installed. The limit is 73.

A separate memorandum requesting Attorney General's authority to place a technical surveillance on Clarence Benjamin Jones has previously been submitted.

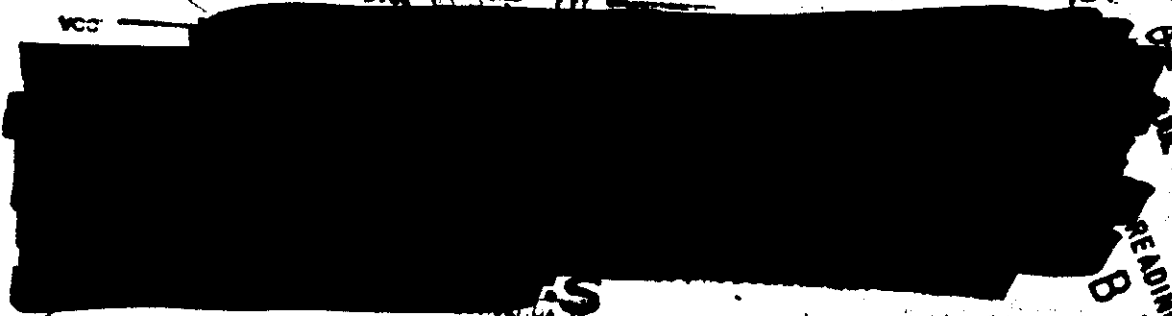
