

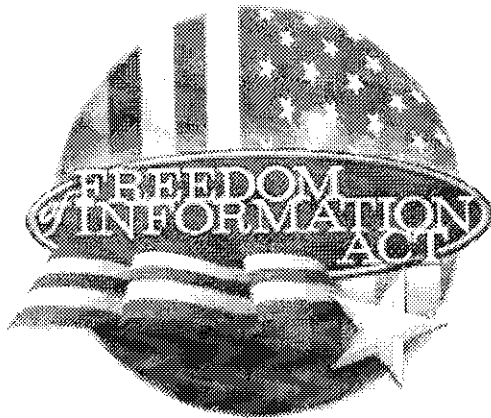

This informative memorandum to record inquiry of Department concerning tapes of microphone surveillances on Martin Luther King, Jr.

On 2/5/76, Supervisor [REDACTED] INTD, returned a call to Mr. Quinlan J. Shea, Jr., on the Deputy Attorney General's (DAG) Staff, who said he had been informed by Civil Rights Division Assistant Attorney General Pottinger that Supervisor Campbell was the custodian of the King tapes and Shea desired some information from Campbell. It was explained to Shea that Pottinger was apparently given a wrong impression when he, Pottinger, listened to some of these tapes. Supervisor William Campbell of the Laboratory played the tapes for Pottinger but Campbell's connection with them are primarily of a technical nature. As to the "custodian" of the tapes, Shea was told that in Bureau records they are charged to Section Chief J. G. Deegan and maintained in the latter's office but that if Shea wants to talk to the person most knowledgeable as to the tapes, it was [REDACTED]

Shea then said that his purpose in calling was a desire to protect the DAG relative to a pending suit wherein someone is attempting to obtain the tapes. He said that it was necessary that he give advice to the DAG to support an appeal regarding a denial of information to the person seeking the tapes. Shea indicated that research resulted in a determination that the privacy issue relating to King himself could not be raised as King is dead but that the Department was exploring the privacy issues as relating to the King family. At this point, [REDACTED] inquired as to whether or not Shea was aware of the efforts which were initiated by the King family through its attorneys to obtain FBI files concerning King. Shea said he was not familiar with this fact and it was suggested to him that he [REDACTED]

might desire to consult with Assistant Attorney General Antonin Scalia. (It will be recalled that early in 1975, Assistant Director Mintz was present at a conference with Departmental officials, including Scalia and attorneys for the King family because of the family's desire to obtain the FBI's files on King).

Shea said he had no desire to hear the tapes which he frequently referred to as the "sex tapes" but wanted to have some idea of their contents. It was explained to him that while the tapes' contents were primarily of personal activities, they were not to the exclusion of other matters such as discussions of current events, civil rights issues and conversations between King and his advisors.

[redacted] inquired of Shea as to exactly what he wanted to know that he would use in his advice to the DAG. He stated that he would like to know whether or not the revelation of these tapes would be embarrassing to the King family and whether or not it would lead to an harassment of the family. He was told that such revelation would be embarrassing but that it was not clear what he meant by harassment. He then asked whether such revelation would likely result in the family being submitted to questions from the press that might be harassing to them. He was told that such revelations would quite likely so result. Concluding, [redacted] told him that if he desired any more information, it might be best for [redacted] to visit his office. He responded that he did not anticipate any further needs in this matter. b7(c)

This Bureau is in possession of 78 reels of tape resulting from our microphone coverage of the activities of Martin Luther King, Jr., during the period 1964-65. We also possess transcripts of these tapes.

Pursuant to the letter of December 12, 1975, from Mr. J. Stanley Pottinger, Assistant Attorney General, Civil Rights Division, setting forth your authorization for Mr. Pottinger's access to tapes concerning King, on December 19, 1975, Mr. Pottinger listened to some of these tapes. In preparation for this hearing, one of our supervisors in the Radio Engineering Section of the FBI Laboratory, had occasion to also listen to a number of the tapes. He observed that there had been some deterioration in the audio quality of the tapes, a condition which could easily occur when such tapes are retained for so long a period of time. It is his further observation that the tapes will deteriorate at an even more rapid pace in the years ahead.

We cannot, of course, anticipate with any degree of certainty the need in the years ahead to be able to listen to and understand these tapes, whether it will be our own personnel or others who will need to listen to them. In view of the foregoing, coupled with the current interest in these tapes by the Department and the Senate Select Committee on Intelligence Activities, we have given consideration to having the tapes duplicated onto fresh tapes which could be used

PURPOSE:

To advise you of a New York Times article (copy attached) on 5/21/73 containing charges by retired Special Agent (SA) Arthur Murtagh that the Bureau in a "get King" movement used electronic surveillance material to undermine the support of the late Martin Luther King, Jr., among his white backers.

SYNOPSIS:

Arthur Leo Murtagh, age 51, a retired SA practicing law in Constable, New York, is very critical of the Bureau and is writing a book about his Bureau experiences. In an interview by the New York Times he made allegations that the electronic surveillance of the late Martin Luther King, Jr., was part of a "get King" movement in the FBI triggered by a hatred of King by the late Director Hoover. Murtagh was assigned to the security squad in Atlanta which handled the King case but he was working on other assignments during the time of the electronic surveillance of King. He was known in Atlanta to be very critical of the disciplinary policies of Mr. Hoover and of the Bureau's weight program. We are checking out those allegations which can be checked but our files show that the surveillance of King was justified and was approved by former Attorney General (AG) Robert Kennedy.

The Atlanta Office has no information to confirm that there was any attempt to assign Murtagh to the King phone tap or that Murtagh refused to monitor the tap as he claimed in The New York Times article.

Murtagh was born 9/25/21, entered on duty as an SA on 4/16/51 and voluntarily retired 9/25/71. He served in Atlanta from 10/30/60 to his retirement date. He is reportedly practicing law in Constable, New York.

Regarding Murtagh's allegation that one of the top officials from Bureau headquarters in Washington, D. C., had tried to persuade community leaders in Atlanta that they should not attend a banquet for King, Atlanta has indicated that former Assistant to the Director William C. Sullivan was in Atlanta about 1965 to attend a conference and at that time Sullivan made an appointment with and talked to the late Ralph McGill, editor of the "Atlanta Constitution" but the substance of their conversation is not known. The appointment was reportedly arranged by SA [REDACTED] who retired, who accompanied Mr. Sullivan but did not remain during the conversation. Mr. Sullivan at the time also attempted to arrange an appointment with the late Bishop Hallinan of Atlanta but this appointment did not materialize. As of this time we have found no

information in our files regarding the nature of the conversation between Mr. Sullivan and Mr. McGill. We are continuing our efforts to locate such information and you will be advised of the results of our search.

On this subject the "Atlanta Constitution" on 5/22/73 carried an article indicating that the Mayor of Atlanta at the time and other city and state leaders were asked by the newspaper if the FBI had tried to interfere in anyway with the banquet for King and all denied any knowledge of such an attempt.

Atlanta can find no record of anyone connected with the Bureau contacting Eugene Patterson, also an editor of the "Atlanta Constitution," regarding King's plans to meet a woman at an airport in Florida as stated in the attached article.

In an effort to further pin down the allegation that McGill and Patterson were contacted we are conducting a file review which will be very lengthy to determine if there is any record of such contacts and to determine the details thereof. The results of this review will be furnished later. Murtagh's charges that intimate details of King's personal life were furnished to newsmen who were urged to write articles disclosing them cannot be substantiated in Bureau files. One article by Jack Anderson on 8/24/69 did refer to details of King's personal misconduct and quoted from a Bureau document but our files indicate that this information was not provided to Anderson or anyone else except The White House which requested the interview that developed the information.

As indicated in the attached article, Murtagh is in the process of writing a book and is apparently using The New York Times article to air sensationalism which will help sell his book. Except for the allegations regarding McGill and the statement by Patterson there is little in the article which can be checked out. Murtagh is quoted as qualifying many of his statements with such statements as "in an apparent effort to

undermine King"; "the persuasion was said to have included"; "he said that he could offer no proof but that he believed completely"; and "from all the things I saw it appeared to me." Perhaps his book when published will contain more information on the bases for some of his allegations.

Until such time that such information is forthcoming and can be checked out we must go by the record which shows that contrary to Murtagh's conjectures that the electronic surveillance on King was triggered by Mr. Hoover's hatred of King, the electronic coverage of King was justified and was approved by the AG at the time.

The attached article has been referred to Inspector John A. Mintz for an opinion as to any Federal violation here. A preliminary opinion by Inspector Mintz is that there appears to be no Federal violation on the part of Murtagh.

ADDENDUM BY LEGALCOUNSEL, 5/23/73, JAM:mfd.

While the information reported in the "NY Times" article attributed to former SA Murtagh does not appear to constitute a violation of any Federal statute, it is very likely that his disclosure to the press violated the secrecy agreement, which I understand he signed, dated April 16, 1951. If it becomes necessary, it might be possible to request the Department to intercede in our behalf and apply for an injunction prohibiting Murtagh from furnishing additional information derived from FBI files. Such an injunction could be based on the agreement he signed in 1951.

F.B.I. Taps Called Plan to Discredit Dr. King

A former agent of the Federal Bureau of Investigation says that in the nineteen-sixties the bureau used material gained in an electronic surveillance of the Rev. Dr. Martin Luther King Jr. in an apparent effort to undermine the late civil rights leader's support among his white backers.

The former agent also said that many newspapermen were urged to write articles disclosing intimate details of Dr. King's personal life—details to be supplied by the bureau after they were picked up in the telephone taps. Three taps on Dr. King were said to have been much more widespread than had previously been reported.

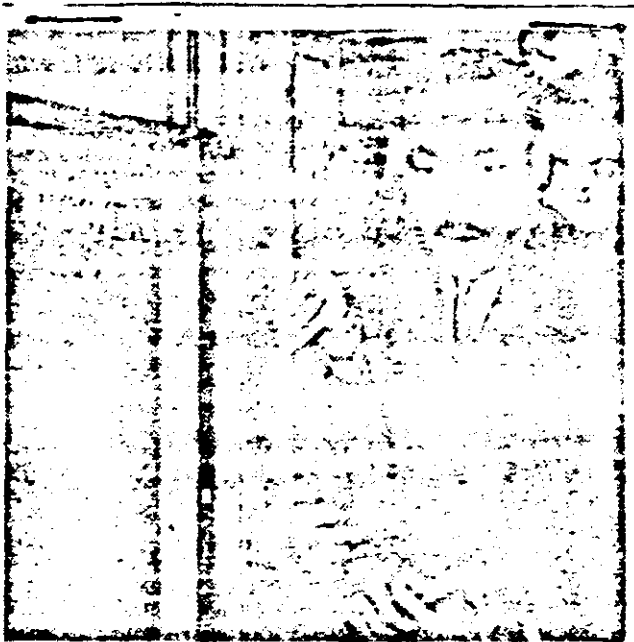
The former agent, Arthur Murtagh, a 51-year-old lawyer now practicing in Constable, N.Y., told The New York Times in an interview that important figures in the F.B.I. even tried to persuade community leaders in Atlanta that they should not attend a banquet that was held to honor Dr. King after he won the Nobel Peace Prize in 1964. The persuasion was said to have included a warning that the bureau had derogatory information about Dr. King that might eventually embarrass those who attended the banquet.

Tap Disclosed in 1968

Mr. Murtagh retired from the bureau in September, 1971, after 21 years of service, including 11 years in the Atlanta office. His account to The Times has been confirmed in interviews with various independent sources.

The fact that Dr. King's telephone was tapped has been well-established. It was disclosed in 1968 while Senator Robert F. Kennedy campaigned for the Democratic Presidential nomination.

After Mr. Kennedy was murdered in early June, 1968, his former associates said that the tap was installed when Mr. Kennedy, as Attorney General, acquiesced in 1963 to J. Edgar Hoover's repeated demands for authority to tap. Mr. Hoover argued that Dr. King had associations with subversive groups who sought to use the civil rights movement against the best interests of the United States.

In 1969, the tap on Dr. King was further described briefly in court hearings involving the draft violation conviction of Muhammad Ali, then the world heavyweight boxing champion. These brief glimpses made it clear that the tap was instituted

in October, 1963, and was continued at least into 1965. There were suggestions that it lasted until 1968, when Dr. King was assassinated, and the bureau has never given any information about the tap.

"Martin Luther King became the No. 1 bureau interest as far as the Atlanta office was concerned," Mr. Murtagh said. The former agent was a member of the 15-man group assigned to the security squad and it was this group that conducted the electronic surveillance of Dr. King, Mr. Murtagh said.

The former agent, who describes himself as one of a half-dozen liberals who survived in the bureau to reach retirement age, said he is now preparing his notes to write a book on his experiences.

Mr. Murtagh said he retired from the bureau on the first day he was eligible. He was very critical of the bureau in the interviews, which were held at his home.

He said that he could not offer proof, but that he believed completely that Mr. Hoover, as bureau director, sought the authority to tap Dr. King's phones in order to get information to destroy the civil rights leader and silence his criticism of the bureau's alleged failures to investigate the complaints of Negroes against white law enforcement

officers in Albany, Ga., from 1961 to 1963.

Mr. Murtagh would not name agents who took part in the surveillance. He said that he believed they had been taking orders, and that to name them now would cause them undeserved embarrassment. He said he had not taken part in the surveillance because he had told the supervisor in charge that he believed the tap was illegal.

When asked to explain how he could enforce such a refusal in a highly disciplined organization such as the F.B.I., Mr. Murtagh said that he had become known as a critic of some activities, and that his work in the Atlanta office was valuable to the agents assigned to direct the office.

He was paymaster, and "control," for a network of undercover informers who were "in place" in black organizations that were growing in importance at that time. He said, for example, that he was able to learn almost anything he wanted to know about the operation of the Southern Christian Leadership Conference, which Dr. King headed.

Mr. Murtagh said he once challenged the agent who ran the surveillance to say whether there was justification for the contention that Dr. King was involved with subversives—the justification for the telephone tap. He quoted the agent as replying, "I would try to tell others that there was, but I wouldn't try to tell it to you."

Mr. Murtagh also said that the extent of the electronic surveillance was never well understood outside limited circles within the bureau. He said that it went on for at least three years, and that more than 5,000 telephone conversations were monitored.

Previously published accounts of the telephone tap have indicated that only three telephones were involved—those in Dr. King's home, at the Southern Christian Leadership Conference offices in Atlanta, and at an office in New York that was used by the person that Mr. Hoover had argued was a subversive attempting to misuse Dr. King. It was this contention that caused Robert Kennedy to approve the telephone tap.

Mr. Murtagh said that telephones all over the United States were tapped, and that it was not uncommon for the Atlanta bureau to discover that it had monitored a call, and that the other end of the call had been monitored by a different listening post.

"The surveillance was massive and complete," Mr. Murtagh said. "He couldn't wiggle. They had him."

Fed Into Washington

Sources in Washington confirmed the broad outlines of Mr. Murtagh's description. These sources confirmed that when Dr. King left Atlanta, the F.B.I. electronic surveillance went with him, and that his telephones in hotels in other cities were tapped, with reports of information derived from these taps fed into Washington as Atlanta data.

In another part of his interview, and again in a way that avoided the use of names, Mr. Murtagh said that after Dr. King won the Nobel Peace Prize, the bureau made a well-orchestrated attempt to undermine the success of the banquet that was held in Dr. King's honor in Atlanta.

The former agent said that persons who understood his critical attitude toward the bureau's activities in the civil rights field told him that an agent from the Atlanta office and one of the top officials from Washington headquarters had called on two religious leaders and on the late Ralph McGill, editor of the Atlanta Constitution, to attempt to persuade them not to attend the banquet.

Mr. Murtagh again would not name the agent or the headquarters official. But he said that, the morning after the Washington man arrived at the Atlanta office, the agent said to Mr. Murtagh, "We're going to get him today. Hoover is going to take care of King today."

No Attack by Editor

Mr. Murtagh said that the bureau had agents assigned to be the contact men for persons such as newspaper editors, and that the man he quoted had been the contact for Mr. McGill. This agent took the Washington man to see Mr. McGill and the next day told Mr. Murtagh, "I guess McGill will be taking care of King." But the editor made no attack on the civil rights leader.

While the death of Mr. McGill and the refusal of Mr. Murtagh to name the agents made it impossible to corroborate his story, an interview with Eugene Patterson, former editor of The Constitution, produced a recollection that parallels the story told by Mr. Murtagh.

Mr. Patterson, now president and publisher of The St. Petersburg (Fla.) Times, said that in the spring of 1964, he was called on by an F.B.I. agent, whom he would not name.

"You people have been giving support to Martin Luther King," Mr. Patterson quoted the agent as saying. "Don't you owe it to your readers to tell them what kind of man he is? Our information is that while he postures as a great moral leader, he is running around with women. Don't you think your readers ought to know this?"

"I told him we didn't run a keyhole-peeking newspaper," Mr. Patterson remembered saying. "I told him that kind of thing had nothing to do with the civil-rights movement."

Urged Coverage

Mr. Patterson said the agent told him that Dr. King would meet a woman at an airport in Florida that weekend, and insisted that the Constitution send a reporter and photographer to record the meeting.

Mr. Patterson refused. Some days later, the agent returned and again insisted that "the newspaper would not print the news if we give it to you," Mr. Patterson said.

A day or so later, according to Mr. Patterson, the agent called and said, "our information is that the meeting is off so it's a good thing you didn't send anybody down t here."

In reflecting on the electronic surveillance of Dr. King, Mr. Murtagh said, "from all the things I saw, it appeared to me to be a 'get King' movement in the bureau. It was triggered by Hoover's hatred of King as a result of King's criticism of the bureau back in '62 and '63."

He also said that he was somewhat ashamed as he remembered that one Saturday night, when the King telephone tap had been in existence for years, he agreed to spend four or five hours manning the listening post when another agent had an emergency that took him off duty.

"I don't really know why I agreed to do it," he said. "I guess it is that you go along and watch it run and it gets so you really believe this is too mammoth and there is nothing I could do."

The AG was contacted at his request late this afternoon. He said that Clarence Benjamin Jones, a NY attorney who has had close association with Martin Luther King, and with Stanley Levinson (a concealed communist), had been in to see Burke Marshall about the racial situation. According to the AG, Jones had indicated he had some reservations about talking with Levinson on the phone. Marshall thought he might have been referring to a possible telephone tap, and passed it off by telling Jones this was something he would have to take up with Levinson.

The purpose of the AG's contact was that this brought to his attention the possibility of effecting technical coverage on both Jones and Martin Luther King. I told the AG that I was not at all acquainted with Jones, but that, in so far as King was concerned, it was obvious from the reports that he was in a travel status practically all the time, and it was, therefore, doubtful that a technical surveillance on his office or home would be very productive. I also raised the question as to the repercussions if it should ever become known that such a surveillance had been put on King.

The AG said this did not concern him at all; that in view of the possible communist influence in the racial situation, he thought it advisable to have as complete coverage as possible. I told him, under the circumstances, that we would check into the matter to see if coverage was feasible and, if so, would submit an appropriate recommendation to him.

If you approve, we will have a preliminary survey made to see if technical coverage is feasible with full security.

The Attorney General orally informed me today that he had been considering the request he made on July 16, 1963, for a technical surveillance on Martin Luther King at his home and office and was now of the opinion that this would be ill advised.

At the time the Attorney General initially asked for such a surveillance, he was told there was considerable doubt that the productivity of the surveillance would be worth the risk because King travels most of the time and that there might be serious repercussions should it ever become known the Government had instituted this coverage. These were the very thoughts that the Attorney General expressed today in withdrawing his request.

With reference to the other technical surveillance requested at the same time, namely, the one on Clarence Benjamin Jones, the Attorney General felt this was in a different category and we should go forward with this coverage. It is noted that this was previously approved in writing by the Attorney General.

The memorandum we sent to the Attorney General on July 23, 1963, requesting authority for the King surveillance has been retrieved and is attached. (attached)

ACTION TO BE TAKEN:

We will take no further action to effect technical coverage on Martin Luther King, either at his home or at his office at the Southern Christian Leadership Conference, in the absence of a further request from the Attorney General.

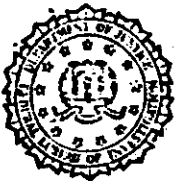

To report the latest attack on the Bureau over the Martin Luther King wire taps by former Attorney General Ramsey Clark in an article, "The Death of Privacy" in the February, 1970, McCall's magazine.

In his article Clark describes privacy as the ultimate freedom and says electronic surveillances are the tools of those unwilling to make the sacrifices that are essential to public safety. He describes King as a great American of open conduct and says the fact that the FBI would tap his phones and bug his hotel rooms should tell us all we need to know about the desirability of those practices. Clark calls these surveillances the act of an incipient police state. Clark says the Government should tell the people of the United States whether the tapes from bugs secretly installed in King's hotel rooms were played to publishers, Senators and others as was rumored after King's death.

There were no wire taps or microphone surveillances on King personally or on the Southern Christian Leadership Conference (SCLC), his organization, during Clark's tenure as acting Attorney General and Attorney General (10/3/66 - 1/22/69). Clark's authority was twice requested for a wire tap on SCLC headquarters in Atlanta, Georgia, but he denied authority both times.

There is nothing in our files to lend any credence to rumors mentioned by Clark that tapes on King were ever played for anyone outside the Bureau.

The Director stated that there should be greater discrimination relative to the dissemination of highly confidential material obtained from sensitive coverage such as telephone surveillances. The Director questioned our dissemination in 1964 of data regarding Martin Luther King, Jr., to Carl T. Rowan, Director of the United States Information Agency (USIA) and to Dr. Leland J. Haworth, Director of the National Science Foundation (NSF). Reasons for such dissemination set forth below.

The documents transmitted to Rowan and Haworth were a 13-page document captioned "Communism and the Negro Movement - A Current Analysis" and a 2-page document captioned "Martin Luther King, Jr., His Personal Conduct." Copies of these documents are enclosed. Also enclosed is one copy each of the three cover memoranda by which authorization was obtained for dissemination to Rowan and Haworth and one copy each of the letters which transmitted the documents to Rowan and Haworth.

Dissemination was made to Rowan as Director of USIA since King's activities in the civil rights movement were receiving world wide publicity. For instance when the 13-page document was sent to USIA, King had been designated as the winner of the Nobel Peace Prize and this award had international ramifications affecting the USIA in view of its role in propaganda involving the U.S., it was felt that if USIA knew the true facts about King it would not further glorify this man or enhance his image on the international scene through its far reaching propaganda outlets. It is normal for USIA to widely publicize U.S. citizens who receive international recognition and we certainly did not want King to get such treatment.

As indicated in the enclosed memorandum Mr. Baumgardner to Mr. Sullivan 12/17/64, our dissemination to Rowan and Haworth as Director of the NSF was based on information received that the NSF had contacted the Southern Christian Leadership Conference (SCLC) for the purpose of obtaining applicants for southern schools. Pursuant to your instructions, information is set forth below regarding requests made to former Attorney General Ramsey Clark for telephone surveillances on Martin Luther King, Jr., or his organization, the Southern Christian Leadership Conference (SCLC).

An article in the Washington Post dated 6/20/69 indicated that former Attorney General Ramsey Clark had stated that the FBI repeatedly requested him to authorize a wiretap on King while he, Clark, was Attorney General. Clark reportedly stated that he had not granted any of these requests and he further indicated that the last of the requests came two days before King's murder.

We never sought Clark's authorization for a telephone surveillance on King's residence. On 1/2/68 Clark's approval was requested for a telephone surveillance on the headquarters of the SCLC in Atlanta, Georgia. The SCLC is the organization which was founded by King. Clark denied authority for this telephone surveillance on 1/3/68. On 4/2/68 authorization was requested from Clark for telephone surveillances on the SCLC headquarters in Atlanta, and the office of the SCLC in Washington, D. C. Authority for these surveillances was denied by Clark in a memorandum to the Director dated 1/17/69. In connection with the request to Clark on 4/2/68 as mentioned above, it is to be noted that this was dated two days prior to King's murder on 4/4/68.

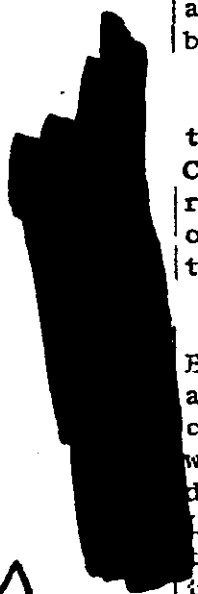
This relates to your letterhead memorandum of September 5 to the Attorney General, relating to Hunter Pitts O'Dell and the related prior memoranda. I appreciate your having sent copies of these to me.

This matter had been brought to the attention of Dr. King some time ago by me, but in accordance with conversations which the Attorney General had with Courtney Evans, it was not felt to be wise in view of the sources of the Bureau's information to state that I knew O'Dell to be under Communist influence or control at any time. I did inform Dr. King and two members of his organization -- Reverend Andrew Young and Reverend Wyatt Walker -- some time ago -- that since O'Dell was believed by many people to have had Communist connections, his association with their organization was not in the best interests of the organization.

At that time, inconclusive steps were taken to remove O'Dell, and his job with the Southern Christian Leadership Conference was changed. In response to direct questions whether I had hard evidence of O'Dell's Communist connections, however, I replied that I was not in a position to give any.

Following further conversations with Mr. Evans in June, however, I brought the matter to the attention of Dr. King very explicitly in my office on the morning of June 22 prior to a scheduled meeting which Dr. King had with the President. This was done at the direction of the Attorney General. Later that morning both the Attorney General and the President separately strongly urged Dr. King that there should be no further connection between O'Dell and the Southern Christian Leadership Conference.

Dear Jack:

Several months ago you submitted your resignation pending an investigation of your alleged affiliation with the Communist party, as was suggested by an article to this effect in the Birmingham and New Orleans newspapers. We accepted this temporary resignation because of SCLC's firm policy that no Communist nor Communist sympathizer can be on our staff or in our membership. We felt that it was imperative to conduct an immediate investigation. As you know, we conducted what we felt to be a thorough inquiry into these charges and were unable to discover any present connections with the Communist party on your part.

The situation in our country is such, however, that any allusion to the left brings forth an emotional response which would seem to indicate that SCLC and the Southern Freedom Movement are Communist inspired. In these critical times we cannot afford to risk any such impressions. We, therefore, have decided in our Administrative Committee, that we should request you to make your temporary resignation permanent.

We certainly appreciate the years of unselfish service which you have put into our New York Office, and regret the necessity of your departure. Certainly, yours is a significant sacrifice commensurate with the sufferings in jail and through loss of jobs under racist intimidation. We all pray for the day when our nation may be truly the land of the free.

The Attorney General orally informed me today that he had been considering the request he made on July 16, 1963, for a technical surveillance on Martin Luther King at his home and office and was now of the opinion that this would be ill advised.

At the time the Attorney General initially asked for such a surveillance, he was told there was considerable doubt that the productivity of the surveillance would be worth the risk because King travels most of the time and that there might be serious repercussions should it ever become known the Government had instituted this coverage. These were the very thoughts that the Attorney General expressed today in withdrawing his request.

With reference to the other technical surveillance requested at the same time, namely, the one on Clarence Benjamin Jones, the Attorney General felt this was in a different category and we should go forward with this coverage. It is noted that this was previously approved in writing by the Attorney General.

The memorandum we sent to the Attorney General on July 23, 1963, requesting authority for the King surveillance has been retrieved and is attached. (*attached*)

ACTION TO BE TAKEN:

We will take no further action to effect technical coverage on Martin Luther King, either at his home or at his office at the Southern Christian Leadership Conference, in the absence of a further request from the Attorney General.

The AG was contacted at his request late this afternoon. He said that Clarence Benjamin Jones, a NY attorney who has had close association with Martin Luther King, and with Stanley Levinson (a concealed communist), had been in to see Burke Marshall about the racial situation. According to the AG, Jones had indicated he had some reservations about talking with Levinson on the phone. Marshall thought he might have been referring to a possible telephone tap, and passed it off by telling Jones this was something he would have to take up with Levinson.

The purpose of the AG's contact was that this brought to his attention the possibility of effecting technical coverage on both Jones and Martin Luther King. I told the AG that I was not at all acquainted with Jones, but that, in so far as King was concerned, it was obvious from the reports that he was in a travel status practically all the time, and it was, therefore, doubtful that a technical surveillance on his office or home would be very productive. I also raised the question as to the repercussions if it should ever become known that such a surveillance had been put on King.

The AG said this did not concern him at all; that in view of the possible communist influence in the racial situation, he thought it advisable to have as complete coverage as possible. I told him, under the circumstances, that we would check into the matter to see if coverage was feasible and, if so, would submit an appropriate recommendation to him.

If you approve, we will have a preliminary survey made to see if technical coverage is feasible with full security.

Pursuant to your instructions, information is set forth below regarding the claim made by former Attorney General Ramsey Clark that the FBI had sought permission to resume a telephone surveillance on Martin Luther King, Jr. as late as two days before King's murder.

We never sought Clark's authorization for a telephone surveillance on King's residence. King was murdered on 4/4/68. On 4/3/68 a memorandum dated 4/2/68 (copy attached) was sent to Clark requesting authorization for telephone surveillances on the headquarters of the Southern Christian Leadership Conference (SCLC) in Atlanta, Georgia, and at the office of the SCLC in Washington, D. C. The SCLC is the organization which was founded by King. Authority for these surveillances was denied by Clark in a memorandum to the Director dated 1/17/69 (copy attached with SCLC listed on page three).

The above-mentioned request for a telephone surveillance on the headquarters of the SCLC in Atlanta was the second request made to Clark. On 1/2/68 Clark's approval had been sought for a telephone surveillance on SCLC headquarters and Clark denied authority for this telephone surveillance on 1/3/68.

The facts set forth above clearly show that we never sought permission from Clark for a telephone surveillance on King's residence. THE ATTACHMENTS INDICATE, HOWEVER, THE REQUESTS FOR COVERAGE OF SCLC WERE BASED ON KING'S ACTIVITIES.

By letter dated January 2, 1968, authority was requested to institute a telephone surveillance on the national headquarters of the Southern Christian Leadership Conference, 330 Auburn Avenue, N.E., Atlanta, Georgia, because its President, Martin Luther King, Jr., had publicly announced he would lead a massive civil disobedience in the nation's Capital in the Spring of 1968. At that time it was pointed out that these massive demonstrations could trigger riots.

By letter dated January 3, 1968, you declined authorization of this installation because, "There has not been an adequate demonstration of a direct threat to the national security."

In view of the recent developments in Memphis, Tennessee, where King led a march that ended in a riot, it is reasonable to assume the same thing could happen later this month when King brings his "Poor People's March" to Washington, D. C.

King, the day after the Memphis riot, was in conference with his principal adviser and long-time secret Communist Party member, Stanley Levison, concerning the events of the preceding day. King stated he was considering calling off the Washington march. Levison advised him to continue his plans for the Washington march.

Although we have no specific data in our files showing that Katzenbach authorized a telephone surveillance on King himself, there is ample information showing Katzenbach was well aware of our electronic coverage on King and his organization, the Southern Christian Leadership Conference (SCLC). Attached is a copy of a memorandum dated 10/27/65 (initialed by Katzenbach in the upper right hand corner) showing we had a telephone surveillance on King's organization, the SCLC. Also attached is a copy of a memorandum 12/1/65 to the Attorney General regarding electronic coverage on King at the Americana Hotel in New York City. In response to this 12/1/65 memorandum, there is attached a copy of a note from Katzenbach to the Director stating, "Obviously, these are particularly delicate surveillances and we should be very cautious in terms of the non-FBI people who may from time to time necessarily be involved in some aspect of installation."

Copies are attached of nine memoranda to the Attorney General dated 10/20/64, 10/22/64, 11/3/64, 11/6/64, 11/12/64, 11/23/64, 12/17/64, 12/31/64, and 2/23/65. These set forth for Katzenbach's information valuable data developed on King. The data involved was derived from electronic coverage on King and the SCLC.

A technical surveillance was instituted on the headquarters of the Southern Christian Leadership Conference, 330 Auburn Avenue, Northeast, Atlanta, Georgia, on November 8, 1963. The Southern Christian Leadership Conference is a racial-type organization headed by Martin Luther King, Jr.

This technical surveillance has provided considerable valuable intelligence information concerning communist influence on the Southern Christian Leadership Conference through King, as well as the communist influence evident in the outspoken position which King has taken in opposition to the United States foreign policy concerning Vietnam. Some examples include the following:

Information has been furnished relating to contacts between King and individuals with communist backgrounds such as Stanley David Levison, Harry Wachtel, Bayard Rustin, Clarence Jones and Randolph T. Blackwell. This information indicates the extent of the influence being exerted on King by these individuals with present and former communist backgrounds. Information thus obtained reveals the part these individuals play in important policy-making decisions of King relative to his organization; assistance which they render King in his writings and speeches concerning racial matters; and the advice and counsel they give King in his declarations concerning United States foreign policy.

Unless you instruct to the contrary, this technical surveillance will be continued for an additional six months.

RE: MARTIN LUTHER KING, JR.

This Bureau's investigation of the communist influence in racial matters has developed considerable information indicating the influence upon Martin Luther King, Jr., head of the Southern Christian Leadership Conference, by individuals with subversive backgrounds such as Stanley David Levison, Harry Wachtel, Bayard Rustin and others. From time to time, King meets with these individuals and coverage of these meetings by this Bureau results in the obtaining of evidence of the influences upon King as well as information concerning the tactics and plans of King and his organization in the civil rights movement. The coverage of these meetings also has developed information concerning King's involvement in the Vietnam situation. These meetings frequently take place in hotel rooms in New York City.

On November 29, 1965, information was obtained that King was to spend the night of November 29, 1965, at the Americana Hotel, 52nd Street and 7th Avenue, New York City. We also had information that King planned to meet with his advisors while in New York City, November 29-30, 1965. Because of the importance of the meeting and the urgency of the situation, a microphone surveillance was effected November 29, 1965, on King in Rooms 3609-3611, Americana Hotel, New York City. This surveillance involved trespass and was discontinued on November 30, 1965.

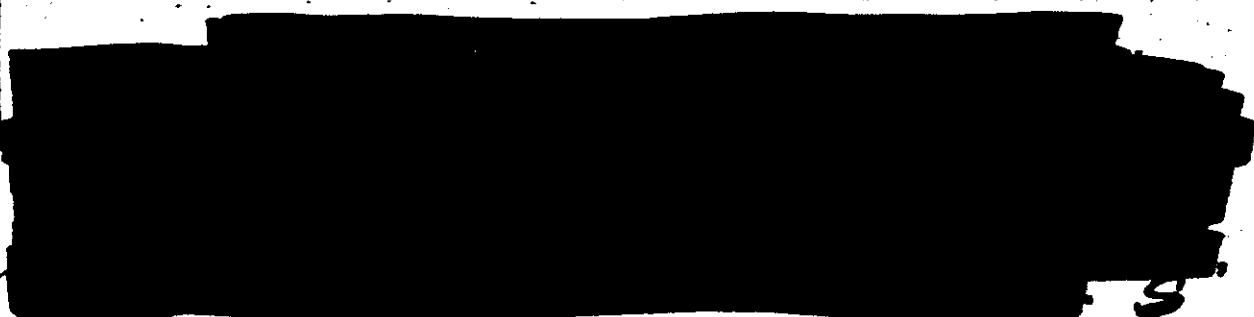

A confidential source of this Bureau who has furnished reliable information in the past supplied the following information concerning a contact between Martin Luther King, Jr., and Clarence Jones on November 4, 1961.

Jones said that now that the election is over they should think about what form "of struggle they should use," adding that he had been discussing it with "our friend." Jones said that he had heard rumors from responsible Democratic people in New York that King may be offered an official role in the Administration. Jones told King that King should think about this and that King must translate his moral influence into political power. King replied that he would think about the matter, taking into consideration "the movement and my personal goal." Jones also told King that King should think about what role "our friend" can play in this period, commenting that "our friend" had been helpful and has abided by the "decisions." Jones expressed the belief that "our friend" should be given some role inasmuch as "we're not in the same situation as we were with the Kennedy Administration." Jones also referred to the fact that the Civil Rights Bill is now the law. King replied "Good, after the election it would be a new situation."

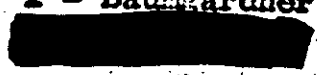

Confidential sources of this Bureau who have furnished reliable information in the past have supplied the following information concerning plans being made by Martin Luther King, Jr., and his associates concerning King's receipt of the Nobel Peace Prize which is to take place December 10, 1964, at Oslo, Norway.

On November 3, 1964, Bayard Rustin contacted the secretary of Dr. Ralph Bunche, Undersecretary for Special Political Affairs, United Nations (UN). Rustin stated that he was speaking on behalf of Martin Luther King, Jr., and requested to see Bunche regarding the receipt of the Nobel Peace Prize by King. (u)

Subsequently on November 3, 1964, Rustin conferred with Bunche and told him that upon King's return to New York City, after receiving the Nobel Prize, there is to be a welcoming affair at either a large dinner at a hotel or an activity at Carnegie Hall. Rustin told Bunche that King wanted to know whether Bunche would be prepared to be chairman of the welcoming committee which will include civil rights leaders and "a number of key liberals." Bunche said that he would be glad to be chairman, but that he would have to be informed as to the others who will be on the committee since there are some people with whom he will not work. Bunche told Rustin that he had sent a letter to King advising King that the Secretary General of the UN was hoping that King would visit the UN upon his return. Rustin told Bunche that he would personally meet with Bunche later and go over the details relative to King visiting the UN. Rustin also told Bunche that an invitation had been extended by the President of Brazil to have King visit Brazil on his way back to the United States. Rustin stated that he felt that this was not wise due to certain aspects of the regime in power in Brazil and inquired as to what Bunche's thoughts were on this matter. Bunche agreed that it was not a very good idea for King to visit Brazil at this time. (u)

On November 3, 1964, Rustin was in contact with Harry Wachtel concerning King's return to the United States from Norway. Rustin stated that King is considering making a speech at Carnegie Hall and selling tickets for the affair, the minimum price to be \$100. Wachtel said that King has inquired about the possibility that President Lyndon B. Johnson might attend such an affair, but that the President would not give an answer until after the election. According to Wachtel, Lee White, a White House aide, has stated relative to the President's attendance "the answer is not no." White has indicated that if the President could not attend, the President would send the Vice President in his place. Rustin indicated that a cocktail party would be held before the Carnegie Hall address by King. (u)

Rustin and Wachtel then discussed who might assist in the arrangements. Wachtel stated that Saul Mills had handled the arrangements for a concert for "us" and had made \$45,000 for "us." According to Wachtel, Mills is interested in the King affair and has submitted a memorandum of ideas on the subject. Rustin and Wachtel agreed to meet with Mills to discuss the matter. Wachtel stated that he would send Rustin a copy of the memorandum by Mills and in reference thereto Wachtel said that he thought the plans in the memorandum were too ambitious for they included an address by King before Congress and a ticker tape parade. (u)

Wachtel told Rustin that he is handling the details concerning King's trip to Norway and has spoken to the Norwegian Ambassador. (u)

Rustin then informed Wachtel that King desires to have Dr. Bunche and some white person to act as cochairmen of the affair welcoming King back to the United States, but that Bunche will not accept until he knows who the white person will be. Rustin indicated that he had considered having Senators Robert Kennedy and Jacob Javits as cochairmen so that there would be a nonpartisan element present. Rustin stated that after due consideration he thought it would probably be best to just have Bunche as chairman and have a subcommittee assisting him. Wachtel agreed with this idea. Rustin also informed Wachtel that King had been invited by the President of Brazil to visit that country, but that King (u)

should tell the Brazilian President that while he would like to visit that country, he will be unable to do so on his return trip from Norway and would be unable to visit Brazil until after the beginning of the new year. X(u)

On November 7, 1964, Wachtel contacted Rustin concerning the plans for welcoming King back to the United States and Wachtel stated that he had spoken to the White House and "the Kennedy front" regarding this matter. Wachtel said that he has Louis Martin of the Democratic National Committee "lined up." It is Wachtel's belief that President Johnson will come to New York City. Wachtel stated that he is waiting to hear from Senator Robert Kennedy in this matter as well. X(u)

Wachtel instructed Rustin to speak with Dr. Bunche and tell him that if the UN gave a luncheon for King, it would be better if held after King's return to the United States, but that the final decision is being left to the UN people. Wachtel suggested that if the UN affair was held before King's departure for Norway, December 4, 1964, would be a good date because it is just after the opening of the General Assembly at the UN and there will be many prominent people there. Wachtel noted the possibility of Leonid I. Brezhnev, First Secretary, Communist Party of the Soviet Union and Kwame Nkrumah, President of Ghana, being at the UN. Wachtel asked "Can you imagine Brezhnev embracing Martin like Khrushchev did Castro?" Rustin replied in the affirmative. X(u)

Wachtel stated that no plans will be made for a ticker tape parade for King until an answer is received from President Johnson. According to Wachtel, Louis Martin of the Democratic National Committee should be given something to do "even if it is just selling tickets." Rustin mentioned the possible use of an armory and stated it would be necessary to contact Governor Nelson Rockefeller of New York who is vacationing in Spain. Wachtel indicated that this could be done later by telephone since there will be additional ideas for the Governor's participation. Summarizing, Wachtel mentioned that Mayor Robert Wagner of New York City could have the ticker tape parade; U Thant, Secretary General, UN, could have the dinner for King; and Governor Rockefeller could have the reception for King. X(u)

On November 7, 1964, Rustin was in contact with King and mentioned that he is beginning the draft of the major speech which King is to deliver and that King can complete it. On November 7, 1964, Rustin also contacted Peggy Duff, a resident of London, England, who is Executive Director of the Campaign for Nuclear Disarmament. Rustin told her that King will be in London on December 6 and 7, 1964, and that Rustin wanted to know if Harold Wilson, Prime Minister of England, would be prepared to receive King. Duff indicated that she would check into this. Rustin said that it should not appear as though this was King's idea and that it was preferred that Wilson announce that he is inviting King to visit him. Rustin inquired of Duff as to whether there is a group of "peace-minded people" in London who would work to raise money for "our work in Mississippi." Duff replied in the affirmative and Rustin explained that the reason for raising funds is that "we" are some \$2,000,000 "in the hole on the Mississippi business" and that there are about 17 churches which have to be rebuilt. Rustin suggested that arrangements might be made to have the London Embassy of some African nation have a reception for King while he is there. * (u)

On November 9, 1964, Rustin told an associate that he was departing for London on November 11, 1964, for the purpose of clarifying a confusion which has developed surrounding King's trip to Europe in December, 1964. The confusion arises from the fact that the Archbishop of Canterbury desires to receive King, but has been opposed by certain elements since King is a Baptist. Rustin also indicated that while in London he is going to determine whether or not King will be able to meet with Prime Minister Wilson. * (u)

Bayard Rustin is a frequent advisor to King and is a former member of the Young Communist League, an organization which has been designated as subversive pursuant to Executive Order 10450. *

Harry Wachtel, also a frequent advisor to King, is the Executive Vice President of the Gandhi Society for Human Rights, a fund-raising adjunct of the Southern Christian Leadership Conference, which Conference is headed by King. [REDACTED]

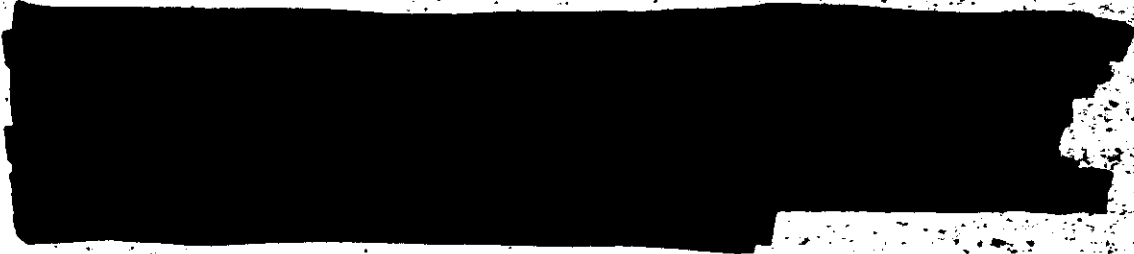

Pursuant to your request the following facts concerning electronic surveillances on Martin Luther King, Jr., and the Southern Christian Leadership Conference (SCLC), and former Attorney General Ramsey Clark's knowledge of these surveillances are set forth.

A wiretap was installed at King's address in Atlanta, Georgia, on 11/8/63 and was discontinued 4/30/65 when he moved. It was not reinstated at his new address. Former Attorney General Robert Kennedy approved this 10/10/63. In addition, on Kennedy's 10/10/63 authorization, wiretaps on King were instituted at the Hyatt House Motel in Los Angeles (4/24-26/64 and 7/7-9/64; at 125 East 72 Street, New York City, temporary address, 8/14-9/8/64); and the Claridge Hotel, Atlantic City, New Jersey, (8/22-27/64). These were discontinued when King left these addresses.

Wiretaps were installed at SCLC headquarters in New York City, 10/24/63-1/24/64 and 7/13/64-7/31/64. The discontinuance 1/24/64 was for lack of productivity; the discontinuance on 7/31/64 was because the office moved. There was a wiretap on the SCLC Atlanta headquarters 11/8/63 to 6/21/66 when former Attorney General Katzenbach ordered it discontinued because of the involvement of an SCLC official in a car theft case. These authorizations were also given by Kennedy on 10/10/63 and 10/21/63.

Former Attorney General Clark became Acting Attorney General on 10/3/66, he was confirmed by the Senate on 3/2/67, and was sworn in 3/10/67. On 1/2/68 Clark's approval was requested for a wiretap on SCLC headquarters in Atlanta, which authority he denied on 1/3/68. Authority was again requested on 4/2/68 and authority was denied by Clark in a memorandum to the Director 1/17/69. On 5/17/68 Mr. DeLoach discussed the King wiretaps with Assistant Attorney General Edwin L. Weisl. However, Weisl did not mention that Clark was aware of Weisl's inquiry concerning the King wiretaps.

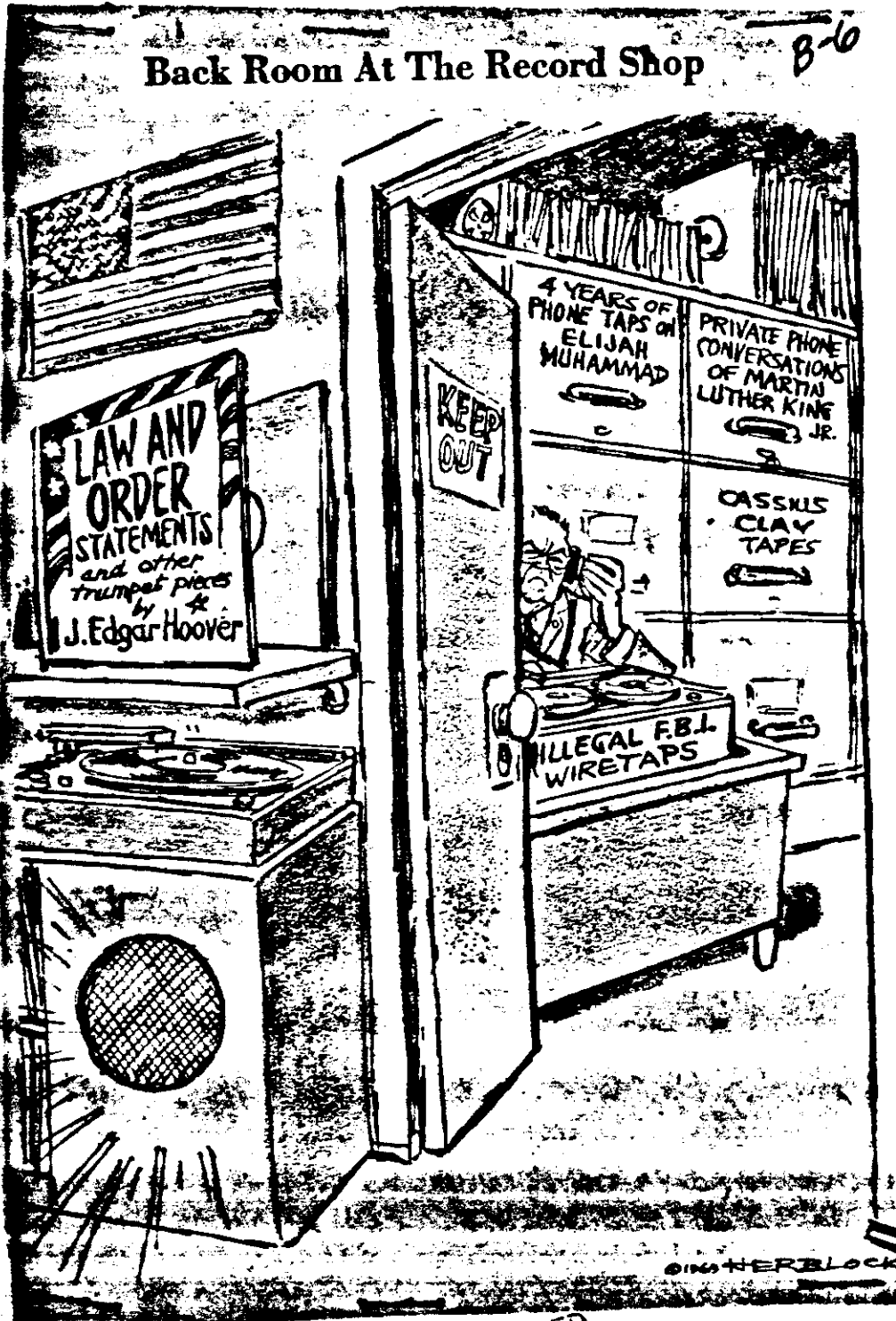

The Director has asked who authorized the wiretaps on Martin Luther King, Jr., and Elijah Muhammad and has asked to see the original authorizations.

There was a wiretap on King's phone at his residence in Atlanta, Georgia, from 11/8/63 to 4/30/65 when he moved. Wiretaps of several days duration were also instituted at the Hyatt House Motel in Los Angeles, California, the Claridge Hotel in Atlantic City, New Jersey, and at a temporary address at 125 East 72 Street, New York City. A wiretap was instituted at the headquarters of the Southern Christian Leadership Conference (SCLC) in New York City on two occasions. All these wiretaps were on the authorization of Robert Kennedy, dated 10/10/63, which is attached.

In addition, a wiretap on SCLC headquarters in Atlanta, Georgia, was instituted from 11/8/63 to 6/21/66 on Kennedy's authorization dated 10/21/63, attached.

A wiretap on the residence of Elijah Muhammad in Chicago was authorized 1/2/57 by Herbert Brownell, authorization attached. It was installed 1/4/57. On this same authorization wiretaps were installed at additional residences of Elijah Muhammad in Chicago, Illinois, and Phoenix, Arizona. The wiretap installed on this authorization was discontinued 6/23/66.

Ramsey Clark became Acting Attorney General on 10/3/66.

Letter received from Representative H. R. Gross (R) of Iowa expressing concern over controversy involving telephone surveillance on Martin Luther King, Jr. Gross requested additional facts regarding this surveillance and King's communist affiliations. Recommended that Gross be contacted by representative of Crime Records Division, thanked for his interest and advised that due to various ramifications involved in this matter, it is not believed appropriate to furnish him data requested.

We have had cordial relations with Gross. In his letter, Gross stated he believed a more complete accounting of King's activities is due the citizens of this nation and would most definitely be in the national interest. Gross requested: (1) that the Director confirm, in as much detail as possible, that the telephone surveillance on King was occasioned by his association with Communist Party members; (2) that the Director describe the occasion on which approval for the King telephone surveillance was requested and received. Gross asked if it was correct that a conference was held in this matter involving the Director, an aide, Mr. Kennedy, and Mr. Katzenbach; (3) that the Director furnish any facts deemed appropriate to demonstrate the extent to which King may have dealt with members of the Communist Party.

Data regarding the approval of the King telephone surveillance by former Attorney General Robert Kennedy and general information regarding King's communist affiliations have already received widespread newspaper publicity. In view of the various ramifications involved in the matter of King's telephone surveillance, it is not believed additional information should be furnished Gross. Release of additional facts by him will certainly result in additional widespread publicity and prompt numerous inquiries to us by members of Congress and FBI critics.

My dear Mr. Vice President:

The following facts are being furnished for your information concerning the telephone surveillance on the residence of the late Martin Luther King, Jr., authorized by former Attorney General Robert F. Kennedy and installed by this Bureau.

On July 16, 1963, an official of this Bureau saw Mr. Kennedy at the latter's request. On that occasion, Mr. Kennedy said he was considering the possibility of a telephone surveillance of King because of King's communist associations. He was advised by the Bureau official that since King was in travel status practically all the time, the productivity of such a surveillance was doubtful and he was asked to consider the repercussions if it ever became known that such surveillance had been instituted on King. Mr. Kennedy said he was not concerned about possible repercussions and that he thought it advisable to have as complete coverage as possible in view of the possible communist influence in the racial situation. He was told that the feasibility of such coverage would be determined and an appropriate recommendation would be submitted to him.

The above-mentioned telephone surveillance was discontinued on April 30, 1965, when King changed residences in Atlanta. At that time matters of interest to us pertaining to King and his organization, the Southern Christian Leadership Conference (SCLC), were being obtained through a telephone surveillance on the Atlanta headquarters of SCLC. This telephone surveillance on SCLC in Atlanta was in existence from November 8, 1963, to June 21, 1966, when former Attorney General Nicholas Katzenbach ordered it discontinued because of the involvement of an SCLC official (Hosea Williams) in a car theft case.

Attached is a copy of Atlanta airtel May 19, 1965, showing the discontinuance of the telephone surveillance on King on April 30, 1965.

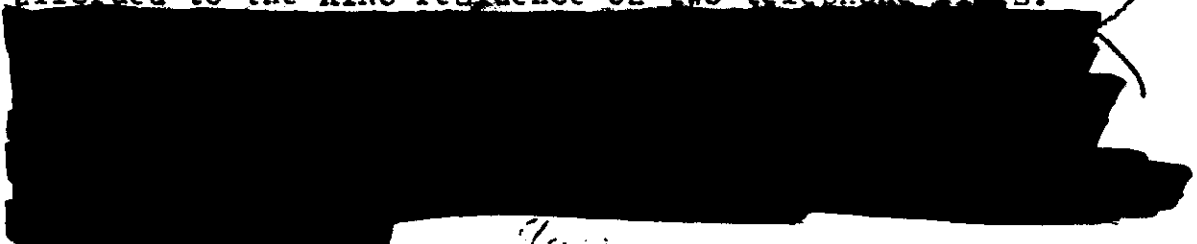

In our 5/21/69 note to the Director advising of the request received from the Department to have SA [redacted] available in the Atlanta Office on 5/27/69 to review with Department Attorney Michael T. Epstein the Martin Luther King case and to prepare possible testimony for the Cassius Clay hearing in Houston, Texas, on 6/2/69, the Director asked the question, "Just what is pending re King?"

There is nothing pending on King. However, since Cassius Clay had appealed his 1967 Selective Service conviction on grounds that his case was tainted by "illegal Government eavesdropping," the Department had requested review of the Martin Luther King file since a conversation between Clay and King was monitored on 9/4/64 in Atlanta, Georgia.

The electronic surveillance established on King was requested and approval was received from the Attorney General. King had a close association with Stanley David Levison, a concealed Communist Party member and the security purposes intended by the electronic surveillance were to determine the extent of communist influence on King, the Southern Christian Leadership Conference, and the racial situation in general.

Ed Weisl, Jr. came over to see me at 4:15 p.m., 5/17/68. He asked me if the rumor was true that was going around Washington to the effect that Bobby Kennedy had specifically asked the FBI to tap the telephone of Martin Luther King. I told Weisl I had not heard this rumor. I asked him what prompted his question. He replied that he had heard about this several times and, as a matter of fact, a statement had appeared in a recent newspaper article.

I reminded Weisl that Messrs. Gale, McAndrews, and I had briefed him regarding all activities pertaining to Bobby Kennedy's requests for microphones and telephone taps during his tenure as Attorney General. I stated this briefing, as he should recall, concerned the basis on which the Department pleaded immunity in the civil suit against our agents in Las Vegas, Nevada.

Weisl stated he remembered the briefing and, as a matter of fact, this was when the information first came to his attention. I asked Weisl why he was now asking me this specific question. He replied because Drew Pearson had found out about this matter and probably would print it in order to embarrass Bobby Kennedy.

I asked Weisl if he had discussed this matter with Drew Pearson. He replied in the affirmative and stated his father, Ed Weisl, Sr., had also discussed the matter with Pearson. Weisl asked me if the FBI would have any objections to this matter being brought out before the public. I told him it appeared as if the matter had already been brought out before the public. I stated he should keep several things in mind, i.e., (1) regardless of how such an article was written, a segment of the Negro population of the United States would still feel very harshly toward the FBI and (2) this would obviously cut off some of our sources of information.

Weisl rebutted this statement with the fact that Richard Harwood of the Washington Post had already printed the fact that

the FBI had accumulated a number of tapes on King, as a result of the utilization of microphones. Weisl stated that Pearson would obviously indicate that Bobby Kennedy had ordered the FBI to take this action. I told Weisl that, nevertheless, certain Negro groups would still blame the FBI, whether we were ordered to take such action or not.

Weisl stated he would try to keep the above matter from being printed, if the FBI felt so strongly about it. I told him we held no brief for Kennedy, in view of the shoddy way in which he had treated the FBI; however, we did not want to be involved in any political maneuvers and action of this nature would most certainly concern politics. Weisl stated he would try to keep this from appearing.

Richard Harwood did include in his recent article on the Director a statement that the FBI had several tapes on Martin Luther King, as a result of the utilization of microphones. This fact has also appeared in a number of other newspapers. Apparently Weisl has discussed this matter with Pearson---Pearson desiring to print the facts in order to embarrass Kennedy.

The record is quite clear, through the medium of memoranda written by former employee Courtney Evans, that Kennedy first requested electronic coverage; however, Evans succeeded in talking him out of it. Several months later Evans approached Kennedy and requested permission for such coverage, at which time Kennedy approved this coverage. While an expose of such facts could obviously hurt Kennedy, such action would also harm the FBI from a public relations standpoint. We, therefore, should have no part in it and should discreetly discourage such action if brought to our attention.

Robert F. Kennedy, during the period he was Attorney General, not only approved recommendations for electronic surveillances but he initially requested such coverage. These are the facts:

Former Assistant Director C. A. Evans by memorandum dated July 16, 1963, to former Assistant to the Director A. H. Belmont reported that he, Evans, contacted Kennedy at his request on that date. Kennedy pointed out that in view of possibly communist influence in racial matters, he desired telephone coverage of King and Clarence Benjamin Jones, a New York attorney who had close association with King. Evans pointed out to Kennedy that King was in constant travel status and it was, therefore, doubtful that a telephone surveillance at his office or home would be productive. Also Evans raised a question as to the repercussions if it should ever become known that such a surveillance had been put on King. Kennedy replied that this did not concern him in the least.

By memorandum dated July 25, 1963, from Evans to Belmont, Evans reported that Kennedy stated he was of the opinion that his request for telephone surveillance on King had been ill-advised and that he was withdrawing his request.

Memorandum of October 7, 1963, to the Attorney General from the Director requested a telephone surveillance on King at his residence 563 Johnson Avenue, Northeast, Atlanta, Georgia. This was approved under the written signature of Kennedy dated October 10, 1963. A telephone surveillance was installed on November 8, 1963, and discontinued on April 30, 1965.

Memorandum dated October 18, 1963, to the Attorney General requested a telephone surveillance on King at his office, the Southern Christian Leadership Conference, 330 Auburn Avenue, Northeast, Atlanta, Georgia. This was approved on the written signature of Kennedy dated October 21, 1963. Telephone surveillance was installed on October 21, 1963, and discontinued on June 21, 1966.

While Kennedy did personally sign two requests for telephone surveillances on King, he did not sign any microphone surveillance requests. The microphone surveillances were put

on by Bureau officials (The Director, Belmont, Sullivan, & Baumgardner) acting under general authority relating to the Attorney General. During 1964 microphone surveillance coverage was placed on King during his travels to Washington, D. C.; Milwaukee, Wisconsin; Honolulu, Hawaii; Los Angeles, California; Detroit, Michigan; San Francisco, California; and Savannah, Georgia.

By memorandum dated March 4, 1964, from F. J. Baumgardner to Mr. W. C. Sullivan recommended and approved that Evans personally deliver to the Attorney General a copy of a "Top Secret" memorandum containing results of microphone surveillances of King and his associates while at the Willard Hotel in Washington, D. C., during January 5 - 7, 1964, and during February 18 - 25, 1964, while King was in Honolulu, Hawaii, and Los Angeles, California. [REDACTED] b7(c)

It also contained King's vilification of the late President and his wife. The memorandum was delivered by Evans on March 10, 1964.

Memorandum from Evans to Belmont of September 11, 1964, reported that Kennedy before leaving office had instructed that the "Top Secret" memorandum submitted to him by the FBI be returned to the Bureau since he did not feel this material should go to the general Departmental files. Evans recommended that the copy of the material be destroyed. The Director instructed that it was not to be destroyed but kept in file with Evans' memorandum. The contents of the "Top Secret" memorandum clearly indicate that the information came from a microphone surveillance.

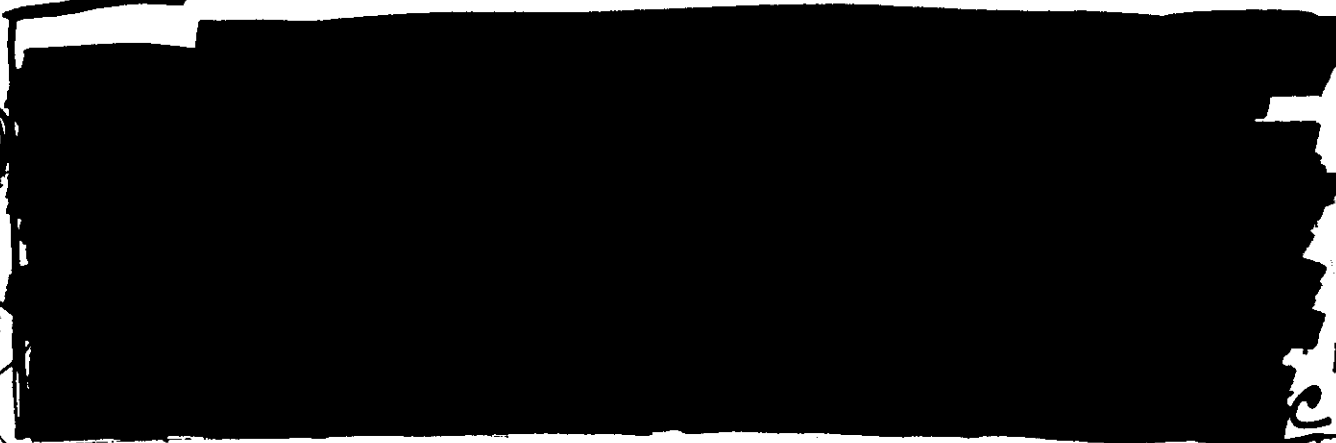

This is to advise you of the microphone and wire tap coverage that we have afforded Martin Luther King, Jr., President Southern Christian Leadership Conference.

As you are aware King has been in close association with individuals having Communist Party backgrounds since his rise to prominence in the civil rights field. Among such individuals is his principal advisor Stanley Levison, a long-time secret communist whose membership in the Communist Party, USA, has been established as late as July, 1963. Clarence Jones, another close advisor to King, was a former member and in a position of leadership in the Labor Youth League, a communist front organization. Bayard Rustin, another of King's close advisors, was a member of the Young Communist League in the early 1940's.

On October 10, 1963, Attorney General Robert F. Kennedy approved technical surveillances on King's current residence or at any further address to which he may move. He also approved the technical surveillance of the Southern Christian Leadership Conference New York City Office or any other address to which it may be moved.

A wire tap was installed on King's residence, 563 Johnson Avenue, Northeast, Atlanta, Georgia, on November 8, 1963, and discontinued on April 30, 1965, when King moved from this address. It was not reinstated on his new residence.

From October 24, 1963, to January 24, 1964, and from July 7, 1964, to July 31, 1964, a wire tap was maintained on the Southern Christian Leadership Conference New York City Office. In addition, on October 21, 1963, Attorney General Kennedy authorized a wire tap on the Southern Christian Leadership Conference Headquarters at Atlanta, Georgia, which was maintained from November 8, 1963, to June 21, 1966, when Attorney General Nicholas deK. Katzenbach ordered it discontinued since he thought it might be prejudicial to the possible prosecution of Hosea Williams, a Southern Christian Leadership Conference official, under Interstate Transportation of Stolen Motor Vehicles Statutes.

On 12/16/66, [redacted], a source close to STANLEY LEVISON, advised that information had come to his attention which disclosed that LEVISON and CHAUNCEY (CHAUNCEY) ESKRIDGE, Chicago attorney and adviser to KING, were in contact on that date. According to the information received by the source, their contact was in regard to the current controversy over eavesdropping. Their comments were as follows:

LEVISON: "This is something we have known about for years. We never knew who it was and chances are it was not just one but several. Surely the local community used to do it, but anytime he (KING) talked on the phone he knew he had visitors."

CHAUNCEY: "That's the first time that it ever came out knowledgeable that the FBI was doing this."

LEVISON: "Oh yea. That's right. Although actually it was communicated to him (KING)".

CHAUNCEY: "We knew it but the public didn't know it."

LEVISON: "The public didn't know it"

CHAUNCEY: "Except that Hoover (Director Hoover of the FBI) called that press conference after that little flap about him. Then Hoover disclosed to newsmen in an off the record meeting of news women. Remember he had the conference with the news women."

LEVISON: "That is right. Yea. What did he say that time to the news women?"

CHAUNCEY: "It was stated in the press that it was off the record, but that he told things about ML (KING) that they allegedly didn't know before. We never knew what he said, but the fact that he did communicate to news women this information is how Reston knew about it."

LEVISON: "It's always been well known that they have secret files on everybody from the President down, and this the press has talked about. As a matter of fact, it came up at that time because they said what's going to happen to those confidential files when Hoover resigns or dies. Who gets them. And of course everyone in Washington is nervous about that."

CHAUNCEY: "I don't blame them."

LEVISON: "This sort of thing you see, has a funny kind of quality to it. People are nervous--on the otherhand, the fella who has them can't use them because then he's in trouble. So it's a kind of equilibrium, that gets established. One of those funny stories I remember from years ago was the racketeer Dutch Schultz, one of the big operators in this area. He knew his phone was always tapped. And he never entered a phone conversation without saying, 'I hope your ears fall off!'"

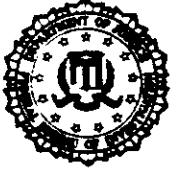

The New York Office called me this afternoon (10/14/65) and advised that Martin Luther King, Jr., has a reservation for tonight at the Astor Hotel in New York City. He is to be in Room 445. The New York Office has available Room 435 from which it advises it can maintain, with full security assured, a microphone surveillance on King.

King has recently been conferring with his advisors with communist backgrounds, such as Stanley David Levison and Harry Wachtel, on his visits to New York City. We have specific information that he plans to see Wachtel on this visit. His conferences with these advisors have shown the communist influence upon King relative to racial matters as well as the Vietnam situation.

The New York Office requested authority to make the microphone installation immediately with full security assured.

ACTION:

On New York's assurance that full security was available and since time was of essence, I told New York to go ahead with the installation as planned. I also authorized the necessary expenditure for the room for monitoring purposes. Memo to A.G. being prepared.
