Synopsis:

The National Renaissance Party is an anti-Negro, anti-Semitic and neo-Fascist group, in NYC. MADOLE presently resides at apartment 8, 10 W. 90th St., NYC, and is employed at L. F. Dommerick and Co., 271 Madison Ave., NYC. MADOLE is national leader and original organizer of the National Renaissance Party and exercises complete control over its activities. He is the principal speaker at National Renaissance Party meetings and controls publication of party literature. No BCI record located for MADOLE.

DETAILS: This investigation is predicated upon information furnished by T-1, who was in a position to furnish reliable information, and who indicated on June 4, 1956, that

T-1 stated that [REDACTED]

Information furnished by T-1 should not be made public except after the issuance of a subpoena duces tecum.

T-2, who has furnished reliable information in the past, indicated on May 9, 1956, that the NRP at present is a neo-Nazi, anti-Semitic, anti-Negro organization with activities generally confined to the New York area. He said that its principal activities consist of holding outdoor meetings and the distribution of literature throughout the United States and abroad where it is reprinted by similar organizations.

This informant stated that the NRP leader and founder is JAMES H. MADOLE and its principal financial contributor is FREDERICK WEISS. He said that at the present time the party membership is very small.

The April, 1955 National Renaissance Bulletin, official NRP publication, listed headquarters at 10 West 90th Street, New York City.

The NRP was the subject of a preliminary report on neo-Fascist and hate groups published by the House Committee on Un-American Activities on December 17, 1954, which stated that this neo-Fascist group's activities and propaganda are clearly subversive and un-American.

[REDACTED], Bureau of Special Services, New York City Police Department, indicated on August 6, 1956, that their records contained the following background information on JAMES MADOLE, leader of the NRP:

He said the subject's father was JAMES MADOLE, deceased, and his mother is GRACE MADOLE, who resides with the subject at apartment 8, 10 West 90th Street, New York City. He stated that he had resided at this address since May 3, 1954, when they moved there from 224 Main Street, Beacon, New York. He stated that GRACE MADOLE is regularly employed and apparently furnishes support for the subject, who has difficulty holding a job. He stated the subject graduated from Beacon High School in June, 1945 and had no other education. He described the subject as 28 years old, 5' 10", 130 pounds, fair complexion, partially bald with blond hair and single.

[redacted] indicated that the Bureau of Criminal Identification, New York City, had no record identifiable with the subject.

On March 15, 1956, a Special Agent of the Federal Bureau of Investigation observed JAMES MADOLE leaving his residence at 10 West 90th Street, New York City, and entering a building at 271 Madison Avenue, New York City.

On March 28, 1956, Special Agents of the Federal Bureau of Investigation observed MADOLE entering the offices of L. F. Dommerick and Co., 271 Madison Avenue, New York City.

A telephonic inquiry on August 22, 1956, to L. F. Dommerick and Co., Murray Hill 3-8650, revealed that JAMES H. MADOLE is presently employed at this firm in [redacted].

T-2 indicated on August 17, 1956, that the subject continues to reside at 10 West 90th Street and continues his position of national leader of the NRP. He stated that MADOLE has complete control over its activities and is the principal speaker at party meetings. He stated that MADOLE also has control over all publications and party literature and distribution of this literature which is anti-Semitic, neo-Fascist, and anti-Negro in content.

T-2 added that MADOLE was the original organizer of the NRP and has been national leader throughout its seven year existence.

T-2 indicated on July 15, 1953 that MADOLE had been the leader of the NRP throughout its existence and that it was his personal zeal and continued work that had kept it in existence. He said that MADOLE had been very sickly as a child having an asthmatic condition and was raised by his mother inasmuch as his father had died when he was quite young.

T-2 stated that MADOLE probably had a fixation on his mother and that his political activities had been encouraged and directed by his mother since the time that MADOLE was in high school. He stated that MADOLE had appeared at all the meetings which have ever been held by the NRP as its principal speaker and whereas others have come in from time to time as speakers, he always appeared to be in complete charge of the meetings.

This informant also pointed out that all literature distributed by the NRP carries MADOLE's name and home address and many of the articles in the National Renaissance Bulletin are attributed to him.

T-2 stated that MADOLE appears to be a rabid Fascist who imagines himself to be a fuehrer. He stated that MADOLE has expressed a bitter hatred of the Jewish race and this hatred has carried over him to becoming one of the primary tenets of the party. He said that MADOLE has never worked very long at any job, but has spent most of his time working for the party and is probably supported by his mother.

T-2 stated on January 15, 1954 that MADOLE is not as active in NRP affairs recently as he formerly was because [redacted]

T-2 added that he believes MADOLE may be forced out of the party and that without the support of FREDERICK WEISS, MADOLE would never have been able to maintain control of the NRP and that now this support [redacted]

T-2 indicated on June 25, 1954 that MADOLE continues to act as puppethead of the NRP and makes arrangements for the meetings. He stated, however, that MADOLE has very little actual control of the activities and that

WEISS directs his decisions regarding the functions of the party. He stated that it is planned that MADOLE will continue to be the principal speaker for the party when the outdoor street meetings are held as he has been in the past.

T-2 indicated on October 15, 1954 that MADOLE now exercises complete control over the NRP and makes all arrangements for its meetings. He stated that MADOLE is the principal speaker at all meetings of the NRP and is in charge of all correspondence and money received by the party.

T-2 stated on January 14, 1955 that MADOLE continues to be the national director of the NRP and is the guiding force in all its activities. He stated that MADOLE arranges for all its meetings and is always the principal speaker at these meetings. He stated that MADOLE also arranges for all publications issued by the party and usually writes most of the material that is placed in these publications.

T-2 indicated on May 31, 1955 that JAMES MADOLE continues to be the titular head of the party and organizes all meetings and is the principal speaker at these meetings. He said MADOLE arranges for the printing of all party literature and usually is the author of all material in this literature. He said that MADOLE is the only person in the party who is actively engaged in attempting to obtain financial contributions for the party as well as new members. He said, however, that during recent months MADOLE has received very little financial aid from any individual except FREDERICK WEISS and has had no success in obtaining new members for the party.

T-2 indicated on August 8, 1955 that FREDERICK WEISS exercises a great deal of control over JAMES MADOLE in his operation of the NRP and that MADOLE depends upon WEISS for considerable financial support for the party. He further indicated that WEISS usually instructs MADOLE as to the content of speeches which MADOLE makes at the NRP meetings.

This informant also pointed out that MADOLE's mother, Mrs. GRACE MADOLE, also is influential in directing the NRP through her son. He said that it had been Mrs. MADOLE's idea originally for the establishment of the NRP and she is wholeheartedly behind it and her son's activities in it. He further alleged that she is the only person who would be able to control MADOLE sufficiently to persuade him to discontinue the NRP.

T-2 indicated on December 30, 1955 that the only individuals at present who appear to be active members of the NRP are JAMES H. MADOLE and FREDERICK WEISS. He stated that MADOLE continues to prepare bulletins distributed by the party and conducts weekly gatherings held at his apartment for the members.

T-2 indicated on January 2, 1956 that GRACE MADOLE, mother of JAMES MADOLE, stated that JAMES had a terrible attack of asthma and was presently in Mount Sinai Hospital. T-2 added that MADOLE has had these attacks quite frequently in the past and as a result has been unable to hold a steady job.

T-2 indicated on April 10, 1956 that MADOLE had suffered another attack of asthma and was in St. Lukes Hospital on April 8, 1956. He added that MADOLE was still in the hospital on April 10, 1956, but expected to be out in time to hold his meeting of the NRP on April 14, 1956.

T-2 indicated on June 2, 1956 that MADOLE had attended a meeting on April 27, 1956 held at the headquarters of CONDE MC GINLEY in Union, New Jersey, a publisher of anti-Semitic, pro-nationalist literature.

T-2 stated that while at this meeting MADOLE collapsed and was taken to a hospital in Irvington, New Jersey. T-2 said that this was another attack of asthma which MADOLE has suffered with for many years. He stated, however, that these attacks have been occurring much more frequently within recent months and are of a more serious nature. He said it was believed that MADOLE would have died during this most recent attack if he had not received oxygen in time.

T-3, who has furnished reliable information in the past, stated on July 8, 1953 that JAMES MADOLE was a very radical Fascist who believed that HITLER was the greatest man who ever lived. He said that MADOLE was also violently anti-Semitic and expressed the idea that all Jews in the United States should be killed.

T-4, who has furnished reliable information in the past, indicated on December 15, 1953 that it is his opinion that MADOLE is mentally unstable and thereby easily becomes prey to any radical organization.

Mr. HAROLD KEITH THOMPSON, 433 East 83rd Street, New York City, indicated on September 9, 1953, that MADOLE has controlled the NRP since its beginning and that he is a very radical person dedicated to the ideals of Fascism. He stated that MADOLE definitely believes that he will someday be able to convert the United States to Fascism. He said that MADOLE is the principal speaker at the party meetings and is recognized as the supreme leader of the party.

[redacted] Alcoa Steamship Company, 17 Battery Place, New York City, indicated on March 8, 1956, that the subject had been employed at this firm as a junior clerk on October 9, 1951 and was discharged in the spring of 1953 because of frequent illnesses. He indicated that the subject's employment application contained the following information:

DETAILS: T-1, who has furnished reliable information in the past, furnished the following information which he received from a source which he termed reliable whose identity he declined to disclose. He indicated on October 19, 1956, that JAMES MADOLE continues to be National Leader of the National Renaissance Party (NRP) and maintains Party headquarters in his apartment at 10 West 90th

Street, New York City. T-1 indicated that MADOLE resides at this address with his mother GRACE MADOLE who also is active in Party affairs. He stated that informal Party meetings are frequently held at this address and that MADOLE utilizes this apartment for the preparation of Party literature. He stated that MADOLE prepares all literature that is distributed by the Party and usually writes all the articles appearing in this literature himself as well as arranging for its printing and distribution.

T-1 further stated that MADOLE recently has attended some informal meetings of the Nationalist Party at their headquarters at 344 East 83rd Street, New York City. He stated this is an anti-Semitic neo-Fascist group similar to the National Renaissance Party, whose membership consists mainly of teen-age boys. He stated that MADOLE has become quite friendly with members of this Party and frequently members of the Nationalist Party have aided MADOLE in the distribution of National Renaissance Party literature. T-1 added, however, that MADOLE had made no effort to cooperate with the Nationalist Party or any attempt to take over control of this Party.

T-1 indicated on May 9, 1956, that the NRP at present is a neo-Nazi, anti-Semitic, anti-Negro organization with activities generally confined to the New York area. He said that its principal activities consist of holding outdoor meetings and the distribution of literature throughout the United States and abroad where it is reprinted by similar organizations.

This informant stated that the NRP leader and founder is JAMES H. MADOLE and its principal financial contributor is FREDERICK WEISS. He said that at the present time the Party membership is very small.

The April, 1955 National Renaissance Bulletin, official NRP publication, listed headquarters at 10 West 90th Street, New York City.

The NRP was the subject of a preliminary report on neo-Fascist and hate groups published by the House Committee on Un-American Activities on December 17, 1954,

which stated that this neo-Fascist groups's activities and propaganda are clearly subversive and un-American.

T-2, who is in a position to furnish reliable information, indicated on September 8, 1956, that JAMES MADOLE and his mother GRACE MADOLE maintain headquarters for the NRP in Apartment 8 at 10 West 90th Street, New York City. He stated that a great many individuals visit this apartment usually in the evening. He added that it appears that at least once a week a Party meeting is held consisting of a dozen or less individuals.

T-2 added that JAMES MADOLE is absent from this apartment during the day and he assumes that he is regularly employed, but he does not know where this employment might be. He stated this apartment consists of one room [redacted]

T-2 added that [redacted]

[redacted], but does not know the identity of the person, but believes it is not the subject or his mother. He added he believes that some of the Party literature may be prepared in this apartment and that all of the Party literature which he has seen has been violently anti-Semitic in nature. He stated that he has never seen the subject or Mrs. MADOLE attempting to solicit members or funds anywhere in the neighborhood of this apartment.

[redacted] indicated on October 17, 1956, that [redacted] at 10 West 90th Street. He indicated that Mrs. GRACE MADOLE had rented an apartment in this building about April, 1954, and that she presently resides there with her son JAMES MADOLE. He stated they pay \$88.00 per month for the apartment which is always paid by Mrs. MADOLE either by check or money order. He stated that when Mrs. MADOLE applied for this apartment he verified her employment at the Metropolitan Life Insurance Company and was told that she had been employed there for the past 20 years.

[redacted] stated he has no further background regarding either Mrs. MADOLE or her son. He stated, however,

that many of the tenants in this building had complained to him at various times in the past about excessive noise in the MADOLE apartment and about the many visitors which come to this apartment. He stated that it appeared that they were holding meetings of the NRP at this apartment fairly regularly on Thursday nights in the past. He stated, however, within the past four months he had no complaints and that apparently these meetings had ceased. He stated he has no personal knowledge of any political activity on the part of the subject or Mrs. MADOLE, but had read in the newspaper that JAMES MADOLE was leader of the NRP. He indicated that so far as he knows none of the other tenants in the building are associated with the MADOLEs in NRP activity.

T-3, who is in a position to furnish reliable information, indicated on August 27, 1956, that the

T-1 indicated on August 28, 1956, that the June-July, 1956 issue of the National Renaissance Bulletin, official publication of the NRP, contained an article entitled "Israeli Scientists Admit that the Jewish People are a Racial Group," by JAMES H. MADOLE. T-1 indicated that this was an anti-Semitic article concerning genocide.

T-1 indicated on September 27, 1956, that the August, 1956 National Renaissance Bulletin contained an article entitled "Tennessee Patriots Rebel Against Supreme Court Tyrants," by JAMES H. MADOLE. T-1 indicated this article was anti-Negro and anti-Semitic in nature.

T-1 indicated on August 1, 1956, that a leaflet prepared by the NRP entitled "Democratic Party, Arch-foe of White Civilization in America" was written by JAMES MADOLE and

was anti-Negro in content. T-1 added on August 17, 1956, that on August 10, 1956, the subject and six members of the Nationalist Party had passed out NRP leaflets at 86th Street between Lexington Avenue and Third Avenue, New York City. He stated that about 1000 copies were distributed of a leaflet entitled "Shall American Soldiers Serve as Cannon Fodder for Jewish Aggression?" which was written by JAMES MADOLE, and which was anti-Semitic in content.

A Special Agent of the Federal Bureau of Investigation observed the subject leaving the building at 271 Madison Avenue at five p.m. on October 19, 1956 and proceeding to Steinway Hall at 113 West 57th Street.

It is noted that 271 Madison Avenue is the building occupied by L.F. Dommerick and Company.

[REDACTED] Nola Studios, 113 West 57th Street, indicated on October 22, 1956, that the subject had been in on October 19, 1956, and made reservations for a room for the night of November 2, 1956, to hold a meeting of the NRP.

identity he declined to disclose. He indicated on December 14, 1956, that JAMES MADOLE continues to reside at 10 West 90th Street, New York City, and remains head of the National Renaissance Party. He stated that MADOLE is the dominant force in this organization and arranges all meetings which are sponsored by the Party. He indicated that MADOLE also prepares and distributes all Party literature.

He said that at these meetings MADOLE is always the principal speaker. He added that at a meeting on December 13, 1956, held at ~~Nola Studios, 113 West 57th Street, New York City,~~ MADOLE spoke at length praising Premier NASSER of Egypt and the Arab states.

MADOLE indicated that there could never be peace in the Middle East until the state of Israel is obliterated. MADOLE also attacked the Supreme Court and Attorney General BROWNELL for forcing the "Negroes" down the throat of the South.

T-1 indicated on May 9, 1956, that the NRP at present is a neo-Nazi, anti-Semitic, anti-Negro organization with activities generally confined to the New York Area. He said that its principal activities consist of holding outdoor meetings and the distribution of literature throughout the United States and abroad where it is reprinted by similar organizations.

This source stated that the National Renaissance Party leader and founder is JAMES H. MADOLE and its principal financial contributor is FREDERICH WEISS. He said that at present the party membership is very small. The April, 1955, "National Renaissance Bulletin", official NRP publication listed headquarters at 10 West 90th Street, New York City.

The National Renaissance Party was the subject of a preliminary report on neo-Fascist and Hate Groups published by the House Committee on Un-American Activities on December 17, 1954, which stated that this neo-fascist group's activities are clearly subversive and un-American.

T-1 indicated on December 7, 1956, that MADOLE had prepared and distributed an announcement entitled "The National Renaissance Party Sponsors a Second Major Political Rally to Oppose American Participation in a Third World Bloodbath", which indicate a Party meeting to be held on December 13.

T-1 indicated on December 3, 1956, that MADOLE had contacted Nola Studio and arranged for a meeting room on the night of December 14. However, he had later changed this meeting date to Thursday, December 13, because he had a date with a new girl friend on the 14th. This informant also stated that MADOLE recently indicated that he had received a letter from [redacted] White Citizens' Counsel in Washington, D.C., which indicated plans to hold a meeting in Washington and requesting MADOLE to be present as one of the speakers. MADOLE stated that he was thinking of going to this meeting when a definite date is established.

The informant added that FREDERICH WEISS had recently printed an article entitled "Who Cares?" which is anti-Semitic, anti-alien, and anti-Negro. He stated that about 8,000 of these pamphlets had been printed and that WEISS had delivered a quantity of them to MADOLE who indicated he would distribute about 300 of them in the South. The informant stated that MADOLE did not indicate how these would be distributed but added that he would not be able to distribute them in the North as it might antagonize his Arab friends.

T-1 indicated on December 17, that MADOLE had received large quantities of pro-Arab and pro-Egyptian literature in recent months which he would stamp with the name of the National Renaissance Party, 10 West 90th Street, New York City, and distribute through Party channels.

T-1 stated that some of these booklets included the following:

"Modern Egypt in its Fourth National Celebration", (published by the Ministry of Foreign Affairs).

"Prosecution of the Arabs in Israel", (published by the Palestine-Arab Refugee Office, New York City).

"Anglo-French-Israeli Aggression Against Egypt", (published by the Egyptian Embassy, Washington, D.C.).

"The Suez Canal - Facts and Documents", (published by the Selected Studies Committee, Cairo).

T-1 indicated on November 27, that the subject had decided to utilize the headquarters of the Nationalist Party an anti-Semitic, neo-Fascist group located at 344 East 83rd Street, New York City, for the display and sale of National Renaissance Party literature and pro-Arab literature. MADOLE advanced his share of the monthly rent amounting to \$22.50, but the landlord of this building evicted the Nationalist Party in November for non-payment of rent.

The informant stated that it is possible a few of the Nationalist Party members will now become

associated with MADOLE and National Renaissance Party.

T-1 also stated ~~BENJAMIN FREEDMAN~~ continues to confer with MADOLE about new issues of the National Renaissance Bulletin, ~~official~~ National Renaissance Party publication. According to the informant, FREEDMAN is anxious to maintain his contact with MADOLE in order to use this publication as a vehicle for his views and propaganda. N.Y.

The informant said that apparently MADOLE continues to get large amounts of Arab literature from the Arab Information Center, New York City.

T-1 stated on November 6, 1956, that a meeting of the National Renaissance Party was held at Nola Studios, New York City, on November 2, 1956. He stated that MADOLE was the principal speaker and spoke against England and Israel and in favor of Egypt.

T-1 indicated on October 23, 1956, that MADOLE indicated he had ordered 500 reprints of the National Renaissance bulletin and indicated that this issue had already brought a profit of \$125.

T-1 indicated on October 23, 1956, that MADOLE N.Y. stated he had been approached by a member of the Nationalist Party, with an offer to rent the front half of the headquarters occupied by the Nationalist Party. He indicated MADOLE could use the front half of this store and MADOLE believed it would be a good opportunity for him to display the Arab literature which the National Renaissance Party is now distributing. b6

T-1 indicated on November 19, 1956, that the September-October, 1956, issue of the National Renaissance bulletin contained an article entitled "The Hidden Facts Behind the Zionist Invasion of Egypt", by JAMES A. MADOLE. He stated this article was anti-Jewish and this bulletin also contained advertisements for several Egyptian leaflets. He stated that this bulletin was prepared by MADOLE with

the help and advice of BENJAMIN FREEDMAN who also gave MADOLE \$90 for the cost of this publication. He stated that MADOLE and FREEDMAN are already preparing another bulletin concerning the Egyptian situation which will be published in the near future.

T-1 indicated on November 2, 1956, that MADOLE had stated that he has earned more than \$400 this year selling Egyptian literature which he has received free of charge and then has sold for a small fee. He indicated that this Egyptian literature has been distributed by MADOLE after he has placed the rubber stamp of the National Renaissance Party upon it. He indicated the two most recent pamphlets were a 23 page booklet entitled "Peace and War" and a 20 page booklet entitled "Threats and Intimidation".

T-1 indicated on July 9, 1956, that the last page of the May, 1956, issue of the National Renaissance Bulletin had again advertised a list of literature which MADOLE had obtained from the Egyptian Information Office at 900 Park Avenue, New York City. MADOLE reportedly has obtained large quantities of Arab and Egyptian literature from the Egyptian Delegation to the UN, 900 Park Ave. and from the Palestine-Arab Refugee Office, 801 Second Ave., NYC. MADOLE has stamped this literature with the National Renaissance Party name and has distributed it through Party channels. This literature is either sold by MADOLE for a small amount of money which he has utilized to operate the National Renaissance Party or has offered this literature free to subscribers of the National Renaissance Bulletin, official NRP publication.

The WFO should check the Foreign Agents Registration records, Department of Justice to determine if JAMES H. MADOLE of the National Renaissance Party is registered. DETAILS:

T-1, who has furnished reliable information in the past, furnished the following information which he received from a source whom he termed reliable but whose identity he declined to disclose.

He stated on March 13, 1957, that JAMES MADOLE continues to reside at 10 West 90th Street, New York City, and remains leader of the National Renaissance Party (NRP).

He added that the subject held a brief informal meeting of the NRP at his apartment on March 7, 1957.

T-1 stated that MADOLE had recently obtained a large number of the February, 1957 issue of "Scribe" from the Egyptian Consulate, 900 Park Avenue, New York City. This is a monthly magazine published by the Center for Middle East Research, Cairo, Egypt.

T-1 added that MADOLE stamped this magazine with the stamp of the NRP, 10 West 90th Street, New York City, and has distributed it through the facilities of the NRP.

He added that MADOLE also continues to visit the Syrian and Arab delegations in New York City where he obtains literature which is also distributed with the stamp of the NRP upon it.

T-1 indicated on May 9, 1956, that the NRP at present is a neo-Nazi, anti-Semitic, anti-Negro organization with activities generally confined to the New York area. He said that its principal activities consist of holding outdoor meetings and the distribution of literature throughout the United States and abroad where it is reprinted by similar organizations.

This source stated that the National Renaissance Party leader and founder is JAMES H. MADOLE and its principal financial contributor is FREDERICK WEISS. He said that at present the party membership is very small. The April, 1955, "National Renaissance Bulletin", official NRP publication listed headquarters at 10 West 90th Street, New York City.

The National Renaissance Party was the subject of a preliminary report on neo-Fascist and Hate Groups published by the House Committee on Un-American Activities on December 17, 1954, which stated that this neo-Fascist group's activities are clearly subversive and un-American.

T-1 indicated on March 1, 1957, that MADOLE had held an informal party meeting at his residence on the evening of February 21, 1957, which was attended by about eight persons.

He stated that nothing of importance transpired during this meeting and no explanation was forthcoming from MADOLE as to why the public meeting of the NRP, previously mentioned by MADOLE for February 22, 1957, was not being held.

T-1 added there was nothing mentioned of plans for future public meetings of the party.

T-1 indicated on February 15, 1957, that MADOLE held a meeting of the NRP at his apartment on February 14, 1957, which was attended by about six persons.

T-1 stated that MADOLE had a quantity of new Arab literature which he had obtained including pamphlets entitled "The Kafr-Kassem Massacre" and "Murder, Rape and Devastation" which were printed by the Egyptian State Information Office and which had been stamped with the name of the NRP.

T-1 indicated on February 1, 1957, that MADOLE had obtained 500 copies of the December, 1956 "National Renaissance Bulletin", which had been printed by CONDE MC GINLEY, editor of "Common Sense."

He indicated that this bulletin offered new subscribers to the bulletin a free copy of a 250 page booklet entitled, "Suez Canal, Facts and Documents."

T-1 stated that MADOLE had obtained this item free of charge at the Egyptian Delegation, 900 Park Avenue, New York City.

T-1 added that the two most recent Arab pamphlets that MADOLE has distributed under the stamp of the NRP are entitled, "The Palestine Problem", a memo submitted to the Secretary General of the United Nations (UN) in its 11th Session by the Executive Bureau of the World Muslim Congress, Jerusalem, and the "Scribe" for January, 1957, which contained pictures showing destruction of civilian property in Port Said allegedly perpetrated by the British Army.

This particular copy of the "Scribe" contained a printed notation "not for sale" and T-1 stated that MADOLE would not attempt to sell this bulletin but would distribute it free of charge to subscribers of the "National Renaissance Bulletin."

A Special Agent of the FBI observed JAMES MADOLE leaving the building at 271 Madison Avenue at 5:00 PM on January 11, 1957, and on March 12, 1957.

T-1 added that MADOLE continues to hold informal meetings of the NRP on Thursday evenings at his apartment and that such a meeting was held on January 3, 1957, which was attended by only two other persons.

He added that another meeting was held on January 10, 1957, which was attended by about five persons.

T-1 added that an individual named [redacted] had recently visited MADOLE and indicated to him that he is interested in Arab literature and asked MADOLE to take him from the Egyptian Office in order to get some money from the Egyptians. *M.H.*

T-1 indicated that [redacted] also has reportedly suggested that MADOLE rent a store where he could sell books and literature and stated that he, [redacted] would help MADOLE with some money to run this store.

T-1 added that MADOLE believes this individual, [redacted] and has probably been sent to infiltrate the NRP by JAMES SHELDON, head of the Anti-Nazi League in New York City. *M.H.*

T-1 said that although MADOLE believes this, he will continue to meet with [redacted] and will accept any aid which [redacted] is willing to furnish to the NRP.

T-2, who is in a position to furnish reliable information, was contacted on February 5, 1957, by SA JAMES P. MARTIN.

[redacted] Foreign Agents Registration Section, Department of Justice, Washington, D.C., advised on February 20, 1957, that neither JAMES MADOLE nor the National Renaissance Party is registered as an agent of a Foreign principal.

She also advised that there was no registration of MADOLE or the NRP as a propaganda agent of any foreign principal.

T-3, who has furnished reliable information in the past, indicated on March 21, 1957, that JAMES MADOLE continues to reside at 10 West 90th Street, Apartment 8, New York City, with his mother, Mrs. GRACE MADOLE.

T-3 stated that in recent weeks there appeared to be a great many people visiting the MADOLE apartment and that MADOLE presumably is holding meetings of the NRP at this apartment quite frequently.

[redacted] Police Department, Davenport, Iowa, advised the Omaha Office on March 16, 1954, that after interviewing [redacted] had given every evidence of being a zealot who is obsessed with the idea of anti-Semitism and who he considers to be a "tough political organizer" for anti-Semitism, who had obviously been coached in how to avoid answering questions put to him by law enforcement officers.

[redacted] a fellow student of [redacted] at the Palmer School of Chiropractic, advised the Omaha Office in March, 1954, that he knew [redacted] well and that he had frequently heard [redacted] state that he is "with the anti-Semitic" movement and it is the purpose of this movement to get control of the United States Government and then to deport all Jews and Negroes, as they are responsible for the spread of communism in the United States.

War Department Headquarters, 2nd Service Command, Governor's Island, New York, by letter dated January 25, 1943, indicated that [redacted] attended meetings of the Christian Mobilizers of the German-American Bund, particularly at Ebling's Casino in the Bronx, New York.

This letter indicated that subject was close to [redacted] acquainted with [redacted] German-American Bund and closely identified with EDWARD JAMES SMYTHE, then under indictment for charges of sedition. NY

The German-American Bund has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

[Redacted] contacted James H. Madole, Head of the National Renaissance Party, New York City, on December 19, 1956.

T-2, who has furnished reliable information in the past, indicated on May 9, 1956, that the National Renaissance Party at present is a Neo-Nazi, Anti-Semitic, Anti-Negro organization with activities generally confined to the New York area. He said that its principle activities consist of holding outdoor meetings and the distribution of literature throughout the United States and abroad, where it is reprinted by similar organizations.

This source stated that the National Renaissance Party's leader and founder is James H. Madole and its principle contributor is Frederick Weiss. He said that at present the Party membership is very small. The April, 1955 "National Renaissance Bulletin", official National Renaissance Party publication, listed headquarters at 10 West 90th Street, New York City.

The National Renaissance Party was the subject of a preliminary report on Neo-Fascist and hate groups published by the House Committee on Un-American Activities on December 17, 1954, which stated that this Neo-Fascist group's activities are clearly subversive and un-American.

[Redacted] Ford Motor Company, Aircraft Engine Division, 7401 South Cicero, Chicago, Illinois, advised that [Redacted] Social Security No. [Redacted] has been employed here since December 20, 1956, as an electrician and does not have access to classified information.

MADOLE was warned by Egyptian officials to be careful and not to bring or send JOSEPH RUDDEN to them for literature. An informant indicates he believes MADOLE definitely an agent of the Arab nations because of the large amount of their literature he is handling and his frequent contacts of Arab officials.]

T-1, who has furnished reliable information in the past, furnished the following information which he received from a source whom he termed reliable, but whose identity he declined to disclose.

He stated that on March 20, 1957, a meeting of the National Renaissance Party (NRP) was held on March 14, 1957, at the residence of JAMES MADOLE, 10 West 90th Street, New York City. He said that MADOLE had the latest Arab literature from the Egyptian Consulate, 90 Park Avenue, New York City, which was stamped with the name of the NRP, 10 West 90th Street, New York City. This literature included "Statement By The Egyptian Government On The Anglo-French-Israeli Aggression" printed by the Egyptian Information Department and "A Decade of Defiance" printed by the Egyptian Embassy, Washington, D.C. (C) (u)

T-1 indicated on March 20, 1957, that MADOLE had stated sometime ago that he was approached by [redacted] of the Syrian Consulate in New York City, and [redacted] United Nations from [redacted] about writing an article in the "National Renaissance Bulletin" in which he would attack Mayor ROBERT WAGNER'S snub of King SAUD. However, now MADOLE states that he will not do this article. He indicated that if he would do an article for these people that they would give him a list of people to send it to who would contribute to the NRP. (C) (u)

MADOLE further stated that he now has a list of Algerians and has been in touch with [redacted] who is connected with the Algerians, but that the Algerians have no money. (C) (u)

T-1 added that [redacted] was scheduled to speak at a NRP meeting about a year ago, but canceled this engagement by saying that he had to leave town at that time.

T-1 indicated on March 13, 1957, that a NRP meeting was held at the apartment of JAMES MADOLE, 10 West 90th Street, New York City, on [redacted]. He added that MADOLE had the February, 1957, issue of the "Scribe," which was stamped with the NRP stamp. [This is a monthly magazine published by the Centre For Middle East Research, Cairo, Egypt, and T-1 said MADOLE had obtained a large number of these from the Egyptian Consulate which he is distributing through the NRP.] (S)(u) b7D

T-1 added that MADOLE continues to visit the Syrian and Arab delegations in New York City where he obtains literature which he distributes through the NRP with the NRP stamp on it. (S)(u)

T-1 indicated on April 5, 1957, that FREDERICK WEISS, the former financial backer of the NRP, had indicated that he is angry with MADOLE because MADOLE refuses to cooperate with him. WEISS indicated that he is thinking of writing an article on MADOLE to the effect that MADOLE has been regularly receiving money from an agent of a Jewish organization. T-1 indicated that the agent referred to by WEISS is [redacted] the Anti-Defamation League in New York City. NY (S)(u) b6 b7C

T-1 added that this is a laughable situation because WEISS himself has been working with this agent for a long period of time.

T-1 indicated on April 5, 1957, that a meeting of the NRP was held on [redacted], at the apartment of MADOLE. [He stated that MADOLE had a large pile of Arab literature which had been rubber stamped with the name of the NRP and it appears that MADOLE is doing a brisk business with the Arabs.] (S)(u) b7D

T-1 indicated a recent pamphlet which MADOLE was distributing through NRP channels is entitled, "Statement By Dr. IZZAT TANNOUS on the Palestine-Arab Refugees Before the United Nations Special Political Committee," dated February 20, 1957, and published by the Palestine-Arab Refugee Office, 801 Second Avenue, New York City.

T-1 indicated on April 29, 1957, that MADOLE recently indicated that he had distributed Arab literature on the evening of April 5, 1957, in the vicinity of East 86th Street, with about five other boys. MADOLE indicated that "the Jews came along and then they called the cops." MADOLE said that a policeman refused to arrest him, saying that there was no law against distributing literature. MADOLE indicated that they had distributed about 500 pieces of literature. MADOLE further indicated that about three months ago "Columbia came here and took pictures of me and I was interviewed for my views upon the Puerto Ricans here in New York City."

T-1 said he believes this was CBS Television and MADOLE indicated that although they stated they would televise it, he had heard nothing about it since that time and he would be happy if it were not shown on television, stating "the Jews sent them in trying to show me up."

MADOLE further indicated that he is running out of Egyptian literature and can no longer trust JOSEPH RUDDEN to go to the Egyptian office to obtain it for him. He said that in a short while his vacation will begin and he intends making several visits himself for additional literature. He added that the Egyptians had arranged for him to get literature in the office of the Algerians at 150 East 56th Street, New York City. ~~(u)~~ ^{7/4}

T-1 indicated on May 8, 1957, that the television program on which MADOLE'S interview was supposed to be used was shown on May 5, 1957, on CBS television in a program by EDWARD R. MURROW concerning the Puerto Rican problem. However, MADOLE'S interview was not utilized, probably because it was highly critical of the Puerto Ricans in New York City and this program showed only favorable comments concerning the Puerto Ricans.

T-1 indicated on May 17, 1957, that a meeting of the NRP was held at MADOLE'S apartment on May 2, 1957, and MADOLE stated that he and four other persons had distributed ~~(u)~~

Arab literature on East 86th Street on April 27, 1957, and had encountered no interference. He said MADOLE had the latest Arab pamphlets which were printed in Cairo, sent to the Egyptian Embassy in Washington, D.C., and then given to the Syrian Office in New York City, where MADOLE obtained them. These pamphlets were entitled, "Jews are a Religious Community, Not a Nation," "Jews Fight Religion," and "The Arabs of Israel." (S)(u)

T-1 further indicated that a meeting of the NRP was held at the subject's apartment on May 9, 1957, and MADOLE had stated he visited the Arab Office for new literature, but was not successful in getting any as they are waiting for new shipments. (S)(u)

MADOLE said the Egyptians told him not to bring or send JOSEPH RUDDEN to them for literature and they also warned MADOLE to be careful. (S)(u)

T-1 added that the New York "Journal American" of May 10, 1957, in a column by LOUIS SOBOL stated that a rabble-rouser who is an undercover agent for Egypt has not registered with the State Department. T-1 added that MADOLE later stated that they were probably referring to him.

T-1 stated on May 21, 1957, that MADOLE is now on vacation from his job and MADOLE said he would make the rounds of the Arab establishments to obtain new literature. MADOLE said he would visit the Syrian Delegation and the Egyptian Delegation on May 22, 1957, and expected to obtain a large amount of literature. (S)(u)

T-1 indicated on September 27, 1957, that JAMES MADOLE continues to reside at 10 West 90th Street, New York City, with his mother, GRACE MADOLE. He stated that MADOLE continues as National Leader of the National Renaissance Party (NRP) and continues to operate the NRP from his apartment. He stated that MADOLE continually receives quantities of Arab literature from various Arab officials in New York City, which he stamps with the NRP name and distributes through NRP channels. T-1 stated that he has received no information which indicated that MADOLE is being paid by any foreign principal for his work in the distribution of this Arab literature. He further stated that he knows of no individual who is able to direct or control any of MADOLE's activities in his work in the NRP or with his distribution of literature.

[redacted] advised on July 31, 1957, that radio station WCBS had carried a program on July 29, 1957, which contained an address by JAMES MADOLE, delivered in behalf of the NRP. [redacted] stated that from statements made by MADOLE, he believed the NRP had for one of its aims the overthrow of the present form of government in this country. He advised that MADOLE outlined the objective of the organization as being "economic, judicial and cultural." He said that among the changes proposed by MADOLE were the abolition of free elections, the placing of prominent Americans, such as DOUGLAS McARTHUR, in office, and the deportation of Negroes and Puerto Ricans to their country of origin.

MADOLE further stated he is preparing a new National Renaissance Bulletin which will be ready for mailing in a few days.

T-1 said MADOLE had originally planned to devote this issue on an attack upon the American Legion but was apparently moved to making this issue to deal with segregation. T-1 said he was not able to learn whether the decision to change to writing on segregation was MADOLE's decision alone or whether he had been influenced. However, MADOLE appears to be taking advantage of the great notoriety on segregation caused by the Little Rock incident and he hopes to obtain new subscriptions to his bulletin and contributions by exploiting this present publicity.

T-1 indicated on October 24, 1957, that subject had been in bed with asthma and the flu for several days. He said that GRACE MADOLE, the subject's mother, indicated she was arranging for an ambulance to take the subject to the hospital, because it is usually necessary to place him in an oxygen tent when these asthma attacks occur as they have in the past. T-1 indicated on October 25, 1957, that the subject was taken from his home by ambulance to St. Luke's Hospital, 113th Street and Amsterdam Avenue, at 10:30 PM on October 24, 1957, and is presently in Room 119. My son, who died in Korea was Lt. Lee R. Hartell died Aug. 27, 1951.

The enclosure submitted by correspondent was a clipping from the "Danbury News-Times," Danbury, Connecticut, dated September 12, 1957. This was a letter to the editor by correspondent and was written in the form of an open letter to Governor Faubus of Arkansas criticizing him on his action in excluding Negro children from public schools.

Based upon the information furnished by correspondent, the Bureau is unable to identify "Adole" who the correspondent states is out to overthrow the Government. If this individual actually made the statements on television as alleged by correspondent, it is very probable that such information has been previously brought to your attention. You should identify the individual referred to by the correspondent and advise the Bureau of his identity and the statements made by him. While it does not appear that correspondent possesses any additional identifying information concerning this individual, the Bureau has no objection to contacting her if it appears necessary. The Bureau should be promptly advised of the identity of "Adole." Your communication should be submitted under appropriate caption, making reference to this communication. Upon identification of "Adole," you should, thereafter, be guided by current Bureau instructions concerning security investigations of individuals.

NOTE ON YELLOW:

ELITE
Correspondent states that one Adole recently appeared on a television program and openly admitted his group was out to overthrow the Government. "Adole" also allegedly admitted his prejudice toward Jews and Negroes. Correspondent states her son, Lieutenant Lee R. Hartell, was posthumously awarded the Congressional Medal of Honor for action in Korea in 1951. Bufiles contain no identifiable data concerning this individual. *USA*

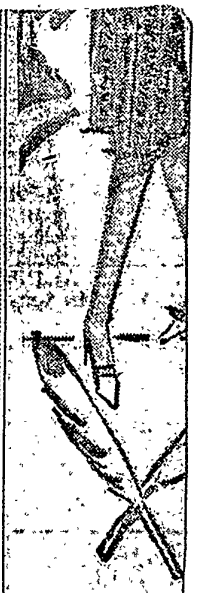

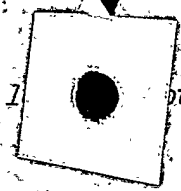

He indicated that he assumed this position several months ago, and he is acquainted with the subject, but has not observed anything unusual about his activities. He stated that MADOLE has numerous visitors, but to date, he has not received any complaints from other tenants, concerning any activities in the MADOLE apartment. He added that Mrs. GRACE MADOLE resides in the apartment with JAMES MADOLE.

T-1 stated on February 14, 1958, that JAMES MADOLE continues to reside at 10 West 90th Street with his mother, GRACE MADOLE, and maintains headquarters of the National Renaissance Party (NRP), in his apartment. He stated that informal meetings of the Party are held weekly in the subject's apartment.

T-1 advised on January 13, 1958, that MADOLE had attended a meeting on January 10, 1958, at Pythian Hall, West 70th Street, New York City, sponsored by "The Truth Seeker," an Atheist group, headed by CHARLES SMITH.

T-1 indicated MADOLE was accompanied by about 15 of his boys and had indicated to his followers that he has no intention of trying to take over SMITH's group, but he hopes to speak regularly at SMITH's meetings, thereby, saving himself the trouble and expense of organizing public meetings of his own.

T-1 said MADOLE spoke at this meeting, along anti-Semitic lines, and that SMITH, who is quite elderly and in ill health, attended the meeting but did not speak.

T-2 indicated on January 10, 1958, that

T-2 said that MADOLE had indicated he is thinking of taking over a group which was headed by a man named SMITH, which group would hold a meeting on January 10, 1958, and MADOLE urged all of his followers to attend.

T-2 stated on January 20, 1958, that he had attended a meeting at Pythian Hall, on January 10, 1958, which was attended by about 35 persons, including about 12 of MADOLE's followers. He said MADOLE spoke at this meeting, along his usual anti-Semitic lines, but had made no further comment about taking over this group, headed by SMITH. T-2 said MADOLE had requested his followers to attend a debate to be held on January 23, 1958, at Hunter College.

JAMES MADOLE was observed by SAS of the Federal Bureau of Investigation (FBI), leaving his residence at 10 West 90th Street, with 5 other persons, and proceeding to Pythian Hall, West 70th Street, New York City, which he was observed to enter.

T-2 indicated on January 24, 1958, that MADOLE and several of his followers had attended a debate held at Hunter College, on January 23, 1958.

T-1 indicated on January 20, 1958, that MADOLE had finished the January, 1958, "National Renaissance Bulletin", consisting of one article entitled, "Zionism, the Jewish Colossus Which Dominates the Western World", by JAMES H. MADOLE.

T-1 said MADOLE indicated the proof copy would go to CONDEY MC GINLEY, on January 20, 1958, to be mimeographed at the offices of "Common Sense", in Union, New Jersey. T-1 said that this article refers to the recent Afro-Asian Conference held in Cairo, as being the condemnation of the Western support of Israel, the Baghdad Pact, and the Eisenhower Doctrine.

MADOLE indicated in the article that the Jewish race constitutes a world-wide network of subversive aliens who, by their action, are driving more than one billion Afro-Asians into the Soviet orbit. MADOLE calls President EISENHOWER a fawning tool of organized Zionism, and indicated that "IKE" helped Zionism during World War III.

MADOLE questions why the United States should consider relations with the Soviet Union objectionable when, during World War II, America had no misgivings about collaborating with Russia. He further stated that the Soviet Russian Government has become anti-Zionist since the termination of World War II, whereas America has become a virtual slave of Jewish ambitions.

T-1 indicated on January 17, 1958, that MADOLE recently had made the rounds of the Arab establishments in New York City, and had obtained the following literature, which he rubber stamped with the name of the NRP, and which he will presumably distribute through NRP channels:

1. "Strife in the Holy Land", an article of 22 pages, in May, 1957, of the Arab League.
2. "Notes on the Suez Canal Controversy", a November, 1956, booklet of the Arab League, containing 18 pages by Doctor FAYEZ A. SAYEGH.
3. "The Aspirations of the People of North Africa", a reprint from a July, 1956, magazine consisting of 16 pages by MUHAMMAD H. el FARRA.
4. "Statement Before the Special Political Committee of the United Nations", by Doctor IZZAT TANNOUS, Director of the Palestine Arab Refugee Office, New York City, dated November 28, 1957.

T-1 indicated on February 4, 1958, that a mass meeting had been held on January 26, 1958, at the headquarters of "Common Sense", in Union, New Jersey. He stated that MADOLE had attended with about 8 members of the NRP, and that MADOLE was the first speaker at this meeting, and went on for about 15 minutes with the usual NRP line.

MADOLE stated that "the white race would rule, and that the Jew is our enemy." He also stated that the Mexicans, Puerto Ricans, and other prototypes in South America and Asia, would have to accept the inevitable or they would be exterminated.

MADOLE further stated that "we will have to seize power, show no weakness and no pity."

T-1 added that [REDACTED]

[REDACTED] MADOLE stated that the NRP stands for the "corporate state and the rule of the white race." MADOLE attacked Christianity as being a total myth, and praised the Vikings, Romans, and Germany under HITLER, and he predicted that in order to survive, we will have to conjure another HITLER and having learned from the past by our mistakes and weaknesses, he indicated that "we will win this time."

MADOLE stated that "Communism and Zionism are polluting the white race and the world doesn't need Jews, Puerto Ricans, and all that scum, which is slowly weakening the white race."

T-2 indicated on January 27, 1958, that he had attended the meeting of [REDACTED] at [REDACTED]

on [REDACTED] He stated along with other members of the NRP. T-2 stated that MADOLE spoke briefly at this meeting, along his usual NRP line of anti-Semitism.

APPENDIX

COMMON SENSE

It is noted that "Common Sense" published by the Educational Association of Union, New Jersey, was characterized in a report issued on December 17, 1954, by the Committee on Un-American Activities of the United States House of Representatives as a "hate group" vehicle publishing "some of the most vitriolic hate propaganda ever to come to the attention of the Committee." According to the report, "Common Sense" depicts Communism as "Judaism", and devotes its pages almost exclusively to attacks on the Jewish, to a lesser extent, the Negro minorities in our nation. Sympathy for the former Nazi regime in Germany is also injected into this propaganda.

NATIONAL RENAISSANCE PARTY

On April 29, 1957, a confidential source stated that the NRP is an anti-Semitic, anti-Negro, neo-Fascist organization with activities generally confined to the New York area. He indicated that JAMES MADOLE, founder and leader of the Party, is the only person who consistently performs Party functions. He stated the Party's main function is the printing and distribution of the "National Renaissance Bulletin" on a monthly basis and other literature from time to time, which is distributed throughout the United States and abroad where it is reprinted by similar organizations.

He stated that the NRP recently has distributed large quantities of Arab literature after stamping it with the name of the NRP and that finance for the Party's operation is partly obtained in this manner.

Both the Catholic and Protestant denominations of Christianity are universalist religions seeking to embrace all mankind within the tentacles of their religious embrace. Clerical dogma is based on "miracles" unexplainable mysteries and supernatural manifestations which obviously have no place in the Twentieth Century world. The following idiocy appeared in the "NEW YORK TIMES" of November 11, 1957 under the title: "A PATRON SAINT HINTED FOR TRAVELERS IN SPACE":

"Authorities of the Roman Catholic Church are informally considering selection of a patron saint for space travelers, a Vatican official said today. It was believed that the most likely patron would be St. Joseph of Copertino, a seventeenth century Italian Franciscan friar. According to tradition, he floated in the air during religious ecstasies. In Italy, he is also considered a patron saint of students."

Perhaps a tribe of South Sea Islanders or the 10,000,000 recently converted African hottentots could swallow this gibberish considering their previous vast experience with "evil spirits" and tribal witch doctors but to seek to ram this idiocy down the gullets of educated Americans and Europeans is beyond human comprehension. Perhaps it will awaken Christians to the undermining of all racial barriers by the clergy when we now discuss the statement issued by the official Vatican newspaper, "OSSERVATORE ROMANO" on September 7, 1957. We quote from the N.Y. DAILY NEWS, page 3, entitled "BLAST FAUBUS IN VATICAN PAPER":

"The semi-official Vatican newspaper "OSSERVATORE ROMANO" today blasted Arkansas Governor Orval Faubus for not letting Negro students go to the same school as whites. It declared such men should be stripped of their political rights. The paper noted that President Eisenhower has declared that he will not permit violation of the Constitution, and suggested:

"The remedy is this: anyone who professes racist principles, or who defends them under no matter what pretext, should not be admitted to exercise any political rights and even less should be eligible for public office—the same as is done in the case of persons who have committed grave crimes. Because this is the gravest crime of all." The Osservatore said it was especially saddening to see such a thing happening in the United States, "the nation that has taken part in the greatest wars and made heavy sacrifices in the name of liberty and democracy and against racism."

We now quote the "NEW YORK HERALD TRIBUNE" of September 7, 1957 entitled, "U.S. RACISTS DENOUNCED BY VATICAN": "The Vatican daily newspaper "OSSERVATORE ROMANO" declared today that racial hatred was crime and known racists should be barred from holding public office in the United States "just as are major criminals." The paper said recent events in the Southern United States were "inexcusable from any point of view whatever." It deplored the fact that "such excesses, which neither sentiments of humanity, patriotism nor democracy have been able to extinguish, have been able to spring up in the middle of the twentieth century." "It should be made illegal (for racists) to hold any public position, as now provided for in the case of major criminals," the editorial said."

This official stand of the Vatican authorities forces Catholics in America and Europe to either accept the breaking down of all barriers between the white and colored races or face possible excommunication from the Roman Catholic Church for seeking to resist these edicts from Rome. The clerical authorities are seeking to interfere with the Apartheid Law in South Africa by defying the government and ORDERING SOUTH AFRICAN CITIZENS OF THE CATHOLIC FAITH TO DISOBEY THE LAWS OF THE COUNTRY BY ATTENDING INTER-RACIAL RELIGIOUS SERVICES. We quote from "THE CATHOLIC WORKER", page 3, September, 1957 issue entitled, "BISHOPS DEFY LAW ON MIXED CHURCHES":

"The Catholic bishops of South Africa have defied that country's new church segregation law by ordering that "Catholic churches must and shall remain open to all without regard to their racial origin. In a declaration read at all Sunday Masses throughout the nation, the 25 bishops said that they alone have the power "to decide on admittance of persons to Catholic places of worship," and that they therefore "take full responsibility" for maintaining interracial churches. The new declaration by the bishops came less than a fortnight after publication of their joint statement condemning apartheid, the government's official policy of race discrimination, as an "intrinsic evil" and a "mockery of Christianity."

"Meanwhile, Archbishop Denis E. Hurley, O.M.I., of Durban, told the Durban press it was clear at the recent plenary conference of the Bishops in Pretoria that South Africa's Church leaders envision ultimate racial integration in all Catholic institutions in the country. The Archbishop, who was elected chairman of the African Affairs Department of the South African Bishops' Conference at the Pretoria meeting, was quoted as saying: "The Church is steadfastly opposed to segregation in the schools and in any other institutions. However, it does realize THAT IT WOULD BE TOO MUCH OF A PSYCHOLOGICAL SHOCK TO SPRING INTEGRATION ON THEM SUDDENLY."

"Senator Verwoerd (a member of the South African Parliament) noted at the time that the bill makes it an offense for a Native, not the clergy, to violate a ban under the church clause. He said, however, that any clergyman who incited Natives to break the law would be dealt with under laws previously in existence. In such cases, he said, persons could be charged, convicted and punished just as they would be for violating any other law, such as marrying people without a license."

Both the Catholic and Protestant hierarchies are more concerned with QUANTITY than with QUALITY. Through their missions and parishes in Africa they are seeking to convert the prolific hordes of illiterate, semi-savages who dwell in

these backward areas of the world to their respective brands of Christian dogma. Because the Negroes, Asiatics and Puerto Ricans are both more numerous and far less educated than their White "brothers in Christ", both churches have found a fertile harvest for their clerical mysticism. Just as the Jew seeks to break down all racial barriers in order to break the resistance of the White race to his complete economic and political domination of Europe and America; so the Christian hierarchies seek the same objective for the purpose of bringing all mankind under their spiritual domination. The Vatican seeks to force inter-racial brotherhood on mankind in order to lower the standards of literacy and economic development to the level of Medieval society when all sources of learning were in the hands of Holy Mother Church and heretics, including all scientific authorities whose findings were at variance with clerical dogma, screamed out their final death agonies on the torture racks of the Holy Inquisition or were slowly burned alive to insure the salvation of their "immortal souls". All economies were of a strictly agrarian nature during this unfortunate period because the clerical authorities well knew that landless peasants, whose entire life consists of back-breaking labor, have little or no time for self-education and must, of necessity, look to "the life hereafter" as their only hope for respite from endless drudgery. The French, Polish, Austrian and Spanish peasants were held firmly under the clerical yoke during the Dark Ages and even today most of the valuable property in the Latin countries as well as Austria is in the hands of various clerical orders which pay no property taxes.

The Jews are supposed to be the mortal enemies of Christianity yet we find their vicious leftist pressure groups working in close harmony with clerical authorities both here and abroad. Why is this so? The Catholic Church has published its views on the race question and anti-Semitism for UNESCO in a 62 page booklet entitled "THE CATHOLIC CHURCH AND THE RACE QUESTION" by the Rev. Father Yves M.J. Congar, O.P. of the Dominican Order. THIS OFFICIAL HANDBOOK HAS RECEIVED THE PAPAL IMPRIMATUR which makes it the official view of the Vatican authorities. We find the following statement on page 22:

"Any form of racism—not only absolute, systematized racism, but also pragmatic and comparatively moderate racism—has disastrous consequences running counter both to the spirit and the letter of Christianity."

We find that the Roman Catholic hierarchy considers that it owes its spiritual doctrine to the early Jews, who allegedly had a covenant with God which made them "God's Chosen People". The Vatican believes that HOLY MOTHER CHURCH is the new "ISRAEL" and that the Jews must now be converted to the New Israel. We quote from page 23 of Rev. Father Congar's book:

"Even more clearly, therefore, we cannot hope to reach and preserve the very heart of Christianity unless we respect what it has inherited from its Jewish forerunners, and hence, unless we treat the remnants of unbelieving Israel (the Jews), which are to be found among all the other peoples, as the fragments of a broken vessel which the highest gifts of our race owe to us. (It notes: The Jews have given us the gifts of nature, the revolutionary agitation which led to the bloody French and Russian revolutions and interest-slavery. Did these gifts also come from God?)"

"...the purpose of God is to unite all men in a single brotherhood..."

The Rev. Father Congar then proceeds to make clear how young children, through religious instruction, can be seduced into glorifying the Jewish race and the new Israel, the Roman Catholic Church. On page 16 we find:

"Thus in the realm of the immortal soul—the pre-eminent, though not the most tangible realm—men have the same vocation and the same essential history. From the earthly point of view I might of course say (at least up to a point): "What have I in common with the Laplanders or the Fuegians? My history is not theirs, nor is their history mine." It is clearly somewhat ridiculous to give Indo-Chinese children French textbooks where they will read, for instance: "Our ancestors the Gauls" But WE CAN ALWAYS GIVE THEM THE BIBLE AND MAKE THEM SAY LIKE GERMAN CHILDREN, "OUR FATHER ABRAHAM". For, as Pius XI most truly said, "spiritually we are Semites"; Abraham is our father, (ED. NOTE: Abraham was, according to the dubious record of the Old Testament, a fine old Jewish whore-master. In the Bible he is called the Father of Mankind.) because he was the first to be "Called" and the first believer. We all have a common history which began with Abraham and is centered on Jesus Christ."

The Rev. Father Congar then proceeds to falsify all the facts of history, science and ordinary common sense in regard to the Negro Question. We quote from page 49 of his book:

"Thus American Catholics still have far to travel in a sphere in which their honour as Christians, far more even than their honour as democrats, is involved. The Catholic Inter-Racial Council, an association directed by Father La Farge, S.J., publishes a monthly organ entitled "INTER-RACIAL REVIEW, A JOURNAL FOR CHRISTIAN DEMOCRACY". This takes its stand on the concept of the absolute unity of the Mystical Body (the Roman Catholic Church) and of liturgical worship. It should be added that the clergy are unanimous in sharing these views... Father J.E. Coogan, S.J. writes that discrimination against Negroes in schools and churches is condemned by theologians as "unjust, impious and scandalous". A moralist, J.F. Doherty, writes that there may perhaps be grounds for taking racial differences into account in the case of a proposed marriage. If, however, after due consideration, a person wishes to marry someone of a different race, no law can justly forbid it, and any law doing so would be an unjust law, not binding, therefore, upon the conscience."

"To all this evidence, of which an infinity of other examples could easily be found, should be added the full text of the letter sent in March, 1952 by Msgr. R. Varin de la Bruneliere, Bishop of Fort-de-France (Martinique) to West Indian students resident in France. The bishop goes beyond the mere rejection of race prejudice; he stresses the special qualities of Negroes, and their positive contribution to civilization and to the countries of which they are citizens. "We have the history of the American Negro to prove the aptitudes of a race... Despite... all these obstacles, the Negro population of America has advanced in all fields. (His wife) they have the highest crime rate and the highest percentage of venereal disease of any single racial group in the U.S.) and today our Negroes hold enviable positions in the arts, science or industry. It may not be generally known that at the present time American Negroes are running 15 banks, 20 insurance companies, 15 trading enterprises and 200 insurance companies. They own 1000-2000 newspapers and periodicals and possess 5,000,000 shares of stock in the leading corporations of the country."

The challenge in Northern cities, Father stated, is the changing neighborhoods. Today there are no stable interracial communities. I think Friendship House can make a valuable contribution toward solving this key problem. "We are anxious," Father explained, "to broaden and deepen our work—to help other old friends, and new friends, too, find ways of destroying the bars that segregation has placed between members (and potential members) of Christ's Mystical Body (the Roman Church). Friendship House has also held many workshops for white groups in past years—offering experience in being part of an interracial group... Looking beyond Chicago, Father pointed out that Friendship House can also offer a unique opportunity to train young workers and students from other areas. A period of work and study at Friendship House can prepare them for work in the apostolate of race relations in their own communities."

Thus we find the Roman Catholic Church concerned solely with breaking down all racial barriers between members of her "spiritual community. In doing so this clerical institution becomes a Trojan Horse or a dangerous Fifth Column in the ranks of the white racial community. Any organization which demands that its members work toward the breaking down of all racial barriers between the white and colored races and which teaches young children that they are the descendants of disreputable ancient Jews has NO PLACE IN A RACIAL NATIONALIST STATE OR COMMUNITY. American Catholics must either heed the edicts of the Roman Pope or face spiritual excommunication. The documentation in this Bulletin can be checked by anyone. American Catholics must either join with the Jews and the Vatican in seeking the destruction of white civilization or work with the NRP against ALL THE ENEMIES OF AMERICA AND WESTERN CULTURE. If you still doubt the danger of racial intermingling fostered by Catholic and Jewish interracial societies like Friendship House study the following article from the "NY DAILY NEWS" of November 11, 1957 entitled "COUPLE, 17, jailed on SEX CHARGES":

"A 17 year old high school couple has been given penal terms on charges of delinquency after admitting sex and drinking activities. Judge Schannen sentenced the boy, James Bowie, a Negro, to six months on the state penal farm, and the white girl, Barbara Baker, to the Indiana Girls' School for an indeterminate term. The two were arrested last week outside a Fort Wayne youth center after creating a disturbance in a parked car. They admitted having sexual relations at least 20 times since the beginning of school last September, police said, and also engaging in drinking parties in Bowie's home. The girl, an attractive blond, said her mother had tried to stop their dating. Fort Wayne juvenile authorities said DANCING OF MIXED GROUPS WAS COMMON IN SEVERAL LOCAL YOUTH CENTERS and THEY KNEW OF AT LEAST 40 WHITE GIRLS AND 30 NEGRO BOYS IN THE CITY WHO GO ON INTERRACIAL DATES. OTHER WHITE BOYS ARE DATING NEGRO GIRLS, THEY ADDED."

American Catholics should give this Bulletin to their local priest and demand a cessation of these activities. WRITE A PROTEST TO FRIENDSHIP HOUSE, 4233 South Indiana Ave., Chicago, Ill. There are many renowned scientists and statesmen who have proven the inherent cultural inferiority of the Negro race. Of course the Vatican would claim that these men should not even be allowed to vote or hold office. WE QUOTE ONLY A FEW AUTHORITIES AS SPACE PERMITS:

I. Ludwig Borchard (German anthropologist) from his book "MAN IN THE PAST, PRESENT and FUTURE"—"Turning from Australia to Africa, we encounter among the lowest human races there, the same brutal degradation and irrationality. "It is sufficient says Eichenhau (Berlin's Ober die Negerrasse)" to have seen black men and to have lived some time among them, in order to be convinced that here is presented a different human nature from that of the white man." The experienced English traveler, Burton, depicts the Negro of East Africa as a being without any moral ideas, or any thought reaching beyond the narrowest circle of things perceptible by the senses. He has no knowledge of the past, no history, no poetry, no belief except the grossest superstition, no domestic life, no attachment to kindred, no inclination to labor, no gratitude, no compassion, no care for the future etc. Mentally

he is totally barren and though he can observe, he can deduce nothing from what he has observed. Hence he has remained at the first beginnings of civilization and for thousands of years has made no progress although he has had sufficient contact with cultivated peoples. He lies even without aim or profit and is in the highest degree obstinate and self-willed just as some animals are accustomed to be."

2. Meredith Townsend (renowned English anthropologist):—"None of the black races, whether Negro or Australian, have shown within the historic time the capacity to develop civilization. They have never passed the boundaries of their own habitats as conquerors, and never exercised the smallest influence over peoples not black. They have never founded a stone city, have never built a ship, have never produced a literature, have never suggested a creed."
3. David Hume (eminent Scottish philosopher, 1742):—"I am apt to suspect the Negroes to be naturally inferior to the whites. There scarcely ever was a civilized nation of that complexion, nor even any individual eminent either in action or speculation."
4. August Forel (Swiss psychiatrist, 1900):—"Even for their own good the blacks must be treated as what they are, an absolutely subordinate, inferior, lower type of men, incapable themselves of culture. That must once and for all be clearly stated."
5. "ENCYCLOPEDIA BRITANNICA" (Vol. 12, page 826, 1911 Edition):—"On the whole it must be owned that after a century of independence and self-government the Haitian people have made no progress if they have not actually shown signs of retrogression." (Haiti was the only self-administered Negro nation)

With these thoughts in mind we sincerely hope that American Catholics will align themselves on the side of the Whites race and Western civilization and cast out the Jewish and anti-racial influences now prevalent in the Roman hierarchy. Inasmuch as investigation in this matter indicates subject is anti-Semitic, you were instructed to resolve the information furnished by T-3. Referenced letter and report dated 2-28-58 contained no information regarding the coverage of this lead by you. This investigation must be done promptly.

A review of previous investigative reports in this case reflects that since the initiation of the instant Registration Act investigation in November, 1956, information has been developed showing that the subject gets a large amount of literature from Syrian and Egyptian diplomatic establishments in New York City as well as from Arab organizations in New York City. Investigation reflects that he distributes this material through his National Renaissance Party but no information has been developed that he is actually acting as an agent of a foreign government. In order to bring this case to a logical conclusion so that it can be referred to the Department, you are instructed to submit your recommendation regarding an interview with the subject within 30 days from the receipt of this letter.

IS ANTI-SEMITISM JUSTIFIED BY HISTORY?

James H. Madole.

What are the real causes of anti-Jewish feeling among the Gentile peoples of the world? Is anti-Semitism mere blind prejudice based on the greed, envy and frustration of the Gentile masses, both white and colored, or is anti-Jewish feeling justified by the stern verdict of history and the natural law of self-preservation? The record of history proves conclusively that the Jews, more than any other racial or religious group, have been reviled, persecuted and extradited from nearly every Gentile nation, both civilized and uncivilized, both Christian and Moslem, during the period of recorded history. Is anti-Semitism always the fault of the Gentile majority or could the activities of the Jewish minority within the Gentile nations be responsible?

The Jewish people are a racial unit bound together by the messianic religion of Judaism. Unlike Protestantism and Roman Catholicism which seek to convert all nationalities and races to a universal religious faith, Judaism serves as a form of spiritual cement binding members of the Jewish race to a messianic doctrine which preaches that God established a Covenant with Israel through Moses on Mount Sinai. Thus the Jewish race became "God's Chosen People" or the "People of the Covenant". They must never assimilate with the Gentile peoples whom they lived among "in Diaspora" (in dispersion). Thus for nearly 4000 years the Jewish race has chosen to live as "a state within a state", refusing to be assimilated into their Gentile surroundings. They have accumulated great wealth and power from their Gentile hosts but they have used this power and wealth to increase the stranglehold of world Jewry on the economy, real estate and natural resources of all Gentile nations. Thus while the world Jewish community waxed fat and prosperous, the Gentile peoples were being slowly bled white and pauperized. The Jew, being internationalist by his very nature, sought to break down all racial and national barriers within the Gentile states. Being an alien the Jew could not conceive of national patriotism and love of one's native land hence he made every possible effort to discourage such feelings among his Gentile hosts. Racial pride was a barrier to Jewish social and economic progress within the Gentile nations hence this natural impulse must also be eradicated.

While seeking to stamp out racial pride and national patriotism among the Gentile peoples, the Jews sought to intensify these passions to the ultimate among "God's Chosen People". The Jew told his own people that their race must never assimilate with the Gentiles because only the Jews and their "holy" nation of Israel have a covenant with God. If they kept themselves pure and free from the contaminating influence of Gentile thought and blood, God would keep his covenant with World Jewry by restoring them to their ancient, Biblical homeland in Palestine. From this messianic creed of a self-ordained "Chosen people" emanated the doctrine of Zionism. Zionist doctrine teaches that all Jews owe their primary loyalty to World Jewry and the Jewish state of Israel established in 1948. Thus Jews residing and prospering in America, Great Britain, France and Germany utilize their wealth and influence to bribe and corrupt the governments and public press of these countries to speak and act in behalf of the state of Israel. By educating his children in separate Jewish schools where they come under the influence of fanatical Zionist

instructors and by using Jewish-owned department store and retail advertising for the purpose of exerting pressure on the American press to conduct "Hate Campaigns" against governments, individuals or groups which dare to oppose the methods and aims of World Jewry, the Jews are fast becoming the subversive agents of a foreign power operating within our national borders. The German-American Bund and the Japanese Black Dragon Society were outlawed and their leaders imprisoned by the U.S. Justice Dept. but not one Zionist organization has even been investigated by our Attorney General. Because of their sinister influence American, British and French foreign policy has become the helpless tool of Zionist pressure groups with unlimited funds at their disposal while 400,000,000 Moslems are being driven into the open arms of Soviet Russia.

To further prove our basic contention that World Jewry represents an alien organism within the bodies of all Gentile nations and that this alien organism is a parasite which drains the wealth of Gentile states and uses this wealth for its own alien purposes, we now quote from several renowned Jewish leaders and publications:

1. Rabbi Schindler, "JEWISH CHRONICLE", April 28, 1911:

"For fifty years I was a partisan of the assimilation of the Jews and I believed in it. The American melting-pot will never produce the fusion of a single Jew".

2. AMERICAN EXAMINER, September 12, 1957, page 11:

"Love is secondary in the traditional Jewish concept of marriage, a rabbi told a B'nai B'rith Institute of Judaism here. The purpose of marriage, said Dr. Arthur J. Lelyveld, now executive vice president of the America-Israel Cultural Foundation, is "not to allow two people to live happily ever after" but to serve as a social base for "THE REARING OF CHILDREN AND THE TRANSMISSION OF JEWISH VALUES". (Ed. Note: When Adolf Hitler made statements like the above in reference to the Germanic people, World Jewry called him a racial bigot and cried up a holy war against Nazi German.)

3. Leo N. Levy, lawyer, leader of B'nai B'rith (1900) Quote from speech in a "MEMORIAL" edited by the Order of B'nai B'rith:

"Who shall say that the Jews are no longer a race? Blood is the basis and sub-stratum of the race idea, and no people on the face of the globe can lay claim with so much right to purity of blood, and unity of blood, as the Jews. The religion alone does not constitute the people. As I have already maintained, a believer in the Jewish faith does not by reason of that fact become a Jew. On the other hand, however, a Jew by birth remains a Jew, even though he abjures his religion."

4. G. B. Stern, author, "DEBATABLE GROUND":

"Jews are a nation. If there was but a theological difference, would there be such striking distinctions in features and temper? To go to the synagogue instead of the church, does that change anything in the curve of the nose? We surely are a nation, a dispersed nation, but the most united nation in the world."

5. "JEWISH WORLD", January 1, 1909 by M.J. Wodislawski:

"Let us take the mask off. Let us play the Lion of Judah for a change. Away, away with false patriotism. A Jew can only recognize one Fatherland, Palestine."

Obviously a tightly-knit race of people holding the beliefs expressed above could not be considered loyal citizens of any Gentile nation. We find the Jewish race creating a world-wide Zionist network of subversion by using the wealth and influence which they have accumulated in their Gentile host-nations to further the aggressive economic and political interests of World Jewry and the state of Israel. The reasons for anti-Semitism become quite evident if we devote study to Jewish international activities.

I. CAUSES OF ANTI-SEMITISM IN THE MIDDLE EAST:

To protect themselves from any future aggression by Israel and her Western allies, similar to the brutal Sinai invasion of November, 1956, the small Arab states of Egypt and Syria merged to form the small Arab states of Egypt and Syria merged to form the UNITED ARAB REPUBLIC under the leadership of President Gamal Nasser. Already the Zionist-dominated Eisenhower Administration had sought to divide the Arab world by bribing King Hussein of Jordan with \$13,000,000 and the right to have his Arab Legion soldiers trained in West Germany by American officers. In return King Hussein abandoned his alliance with Egypt and Syria and now is seeking to preserve his feudal monarchy by setting up a rival merger with King Feisal of Iraq. Iraq has long been a member of the American-sponsored Baghdad Pact and no Arab nation belonging to this alliance is permitted to use the arms which it obtains from America against Israel. Hence Israel uses the Baghdad Pact as its shield of protection against the righteous wrath of her Arab nationalist enemies. Like all other Israeli weapons, the Baghdad Pact carries a "made in America" label. The Zionists now hope to convince King Hussein of Jordan and King Feisal of Iraq that the United Arab Republic constitutes a greater menace to their respective thrones than does the future prospects of Zionist expansion in the Middle East. If the people of Iraq, Saudi-Arabia and Jordan refuse to awaken and join hands with President Nasser to curb Israeli aggression, the Arab world shall remain divided and ripe for conquest.

Why is anti-Jewish feeling so intense in the Middle East? The invasion of Egypt by Israel, France and Great Britain in late 1956 left bitter scars and memories. We must remember the diabolical campaign waged by World Jewry to secure the entrance of America into World War II. Now President Nasser of tiny, little Egypt was the "Hitler of the Nile" and World Jewry started to sing their Hymn of Hate which was to arouse the Western Powers to another crusade in behalf of "the poor, persecuted Jews". Remember the never-ending tales of persecution and concentration camp outrages brought to America by teeming hordes of Jewish "refugees" during the early years of the Hitler regime in Germany? Remember how these same "victims of Nazi persecution" brought with them to America gold, precious gems and packing cases filled with the loot of Central Europe? (These huge packing cases were laughingly referred to as "Jewish coffins.") Americans found out later that Hitler's main grievance against the Jews was the fact that this alien minority had bought up nearly 80% of Germany's wealth, industry, land and assets at ridiculous prices during the terrible inflation of 1923-24. These assets were purchased with valuable foreign cash by foreign Jews who flocked to prostrate Germany like buzzards descending on the body of a dying man.

Exactly the same pattern was followed in Egypt as was followed in Germany by the Jews. We hear again the trumped-up atrocity stories and tales of woe. We quote "THE AMERICAN ZIONIST", page 20, entitled: "50,000 EGYPTIAN JEWS FACE DEPORTATION BY SUMMER, REFUGEE TELLS UJA:

"A cold pogrom is taking place in Egypt. Nasser is subjecting a helpless minority to every oppression to which Jews were subjected by Hitler, short of death camps," Rabbi Herbert A. Friedman declared. "Egypt is in economic straits since Nasser mortgaged his cotton crop to the Communists for guns and blocked the Suez Canal," Rabbi Friedman said. "Now he plans to enrich himself as Hitler did by a process of economic squeeze on the Jewish group. The situation cries out for U.N. investigation. "Nasserism is Nazism revived," the UJA Executive declared, NEARLY 800 LEADING JEWISH FIRMS HAVE BEEN CONFISCATED, and their owners jailed or ordered out. Professionals can't practice, artisans have no clientele. If these people don't get out, they will begin to starve."

In the same January, 1957 edition of "THE AMERICAN ZIONIST" on page 3 we have a purported interview with Jewish refugees landing in Naples from Egypt. This article is entitled "EGYPT JEWS TELL OF NAZI TERROR":

"Through tired lips came the stories of terror, torture and death. They were told two decades ago by the Jews driven from Hitler's Germany. They are being told again by Jews driven from Nasser's Egypt. According to the refugees, the government started by expropriating Jewish as well as British bank accounts. THIS AFFECTED EGYPT'S MOST IMPORTANT FINANCIAL INSTITUTIONS, ITS INSURANCE FIRMS, IMPORT, EXPORT AND WHOLESALE ESTABLISHMENTS. ALL THIS, THE REFUGEES SAID, BROUGHT BUSINESS TO AN ALMOST COMPLETE HALT. The refugees agreed that the basis of the anti-Semitic policy is Egypt's need for money and its hope to get it from the ESTIMATED \$600,000,000 WORTH OF JEWISH PROPERTY IN EGYPT."

We also find that the great majority of Jews owning this \$600,000,000 worth of Egyptian property and 800 leading Egyptian firms were not even citizens of Egypt but fell into the category of "stateless persons" or Jews who held foreign passports and took their financial profits out of Egypt. Thus the great masses of destitute, poverty-stricken Egyptian people were forced to look on while the Jewish locusts stripped their nation of its meagre assets. Secondly, although Egypt has officially remained in a state of war with the government of Israel since 1948 not one Egyptian Jew suffered privations until after the Sinai invasion of November, 1956. The Israeli Army knew exactly where to cross the Egyptian borders without encountering a single Egyptian Army unit. Their position was not discovered until the Israelis had advanced nearly 100 miles into the Sinai Peninsula. This military miracle was accomplished as a result of skillful espionage by Egyptian Jews who repaid the country where they had resided and prospered with treachery and betrayal. THIS MAY HELP TO EXPLAIN ANTI-JEWISH SENTIMENT IN THE MIDDLE EAST.

2. CAUSES OF ANTI-SEMITISM IN IRAN (PERSIA):

The chief purpose of the Iranian (Persian) Jewish community is to keep Iran tied to the Baghdad Pact thus preventing her large Moslem population from siding with the neighboring Arab states against Israel. We quote a dispatch from Tel Aviv in "THE AMERICAN EXAMINER" of December 26, 1957 entitled, "Jews in Iran In First Parley":

"The first convention of Iranian Jewry in modern times was an "important milestone" in the long and ancient history of the Jews in Persia, Prof. Arieh Tartakower president of the Israel section of the World Jewish Congress, who participated in the parley, declared in Tel Aviv. There are some 85,000 Jews in Iran, Prof. Tartakower estimated. He noted that of 17,000 JEWISH CHILDREN IN THE COMMUNITY, 11,000 WERE RECEIVING A JEWISH EDUCATION...The WJC leader said that Persian Jewish women were emancipated and that many of them had participated in the convention of Iranian Jews."

"THE LONDON JEWISH CHRONICLE", in a dispatch from Teheran, reported that the convention, which lasted four days and was attended by representatives of all Jewish organizations in Iran, was opened by Prince Gholam Reza Pahlevi, the brother of the Shah of Persia. An address was made by Hussein Ala, Minister of Court, who said that Mohammed Reza Shah Pahlevi, the Iranian Sovereign, "had the welfare, happiness and progress of all his subjects at heart, regardless of their race or religion."

In this way the Zionist Jews are skillfully organizing the Jewish communities throughout the world to act as agents of the Israeli state. We find Iranian Jewish children sent to schools where they will be trained as fanatical young Zionists without loyalty to any nation but Israel. When Israel starts its inevitable drive for expansion in the Middle East these Jewish communities will serve as potential fifth-columns in every nation where they are firmly established. Americans are reminded of Eisenhower, Nixon, Truman and Roosevelt when they see the brother of the Iranian potentate rushing to a Jewish convention to heap praise upon a race of people whose deceit and treachery extend back into history for over 40000 years.

3. CAUSES OF ANTI-SEMITISM IN INDONESIA:

We quote an article from "THE AMERICAN EXAMINER" of December 26, 1957 entitled, "Indonesian Jewry Facing Hardships, REPORT Shows": "The Australian Jewish community offered its assistance to any Jews forced out of Indonesia in the current anti-Dutch disorders. The offer was made by Sidney D. Einfeld, president of the Executive Council of Australian Jewry, to the Dutch (Jewish) community in Sydney, Australia. He pledged that his organization would provide temporary accommodations and other care to Indonesian Jews expelled or fleeing from their country...Since the Indonesians took over control of their own country the economic position of the Jews has worsened. Together with other non-natives in the population, they have been forced out of business and well paid positions by government regulations and laws aimed at putting control of the economy in the hands of Indonesians."

As a result of this patriotic policy both President Sukarno of Indonesia and President Nasser of Egypt have been branded as "Red-dominated" by America's pro-Zionist press and radio. The peoples of Asia and Africa must learn to differentiate between Western Imperialism and unscrupulous Jews of French, British or Dutch nationality who have exploited their land and natural resources under the protection of the French, British and Dutch flags. The people of America and Western Europe no longer control their governments, industries or media of communication. WESTERN CIVILIZATION HAS BECOME THE SLAVE OF JEWISH IMPERIALISM. This is the fundamental cause of anti-Semitism.
