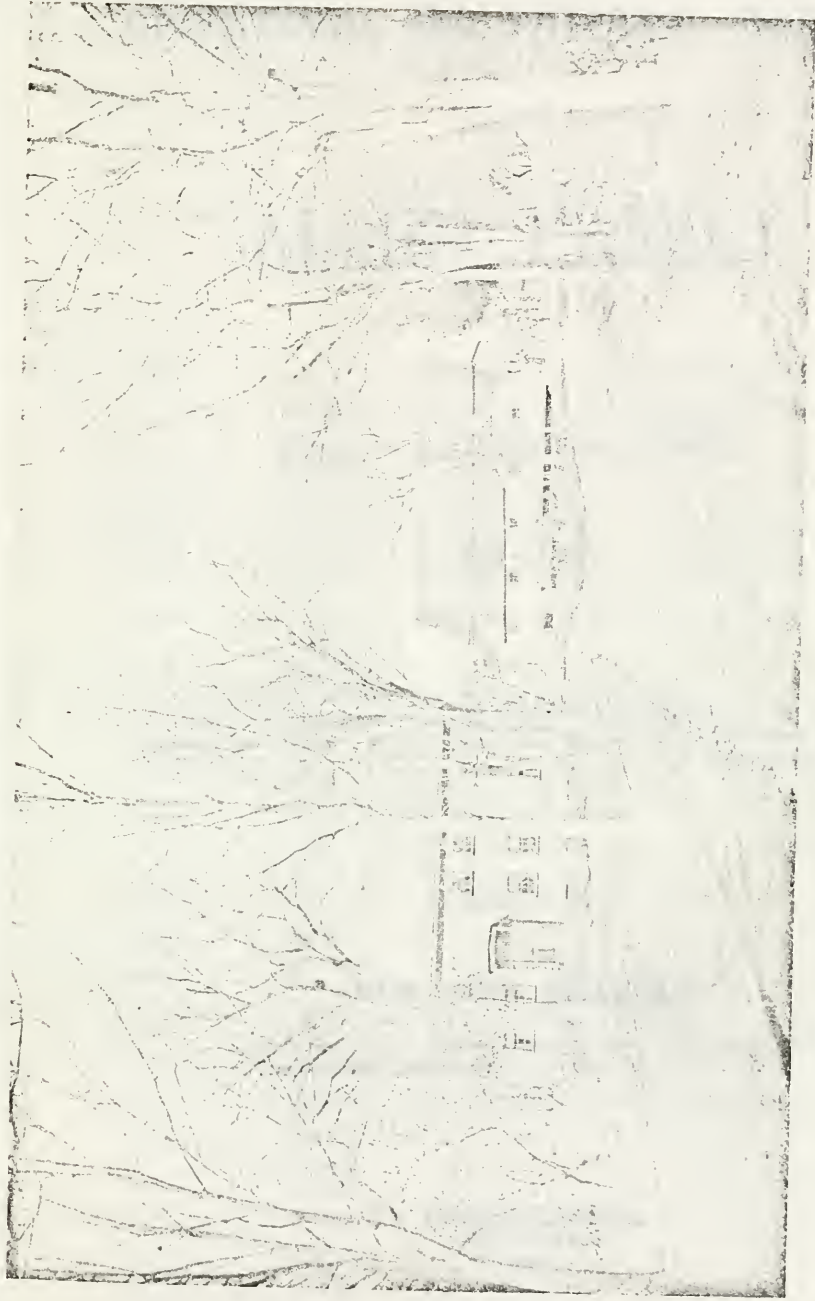

P R E F A C E.

THIS work was commenced for my own gratification and pleasure, and without a thought of publication; but I have been induced to have a few copies privately printed at the request of others of the family who have manifested an interest in it, and who, like myself, feel a reverence for ancestral connections. In regard to the ancestry of Samuel Allen in the old world we know but little, except that he and his two brothers, Matthew and Thomas, came from Braintree, Essex County, England, in 1632. It is to be hoped that future researches will throw light upon this point.

The system of arrangement adopted is that used in the "New-England Historical and Genealogical Register." Suppose we wish to find the record of Capt. Noah Allen. The first thing to be done is to look in the Index under that name. We there find that Capt. Noah Allen appears on page 13. Turning to that page we see his name and his record, his pedigree being put down thus:—19. Capt. NOAH⁵ (*Joseph*,⁴ *Samuel*,³ *John*,² *Samuel*¹), b. in East Windsor, &c. This shows at a glance the pedigree of Capt. Noah Allen. He is the fifth generation from Samuel Allen the emigrant. He is the son of Joseph, the grandson of Samuel, the great-grandson of John, and the great-great-grandson of Samuel the emigrant. Now if we wish to find the birth and parentage of Capt. Noah Allen's father, we turn back to No. 19, which we find in small figures at the left hand, near the middle of page 9, and at the head of this family we find 8. JOSEPH,⁴ his father, whose birth and parentage are found in

the same way. Proceeding in this manner we arrive finally at his great-great-grandfather, Samuel,¹ the original emigrant.

The following abbreviations, in addition to the usual ones of the names of States and of the months, have been used:—b. born; m. married; d. died; unm. unmarried; dau. daughter; bapt. baptized.

Grateful acknowledgments are due for valuable and important contributions from Mrs. Maria C. Mitchell, New Haven, Conn.; Orlando Allen, Esq., Jabez S. Allen, Esq., Henry W. Allen, Esq., East Windsor, Conn.; B. Rowland Allen, Esq., Hartford, Conn., and to those other members of the family and others who have so kindly assisted me in collecting information. Without these collateral aids, the work could never have been brought to its present degree of fulness and completeness.

The compiler wishes it distinctly understood that he does not regard this book as containing a complete genealogy of the descendants of Samuel Allen, Senior, and he has no doubt that it contains many errors. He desires that these imperfections may be removed. He requests that any one examining this book who detects any error, however trivial, or notices any omission which he can supply, to communicate the information to him without delay, because that which is deferred is apt to be neglected until it is forgotten. Any information thus communicated will not be lost, as the compiler hopes to publish a new and enlarged edition.

ation. On page 15, we find 3. JOSEPH², son *James*¹ (1); the figure in parenthesis indicates the number of the paragraph containing particulars of the person after whose name it occurs.

When no State is given, the city or town is understood to be in Massachusetts.

The plate for our frontispiece was kindly furnished by the Allen brothers, the present owners of the homestead. The house has undergone some changes since it was erected in 1673-4 at the time of, or soon after, the marriage of its original owner. It was standing in the early part of 1675-6, as was the cooper's shop close by, at which time the Indians attempted its destruction by fire—see paragraph 3, page 15, for fuller particulars of this affair. The house was similar in style to those of its day, and at the latter part of the last century consisted of two stories with a large chimney in the centre, the only ornament being a Doric scroll over the front door. In our present illustration the two windows to the left of the front door are in a room added to the house in 1814. The room having two windows to the right of the door was built about 1787, and has been the scene of many weddings. To the right of this is a smaller room with one front window, still older, and directly in its rear is the room where the Indians started the fire. The homestead is now occupied by Mr. Joseph Addison Allen (one of the three owners), of the seventh generation of Allens born there, the place never having been out of possession of the family.

Before closing these few introductory remarks the compiler desires to express his thanks to the several members of the family who have so cheerfully rendered him assistance, knowing, that without their aid much valuable material must have been omitted.

INTRODUCTION.

The name *Allin* or *Allen* is derived from the British and thought to be a corruption of *Ælinus*, which signifies sun-bright. In the Gaelic we have *Aliune*, signifying fair, handsome, etc., while the Irish *Alun* denotes fair, beautiful*, and the English *Allan* or *Allen*, all-winning, all-conquering†.

The name in the form *Allan* appears but once in Walford's "County Families," and then in Devonshire, while the form *Allen* is of frequent occurrence.

The family in which we are interested appears to have located in the parish of Colby, Norfolk, England, where we find in the latter part of the 16th century one Reginald Allin, an extensive land owner. At the time of his son John's matriculation at Caius College, Cambridge, in 1612, he is styled "Gentleman," but in his will, proved at the Consistory Court of the Bishop of Norwich, 27 Jan., 1615-6, he is called "yoeman." In this will he refers to the fact of having received certain lands in Colby "from Richard Allin, my father." We have been unable to fully identify this Richard, though we have record of the will of one Richard Allin dated 27 Feb., 1558, and proved in the Consistory Court of the Bishop of Norwich, 18 May, 1559, but unfortunately his residence is not given. He mentions son John "the elder," to whom he leaves house and land, daughter Johan and sons Robert and Richard. He may have been the grandfather of Reginald, but certainly not his father, for Reginald was not married until about 1583-4, and assuming that he was then twenty-five years of age would make his birth about 1559. He is not mentioned in Richard's will, and to have received land from him he must have been of age previous to 1559, which would make him forty or more years old at time of marriage.

The following data is taken from a copy of the Colby parish register‡, which begins in 1552:

Reginald Allin of Colby, Norfolk, England, is the earliest to whom we can trace. He was a son of Richard Allin and was probably born about 1559. He appears to have been a man of substance, owning land in seven parishes and two counties*. He was buried in Colby, 9 Nov., 1615, his will being proved in the Consistory Court of the Bishop of Norwich, 27 Jan., 1615-6, and was witnessed by a James Allen. The will mentions his wife, Margoria, and most of their children, as will appear presently. The following children are recorded in the Colby register :

- i. Anna, baptized 25 March, 1584, mentioned in her father's will as wife of Simon Toll.
- ii. Grace, baptized 25 July, 1587, mentioned as wife of Vincent Porter in her father's will.
- iii. Em. baptized 25 Dec., 1588.
- iv. Richard, baptized 8 Feb., 1589, mentioned in his father's will as "my eldest son" to have with "Stephen Allin, my third son." certain lands in Colby, "which I had from Richard Allen, my father." The Colby register gives the following child of Richard:
 Reginald, baptized 8 Sept., 1615.
- iv. Francis, baptized 16 June, 1591, mentioned in his father's will as "my second son."
- v. Stephen, baptized 3 Feb., 1593, mentioned in his father's will as "my third son," and besides the share in the land with his brother Richard, he is to have, "to occupy and use" with his mother, the house and lands until the children "accomplish the age of twenty-three years."

- vii. Dorothea, baptized 30 Aug., 1595, mentioned in the will.
- viii. John, baptized 22 May, 1597, to receive a certain sum at stated periods towards "maintaining him at college at Cambridge." He was the first pastor of the church in Dedham, Mass. *
- ix. Elizabeth, baptized 6 Jan., 1598, mentioned in her father's will.
- x. William, baptized 12 March, 1600, and probably the "child of Reginald Allin;" buried 13 March, 1600.
- xi. Robert, baptized 6 Feb., 1603, mentioned in father's will.
- xii. Edward, baptized 6 Feb., 1603, mentioned in father's will.
- xiii. Margoria, baptized 2 Aug., 1606; by her father's will she was to receive "in consideration of 40 shillings given unto me for her by her god-father, Thurston, many years past, five pounds."

The connection between our ancestor — James Allin of Medfield — and the foregoing family is based upon the following clause in the will of Rev. John Allin of Dedham, Mass., who was a son of Reginald Allin of Colby: "To my Cozen James Allin of Medfield twenty shilling to be delivered to him in Country paymt. * * * within three months after my decease." This will was dated 23 Aug., 1671, and from contemporary sources we shall see that the term *cousin* was synonymous with nephew, in support of which statement I cite the following: — Robert Eames died in Dracut, Mass., about 1671 and by will bequeathed certain property to "my cousin Richard, son of my sister Dorothy Newman," etc. †; also, the Rev. Thomas Parker of Newbury, Mass., had for an assistant one John Woodbridge, whom we know to have been his nephew; yet, in a deposition sworn to in the court in Ipswich, and dated 30 March, 1669, we read — "Afterwards Mr. Parker expressed thus — Those that are for the continuance of my cousin Woodbridge in the way of preaching as formerly he hath done," etc. ‡ The connection being thus established it remains only to ascertain which of Reginald's sons was father of our ancestor, and doubtless a search in the parish registers in the vicinity of Colby would show the missing link of our genealogical chain.

We also find one Robert Allin in Dedham, whom the Rev. John Allin calls a "near kinsman" in his will already noted. He was admitted to the church in Dedham in February, 1667, made free 31 May, 1671, and d. in Dedham, 22 Sept., 1690. He was unmarried, as the following extracts from the Dedham records will show:

25 August, 1663, "Robt Allin is allowed to sorjune at John Bacons."

14 April, 1669, "Robert Allin engage to giue further account when he is agreed where to sojourn."

In 1663 he was taxed 3s. 4d. in the country rate and the same the next year. His name appears in the list of legal votes for 1666.

Before proceeding with the main genealogy we will devote a few lines to the consideration of the almost universal tradition in our family, that the Allens are of Scotch origin. As will appear presently, our emigrant ancestor, James Allin, was married in Dedham, Mass., in 1638, to Ann Guild, who *came from Scotland* with her two brothers, John and Samuel, in 1637-8. Here, then, is the foundation for our tradition; we have already seen that the Allins were residing in Colby for nearly a century before the appearance of the name in America.

THE ALLEN FAMILY.

1. JAMES¹ ALLIN was a grandson of Reginald Allin of Colby, Norfolk, England, and probably came to Dedham with his uncle, the Rev. John Allin, about 1637. He is first mentioned in the records of that town under date 6 Apr., 1638, when —

James Allin accepted to haue six acres layd out for him in y^t corner by Jeffery Myngey yf ther it may be fownd fitt.

He received other grants at various times; was admitted to the church 2 Oct., 1646, and made free 26 May, 1647. In 1648 his estate was valued at £2, his tax for that year amounting to 3s. 5d. From a vote of the selectmen in February, 1650, we learn —

Lief Fisher is deputed to treat with Joshua Kente & conclude with him for the beatinge of the Drume: he is desired to put the Deacons in minde to put the worke that James Allen now [] into the hands of the said Joshua [] that he may carefully attend the shutting the meeting-house doores & the keepinge out of the doggs.

In 1649 some of the inhabitants of Dedham formed a company for the purpose of beginning a settlement at Boggestow, upon the Charles river, now known as Medfield. James Allin was one of the first thirteen proprietors of the new town and the fifth to be granted land. The affairs of the infant settlement were at first conducted by a committee, who, 19 June, 1650, laid out the thirteen house-lots and in their records we read: —

5. To James Allen, seven acres abutting upon the waste lands upon all the sides there of round about.*

This lot was on South st near the present residence of Mr. Rhodes. In the town valuation for 1652 we find the following: †

About 1653 he was granted land as follows :

Meadfield granteth to James Alin six Acres of Upland that lieth on the north plaine Abutting toward the west on Stony Winter Brook, against the lands of Thomas Wight, and on the waste lands on all other parts.

This grant was near the house-lot of his son Joseph. He received other grants at subsequent times and owned land on both sides of the river. His will* was dated 23 Sept., 1676, in which he gives house, barn, etc., to his son-in-law, Joseph Clark, from which fact it is believed he owned two places, having given the homestead to his son Nathaniel, who is known to have lived in the estate on South street. James m. in Dedham 16 Mch., 1638, Ann Guild, who d. in Medfield 29 Mch., 1673; he d. there 27 Sept., 1676. Ch. all born in Dedham except the youngest.

3. JOSEPH², son *James*¹(1) b. in Medfield, 24 June, 1652, settled in the northern part of the town on Castle Hill, since known as the Allen Place. In 1673 he was granted two lots of land, one between land owned by his father—below Samuel Wight's—and the road leading to "Goodman Morse's;" the other between his father's land and that owned by Samuel Wight, bounded on the east by the highway to Natick.† He was a cooper by trade, his house and shop having been built before King Philip's war. On 21 Feb., 1676, the Indians attempted to burn the town and his house was among the first to receive their attention. According to tradition the savages took shavings from the shop, and piling them upon the kitchen floor, applied the torch. Fortunately they had been placed upon a trap door, which being consumed, let the

burning pile fall into the cellar where the flames were soon extinguished, thus doing no further damage. All of the other houses in this part of the town were destroyed. The 21 Sept., 1676, he received from his father six acres of upland and one acre of meadow, evidently his share in the estate, as his name does not appear in his father's will, dated two days later. His name appears among list of proprietors in 1675 and 1701. He was made free 11 Oct., 1682; sealer of weights and measures in 1688, and admitted with his wife to the first parish in 1697³. He m. in Seakonk (Rehoboth), 10 Nov., 1673, Hannah, dau. of William Sabin, b. there 22 Oct., 1654; d. in Medfield 1730³; he d. there 14 Jan., 1703. Ch. all b. in Medfield.

The house was built on the easterly side of Trout Brook, in the 3rd precinct, a short distance in the rear of the present Congregational church.† The Allen family occupied seats of prominence in the church and the

During cold weather the school-house, near the church, was opened at stated intervals during church service in order that the congregation might warm themselves, and Hezekiah Allen was one of the committee to "open, shut and secure the fire and keep order in said house."* He was a member of Capt. Ebenezer Battle's company at the Lexington fight 19 Apr., 1775, serving six days. In 1784 Dover was made a separate precinct, at which time he was chosen clerk, the fac-simile of signature being taken from

the town books. He was chosen treasurer in 1786; warden in 1787-8-9. In 1788 was one of a committee to defend the district in a suit concerning the boundary line between Dover and Dedham. The next year he was chosen to col-

lect the minister's tax; was fence-viewer* in 1792, 1794 and 1798. In 1792 he was a member of the committee to regulate a house set apart for a small-pox hospital, and "to set bounds around it." Being dependent upon his own labors he met his college expenses by teaching school, in which he was so successful that at the time of his graduation he was free from debt. He entered Brown's University in 1795, graduating with honors in 1798, and at once began studying for the ministry with the Rev. Dr. Forbes of Ravinham. In 1801 he was settled over the first parish church of Pembroke, remaining pastor for over forty years, his preaching being noted for its brevity and originality of treatment. Soon after his settlement, finding his salary of \$475 inadequate to meet the expenses of his growing family, he opened a school for boys, which proving so successful, his pupils became so

numerous, making the work in connection with the duties of his parish such a tax on his strength he was forced to abandon the school. His son turned his attention to farming, and by adopting the plan of selecting different soils for different crops, he soon became the most successful farmer in the county. He was one of the founders, and many years president, of the Plymouth County Agricultural Society, and in 1849 was elected member of the Royal Agricultural Society of Tunis, Virginia. Was a frequent contributor to agricultural papers, dwelling only upon his own observation and experiments rather than scientific research. He was among the first to utilize surface earth, the piles of which about his farm being at first contemptuously called "Allenites"; but having demonstrated its worth, the name was continued in honor of the supposed originator of a useful practice. While a minister he took no part in public affairs, not even voting, but soon after his retirement he was elected to the State Senate of which body he was an efficient and honored member*. Everything for the tables, except the warm meats, was cooked at home and carried down by the family. Two colored men walked down from Medfield to serve at the spread." Soon after graduation, and while staying with the Rev. Henry Ware, in Cambridge, he received an invitation to supply the pulpit of the church in Weston, as a candidate for settle-

ment; but being in poor health he wisely followed the advice of his physician and "took a long journey on horseback" to the springs at Ballston, N. Y.,* receiving much benefit and enjoyment from the trip, and by proper care "as to diet and exercise, he was able to retain good health through a long life." In 1816 he was settled as minister of Northboro', and in the following spring began the erection of "the manse," the young men of the town assisting to dig the cellar and rendering such other help as they could. The house was built nearly square, of "two stories, a hipped roof, and a broad porch in front," and was placed on rising ground a little below the foot of the common, south-west of the meeting-house.† On the seventy-first anniversary of his ordination, his children caused to be placed in the wall of the church he served so long, a plain tablet of white marble with a suitable inscription. That triumph he happily lived to witness with the joy and thanksgiving of Simeon of old, and towards its achievement he did his part by example, testimony, and works.'"^{*}

During part of his early life he had been brought up among relatives who held doctrines more nearly Calvinistic than the rest of the family; and these he adopted and retained through life, though modified by a genial disposition and kindly affections. He moved farther and farther west, living for some years in southwestern Wisconsin and spent his last years as missionary in Iowa."[†]

A BRIEF SKETCH OF REV. JOHN ALLIN.
THE FIRST MINISTER OF
DEDHAM, MASS

JOHN ALLIN was a son of Reginald Allin of Colby, Norfolk County, England, and was baptized there 22 May, 1597, and matriculated at Caius College, Cambridge, the record reading —

Allen, John, of Colby, Norfolk, son of Reginald Allen, gent.; School, North Walsham, under Mr. Tyllas, three years, age 16. Admitted Scholar, lit. grat. April 27, 1612. Tutor and surety Mr. Thomas Weatherell, fellow.*

He took bachelor's degree in 1615 and master's in 1619.

The paper,* by the late Professor William F. Allen of Madison, Wis., seems to leave no doubt as to the identity of John Allin of Colby and the first minister of Dedham, Mass., one of the strongest arguments in its favor being the similarity of the signatures; the first of which was written when he took his master's degree, and the second in Dedham, some fifty years later. The fac-similes here shown were kindly furnished by the late Professor Allen. Other facts tending to prove the identity are, that being a Puritan he would have studied at Cambridge and at Caius College, and we have already seen (vide p. 11) that his father left by will a certain sum to be paid at stated periods "towards maintaining him at college at Cambridge," and the registers of that University show no other of the name whose age at all corresponds †

It is difficult to determine in what year he sailed for America, as he was forced to leave England in disguise and probably under an assumed name. He came in company with Mr. Fiske, who was subsequently the first minister of Chelmsford, Mass., and we learn that after passing the Land's End "they entertained the passengers with two sermons a day, besides other agreeable discourse and devotional exercises, which filled the voyage with so much religion

that one of the passengers being examined because of diverting himself with a hook and line on the Lord's day, he protested 'that he did not know when the Lord's day was; he thought every day was a Sabbath, for they did nothing but pray and preach all the week long.'"*

The subject of this sketch first appears in Dedham under date 18 July, 1637, when he —

with diurse others being ppownded to sit downe with vs onely in the same condiçon they are accepted to doe pvided y^t they bring certificate from y^e magistrates according to the order of Court as they ought to doe.†

The above conditions complied with, we find him present at a town meeting held 28 Nov. following, from which time he took an active part in town affairs, and it is probable that he at once began the formation of a church, though it was not fully organized until 1638. The proceedings were written out by him as "A brief history of y^e Church of Christ (gathered) in his name, at Dedha' in New England y^e 8th day of y^e 9th month 1638." The manuscript is still extant and has been printed in full in the second volume of the Dedham Records. It contains a minute account of the formation of the church, the manner of selecting and ordaining the pastor and other officers, and is of much historical value in throwing light upon the ecclesiastical history of that period.

He became a man of much prominence in the colony, serving as a member of many important committees. Some difficulty arising between the colony and the mother country, the matter was referred to the ruling elders of the several churches, and he was made chairman and delivered their opinion.‡ On the 17 Oct., 1643, the General Court granted him land as follows:—

Mr John Allin the pastor of Dedham is granted 200 ac of land to be layd out by Eleazar Lusher & Edward Rice.‡

This grant was located at "Bogastow," on the Charles river, at the present town of Medfield. When the Synod met in Cambridge—15 Sept., 1648,—for the purpose of forming a system of church government, he was appointed to preach the sermon, taking his text from Acts xv., the discourse being "a very godly, learned and particular handling of near all the doctrines and applications concerning that subject, with a clear refutation of such errors, objections and scruples as had been raised about it by some young heads in the country."*†

He was elected an Overseer of Harvard College 18 Oct., 1654,*‡ and at the October session of the General Court in 1656 was chosen with Mather, Bulkley, Chauncey and Whiting on a com-

mittee of thirteen to meet 5 June, 1657, "to consult and debate" the so-called thirty questions.

Receiving large grants of land from the town he became, like many ministers of that day, a well to-do-farmer, possessing a goodly stock of cattle, and a house consisting of a parlor, kitchen and buttery on the first floor, with sleeping rooms above.

Jonhson says: —

"They [Dedham] called to the office of pastor the reverend, humble and heavenly minded Mr. John Allin, a man of very courteous behaviour, full of sweet Christian love toward all and with much meekness of spirit, contending earnestly for the faith and peace of Christ's children."

He was greatly loved by his people, who, after his death, published the last two of his sermons, "writing their preface in tears." * The town voted to raise money "for the paym^t of the charge of our late Reuer^d Pasto^rs M^r John Allin his funerall," † and at a town-meeting held 11 Mch., 1671 —

It was ordered by Gen^l consent that conueanient Tombe or monument of stone and lime mortar and covered with meet Timber be erected ouer the Graue of our late Reuer^d Pasto^r and an inscription cut thereon with the date of his death. ‡

Of his published works the following list appears: §

Dudley; and died 26 Aug., 1671, "after an easy sickness of ten days . . . his beloved wife Katherine died three days after; both were buried in the same grave."** ‡

In the yeare of our Lord: 1676: the: 23: day of the seaventh moth I James Allin of Medfeilld in the County of Suffulke in new England being by the good hand of god preserved to old age and being there by and other infirmities attending the same yet in mind of my change and considering that it is my duty to prepaire for Death that I be not unprepared when it shall com I have thought fitt to make this my Last will and testament in maner and form as followeth viz first I give and bequea my soull into the armes of Jesus Christ my deere redemer and as for my bodye I comit it to the earth after my deces to be Christianly buried at the Descretion of my Xecutors and as for my worltdly goodes which god of his mercy have given me I Doe Disspose of them in maner as followeth viz I give and bequeath unto my son Nathanell Allin sixe acres of upland lyeing and being in Medfeilld neer maple Swamp bounded with the Comon Land on all y^t as all soe two acres of meadow Land the one acre Lyeing up strem on Charles river the other acre Lyeing upon a small brook calld mill brook all Soe I give unto the said Nathanell Allin six pound to be payd by my Executor in good and currant Cuntry pay with in the space of one full year after my Decease And I give and bequeath unto my son in law Joseph Clark and his heires for ever all that my house Lott with all my buillding thereupon both Dwelling houses barnes and Leantoes with all the Orchards and gardings belonging thereunto with all my other Landes both upland meadow and Swampes now Lyeing and being in Medfeilld not formerly Dissposed of with all rights and prevelidges belonging thereunto with all my housholld goodes and moveables still provided: first that the said Joseph Clark Doe Duely and careffully provid for me Duering the tarme of my naturall Liffè both flood and Rayment Sutable to my condition with what soe ever else may be needfull and convenient for the preservation and comfort of my Liffè whilist I live in this worlld and a christan buriall when ever it shall please god to take me hence 2^{dly} that when ever it shall please the Lord to take me out of this worlld that what Soe ever shall then remaine of what my houses Landes and moveables above speasified: given and granted in this my Last will and Testament unto the abovesaid Joseph Clark the thirten pound a yeare with the produce of my estate Dewring the


tarme of my naturall Liffe excepted) shall be Devided amongst my children as followeth viz first I give and bequeath unto my Daughter Sarah Whit Wiffe to Domingo Whit of Lin six pound and to my Daughter Mathew Saben Wiff to William Sabin of Rehoboth five pound over and above there equalle share with the rest of my children iff my estate shall amount to more then thirty pound when it shall pleas god to take me away (to be payd them with in the space of one full yeare after my decease in good and curant contry pay but if it should pleas the Lord to Lenthen out my Life soe as what I leave should not com to thirty pound then they to have each of them but duple share and further my will is that what y^t of my estate is Left when it shall pleas god to take me away there shares shall be payd yearlye to them not exceding forty shillings p year to each of them nor less then flortye shillings a year if there be estat lefte the which said shares shall be payd some time in the second yeare after my Decease and soe yearlye acording to what estate is Left to be payd in Contry pay or som of the remote Landes and I Doe hereby rattifie and confirme unto and upon all my sones all such Landes *all such Landes* as have bene given them by me formerly and I Doe heereby constitute appoint and ordaine my Loveing and wellbeloved son in law Joseph Clark Executor this my Last will and Testament to the intent that he shall see the same efectually pformed according to my true intent and mening therein and to him I commit and give full power and trust for the execution thereof and I doe all Soe nominate and appoint my trusty and well beloved freind George Barbur of Medfield Suproviser of this my Last will and testament Desireing that he would be Ayding and Assisting to my Executor in the execution thereof and I Doe heerby utterly rovoke all other willes and bequeatthalls what soe ever by me formerly made at any and in token that this is my Last will and Testement written & contained in this sheeth of paper I have heere unto put my hand and affixed my Seall this three and twenty of the seaventh moth in the yeare of our Lord one thousand six hundred seventy & six.
