



PREFACE

One hundred and thirty four years have passed since Anthony Lawson III, with his wife and four sons came to America. His descendants are scattered in the states of Virginia, West Virginia, Kentucky and others. No printed pedigree of this eminent Northumberland Lawson family exists. The Author has compiled much valuable data of the ancestors and descending families, and all known information is included. Cooperation by correspondence is difficult to secure, and some of the descendants are mentioned with scant data.

Hundreds of letters were sent to descendants, and many remain unanswered. Many public records have been examined; many cemeteries and burial grounds have been visited; hundreds of pages of local histories have been read; family Bibles have been examined in quest of data to fill the pages of this brochure.

Encouragement and cooperation from some of the interested relatives of Anthony Lawson III have made this publication possible and although it may seem brief to many, it is a sincere attempt to preserve and bring together all known history of the early Lawsons of Logan County, West Virginia.

There may be evidence of discrepancy of dates and names, and errors may be discovered by those who may have better and more accurate data. Those who may find incorrect matter should report such to the Author with proper corrections. A supplemental edition could be printed in the future and delivered to each subscriber.

It should be remembered that West Virginia was a part of Old Virginia until the latter state decided to join the Confederacy, and therefore its early history is tied up with the Old Dominion. West Virginia was proclaimed a state May 20, 1863. Logan County, Virginia, was organized in 1824 from Cabell, Kanawha and Giles Counties. The town of Logan was organized in 1827, and first named Lawnsville. In 1852 it was named Aracoma, and in 1907 the name was changed to Logan to conform with the name of the county.

Mingo County was created from Logan County in 1895, and the town of Williamson was organized before then.

That part of Virginia which later became West Virginia is herein referred to as (West) Virginia or (W.) Va.

Anthony Lawson was seated at Stanton Old Hall, near Morpeth, Northumberland County, England. He is the progenitor of three succeeding Anthonys, born in Northumberland County, England. To designate them with certainty, they are numbered I, II, III, and IV. After Anthony III immigrated to America, he was known as Anthony, Sr. and his youngest son, Anthony IV, was known as Anthony, Jr.

Some obituary notices and the United States Census record for 1850, of Logan County, (W.) Va., have been printed as proof of ages, dates, etc. Each family in most instances is treated separately.

The diary of Anthony Lawson IV is so important and interesting that its inclusion will interest those who have not seen it.

No effort has been made to include the young generations because vital statistics are now permanently recorded in public records.

At the end of the Booklet, four pages of especially prepared blanks for further records, corrections etc. are included.

The United States Census record is important because it gives the names of the children in succession, and the ages at the last birthday. Under each family group the date is printed. The other names listed with the Lawson are boarders, or perhaps persons residing therewith. Roxalina Lawson, daughter of Anthony IV, spelled her name Rochsalina.

Unfortunately, the chronicling of the "History of Logan County" has been done carelessly, and many inaccurate dates, names and other important matter relative to the Lawsons and allied families of Logan County have caused confusion.

The article found on page 73 of the above mentioned local history is reprinted with corrections. It is the Author's thought that in preserving and assembling a correct pedigree of Anthony Lawson of Northumberland and Logan County, West Virginia, the matter assembled should be proved as to correctness. An effort has been made to establish the correct account of each descendant as accurately as possible.

It would be ungrateful not to mention the names of some of

Without her help this brochure would probably never have been printed. Many others have cooperated with the Author and the sincerity they have shown is appreciated and will long be remembered.

The marriage record before 1872, at Logan Court House, is missing, and its loss has been difficult to overcome.

This booklet is copyrighted and two of the best copies deposited at the Library of Congress. Any descendent of Anthony Lawson of Northumberland may use any part without permission from the Author.

Family records indicate that Anthony II and Margaret (Caiss) Lawson had three sons and two daughters. The Author has no information of the two daughters.

ANTHONY LAWSON III

Anthony Lawson III, the ancestor of the American lineage of Northumberland Lawsons, immigrated to the present site of Logan, West Virginia, from Alexandria, Virginia, in 1824 or sooner. He engaged in the general mercantile business and purchased and traded merchandise for furs and ginseng, and disposed of these products in the market at Philadelphia. The furs, ginseng and other products were transported down the Guyan River in flat bottom boats, known as push boats. At Guyandotte the products were loaded on Ohio River boats and transported to Pittsburgh and from there overland to their destination. In Philadelphia he purchased merchandise and brought it back in the same manner. He was one of the few persons who owned slaves, and it is said that he promised his slaves their freedom after his and his wife's death. Early in 1847, he made one of his periodical trips to Philadelphia. He traveled by horse to Guyandotte and from there, as was the custom, by a river boat to Pittsburgh. On his return, he became very ill and after he was taken from the boat at Guyandotte, he soon died with cholera. He is buried there in the city cemetery, which is enclosed with a high iron fence. His grave is enclosed also in an iron enclosure and marked by a large gravestone.

After the death of Anthony III, during a cold winter night on the 27th of December, 1847, while Ann Lawson, the wife of Anthony III, was mending a shirt for a Negro, this same Negro came in to her room and struck her over the head and killed her with an iron poker. The Negro thought that after her death he would get his freedom. Another Negro was implicated in the cruel murder. Soon after her death, the Negroes became frightened and ran away, but they were quickly apprehended and returned for trial. The Negro who murdered his owner was hanged and the other severely punished. This narration is from family tradition and is thought to be true.

Argent, a chevron between three martlets sable. The crest is two arms holding up the sun in splendor with the appropriate motto: *Rise and shine*. This was a grant to the Yorkshire branch of the Lawson family—of Brough Hall.

This is a silver (argent) shield and is charged with a black or sable chevron which is between three black martlets or footless swallows.

The chevron, likened to the roof of a house, is emblematical of protection of the defenseless and was granted as a reward to those who built fortresses and churches for their country's good. The martlet or footless swallow was a messenger of good news, and as it was always on the wing, needed no feet.

ANTHONY LAWSON I

The eminent English progenitor of a lineage of distinguished English and American descendants, lived at "Stanton Old Hall" near Morpeth, Northumberland, England, and died at more than ninety years of age. The name of his wife is unknown, and the scant data available mentions only one son, Anthony II, 1727 -1819, who first married Margaret Clay, and after her death he married Margaret Caiss.

Anthony Lawson II, lived at "Stanton Old Hall" the place where his father lived and died, holding as did his father, two farms, "Fieldhead" and another. He was born in 1727, and died 1819. He first married Margaret Clay, to this union one child was born Margaret, who married John Leah; witnesses: Mary Lawson and Lewis Bilton. After the death of Margaret (Clay) Lawson, he married Margaret Caiss in 1784.

Children of Anthony II and Margaret (Caiss) Lawson:

(1) Anthony Lawson III, born at Stanton, in the Parish of Longhorsley, Northumberland County, England, Oct. 31, 1785, died at Guyandotte, (W.) Va. May 20, 1847, and is buried in the City cemetery there. Anthony III, married Ann Bilton, May 20, 1806. The ceremony being performed at Saint Helen's Church, Longhorsley Parish, down the meadow from the village, (by license) Rev. Robert Oliphant officiating; witnesses: Lewis and Jane Bilton.

(2) George Lawson, married Eleanor Bilton, of Northumberland County, England, and later lived in Liverpool, where some of his descendants now live. There was issue, a daughter, Mary married James Brewis, who died before 1870. Their children were Thomas Anthony, Robert, William and Jane. Ursula another daughter married John Gibson and lived in Liverpool.

Jane Brewis married a Davidson and had the following children: James, Thomas, Jane, Elizabeth, Mary, who married John Smith, and Margaret, who married Joseph Henry Taylor. Jane (Brewis) Davidson died before 1870.

(3) John Lawson, was born 1796, and married Elizabeth (surname unknown) in England. He with his wife, Elizabeth came to America in 1816, and settled in Alexandria, Virginia, and engaged in the grocery business on Cameron Street. Elizabeth, his wife was born 1798, died July 25, 1849, and after her death, he married Isabella McCardell, of Hagerstown, Maryland, Mar. 29, 1851, Rev. Mr. Anspach officiating. John Lawson died June 18, 1851, without issue, and is buried by the side of Elizabeth, his first wife, in the Saint Paul Episcopal Church cemetery, Alexandria, Virginia. I AND TAXABLE AND A

ANTHONY LAWSON III SON OF ANTHONY II AND MARGARET (CAISS) LAWSON

Anthony Lawson III, was born at Stanton, in the Parish of Longhorsley, Northumberland County, England, October 31, 1785, died at Guyandotte, (W.) Virginia, May 20, 1847. He is buried in the City cemetery at Guyandotte, West Virginia. He married Ann Bilton, May 20, 1806. The ceremony was performed at Saint Helen's Church, Longhorsley Parish, down the meadow from the village, (by license) Rev. Robert Oliphant officiating. Witnesses: Lewis and Jane Bilton. Ann Bilton was born at Fieldhead, in the Parish of Longhorsley, March 17, 1783 and died December 27, 1847 at Logan (West) Virginia.

Children of Anthony III and Ann (Bilton) Lawson:

(1) John Lawson, was born March 15, 1807, at Woodcroft, England, and is registered at the Parish Church of Stanhope, Durham County, England. He was killed in the prime of his life by a falling tree, March 9, 1844. He is buried in the Lawson family cemetery, near his homestead, midway between Williamson and the Mouth of Sycamore, Mingo County, West Virginia.

(2) Lewis Bilton Lawson, was born December 4, 1808, and is registered at the Parish Church of Stanhope, Durham County, England. He died May 17, 1869, near Logan, in Logan County, West Virginia. He is buried by the side of his wife in the Lawson cemetery at Stollings a village at the Mouth of Dingess Run Creek, near Logan, W. Va.

(3) James Lawson, was born April 18, 1811, at Stanton, in the Parish of Longhorsley, Northumberland County, England; he is registered at the Parish Church of Longhorsley. He died at Blacksburg, Virginia, April 30, 1872, and is buried there.

(4) Anthony Lawson IV, was born February 22, 1813, at Stanton, in in the Parish of Longhorsley, Northumberland County, England, and is registered at the Parish Church of Longhorsley. He died March 12, 1885, and is buried in the East End cemetery at Wytheville, Va.

(5) George William Lawson, was born at Smith's Farm near Alexandria, D. C., United States of America, December 8, 1818 and died July 23, 1919, and is buried there.

ANTHONY LAWSON III

Anthony Lawson was a native of Northumberland, England, and was born Oct. 31, 1785. Sometime about the year 1817, he emigrated to America with his wife and four sons, John, Lewis B., James and Anthony IV. He remained for a while at Alexandria, Va. where his brother, John, who had preceded him to America, lived.

Colonel Andrew Bierne, of Lewisburg made his acquaintance, and induced him to come to the wilds of Guyan River and engage in the fur and ginseng trade. He first settled at the present site of Oceana and remained there for about four years, and then moved to the present site of Logan Courthouse where he remained until his death which occurred in Guyandotte in 1847 while he was returning from Philadelphia where he had been to purchase goods.

Mr. Lawson was a member of the first County Court of Logan County, and was during his life a leading citizen of his community. His wife survived him for something over seven months when she was murdered by two of her slaves. Her tombstone has the following inscription:

"Sacred to the memory of ANN Lawson, wife of Anthony Lawson, Sr. of Logan County, Virginia, who was born in the Parish of Longhorsley in the County of Northumberland, England on the 17th day of Mar. 1783 and was cruelly murdered on the night of the 27th of Dec. 1847, by two of our own negroes."

The sons of Anthony Lawson III, were all prominent men in the County. John married Emily Butcher, daughter of Joshua and Sarah (Clark) Butcher, and was killed by a falling tree in 1844. Lewis B. married Polly Dingess; James married Matilda Dingess, both were daughters of Peter and Sallie (Farley) Dingess. Anthony IV, the youngest son married Ann Brooke Robertson, a daughter of Edwin and Ann Brooke (Mennis) Robertson.



Mrs. Chloe S. Robertson, consort of Edwin, resident of the County of Logan, died at her place of residence on the morning of the 18th of June last, after a three weeks spell. of sickness, in the 39th year of her age. She was the daughter of John Stone, Esq., formerly of Pittsylvania County. Mrs. Robertson left a husband and a family of children, as well as numerous connections and a large circle of devoted friends Mrs. Robertson was exemplary in all to lament her loss. private and social relations of life and was much esteemed and beloved by all her relations and acquintances. She was ardently pious and during her protracted illness she bore all her sufferings, which was often extreme, with perfect Christian resignation, and closed her earthly career triumphing in the Christian faith. Notwithstanding the severe bereavement and affliction which the relatives and friends of Mrs. Robertson have suffered in her loss, they have much consolation in the perfect assurance which they feel, that she is now ineffable happy in the realms of eternal bliss.

Richmond Whig, published June 17, 1847 Lynchburg and Winchester Papers Please Copy.

Col. Anthony Lawson, Sr. of Logan County, died May 20, 1847 at Guyandotte, Virginia, aged upwards of 60. He was on his way home from Philadelphia. He emigrated to this country more than 20 years ago, and often spoke of the beauties of the place of his birth, the vicinity of Ainwick Castle, the seat of the Percies in Yorkshire, England. He accumulated a large fortune which he left to his children.

Ann Bilton was born at Fieldhead, in the Parish of Longhorsley, on the 17th of March, 1783.

Anthony Lawson III was born at Stanton, in the Parish of Longhorsley, on the 31st of October, 1785.

Anthony Lawson III and Ann Bilton were married on the 20th of May, 1806, in the Parish Church of Longhorsley, Northumberland County, England, and regularly registered.

REGISTER OF THE FAMILY OF ANTHONY III AND ANN (BILTON) LAWSON

John was born on the 15th of March, 1807, at Woodcroft.

Lewis Bilton was born on the 4th of December, 1808.

The above two children are registered in the Parish Church of Stanhope, County Durham, England.

James was born at Stanton, on the 18th of April, 1811.

Anthony IV also was born at Stanton, February 22, 1813.

These two children are registered in the Parish Church of Longhorsley, Northumberland County, England.

George William was born December 8, 1818 at Smith's Farm near Alexandria, D. C., United States of America.

Isabel Bilton, widow of John Bilton, of Causey Hagg, near Longhorsley, died June 11, 1811, aged 89 years.

It is thought that Isabel is the grandmother of Ann (Bilton) Lawson, wife of Anthony Lawson III. Causey Park Hagg is in sight of Stanton Old Hall, and the church is almost in sight of both and equally distant.

JOHN LAWSON SON OF ANTHONY III, AND ANN (BILTON) LAWSON

John Lawson, born March 15, 1807 at Woodcroft, England, is registered at the Parish Church of Stanhope, Durham County, England. He died March 9, 1844 near his homestead, which was located near Tug River, one mile north of the Mouth of Sycamore Creek (West) Virginia. The memorial inscription on his gravestone is as follows: "Sacred to the memory of John Lawson, who was cut off in the prime of life by a blow from falling a tree near this place on the 9th day of March 1844. Aged 56 years".

He is buried by the side of his wife in the Lawson family cemetery located on a steep rocky hill near his homestead. He came to America as a lad with his parents, Anthony III and Ann (Bilton) Lawson. He spent a few years in Alexandria, Virginia, with his parents where his Uncle John resided. About the year 1820, his father, Anthony Lawson III, settled on Clear Fork of Guyan river at a site afterwards named Oceana. About four years later, Anthony Lawson III moved to, or near, the site of Aracoma, on the Guyan River, which is now Logan, West Virginia.

In the year 1830, John Lawson was appointed by the United States Bureau of Census to take the census of Logan County, (W.) Virginia. He became active in business, especially in the sale and purchase of lands in Logan County. The deed records of Logan County indicate that there were at least five deeds recorded in the name of John Lawson for a total area of 26,400 acres of valuable mineral lands situated on the Tug River at and near the Mouth of Sycamore Creek.

On August 29, 1833, he married Emily Butcher, a daughter of Joshua and Sarah (Clark) Butcher at Logan, (W.) Virginia. To this union six children were born.

Emily Butcher, a daughter of Joshua and Sarah (Clark) Butcher, was born January 2, 1813 in Logan County, (W.) Virginia and died March 30, 1902 at her homestead near Williamson, W. Va.

After the death of her first husband, John Lawson, she married George Smith; and to this union two children were born, they were America Victoria, born March 1, 1851 and Allen Butcher Smith born October 3, 1852.

Emily (Butcher) Smith is buried by the side of her first husband in the Lawson family cemetery near the old homestead. The following is inscribed on her gravestone: "Emily Smith, wife of John Lawson, born January 2, 1813, died March 30, 1902. Aged 89 years, 2 months, 28 days."

(1) George W. Lawson, born September 24, 1834, died August 1, 1906, at Williamson, West Virginia. He is buried at the Lawson family cemetery, near the Mouth of Sycamore, West Virginia. He married Chloe Ann Robertson, daughter of Edwin and Chloe S. (Stone) Robertson, at Logan, (West) Virginia, February 23, 1854. Chloe Ann Robertson was born May 1, 1836, at Logan, (W.) Virginia, and died at Williamson, West Virginia, March 30, 1912.

(2) James Montraville Lawson, born February 18, 1836, died December 4, 1881 at Jacksonville, Florida. He is buried in the Lawson family cemetery on John's Creek, Pike County, Kentucky. He married Mary Ann Williamson, July 29, 1866 in Pike County, Kentucky.

(3) John Marshall Lawson, born November 6, 1837, died October 6, 1838. He is buried near his parents in the Lawson family cemetery.

(4) William Henry Harrison Lawson, born 1839, died May 11, 1854. He is buried near his parents in the Lawson family cemetery.

(5) Melvin Bilton Lawson, born April 24, 1841, died May 12, 1884 at Asheville, North Carolina. He is buried at the Dr. George W. Lawson cemetery near the Mouth of Sycamore, Mingo County, West Virginia. He married Katherine Virginia (Jennie) Cassell, a daughter of Col. Joseph Cassell. She was born January 30, 1849, died April 21, 1925. She is buried in the East End cemetery in Wytheville, Virginia.

(6) Sarah Bilton Clark Lawson, born March 12, 1843, died January 27, 1916 at Roanoke, Virginia. She is buried in the Dr. George W. Lawson cemetery near the Mouth of Sycamore, Mingo County, West Virginia. She married James Robert Crockett, a son of Sanders S. Crockett at Wytheville, Virginia.

George W. Lawson, son of John and Emily (Butcher) Lawson, was born September 24, 1834 at the old homestead south of Williamson, Mingo County, (West) Virginia. He died in Williamson, West Virginia August 1, 1906.

George was a lad of nine years when his father, John, was killed by a falling tree near his home.

On February 23, 1854, he married Chloe Ann Robertson, daughter of Edwin and Chloe S. (Stone) Robertson at Logan, (West) Virginia. Chloe Ann was born May 1, 1836 at Logan, (West) Virginia and died March 30, 1912 at Williamson, West Virginia. She is buried by the side of her husband in the Dr. George W. Lawson cemetery situated on a high knoll, near the old homestead at the Mouth of Sycamore, West Virginia.

George W. Lawson became an outstanding physician of his day and practiced medicine in Logan County for many years. Dr. Lawson took great pride in the medical profession. He suffered many hardships during the cold and stormy weather to render services to the sick and suffering people living in the mountains of Logan County. His devotion to duty gained him much fame throughout that section of West Virginia.

He was a man of fortune, holding large tracts of valuable coal and timber lands. He resided at the homestead located at the Mouth of Sycamore and reared his family there. He was for many years engaged in the mercantile business and was also postmaster at Mouth of Sycamore. He moved with his wife, Chloe Ann, to Williamson soon after the town was surveyed and organized into a municipality. Dr. Lawson, along with other citizens, organized the Bank of Williamson and served as its President. He was a charter member of the Masonic Lodge of that city and also a member of the Presbyterian Church of Williamson. Politically he was a Democrat and a firm believer in the principle of democracy.

James Lawson, born April 18, 1811, at Stanton in the Parish of Longhorsley, Northumberland County, England, is registered at the Parish Church of Longhorsley. He died at Blacksburg, Virginia, April 30, 1872, and is buried in the cemetery there. He married Matilda Dingess, a daughter of Peter and Sallie (Farley) Dingess, March I, 1838, near Logan (West) Virginia. She was born August 1, 1818, at Logan, (W.) Virginia, died April 19, 1860, and is buried in George W. Nighbert burial ground, Logan County, West Virginia. She is a sister of Polly Dingess, who married Lewis B. Lawson, a brother of James.

JOHN LAWSON SON OF ANTHONY II AND MARGARET (CAISS) LAWSON

John Lawson, son of Anthony II and Margaret (Caiss) Lawson was born 1796, Northumberland County, England. He married Elizabeth (surname unknown) in England. John and his wife, Elizabeth, came to America during the year of 1816 and located in Alexandria, Virginia. He was a merchant, and soon after his arrival in America, he engaged in the general mercantile business on Cameron Street in Alexandria. He soon became a leading citizen in that community and enjoyed a splendid commercial business. During his thirty five years as a resident of Alexandria he became wealthy and was one of the outstanding and beloved citizen of that community.

His wife Elizabeth died July 25, 1849, at the age of 51 years. She is buried in the Saint Paul cemetery of that City.

After his wife's death, John married the second time Miss Isabella McCardell of Hagerstown, Washington County, Maryland. The marriage license was issued on the 29th day of March, A. D. 1851 and was addressed to Rev. Mr. Anspach.

John Lawson died June 18, 1851, and is buried by the side of his first wife, Elizabeth, in Saint Paul cemetery. His will is dated June 7, 1851, witnesses: O. Fairfax, Francis Murphy and Lau. B. Taylor. His will was probated June 25, 1851, and he bequeathed five hundred dollars annuity payable quarterly and his slave girl, Ellen, to his beloved wife as long as she remained his widow. The remainder of his estate was given to his two Nephews, Thomas A. Brewis, who lived with him and his Nephew Anthony Lawson IV of Logan Virginia (now W. Va.)

These two Nephews were appointed executors of his estate, without bond, except as to the payment of the annuity to his wife Isabella. The following is an item from the Alexandria Gazette of June 19, 1851.

"John Lawson died in this town on the 18th inst. in the 55 year of his age, John Lawson, a native of the County of Northumberland, England, who for the last 35 years was a citizen of Alexandria. Mr. Lawson bore through life a high character for integrity and benevolence; and his death will be mourned by the many who have

experienced his kind offices in the hour of need or distress. His funeral will take place this morning at 10 o'clock from his late residence on Cameron Street."

THOMAS ANTHONY BREWIS

Thomas Anthony Brewis, a son of James and Mary (Lawson) Brewis of Northumberland County, England. His mother is a daughter of George Lawson, who is a brother of the above mentioned John Lawson. James Brewis, father of Thomas Anthony, died before 1870.

Thomas Anthony came to America and lived with his uncle, John Lawson in Alexandria, Virginia. He married Eugenia Alverda Waters, daughter of Thomas A. and Sarah L. (Nelson) Waters of that place. Thomas Anthony was killed at the falling of the floor of the Capitol Building in Richmond, Virginia in 1870. He died April 27, 1870, intestate and without issue. William Henry Marberry' was appointed Administrator of his estate and later he was given power of Attorney for the English heirs.

Soon after the death of Thomas A. Brewis his wife Eugenia Alverda married Charles Ewing Easter of Baltimore, Maryland.

ANTHONY LAWSON IV

Anthony Lawson IV, known among his friends as Anthony, Jr., was the youngest son living of Anthony III. Young Anthony married Ann Brooke Robertson, the youngest daughter of Edwin and Ann Brooke (Mennis) Robertson. This happy couple resided near their parents' residence, which is now Logan, West Virginia. Anthony IV was an enterprising and successful business man. The deed records of Logan County, West Virginia, indicate that he was active in the purchase and sale of many tracts of valuable coal lands in Logan County.

He was active in promoting facilities for education and gave land for public school sites. He also assisted financially and otherwise in the construction of school buildings.

About 1857 he decided to move his family to Burke's Garden in Tazewell County, Virginia, and later moved his family to Wytheville, Wythe County, Virginia, where he remained until his death. Many of his descendents live in the state of Virginia and adjoining states; some of them remain in Wytheville.

The descendents of Anthony Lawson IV are distinguished by their popularity and high standing in the communities where they reside; many of them are Daughters and Sons of the American Revolution. A second to be added as a second to be a

THE REVEREND GEORGE ROBERTSON OF BRISTOL PARISH, VIRGINIA

The Reverend George Robertson was born in Scotland about 1668.¹ Nothing is known of his birthplace or boyhood. It is said that he was educated at St. Andrew's College, Fifeshire, and graduated.² After preparing himself for the cloth, his ascent in the ministry was rapid. On December 20, 1691, he was ordained Deacon; on January 14, 1692, he was made Priest; and on February 20, 1692, he was licensed by the Bishop of London as a missionary to go to the Colony of Virginia. Sometime in that period (probably 1692), he was assigned as Chaplain to an English man-of-war.³ A reasonable explanation is that upon his appointment as missionary he resigned his naval chaplaincy and sailed from England to pursue his calling in the New World. No evidence has been discovered that he ever became a Doctor of Divinity.⁴ 1366425

It has been said that the Reverend George Robertson contracted a first marriage in England to a lady named Mary, but whose surname is unknown, by whom he had a son George.⁵ No record has been found to substantiate this marriage. So early a marriage is exceedingly doubtful because he became Chaplain of the man-of-war quite young and he seems to have come to Virginia directly from the English Navy. There is no reference to his being married when he came to Bristol Parish, a fact that would likely have been noted had it existed. No available record suggests that he was married twice." The writers agree that he settled at Picketts in that part of Henrico County which later became Chesterfield County.¹

The Reverend George Robertson married, after his arrival in Virginia, but there is much uncertainty as to the lady he married and confusion as to their four children. Largely by reason of the statement in the Richmond Times Dispatch Robertson pedigree, it was accepted by members of the family for a long time that the lady he married in Virginia was Mary Eppes, daughter of Peter Eppes, of Bermuda Hundred, and widow of Colonel Joseph Royall. Of late years, however, this acceptance has been seriously questioned."

The lady the Reverend George Robertson married in Virginia could have been, and probably was, Mary Worsham. The basis for this suggestion is the will of John Worsham, dated in 1729, in which he names, among other children, his daughter, Mary Robertson,⁸ and also the will of John Worsham, Jr., made in 1768, in which he names his sister, Mary Robertson.¹⁰

The children of the Reverend George Robertson were George, John, James and Elizabeth. By coincidence James Robertson, the son of the Reverend George Robertson, also had children named George, John, James and Elizabeth and also Mary and Martha. This similarity in names of the two sets of children probably led the author of the Richmond Times Dispatch Robertson pedigree into error for the George, John, James and Elizabeth assigned by him to the Reverend George Robertson as his children were, in fact, the grandchildren of the cleric and children of his son, James Robertson."

Edwin Roberston was born circa 1790, married Ann Brooke Mennis, a daughter of Captain Callohill and Martha Mennis, circa 1809. After the death of Ann Brooke (Mennis) Robertson, Edwin Robertson married Chloe S. Stone, a daughter of John and Jennie (Campbell) Stone at Logan Court House, Virginia circa 1825. Issue: (1) Elizabeth; (2) Augusta; (3) John Edwin; (4) Laidley; (5) Chloe Ann; (6) Sidney Baxter Robertson. Edwin was County Court Clerk of Logan County, Virginia until his death. His second wife, Chloe S. (Stone) Robertson died June 18, 1839 at Logan, Virginia (now West Virginia).

Children of Edwin and Ann Brooke (Mennis) Robertson:

(1) Callohill M. Robertson, born circa 1817, married Mary Eppes (Polly) Robertson, his cousin, of Amelia County, Virginia. While quite young he went south and located in Alexandria, Rapides Parish, Louisiana and engaged in the mercantile business. He was one of the most successful merchants in the state, being the principal business manager of the firm of which he was a member. He married Agalice Baillio, daughter of Augusta Baillio and Felonise Laysarrd of Alexandria, Louisiana. Henry Robertson died in the 45th year of his age; after his death his wife went to Donnaldsonville, Louisiana to live with her only daughter. They moved to Wytheville, Virginia, where she died on January 14, 1903 and is buried by the side of her husband in the East End cemetery at Wytheville, Virginia. Issue: (a) Valcolon W. Mather, married Ollio Keith of Kansas City, Missouri. He was a physician and practiced medicine in Huntington, West Virginia and Kansas City, Missouri. Dr. Valcolon W. Mather and his wife are buried in Huntington, West Virginia. She died at the age of 83 years at her summer home on Mackinac Island, Michigan. Their son, Harry Feld, became a famous surgeon and practiced his profession for forty years in Kansas City, Missouri. He died November 23, 1936. His survivors were his widow, Lillian V. (3) John Edwin Robertson was born February 9, 1830 in Logan County Virginia and was only nine years of age when death deprived him of his mother. After his mother's death, he went to live with his sister who lived in Barboursville, Cabell County, and in his new home attended school for one year. His father then placed him in Marshall College and on leaving that institution he went to Alexandria, Louisiana, where for three years he was employed in his brother Henry's store. In 1849, being then 19 years of age, he sought the gold field of California. John Edwin remained in the land of his quest until 1861. At the beginning of the Civil War in 1861, he returned to his home in West Virginia. He enlisted in the Border Rangers of Jinkins Brigade and fought for the Confederacy througout the four years of conflict. He took part in many engagements. Sidney Baxter Robertson was born July 10, 1837 in Logan (6)County (West) Virginia. He was the youngest child of Edwin and Chloe S. (Stone) Robertson. His mother died when he was three years of age. Before 1861, he went south and located in New Orleans, Louisiana. When the Civil War was declared, he enlisted in the Confederate Army and served as Second Lieutenant throughout the conflict. After he was discharged from the Confederate Army, he married Helen Ione Duke, April 11, 1865 at Harrisonburg, Louisiana. Helen I. (Duke) Robertson was a daughter of B. C. and Elizabeth Duke of Harrisonburg, Louisiana. She was born December 21, 1844 at Harrisonburg and died September 1, 1908 at Mena, Arkansas. Sidney B. Robertson and his wife were baptised in the Methodist Church South by Reverend John I. Winn at Oak Grove Church December 21, 1873. Some of their children were born at Myrtle Grove Plantation, Avoyelles Parish, Louisiana. In years following they located at Neosho, Missouri, then Bentonville, Ark. From Bentonville they moved to Cloud Chief, Okla. where Sidney B. continued his profession as a civil engineer. He, with his family, returned to Arkansas. In May 1896, he located at the present site of Mena, Arkansas, where he supervised and directed the surveying and laying out of the townsite of Mena. He established a residence for his family in Mena, where he remained until his death. He was County Surveyor of Polk County, Arkansas. He died in Mena, September 6, 1932 in the 94th year of his age.

JOHN STONE

John Stone married Miss Jennie Campbell in Pittsylvania County, Virginia circa 1806. He settled in the wilds of the Guyan river at a place now known as the Old Stone Farm in 1809, not far from the present site of Logan, West Virginia.

Crispin L., the eldest son of John Stone, was born in Pittsylvania County, Virginia circa 1808. He married Mildred (Milly) Workman and they had at least four children. Crispin L. died in 1892 in the 85th year of his age. He was was one of the best and most useful citizens in Logan County. During a long and honorable life he served the people well and faithfully in several official positions, among which were Justice of the Peace, Surveyor, Clerk of Circuit Court and County Superintendent of Free Schools.

Samuel J. Stone, another son of John and Jennie (Campbell) stone, was born in 1812 and married Polly Hatfield. They had at least seven children.

John Stone's daughter, Chloe, married Edwin Robertson, who up to the time of his death was Clerk of the County Court of Logan County. The children of Edwin Robertson were John Edwin, who lived about one and one half miles from Logan Court House and owned large tracts of land adjoining Logan, and Chloe Ann, who married Dr. George W. Lawson.

February 22, 1776, Ensign, First Virginia Regiment.

February 23, 1776, First Lieutenant, First Virginia Regiment.

- November 18, 1777, Captain, First Virginia Regiment.
- Taken prisoner at Charleston, South Carolina, May 12, 1780.
- Transferred to Seventh Virginia Regiment, February 12, 1781 and served there to the close of the War.

Recorded in Hertman's Register, Page 295.

Callohill Mennis died in Breckenridge County, Kentucky in 1812. Martha Mennis, his widow, was the administratrix. Francis C. Mennis, Edwin Robertson and his wife, Ann Brooke, Callohill Mennis Jr., Martha Mennis, Robert Mennis and Andrew Mennis were the heirs of Callohill Mennis, deceased.

Colonel Charles A. Dempsey married Lena Mennis Lawson, December 30, 1903 at Brookland, Virginia. They lived in Washington and in October 1904, Colonel Dempsey received a detail with the National Guard of Virginia and remained in Richmond until his death. No issue. Colonel Dempsey by his first marriage had one son, William Worth Dempsey, like his father, a graduate at West Point.

Robert Lawson Peirce married Julia Settle of Galveston, Texas, and they have two children, (a) Julia Settle Peirce, born June 25, 1908, (b) Elizabeth Lawson Peirce, born May 17, 1911.

Edwin Robertson's name may have been Edwin Joseph Robertson, however his signature to documents and papers was written uniformly Edwin Robertson.
