Using this as a base I have attempted to compile a fairly complete bibliography on communes, counter-culture and philosophical critiques of contemporary American society and the organizational alternative to it.

I have concentrated almost exclusively on works which have been published in standard sources. I have attempted to collect all books of readings relevant to the area.
