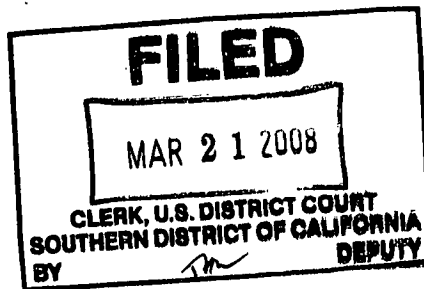

The undersigned complainant duly sworn states:

That on or about March 20, 2008, within the Southern District of California, defendants Antonio DIAS-Suarez and Luis Enrique SALGADO-Vega, did knowingly and intentionally possess with intent to distribute approximately 814.80 kilograms (1,796.3 pounds) of marijuana, a Schedule I Controlled Substance, in violation of Title 21 United States Code, Section 841(a)(1).

And the complainant states that this complaint is based on the attached Probable Cause Statement, which is incorporated herein by reference.

4 The statement of facts is based on the reports, documents, and  
5 notes furnished to Drug Enforcement Administration Task Force  
6 Officer Cynthia M. Barajas

7 On March 20, 2008, at approximately 5:00 p.m., United States  
8 Border Patrol Agent (USBPA) Matthew Tucker was performing his  
9 official duties at the 808 Checkpoint, approximately 25 miles east  
10 of the Calexico, California West Port of Entry when Remote Video  
11 Surveillance System operators saw two vehicles drive north over the  
12 Drop 3 access road.

13 At approximately 5:10 p.m., while USBP Agent Tucker traveled  
14 eastbound on Highway 98, looking for the vehicles matching the  
15 description that the RVSS provided, USBP Agent Tucker drove past  
16 the first black vehicle and noticed that all the windows had been  
17 blacked out and that the driver was covering his face with his left  
18 hand. Shortly after that, the second vehicle drove by also with  
19 blacked out windows with the driver also concealing his face with  
20 his hand.

21 USBP Agent Tucker made a U-Turn and began traveling westbound  
22 on Highway 98. USBP Agent Tucker activated the emergency lights on  
23 the Cadillac Escalade. Agent Tucker upon contacting the driver  
24 smelled marijuana and noticed bundles of what appeared to be  
25 marijuana. The driver was later identified as DIAS-Suarez, Antonio.

26 At approximately 5:23 p.m., USBP Agent Julio Gutierrez saw a  
27 small black SUV that matched the description of the second vehicle  
28

1 heading westbound on Highway 98. Agent Gutierrez notified his  
2 dispatch that the driver of a black Suzuki SUV bearing California  
3 license plates 5YML124 was failing to yield. Upon contacting the  
4 driver who was later identified as Luis Enrique SALGADO-Vega.  
5 SALGADO-Vega arrived to the East Highline Canal where he stopped his  
6 vehicle and attempted to flee back to Mexico on foot. Agent Daniel  
7 Black was able to subdue SALGADO-Vega before he could abscond back  
8 to Mexico. SALGADO-Vega stated that he does not have any  
9 immigration documents. Agent Gutierrez also noticed that the inside  
10 of the vehicle was full of plastic wrapped bundles with the odor  
11 and consistency of bulk marijuana. SALGADO-Vega and DIAS-Suarez  
12 were placed under arrest and transported to the Calexico Station  
13 for processing and turned over to DEA.

14 Records checks later confirmed that both vehicles had been  
15 reported stolen. The Cadillac Escalade yielded 1,117.2 pounds of  
16 marijuana. The Suzuki yielded 679.1 pounds of marijuana.

17 DEA Special Agents Joanne Camacho and Task Force Officer  
18 Cynthia M. Barajas were called and responded to the Calexico United  
19 States Border Patrol Station.

20 TFO Barajas, as witnessed by SA Camacho, advised DIAS-Suarez  
21 of his Miranda warnings. DIAS-Suarez stated he understood and  
22 agreed to answer questions.

23 DIAS-Suarez stated that he met Ishmael on March 19, 2008, in  
24 Cuervo, Mexico. DIAS-Suarez stated he heard Ishmael was in need of  
25 drivers to cross marijuana into the United States and that he would  
26 pay good money. DIAS-Suarez introduced himself and agreed to drive  
27 a marijuana load into the United States. DIAS-Suarez stated that he  
28

1 knew he was transporting marijuana and that this was his first  
2 time. DIAS-Suarez also stated he saw the second driver SALGADO-Vega  
3 at the same residence in Mexico where he picked up the loaded  
4 vehicle from a person by the name of "GORDO". DIAS-Suarez was  
5 advised that once he would reach the highway, he would be contacted  
6 by an unknown driver to direct him where to drop off the marijuana.

7 On March 20, 2008, USBP Agent Blake tested the bundles that  
8 contained a green leafy substance with a NIK-field testing kit. The  
9 bundles tested positive for the properties of Marijuana.

10 On March 21, 2008, at approximately 1253 a.m., TFO Barajas,  
11 TFO Tabarez, and SA Camacho transported Antonio DIAS-Suarez and  
12 Luis Enrique SALDIAGO-Vega to the Imperial County Jail.
