ANITA P. ARRIOLA declares:

1. I am counsel for plaintiff James L. Adkins in the above-captioned case. I make this Declaration in support of plaintiff's Motion to Disqualify Office of the Attorney General. I have personal knowledge of the facts contained herein.

2. Assistant Attorney General Robert Weinberg ("Weinberg") filed an Appearance of Counsel in this matter on June 30, 2010 on behalf of defendants Paul Suba, D. B. Anciano, and Serafino Artui. On December 8, 2010, I received an email from Weinberg. In the email, he informed me that Assistant Attorney General Kenneth Orcutt ("Orcutt") would appear in this

case as counsel for defendants John F. Taitano ("Taitano") and Jesse P. Rodriguez ("Rodriguez"). A true and correct copy of that email (without enclosures and without the string of emails preceding it) is attached hereto as Exhibit A.

3. On December 14, 20 and 27, 2010, I received three emails from Orcutt informing me that he represents Taitano and Rodriguez in this case and that he would accept service of the summons and Second Amended Complaint ("SAC") on their behalf. True and correct copies of those emails are attached hereto as Exhibits B, C, and D.

4. Weinberg and I agreed to meet on December 14, 2010 to discuss possible resolution of this case. We met on that date at Java Junction at 10 a.m. During our meeting we discussed plaintiff's new claims concerning the tampering of Mr. Adkin's cell phone and the destruction of the photographs in the cell phone. Weinberg disclosed to me that, with respect to such claims, defendants Taitano and Rodriguez would be asserting the defense of "reliance upon advice of counsel." He stated:

I was the counsel and they relied on me. I was the one that told them to take the camera and see what was in it. See, I thought, and I still think, that the pictures would show that Mr. Adkins took the photos from the road, and not off the road as he claims. So Taitano and Rodriguez took the camera but they said when they checked it, they couldn't turn it on and I told them to go to a store to get a charger. But they still couldn't turn it on.

5. Plaintiff filed his SAC in this matter on November 24, 2010. The Office of the Attorney General was served with a copy of the SAC on the same day. Defendant Jesse P. Rodriguez was served with a summons and the SAC on December 20, 2010 through his attorney Orcutt. I was informed by Orcutt on December 27, 2010 that he is authorized to accept service of summons and the SAC on behalf of John F. Taitano, (see Exhibit D), but Taitano has not been served.

I declare under penalty of perjury under the laws of Guam and the United States that the foregoing is true and correct.

Feliz Navidad and Happy Hanukkah. A Christmas through New Years holiday without brief writing sounds great to me to me too.

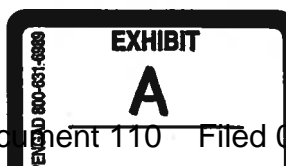

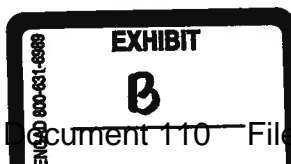

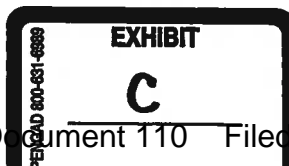
