- 16 1. I am an adult, over the age of eighteen, and otherwise competent to testify in
- 17 a court of law.

- 19 2. On or about 29 April 2010 I learned that the Guam Police Department would
- 20 no longer represent co-defendant Sarapino Artui, nor me, in this civil suit filed
- 21 against us.

- 23 3. Since learning this, Mr. Artui and I have been actively seeking representation
- 24 by counsel. Although we believe we may ultimately secure representation, we
- 25 have not yet done so.

1 4. On or about 3 May 2010 I learned that the Attorney General of Guam would  
2 not represent us either. This decision (as well as that of the Guam Police  
3 Department) is based upon perceived conflicts of interest.

5 5. Because of the decisions of the Guam Police Department and the Office of  
6 the Attorney General, both myself and Mr. Artui are unrepresented.

7 6. We believe that an extension of time in which to file objections to a  
8 Magistrate's Report and Recommendation would allow us to obtain  
9 representation and allow a lawyer(s) time to review the report.


