**JOINT STATUS REPORT AND  
 REQUEST TO VACATE  
 DECEMBER 12, 2018 CASE  
 MANAGEMENT CONFERENCE**

17 Plaintiff Elizabeth Baker and Defendant Apttus Corporation, by and through  
 18 their respective undersigned counsel, pursuant to the Court's Minute Order dated  
 19 September 24, 2018 (ECF No. 66), respectfully provide a status report and request to  
 20 vacate the currently-scheduled December 12, 2018 case management conference.

21 The Minute Order states that further case management conferences are set for  
 22 December 12, 2018, and January 10, 2019, and the parties are to "file joint or separate  
 23 case management reports by no later than four court days prior to each conference. If  
 24 counsel determine that a conference is not necessary, counsel have leave to request that  
 25 the conference be vacated." ECF No. 66.

26 The parties have agreed to mediate the claims in this case, in addition to the  
 27 claims brought in *De la Cuesta v. Apttus*, Case No. 3:17-CV-0520-MMD-CBC,

1 currently pending before this Court. The parties have scheduled private mediation  
2 sessions for December 11 and 12, and January 11. The parties have determined that the  
3 December 12, 2018, case management conference is not necessary, and request that the  
4 conference be vacated so that the parties can engage in mediation on that date.
