# NOTICE OF REMOVAL AND DEMAND FOR JURY TRIAL

### TO THE HONORABLE UNITED STATES DISTRICT COURT:

COMES NOW Allstate County Mutual Insurance Company and files its Notice of Removal pursuant to 28 U.S.C. §1446(a), as well as its formal Demand for Jury Trial, and in support thereof would show the Court as follows:

- 1. On August 17, 2017, Plaintiff Rebecca Ann Fults filed her Plaintiff's Original Petition in the matter styled *Rebecca Ann Fults v. Allstate County Mutual Insurance Company*, Cause No. 096-293963-17, pending in the 96<sup>th</sup> District Court of Tarrant County, Texas in which Plaintiff asserted a *Stowers* claim, as well as claims for bad faith and breach of the Insurance Code due to Allstate County Mutual Insurance Company's failure to settle Plaintiff's bodily injury claim.
- 2. Plaintiff served Allstate County Mutual Insurance Company with a copy of the Petition by certified mail, return receipt requested on September 19, 2017.
- 3. Defendant files this Notice of Removal within 30 days of receiving Plaintiff's Original Petition. *See* 28 U.S.C. §1446(b). This Notice of Removal is being filed within one year of the commencement of this action.

- 4. All pleadings, process, orders, and other filings in the state court action are attached to this Notice as required by 28 U.S.C. §1446(a) and are attached hereto as Exhibit "A." A copy of this Notice is also concurrently being filed with the state court and served upon the Plaintiff.
- 5. Venue is proper in this Court under 28 U.S.C. §1441(a) because this district and division embrace Tarrant County, Texas, the place where the removed action has been pending.

II.

## **BASIS FOR REMOVAL**

- 6. Removal is proper based on diversity of citizenship under 28 U.S.C. §§ 1332(a), 1441(a) and 1446.
- 7. Plaintiff is, and was at the time the lawsuit was filed, a citizen and resident of the State of Texas and owns the property in question which is located in Tarrant County, Texas (Petition, para. 1).
- 8. Defendant Allstate County Mutual Insurance Company is an Illinois corporation with its principal place of business in Illinois and is a citizen of the State of Illinois for diversity purposes, and therefore, complete diversity exists.

# A. The Amount in Controversy Exceeds the Jurisdictional Requirements for Subject Matter Jurisdiction

9. This is a civil action in which the amount in controversy exceeds \$75,000.00. Plaintiff alleges that Defendant is liable under a "Stower's claim" because Plaintiff alleges that Defendant unreasonably failed to settle a claim within policy limits. Specifically, Plaintiff alleges damages in the amount of the judgment entered on February 19, 2015 in the amount of \$144,938.97. (Petition, para. 4.15).

10. In addition, the Plaintiff's Original Petition alleges that Defendant is liable under the Insurance Code. (Petition, para. 5.03).

III.

### THE REMOVAL IS PROCEDURALLY CORRECT

- 11. Defendant was served with the Plaintiff's Original Petition on August 31, 2017. Defendant filed this Notice within the 30 day time period required by 28 U.S.C. §1446(b).
- 12. Under 28 U.S.C. § 1441(a), the removed action is proper in this Court as the district and division embracing the place where the state court action is pending.
- 13. As required by 28 U.S.C. §1446(a) and Rule 81.1 of the Local Rules, all pleadings, process, orders, and all other filings in the state court action previously filed are attached hereto as Exhibit "A."
- 14. Pursuant to 28 U.S.C. §1446(d), promptly after Defendant files this Notice, written notice of the filing will be given to Plaintiff.
- 15. Pursuant to 28 U.S.C. §1446(d), a true and correct copy of this Notice of Removal will be filed with the Clerk of the Tarrant County District Court, promptly after Defendant files this Notice.
- 16. Defendant hereby demands a trial by jury.

IV.

### **CONCLUSION**

Based on the foregoing, the exhibits submitted in support of this Removal and other documents filed contemporaneously with this Notice of Removal and fully incorporated herein

by reference, Defendant Allstate County Mutual Insurance Company hereby removes this case to this court for trial and determination.
