Prior art of record does not disclose a device for generating mipmap from the video source, the device includes a first adder for adding two texels of the same column of neighboring screen lines, a first FIFO buffer for storing the output from the first adder if the two added texels belongs to an even column, a second adder for adding the even column stored in the first FIFO buffer and the odd column outputted from the first adder at the next clock cycle, and a second FIFO buffer for storing the output of the second adder. Further, the above elements are connected in the exact connection as stated in the independent claims 15 and 34.
