The entire delay in filing the required reply from the due date for the reply until the filing of this petition pursuant to 37 CFR §1.137(b) was unintentional.

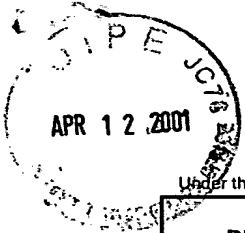
