The Examiner is respectfully thanked for the courteous interview held with Myun Ki Han, S. Paul Lee; (Inventors), two representatives of Georgetown University, the Assignee of this application, and the undersigned.

During the interview, proposed claims were presented which correspond substantially to those submitted herewith. Specific support for these claims is identified above. This identification is meant to be exemplary and not exhaustive. Claim 15, the only independent claim, was discussed in particular during the interview. It is contemplated that this claim should be allowable for substantially the same reasons that the claims of the parent application (USP 5,763,181) were granted..

Also, several references were discussed at the interview, which are cited in the accompanying Information Disclosure Statement. As discussed during the interview, these references should not affect the patentability of the present claims. In particular, it was noted that Japanese Kokoku Patent Application Publication No. Hei 5-15439 (published March 1, 1993) fails to teach a continuous fluorimetric assay as claimed herein. This is apparent, e.g., based on page 5, lines 27-29, of the document, and the Examples.


Further, the other references are believed to be no more relevant than prior art considered during prosecution of the parent application, now U.S. Patent 5,763,181.
