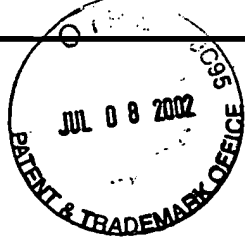

NOTES


